**DESCRIPTION**

FIG. 4 is a top elevational view showing the design for the planer of FIG. 1;

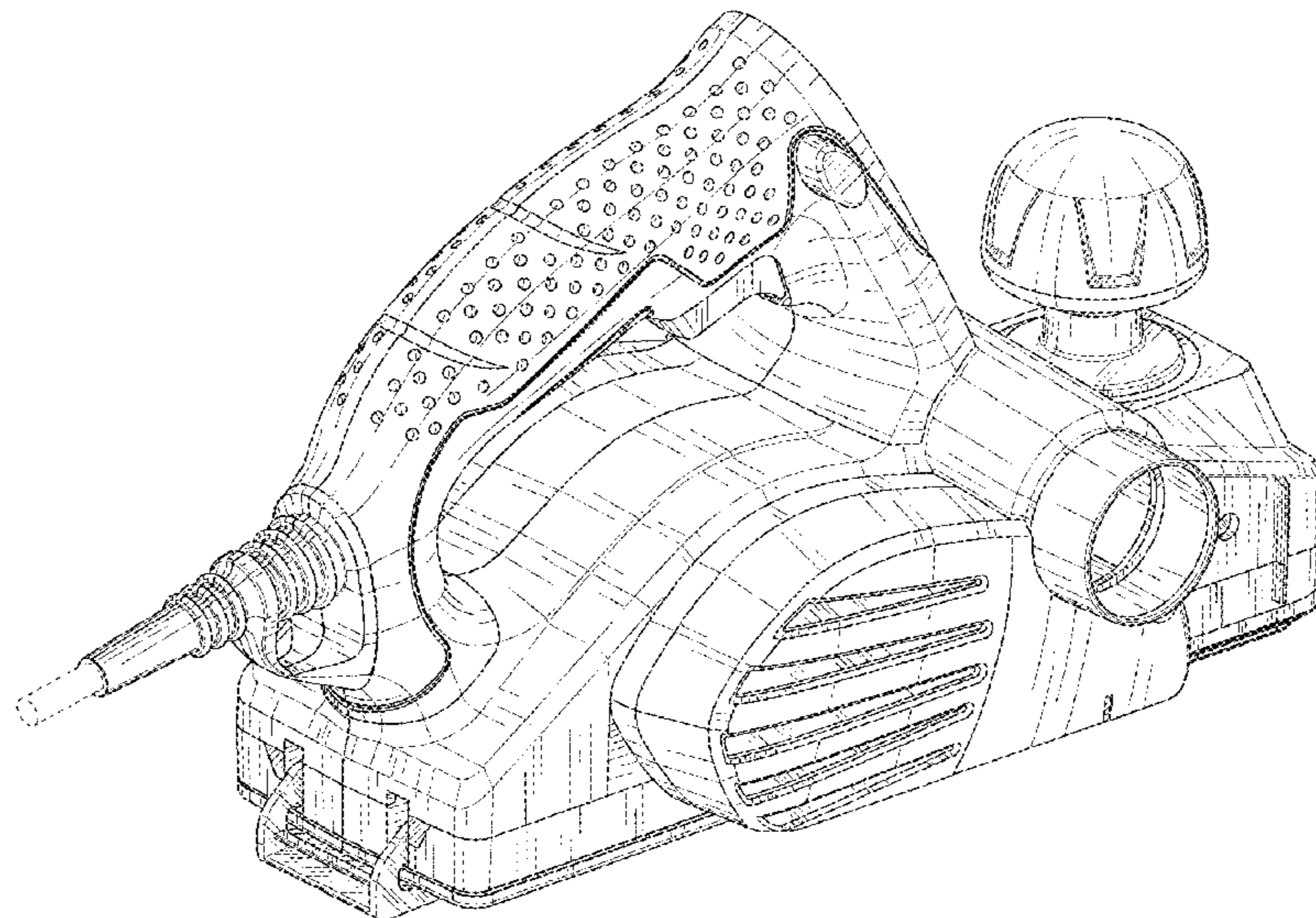
FIG. 5 is a bottom elevational view showing the design for the planer of FIG. 1;

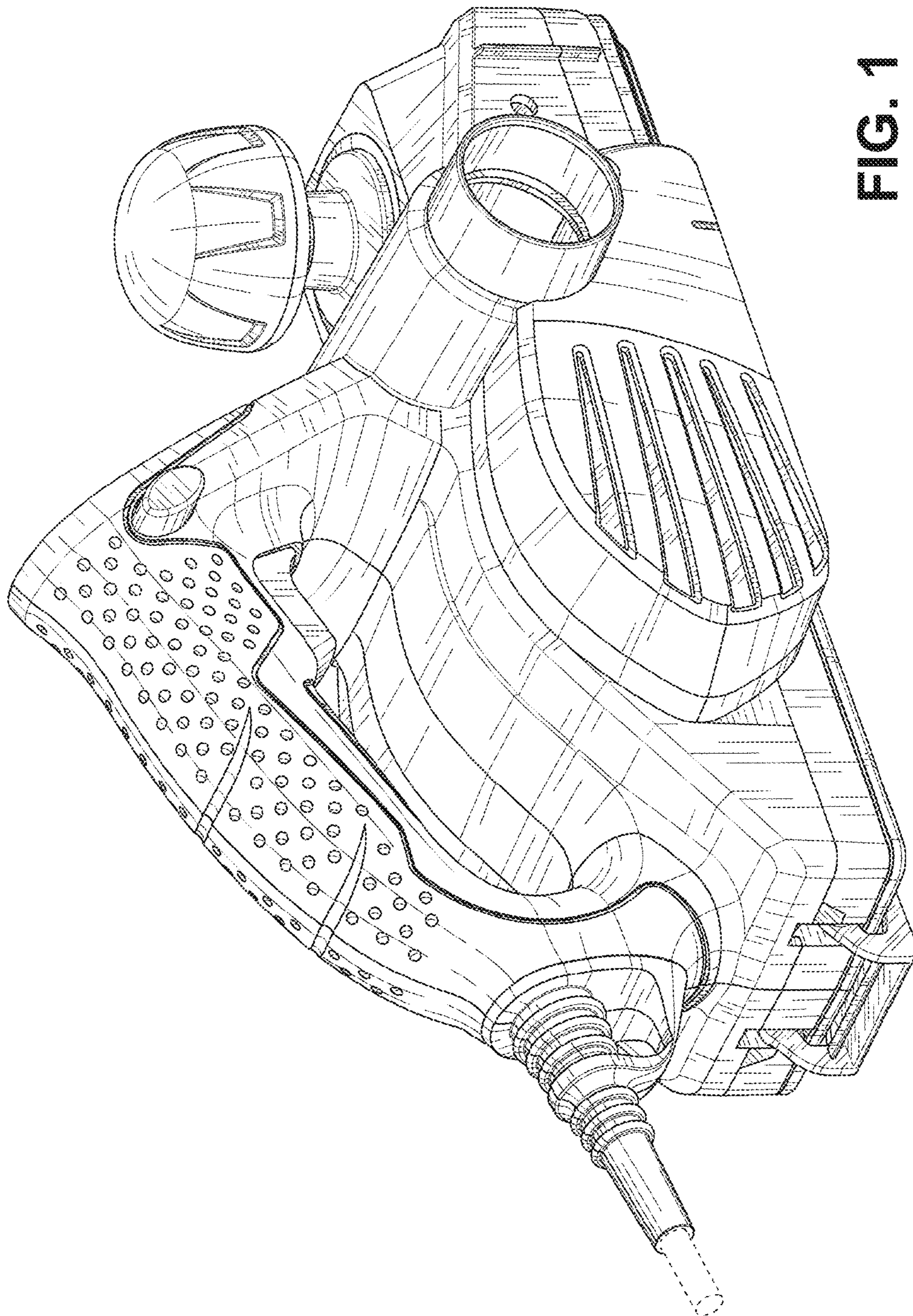

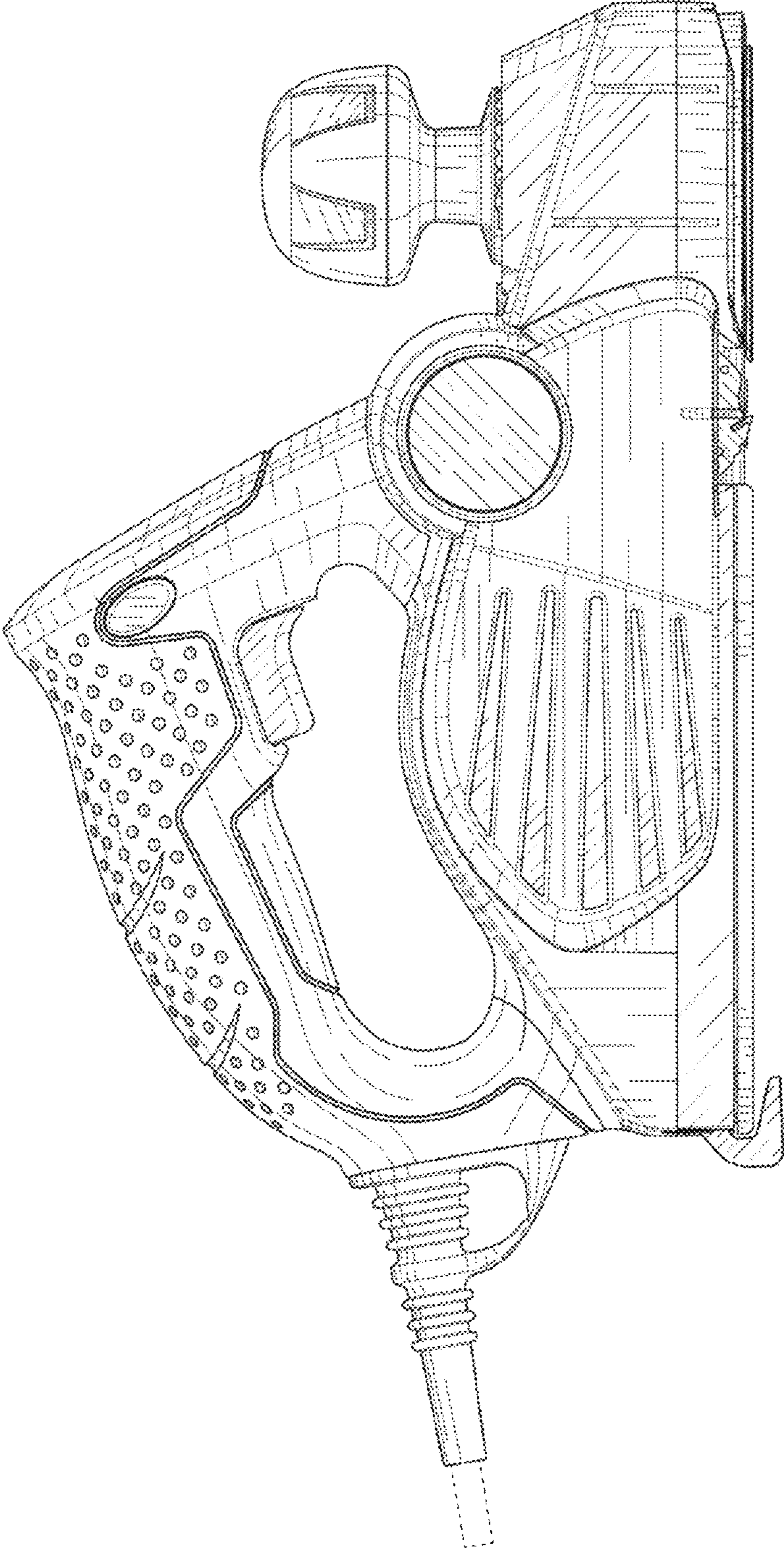

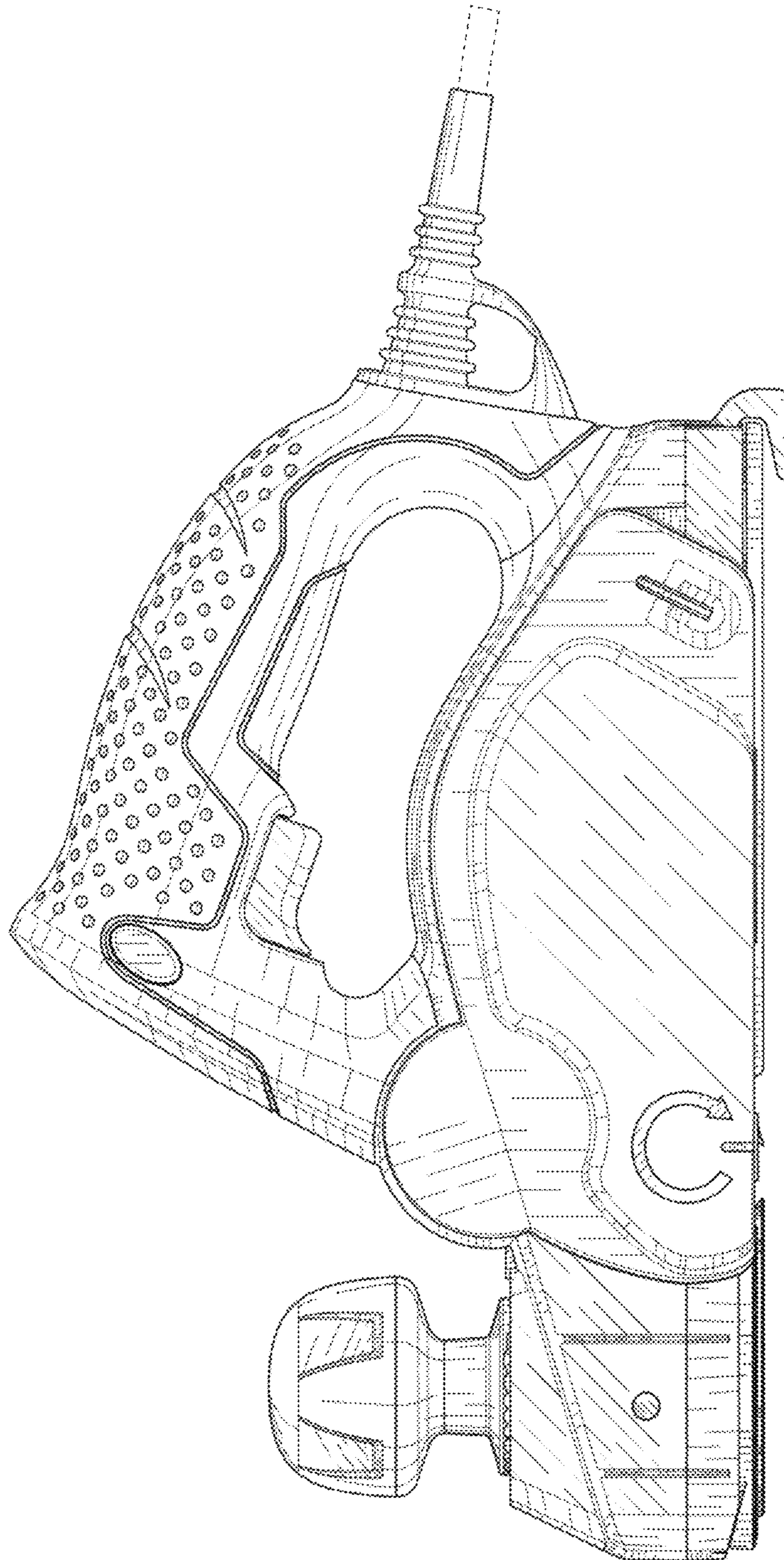

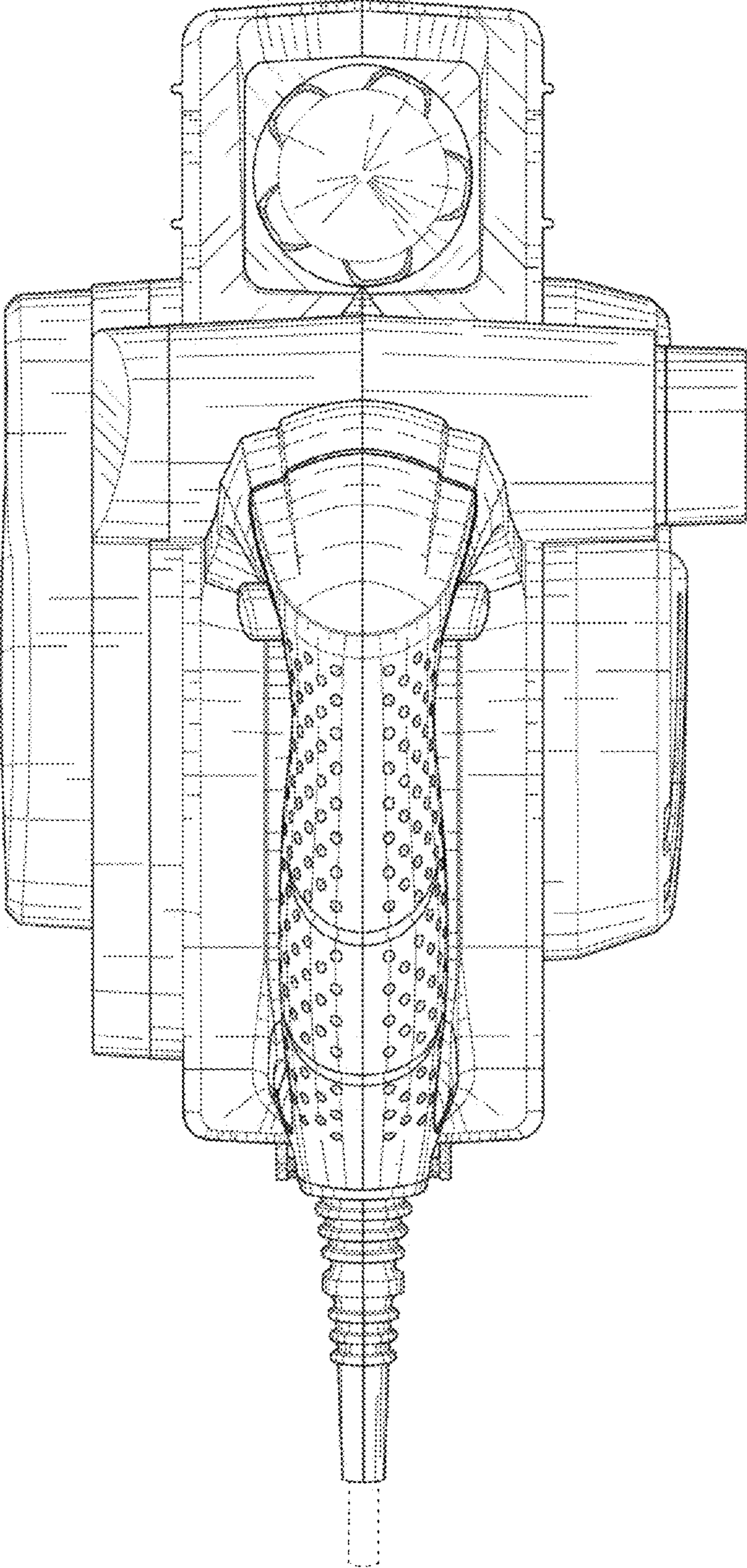

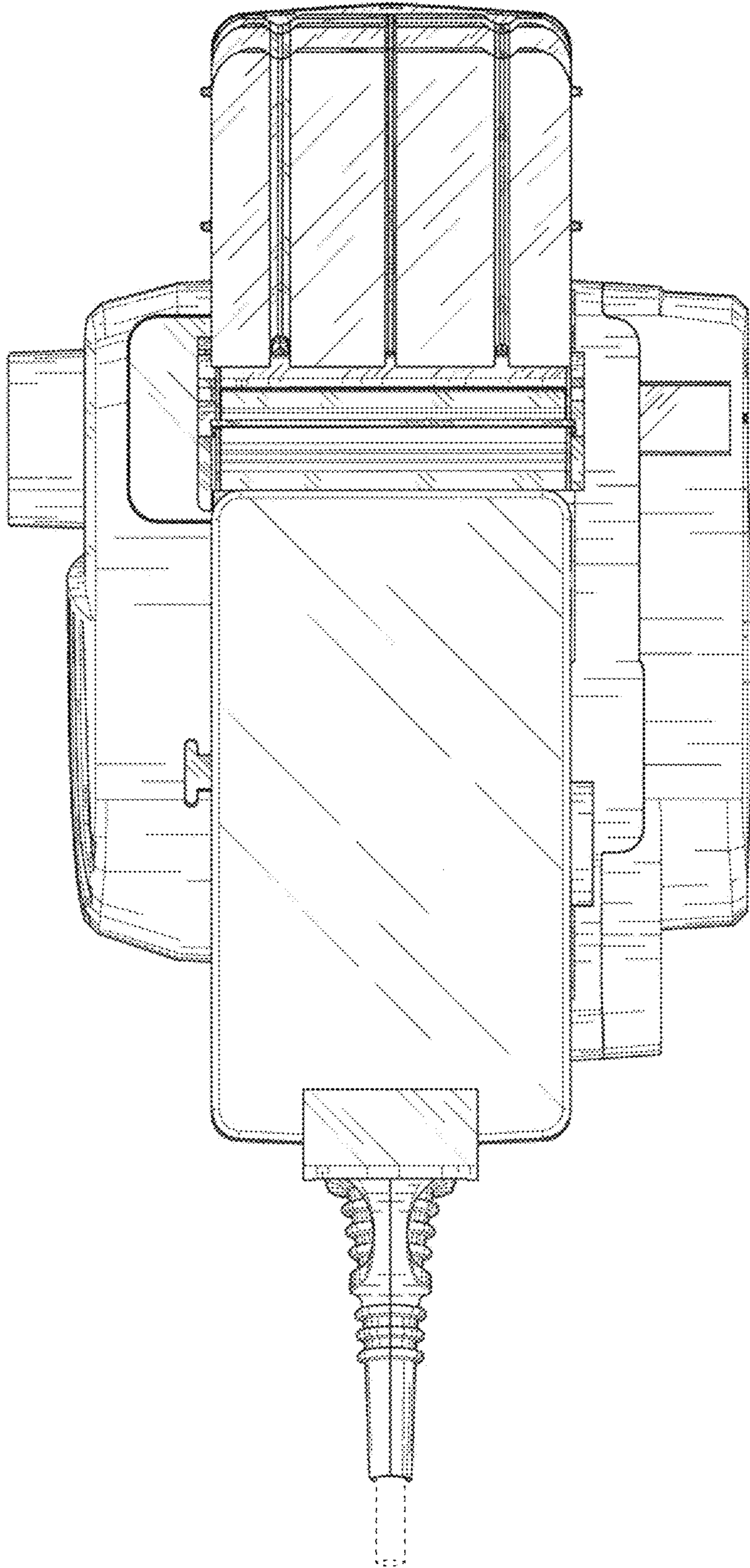

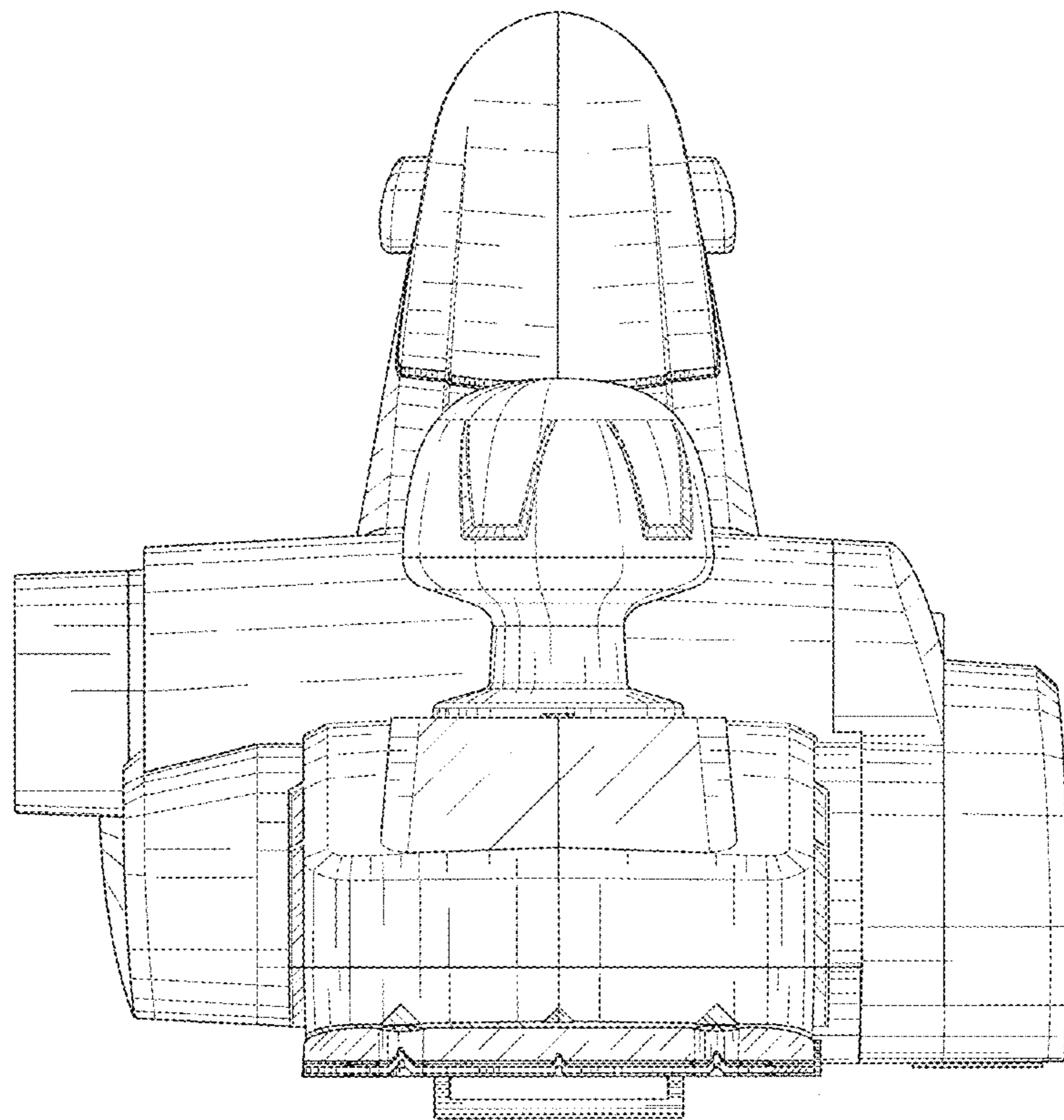

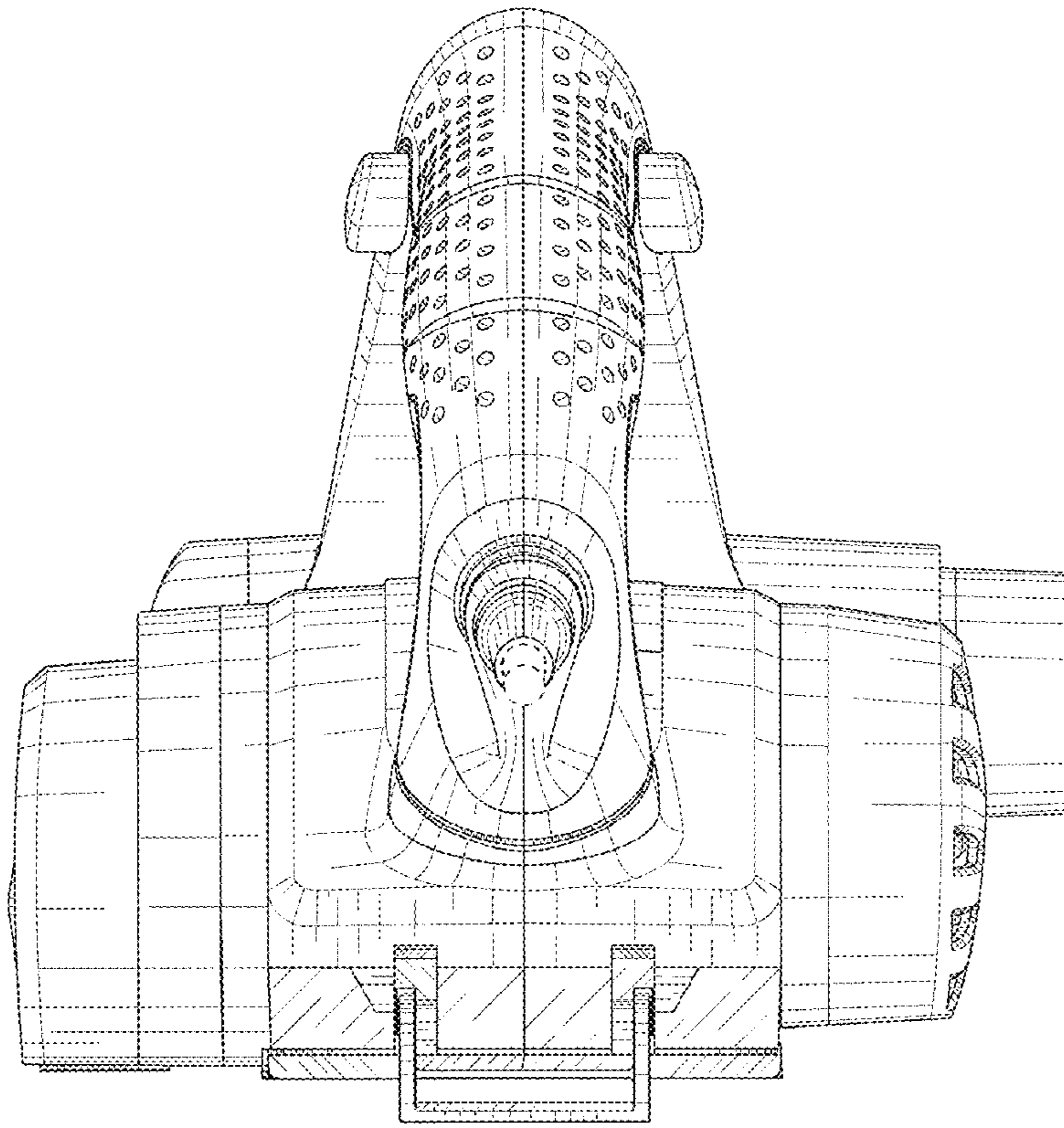
