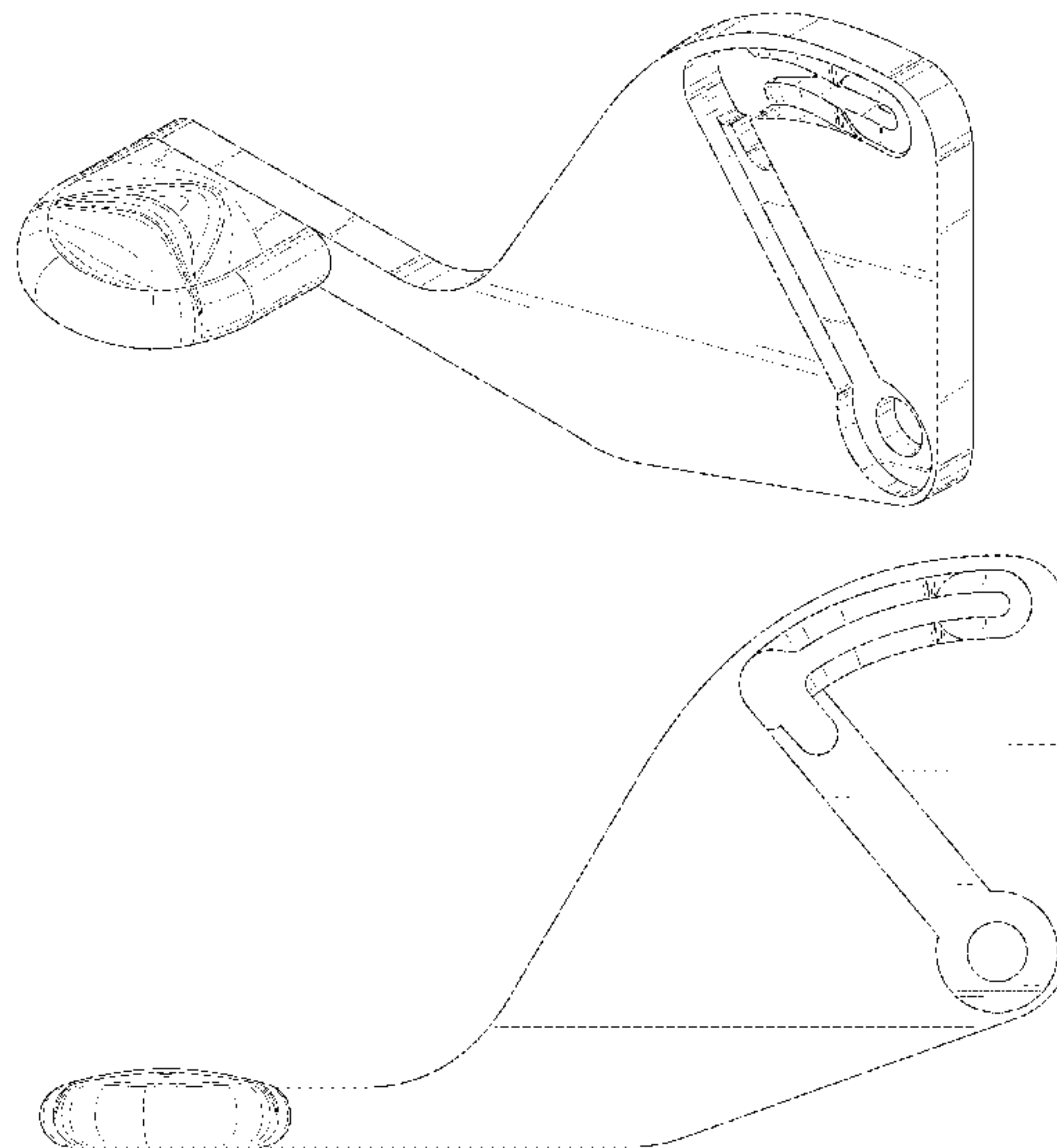
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, top, and right side perspective view of a door lever, showing the new design;
FIG. 2 is a front side elevational view thereof;
FIG. 3 is a rear side elevational view thereof;
FIG. 4 is a left side elevational view thereof.
FIG. 5 is a right side elevational view thereof; and

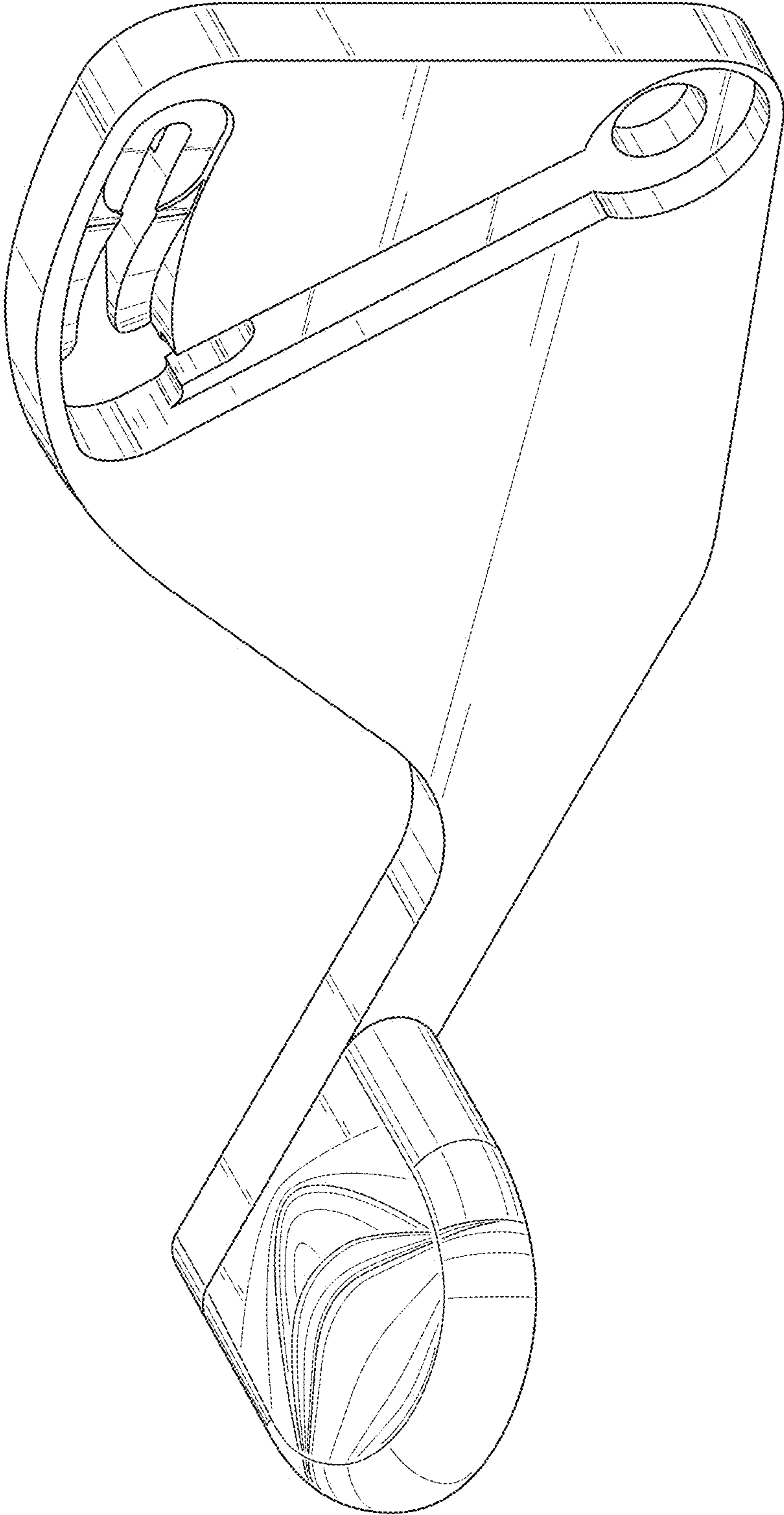

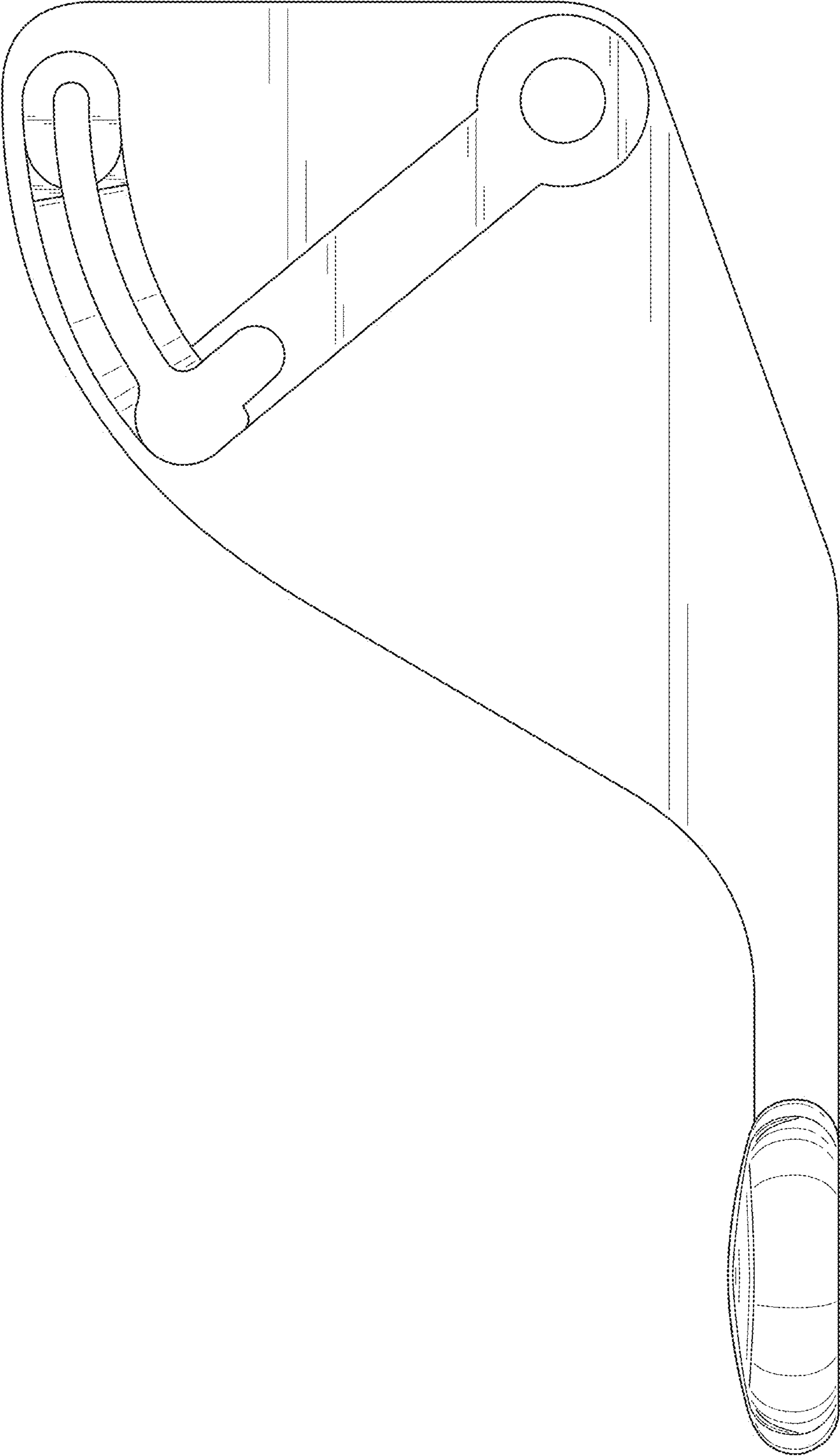

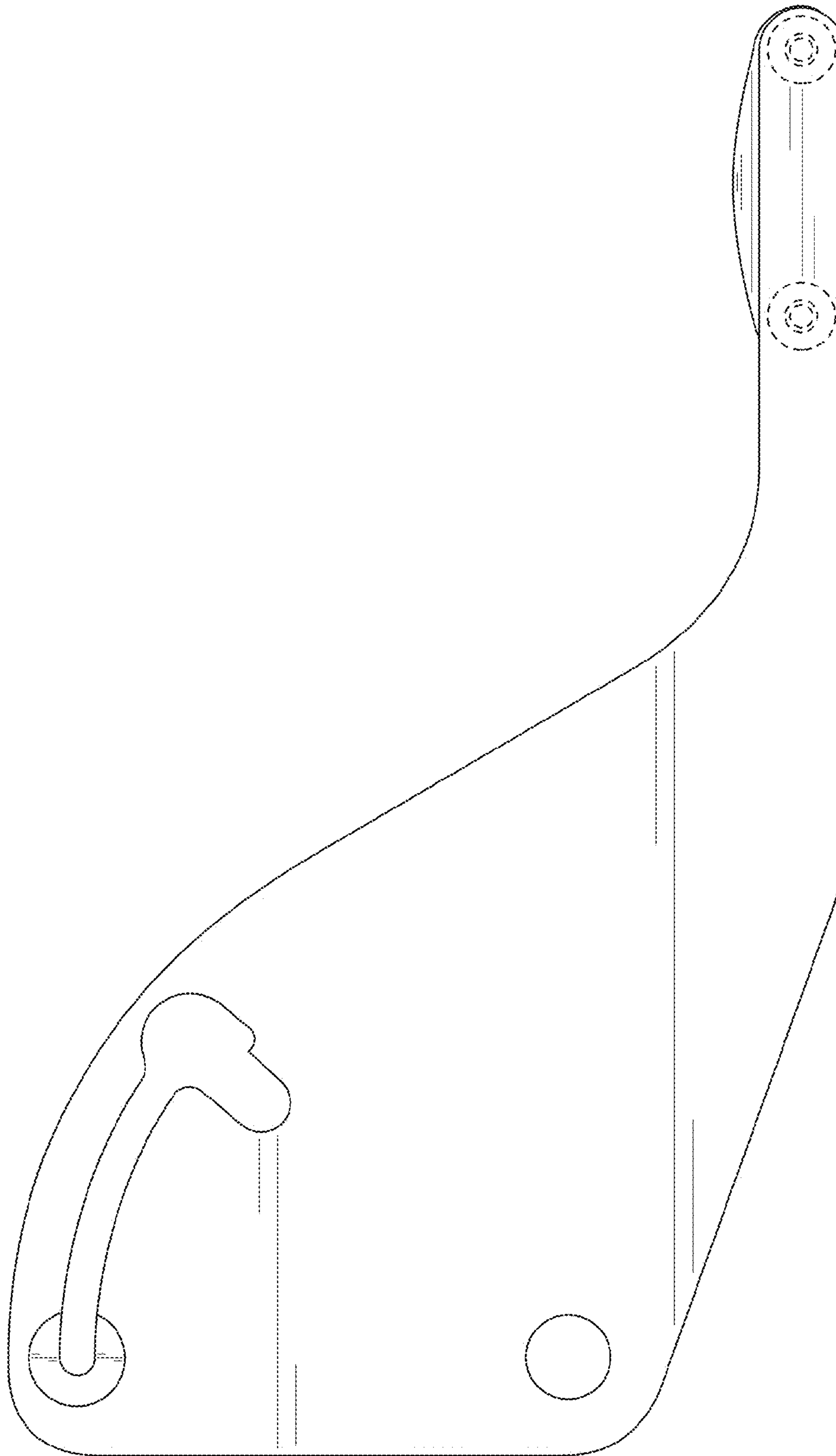

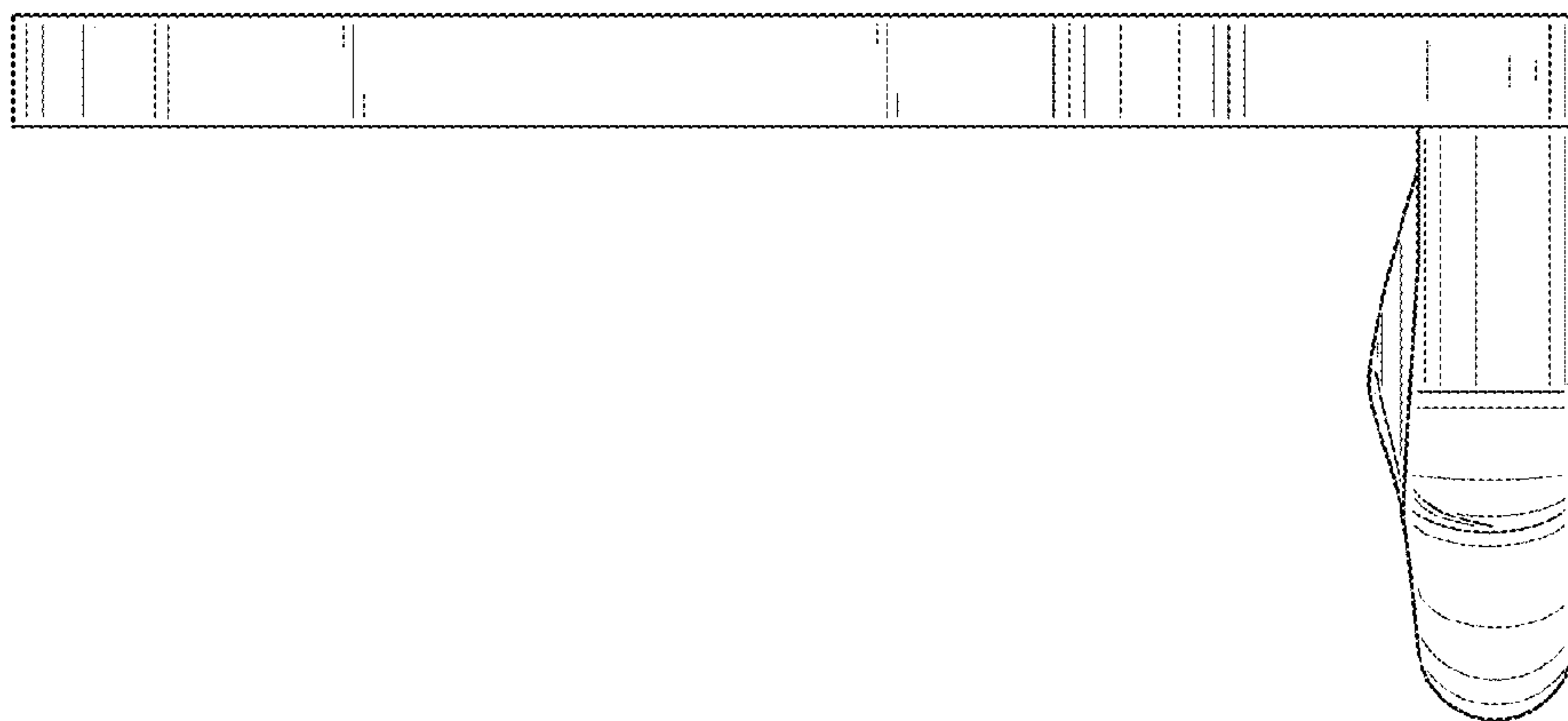

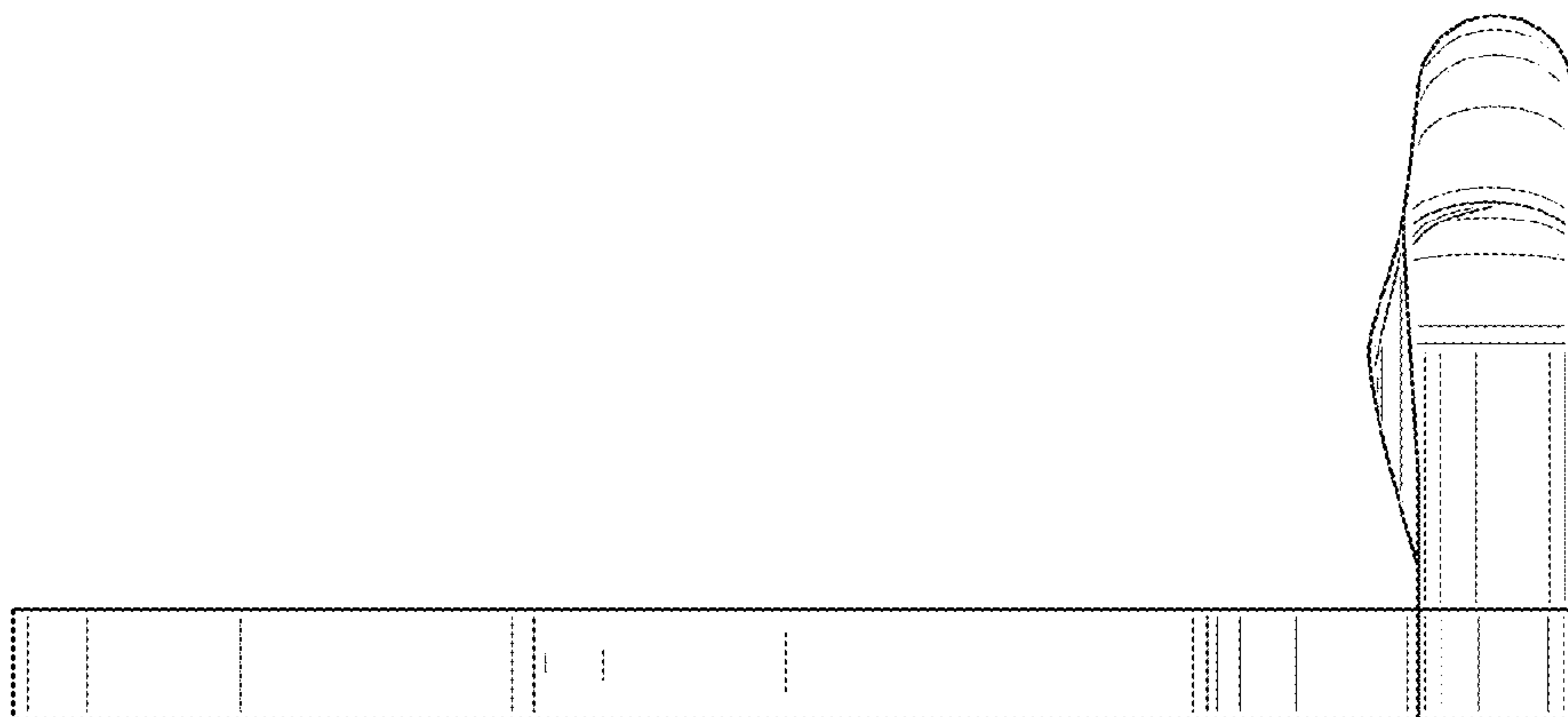

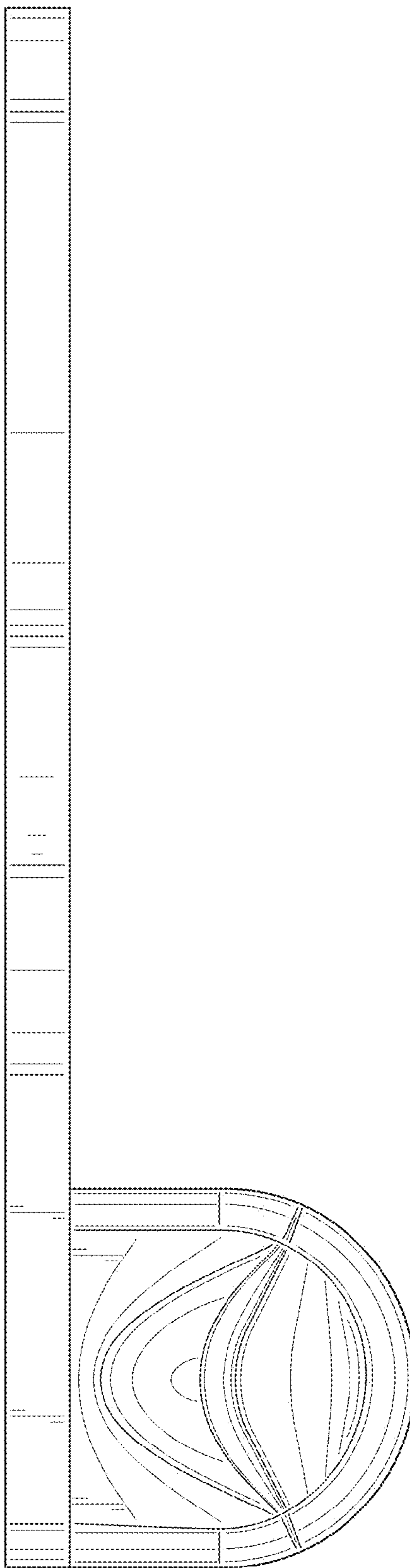
