**DESCRIPTION**

FIG. 4 is a front elevation view of the claimed design of FIG. 1;

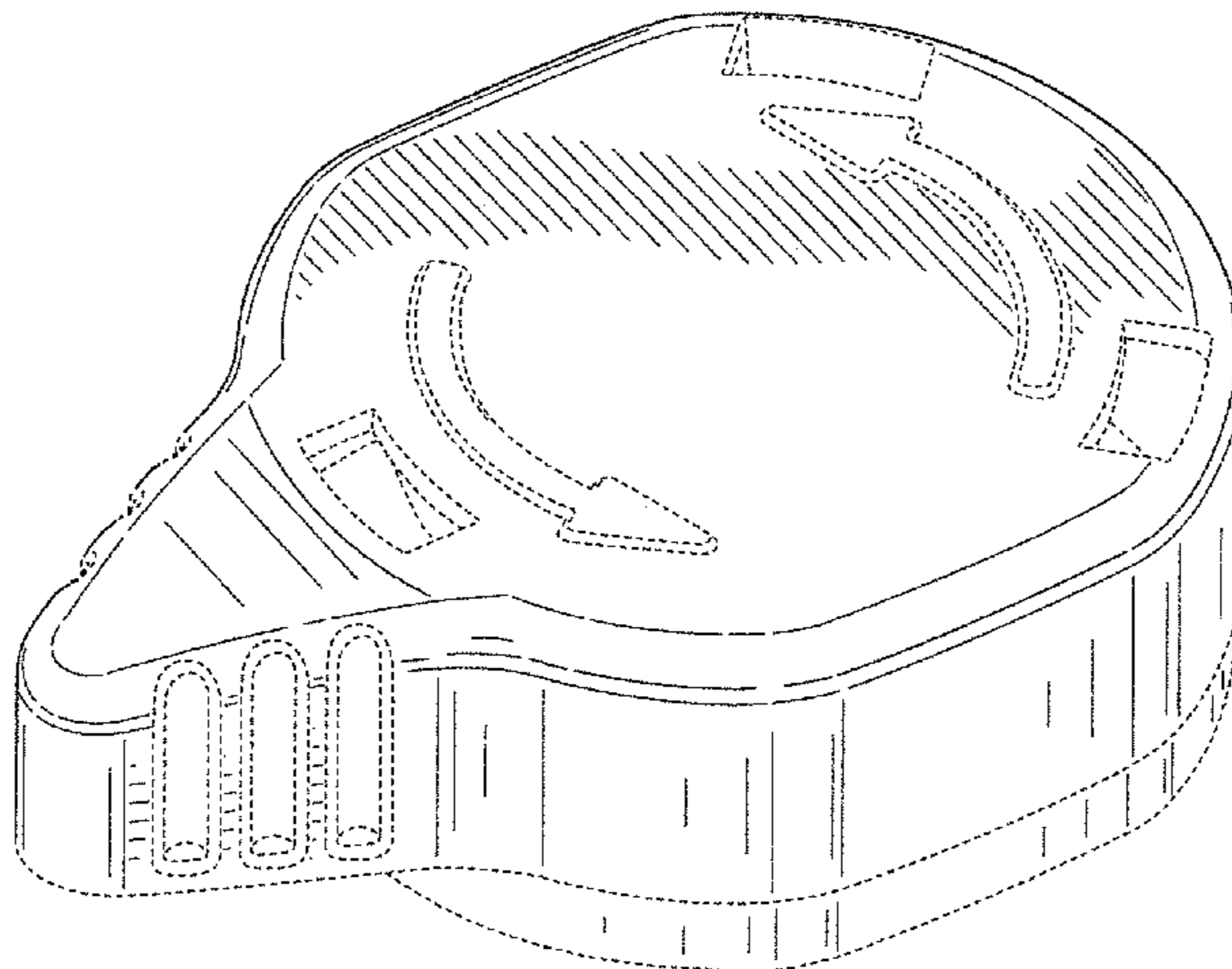
FIG. 5 is a rear elevation view of the claimed design of FIG. 1;

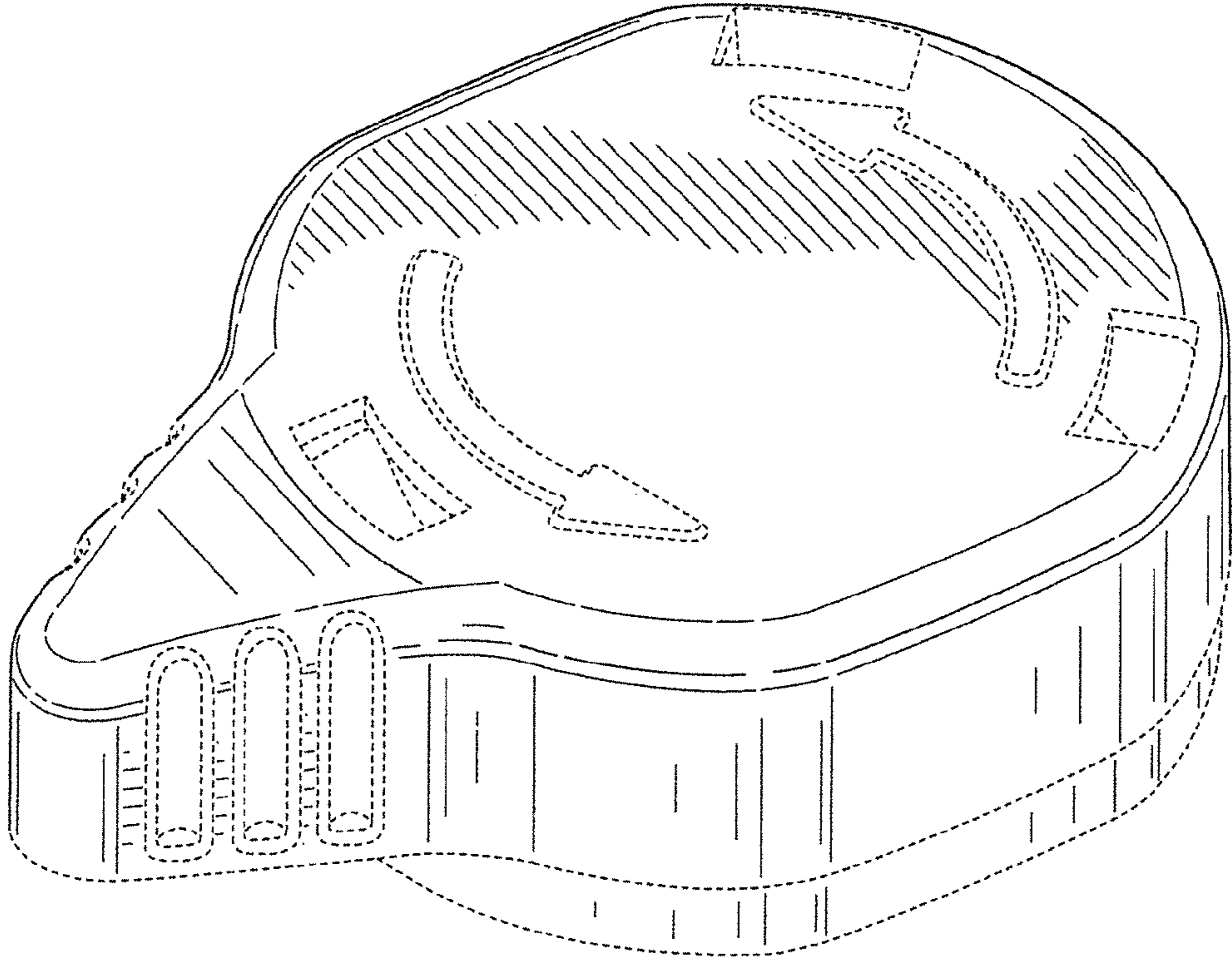

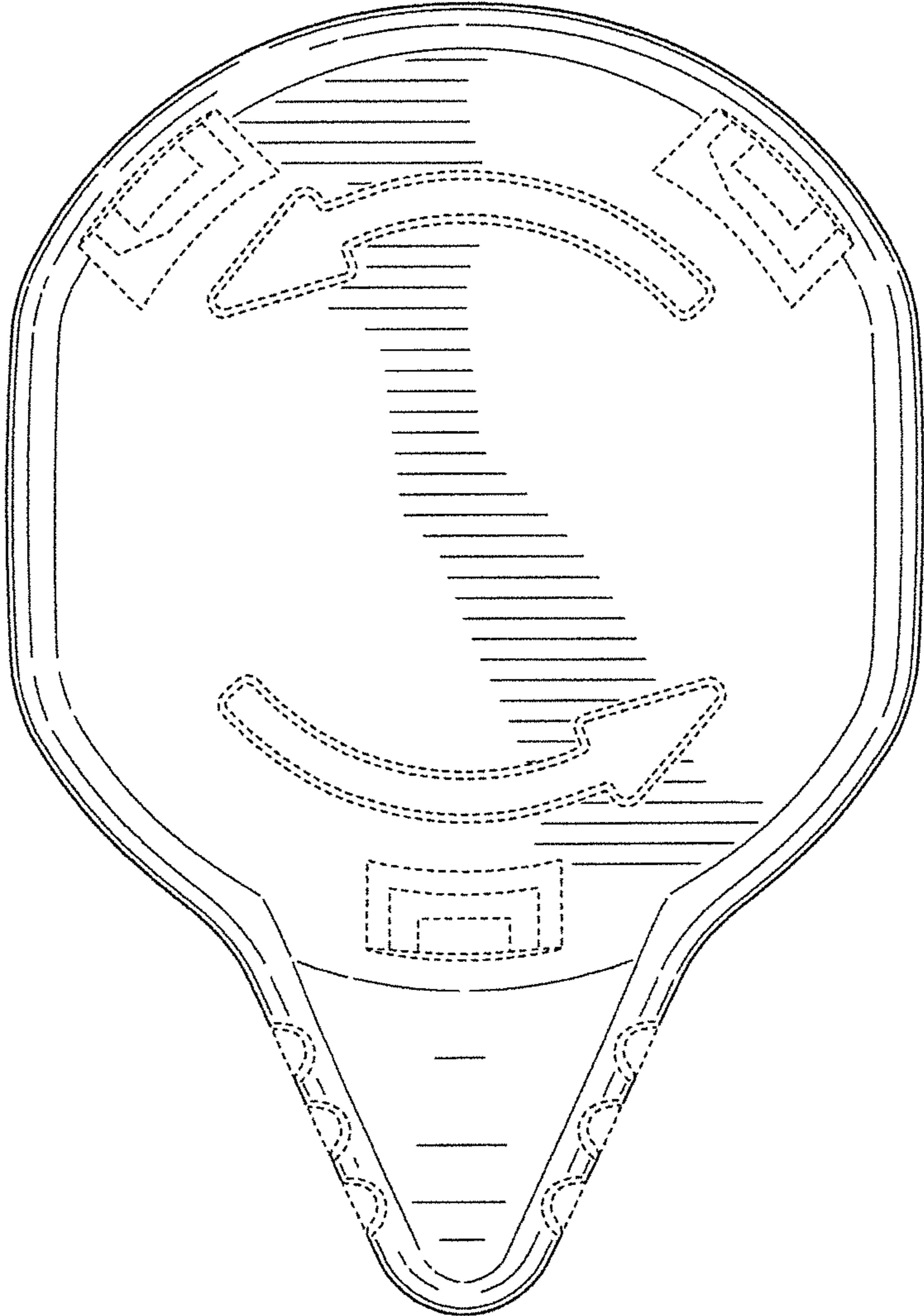

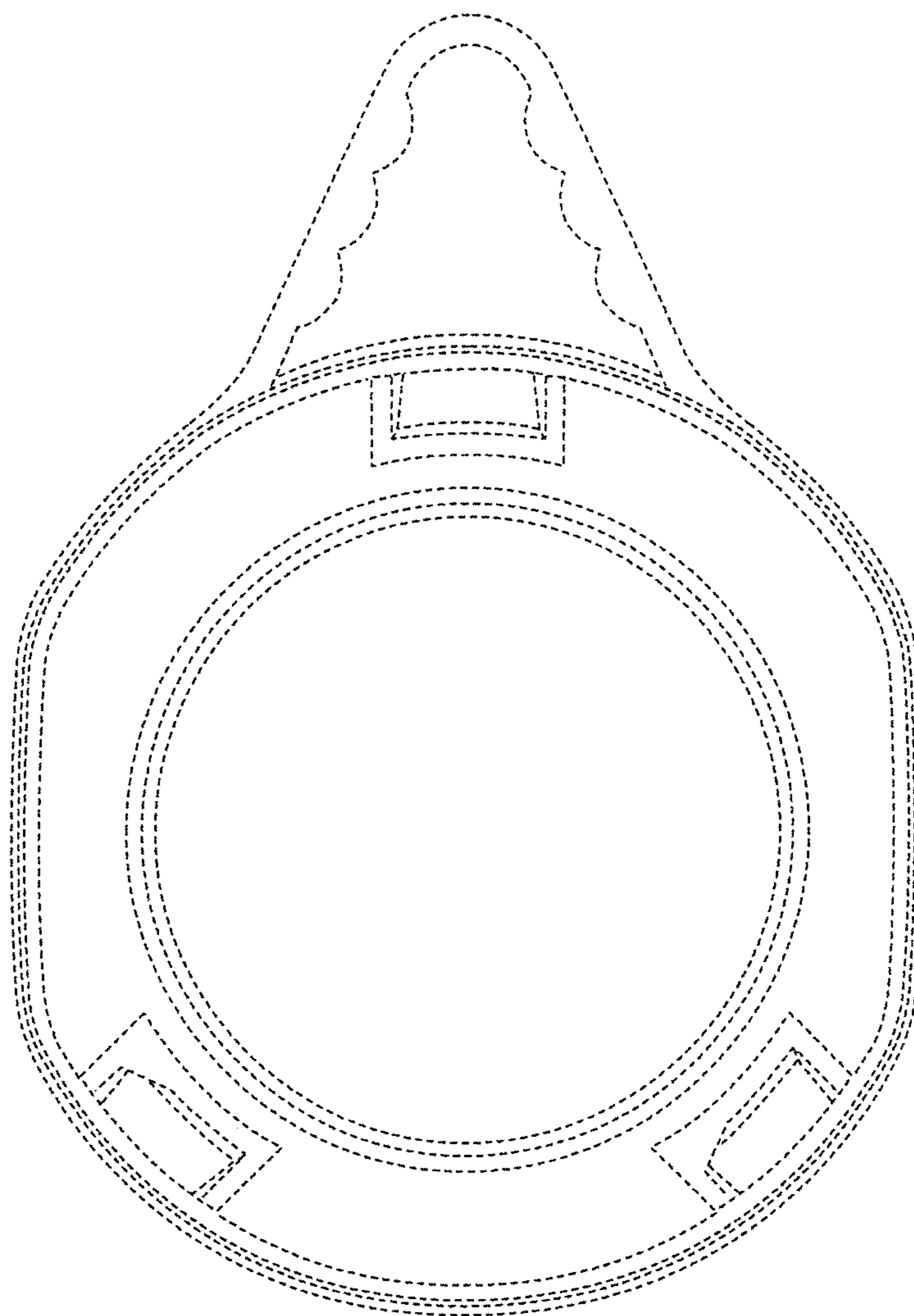

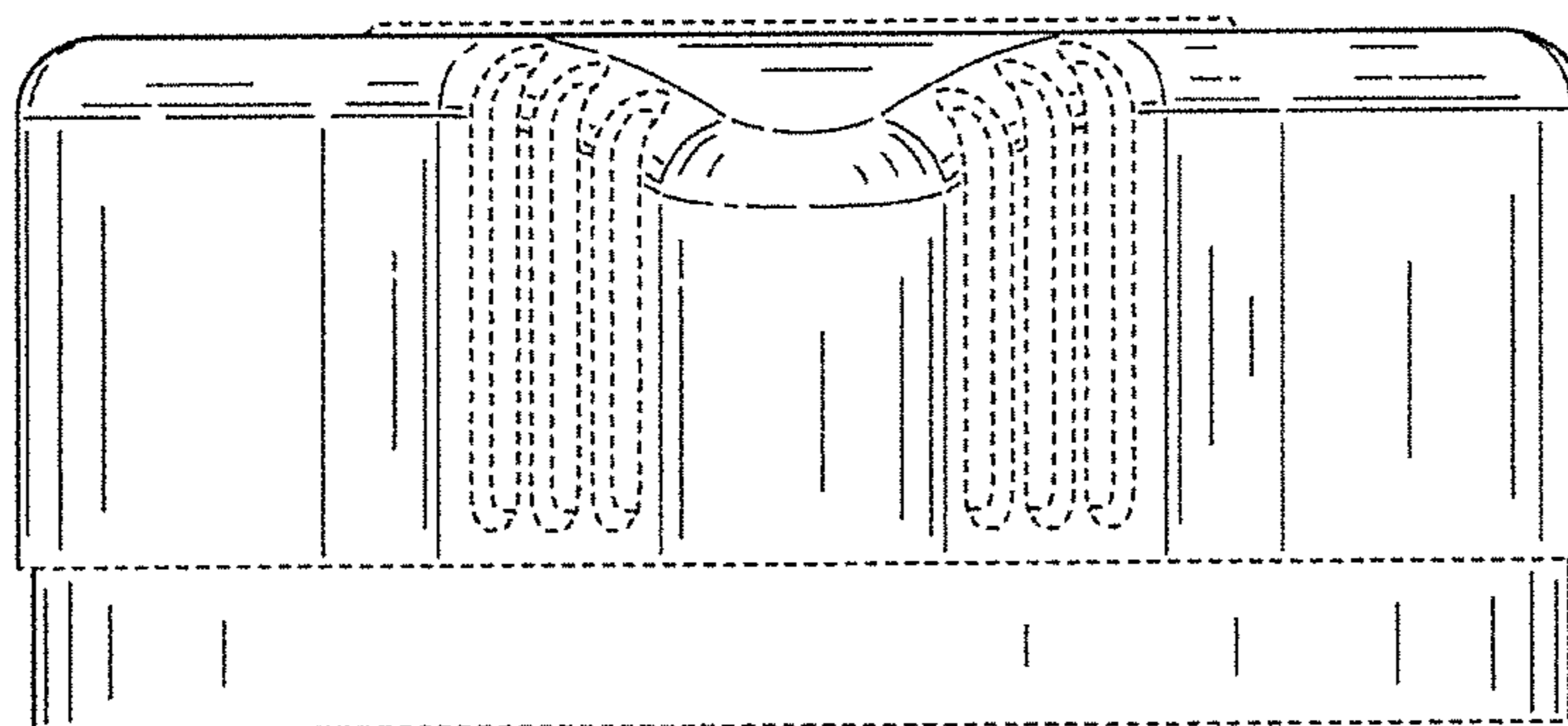

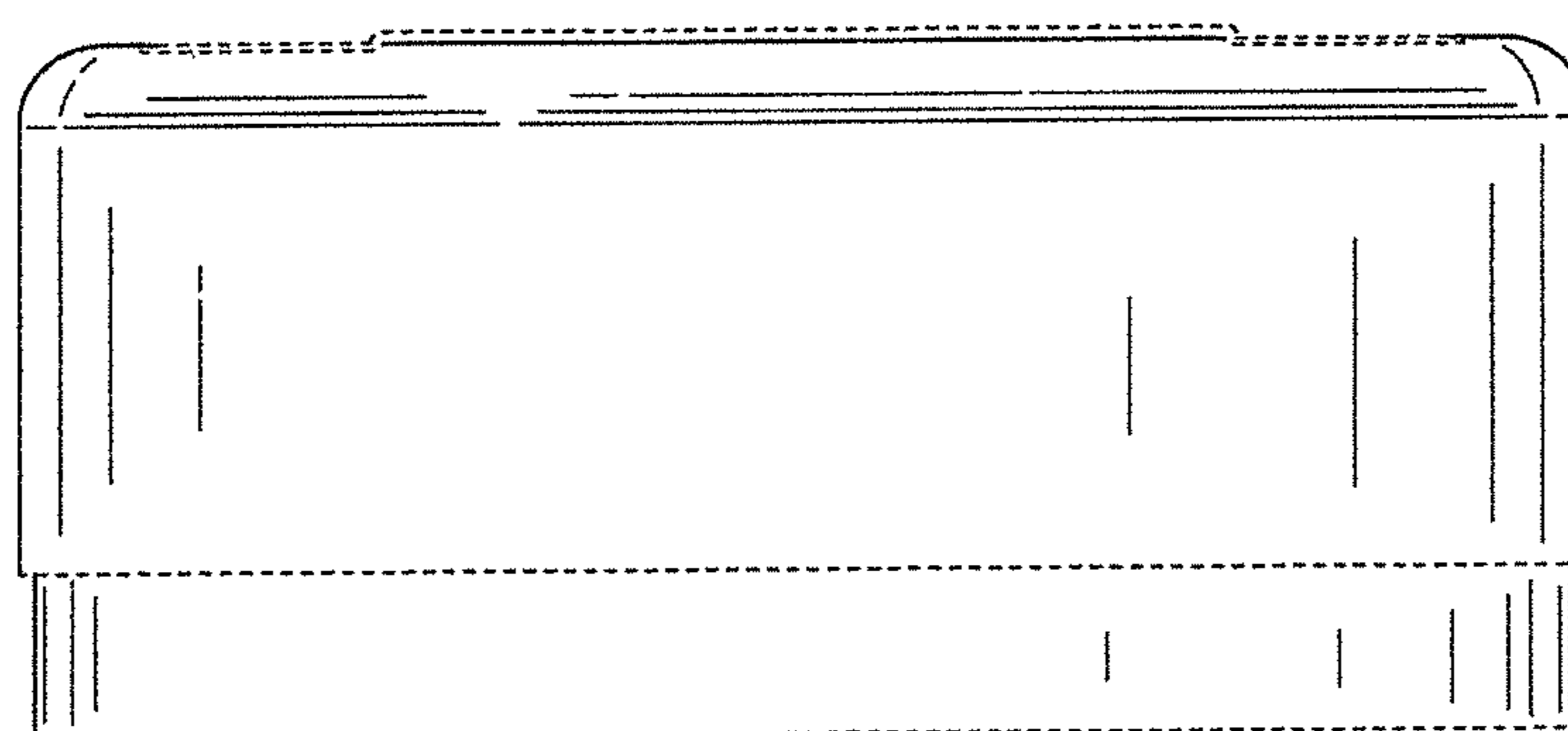

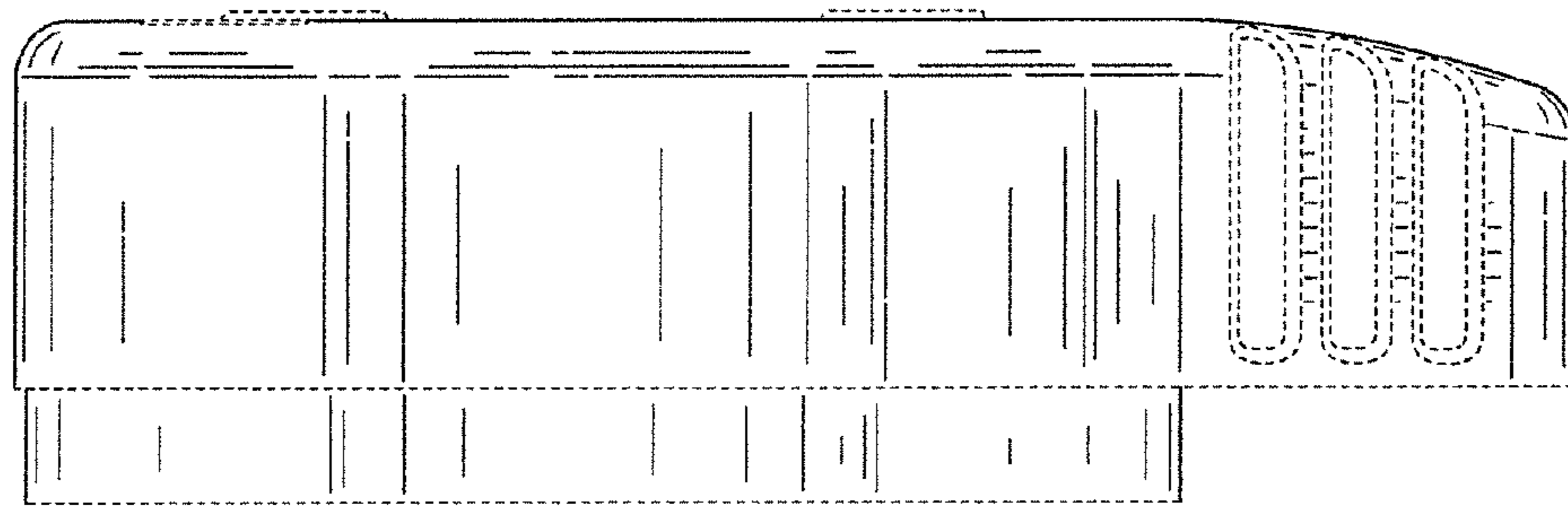

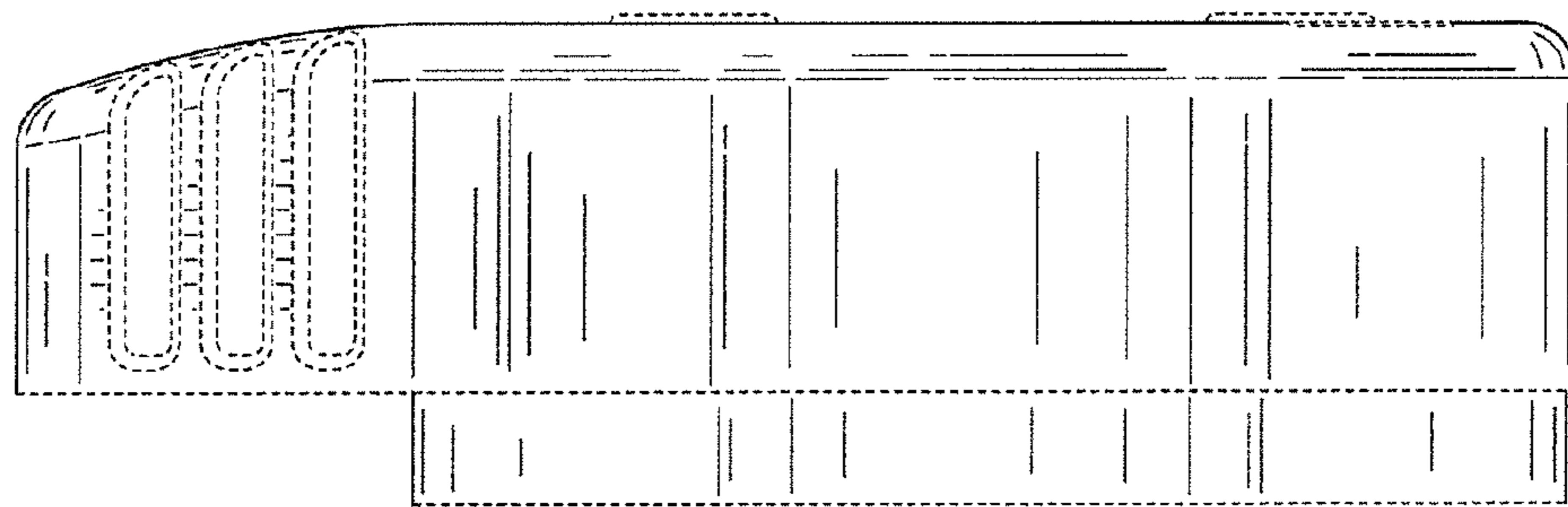
