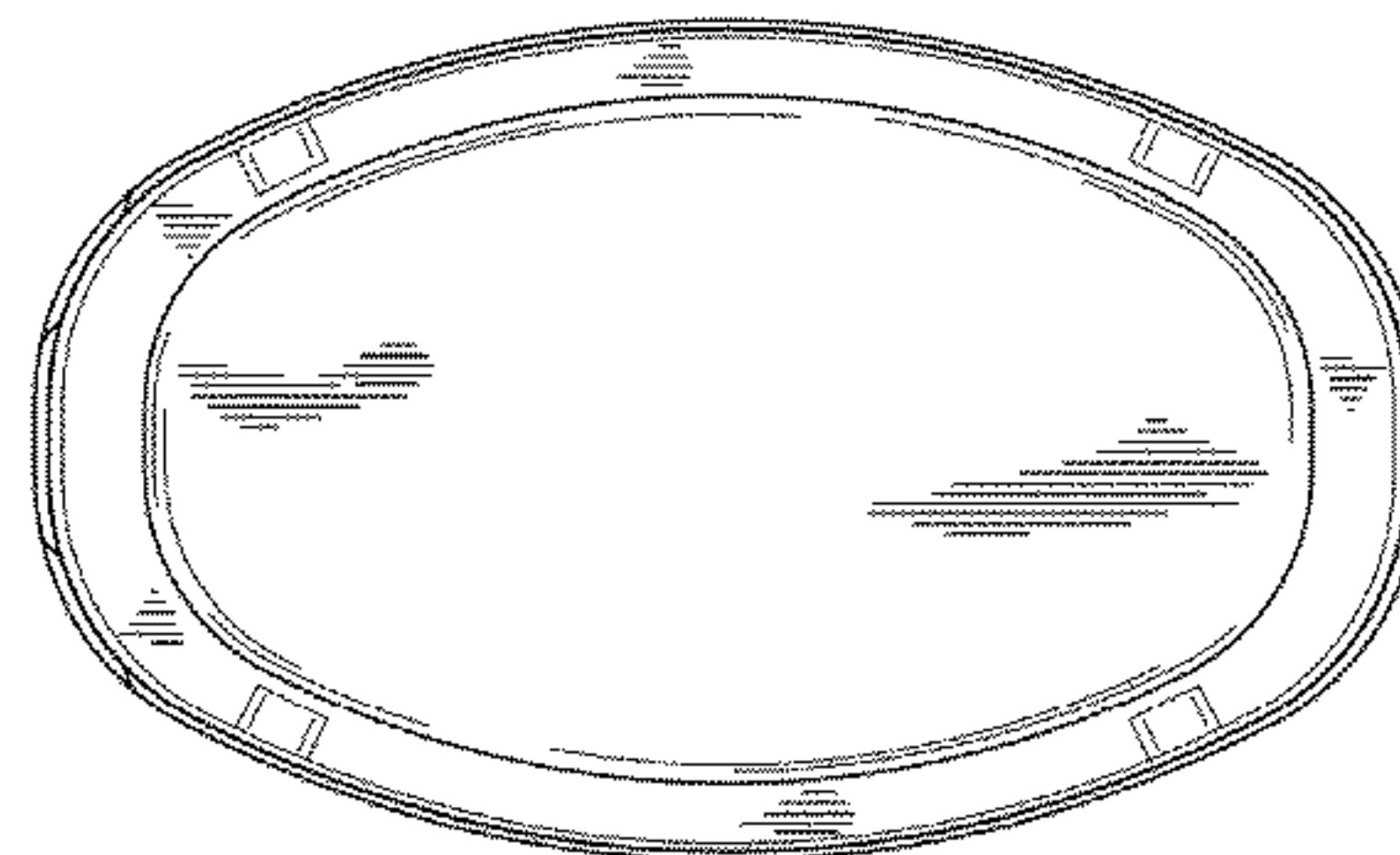
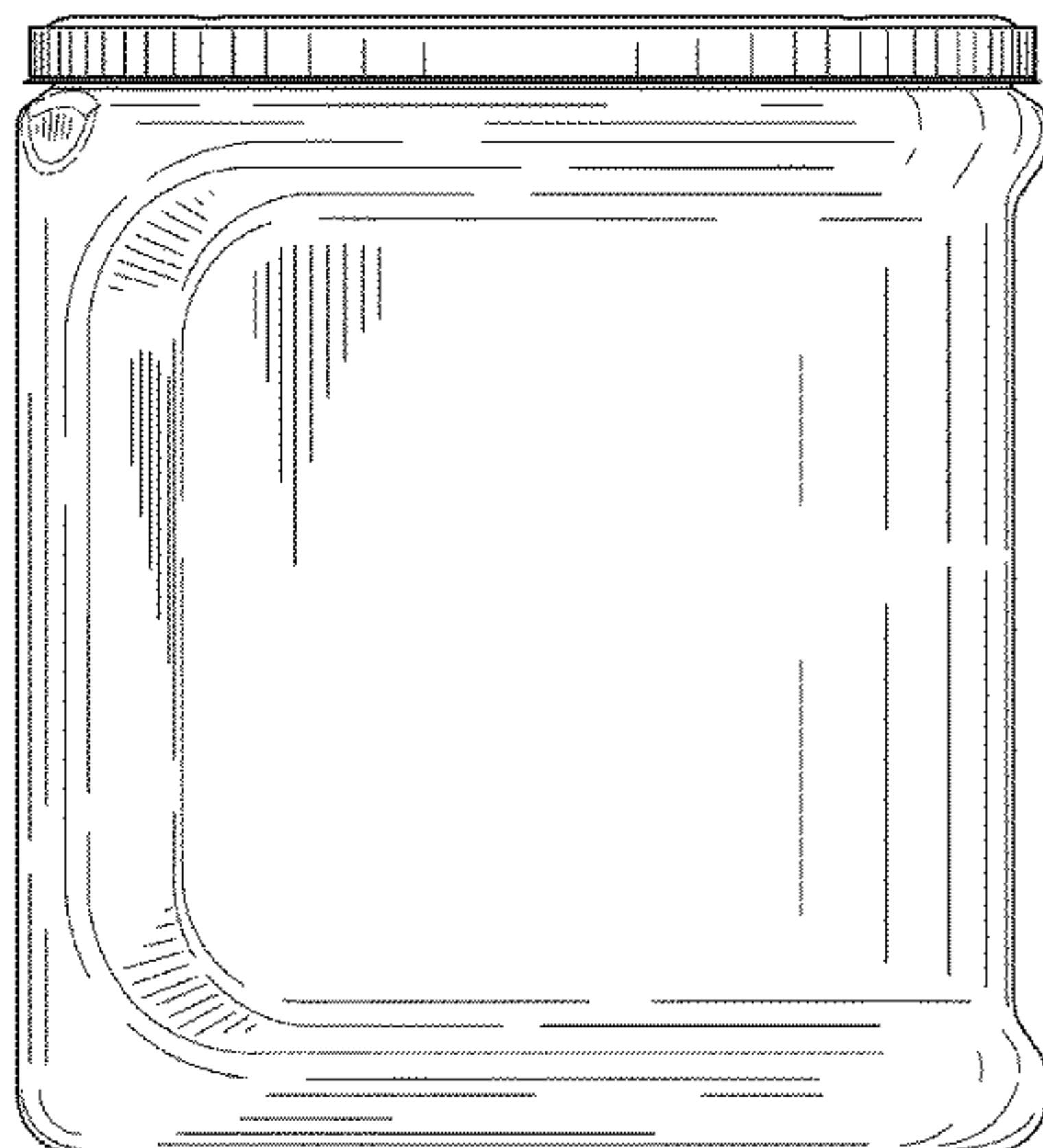
We claim the ornamental design for a container, as shown and described.

DESCRIPTION

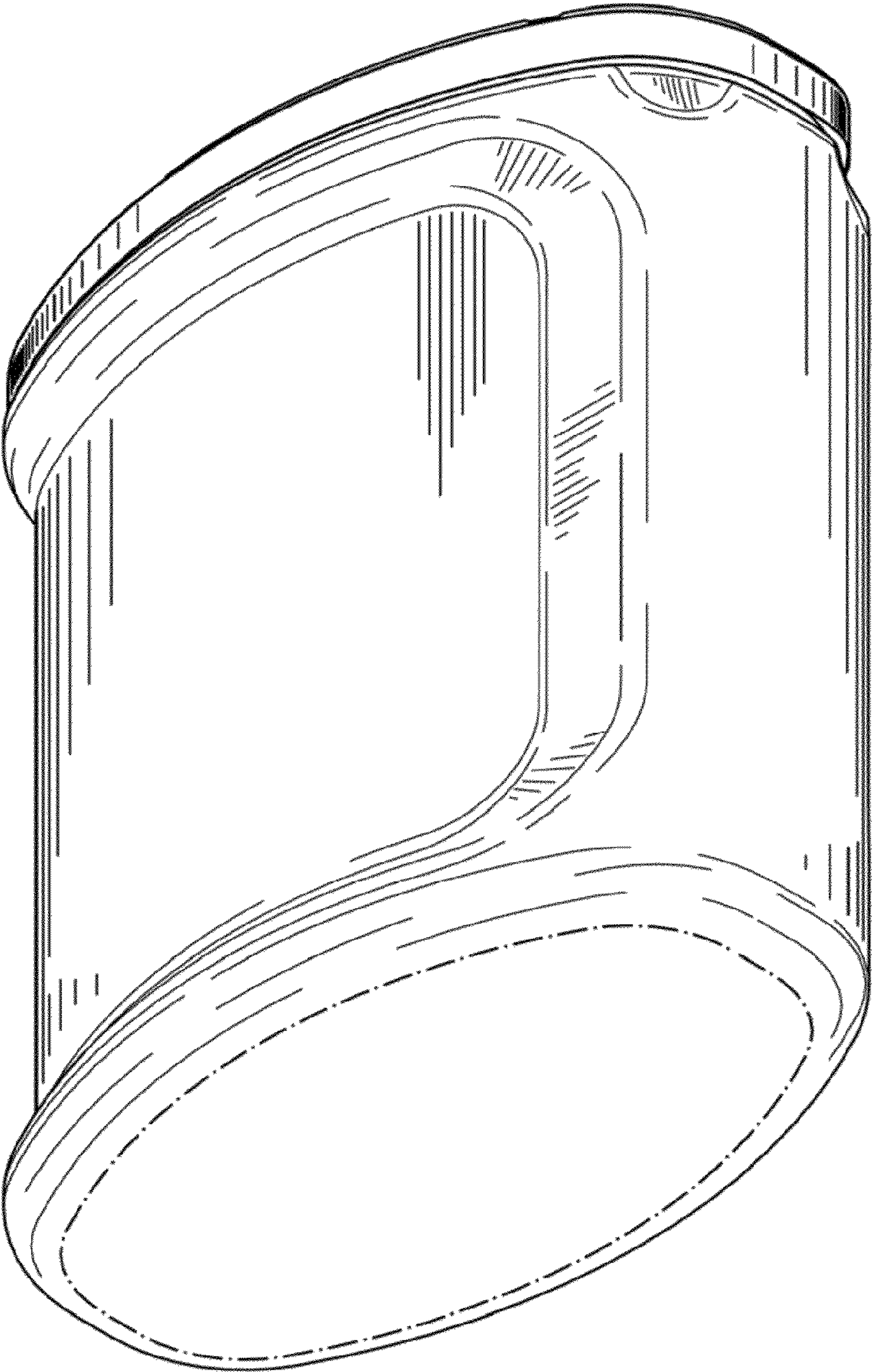

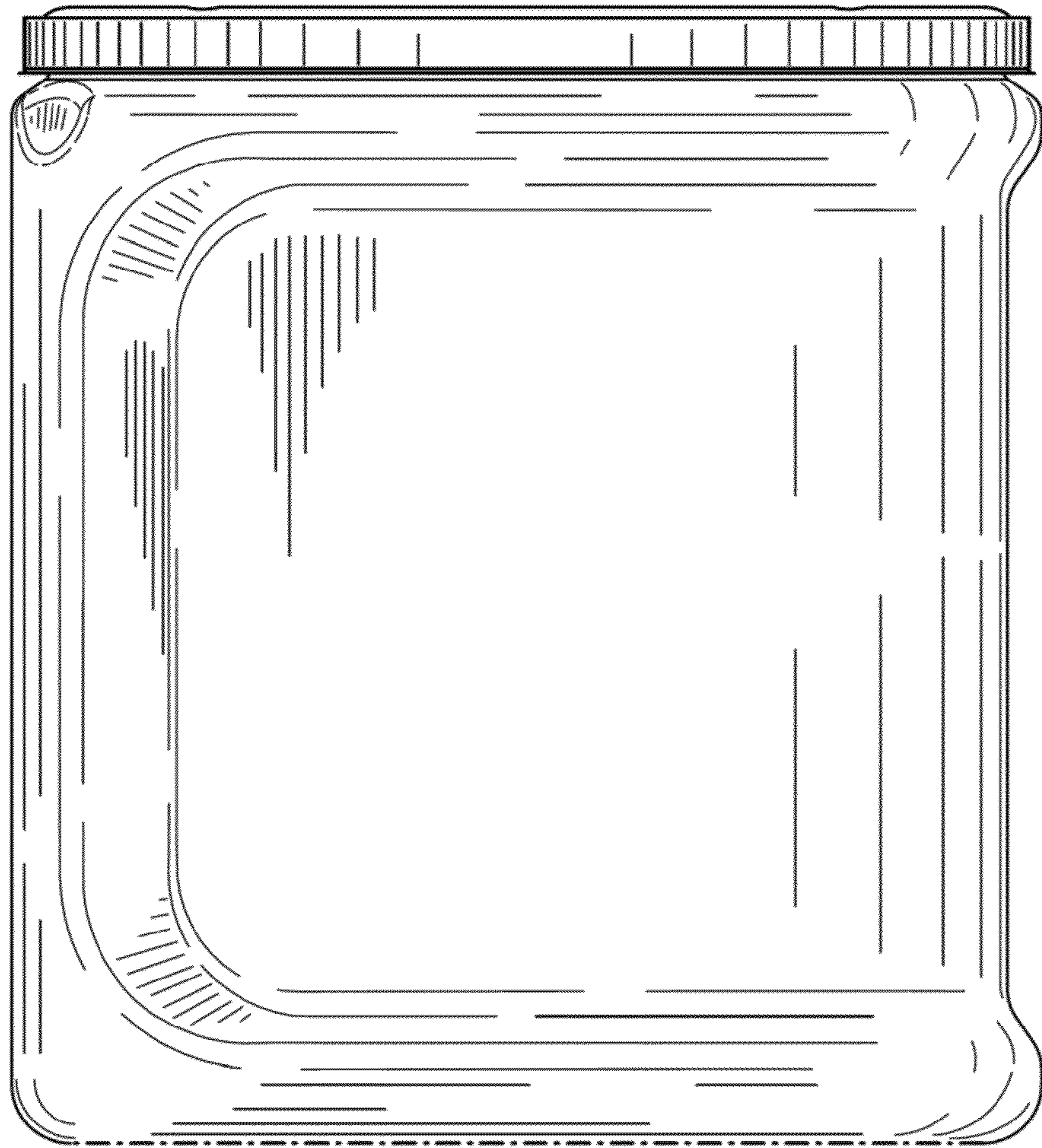

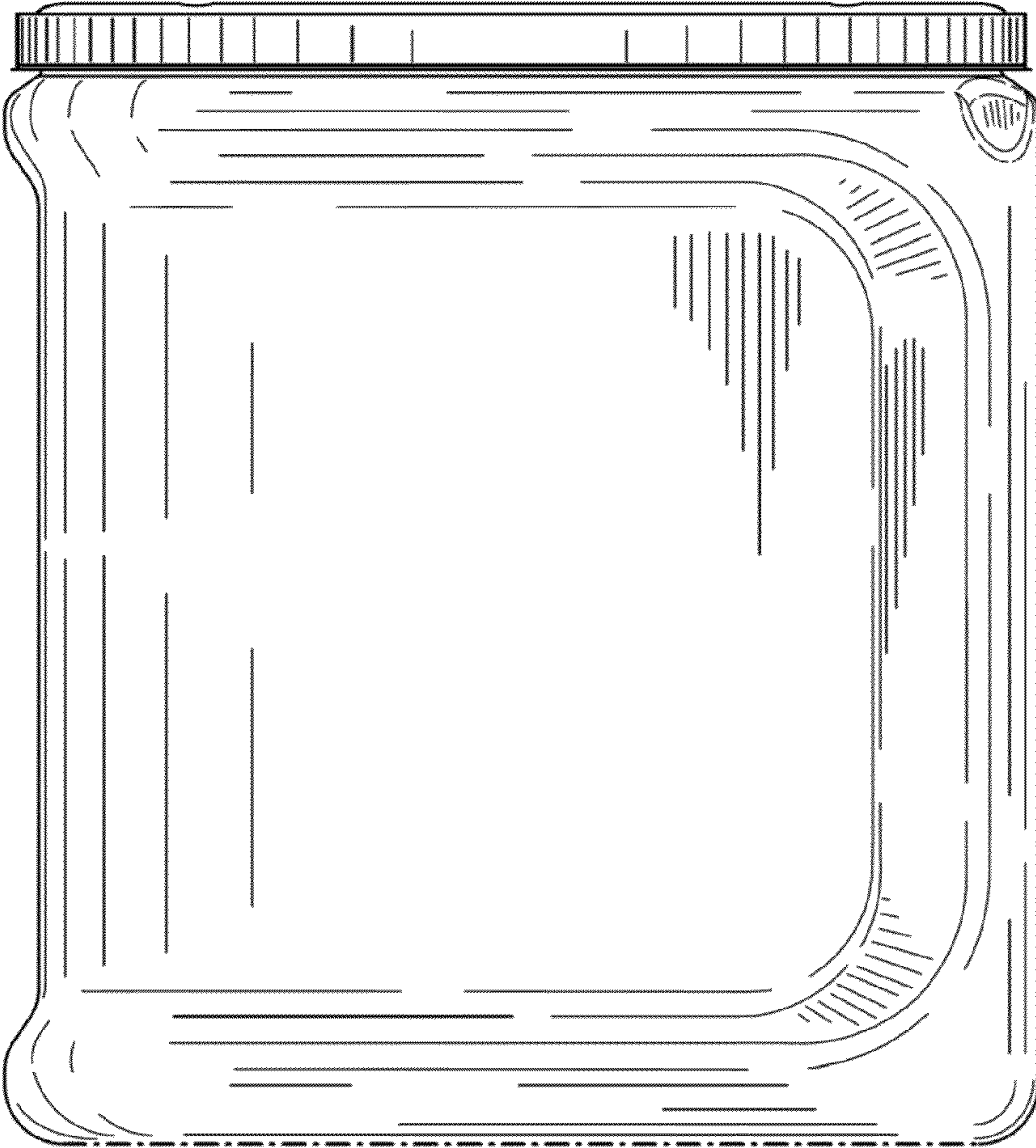

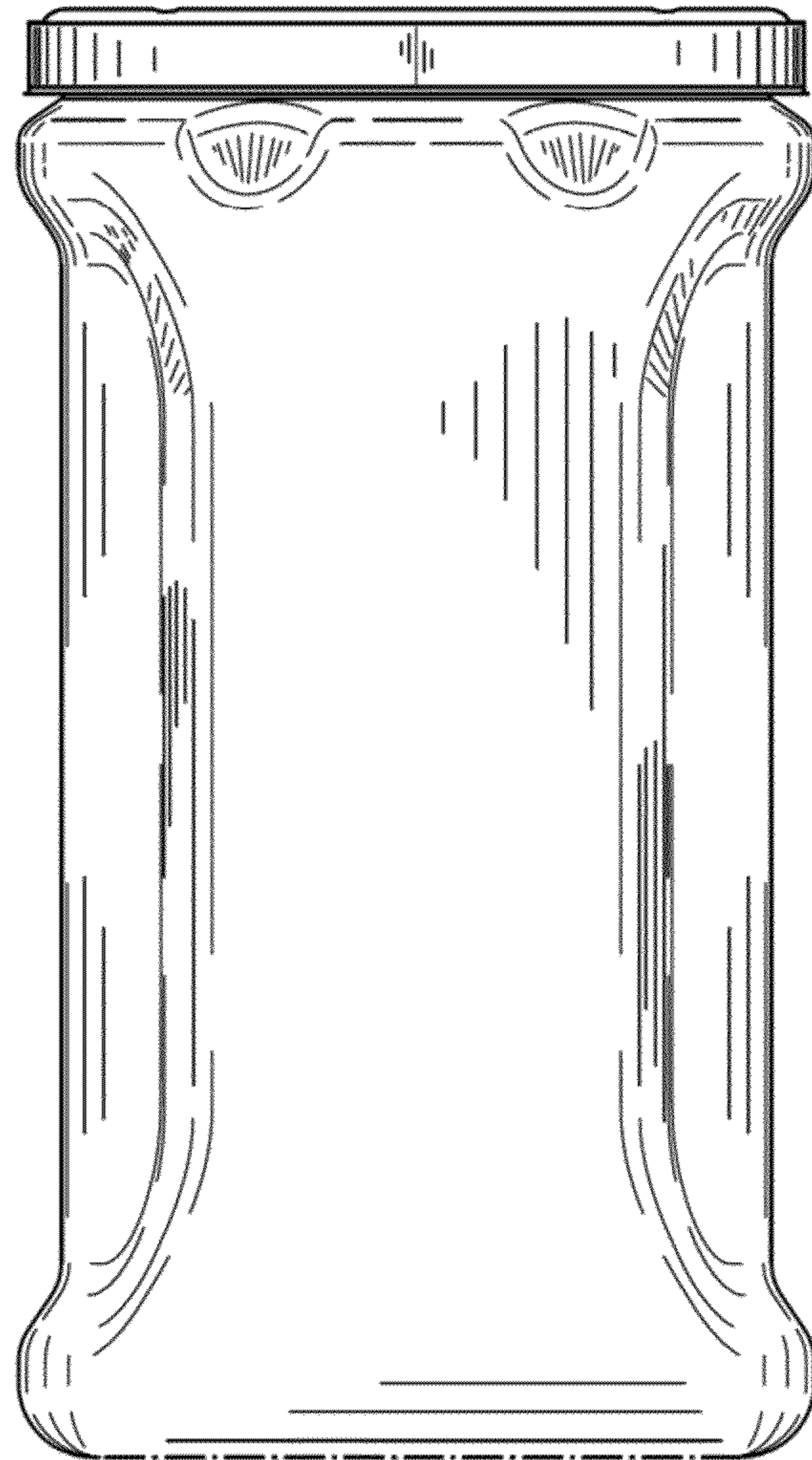

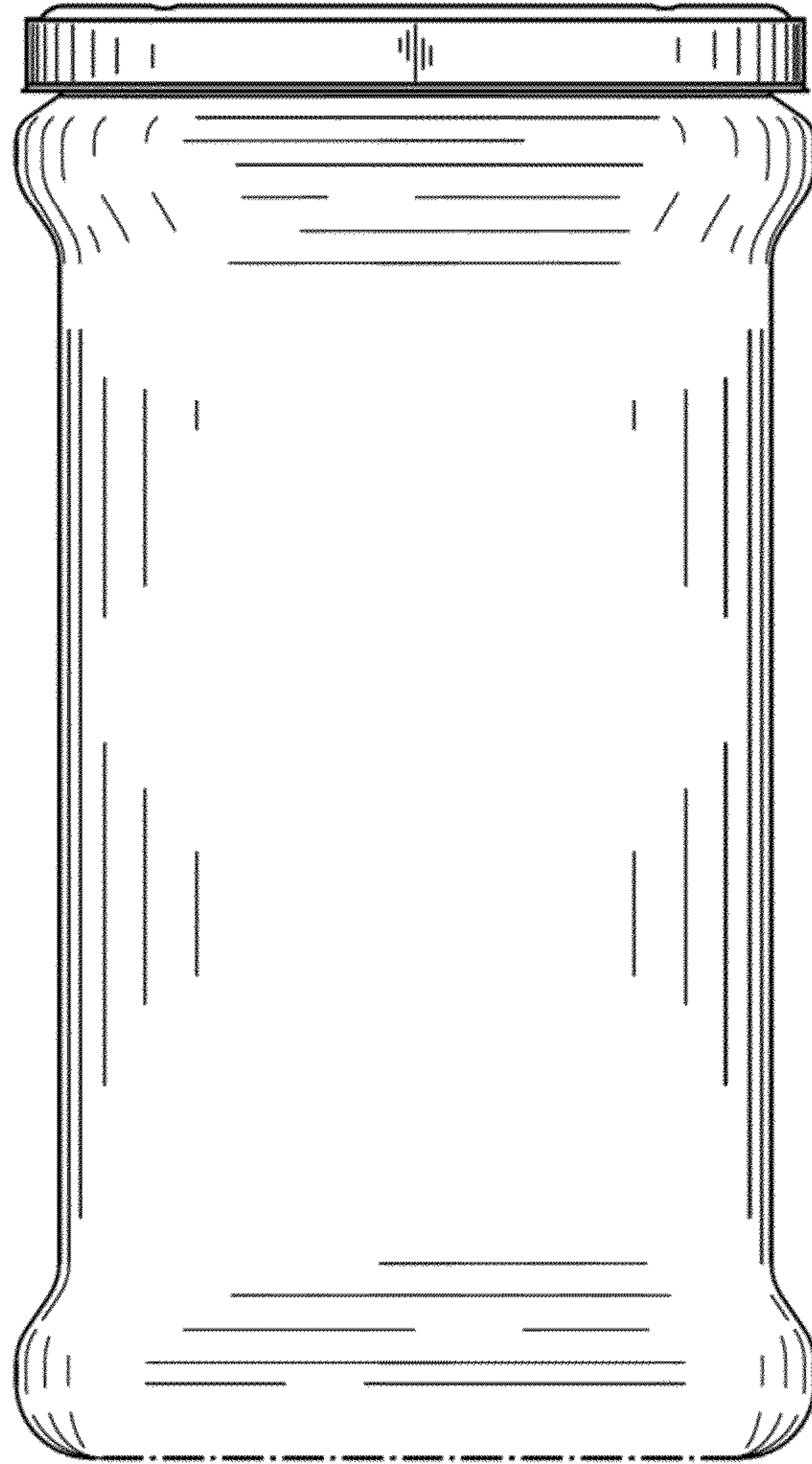

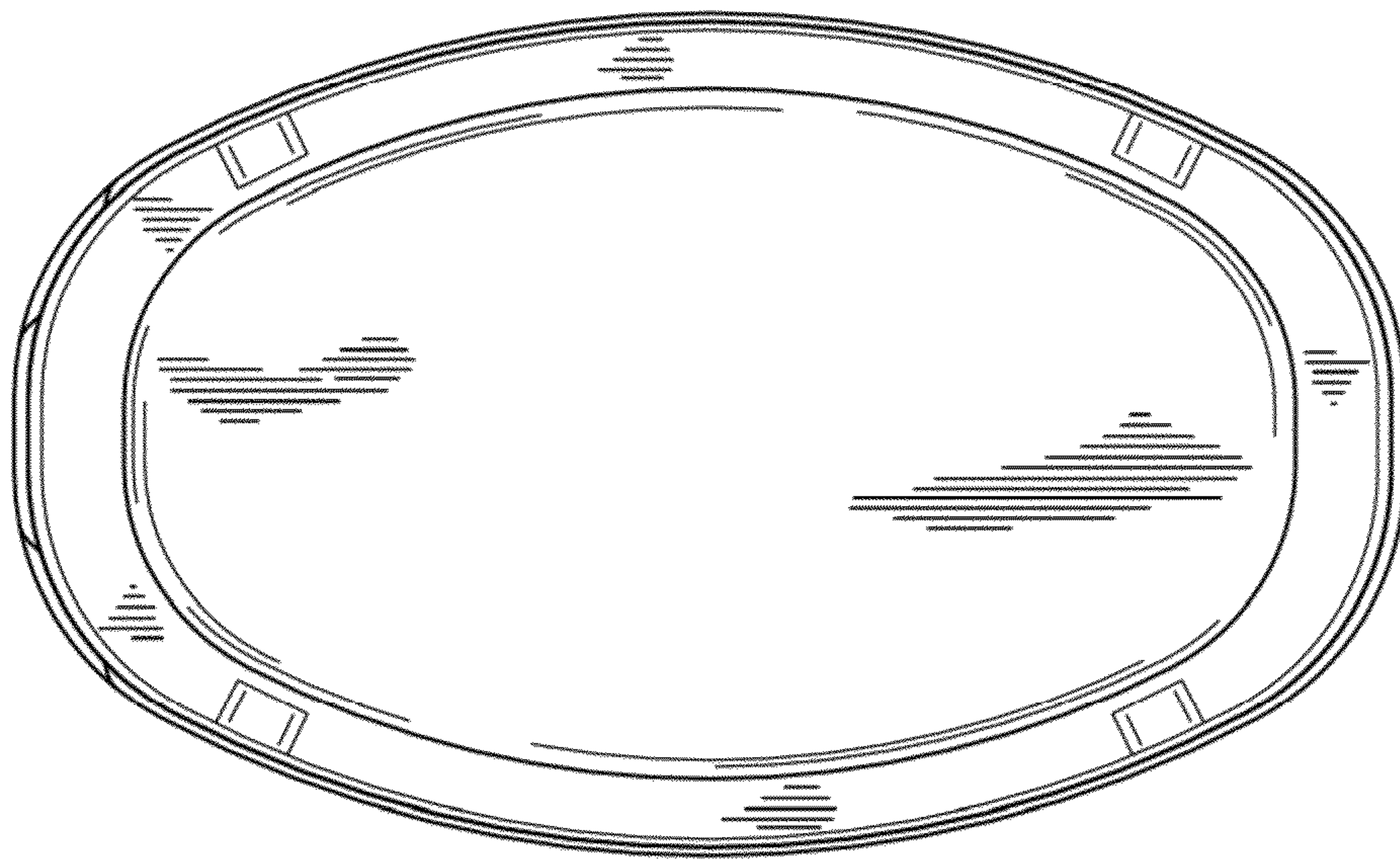

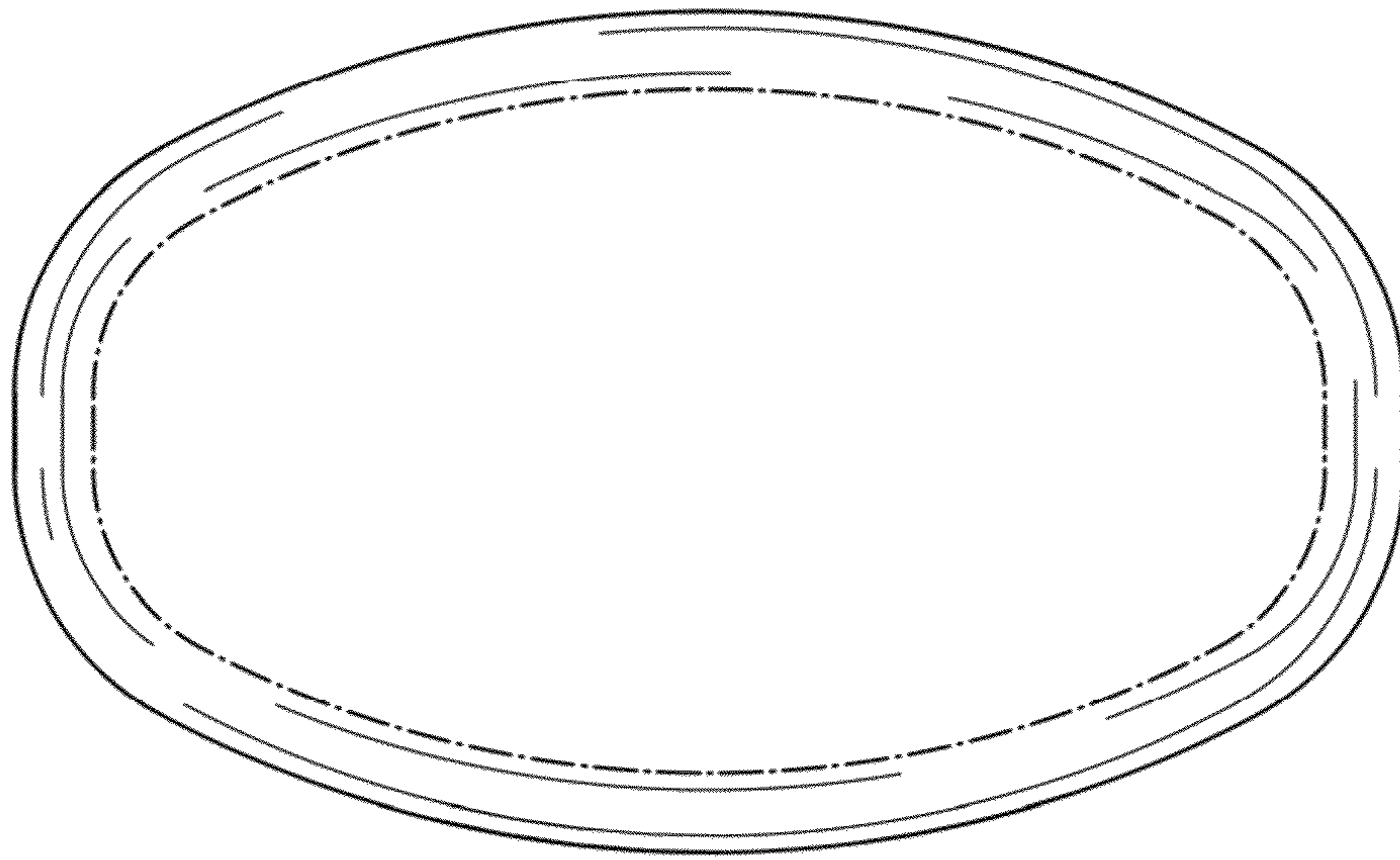

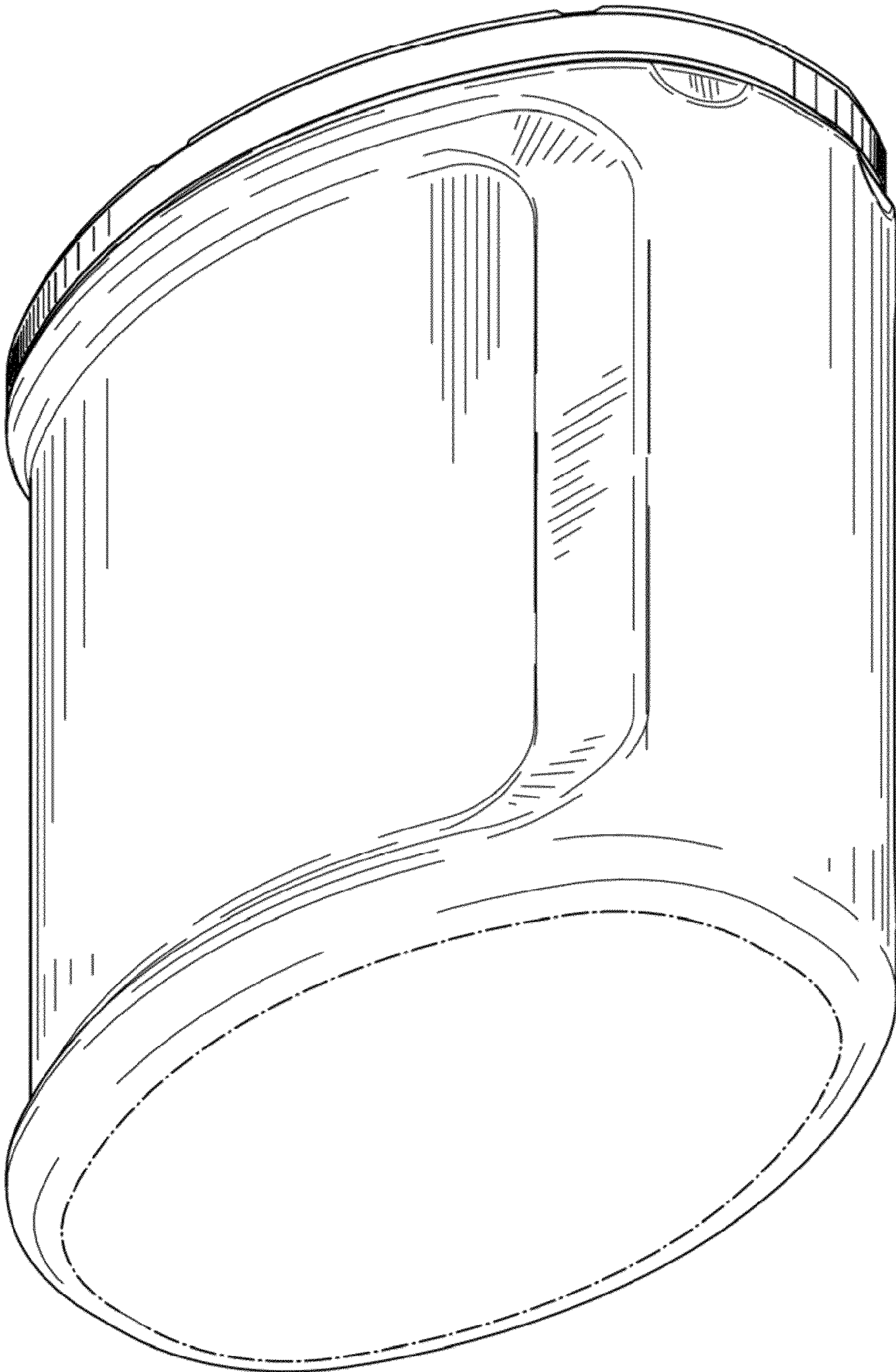

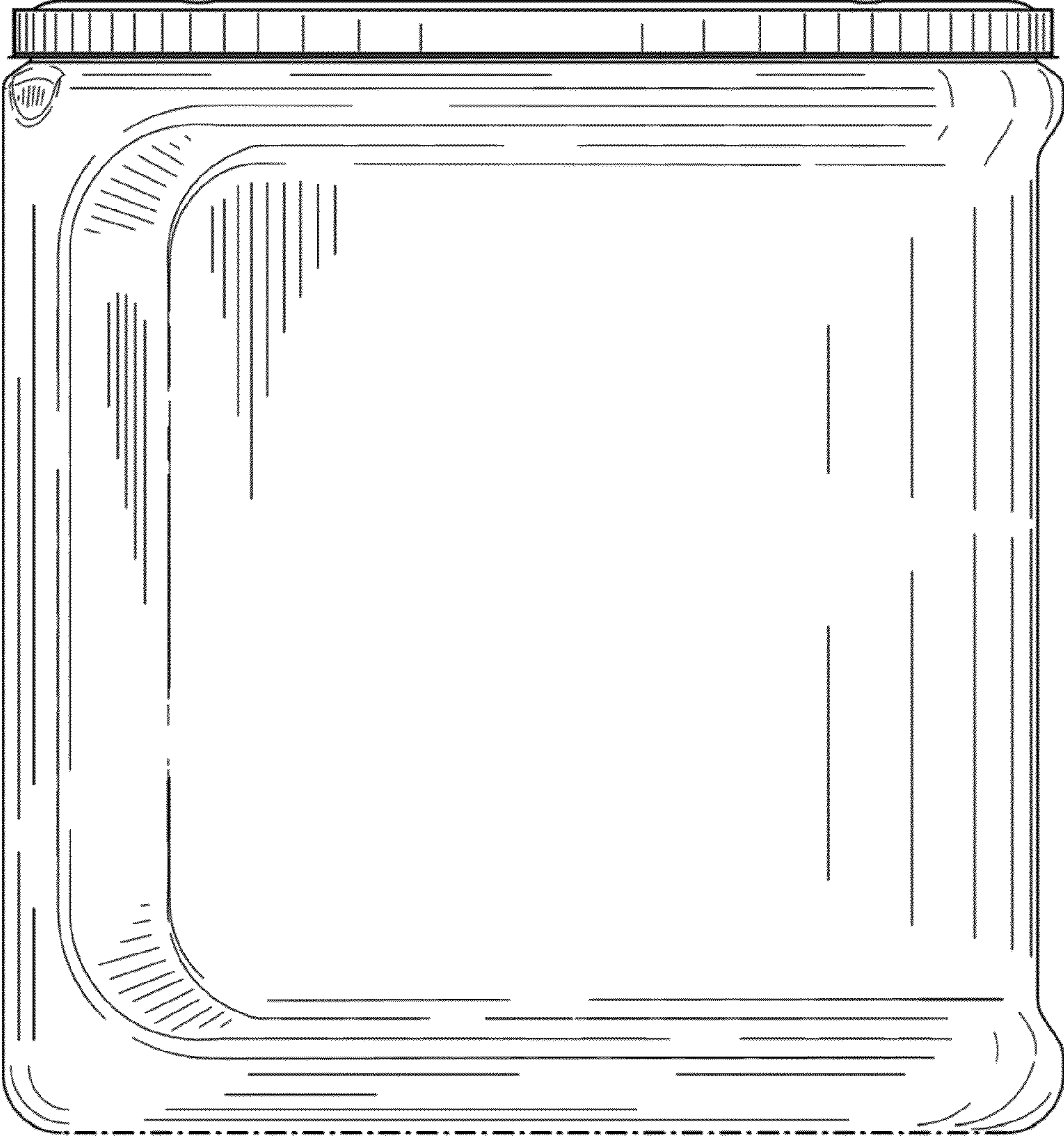

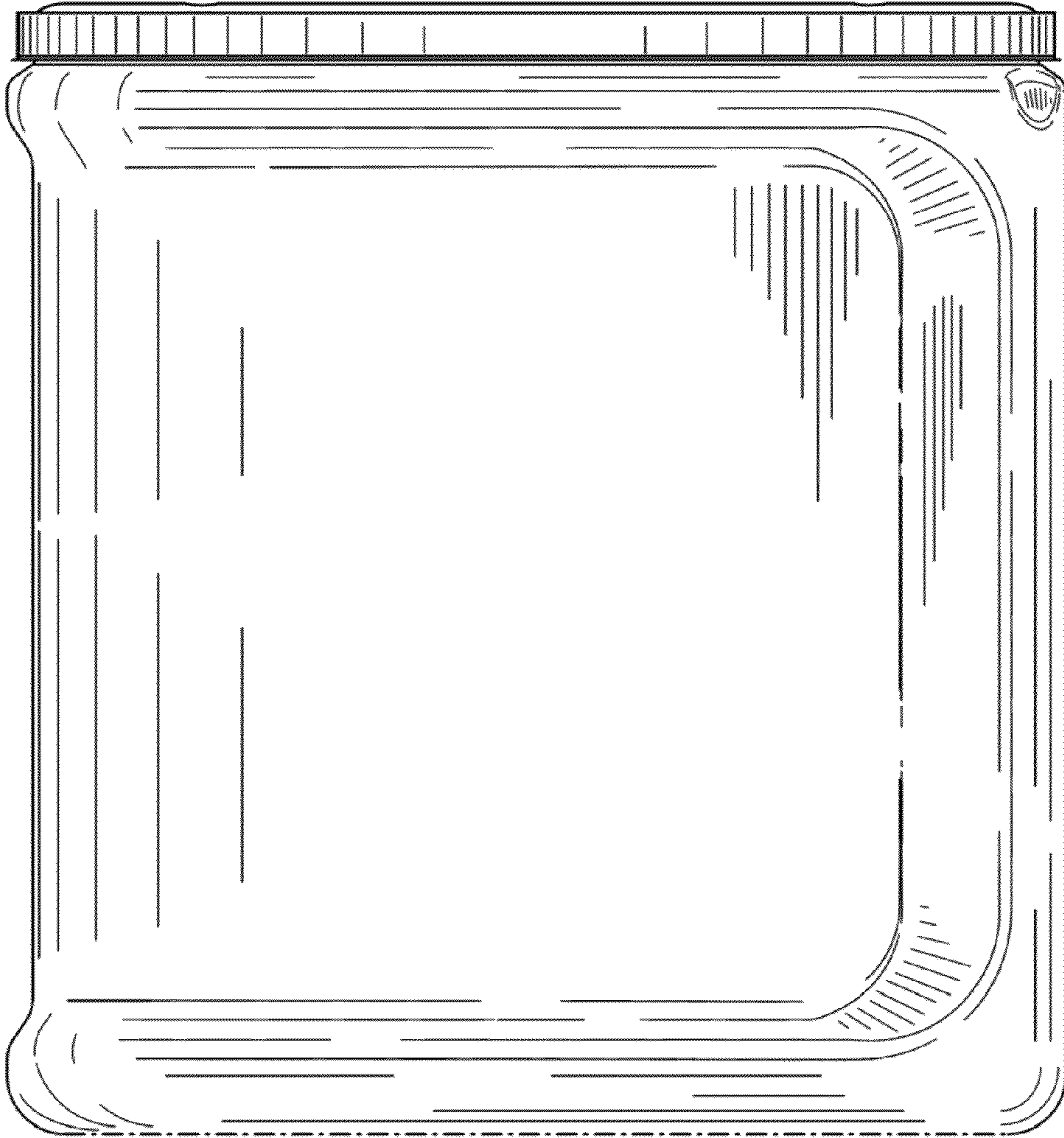

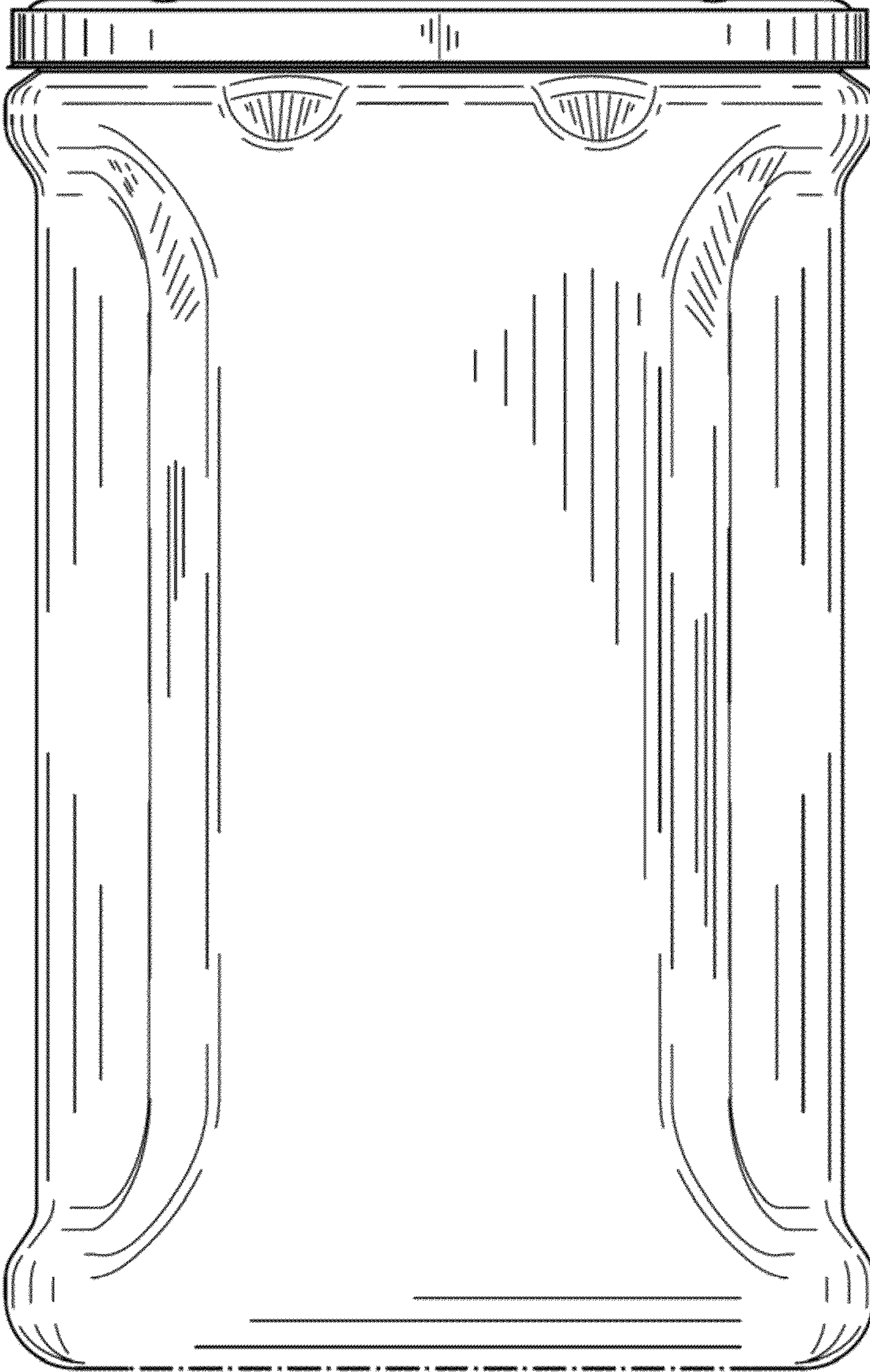

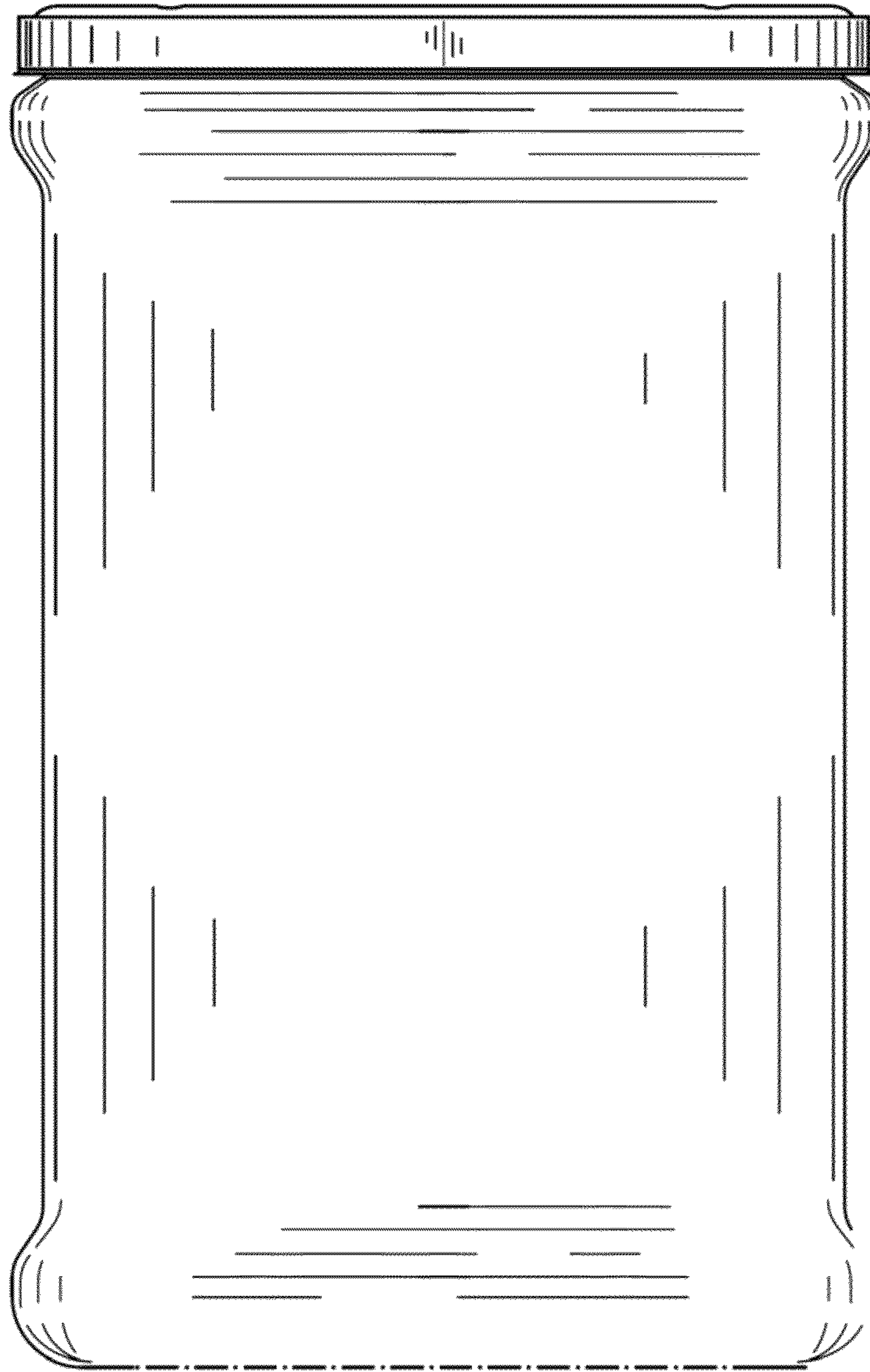

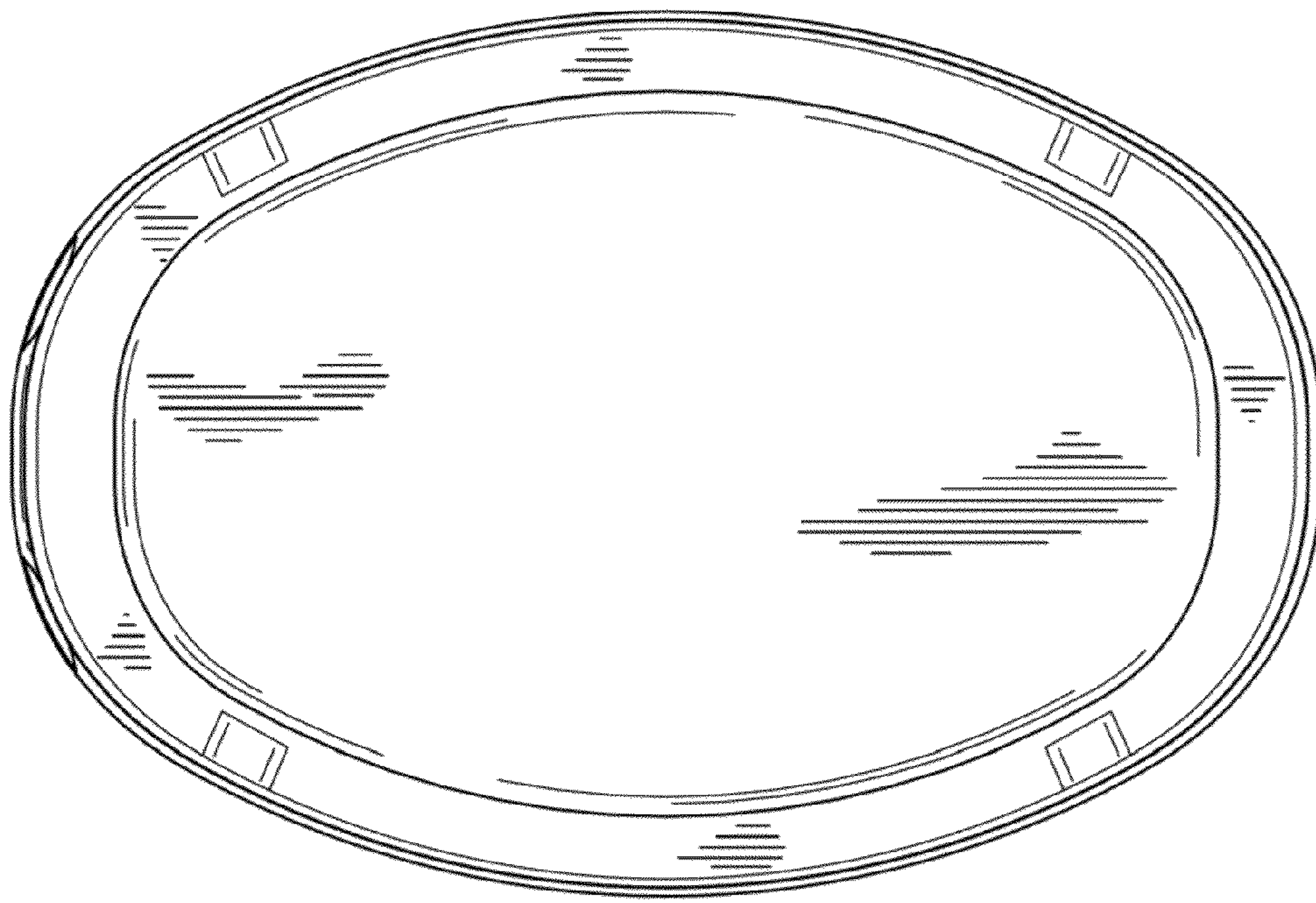

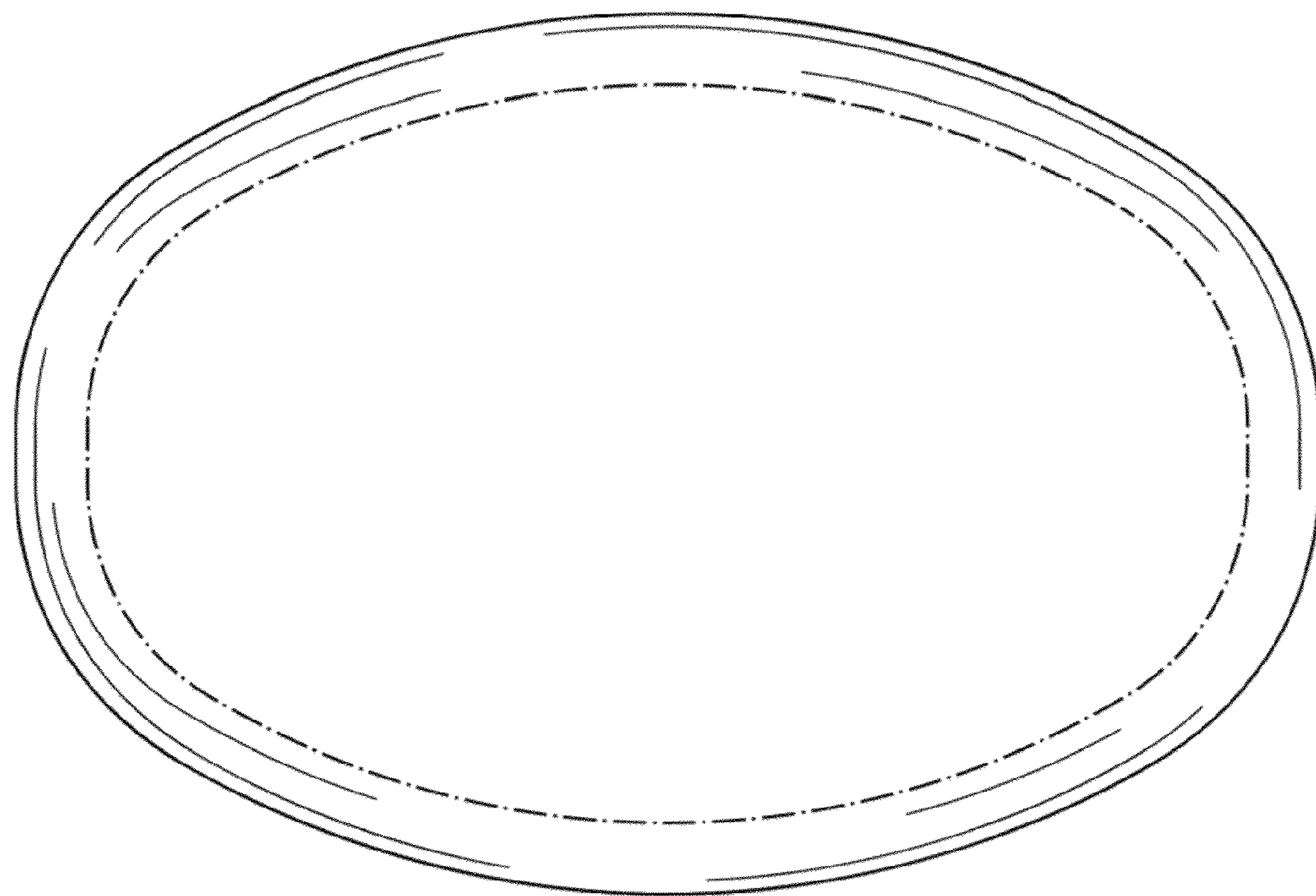

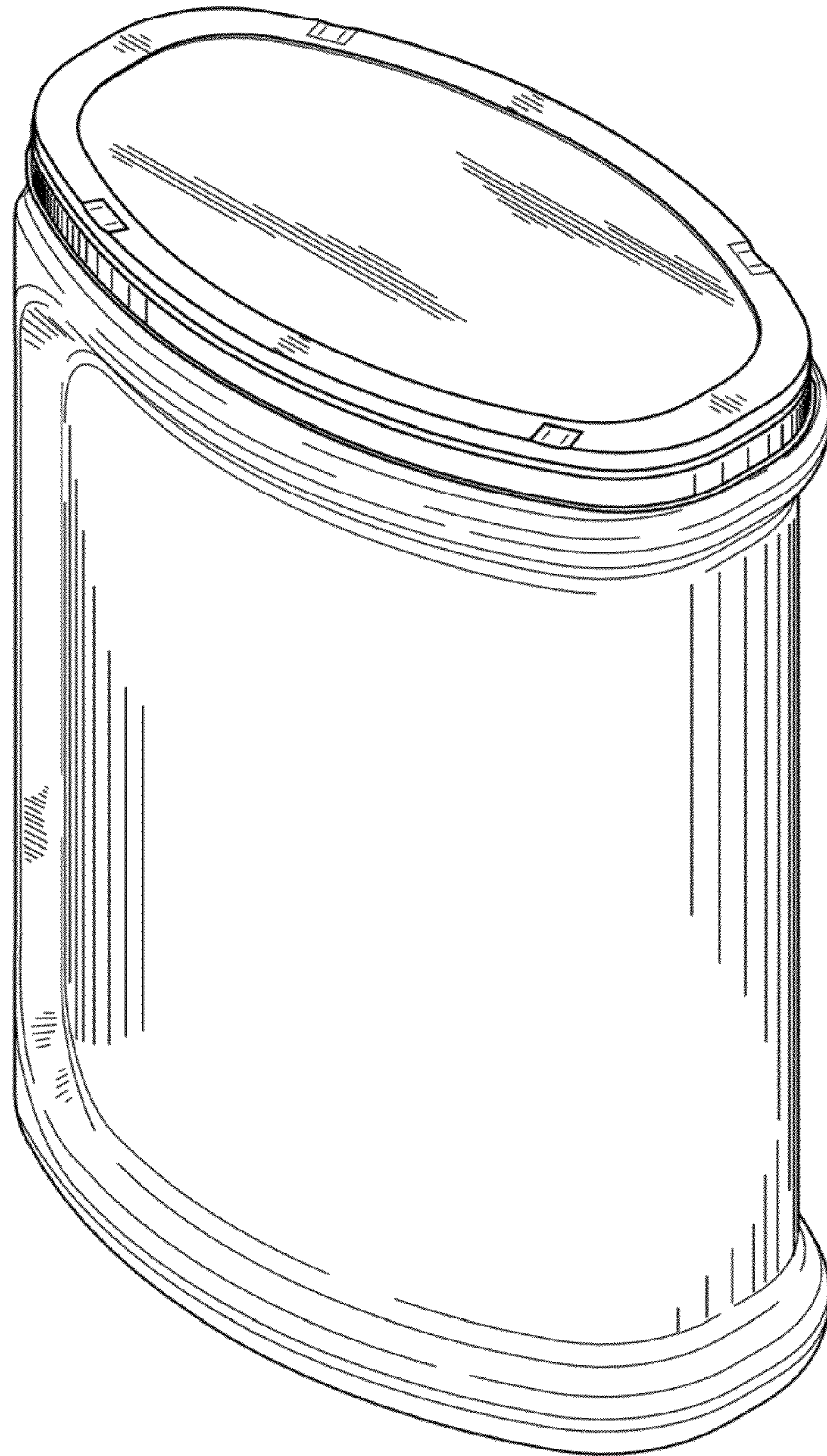

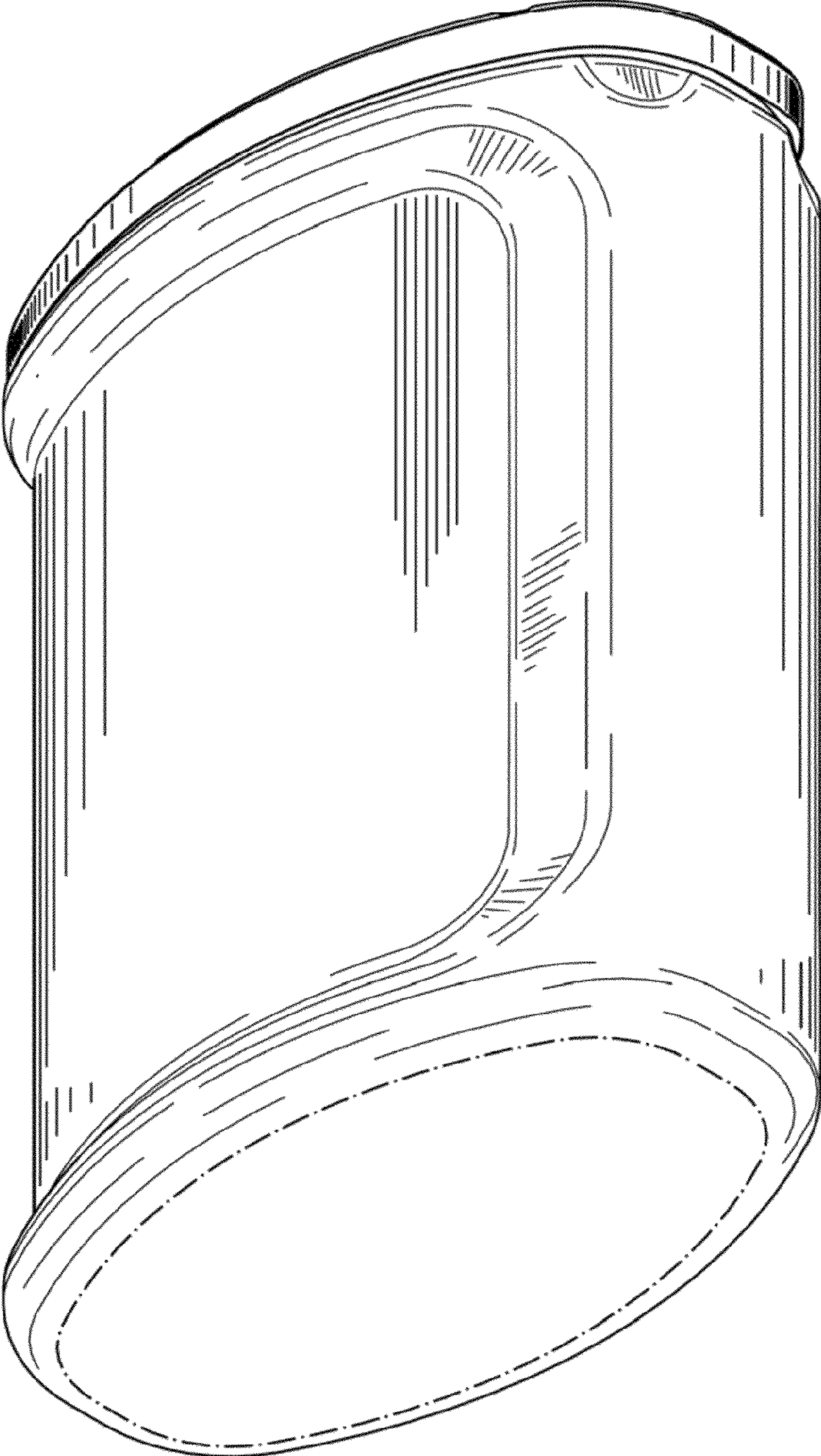

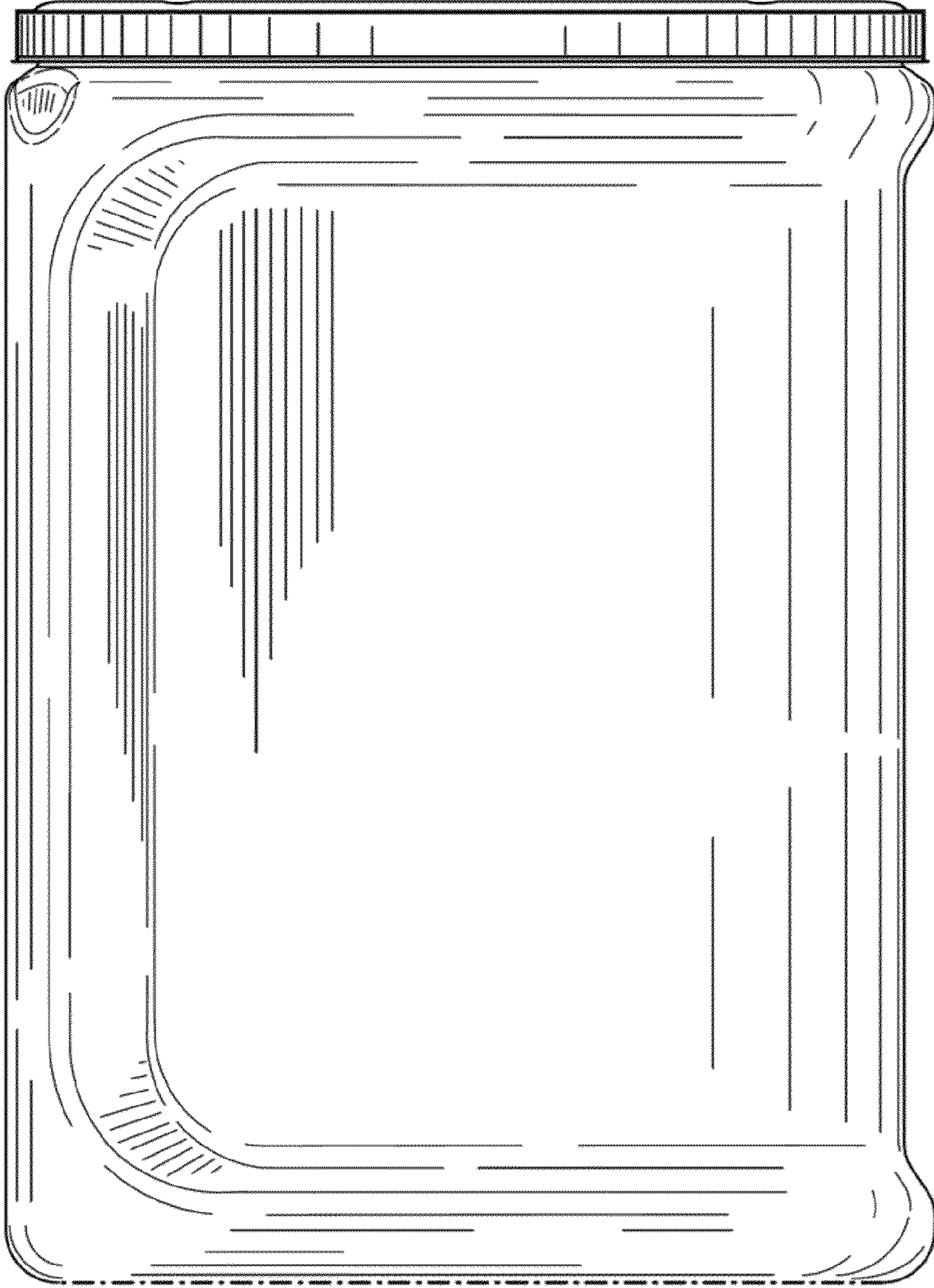

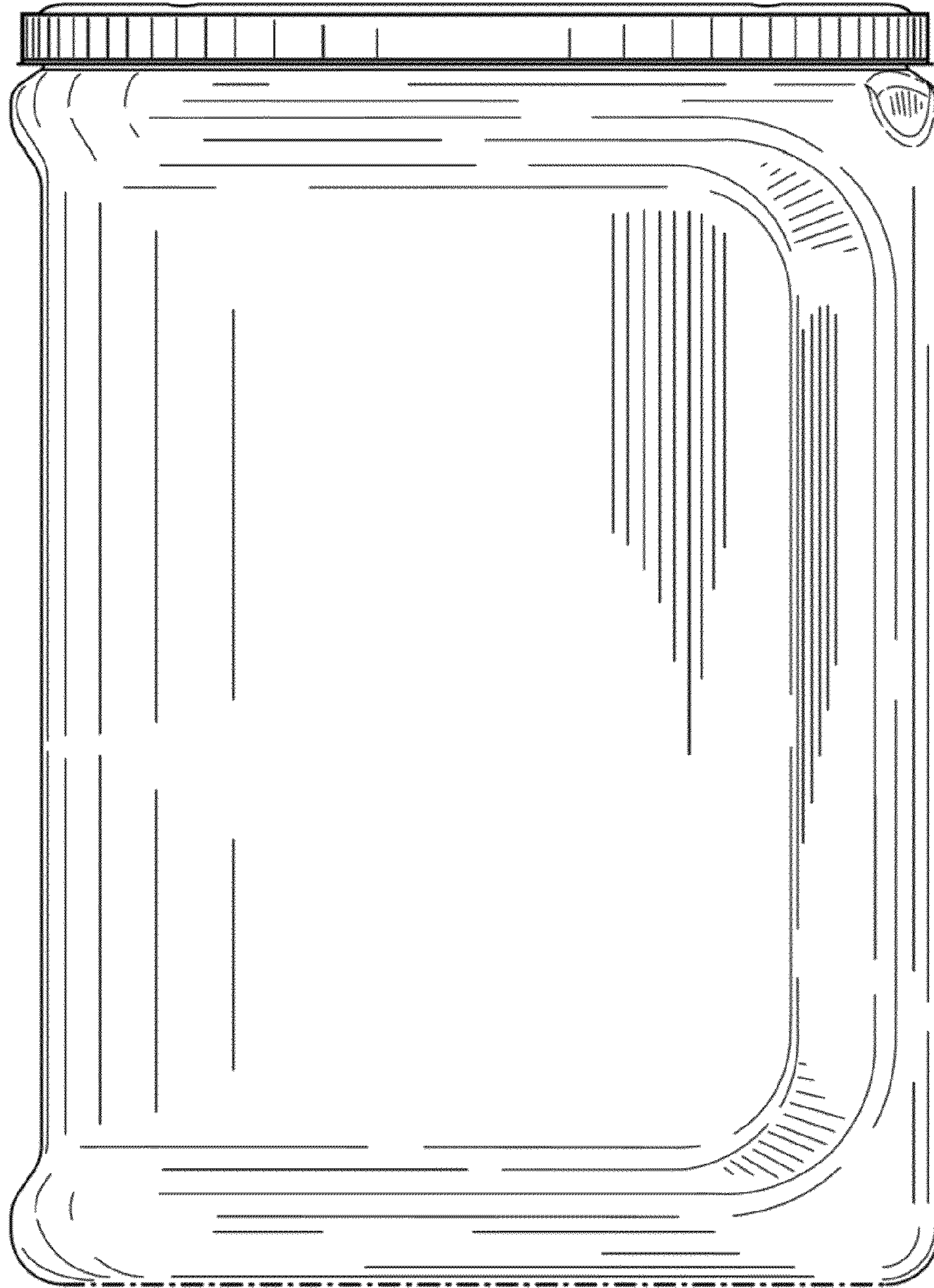

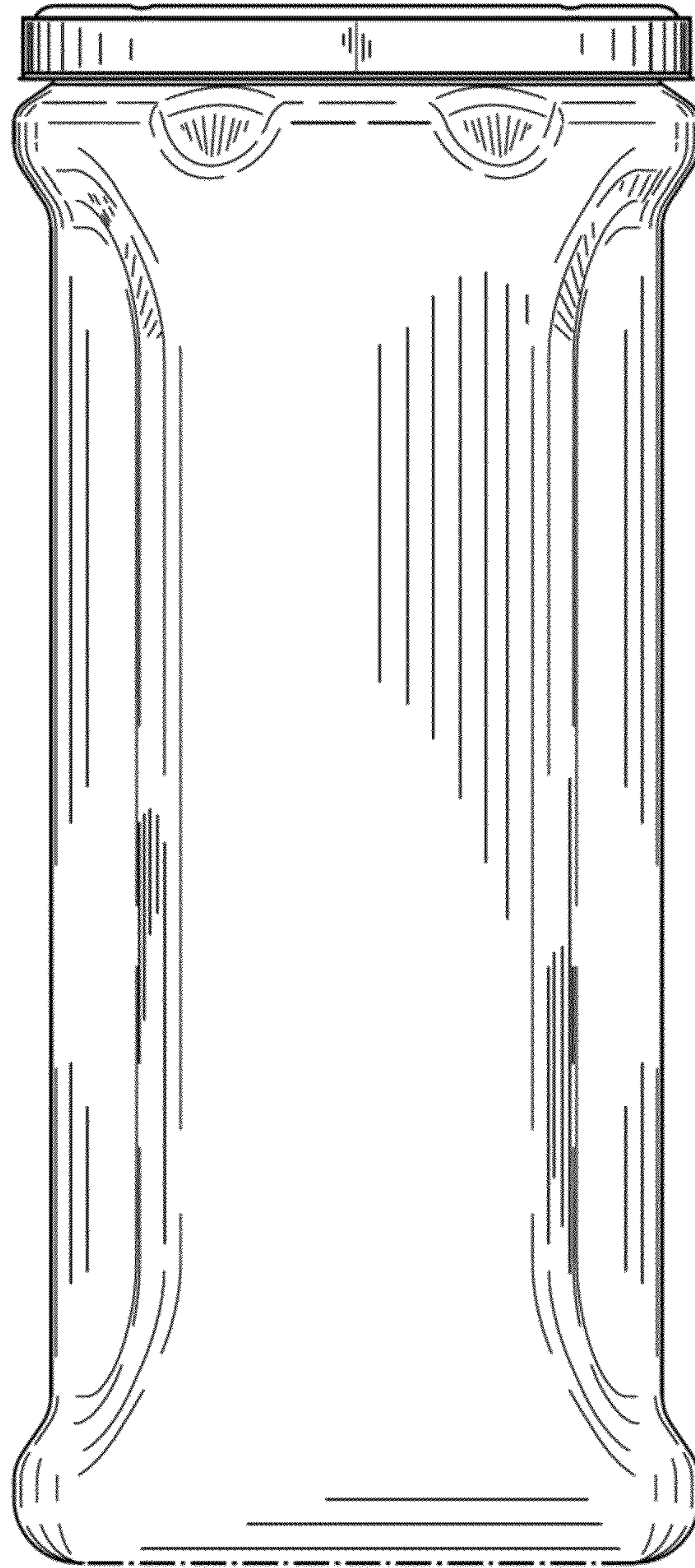

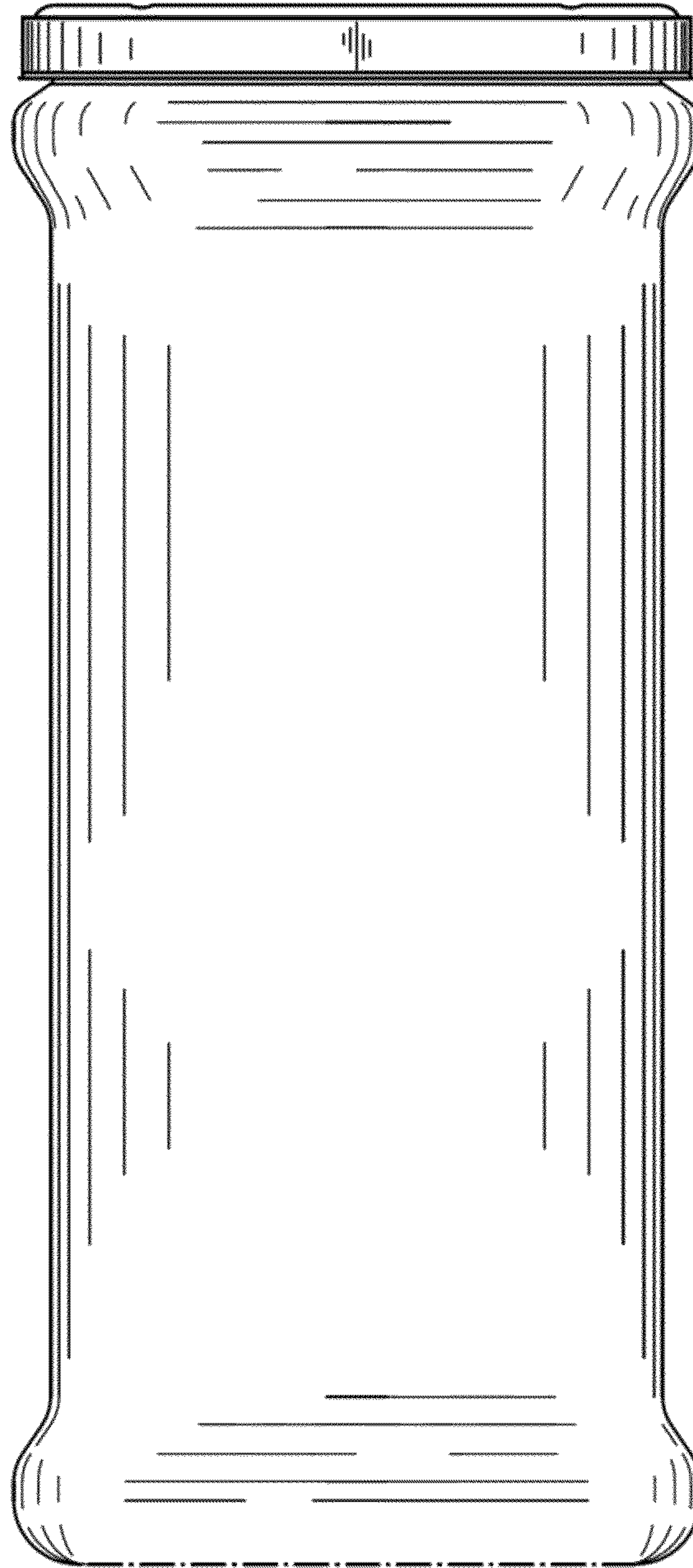

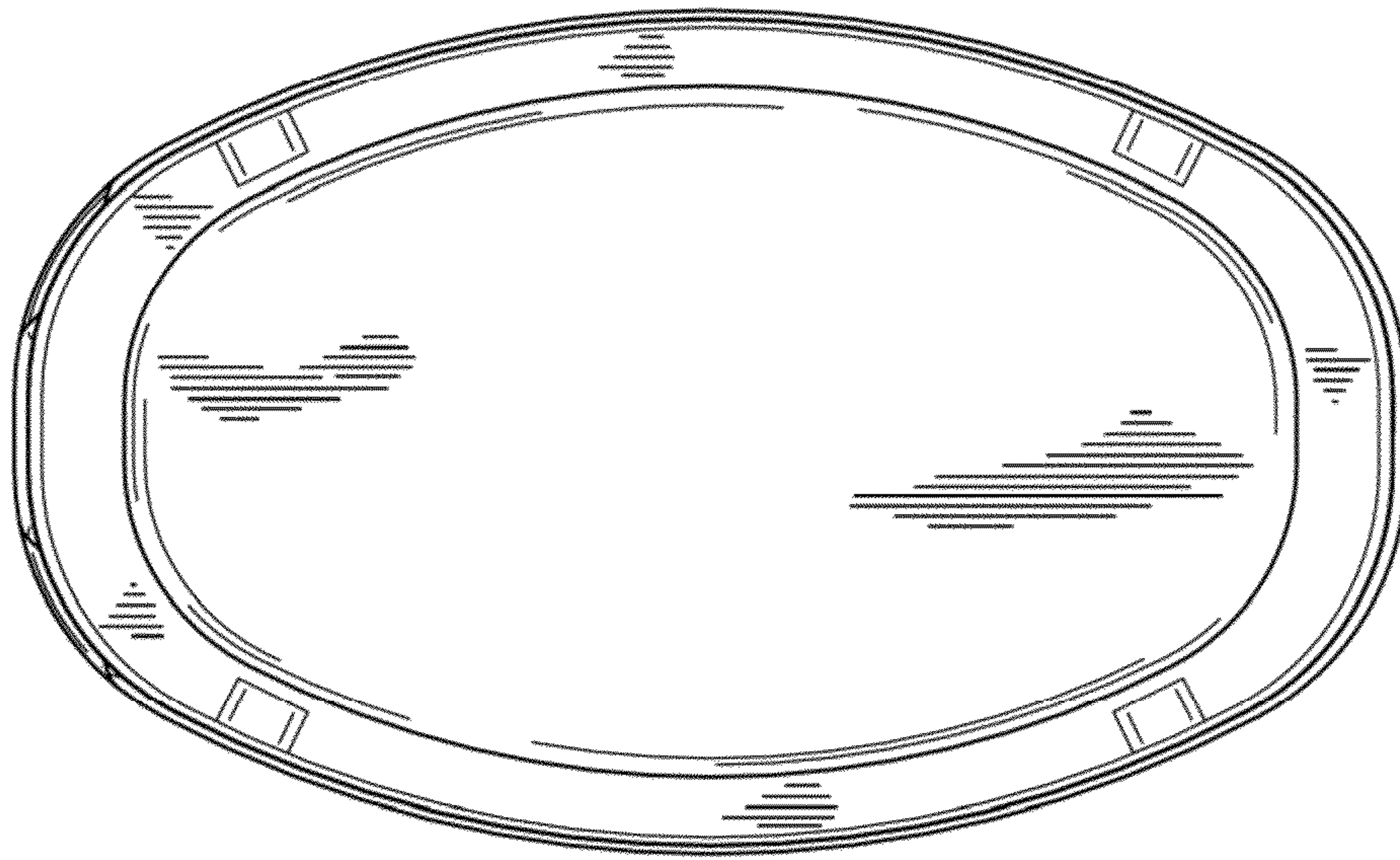

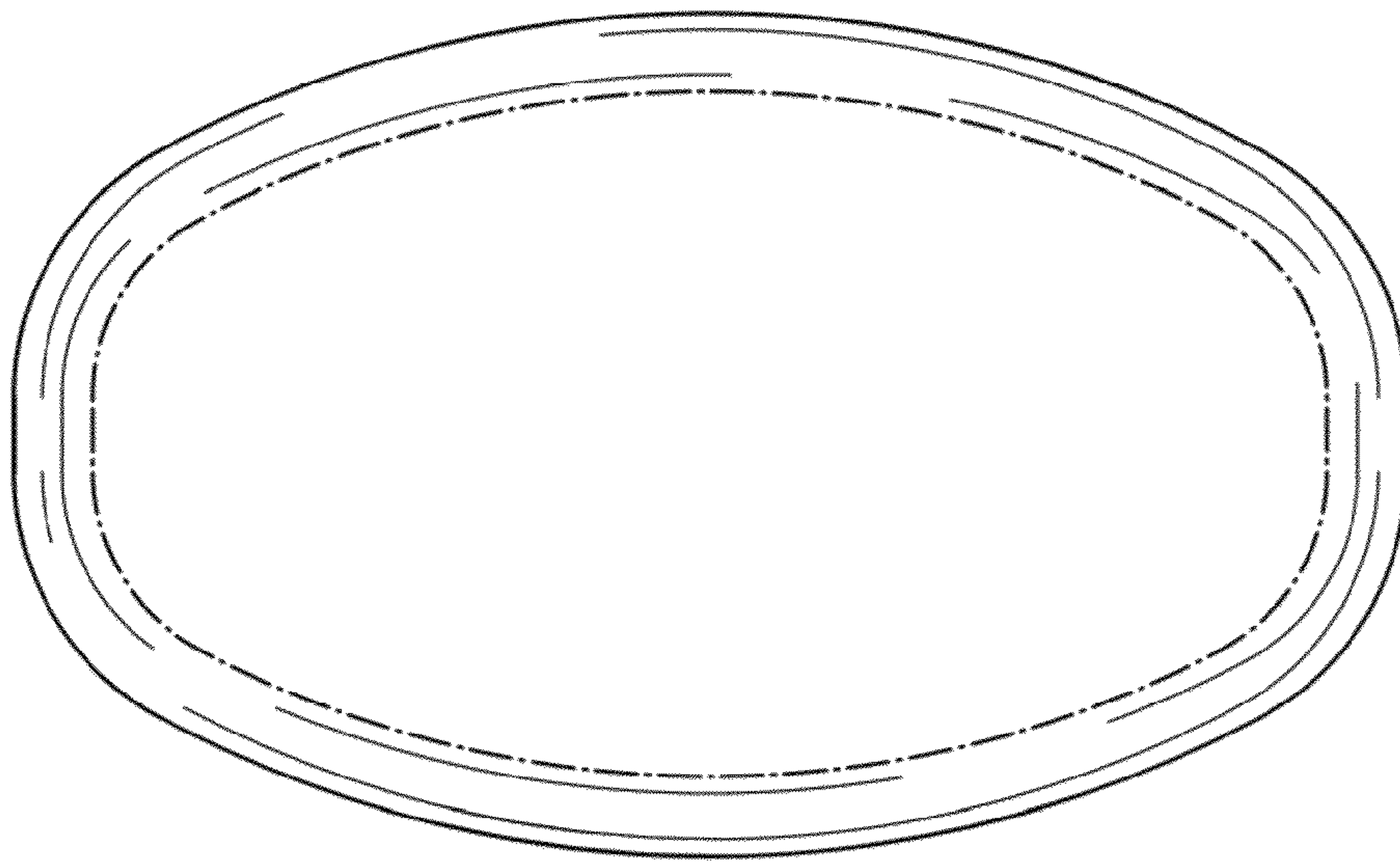

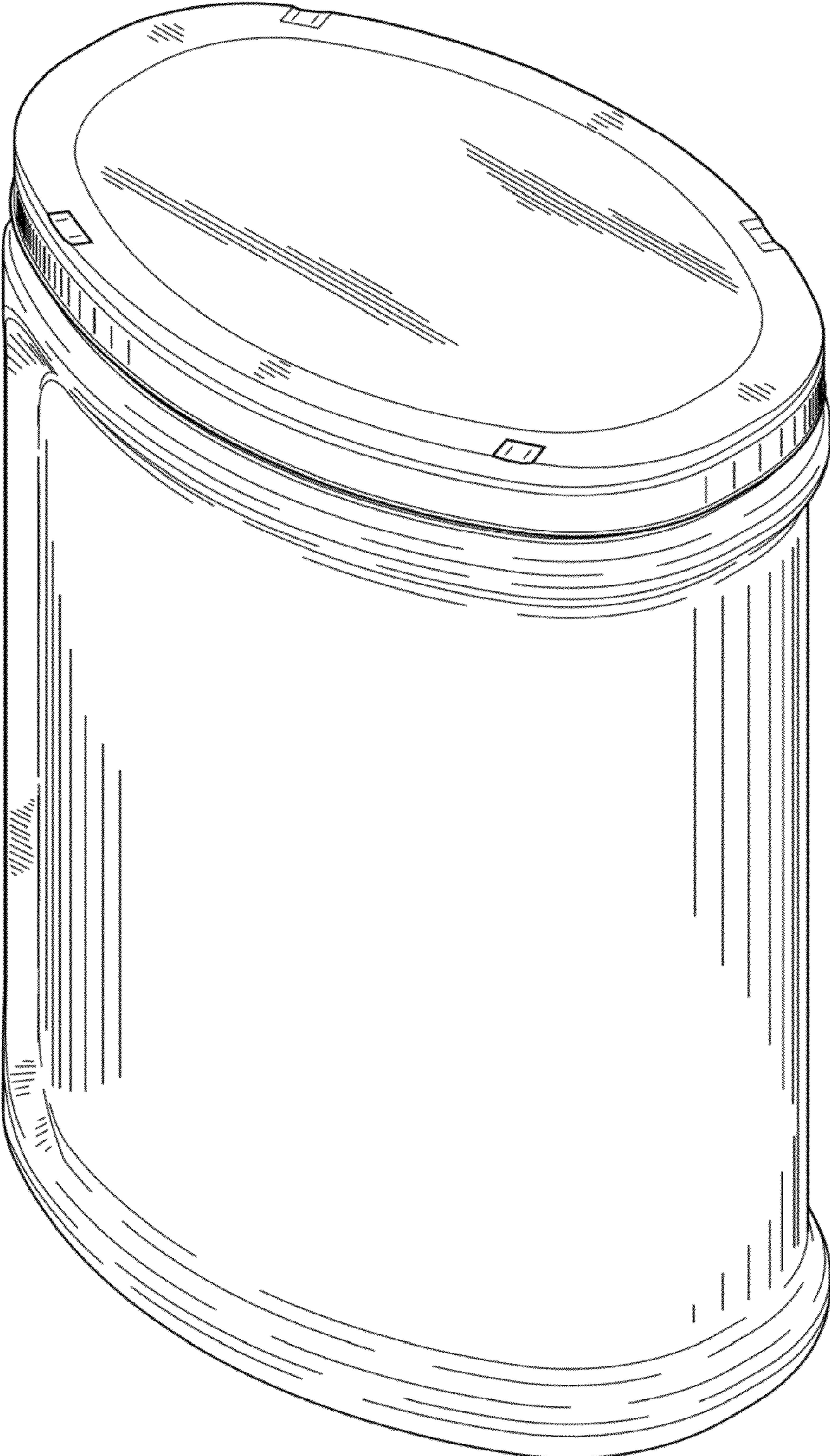

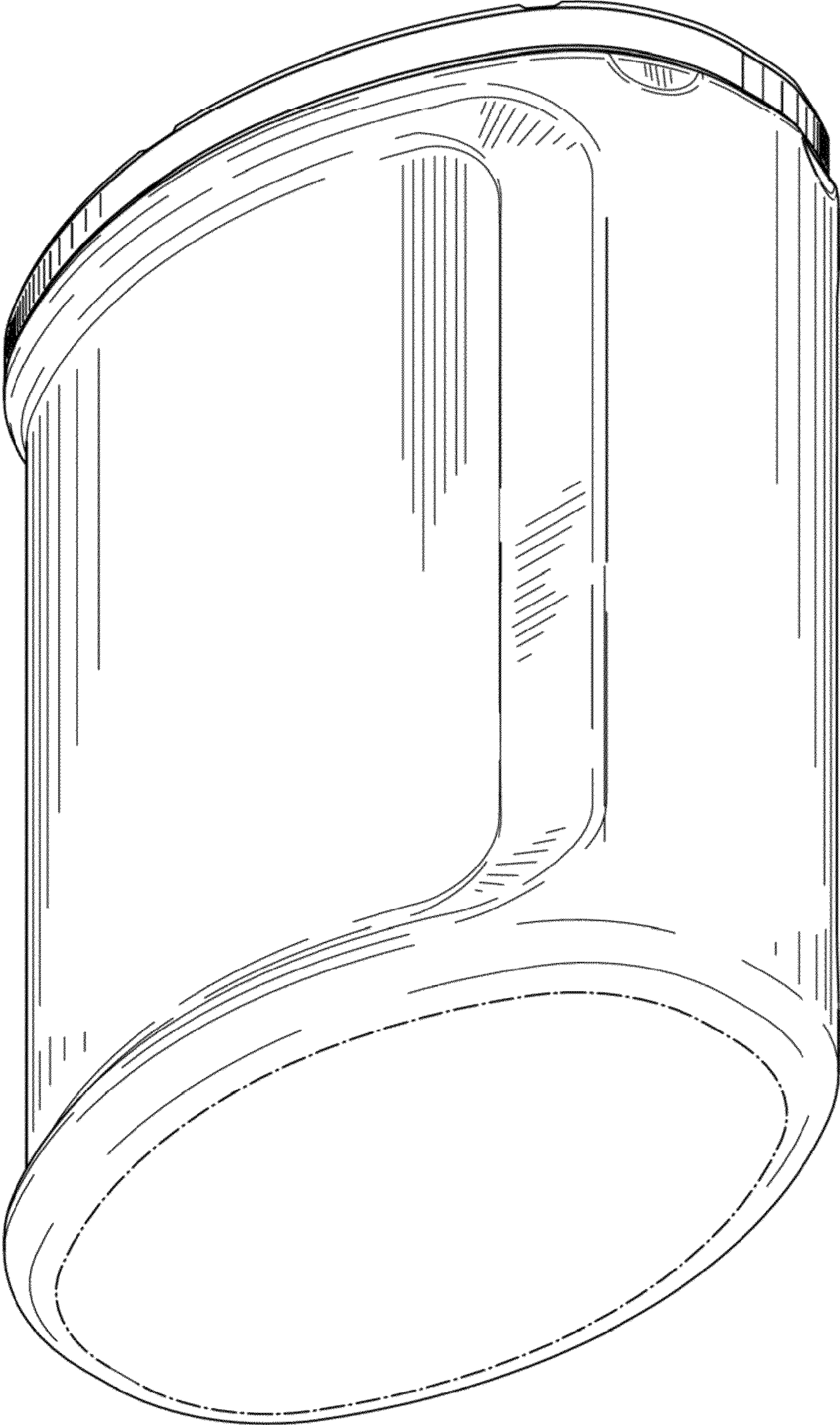

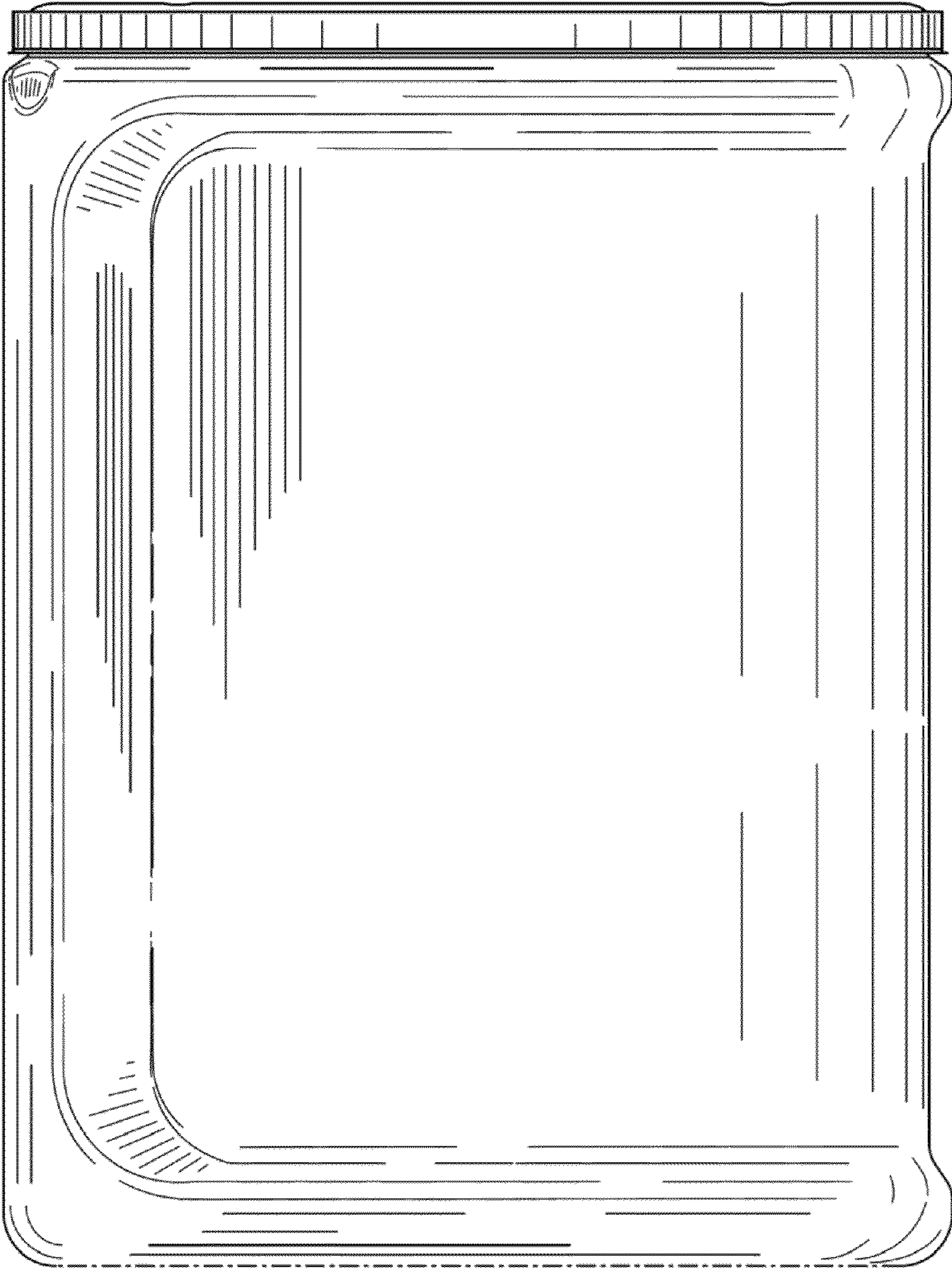

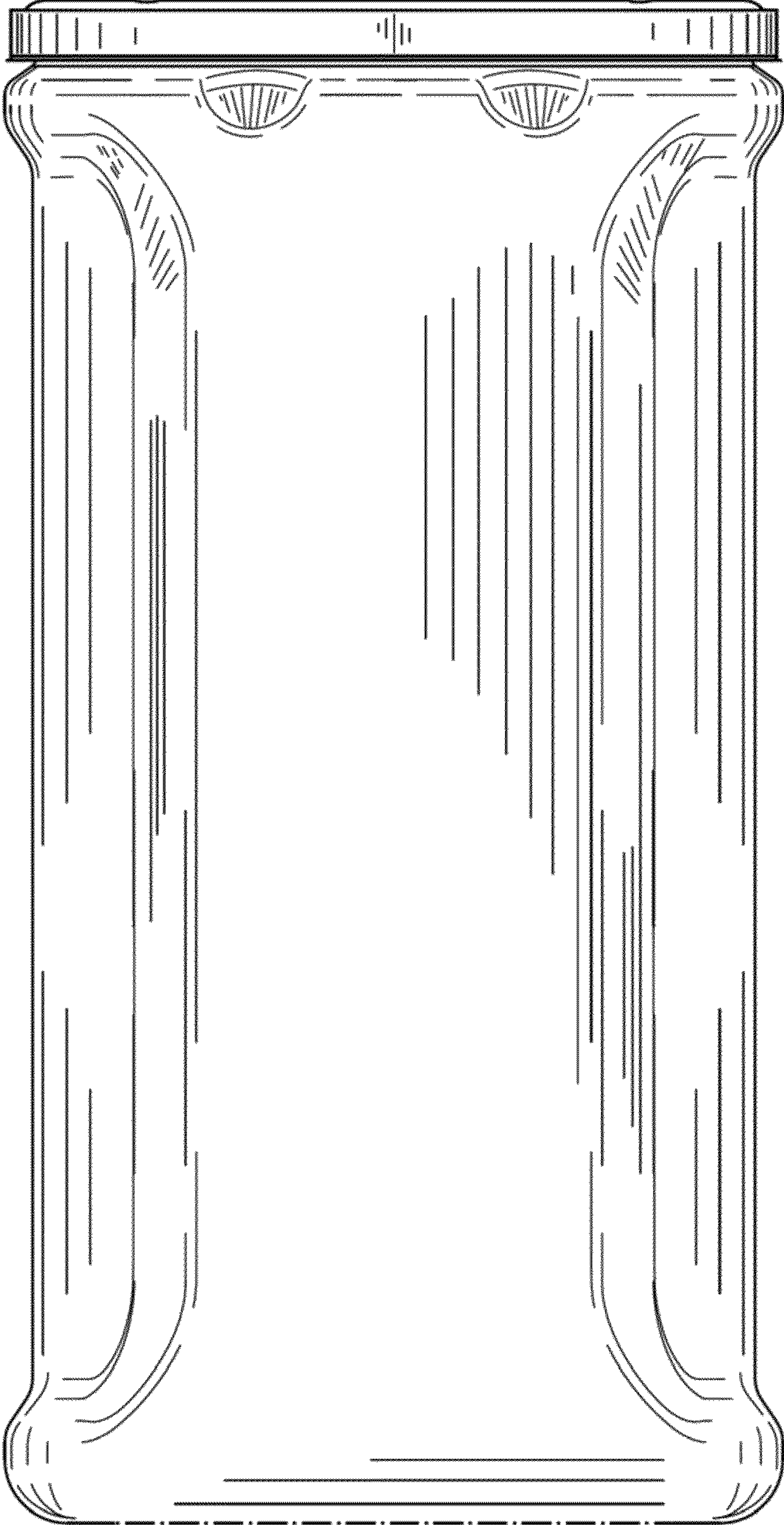

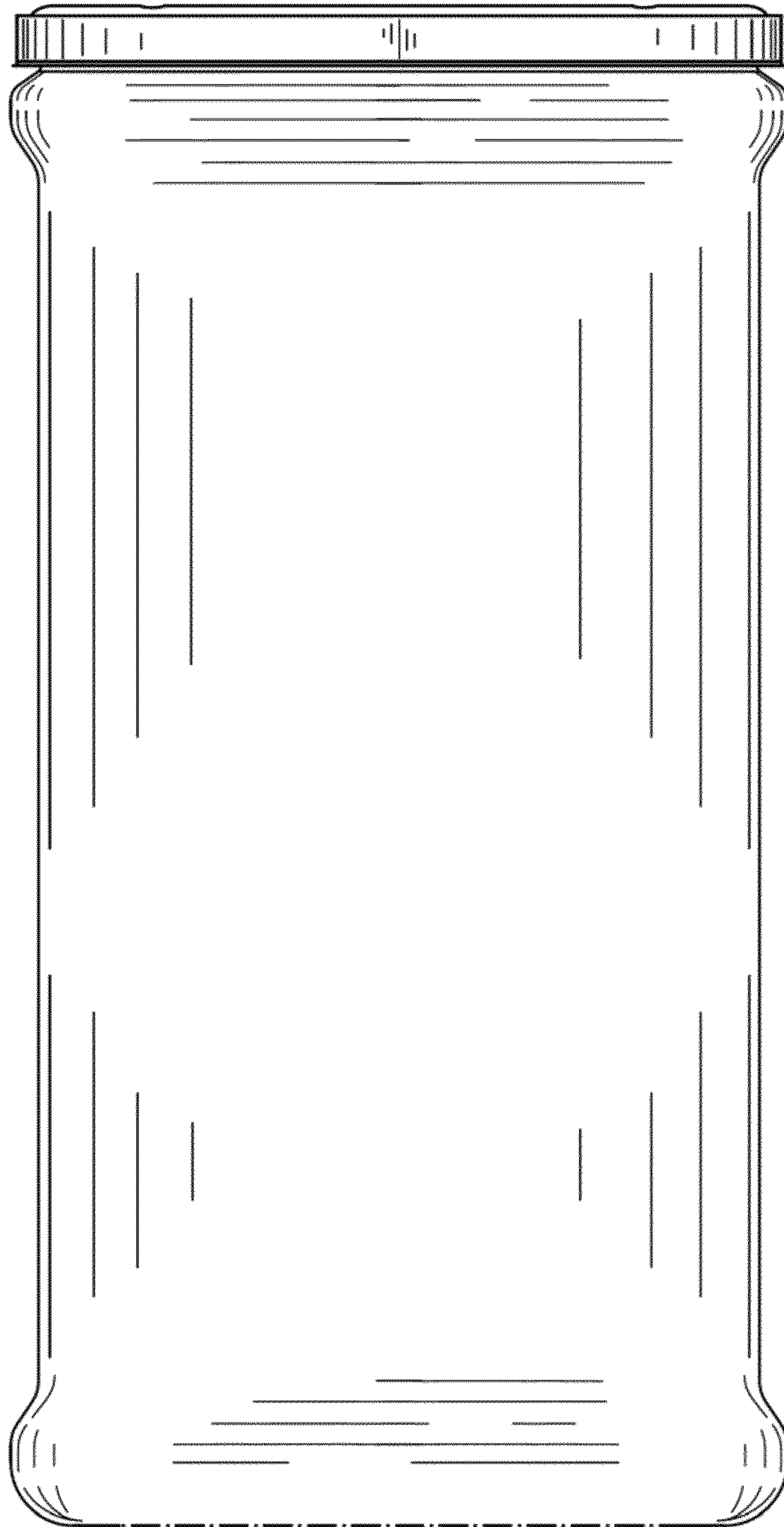

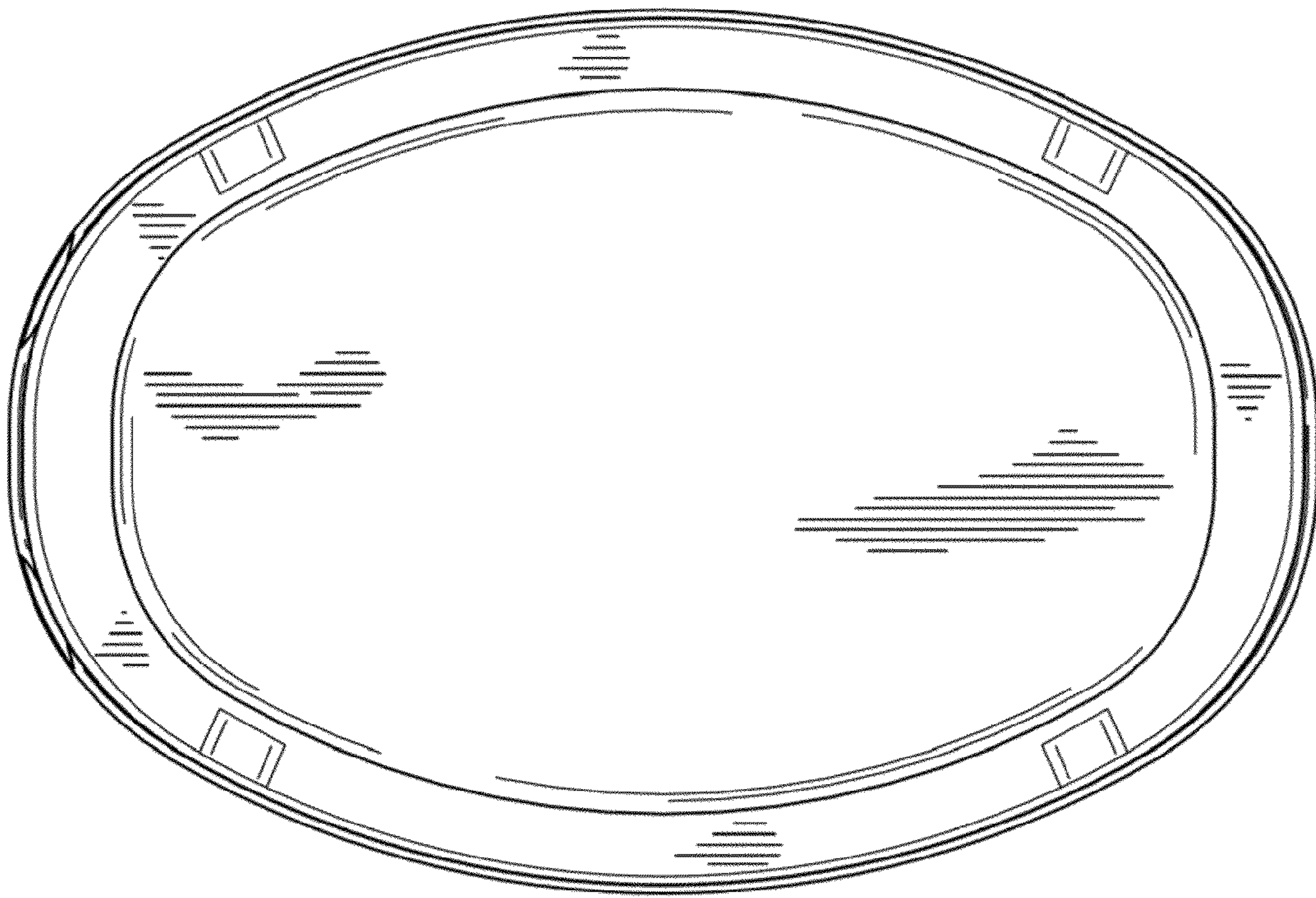

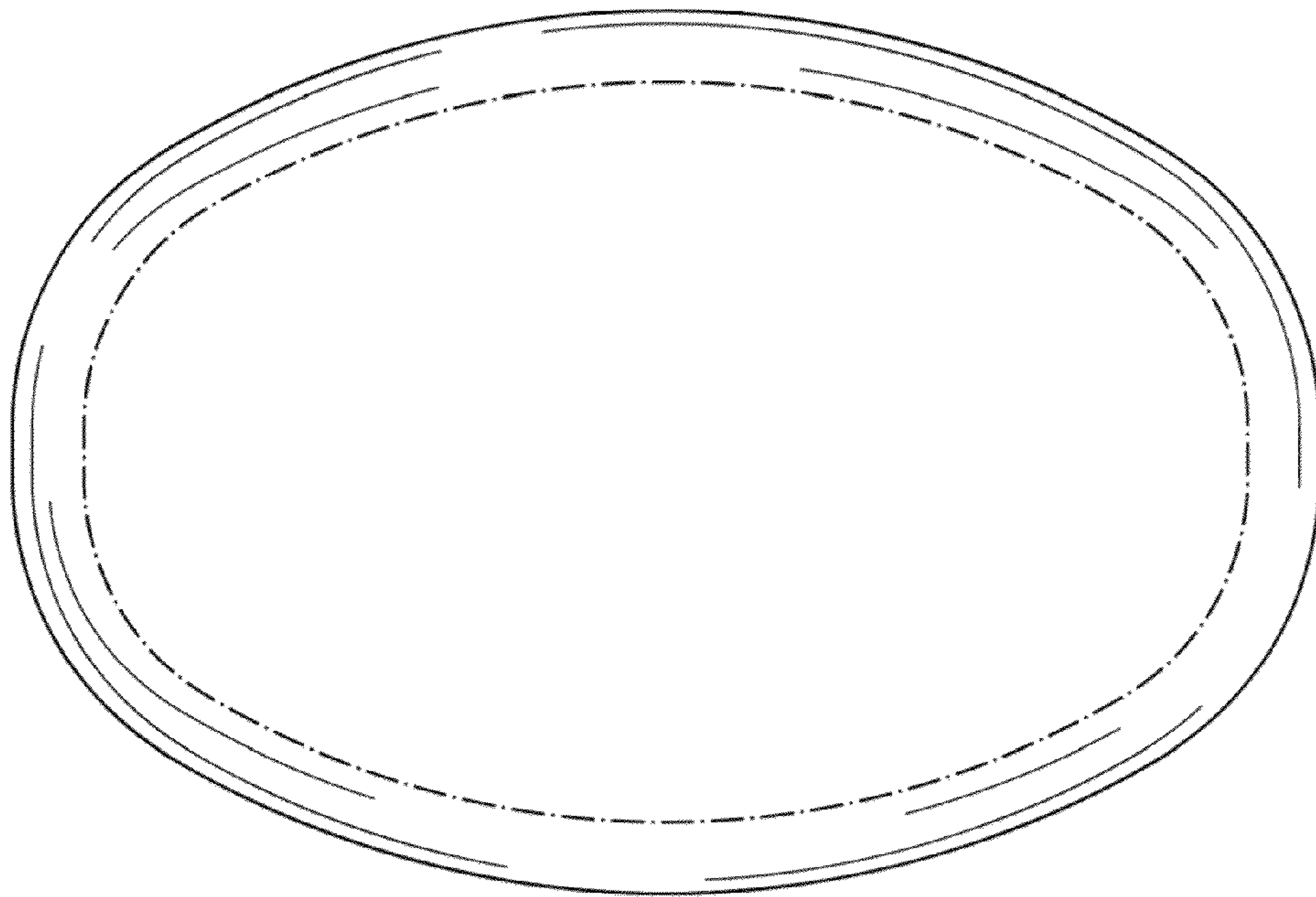
