FIG. 7 is a bottom-plan view of the multi-purpose bag.

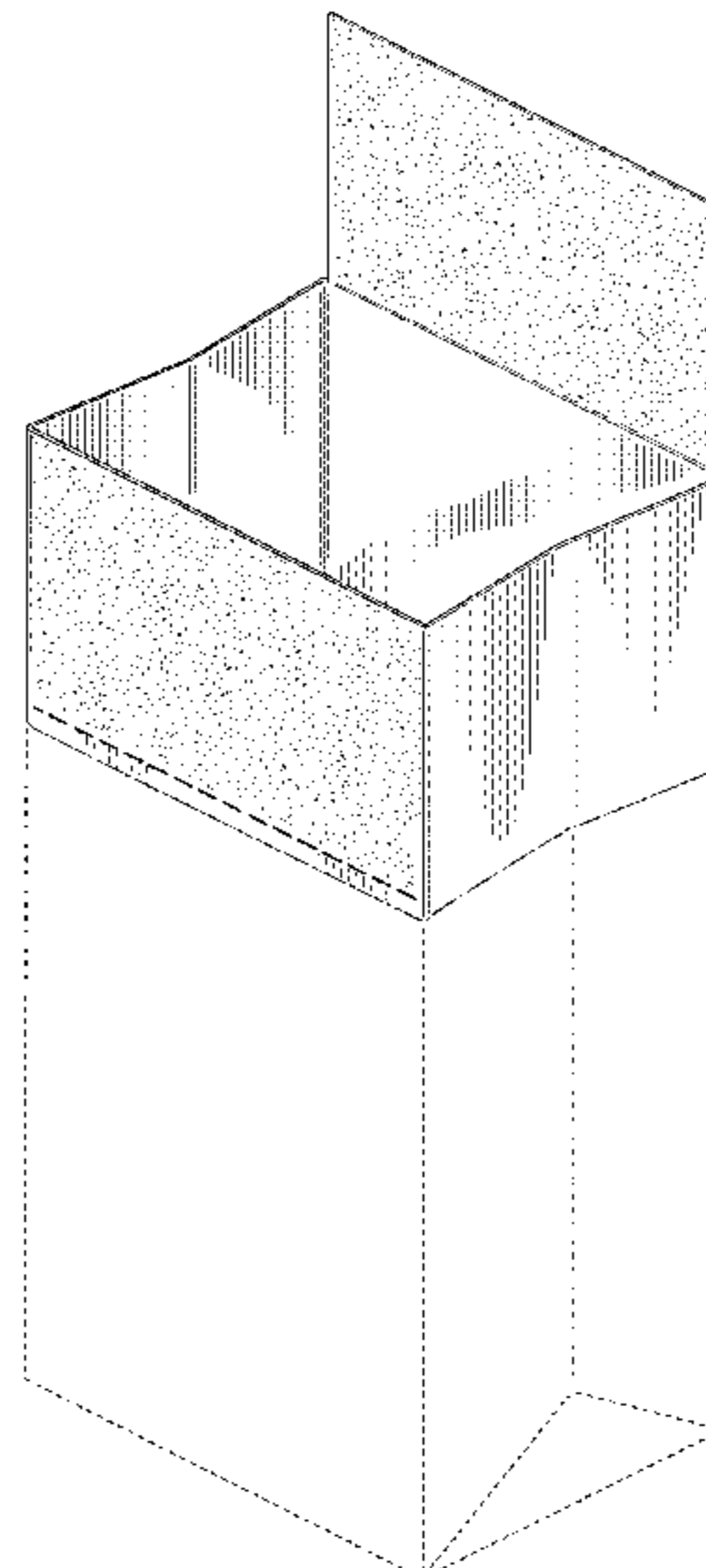

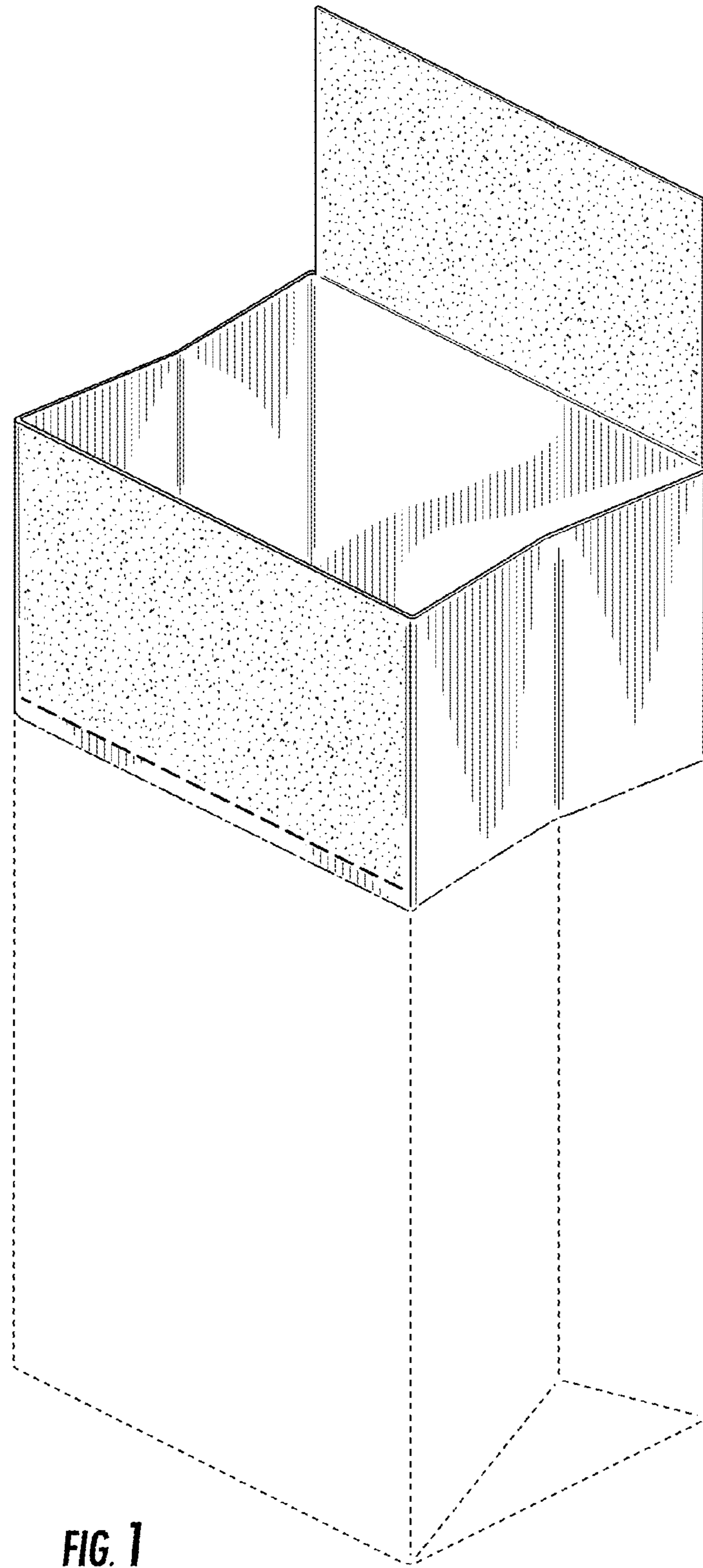

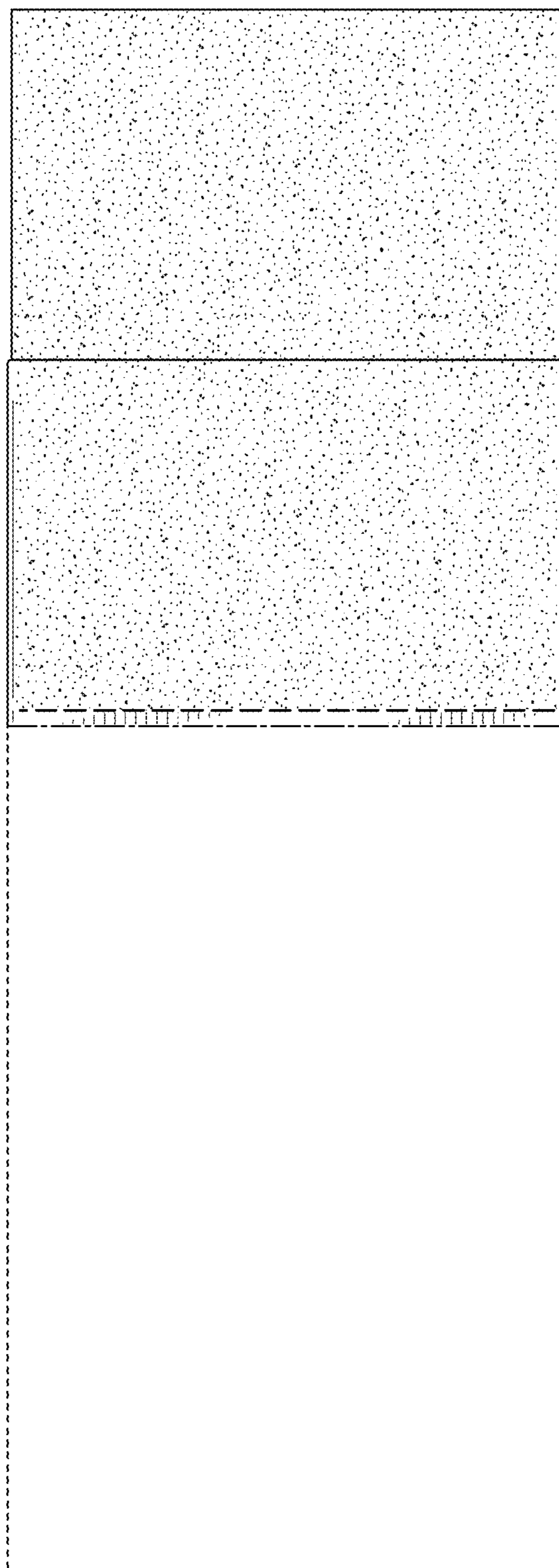

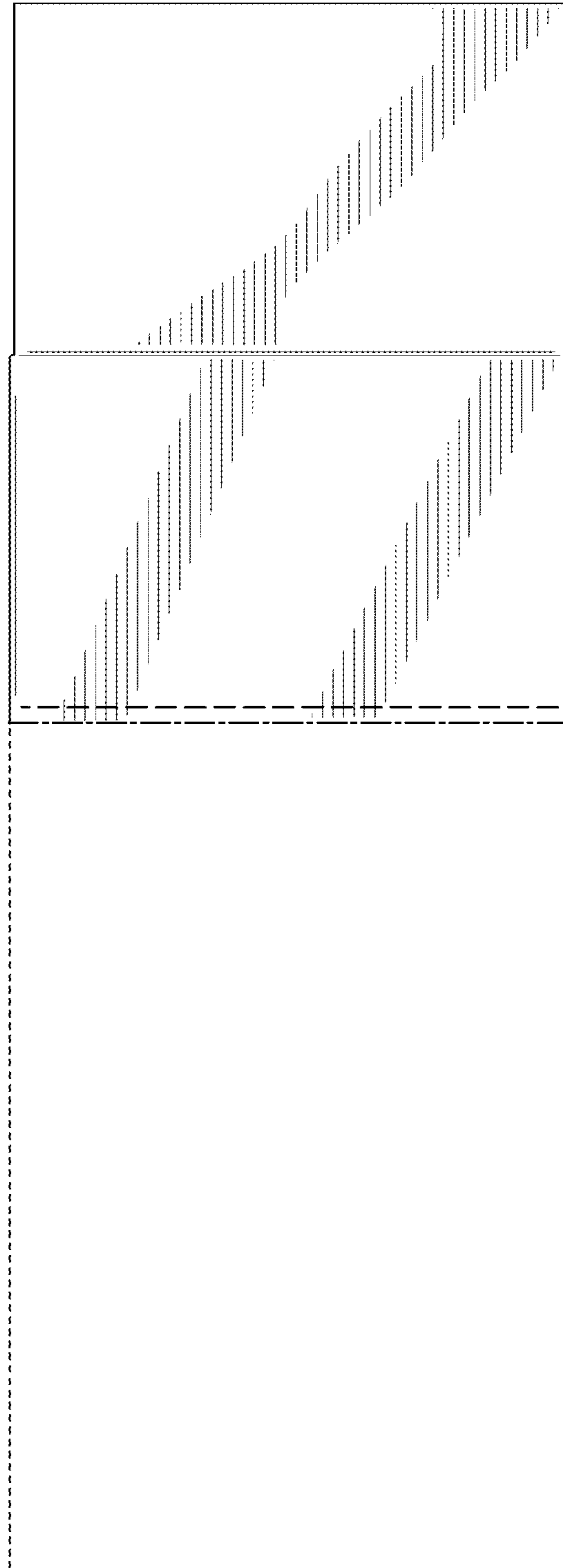

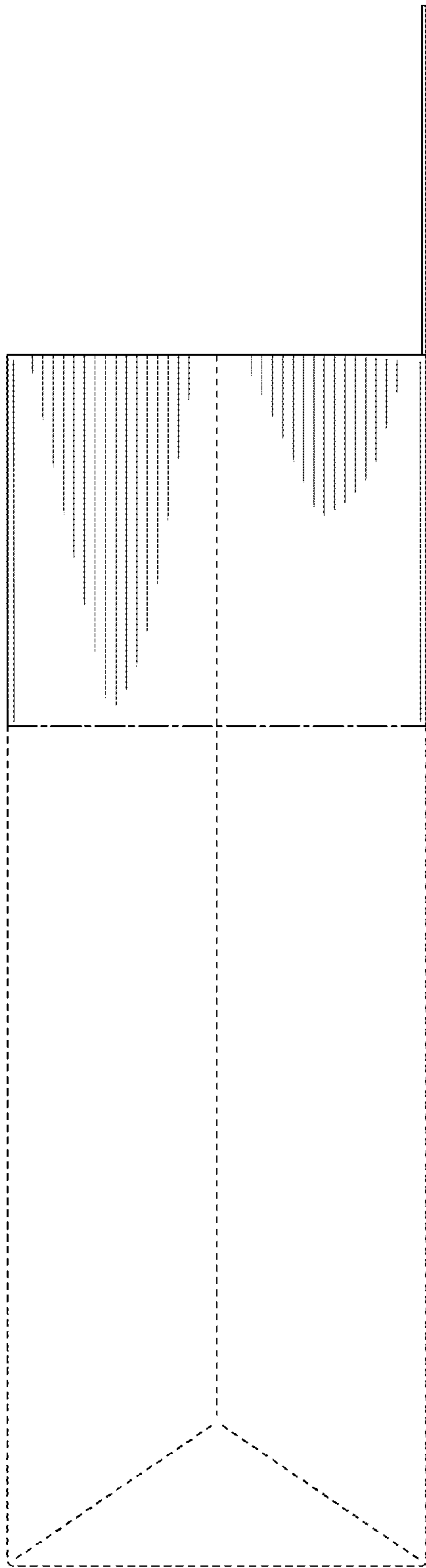

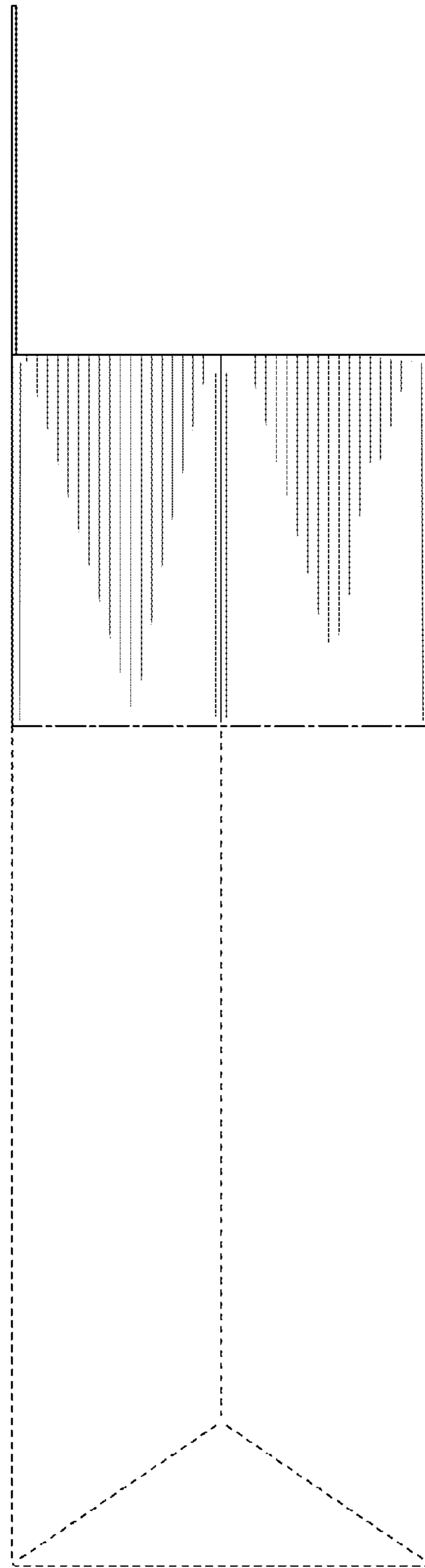
