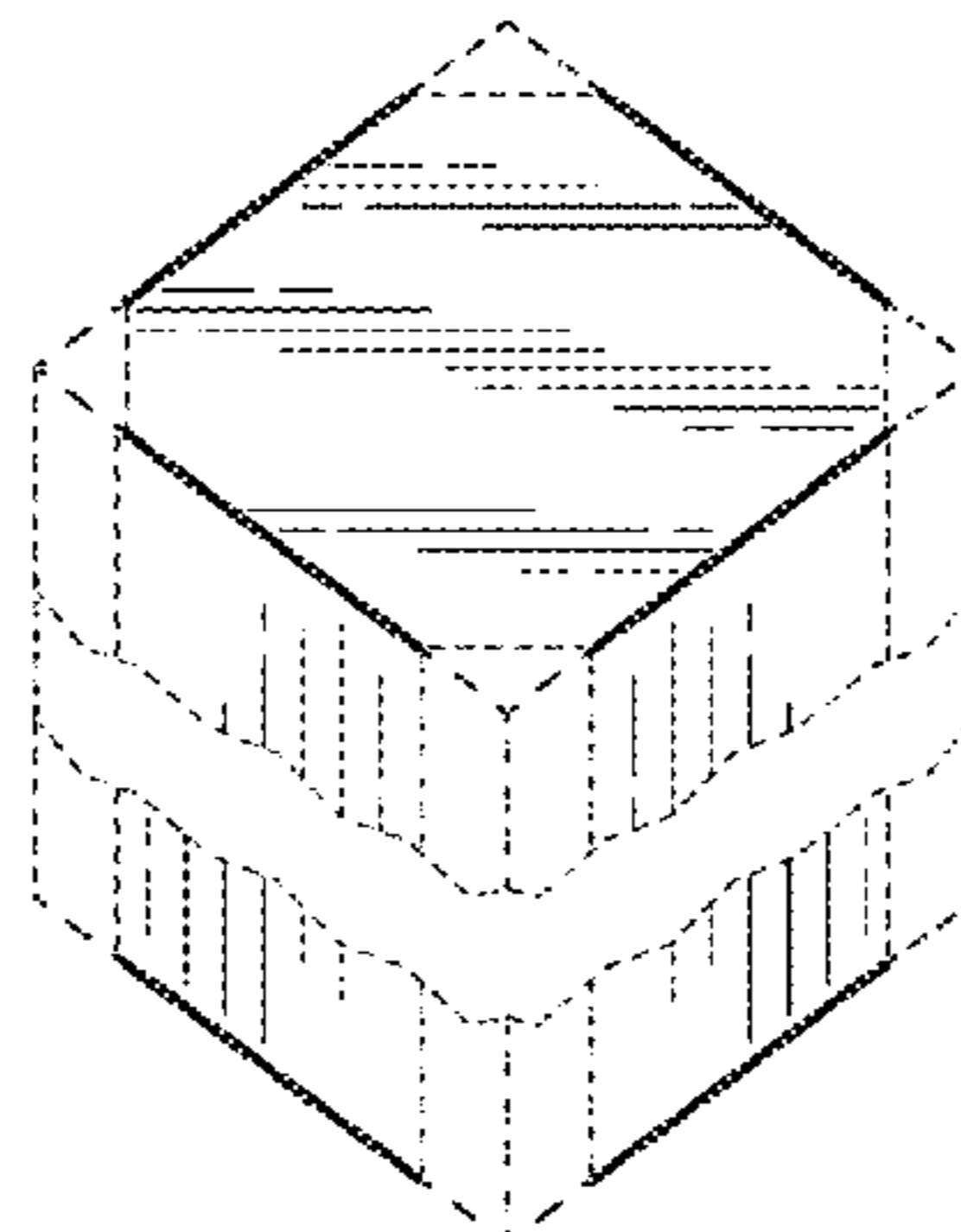
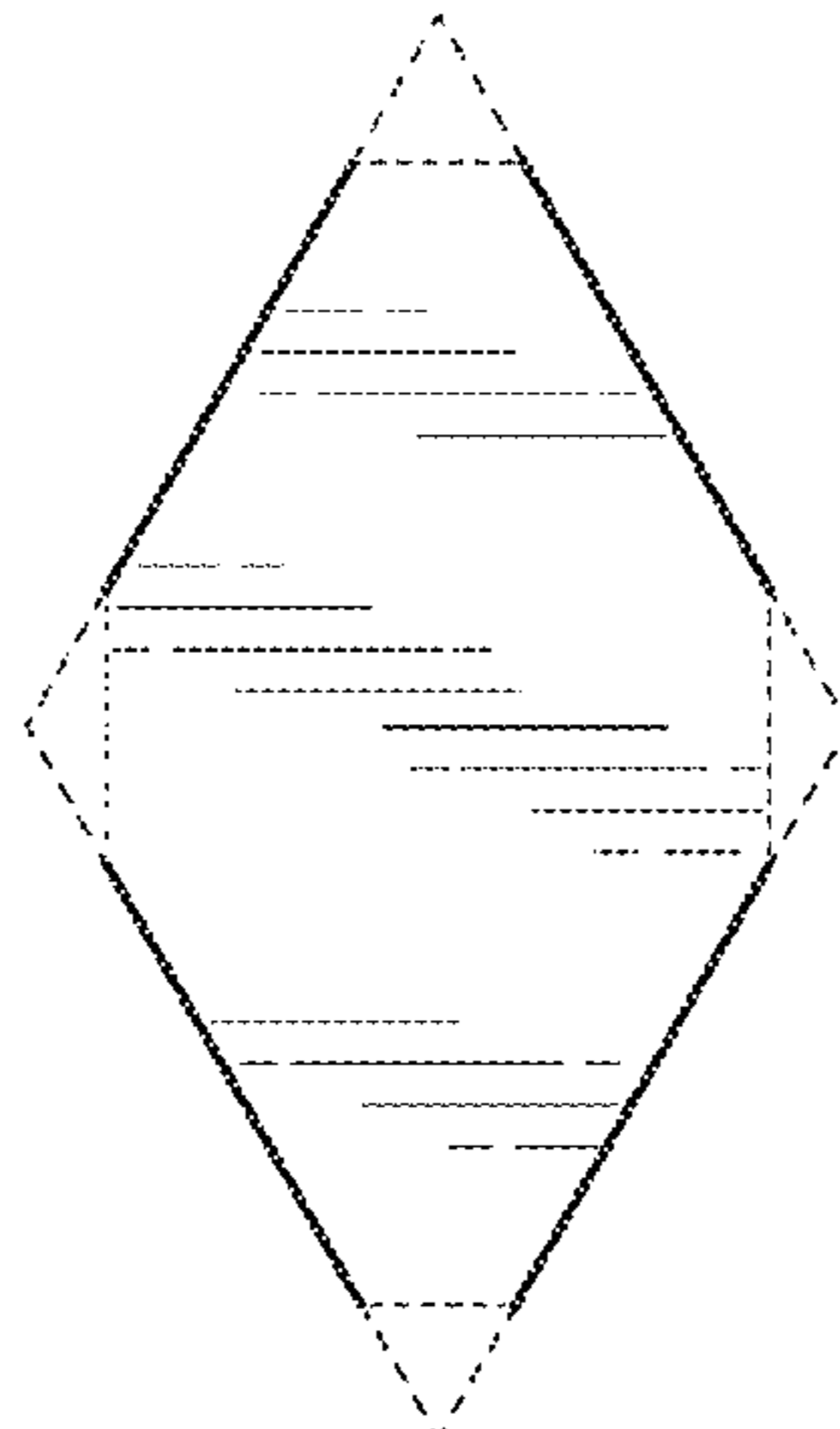
The ornamental design for a diamond-shaped semiconductor die, as shown and described.

DESCRIPTION

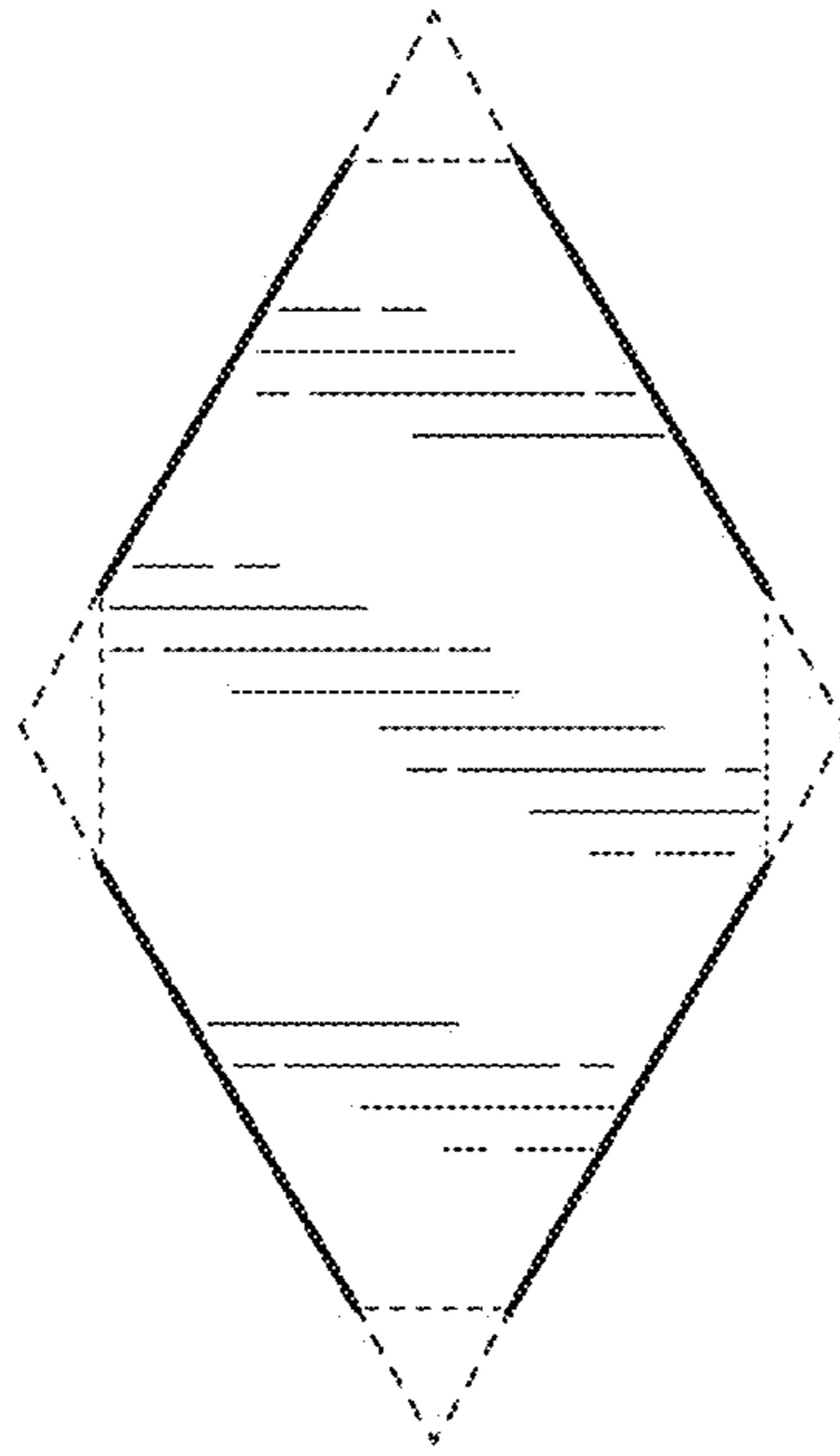

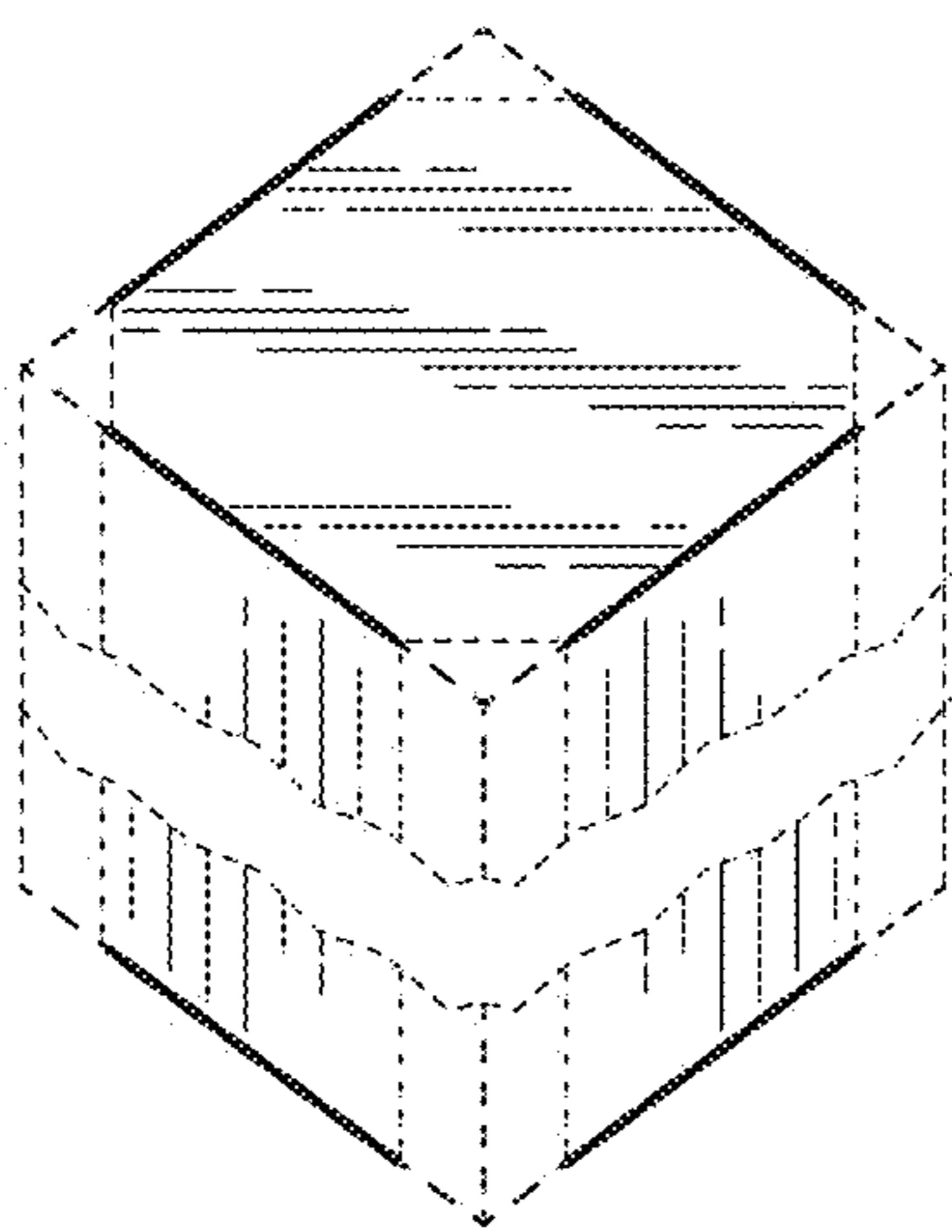

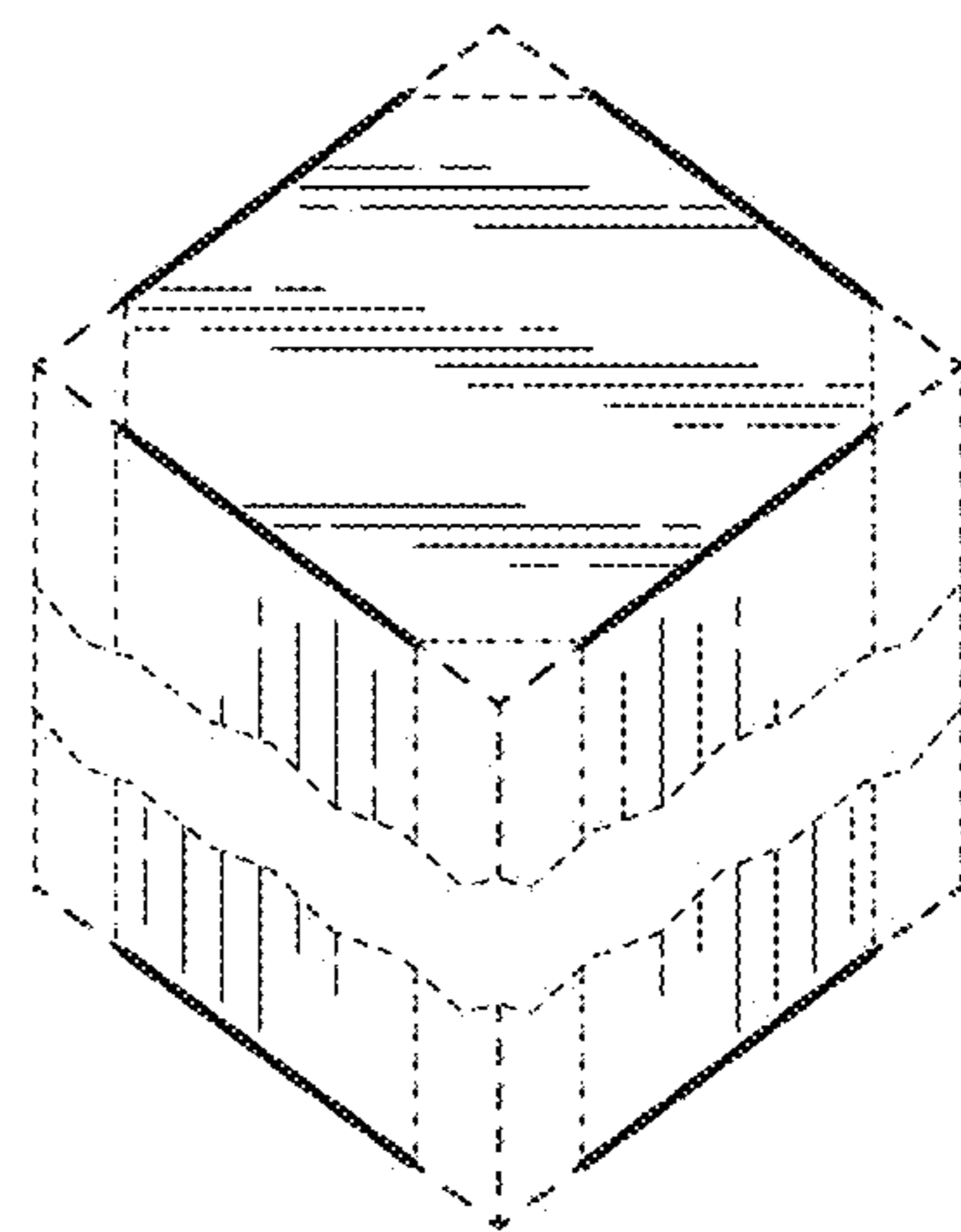

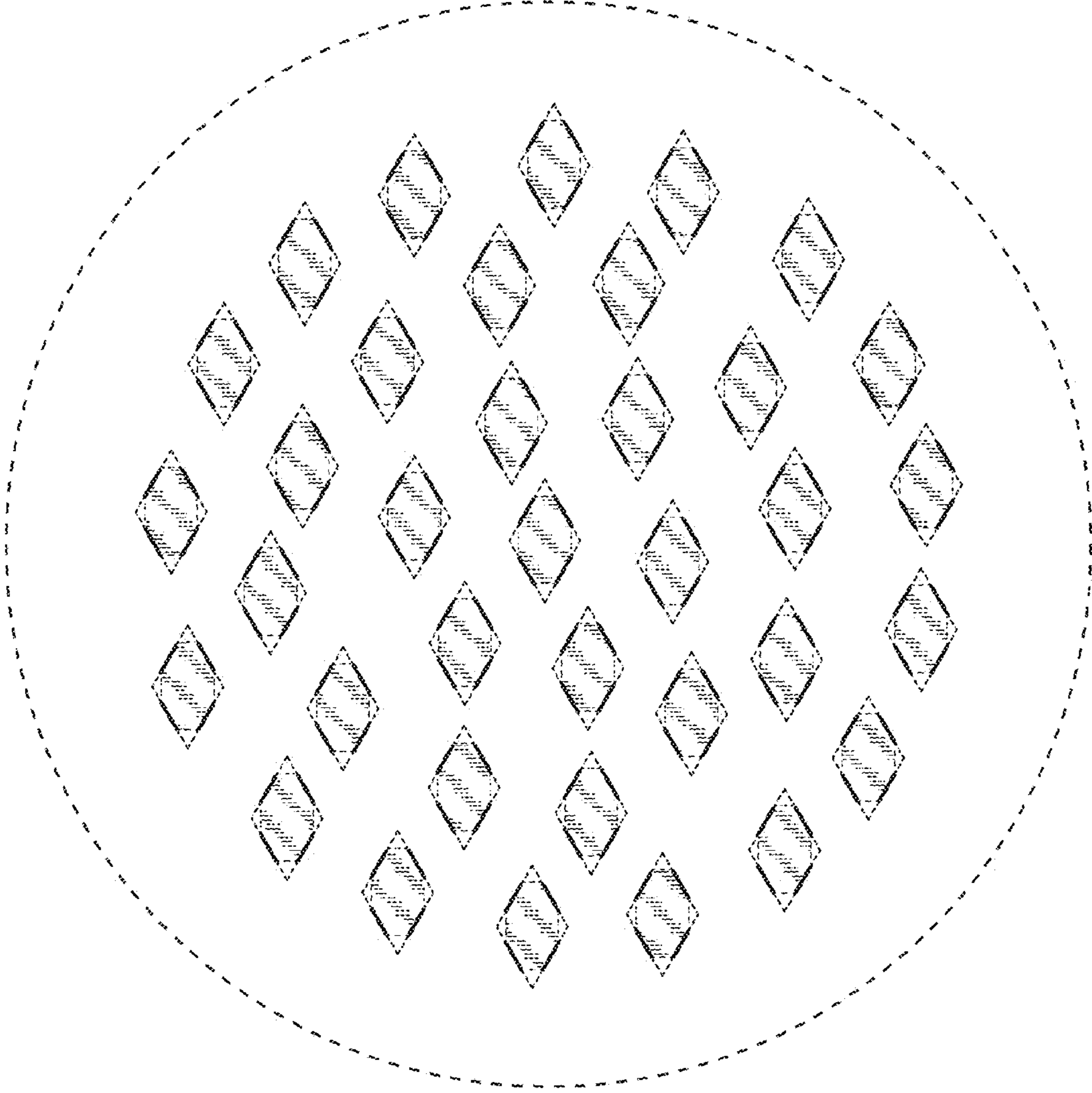

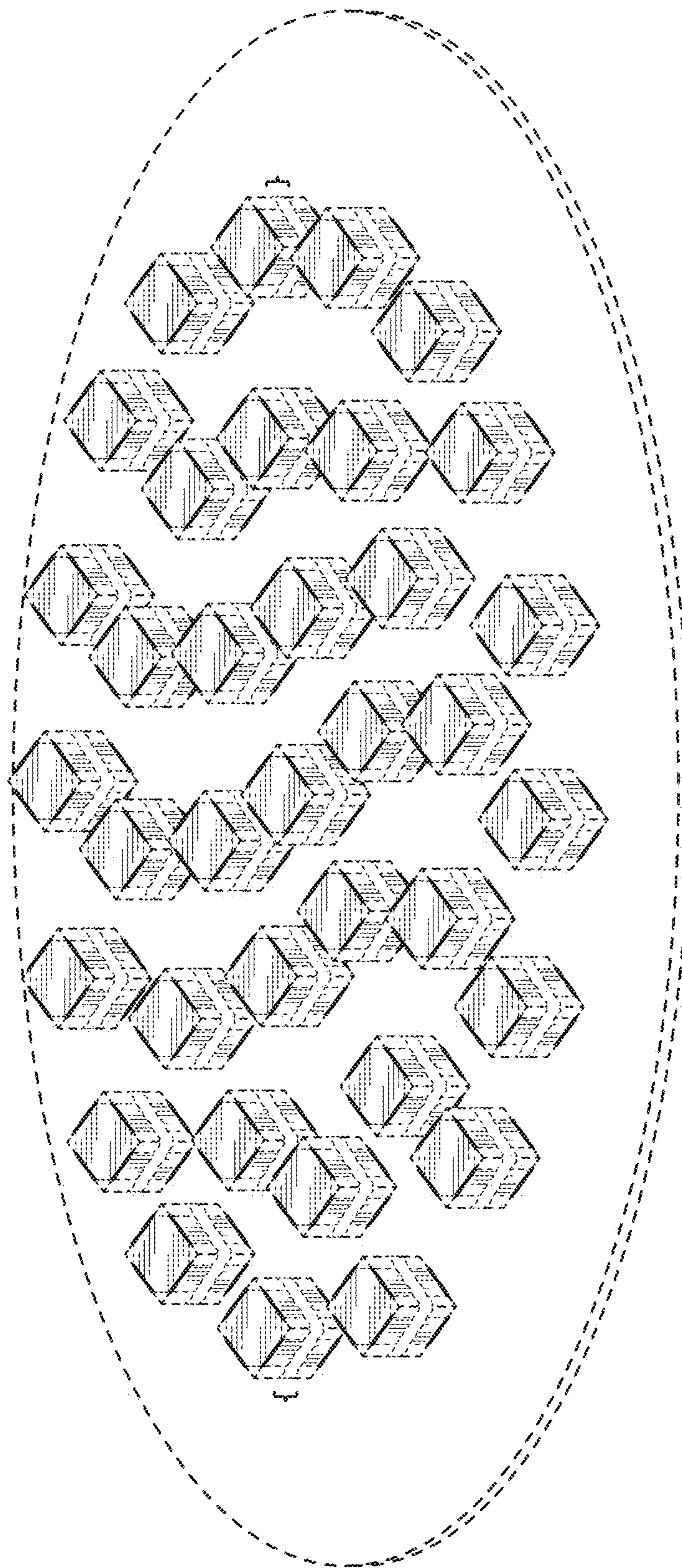

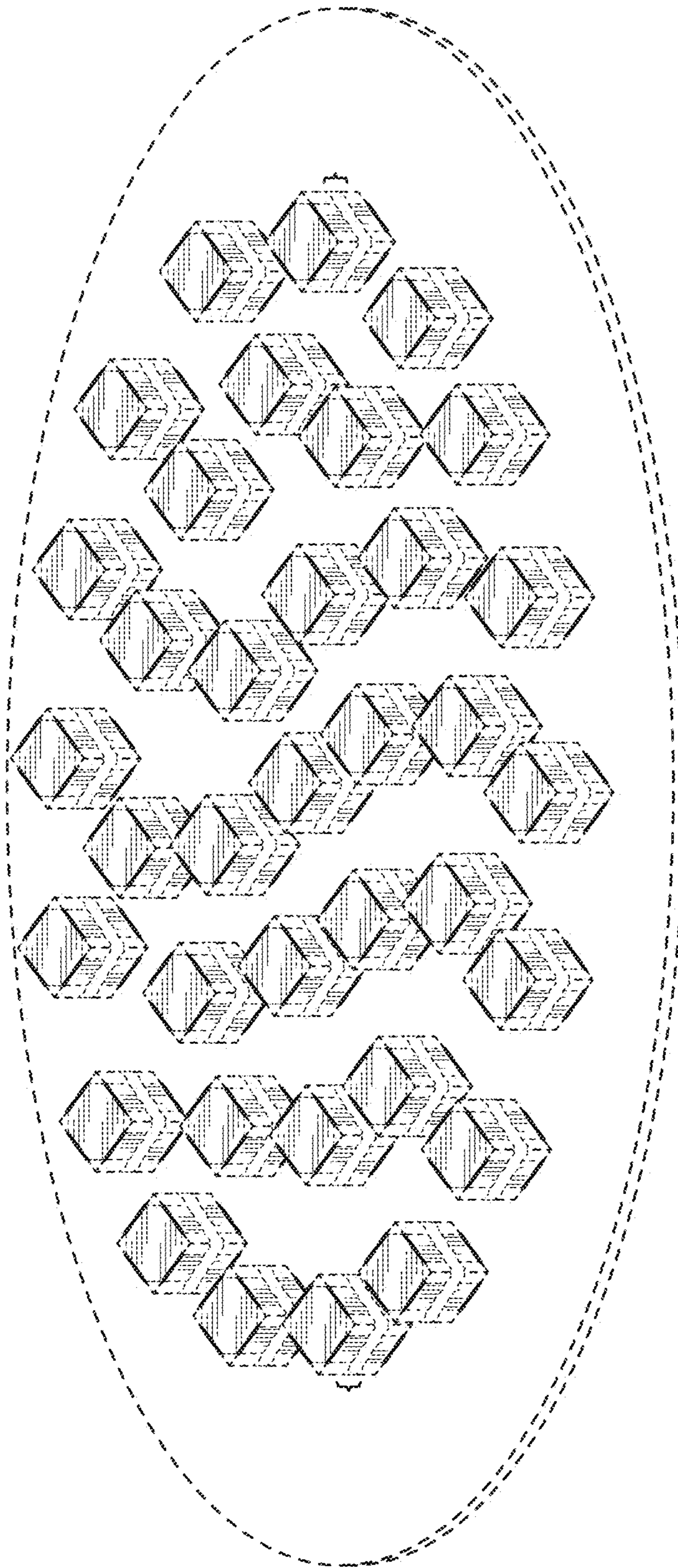

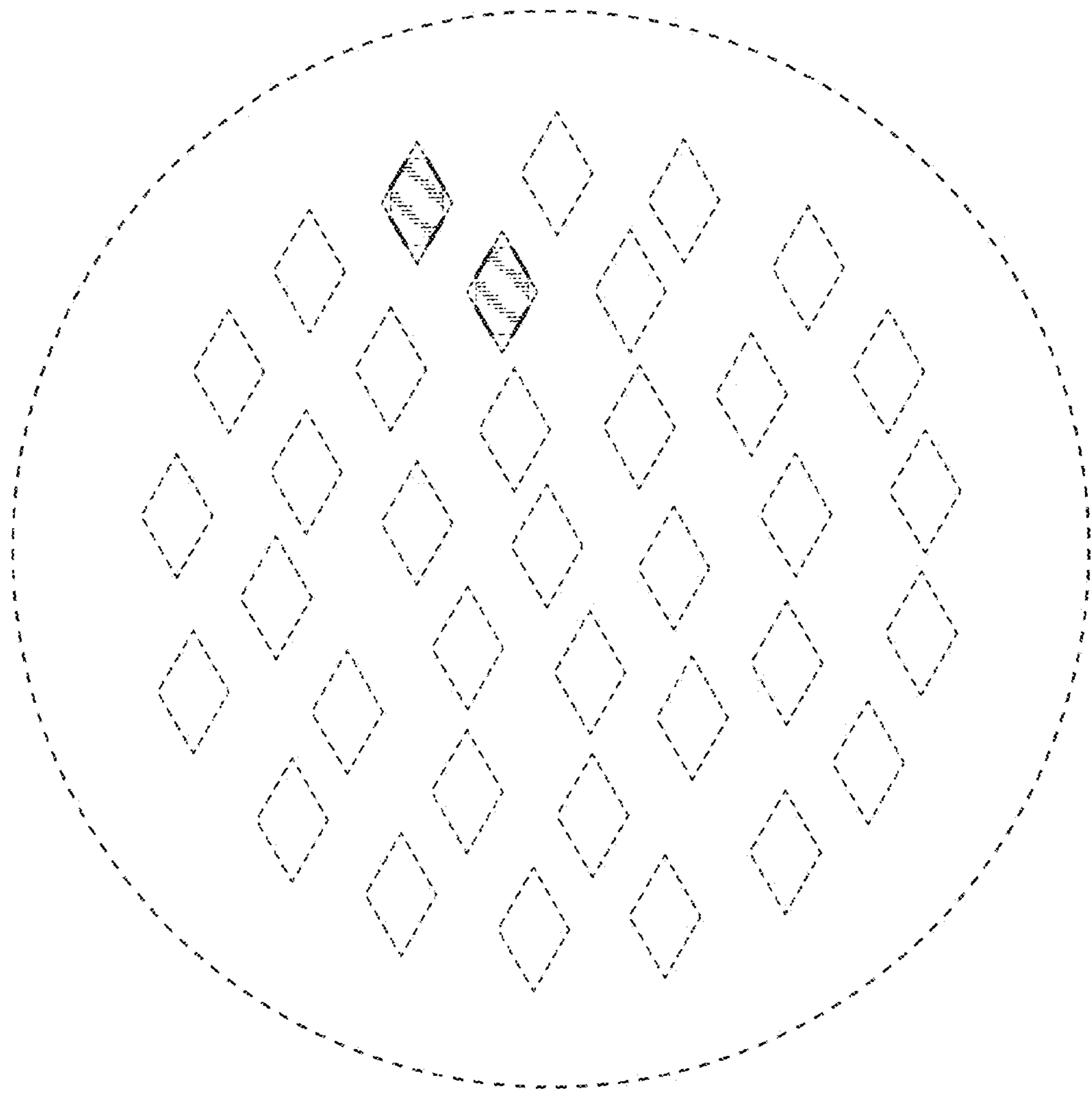

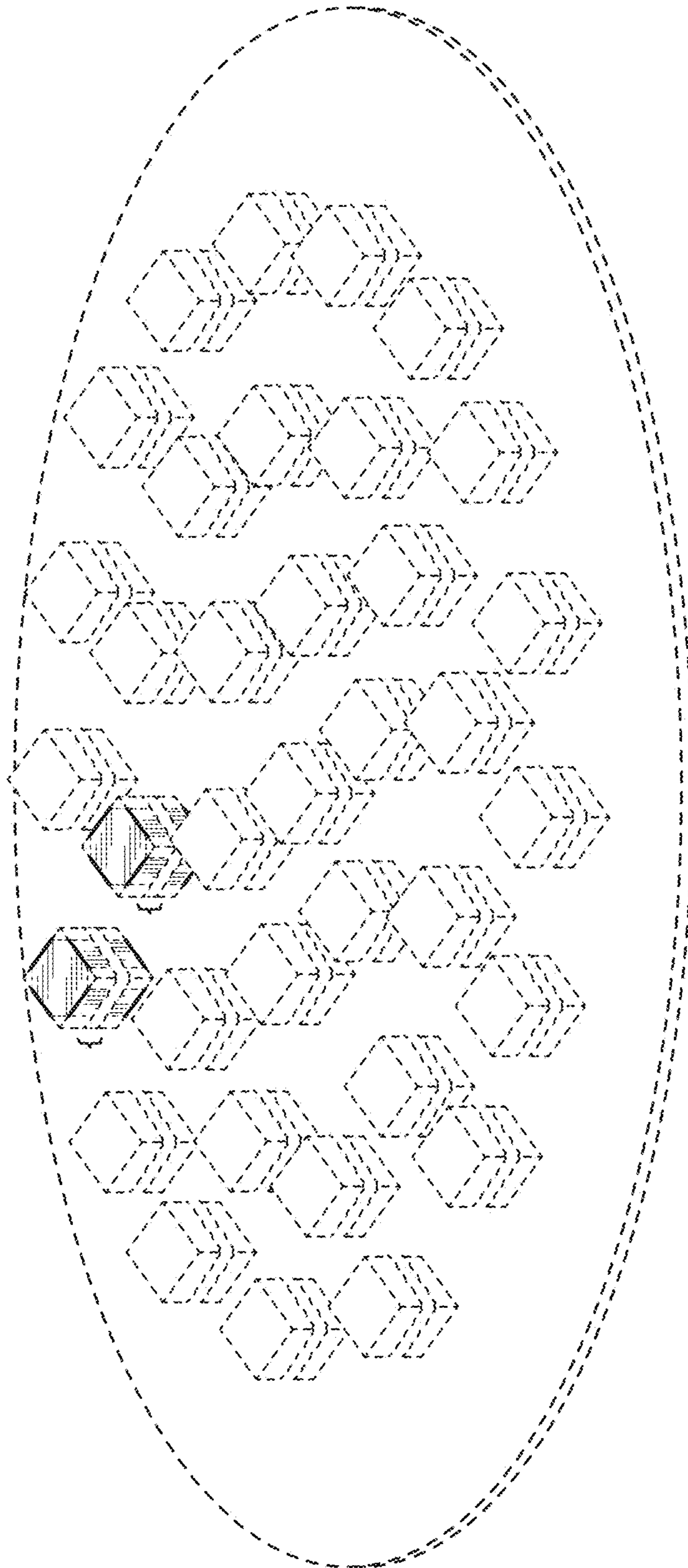

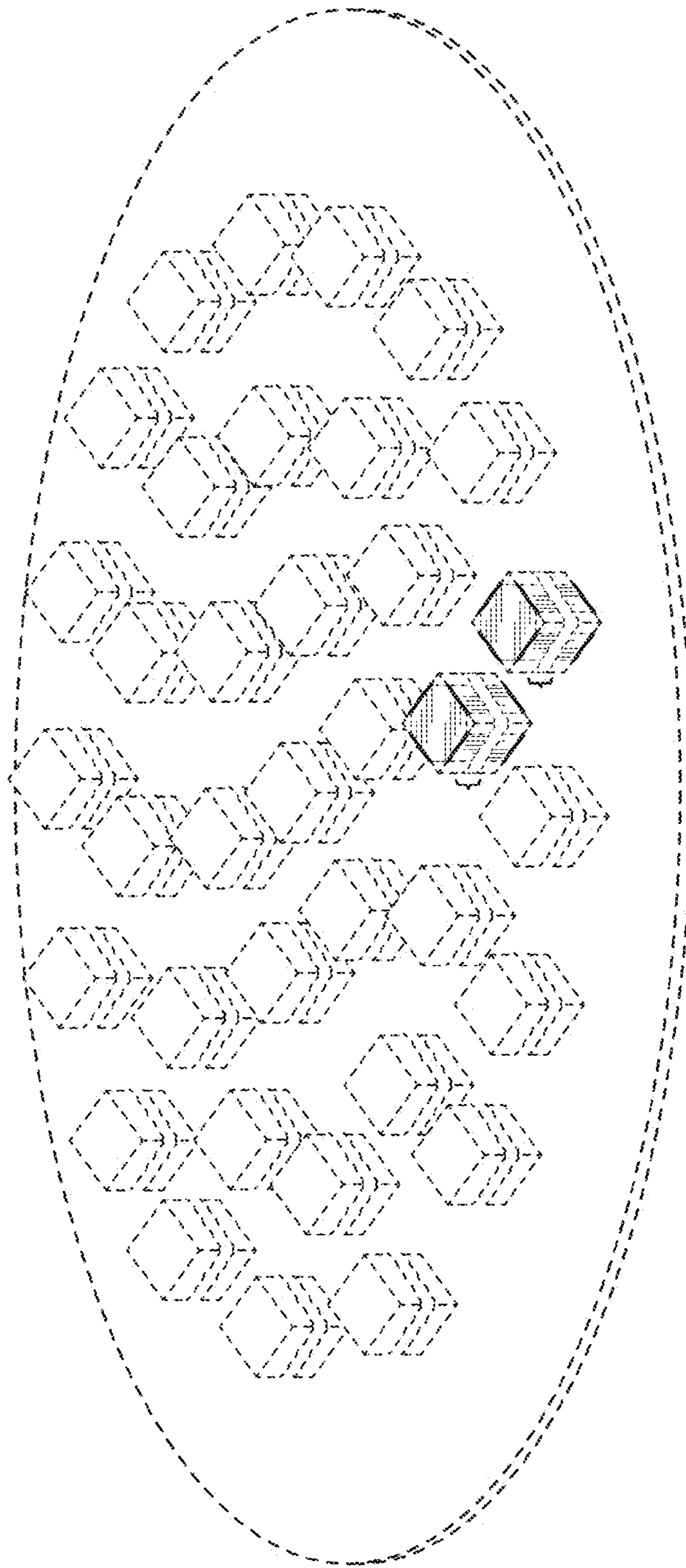

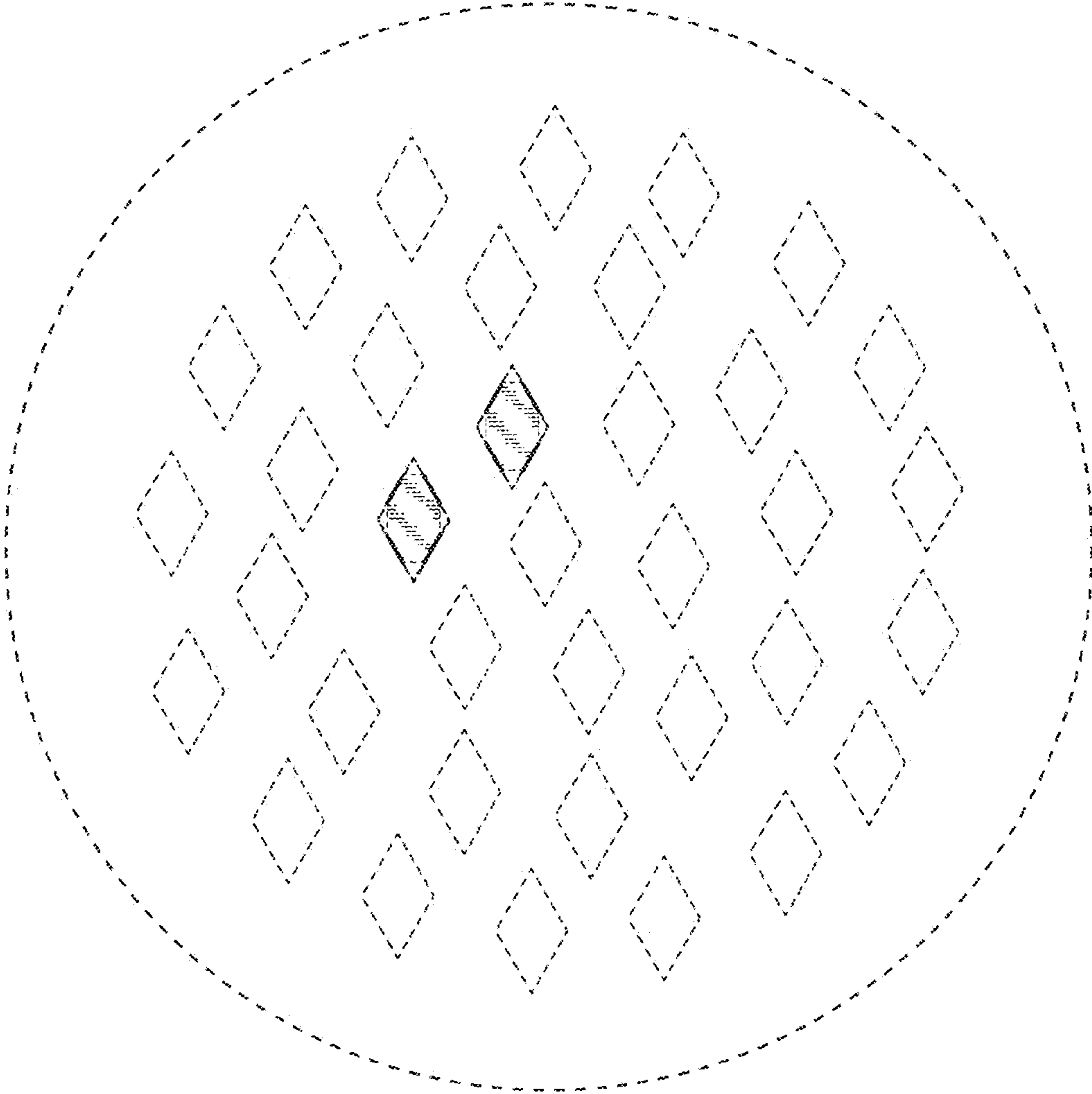

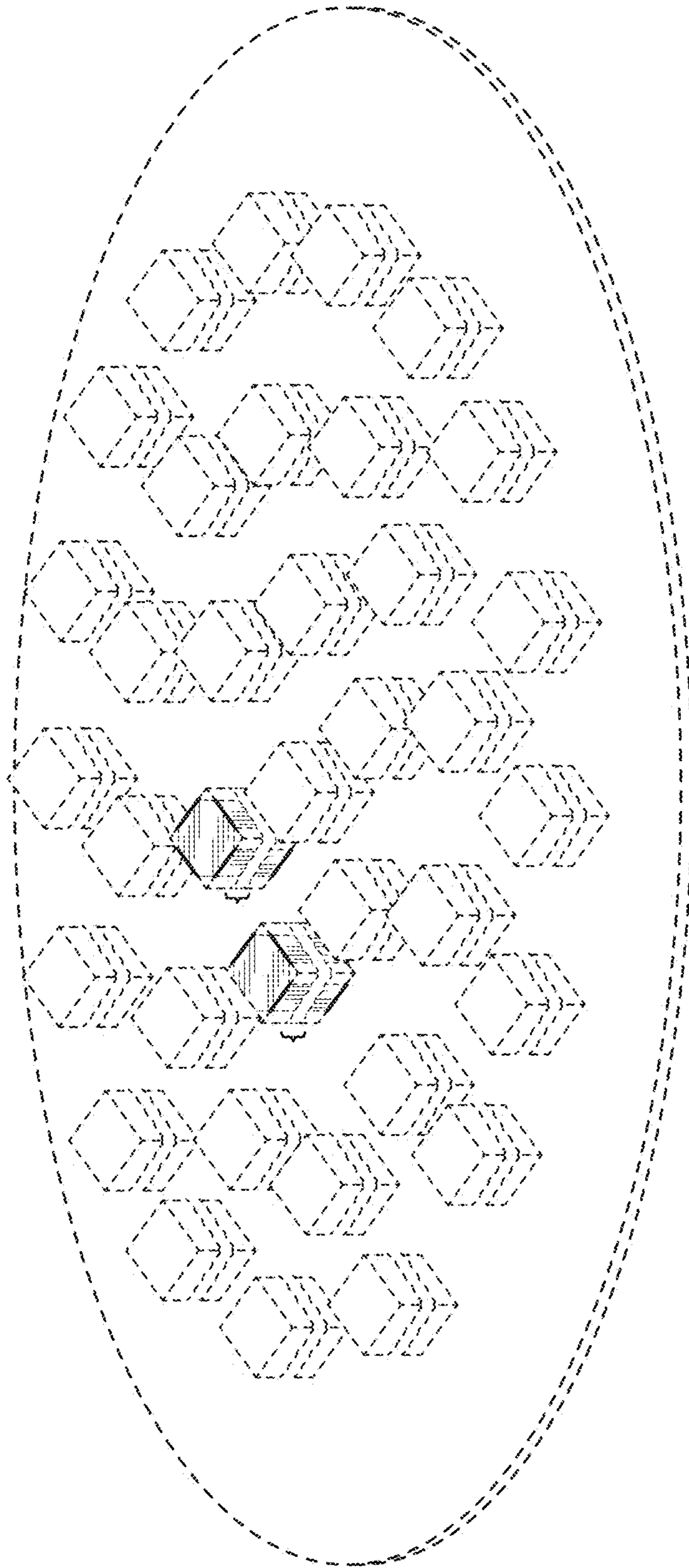

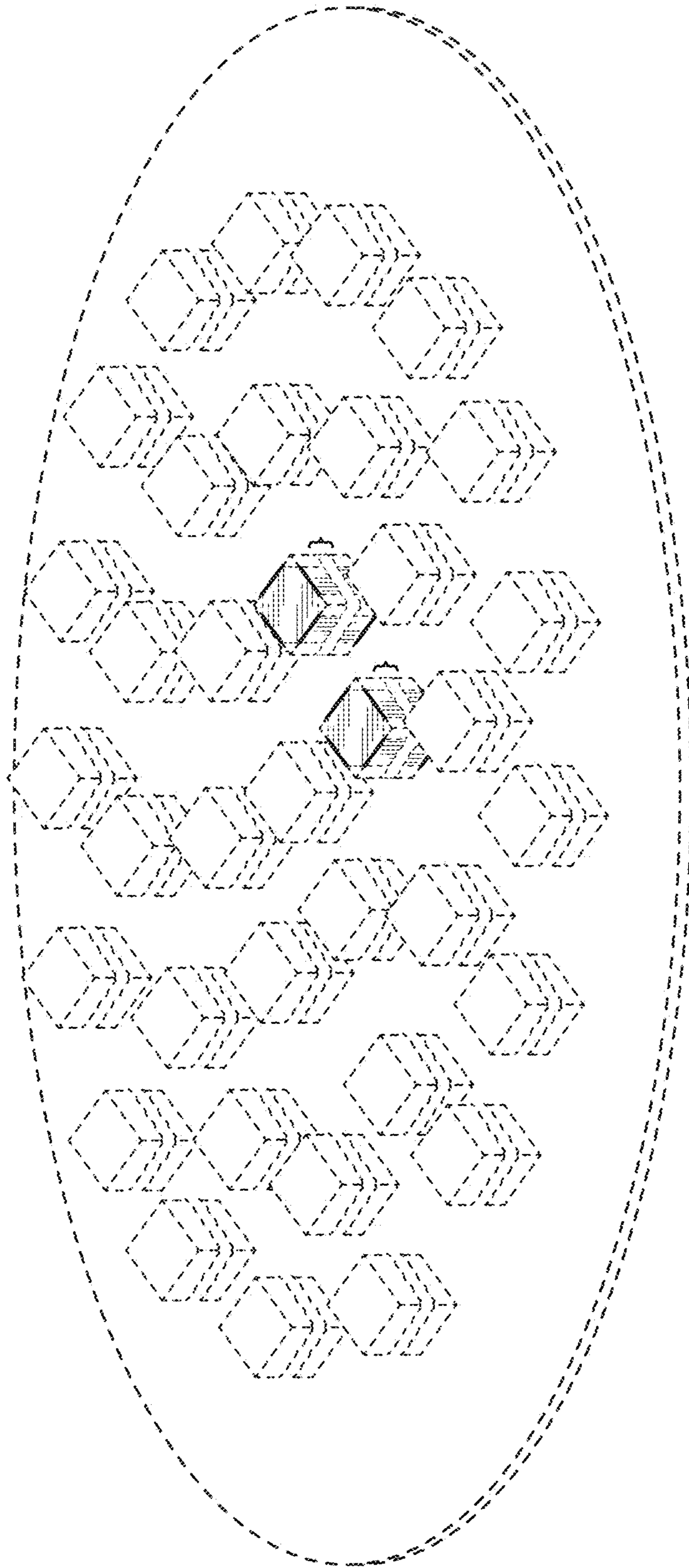

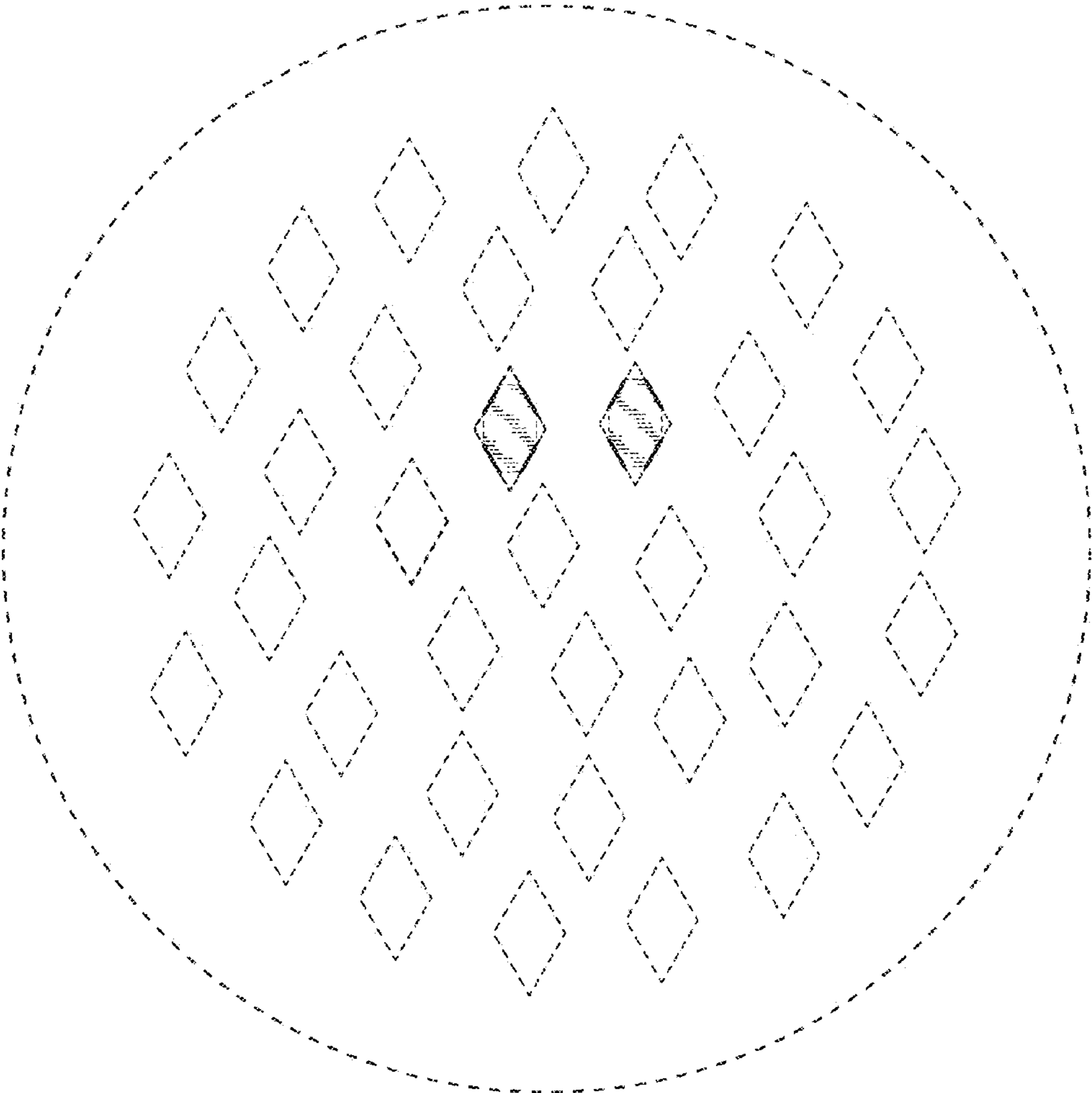

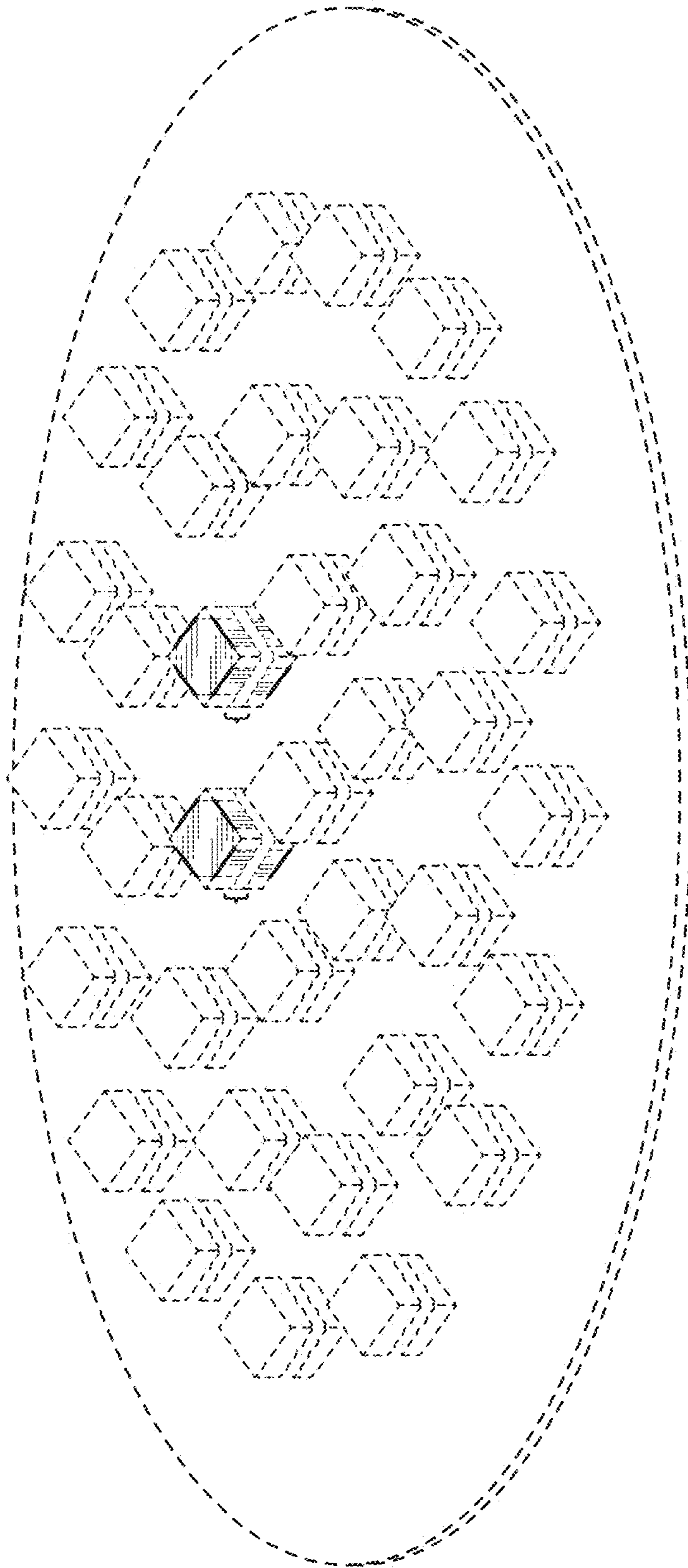

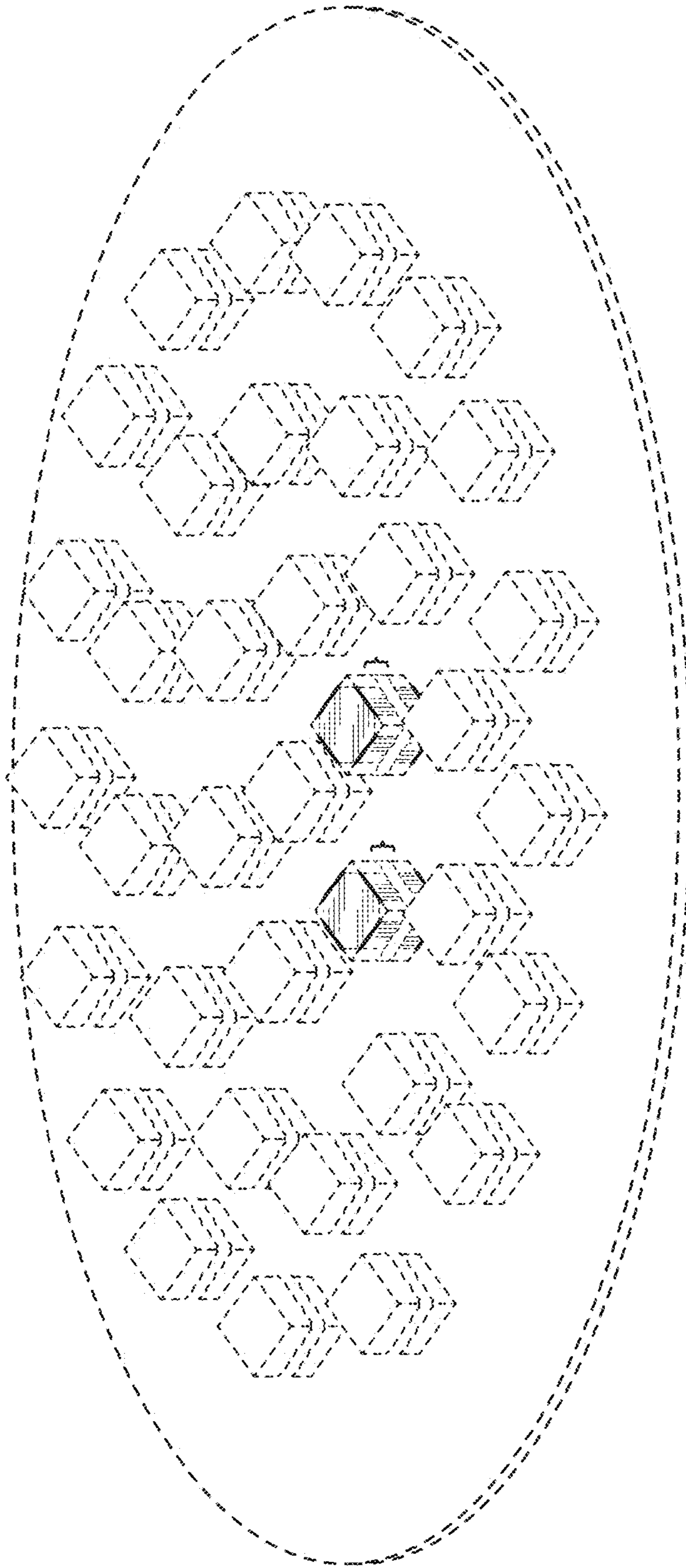

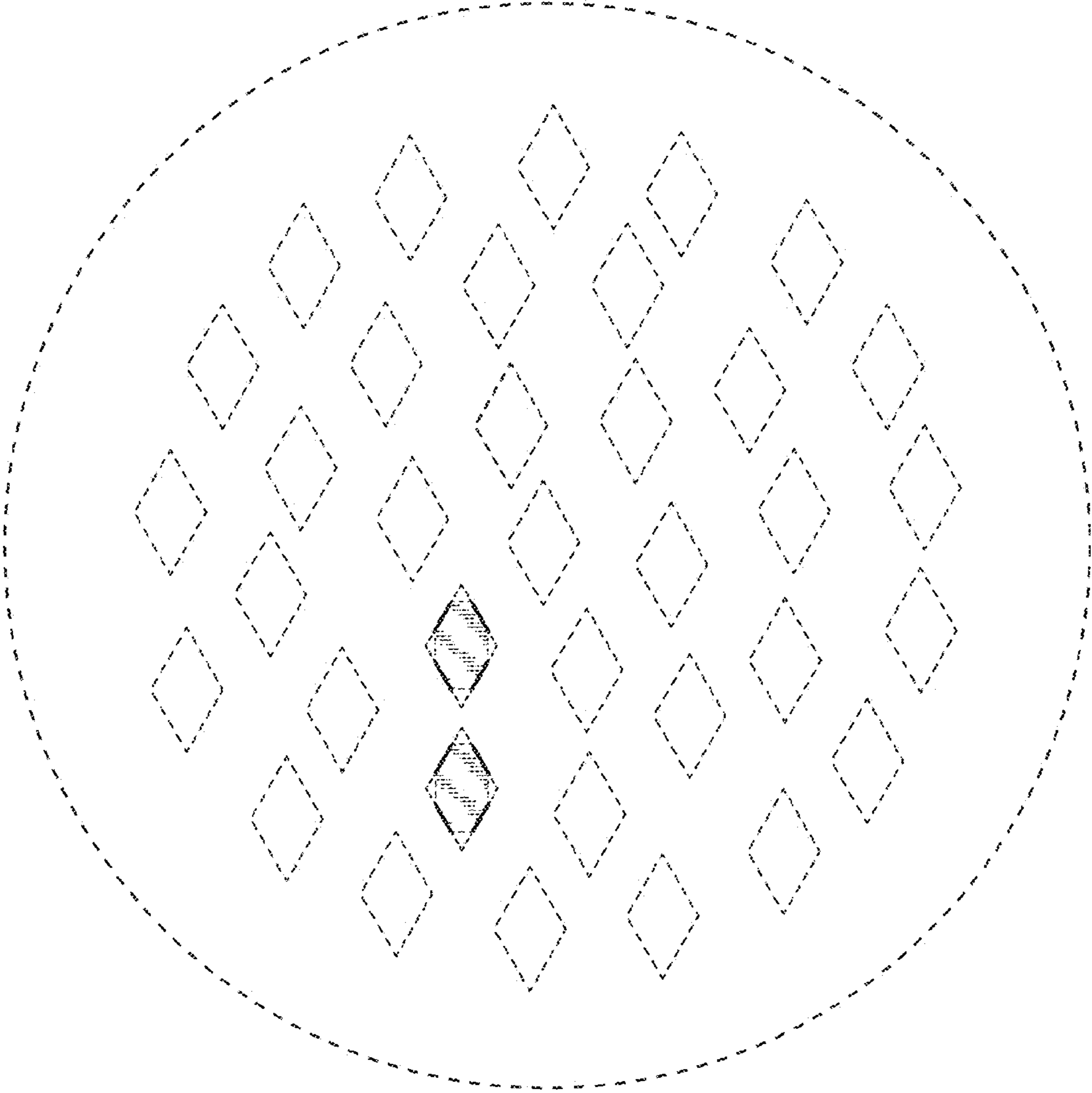

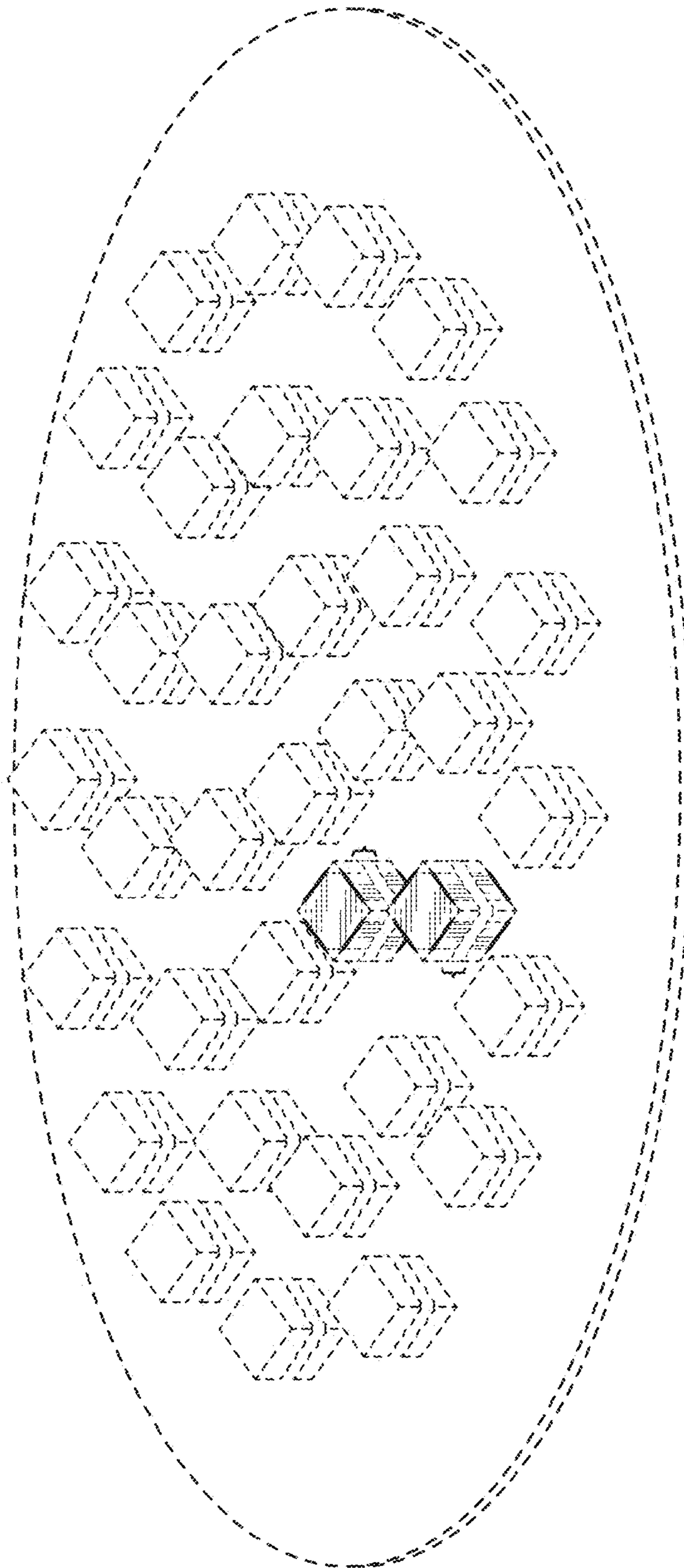

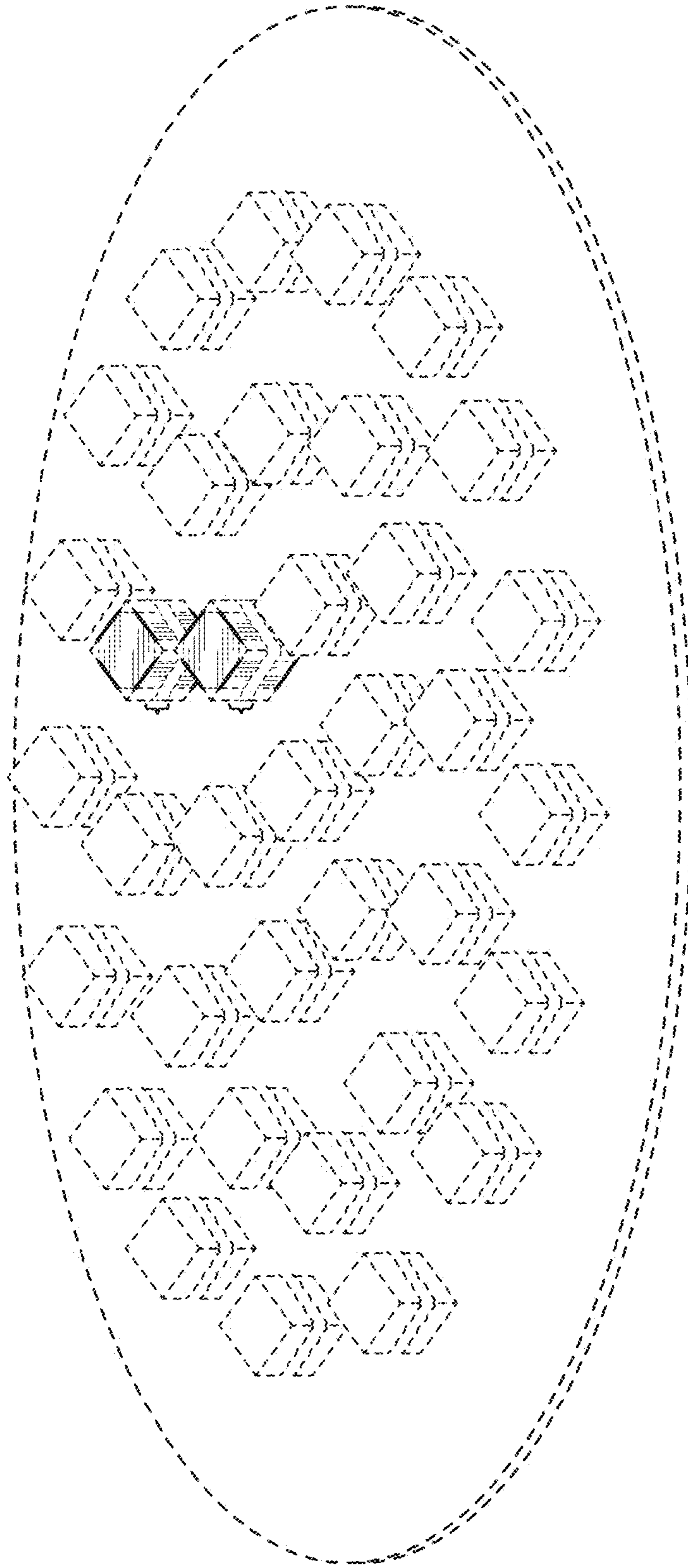
