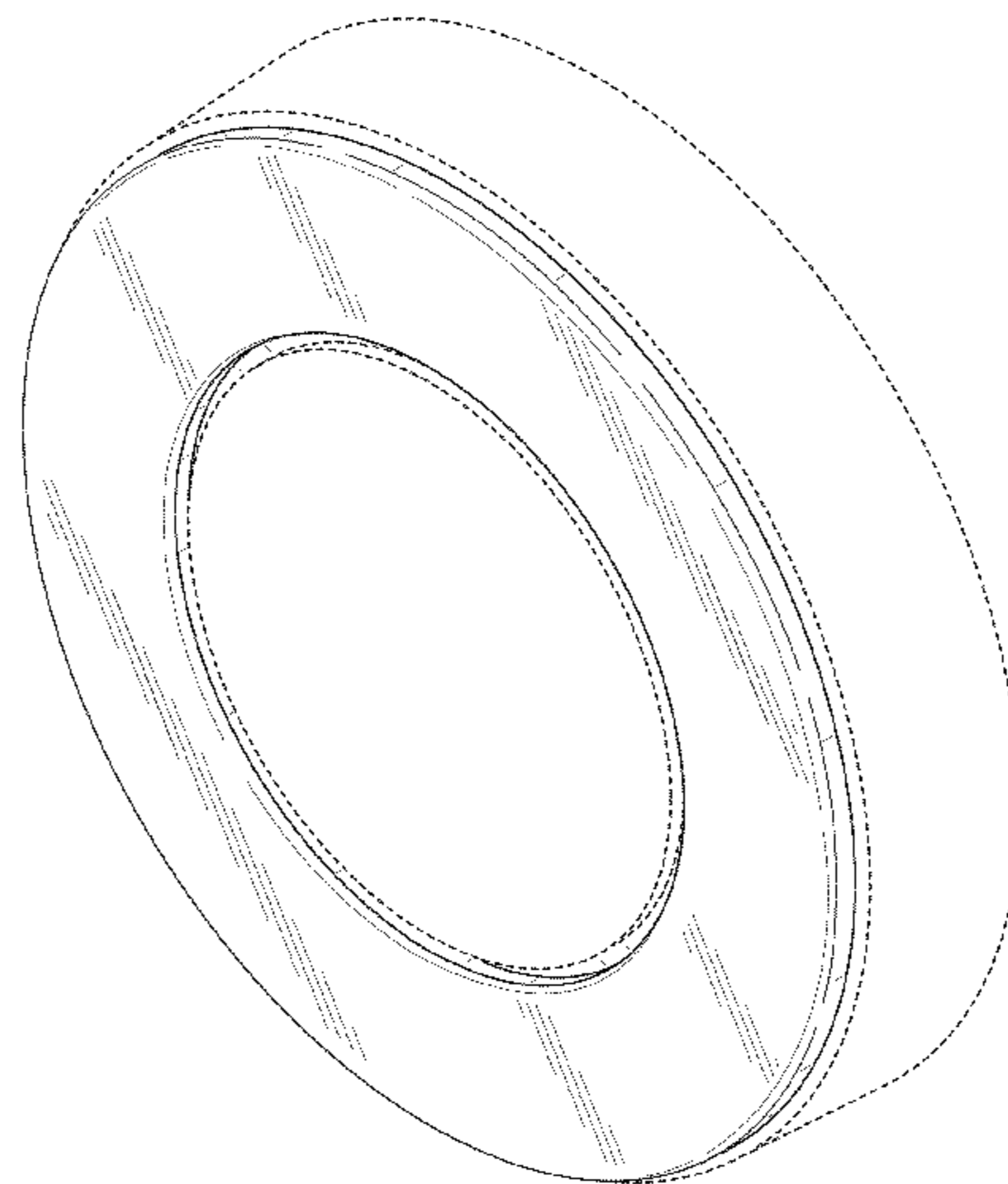

FIG. 1 is a front perspective view of a microphone of the present invention;
FIG. 2 is a front view thereof;

FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

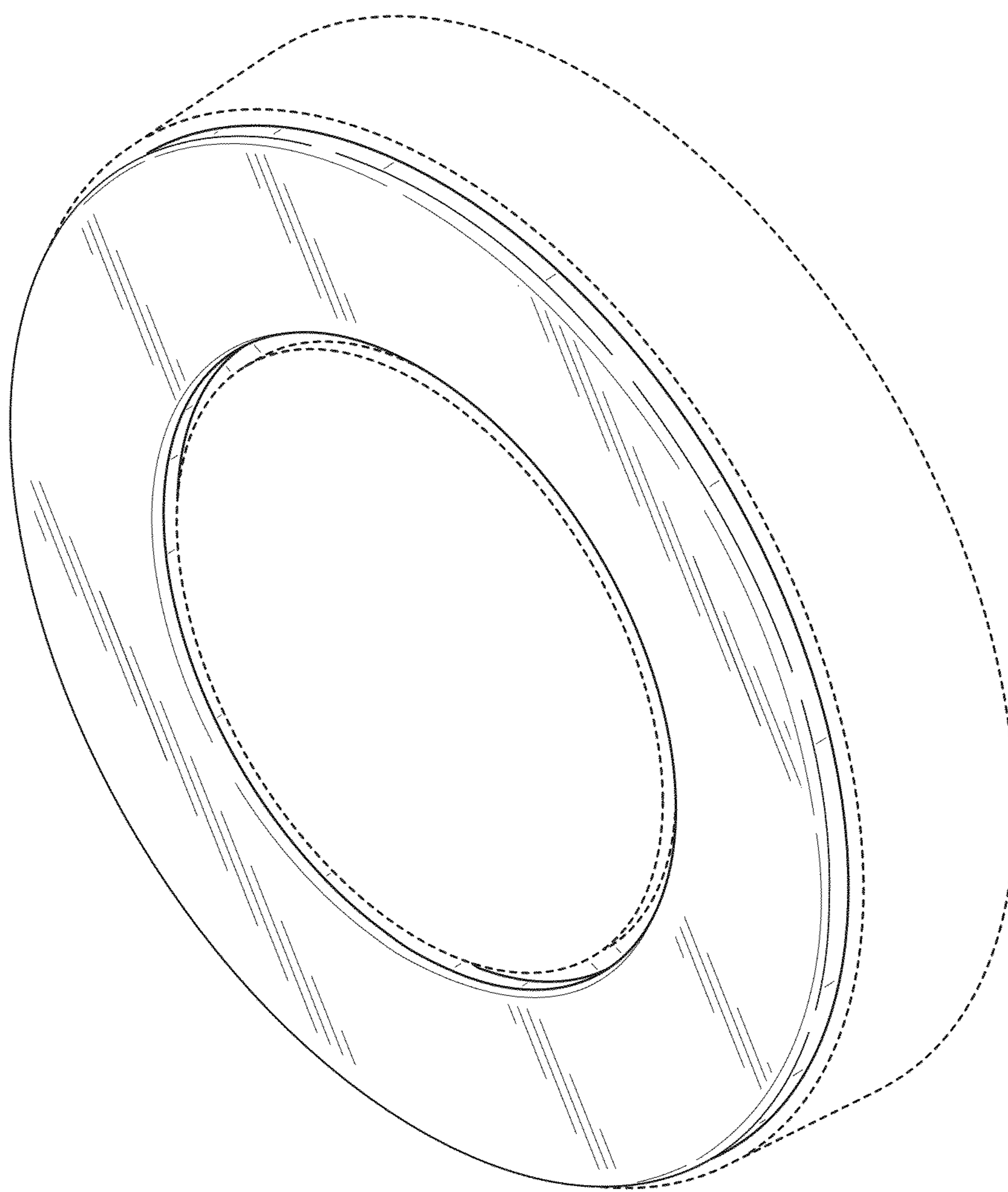

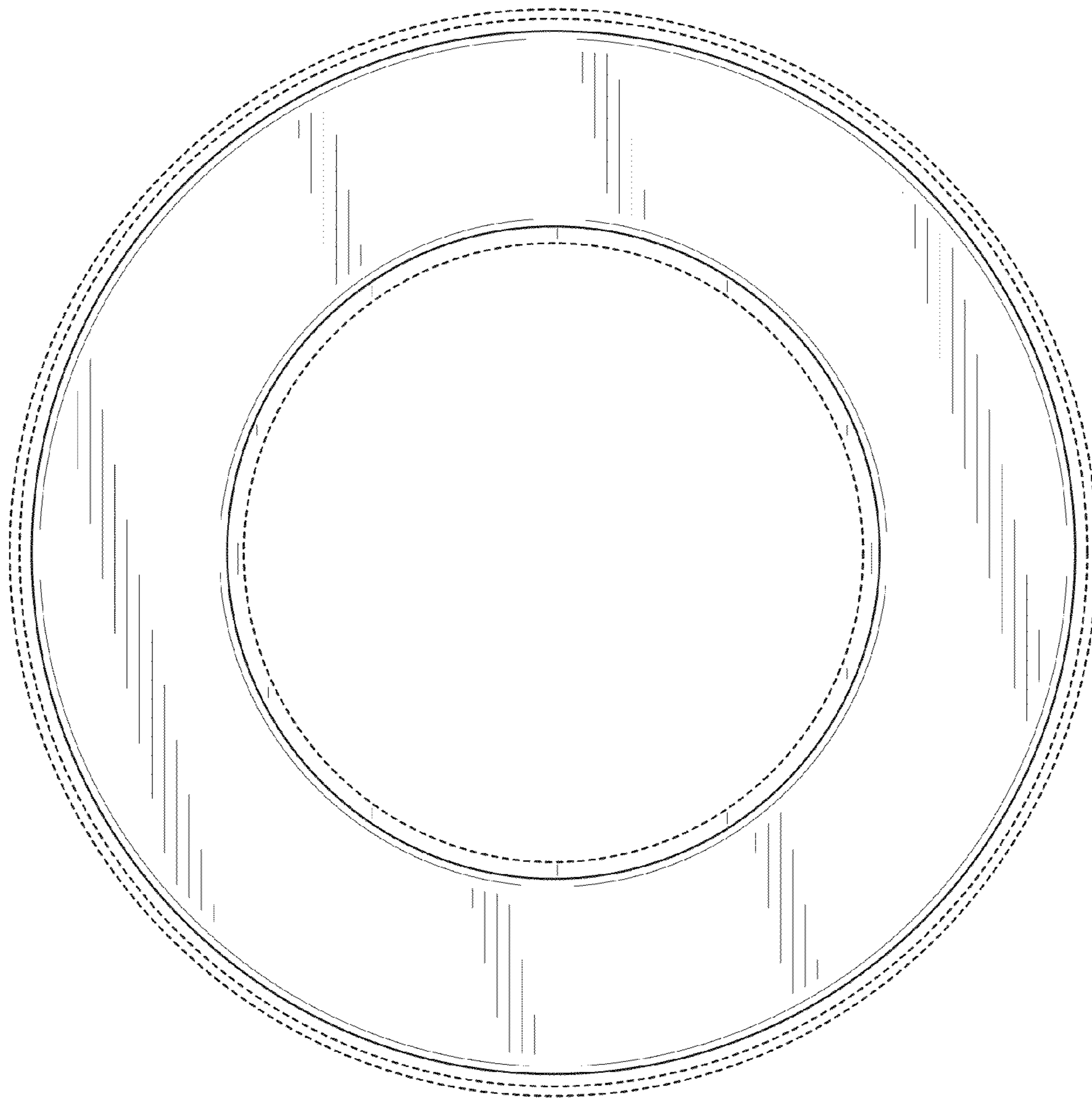

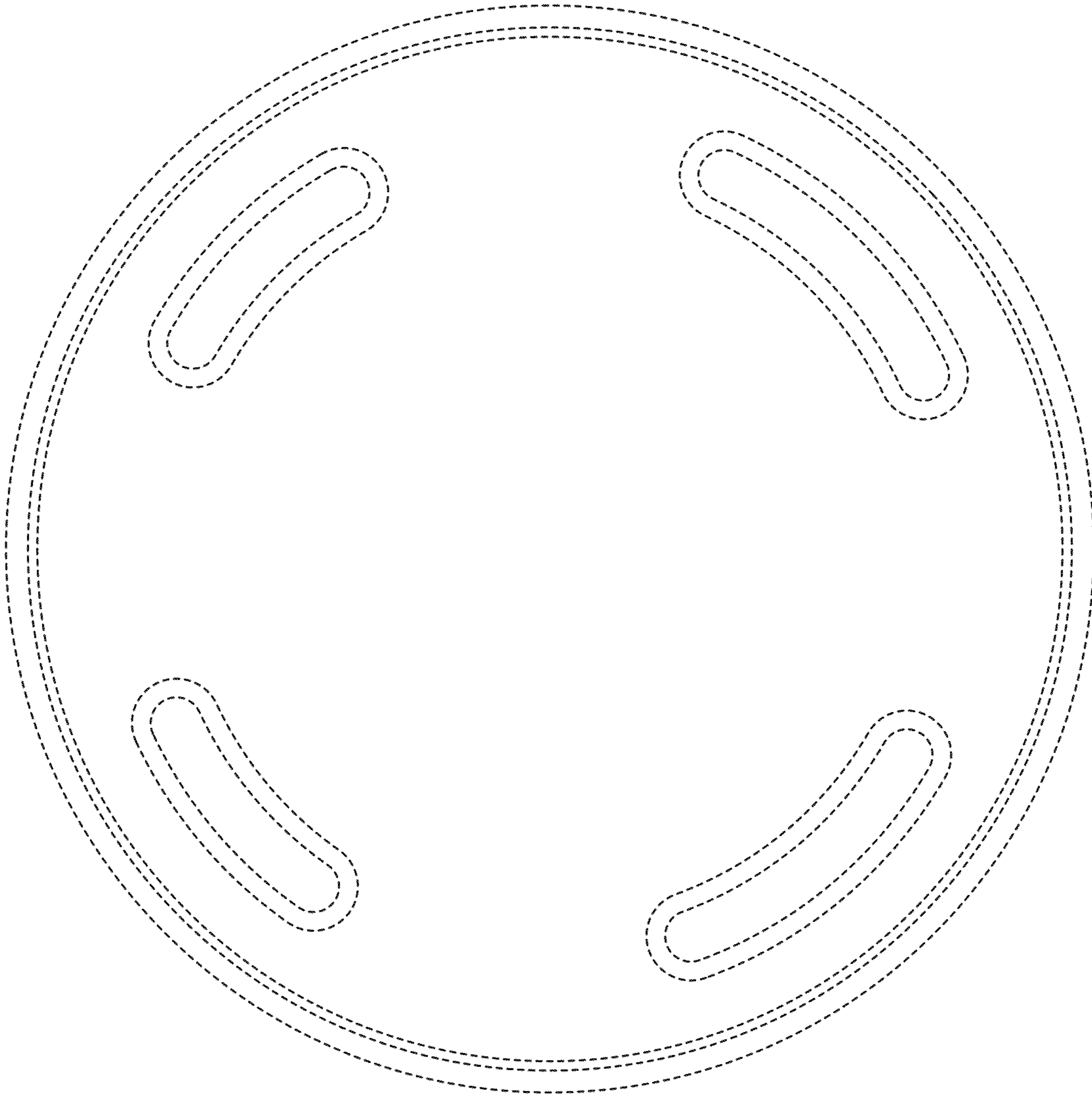

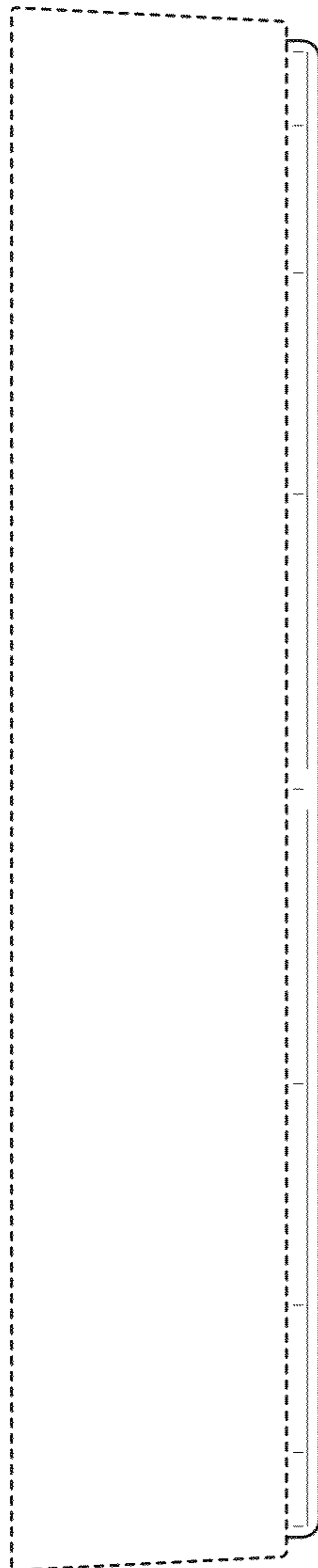

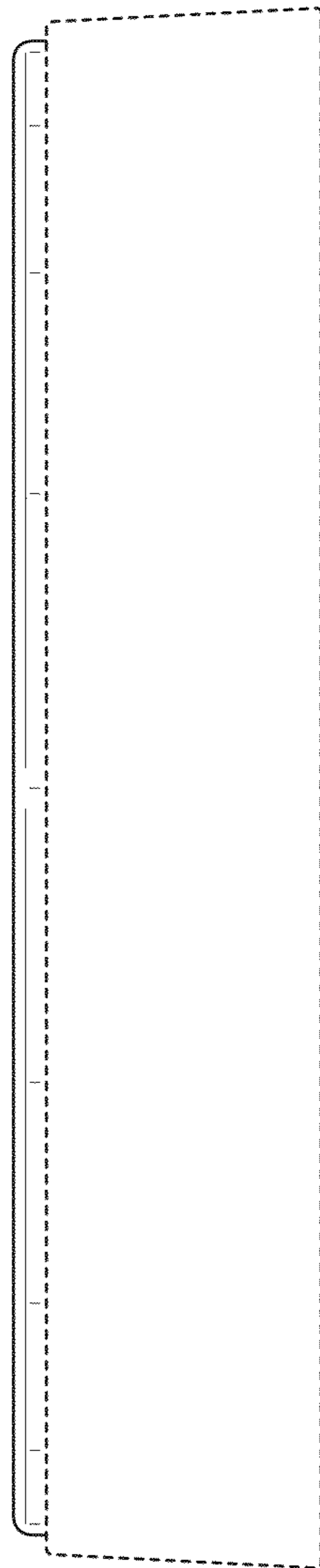
