(57) **CLAIM**

The ornamental design for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mobile phone showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left-side view thereof;

FIG. 5 is a right-side view thereof;

FIG. 6 is a top view thereof;

FIG. 7 is a bottom view thereof;

FIG. 8 is a rear perspective view thereof;

FIG. 9 is an enlarged view of the encircled portion shown in FIG. 3;

FIG. 10 is an enlarged view of the encircled portion shown in FIG. 3;

FIG. 11 is an enlarged view of the encircled portion shown in FIG. 3; and,

FIG. 12 is an enlarged view of the encircled portion shown in FIG. 3.

The dot-dash broken lines in FIGS. 3 and 9-12 indicate portions of the claimed design shown in an enlarged scale.

The dash-dash lines immediately adjacent to the claimed shaded surfaces represent bounds of the claimed design, all other dash-dash broken lines depict unclaimed portions of the mobile phone only and form no part of the claimed design.

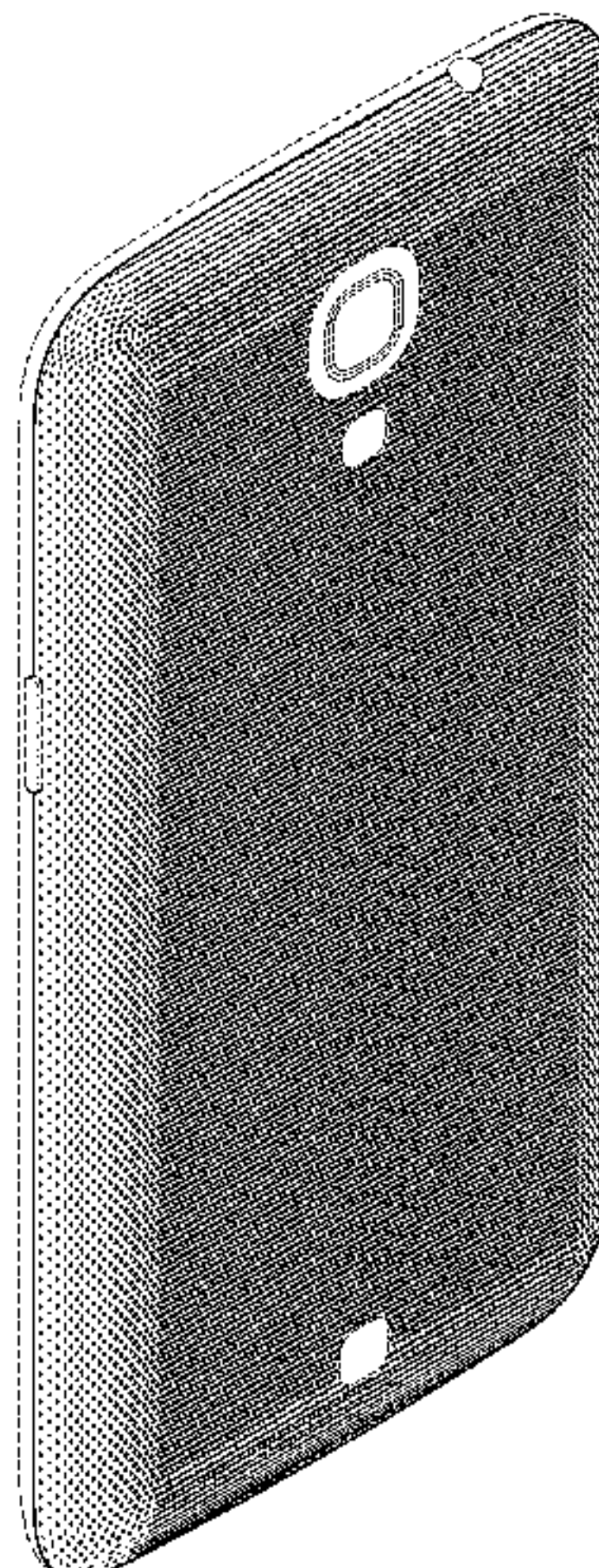

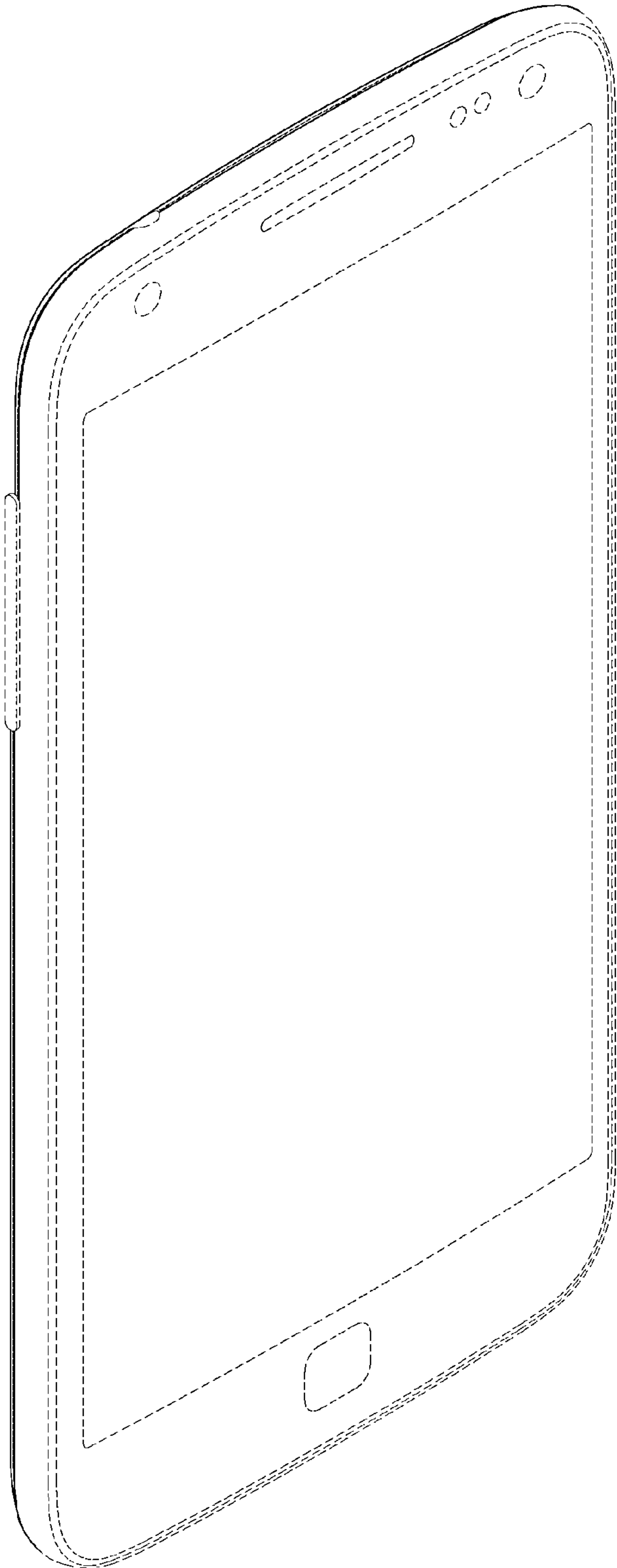

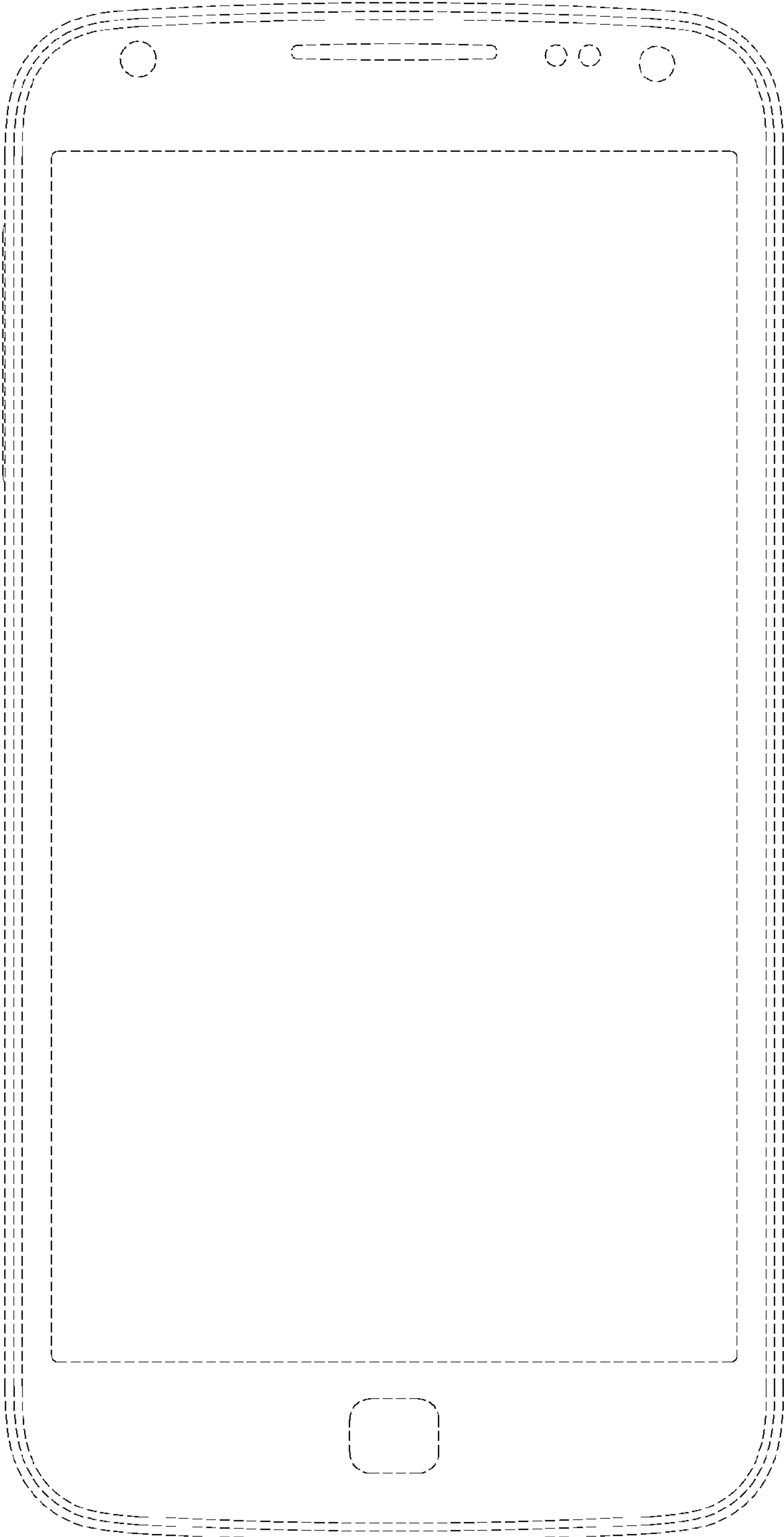

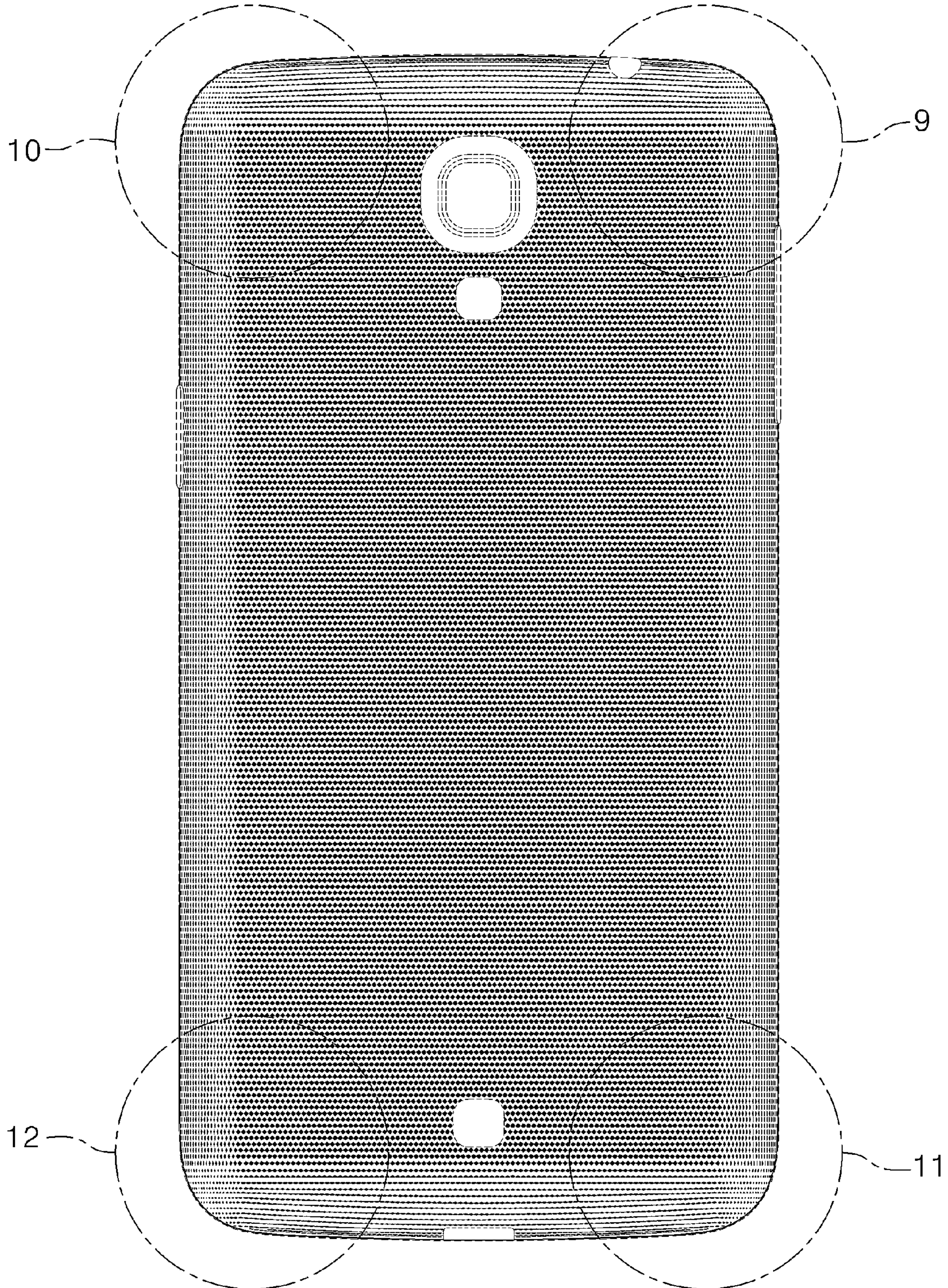

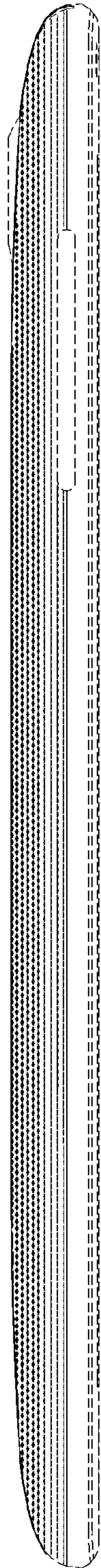

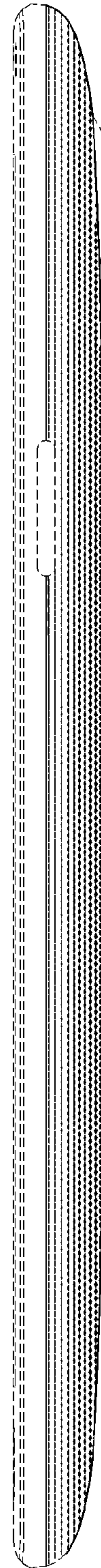

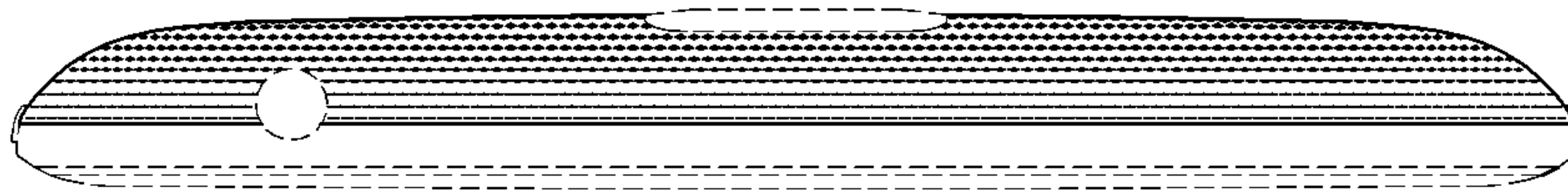

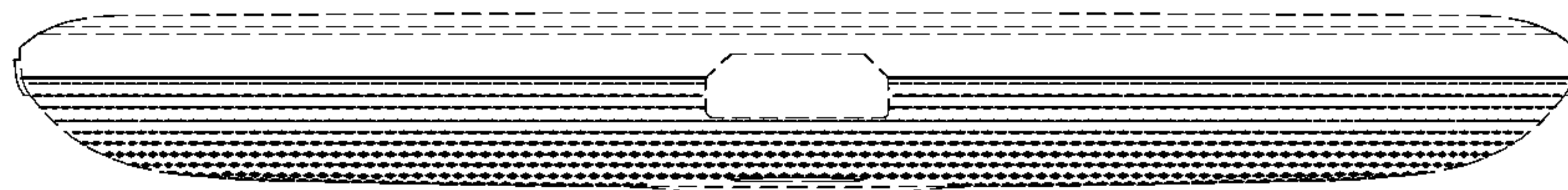

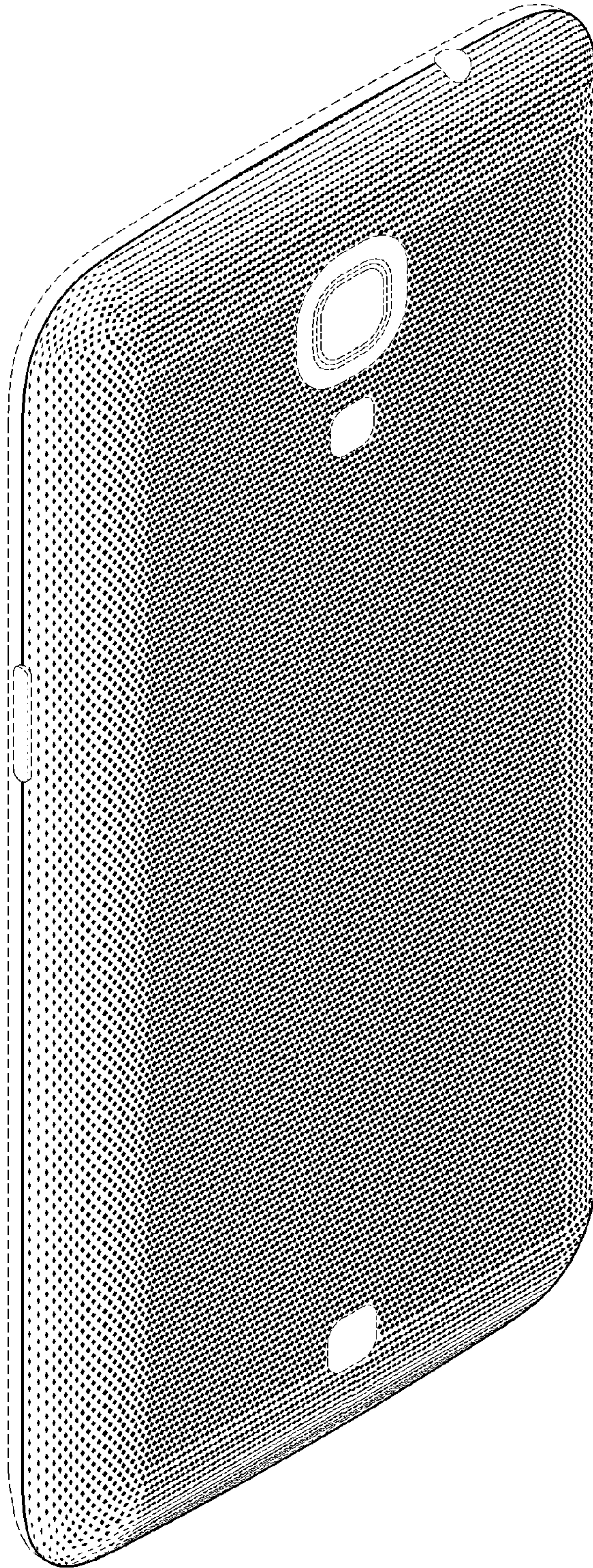

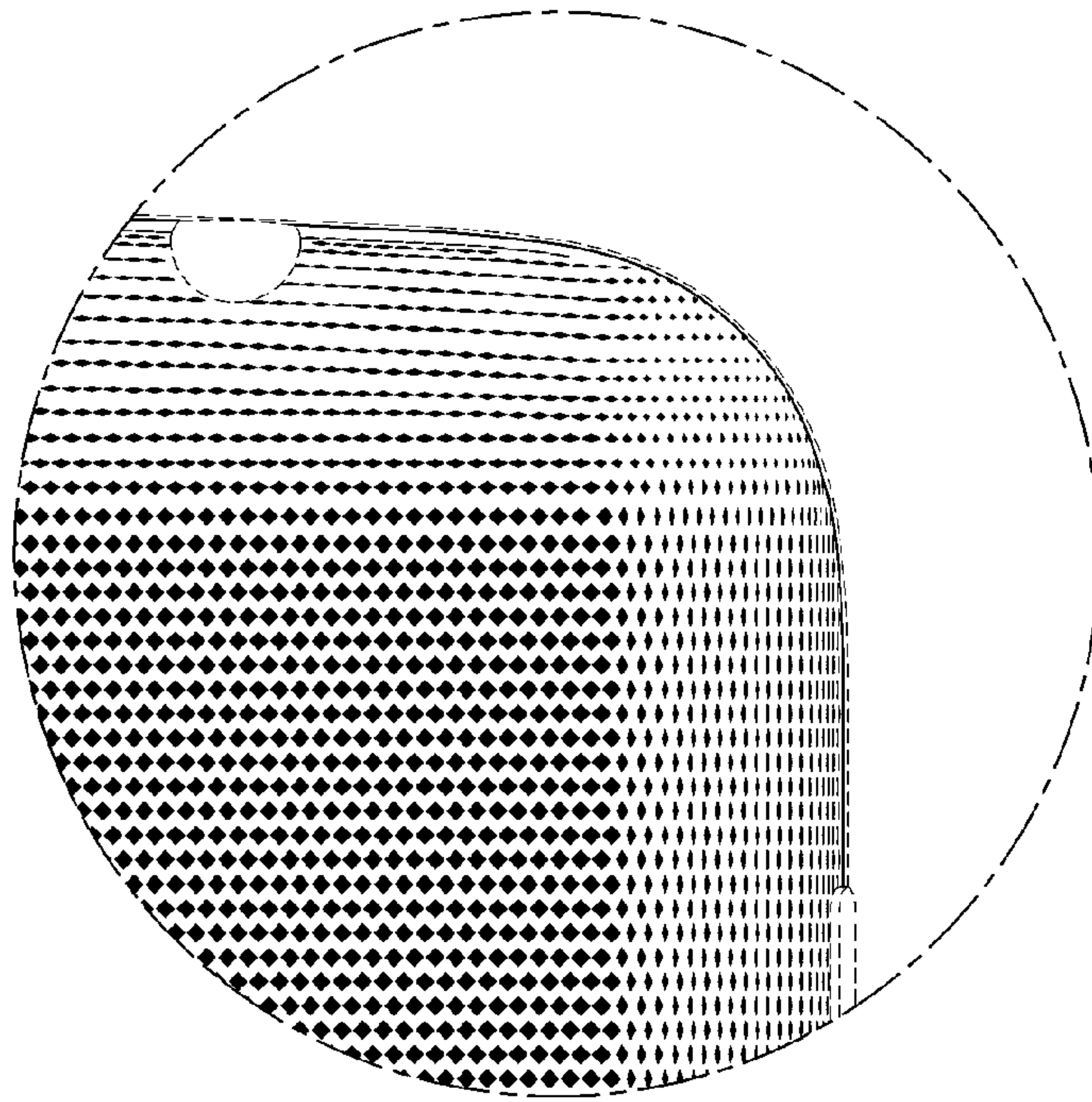

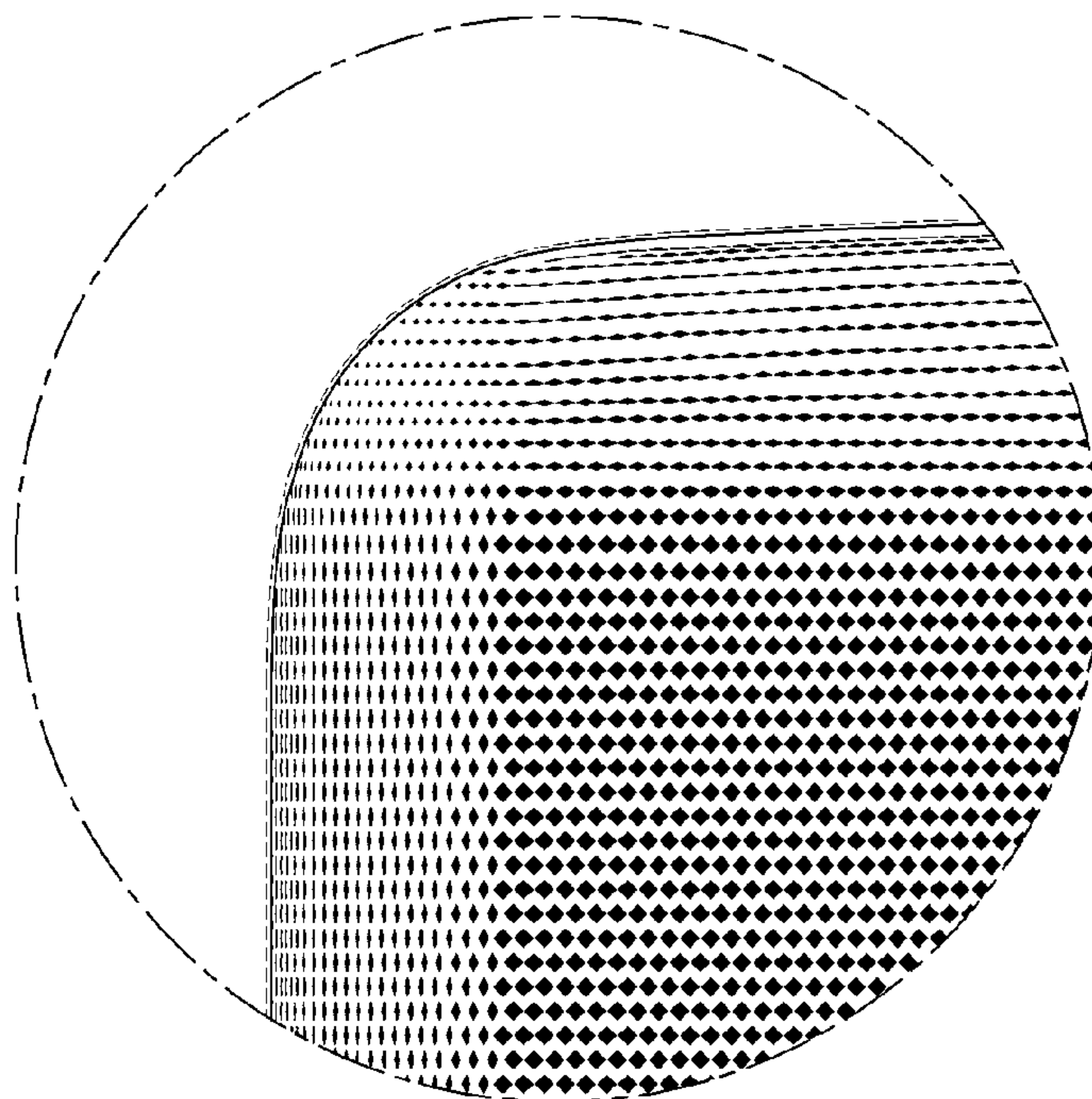

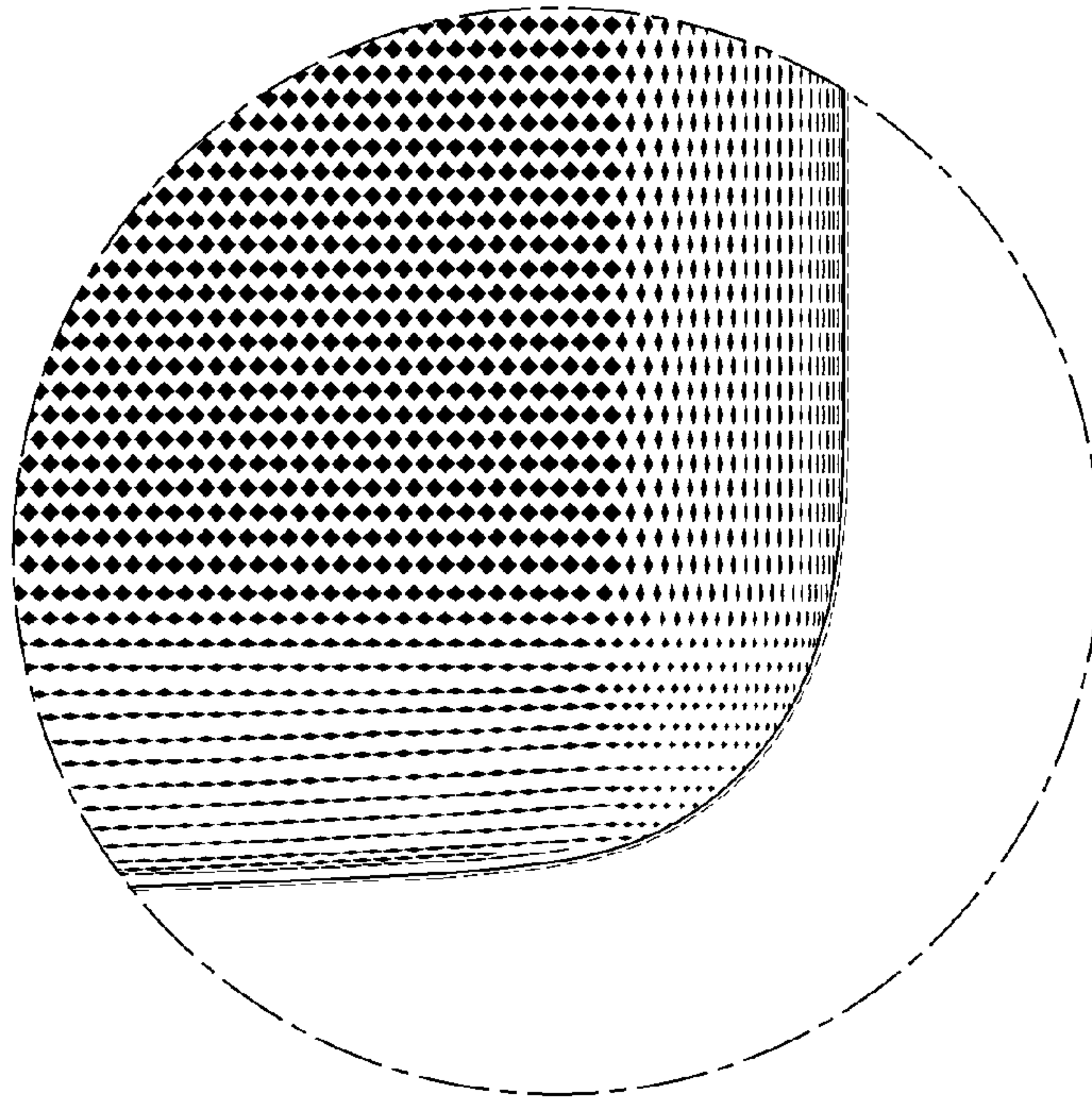
