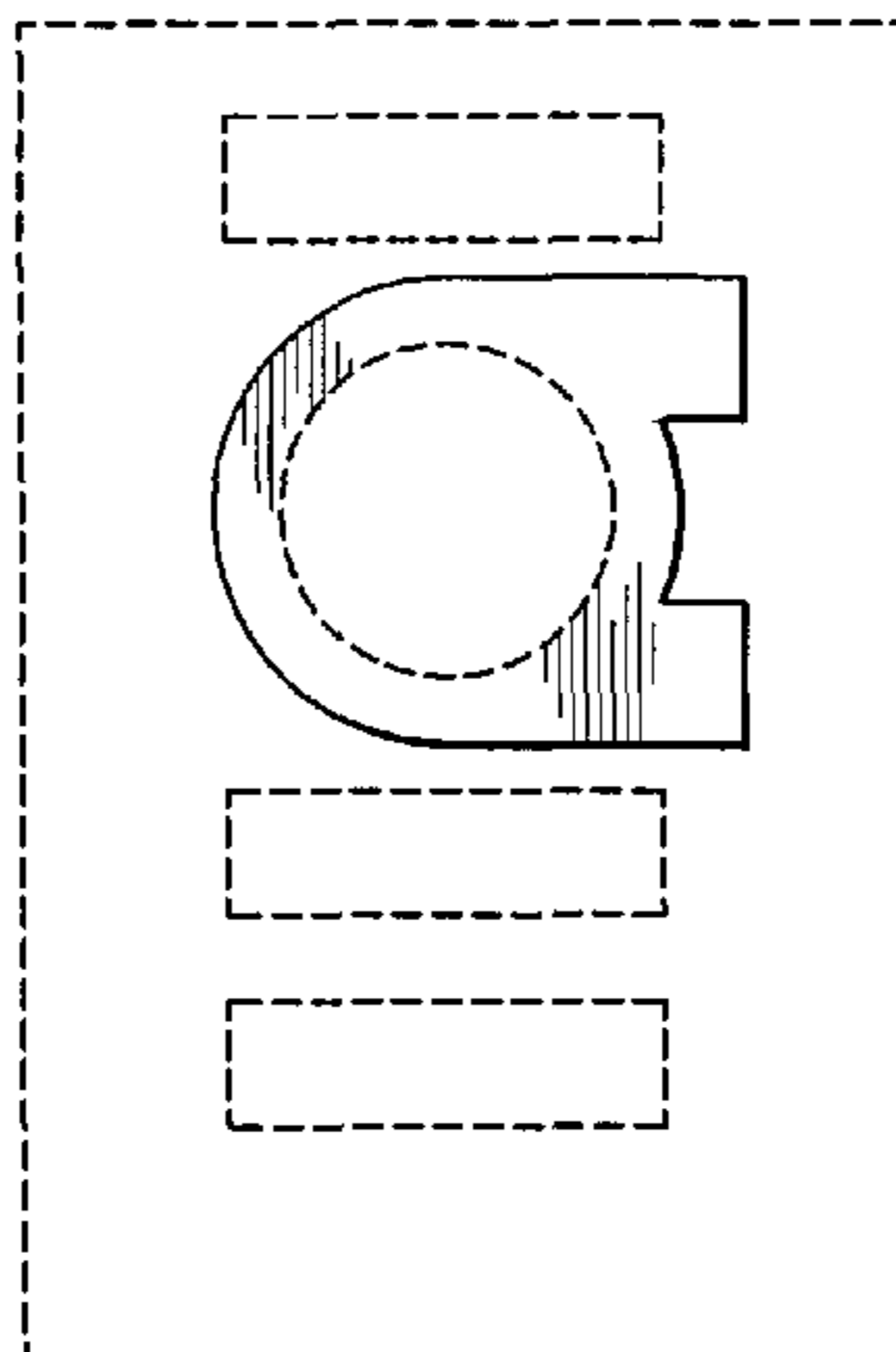

(57) CLAIM

The ornamental design for an information storage device, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an information storage device;
 FIG. 2 is a rear elevational view thereof; and,
 FIG. 3 is a right side perspective view thereof, the left side perspective view being a mirror image of the right side perspective.
 Broken lines and entirely unshaded portions contained within broken lines are not claimed.

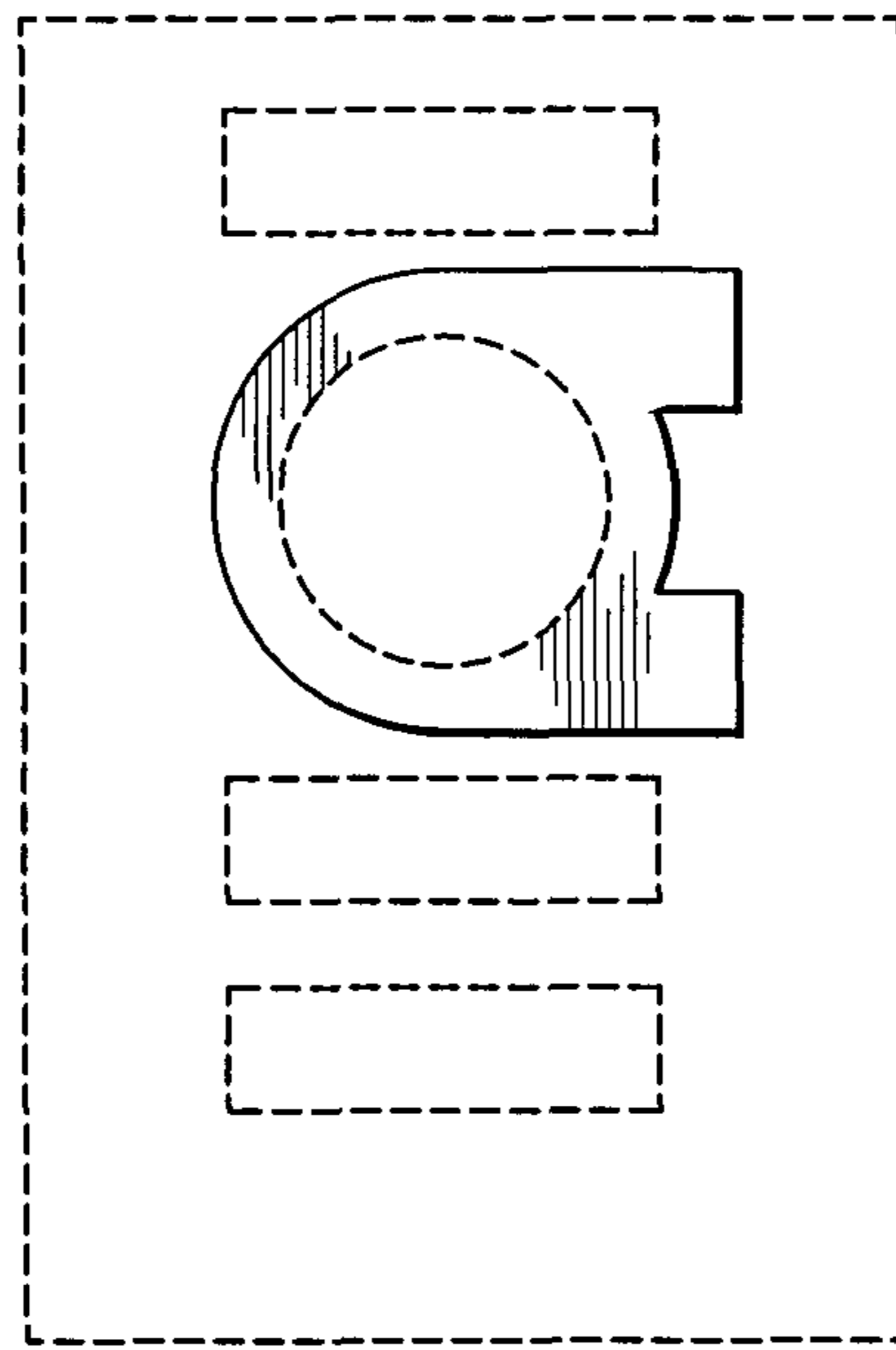

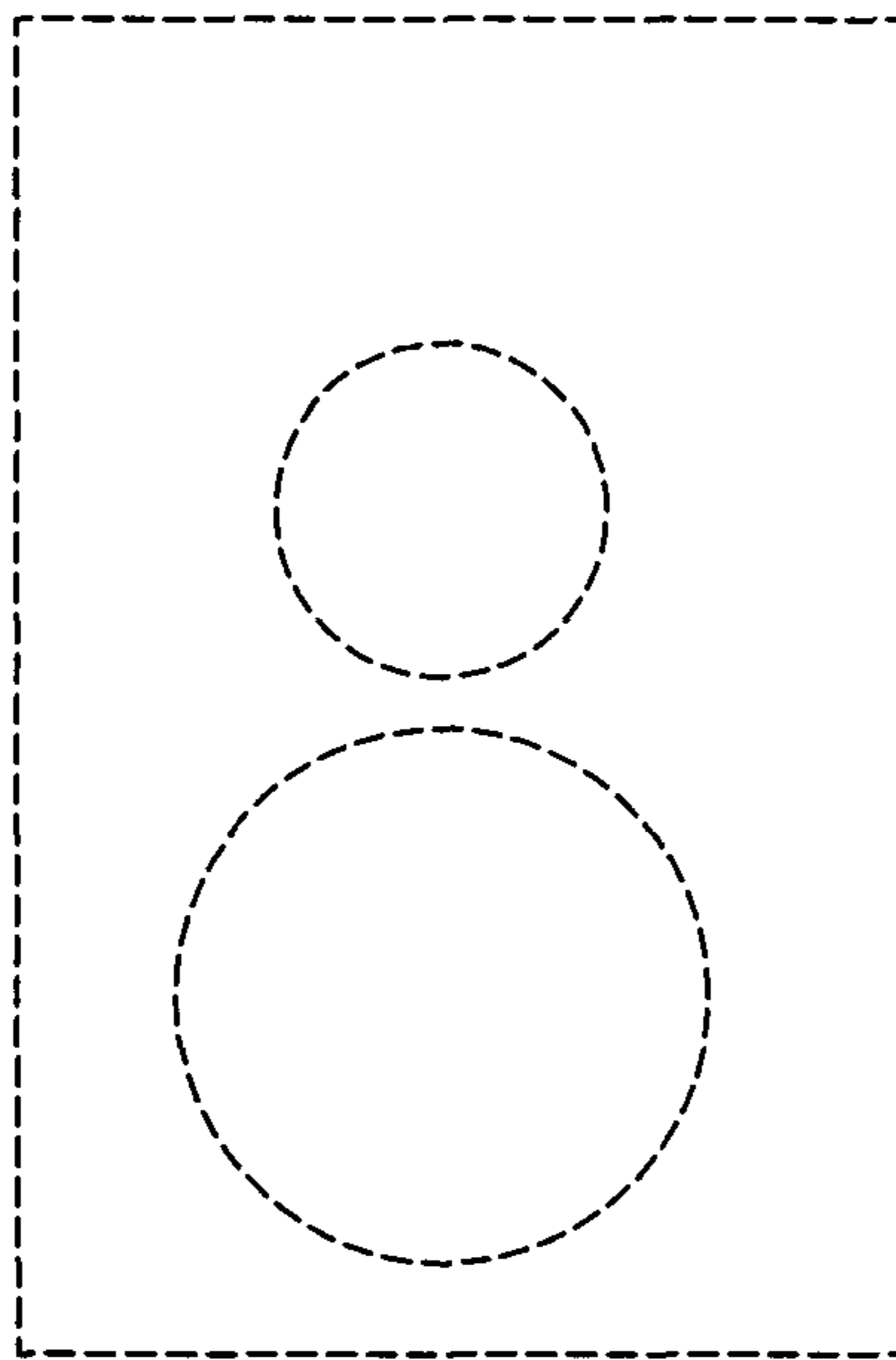

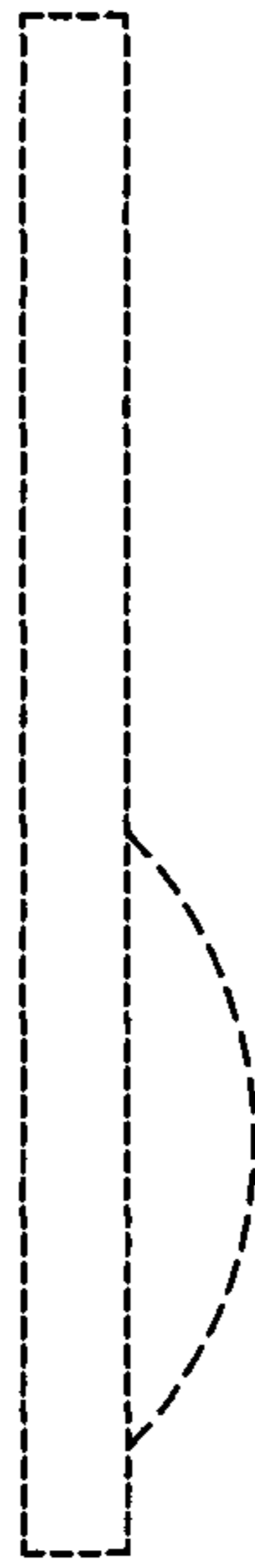
