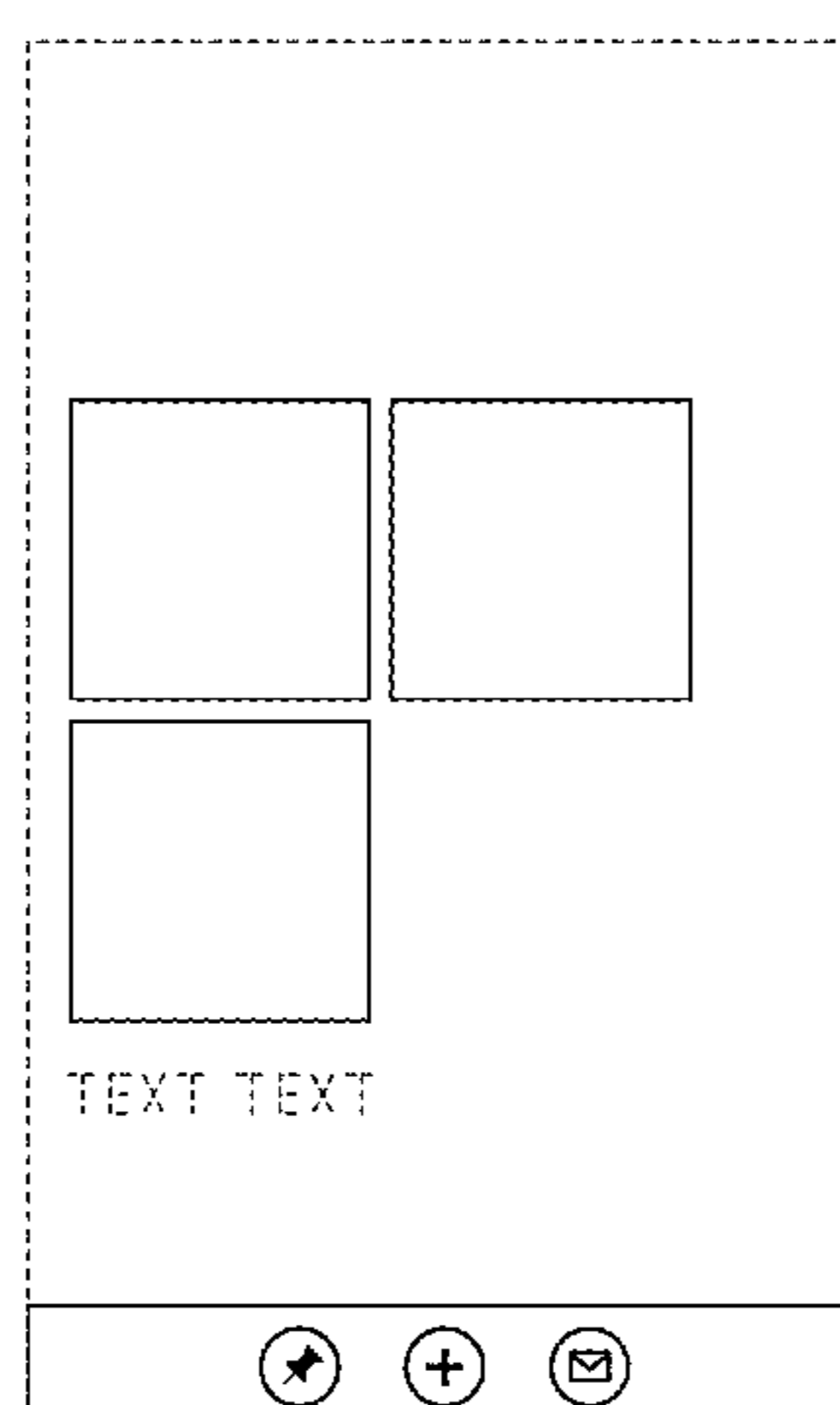
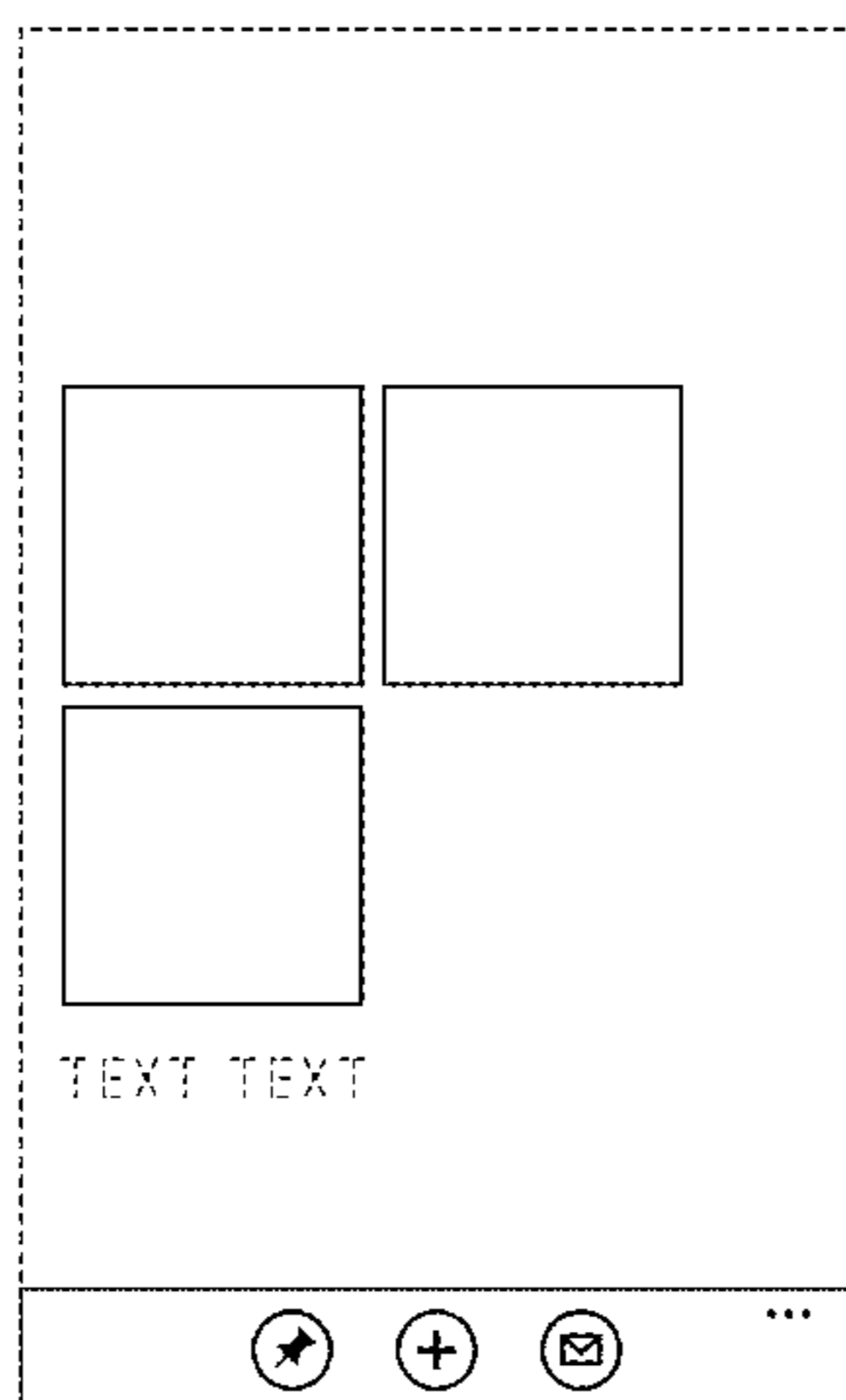
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a display screen with graphical user interface showing the new design; FIG. 2 is another front view thereof; FIG. 3 is a front view of a second embodiment of a display screen with graphical user interface showing the new design; and, FIG. 4 is another front view thereof. 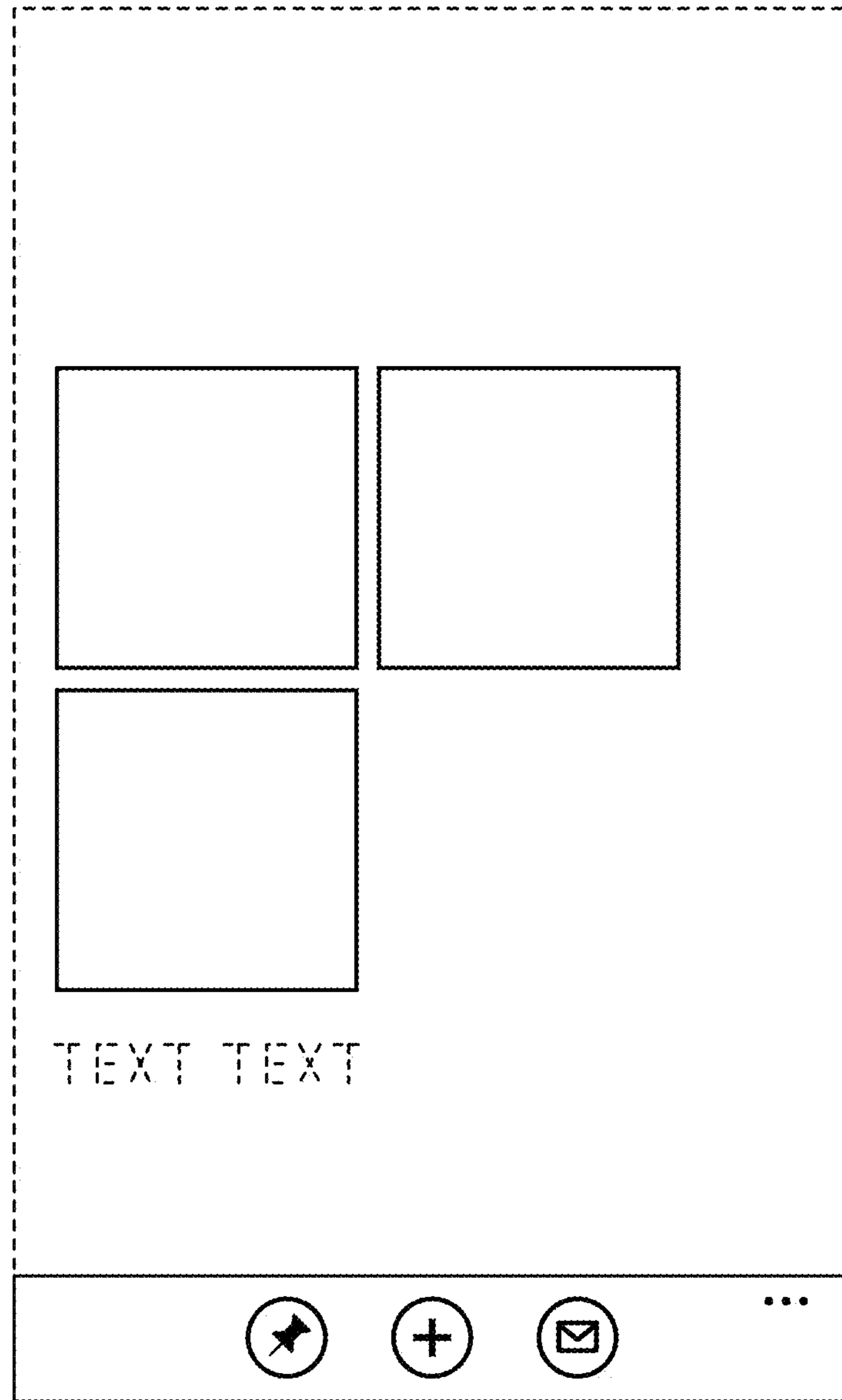

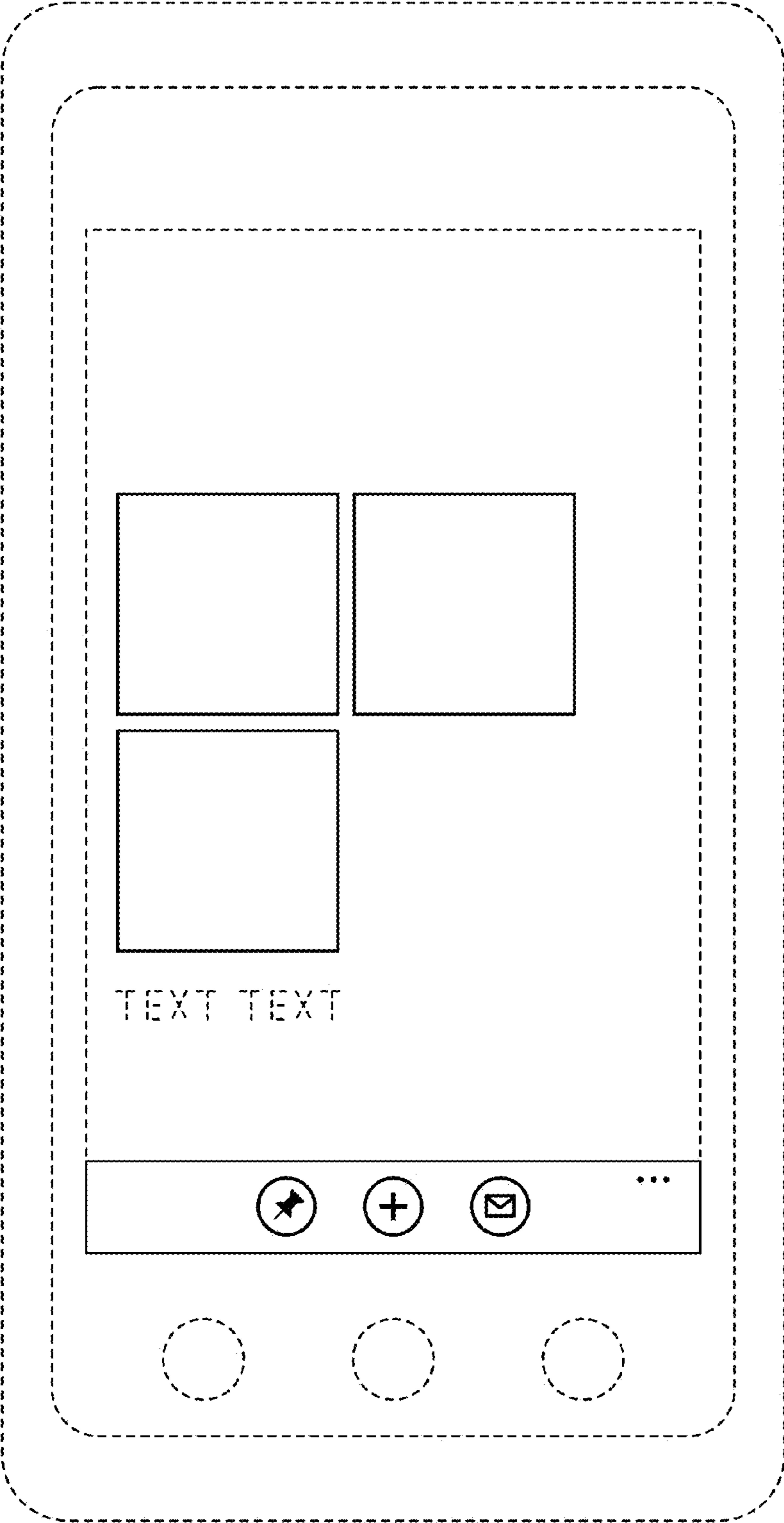

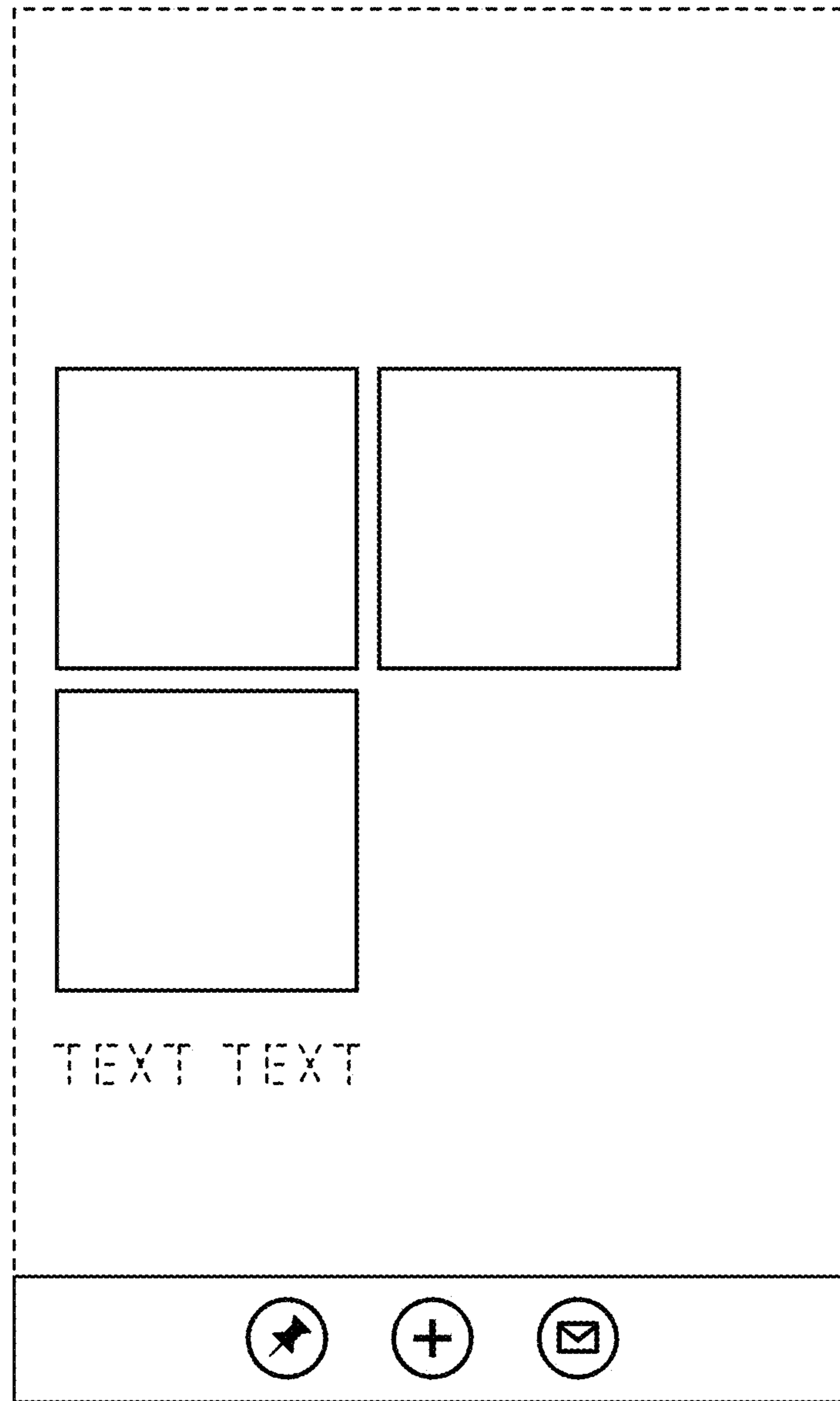

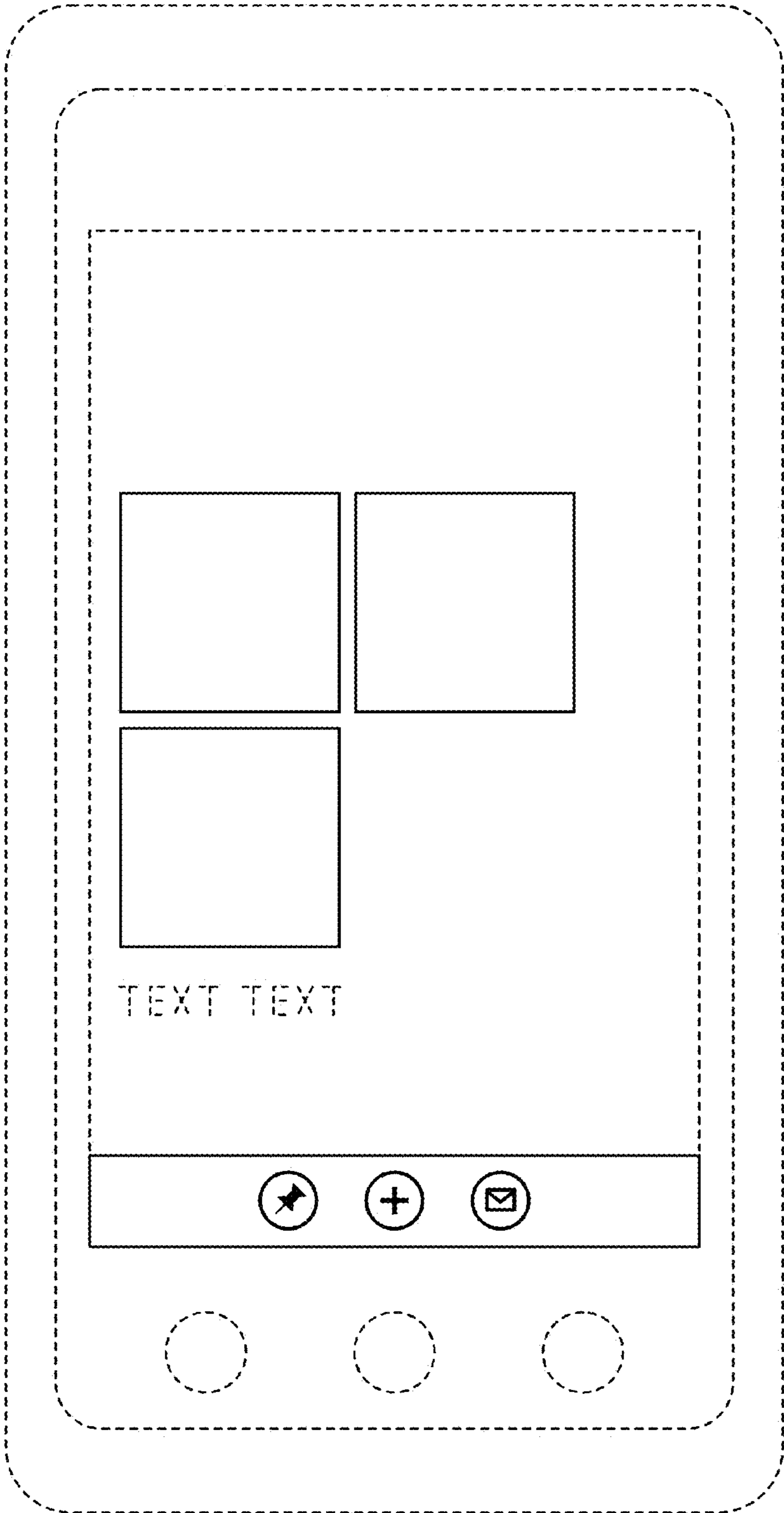
