(57) **CLAIM**

The ornamental design for a pillow sunglasses lens cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pillow sunglasses lens cover showing my new design being applied on pillow design shaped sunglasses;

FIG. 2 is a front view of the pillow sunglasses lens cover of FIG. 1;

FIG. 3 is a top view of the pillow sunglasses lens cover of FIG. 1;

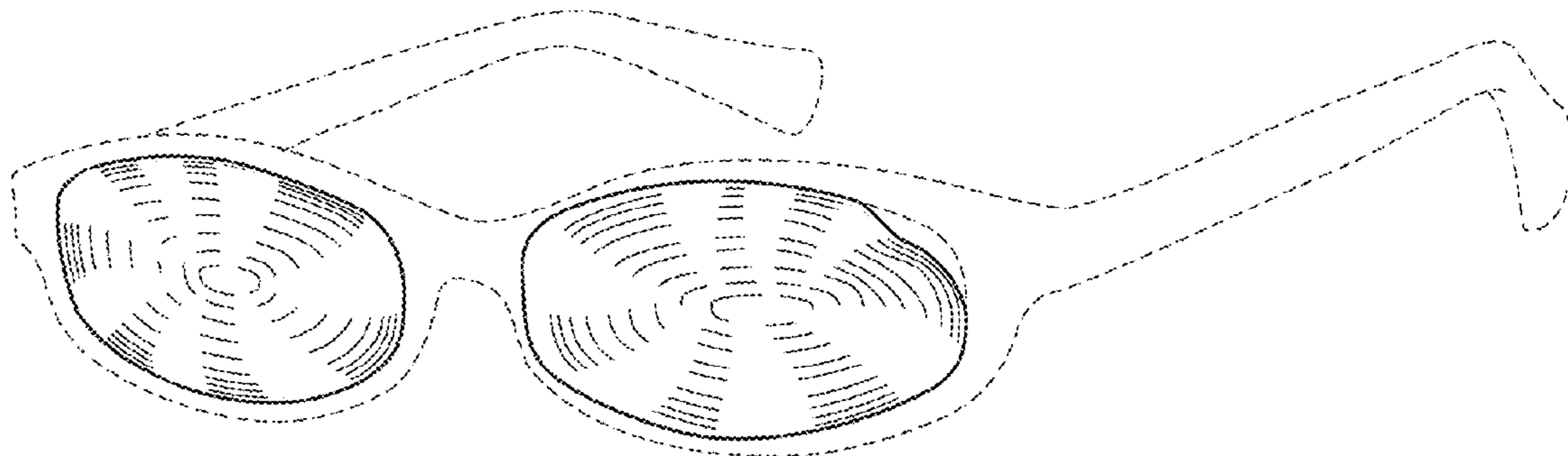
FIG. 4 is a bottom view of the pillow sunglasses lens cover of FIG. 1;

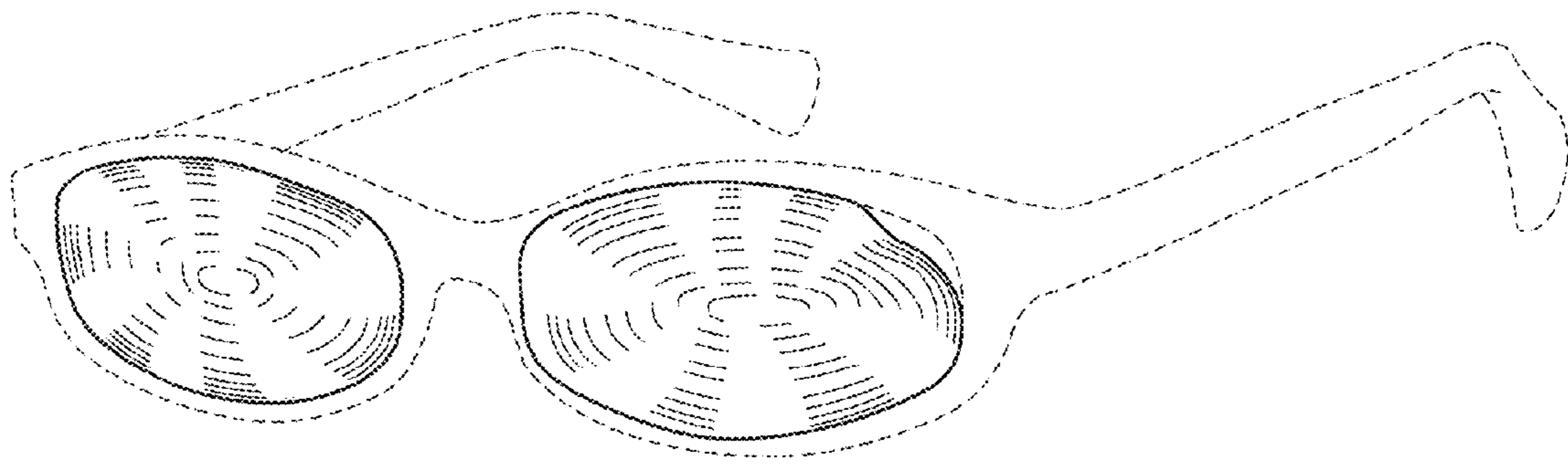

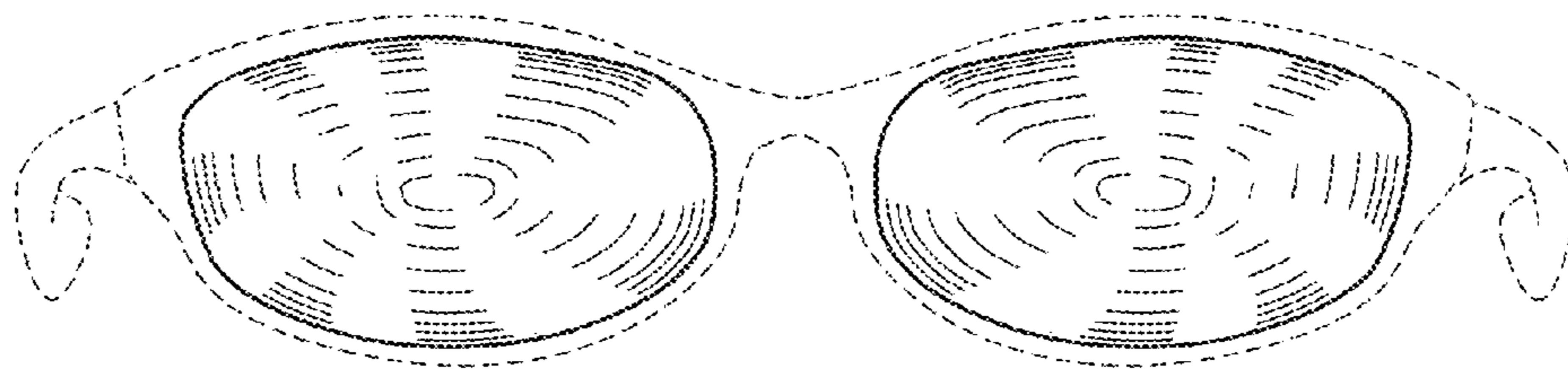

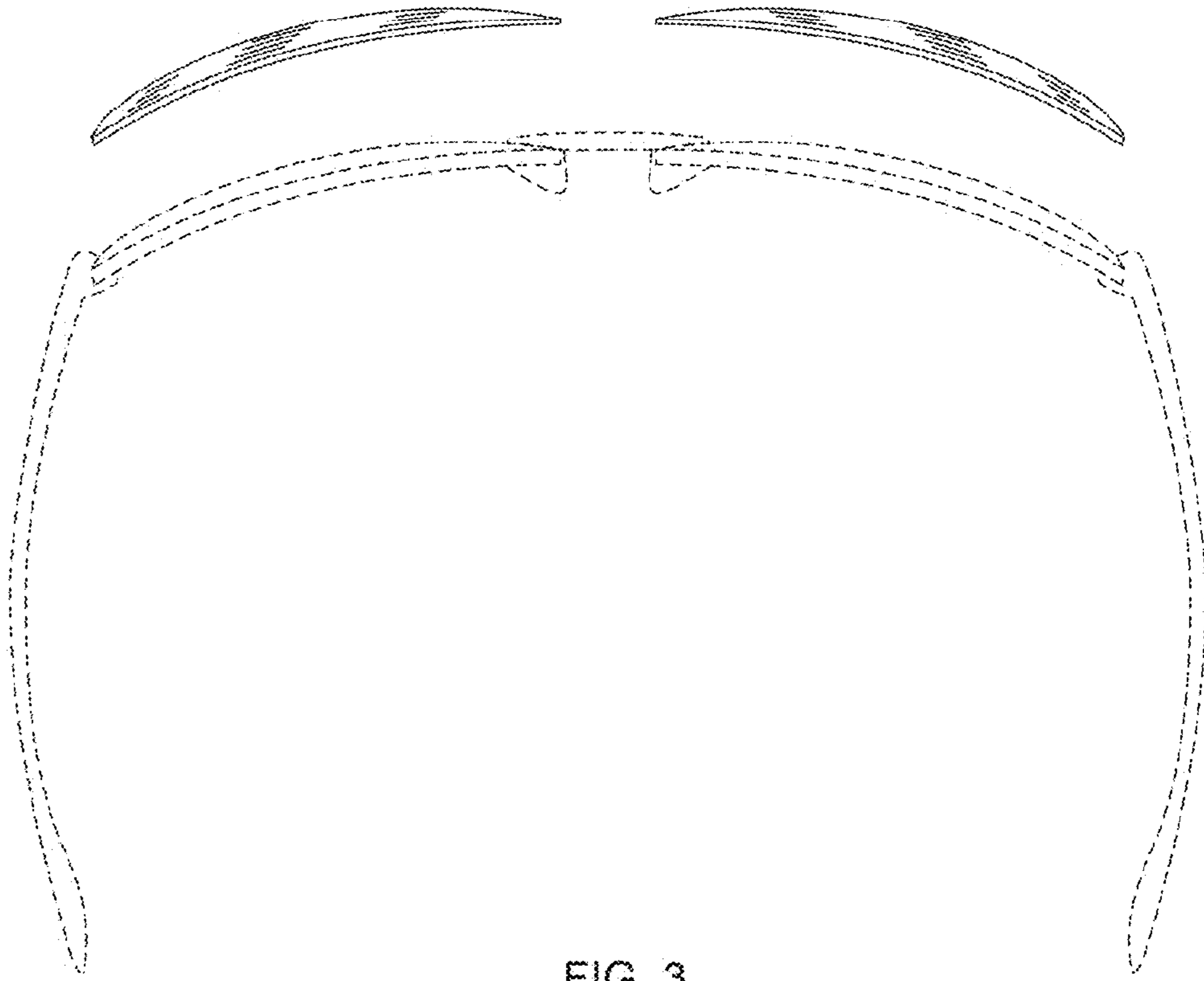

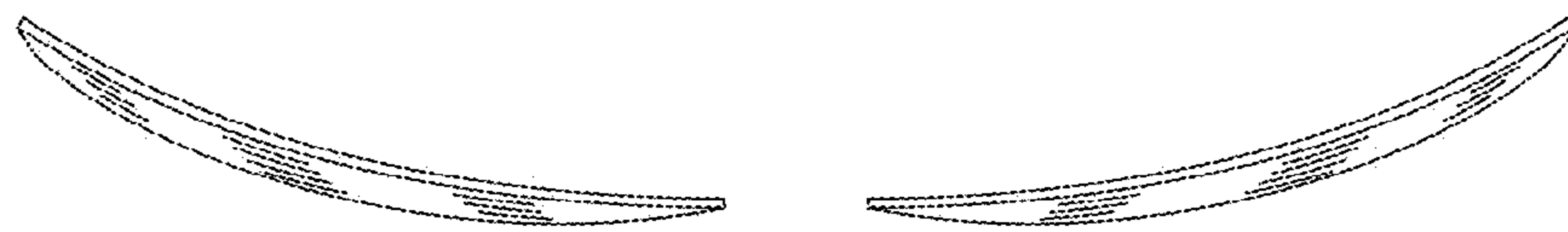

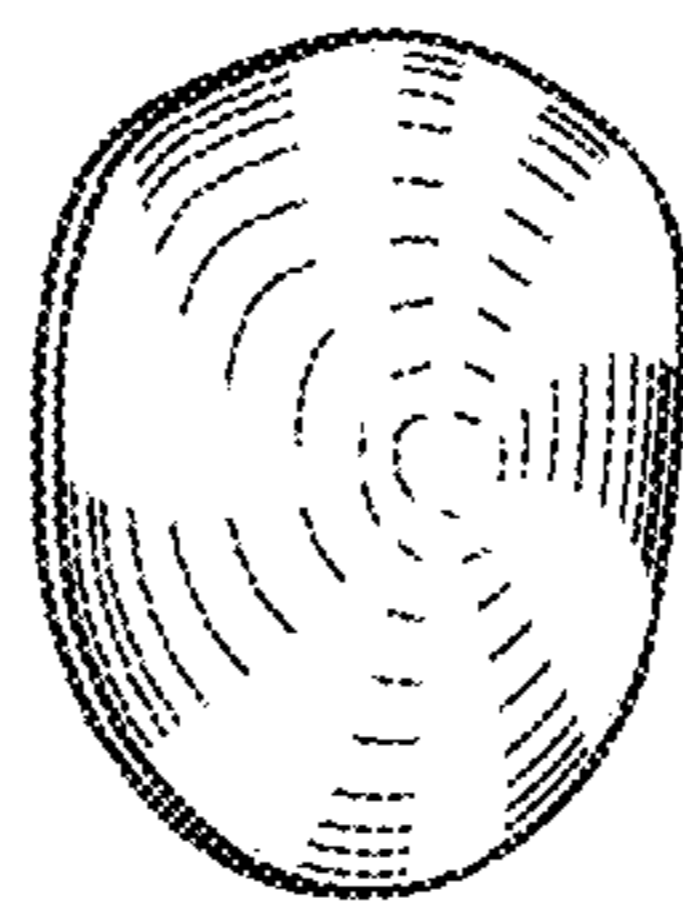
