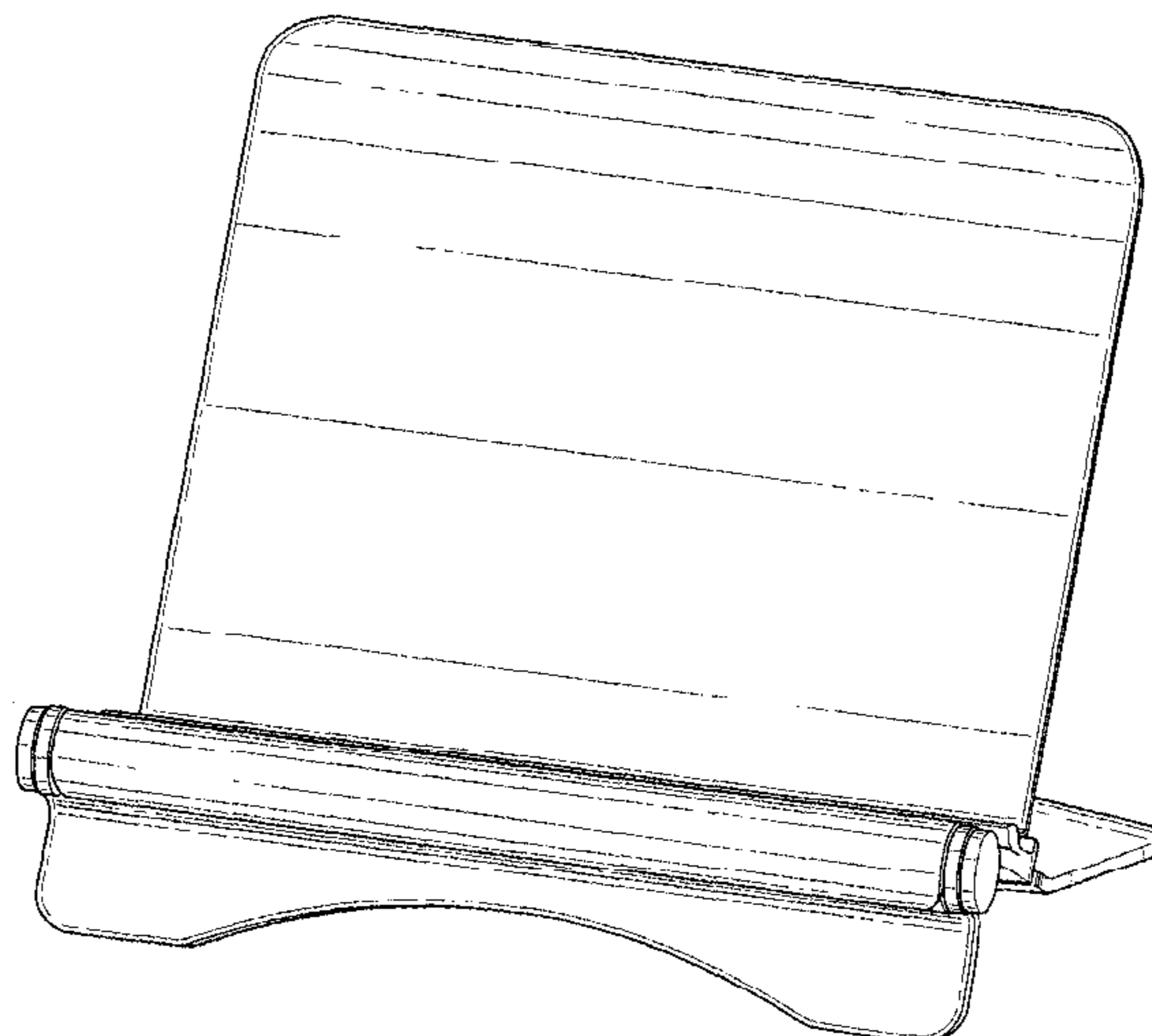

The ornamental design for a book and tablet stand, as shown
and described.

DESCRIPTION
FIG. 1 is a perspective view as seen from the front right side
of a book and tablet stand showing my new design with an
arm positioned for holding a tablet;
FIG. 2 is a front view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a left side view thereof;
FIG. 8 is a perspective view as seen from the front right side
of the book and tablet stand of FIG. 1 showing the arm
positioned for holding a book; and,
FIG. 9 is a right side view thereof.

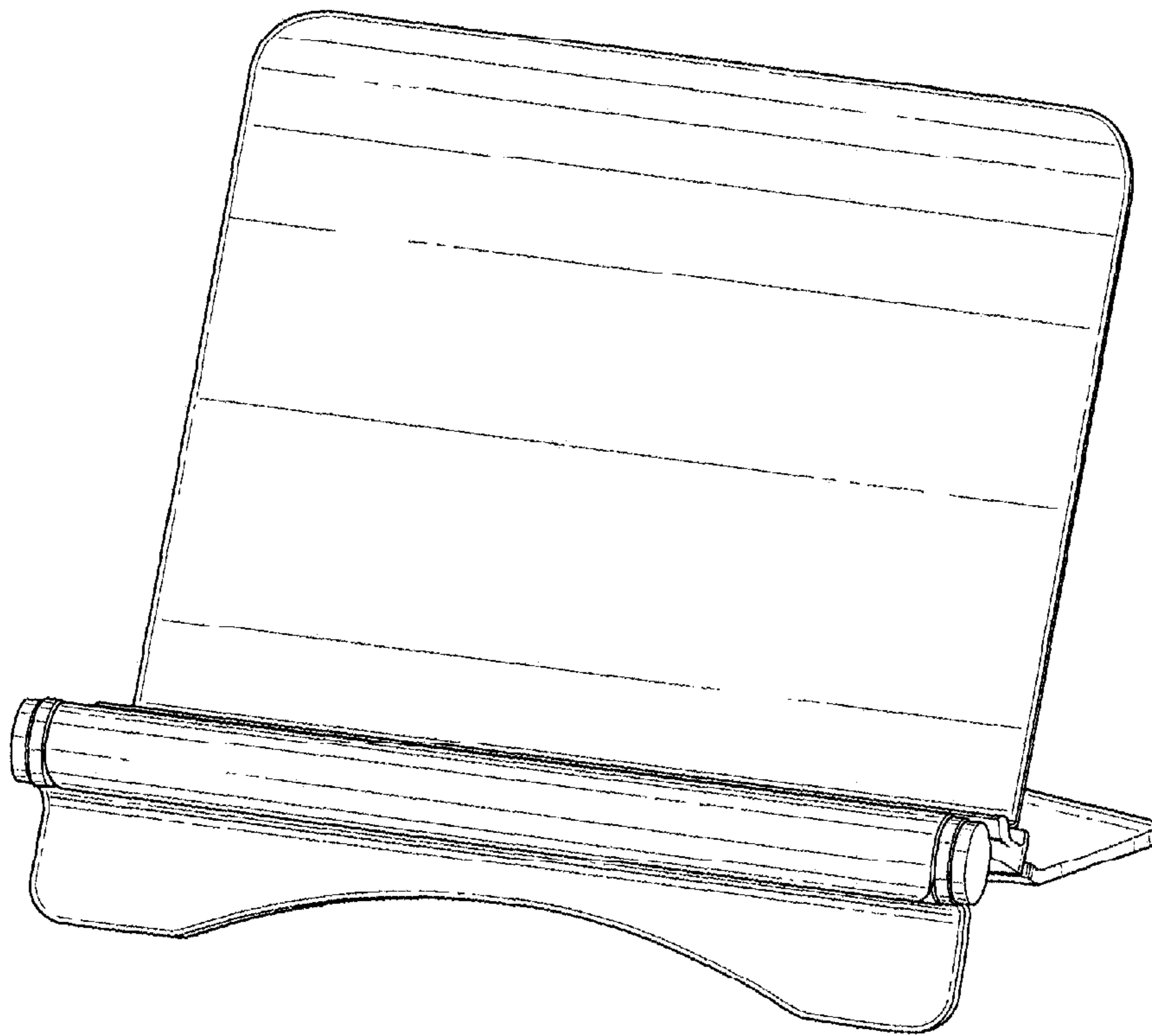

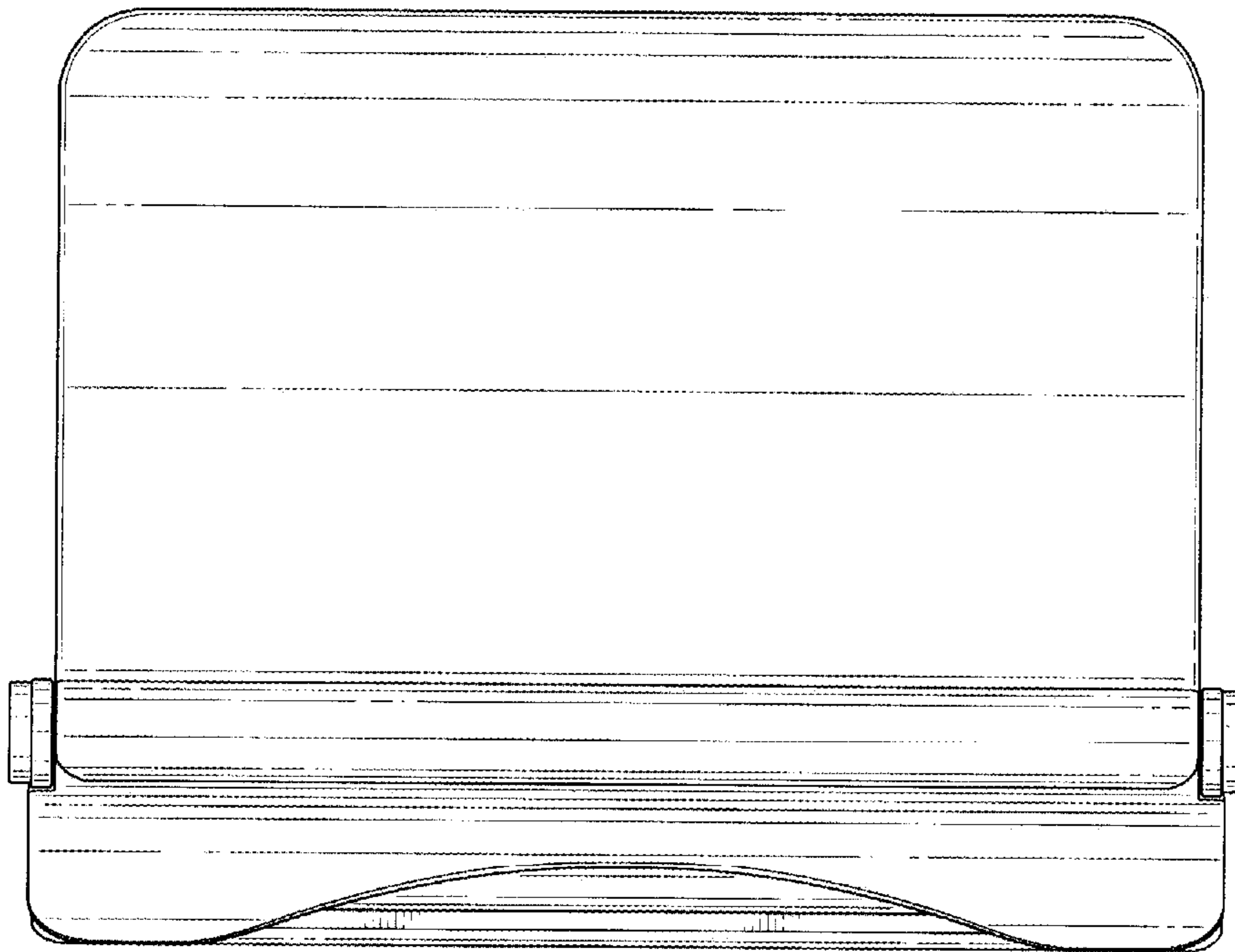

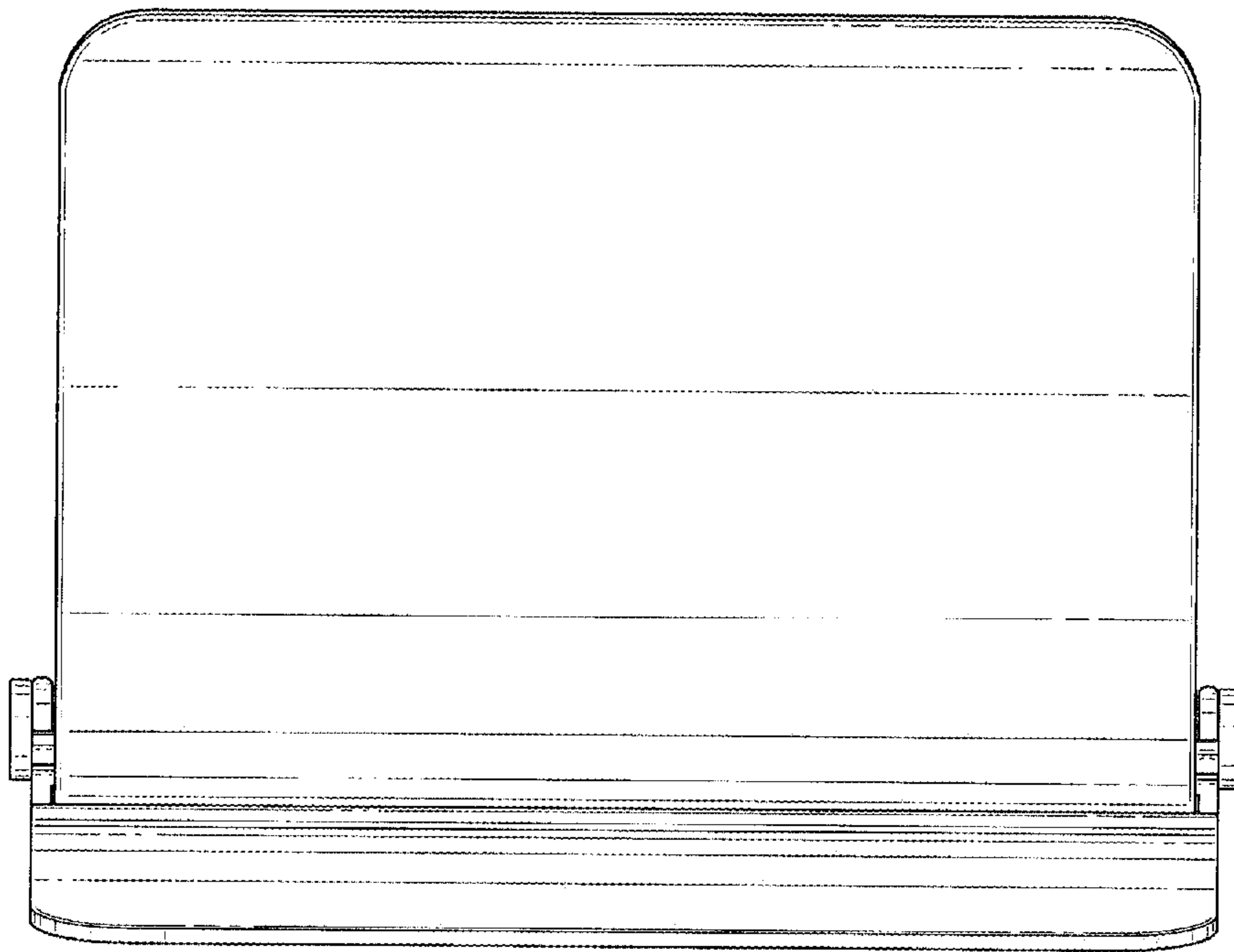

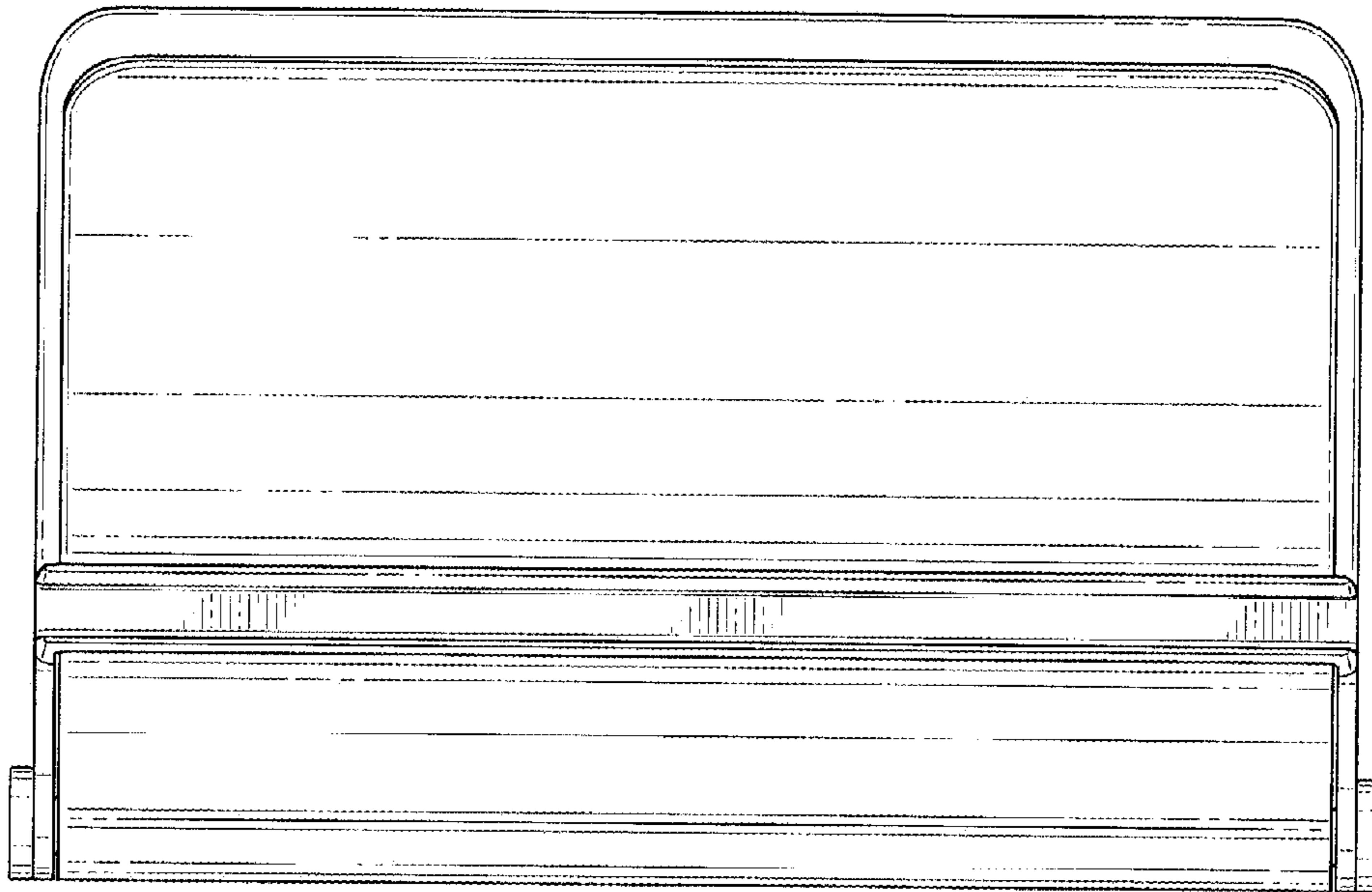

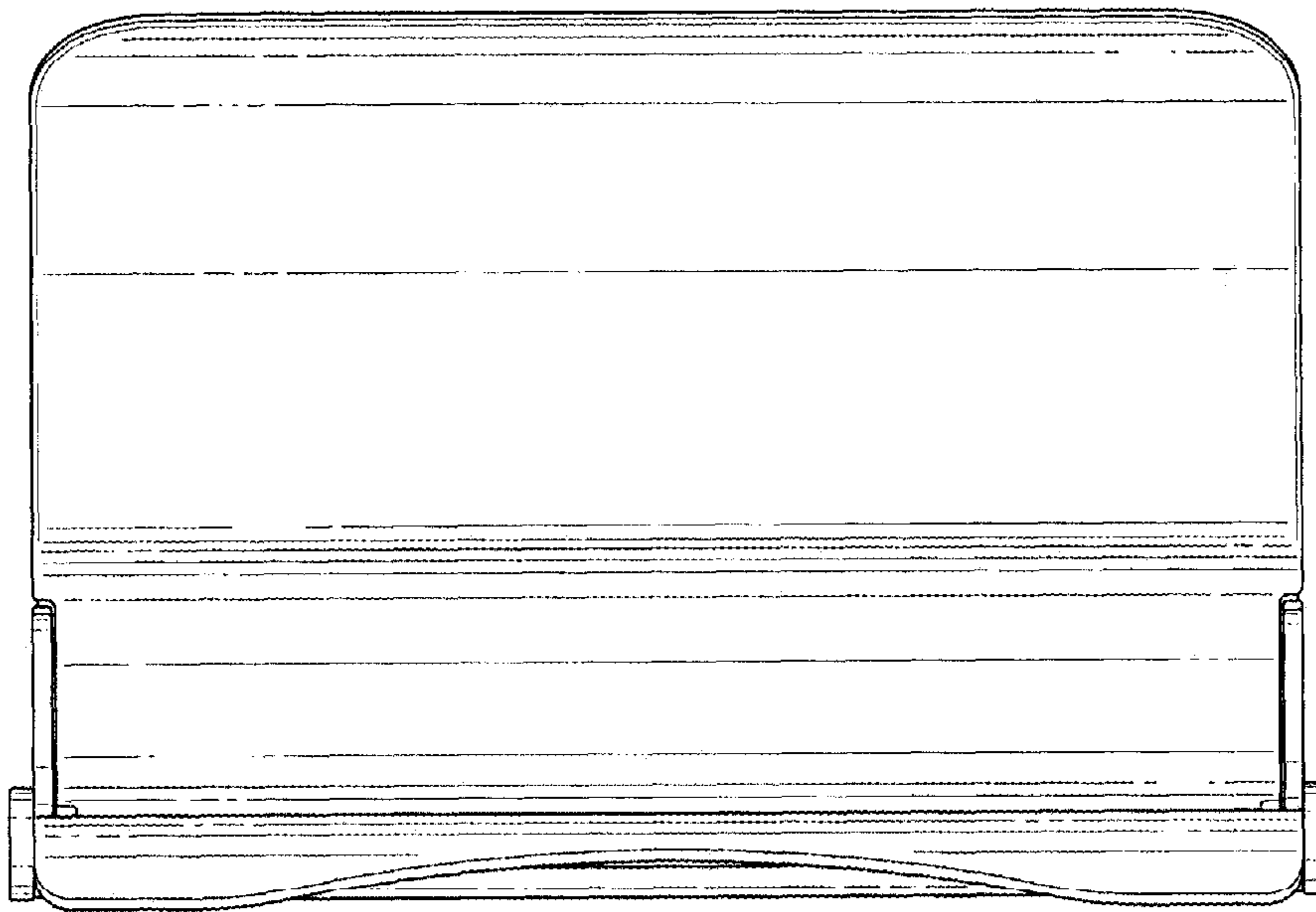

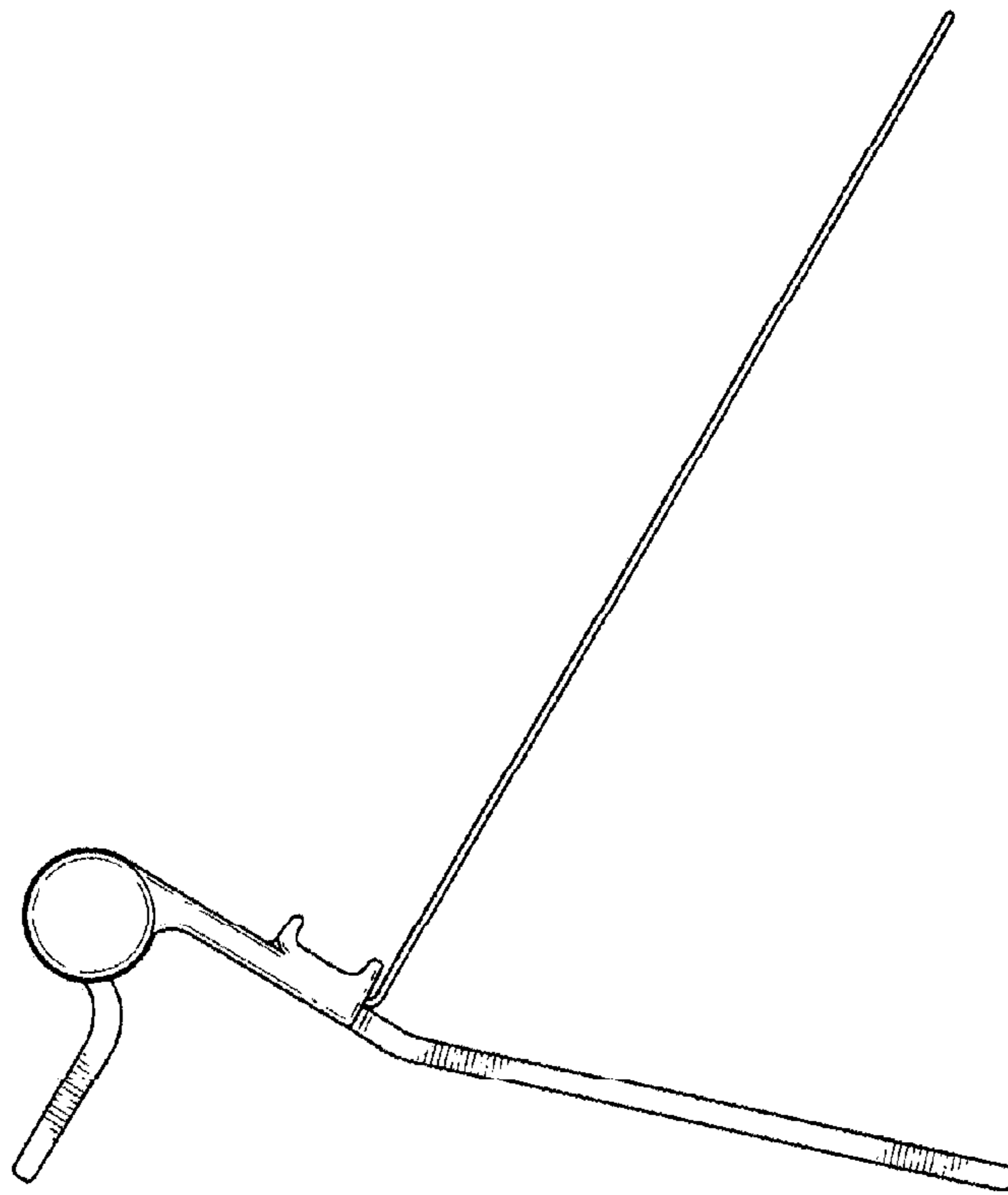

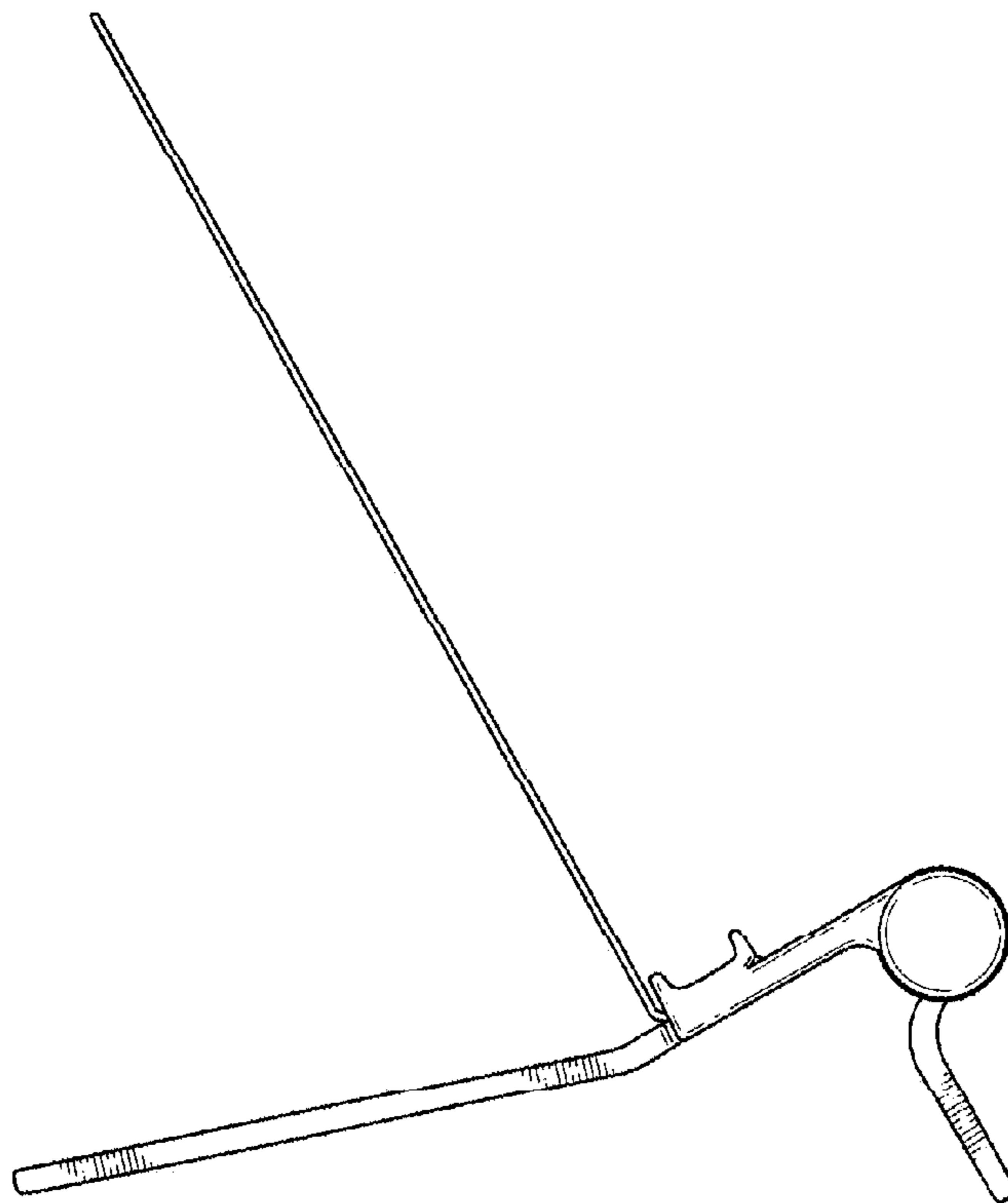

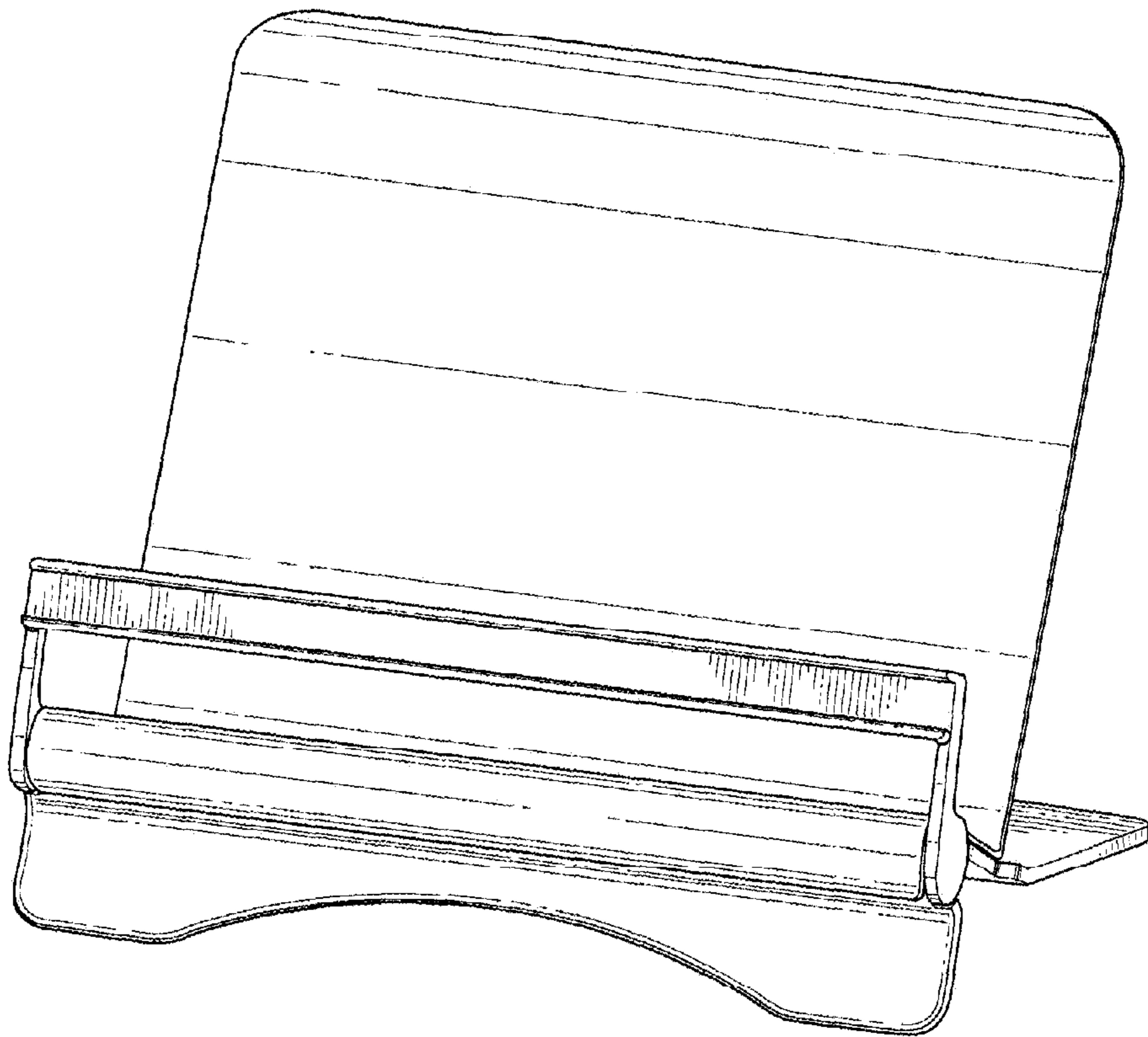

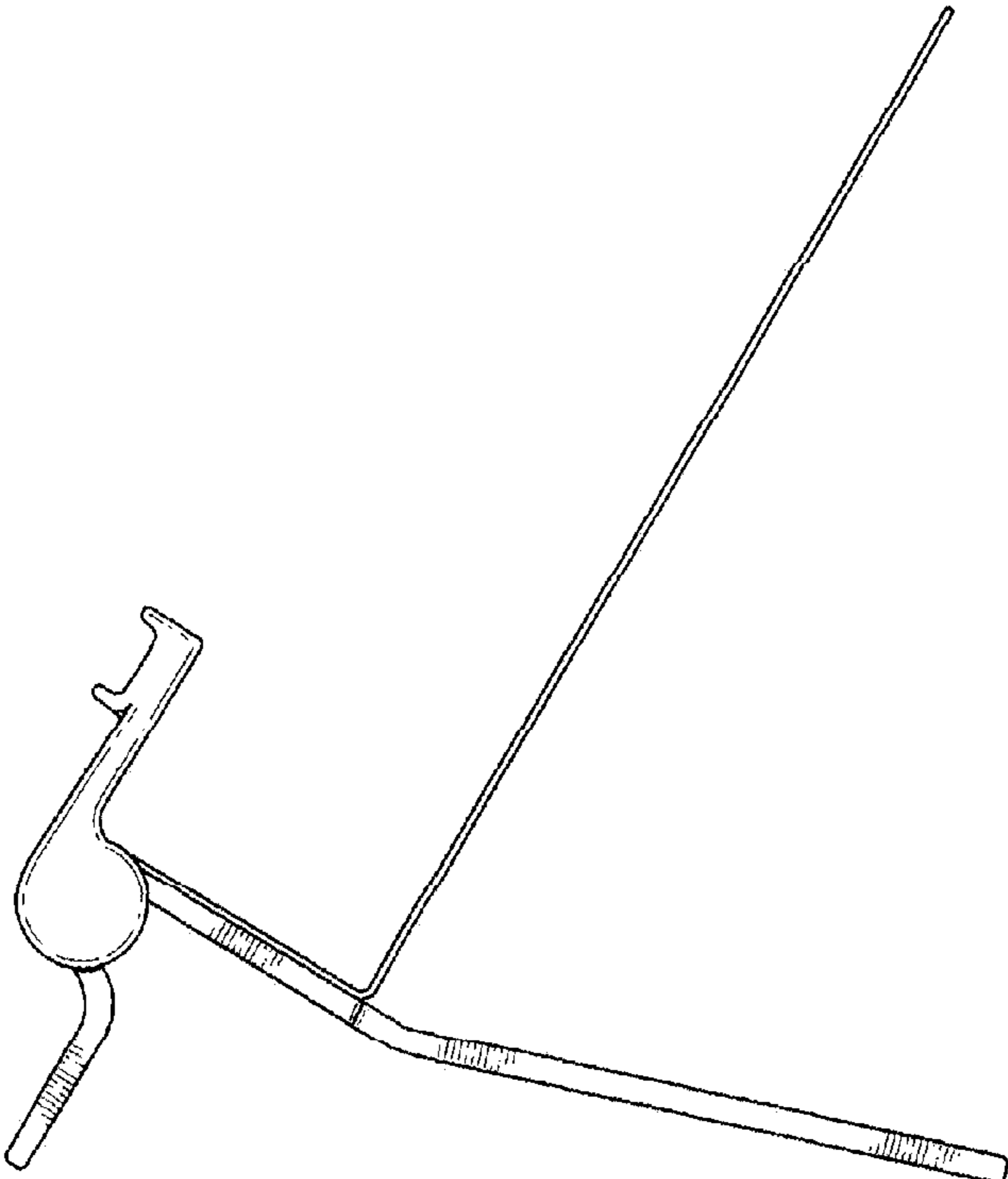
