FIG. 2 is a front view thereof;

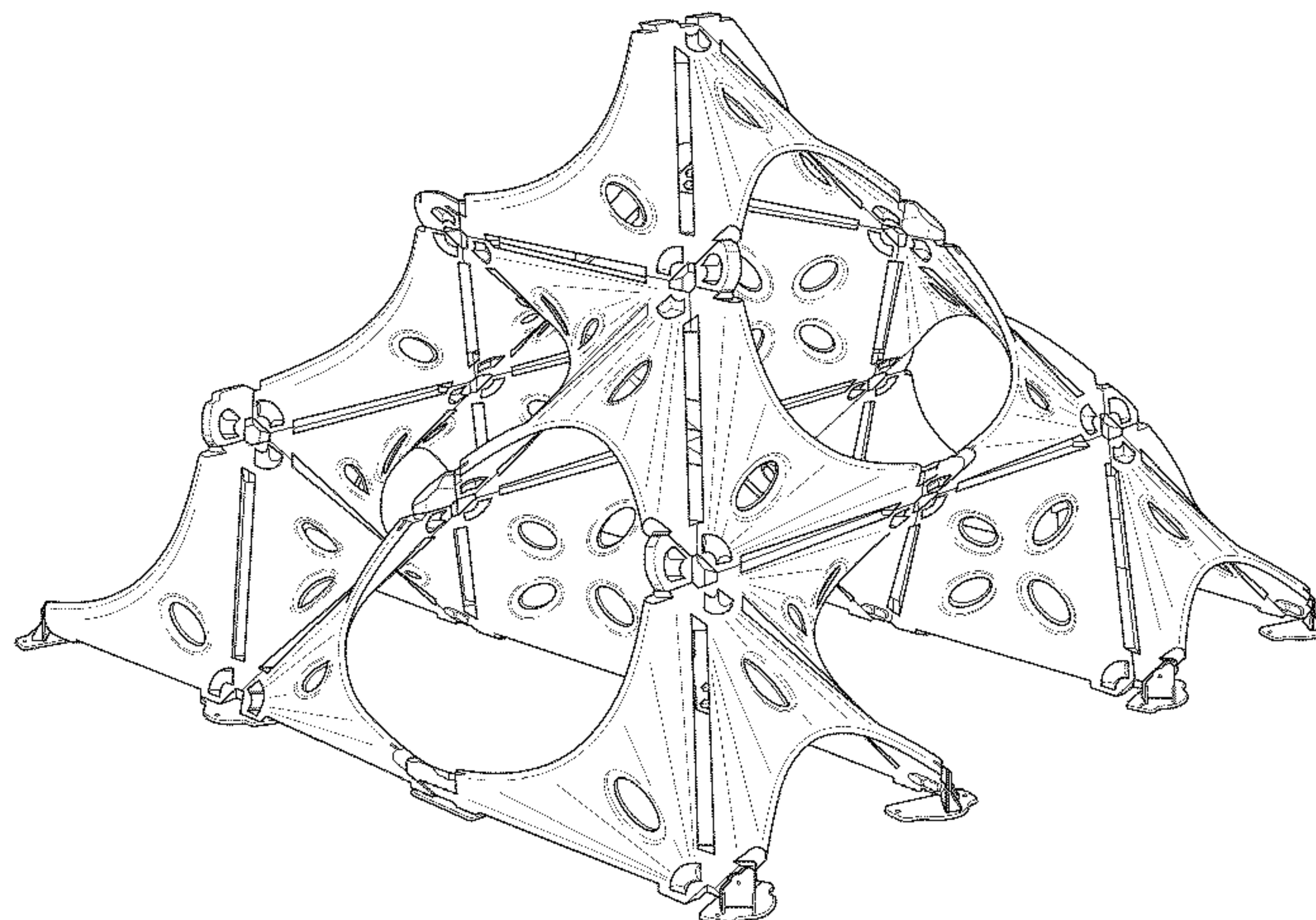
FIG. 3 is a side view thereof, an opposite side view being a mirror image thereof;

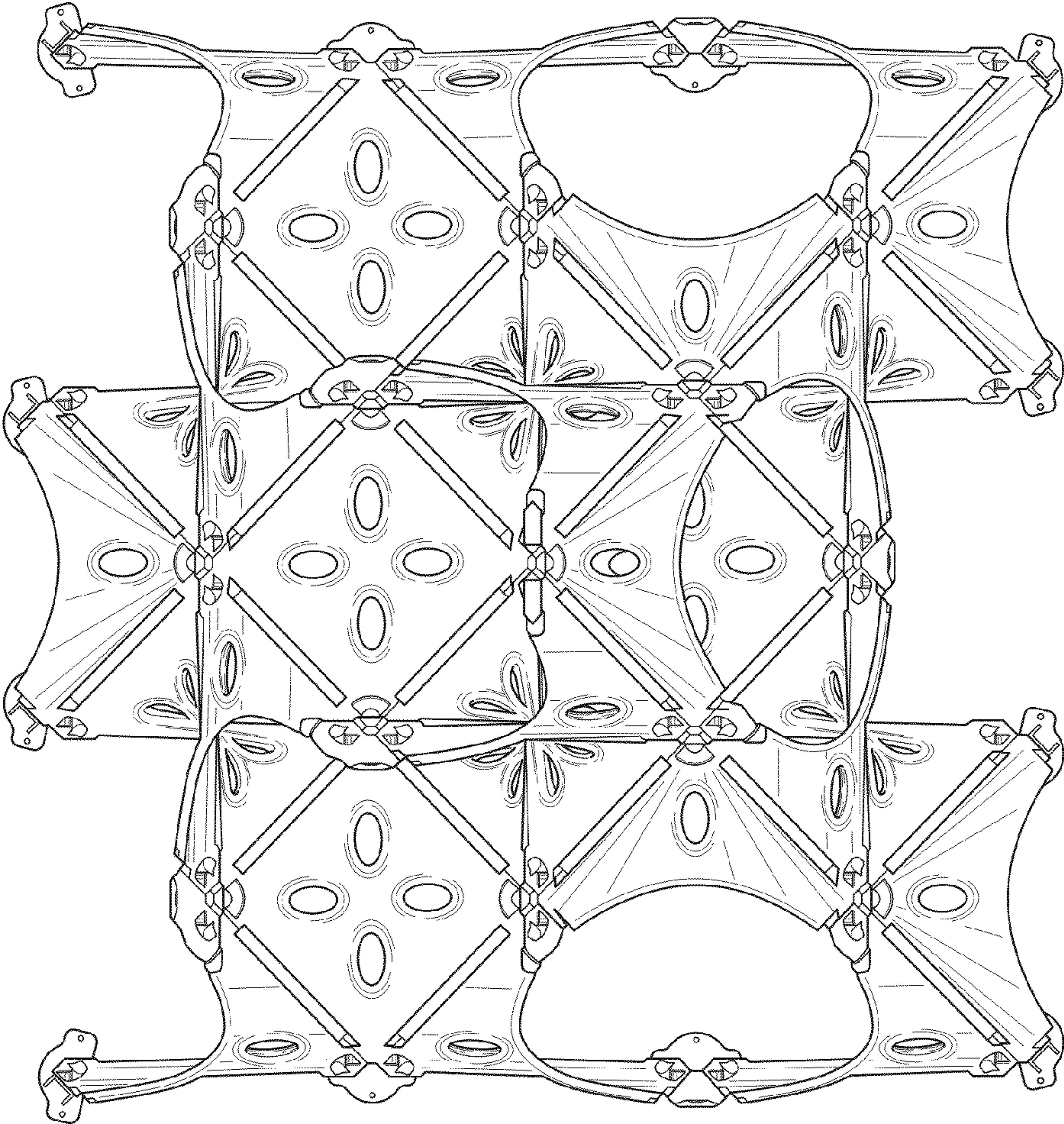

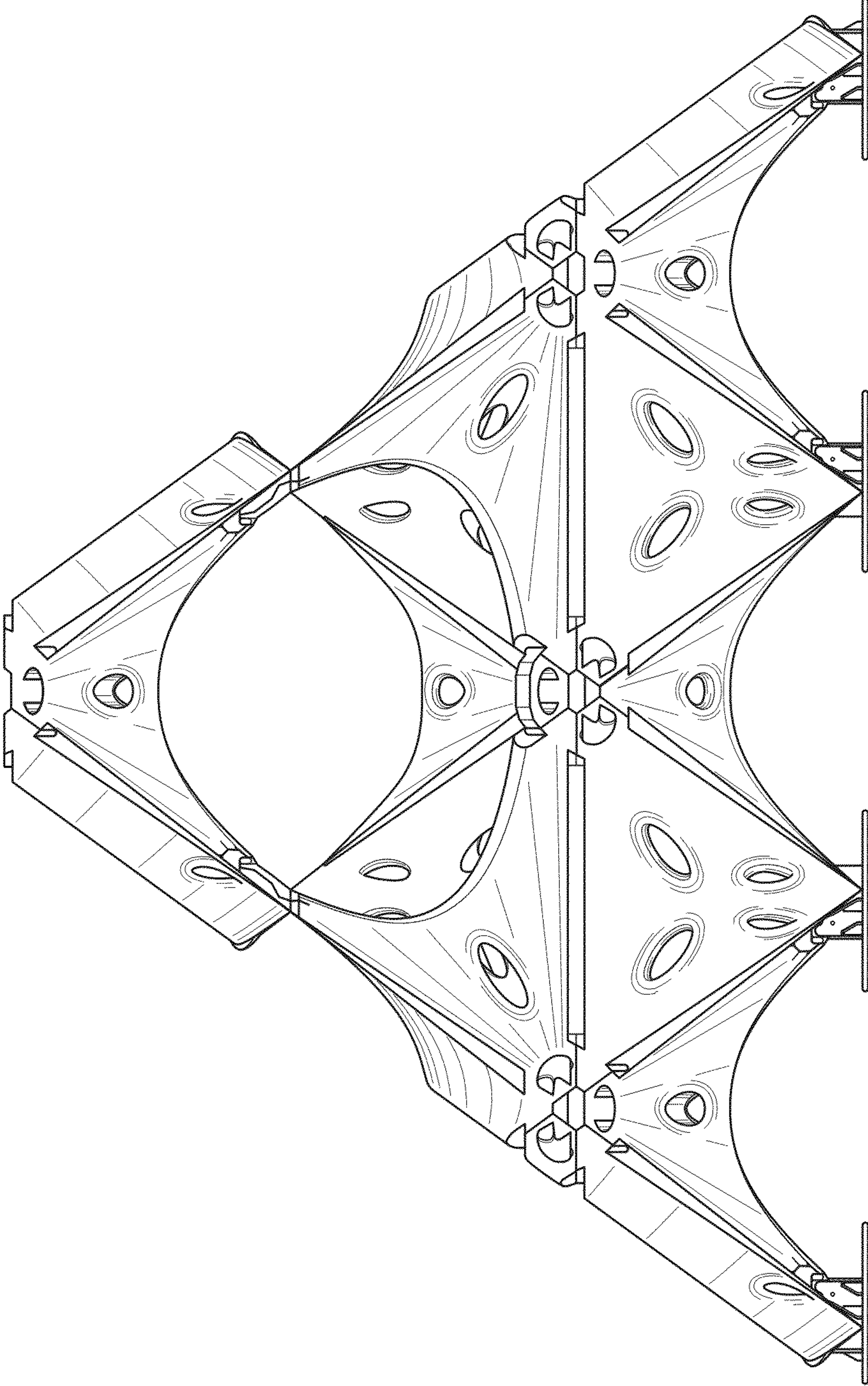

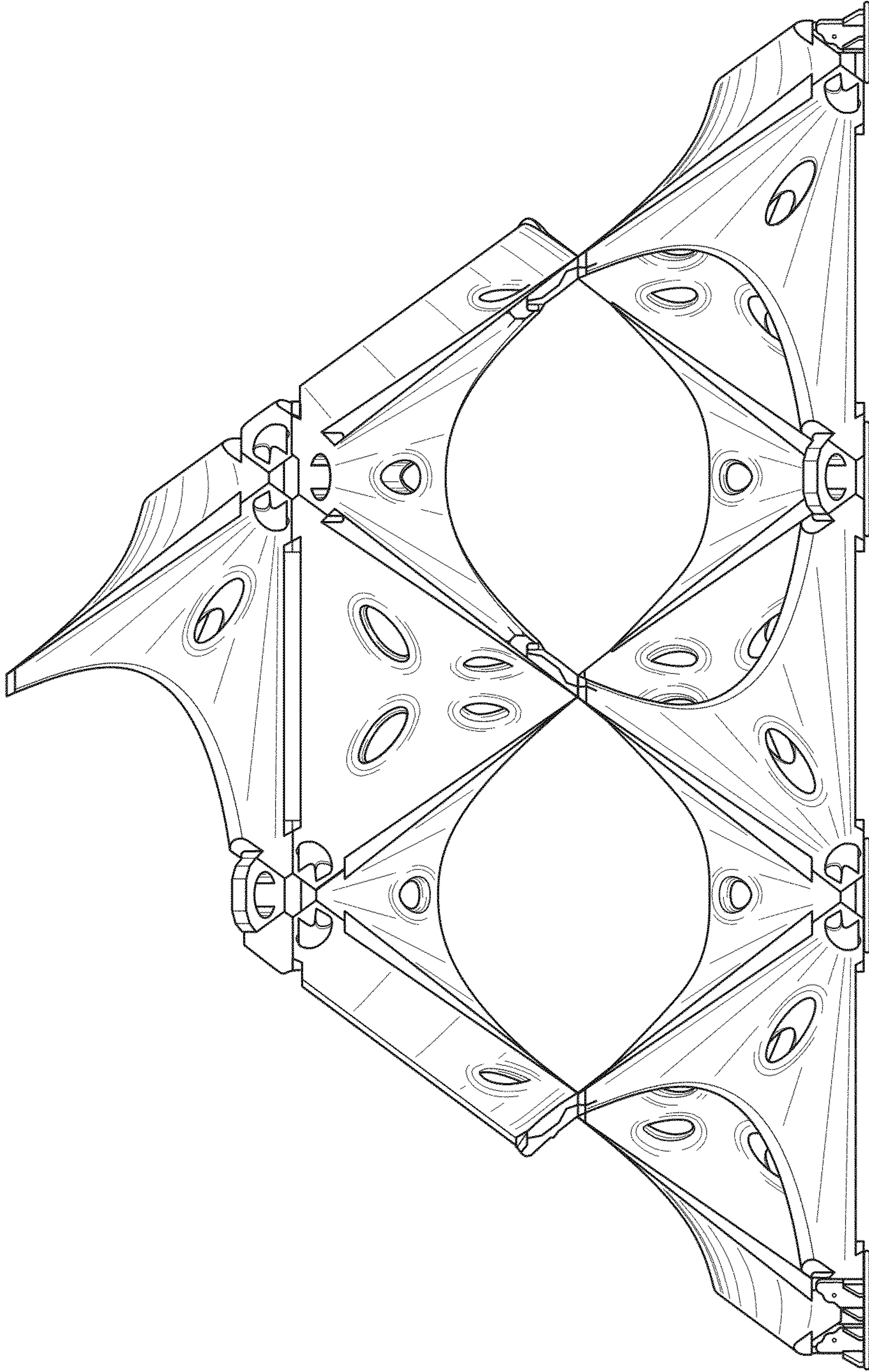

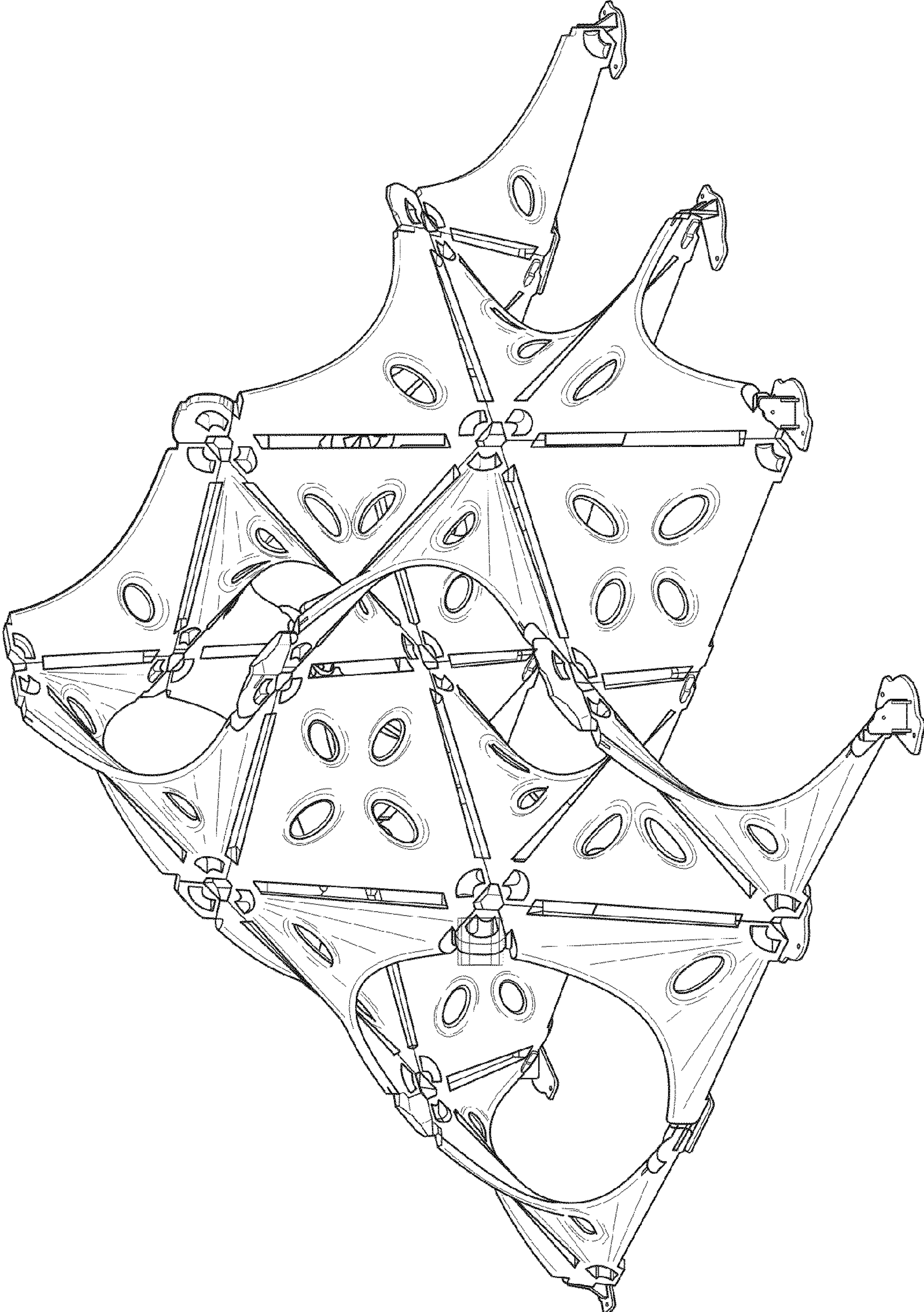

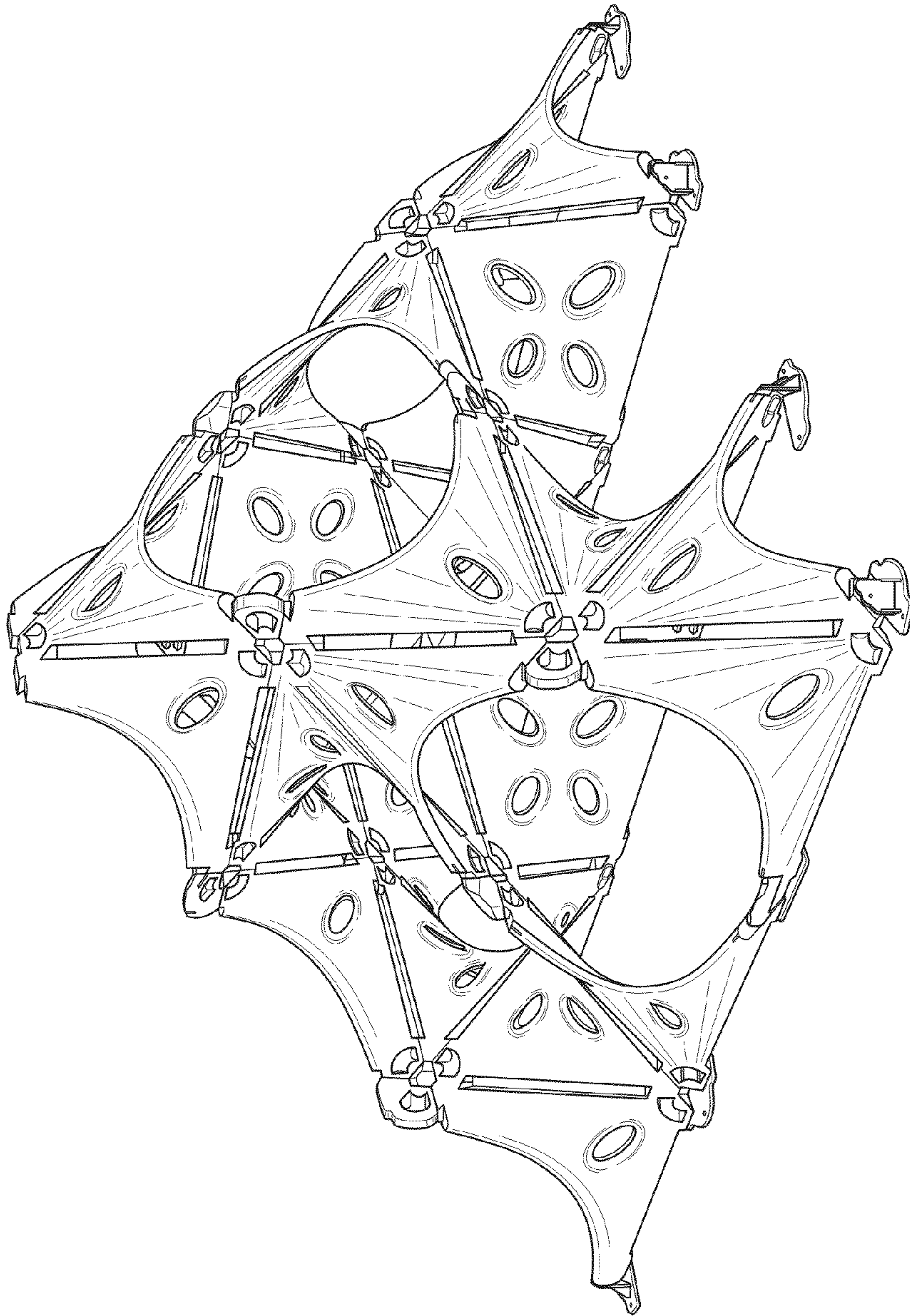

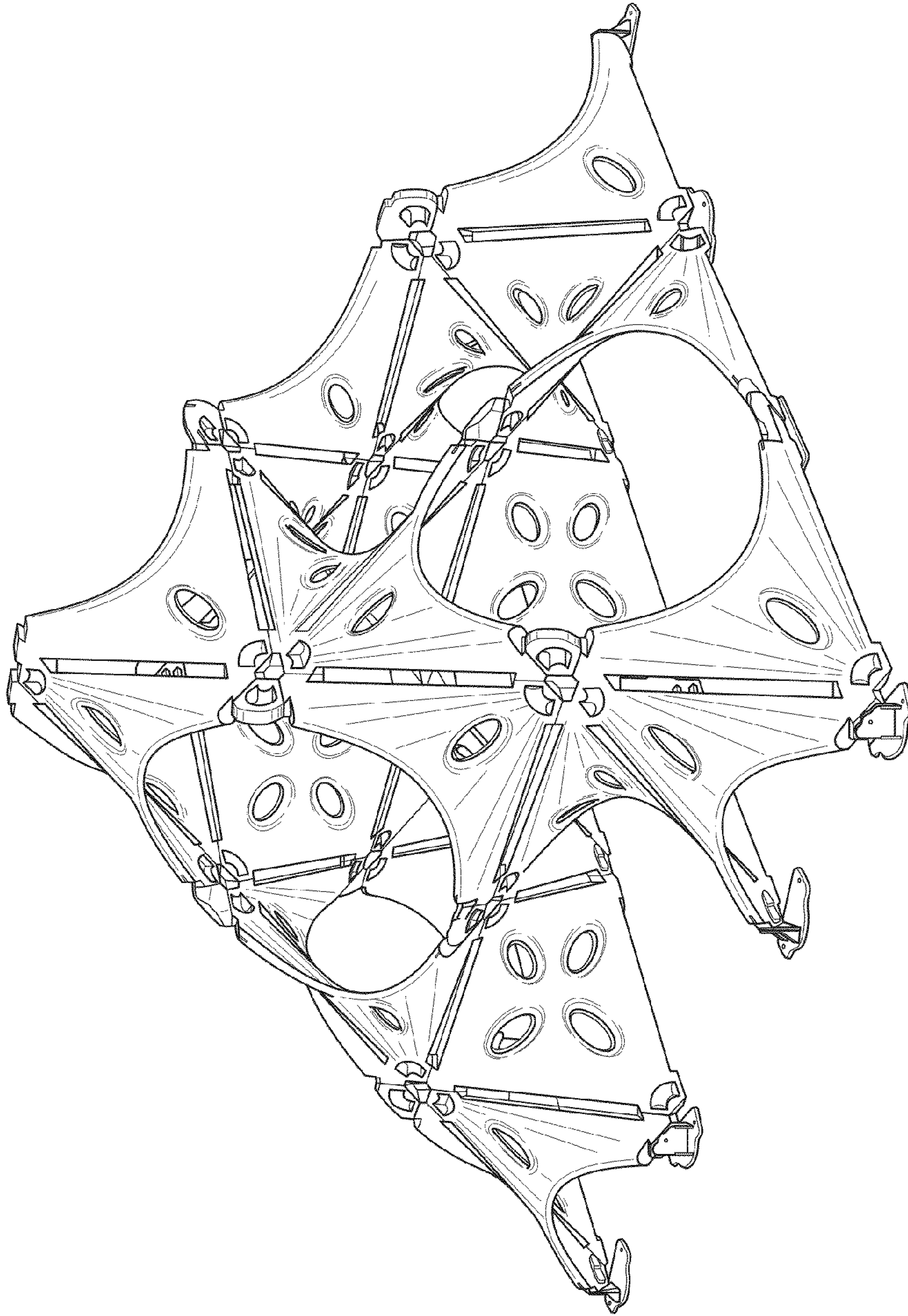
