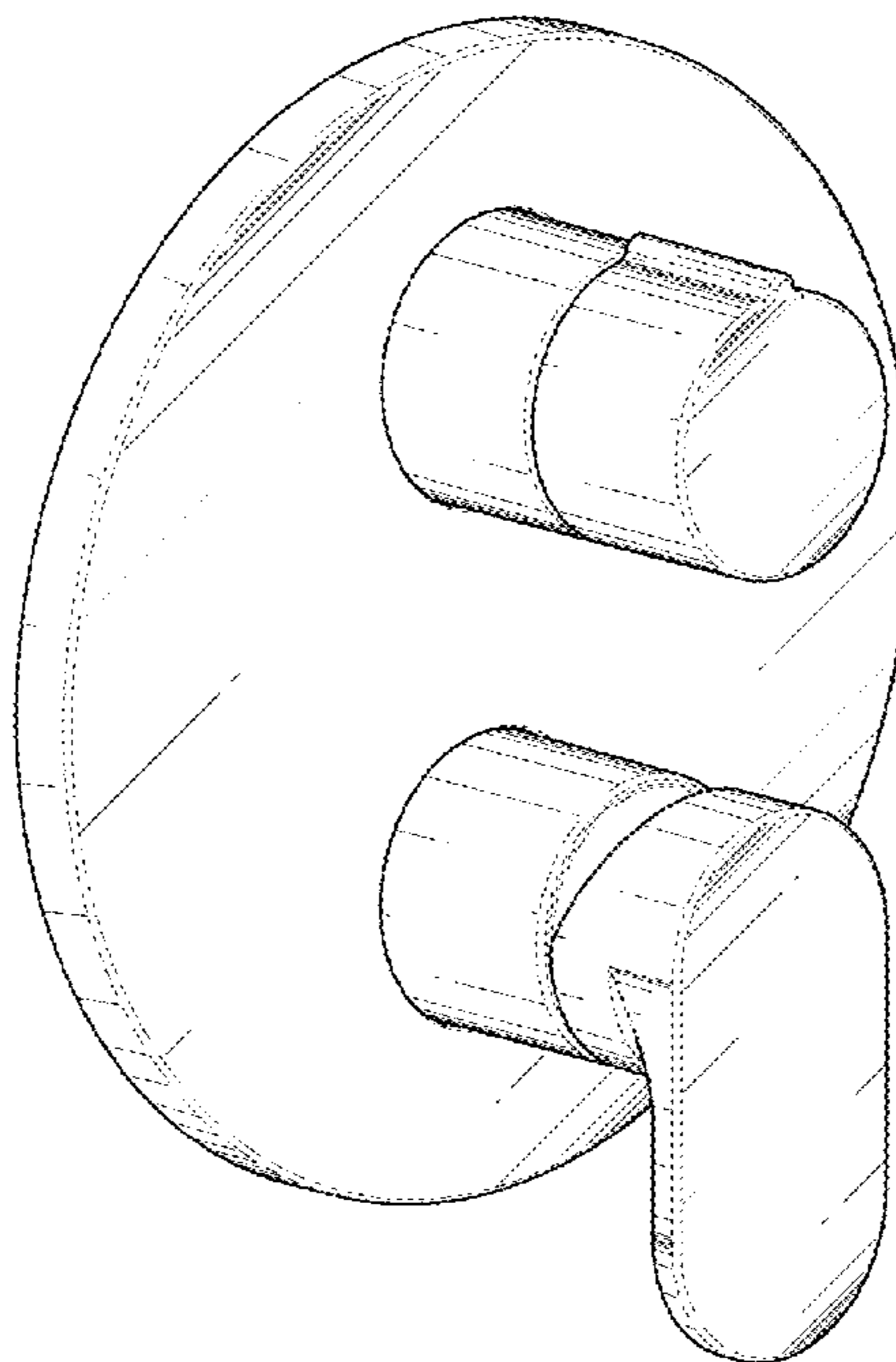
(57) **CLAIM**

The ornamental design for a thermostatic mixer, as shown and described.

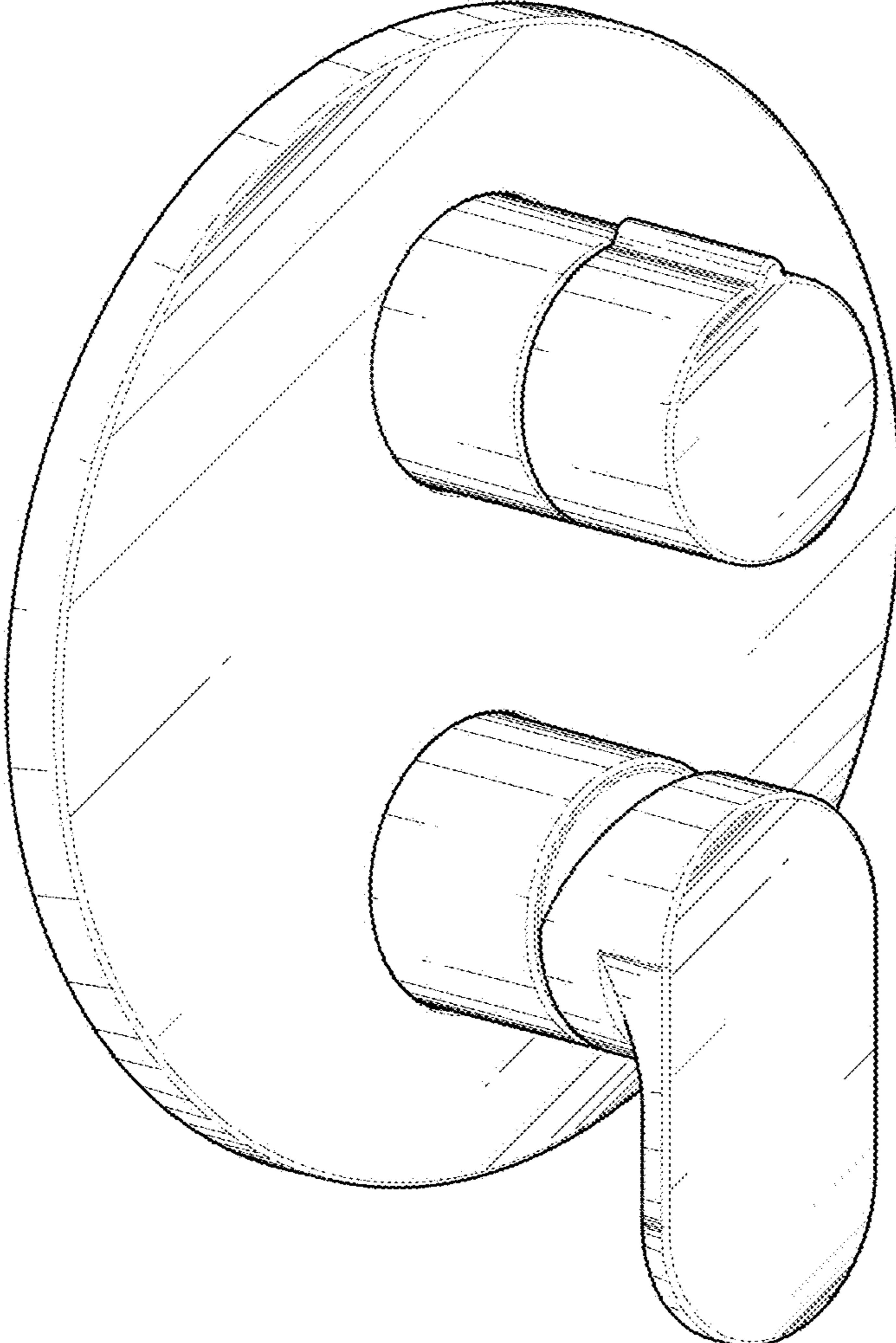

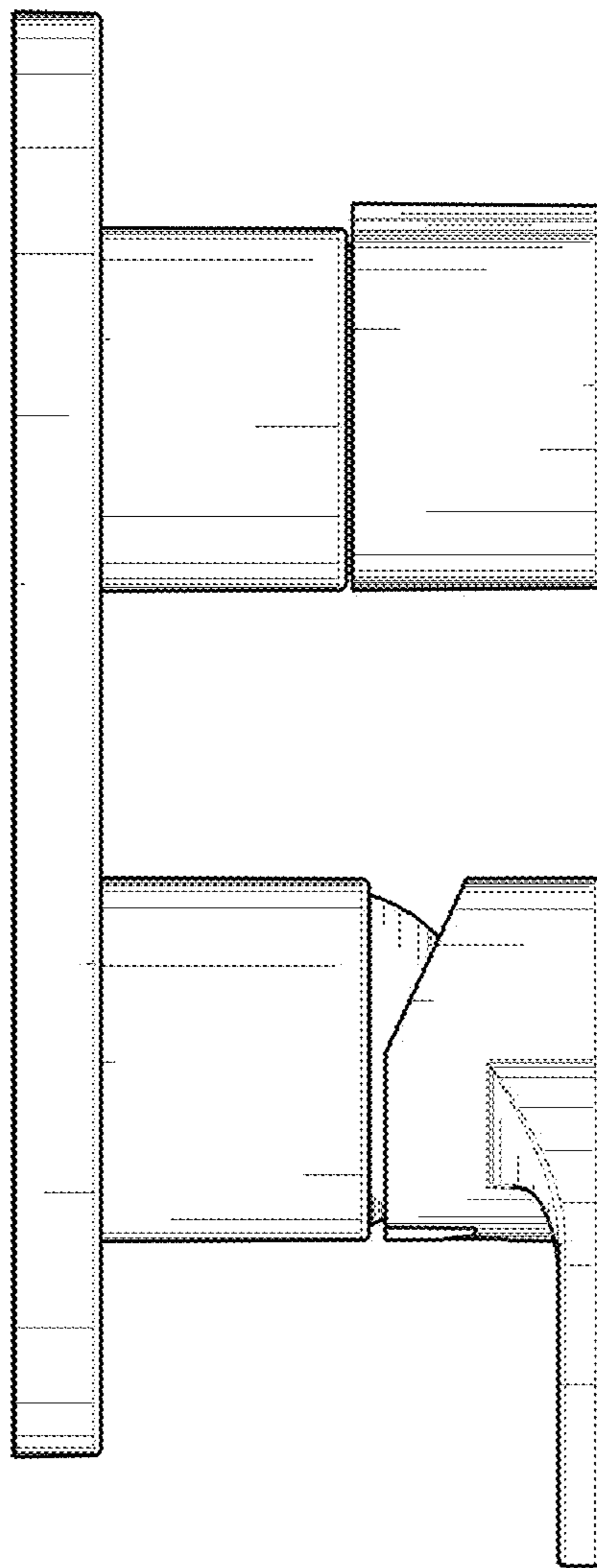

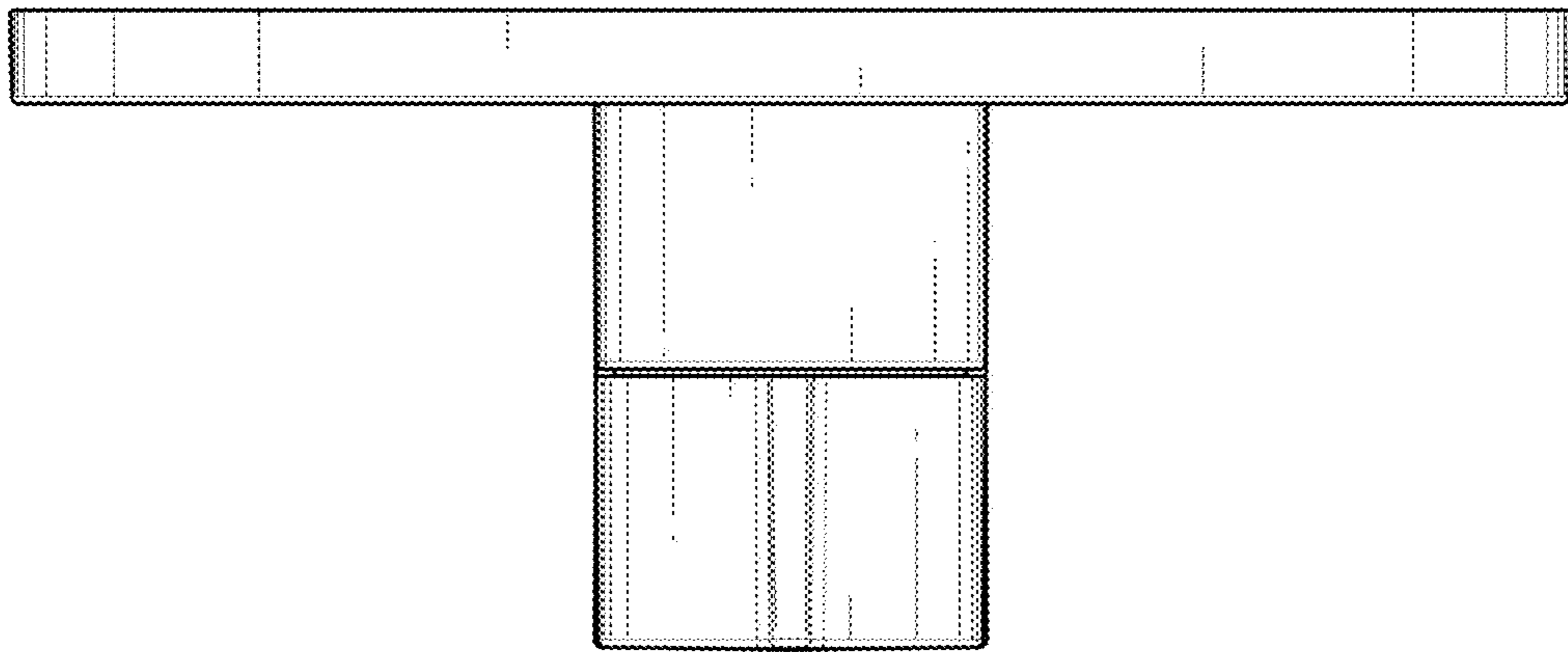

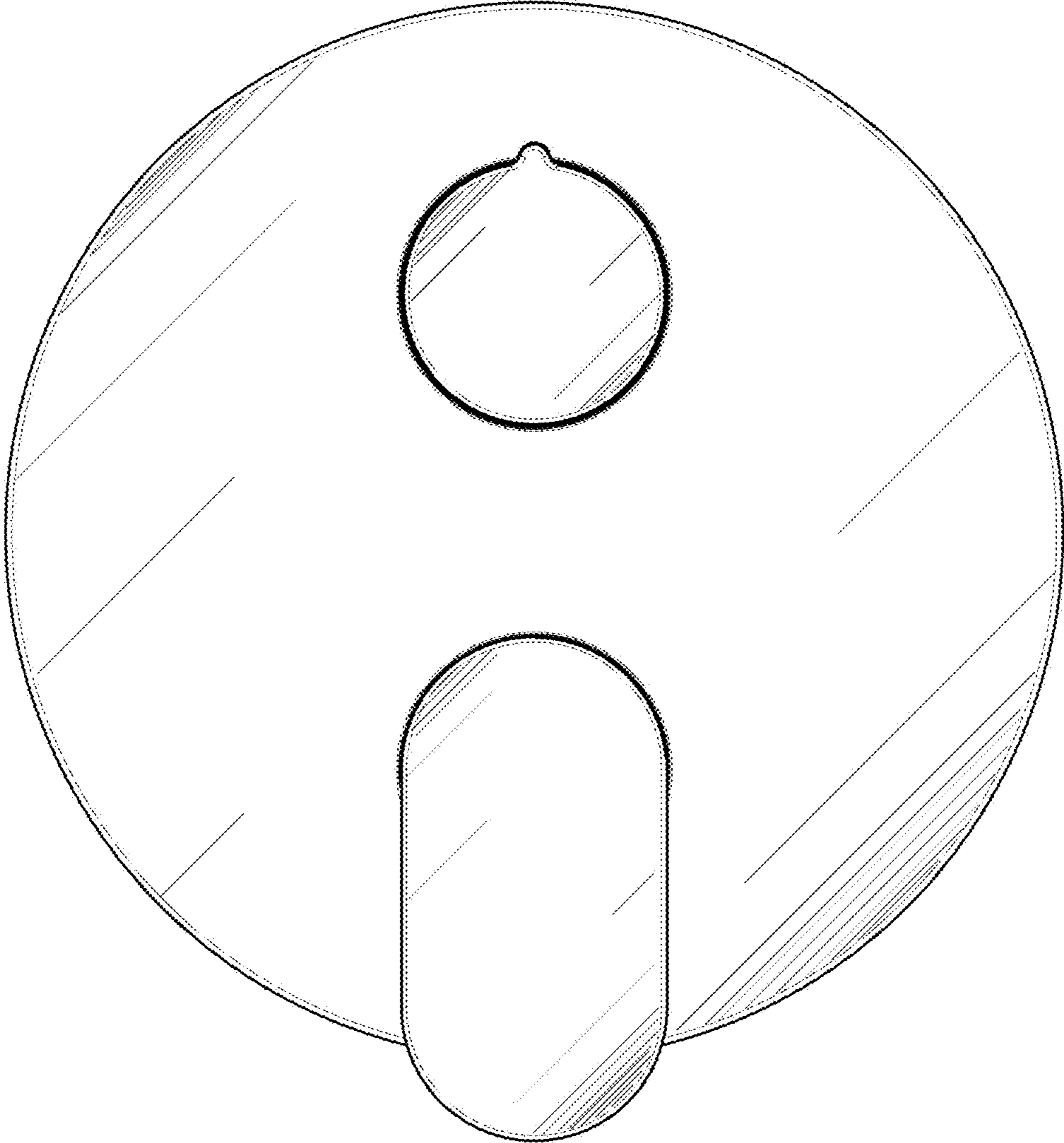
