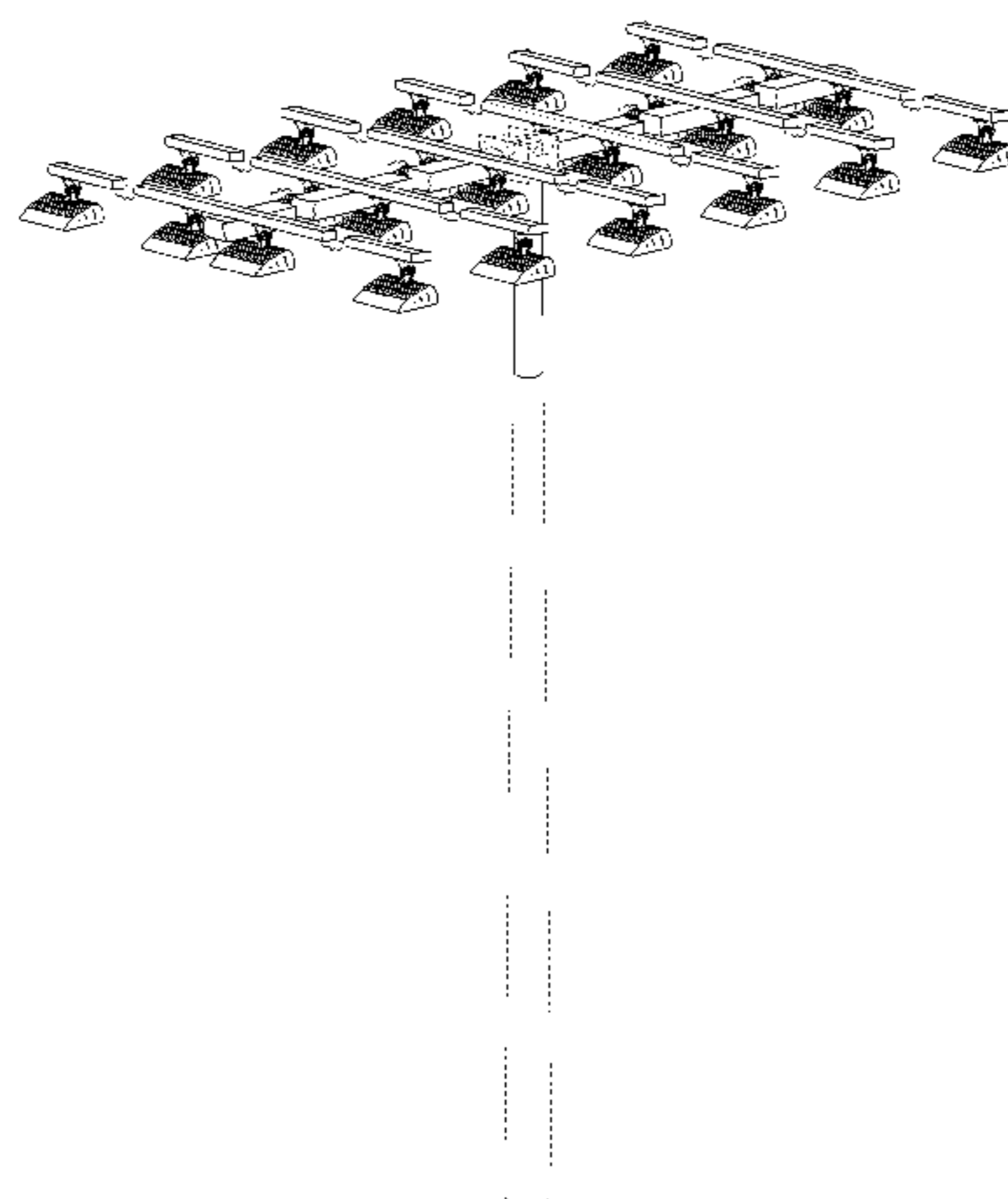

(57) CLAIM

The ornamental design for an array including adjustable
 armature, knuckles, and lighting fixtures, as shown and
 described.

DESCRIPTION

FIG. 1 is a perspective view of the design shown in a typical
 environment in which it is used;

FIG. 2 is an enlarged perspective view of the design;

FIG. 3 is a front elevation view of FIG. 2;

FIG. 4 is a back elevation view of FIG. 2;

FIG. 5 is a reduced in scale top plan view of FIG. 2;

FIG. 6 is a reduced in scale bottom plan view of FIG. 2;

FIG. 7 is a right side elevation of FIG. 2; and

FIG. 8 is a left side elevation of FIG. 2;

FIG. 9 is a perspective view of an embodiment of the design
 shown in a typical environment in which it is used;

FIG. 10 is an enlarged perspective view of the embodiment of
 FIG. 10;

FIG. 11 is a front elevation view of FIG. 11;

FIG. 12 is a back elevation view of FIG. 11;

FIG. 13 is a reduced in scale top plan view of FIG. 11;

FIG. 14 is a reduced in scale bottom plan view of FIG. 11;

FIG. 15 is a right side elevation of FIG. 11;

FIG. 16 is a left side elevation of FIG. 11;

FIG. 17 is a right side elevation view of the embodiment of
 FIGS. 9-16 with lighting fixtures in different possible exem-
 plary operational orientations than FIG. 15, for illustration of
 alternative angular position adjustability;

FIG. 18 is a perspective view of an individual fixture in
 isolation taken generally along line 18-18 of FIGS. 2 and 10;

FIG. 19 is a perspective view of the individual fixture of FIG.
 18 from a different viewing direction;

FIG. 20 is a top plan view of FIG. 18;

FIG. 21 is a bottom plan view of FIG. 18;

FIG. 22 is a front elevation of FIG. 18;

FIG. 23 is a back elevation of FIG. 18;

FIG. 24 is a right side elevation of FIG. 18;

FIG. 25 is a left side elevation of FIG. 18;

FIG. 26 is a perspective view of a visor in isolation that is
 installed on the housing of FIGS. 18-25;

FIG. 27 is a top plan view of FIG. 26;

FIG. 28 is a bottom plan view of FIG. 26;

FIG. 29 is a front elevation view of FIG. 26;

FIG. 30 is a back elevation view of FIG. 26;

FIG. 31 is a left side elevation view of FIG. 26;

FIG. 32 is a right side elevation view of FIG. 26; and,

FIG. 33 is a view taken along section 8-8 of FIG. 27.

The broken lines shown in the drawings illustrating
 unclaimed portions of the array including adjustable arma-
 ture, knuckles, and lighting fixtures form no part of the
 claimed design. The separations (indicated by brackets) in
 FIGS. 1-8 indicate that, for illustration, the precise length of
 armature, particular number of knuckles and lighting fixtures
 (both total number and number per armature), and precise
 number of armatures is not claimed. FIGS. 18-25 are included
 to show in isolation more detail and in enlarged scale portions
 of an individual fixture housing such as is used in the fixtures
 in the array of fixtures shown in FIGS. 1-17 for clarity such as
 are shown in FIGS. 1-17. FIGS. 26-33 are included in isola-
 tion to show in more detail and in enlarged scale portions of an
 individual visor such as is installed on the front edge of the
 housing of FIGS. 18-25 in the fixtures in the array of fixtures
 shown in FIGS. 1-17 for clarity. FIGS. 1-17 define the overall
 design and FIGS. 18-33 are included to clarify portions of the
 fixtures in FIGS. 1-17 only.

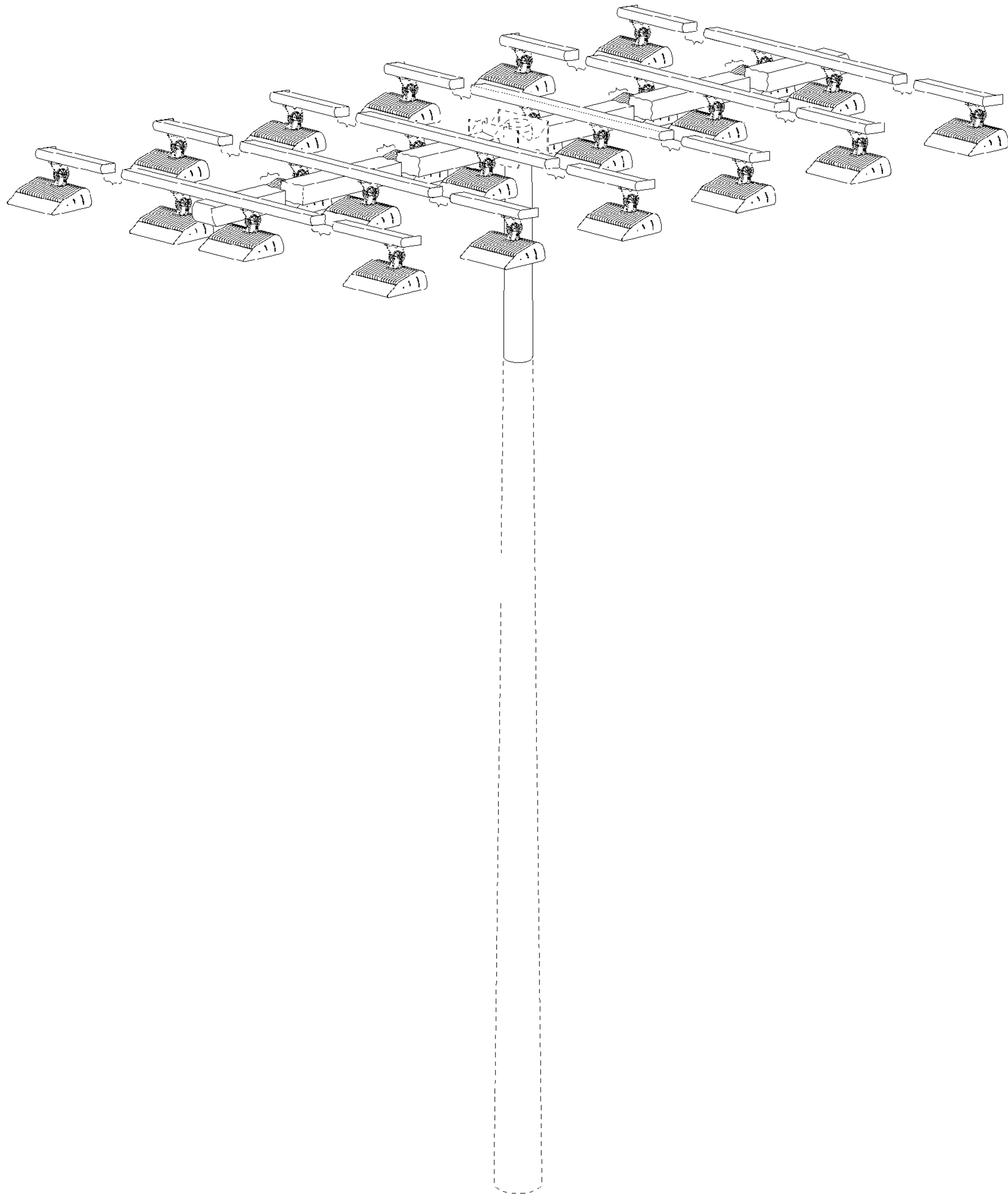

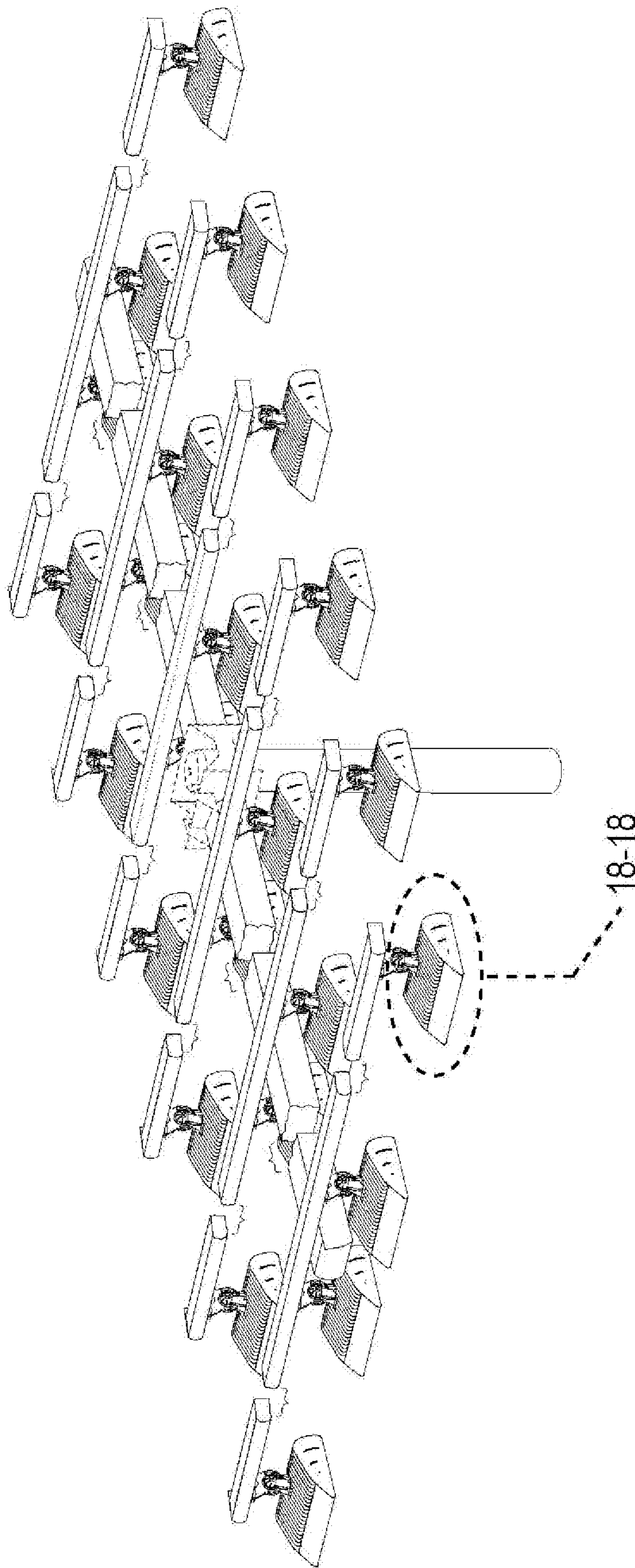

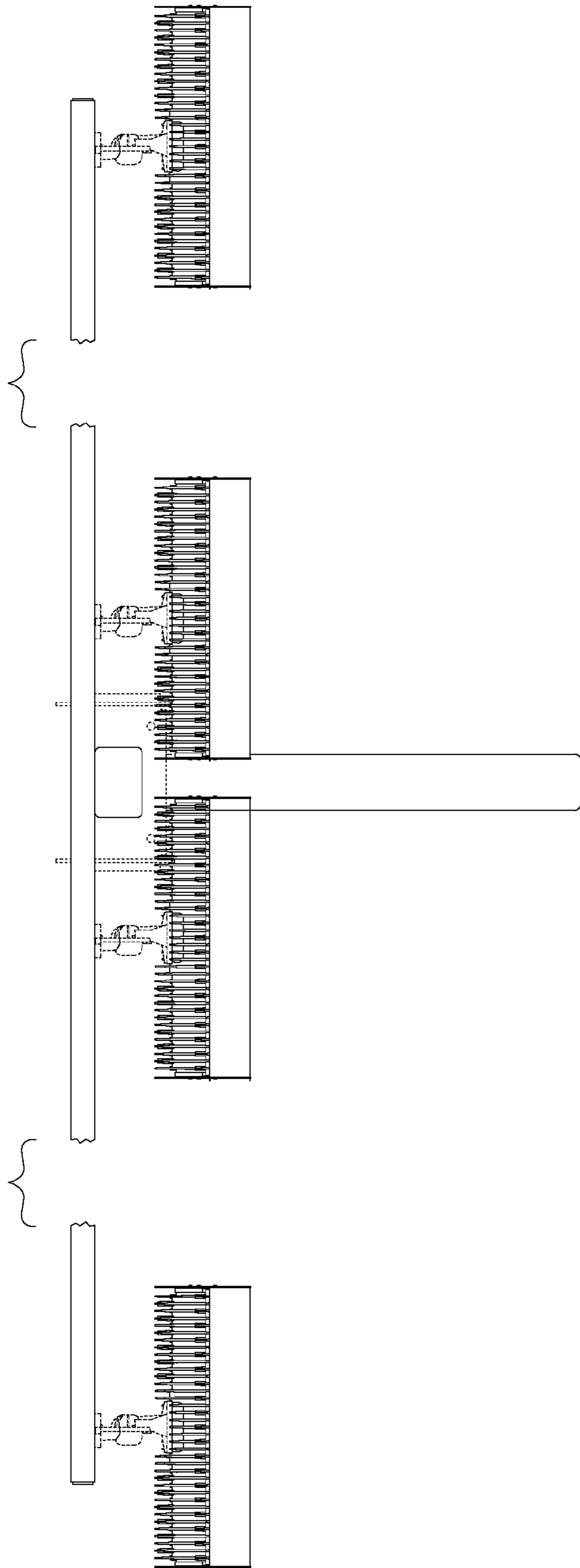

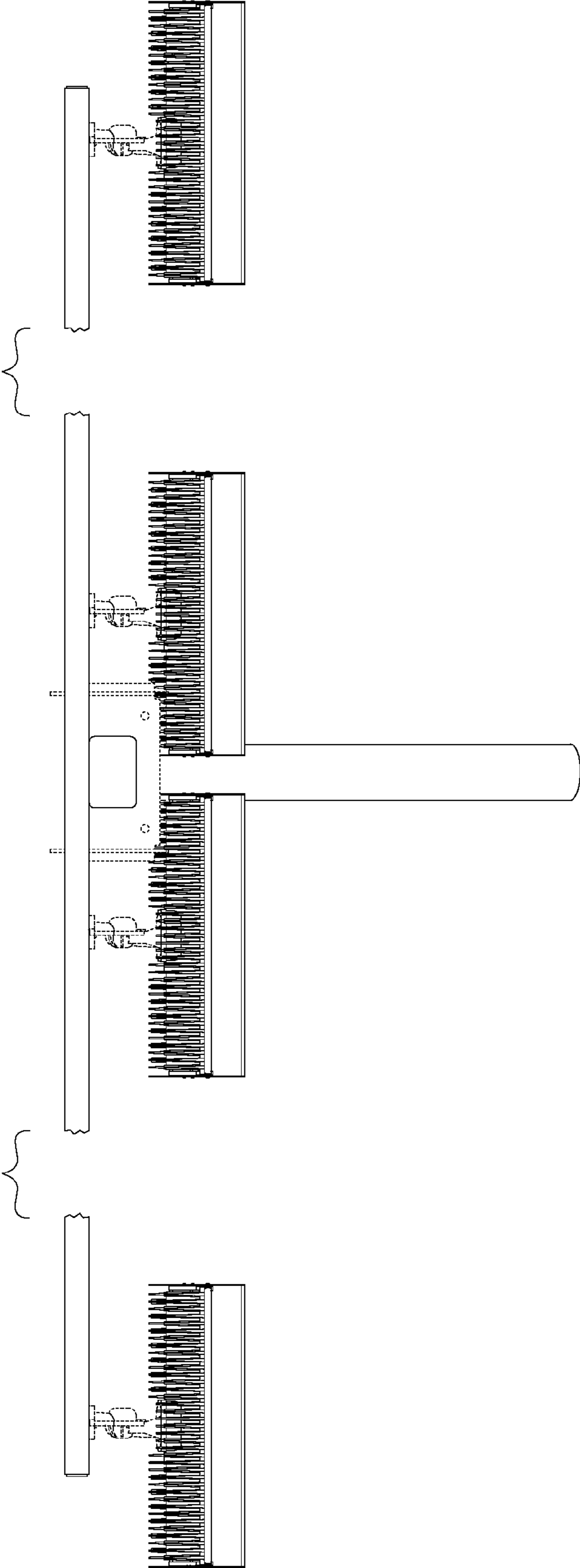

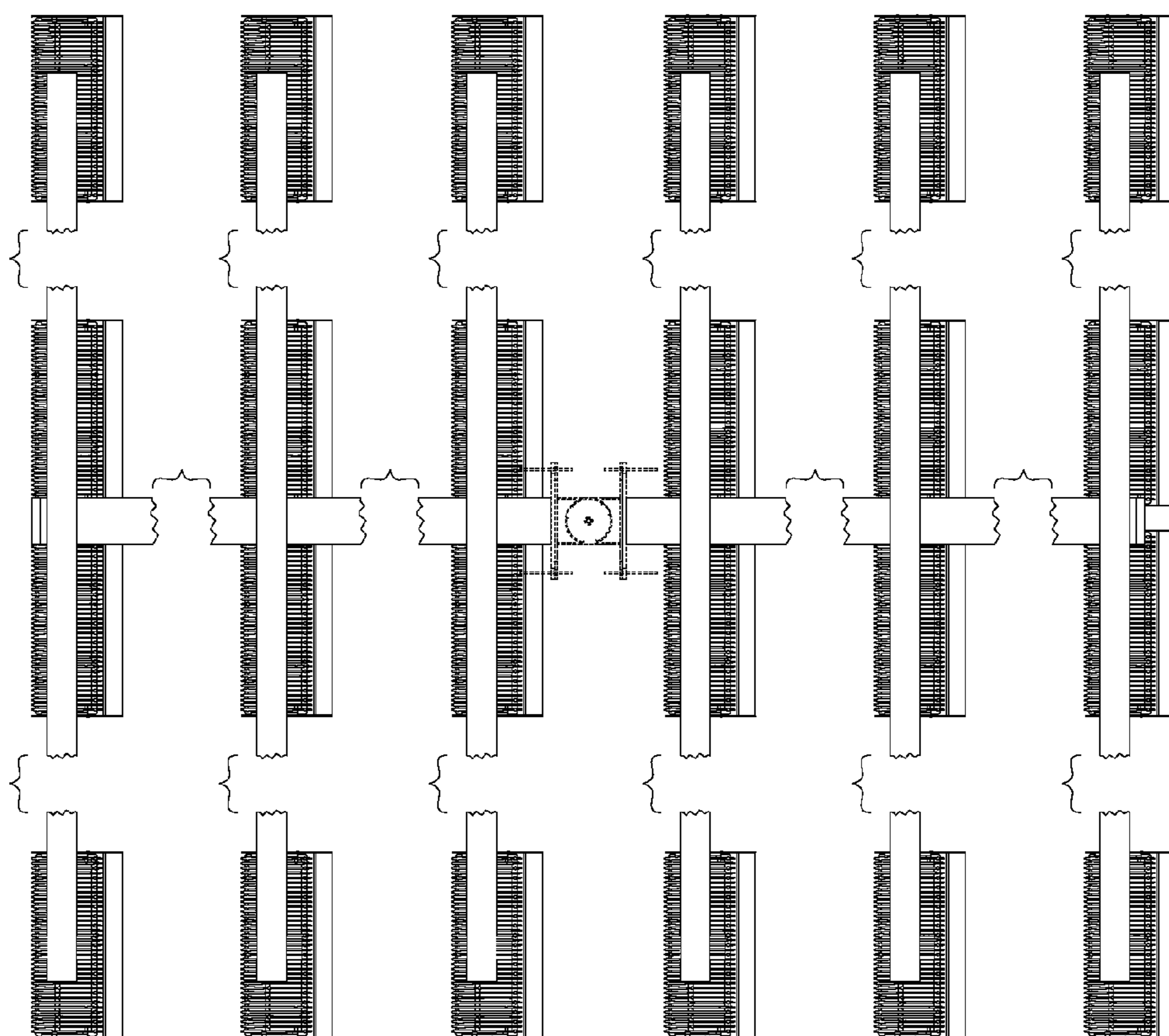

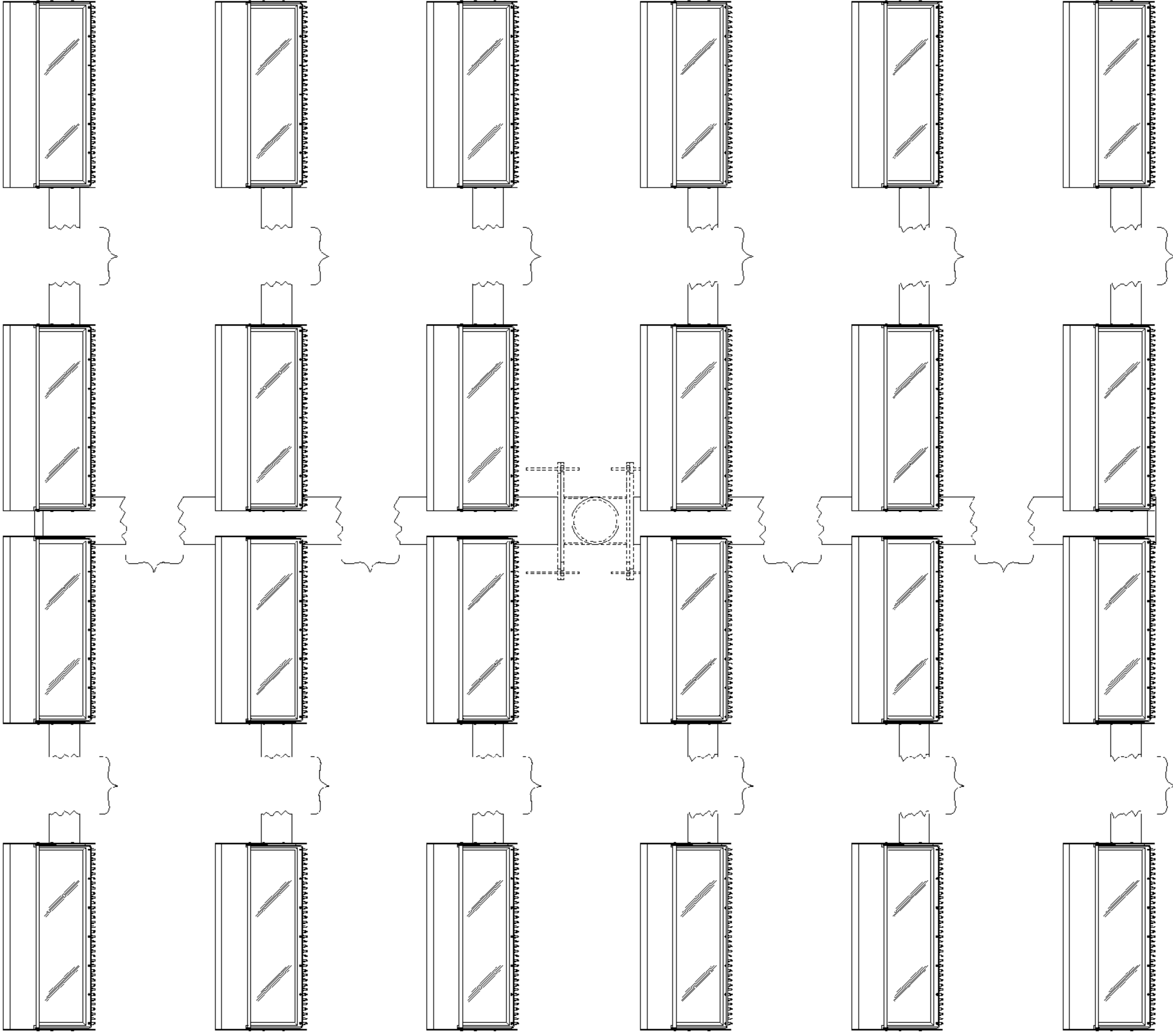

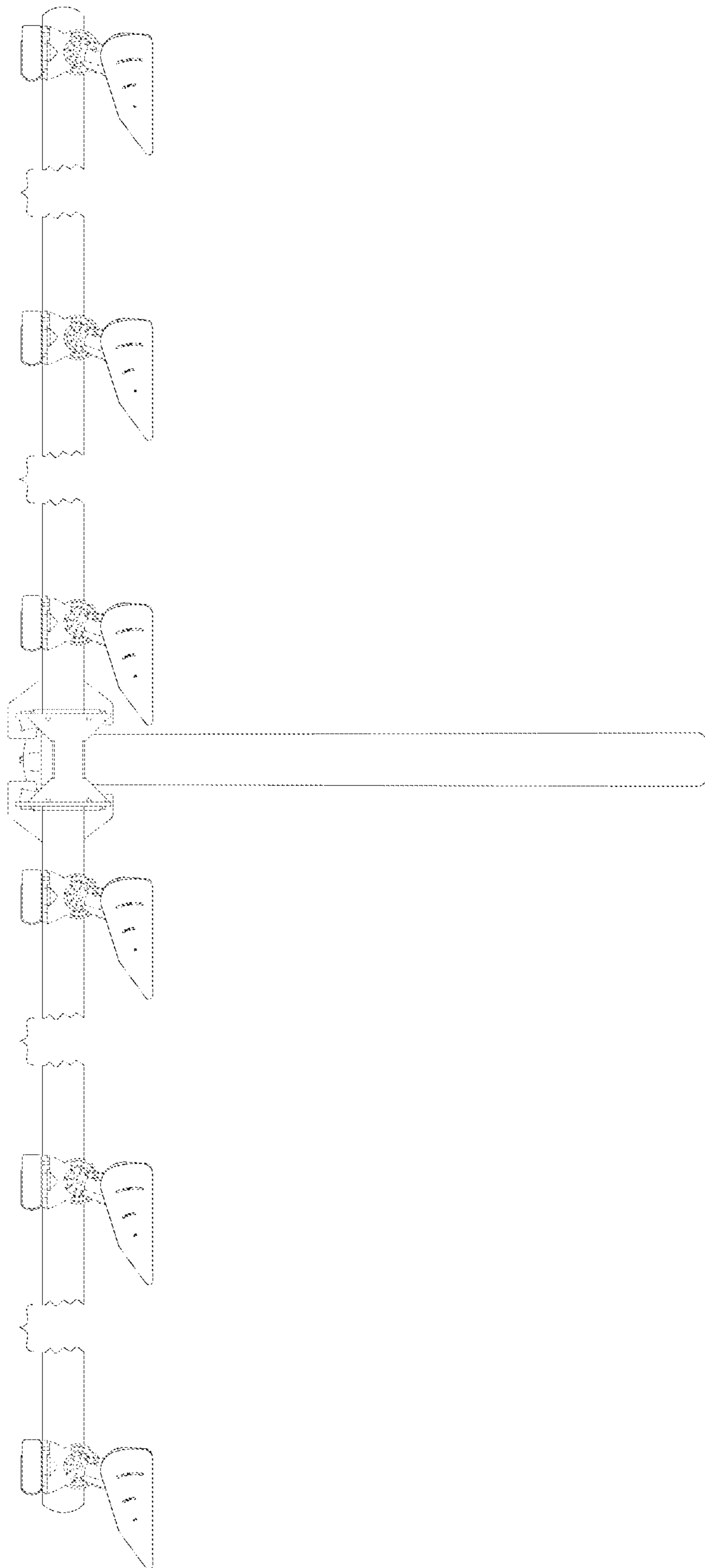

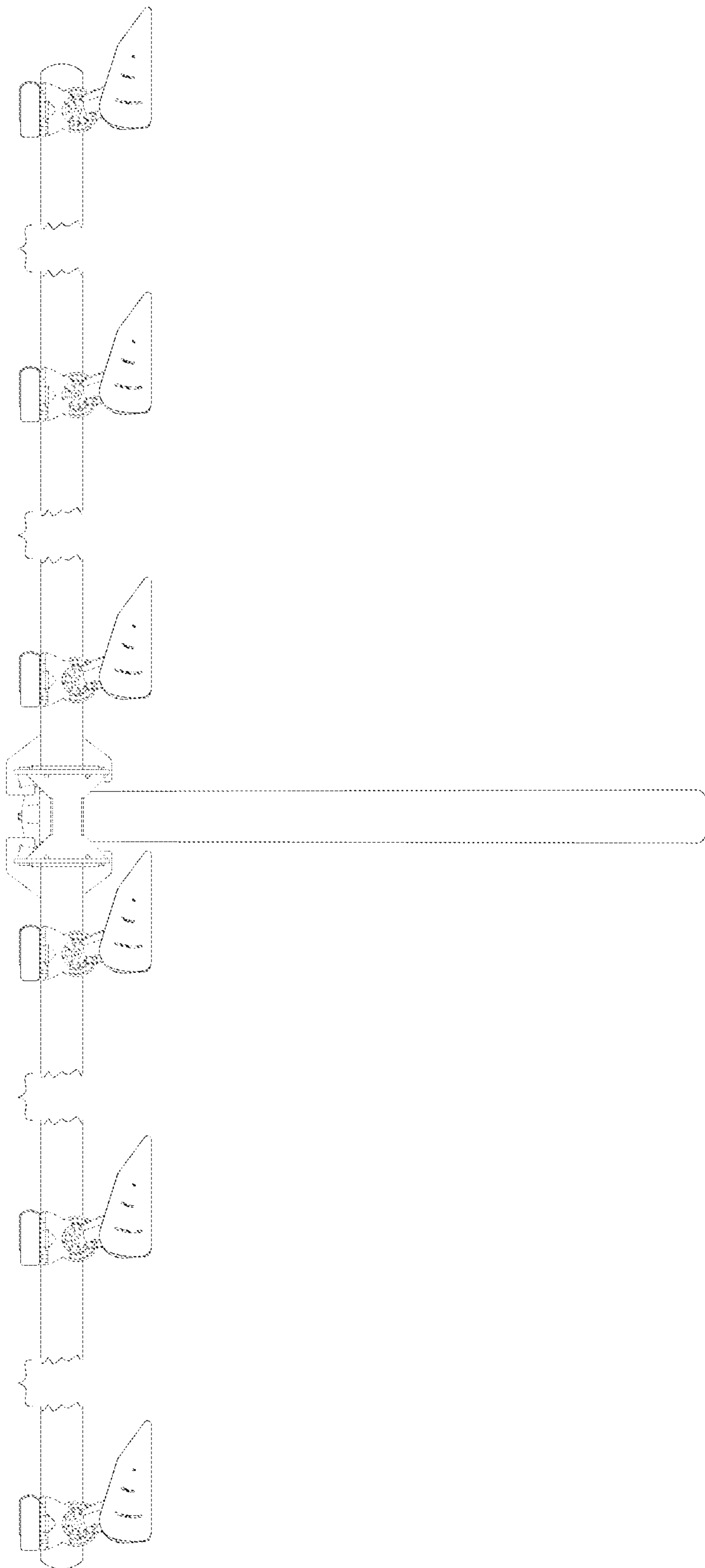

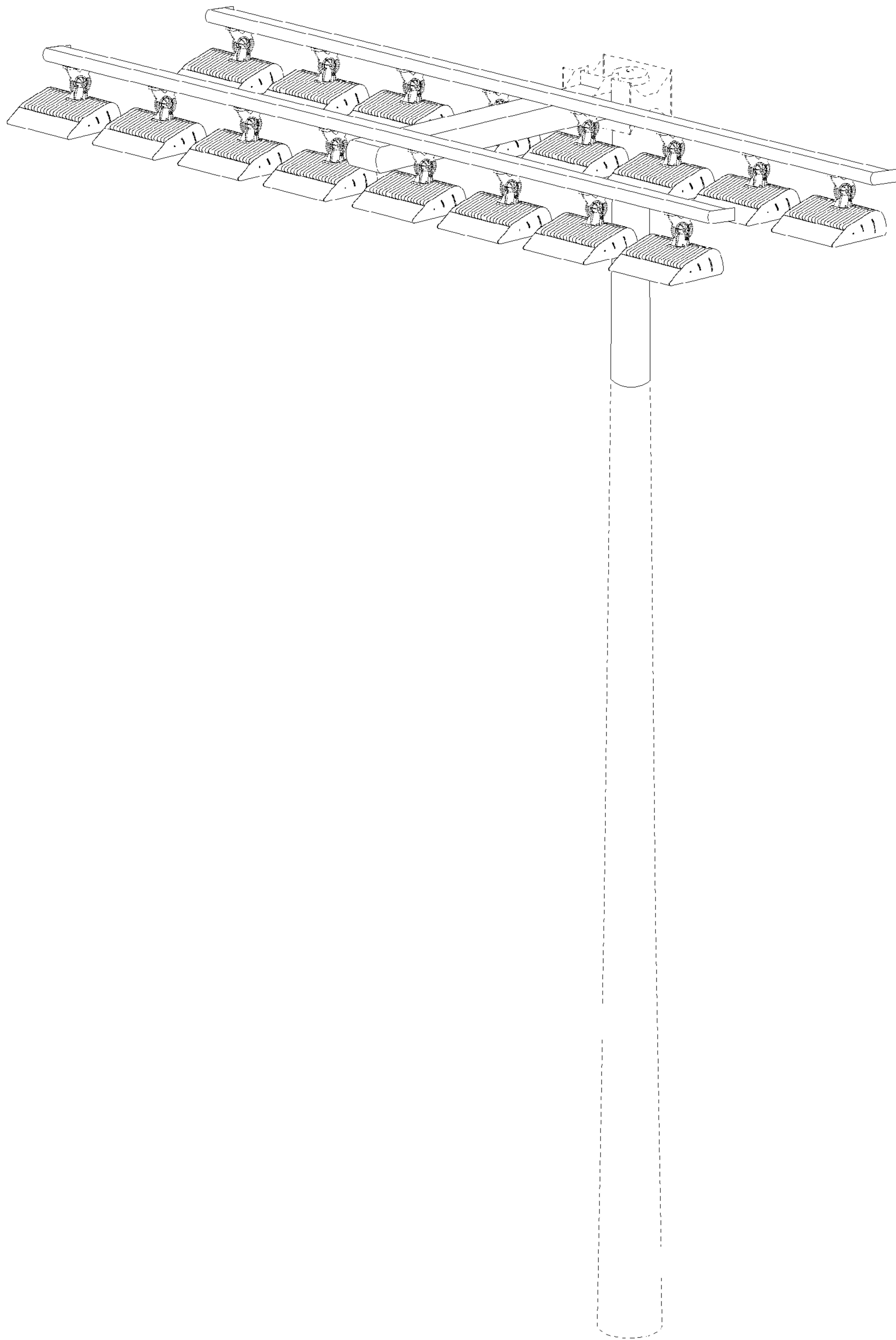

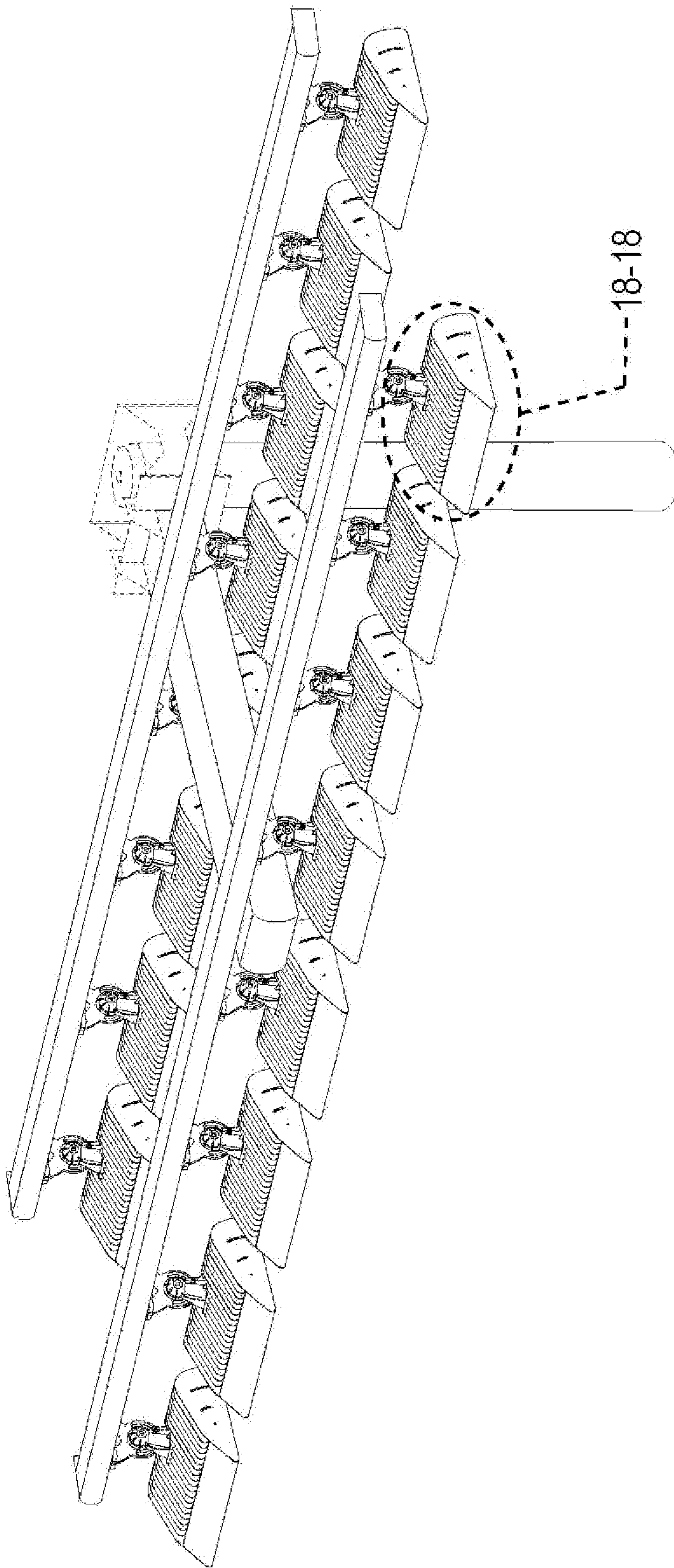

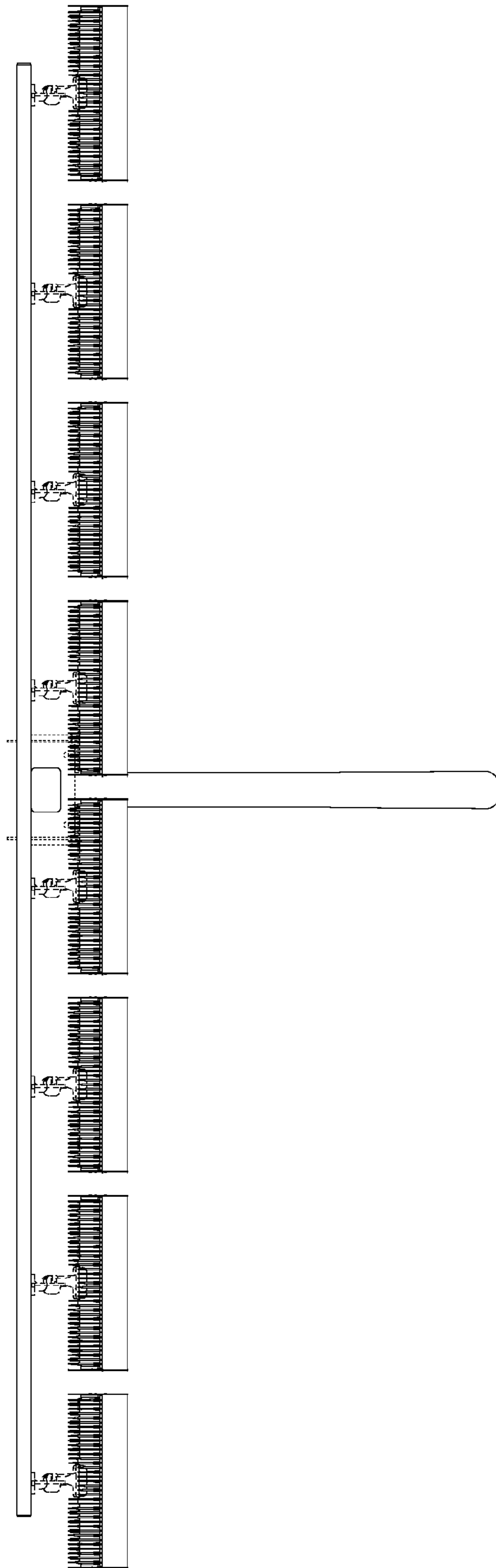

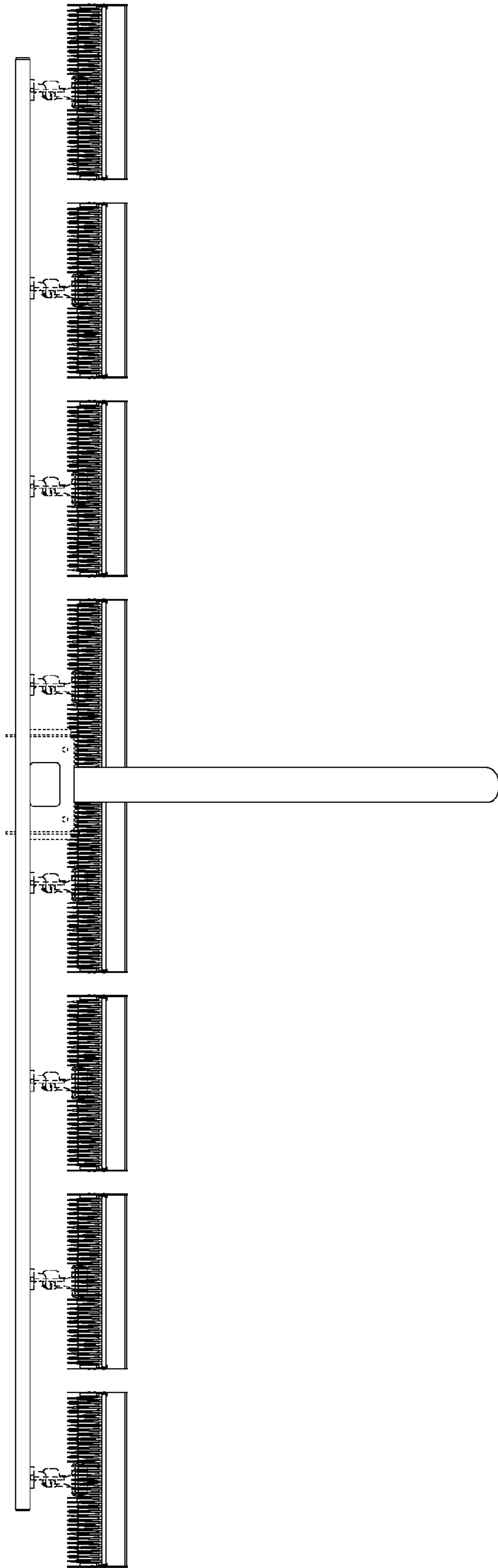

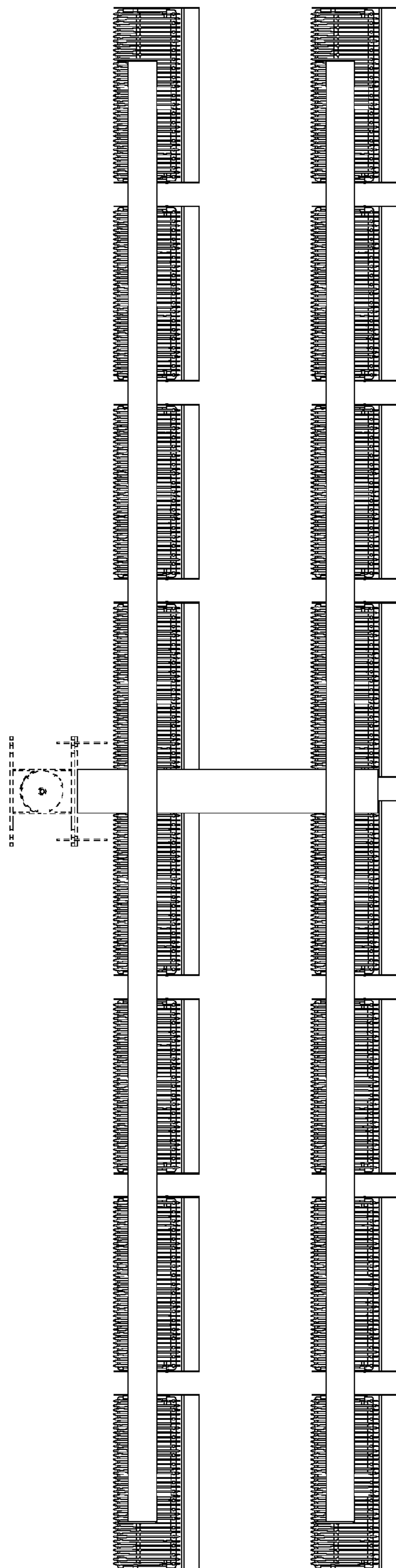

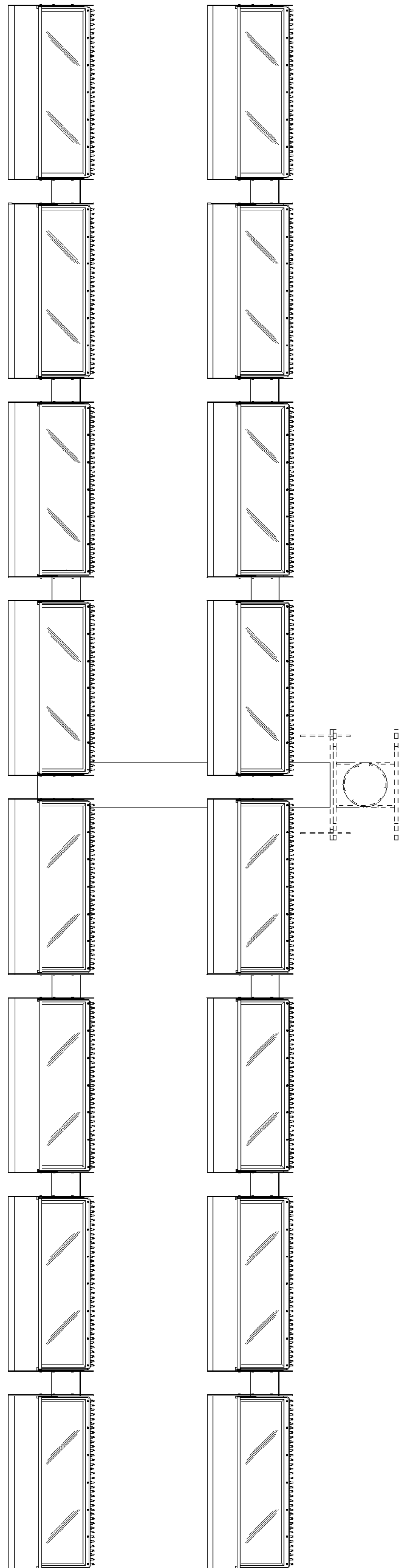

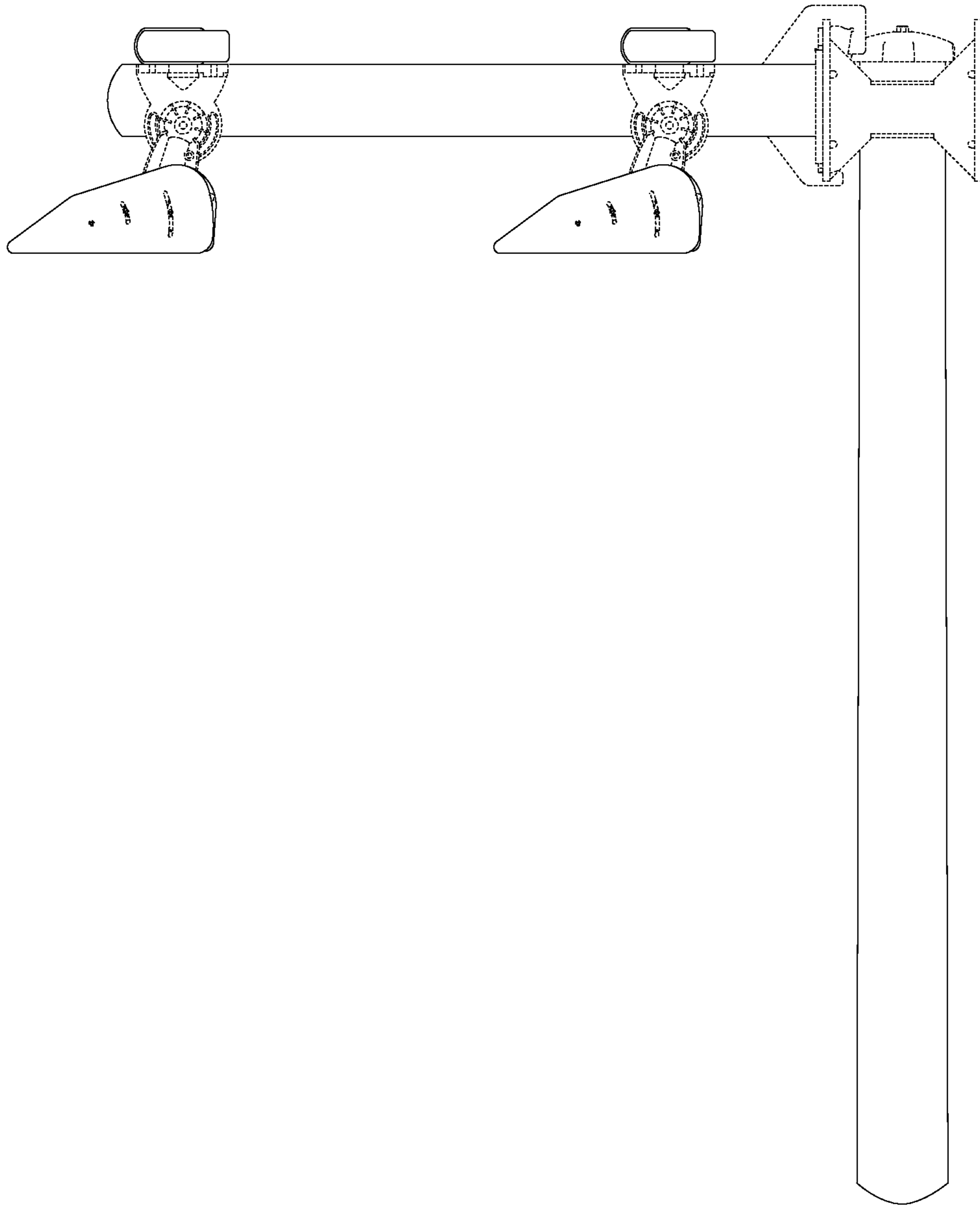

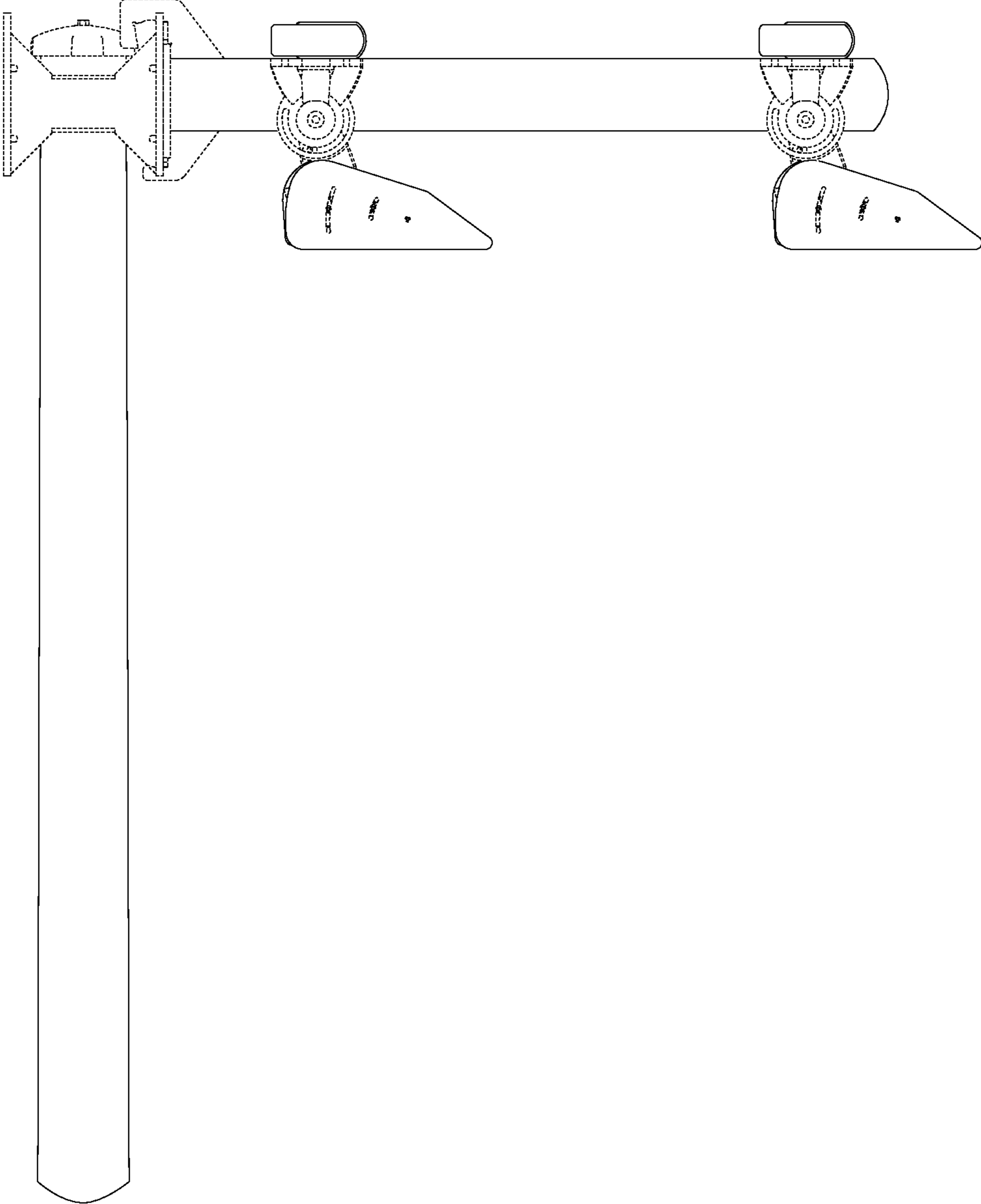

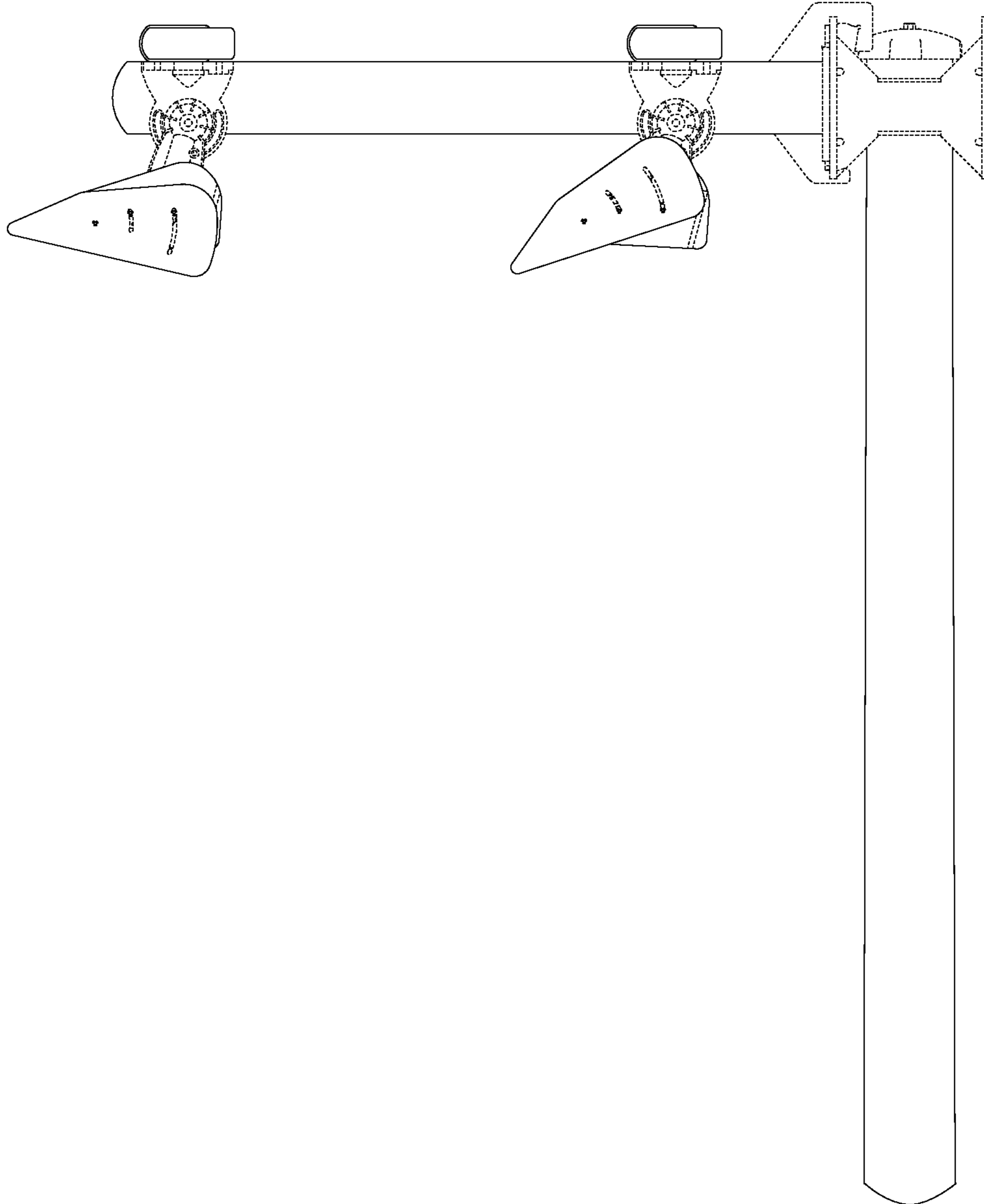

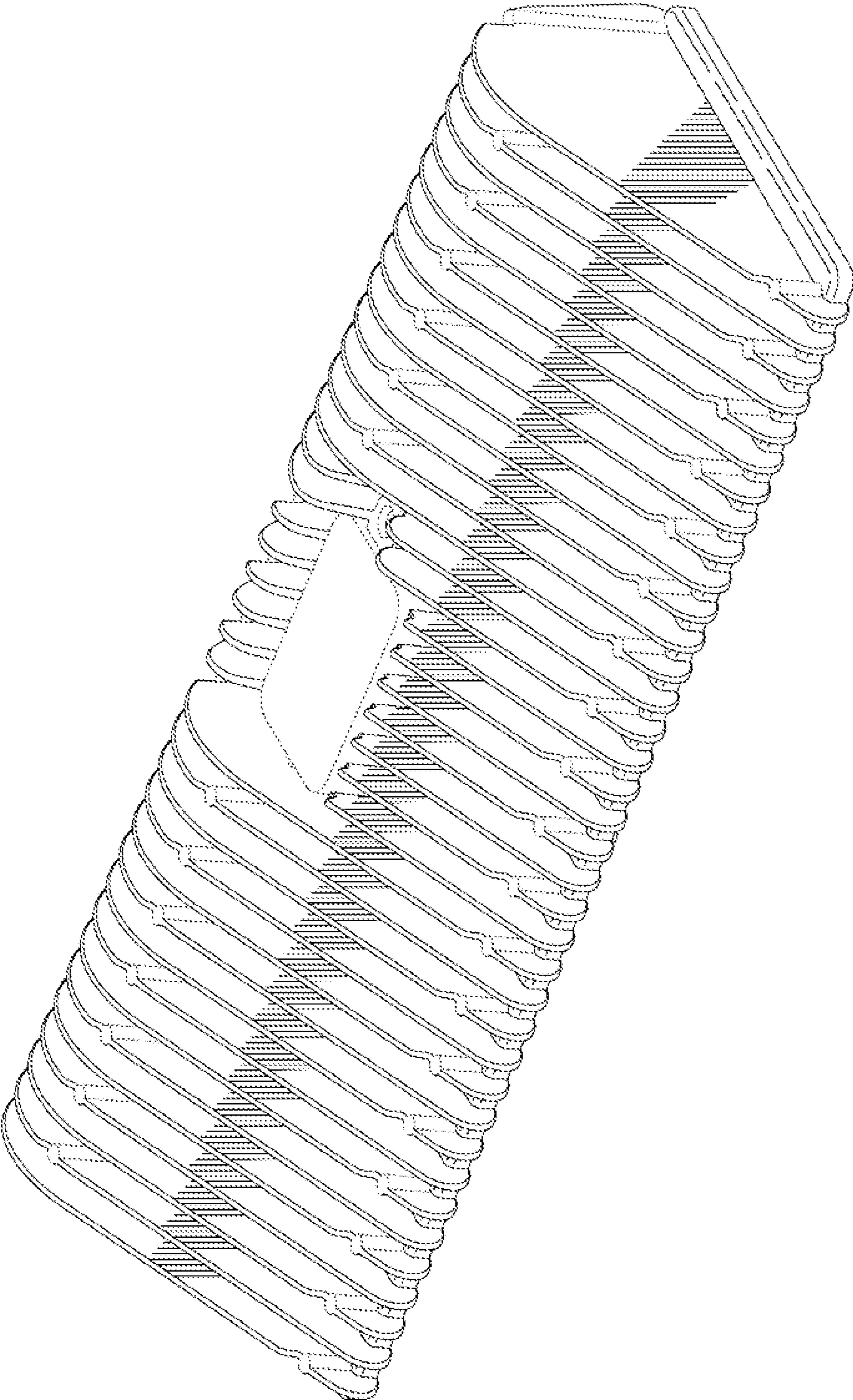

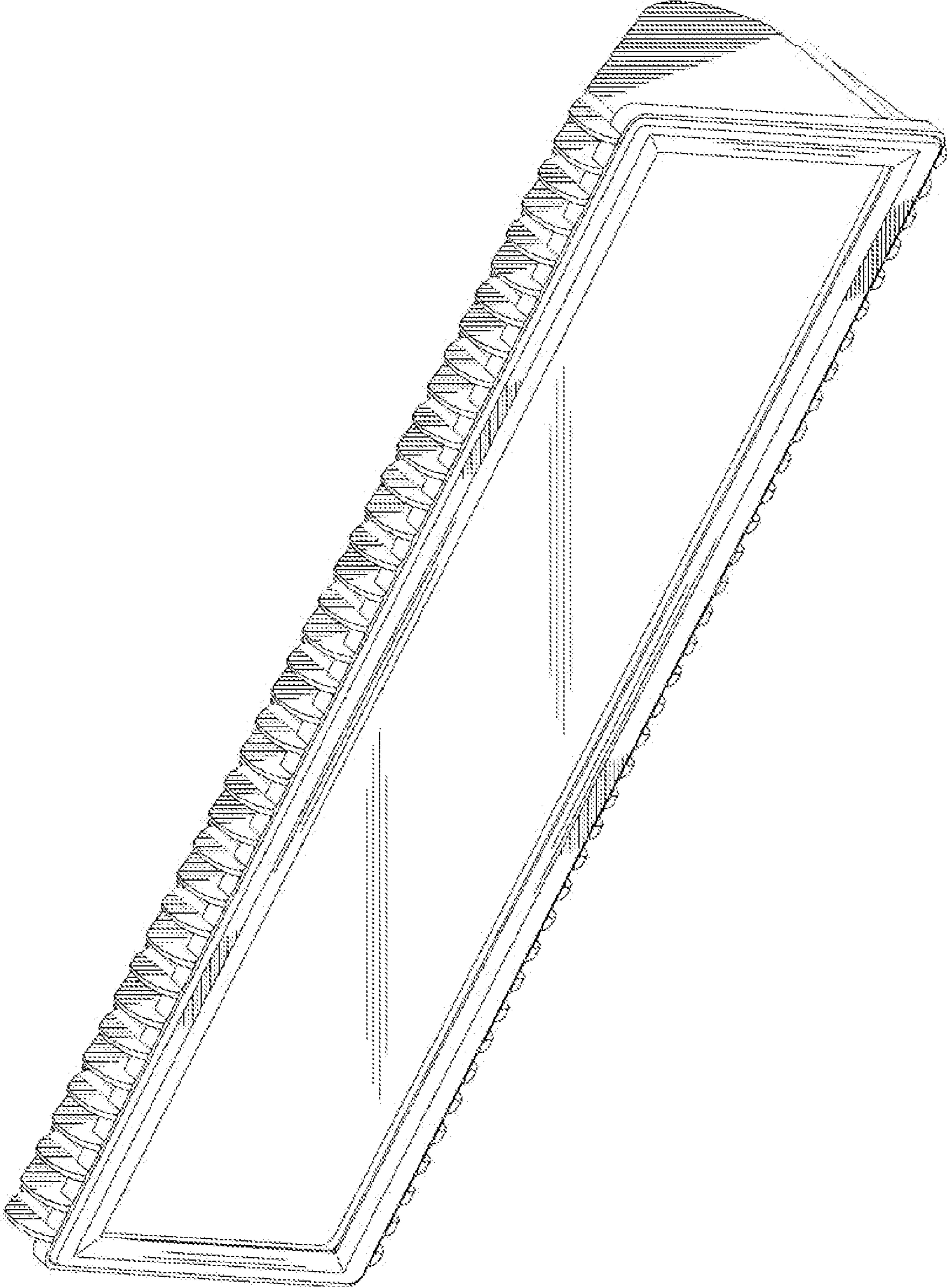

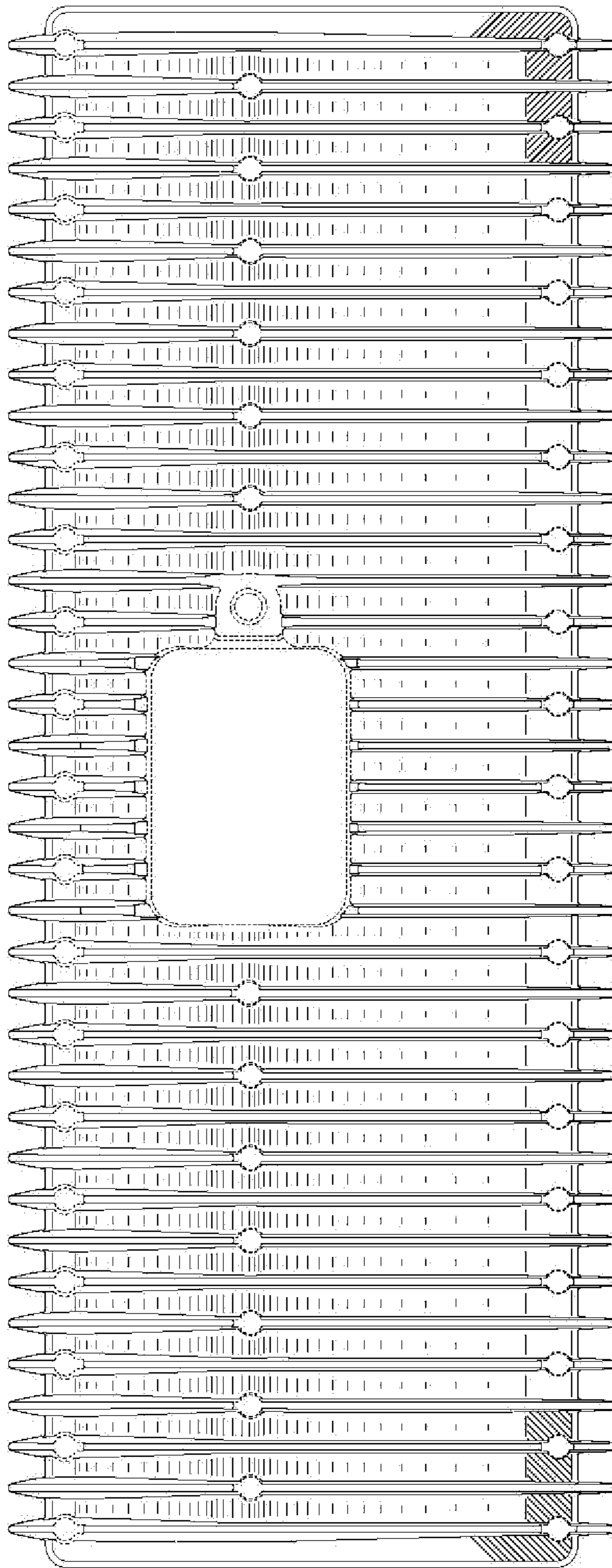

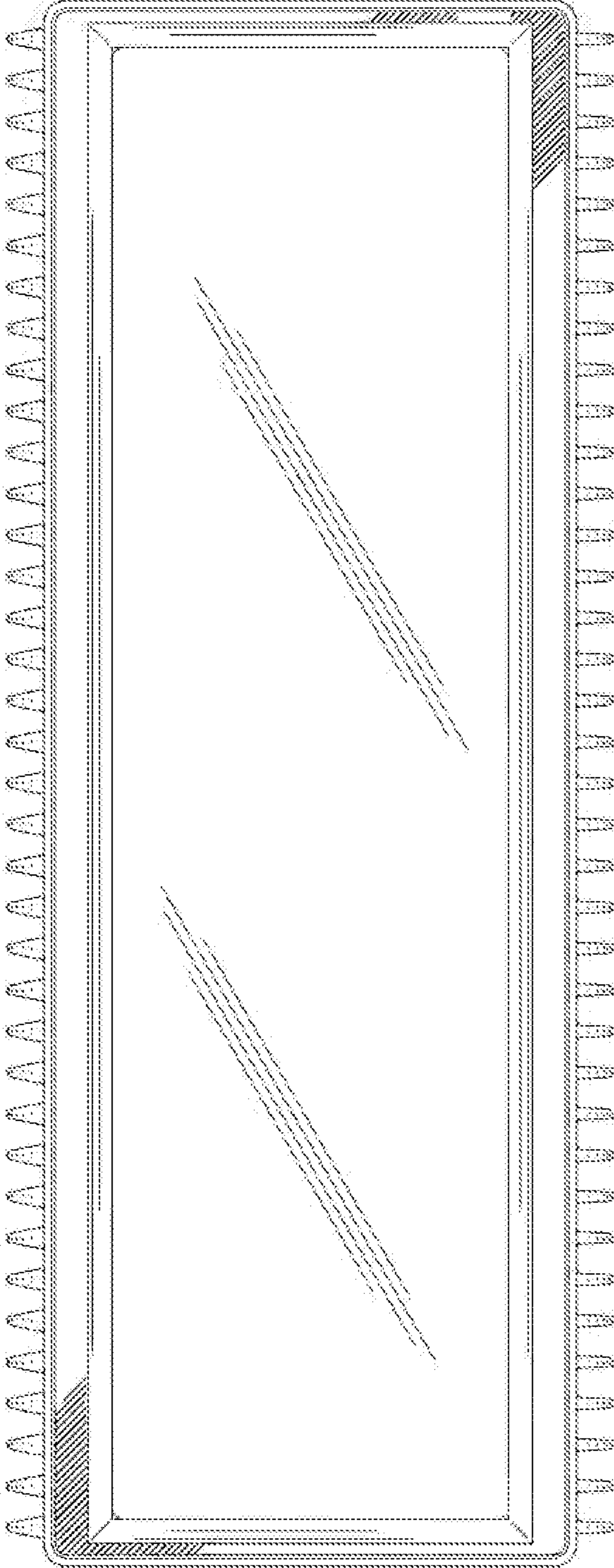

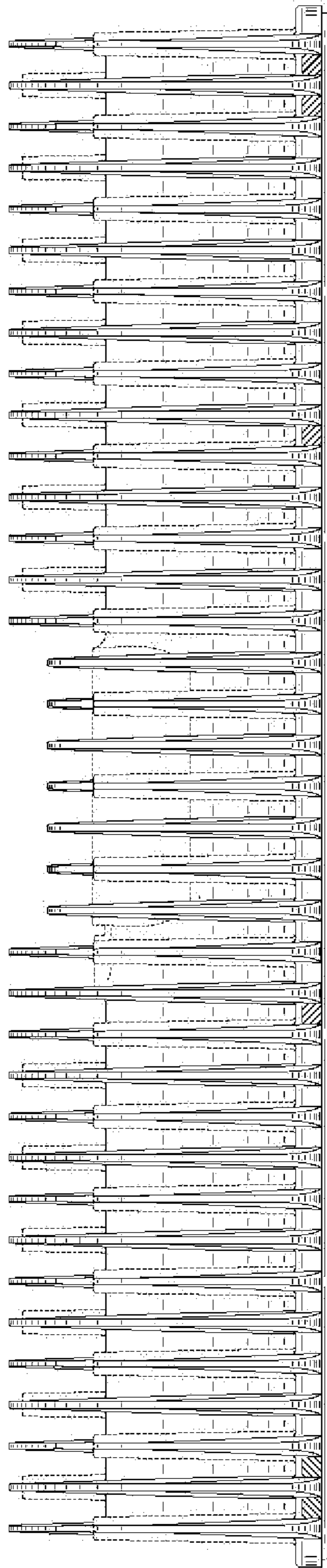

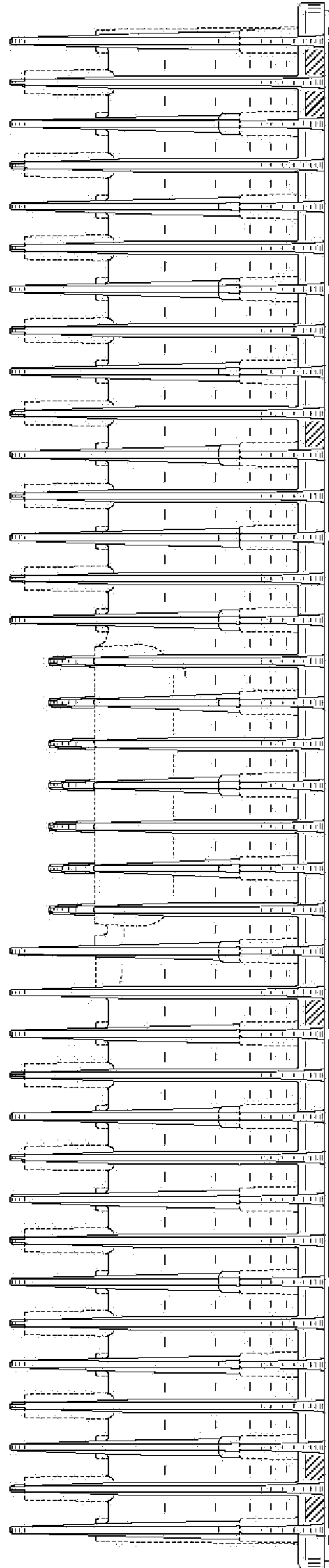

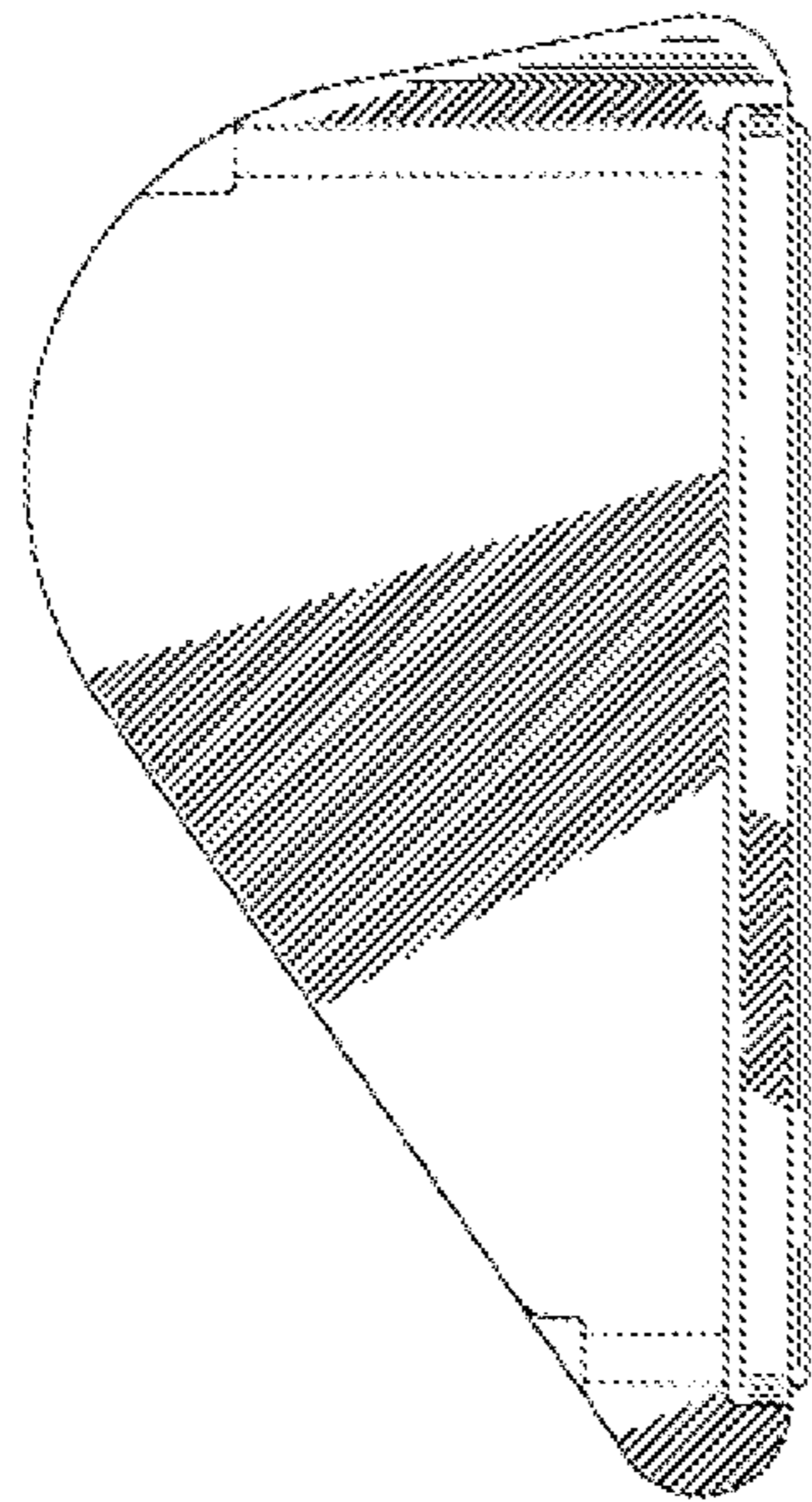

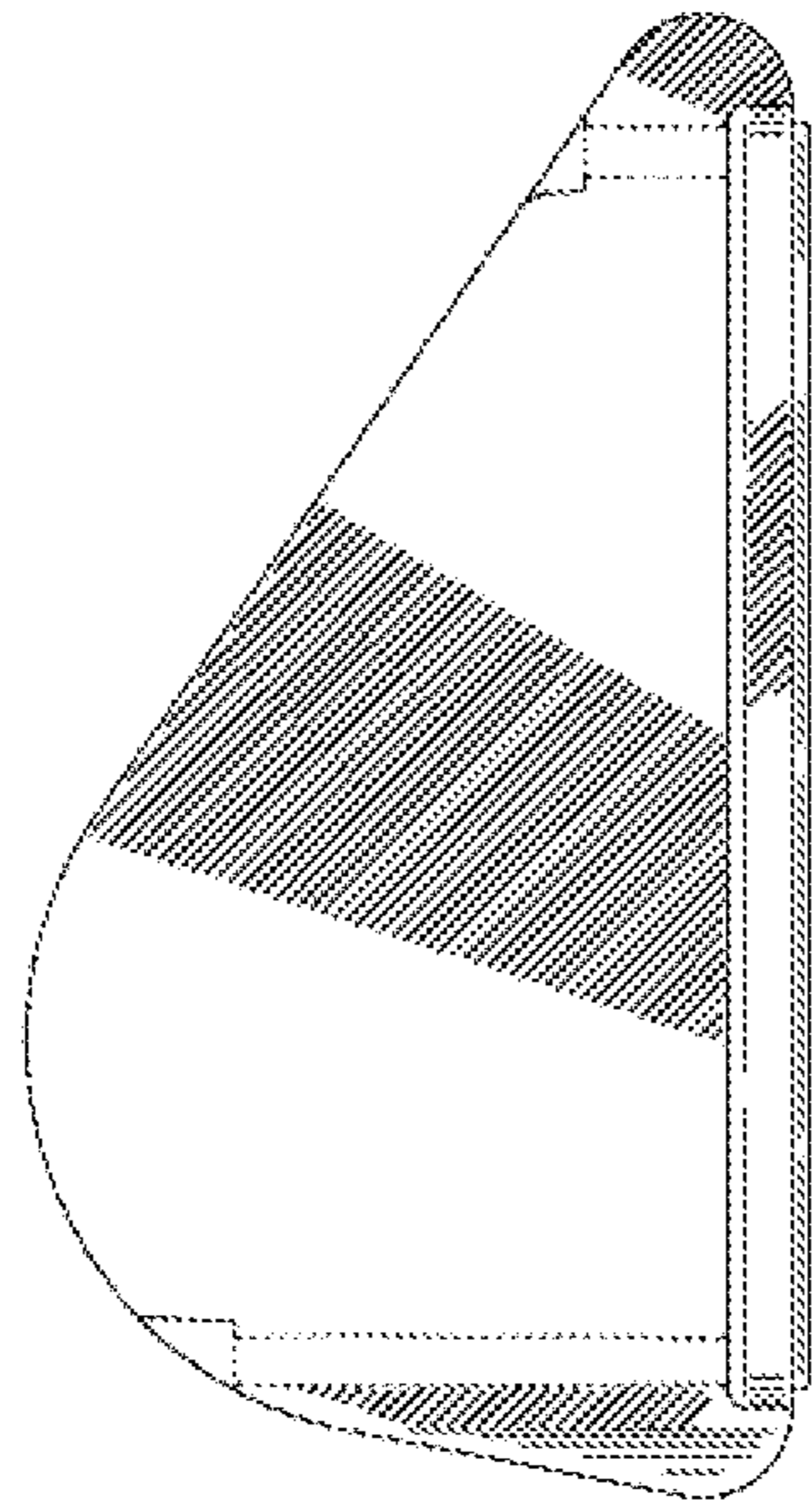

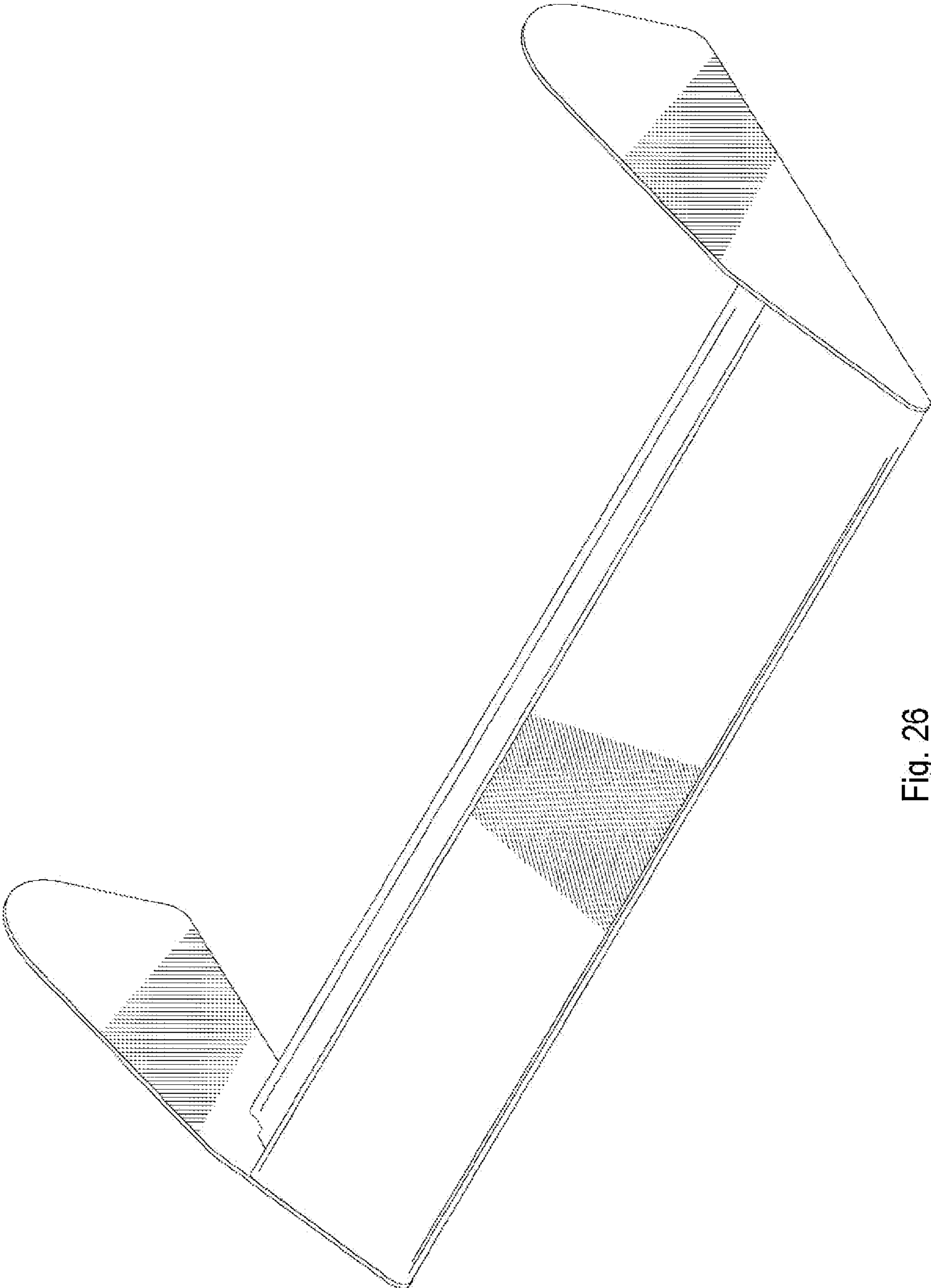

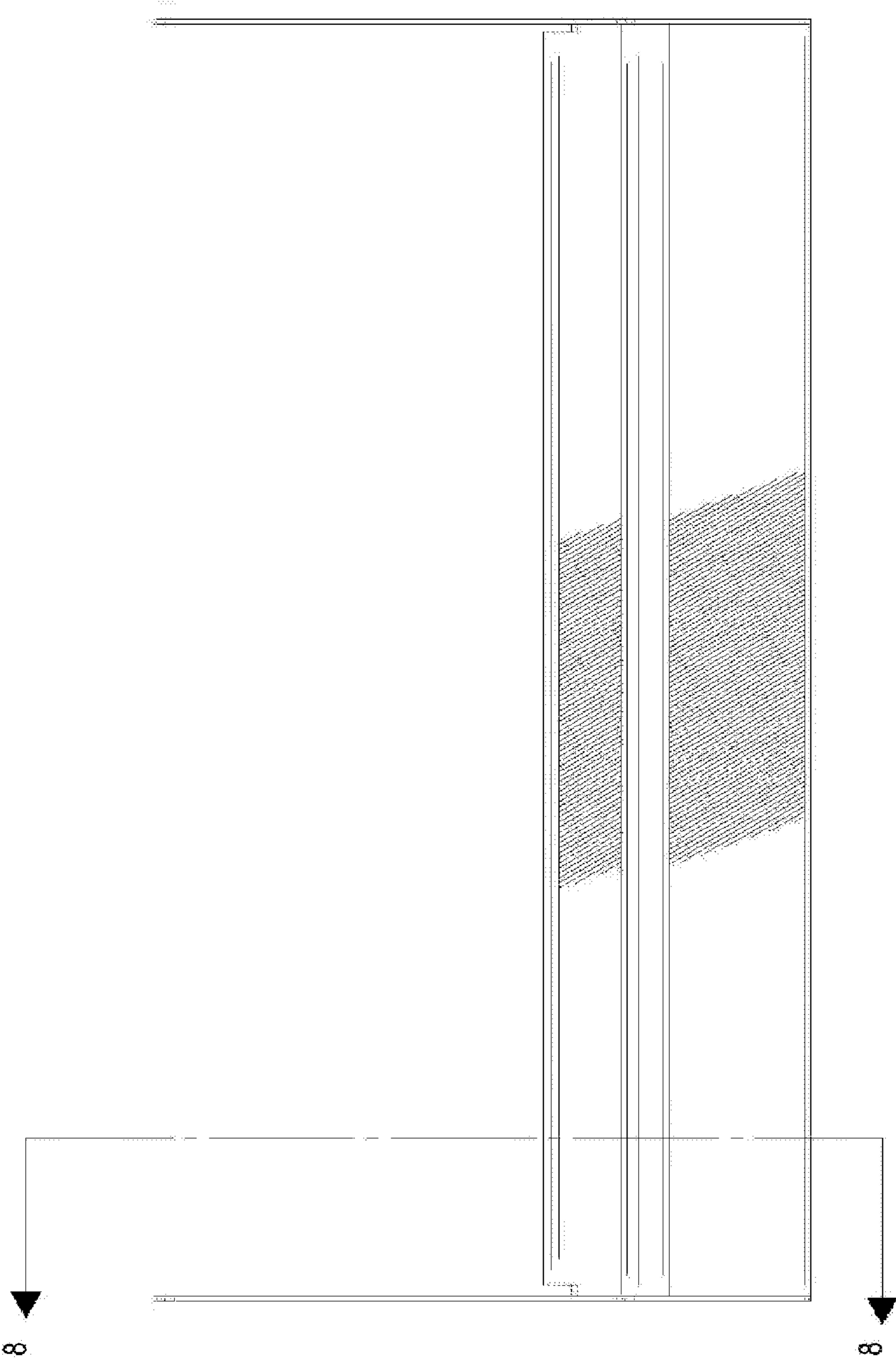

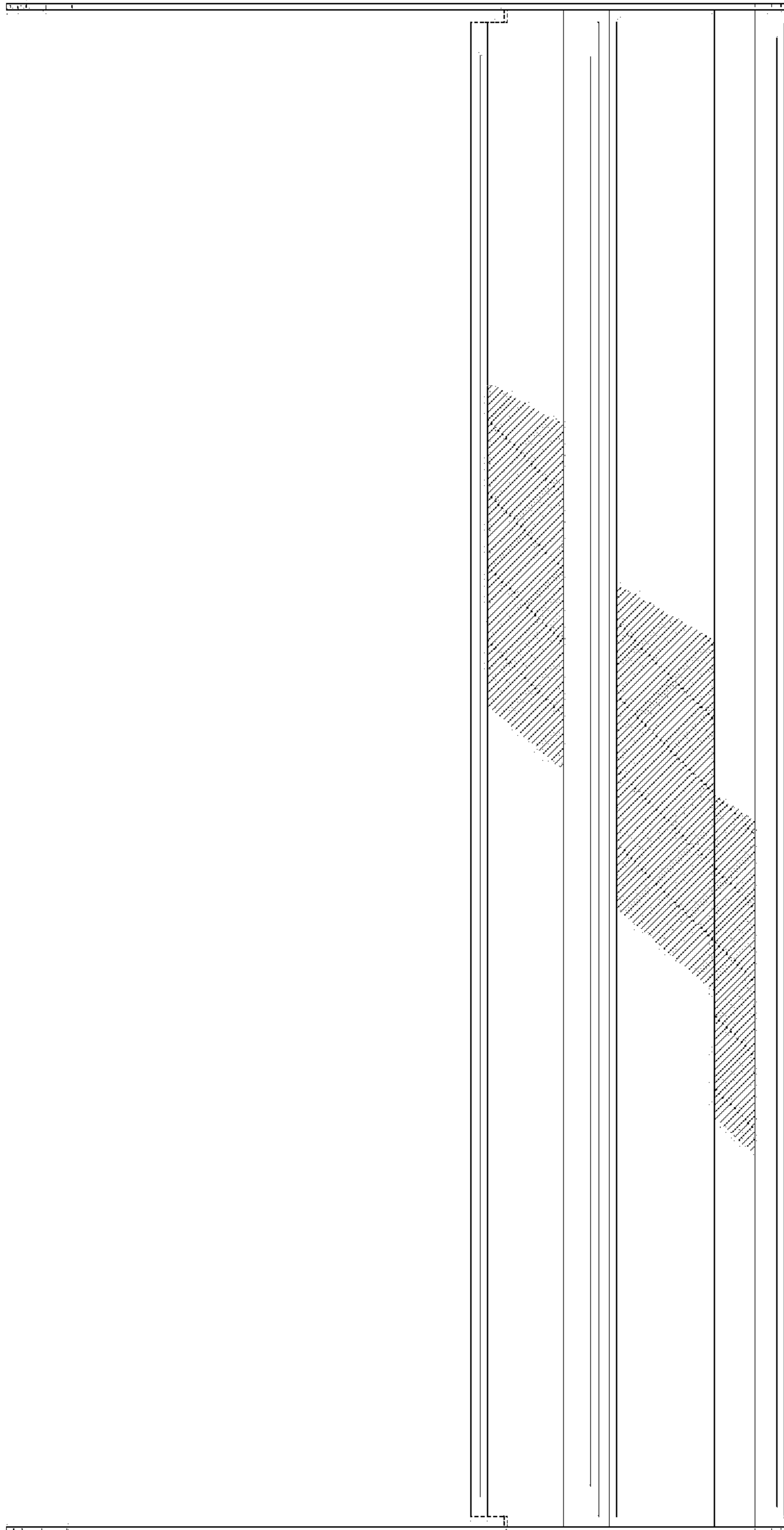

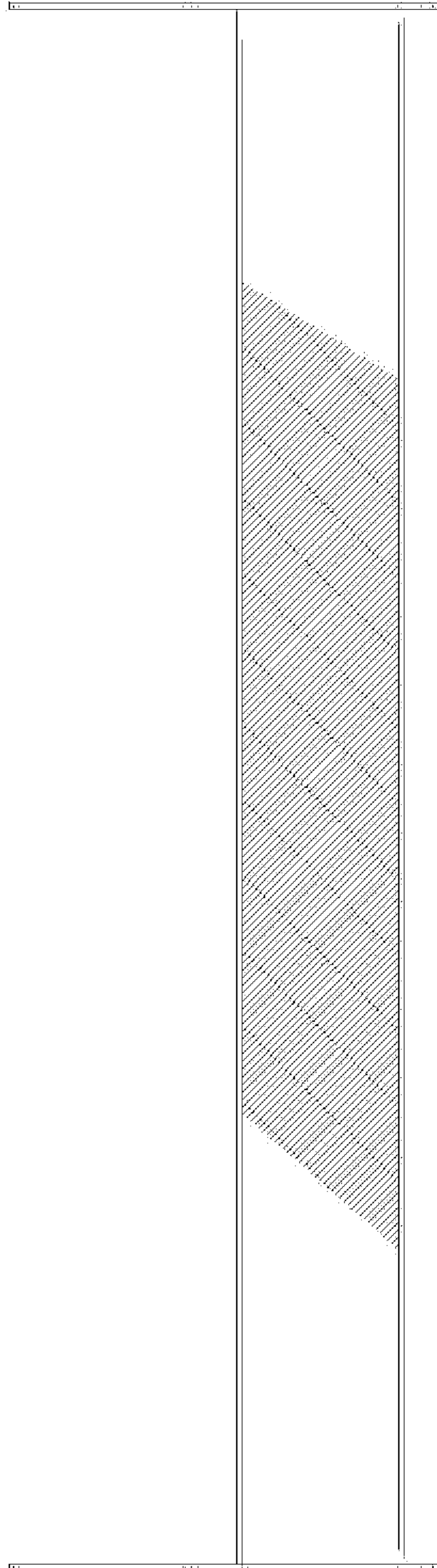

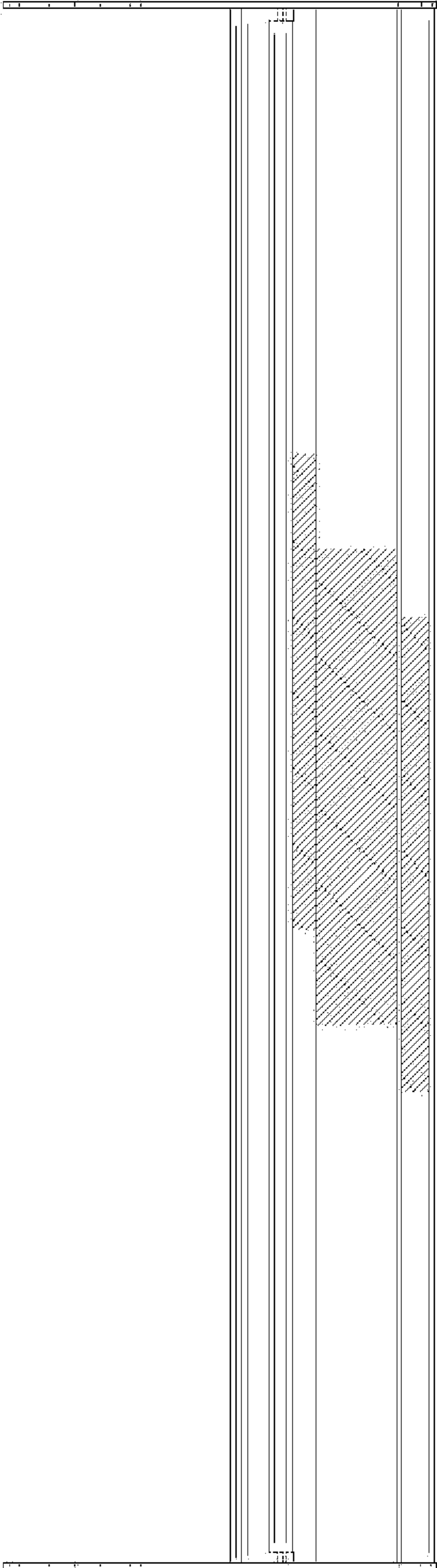

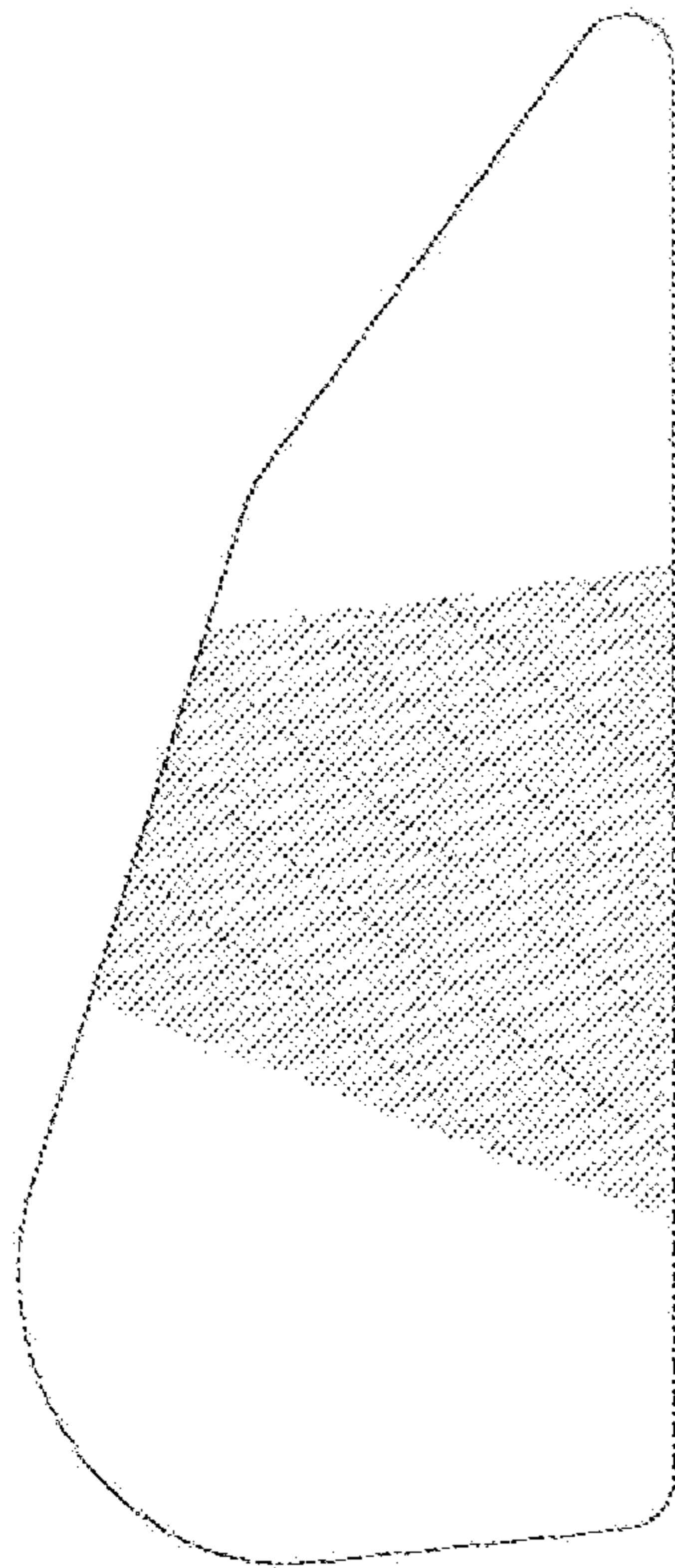

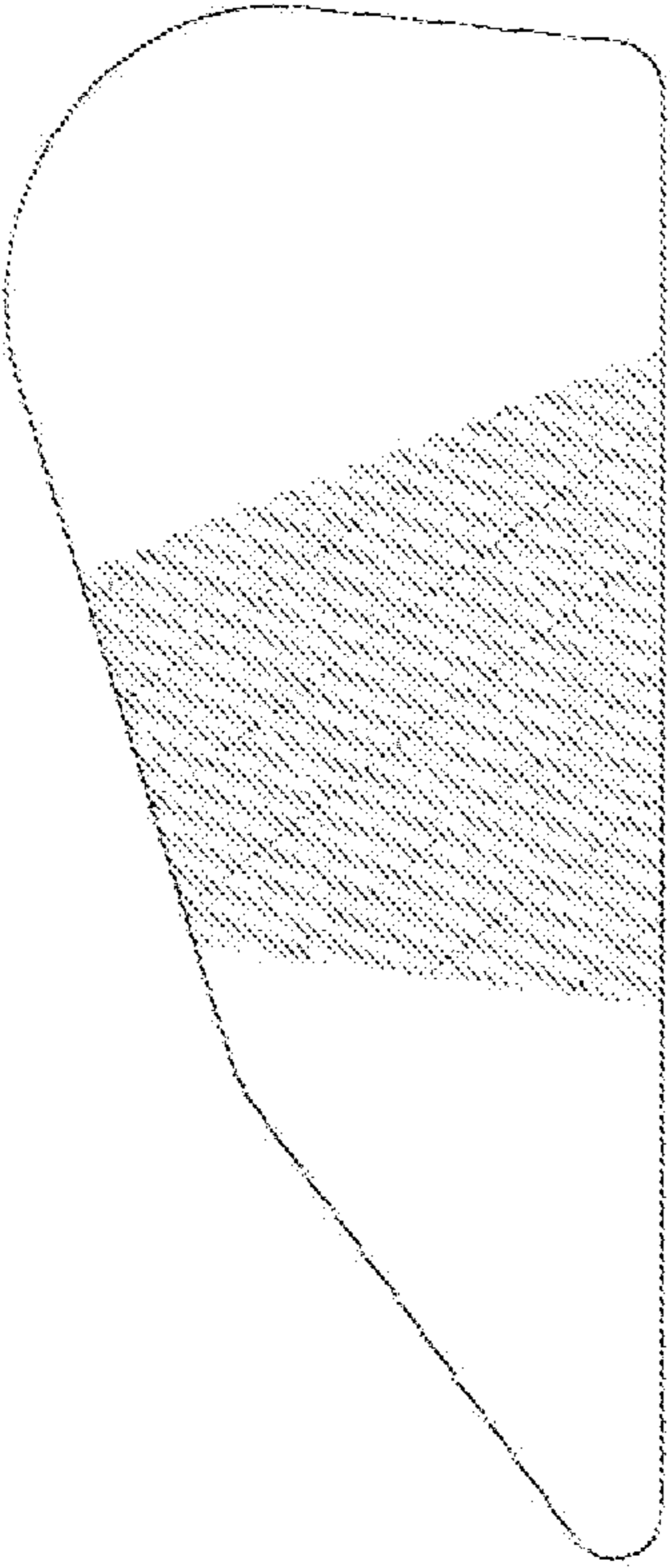
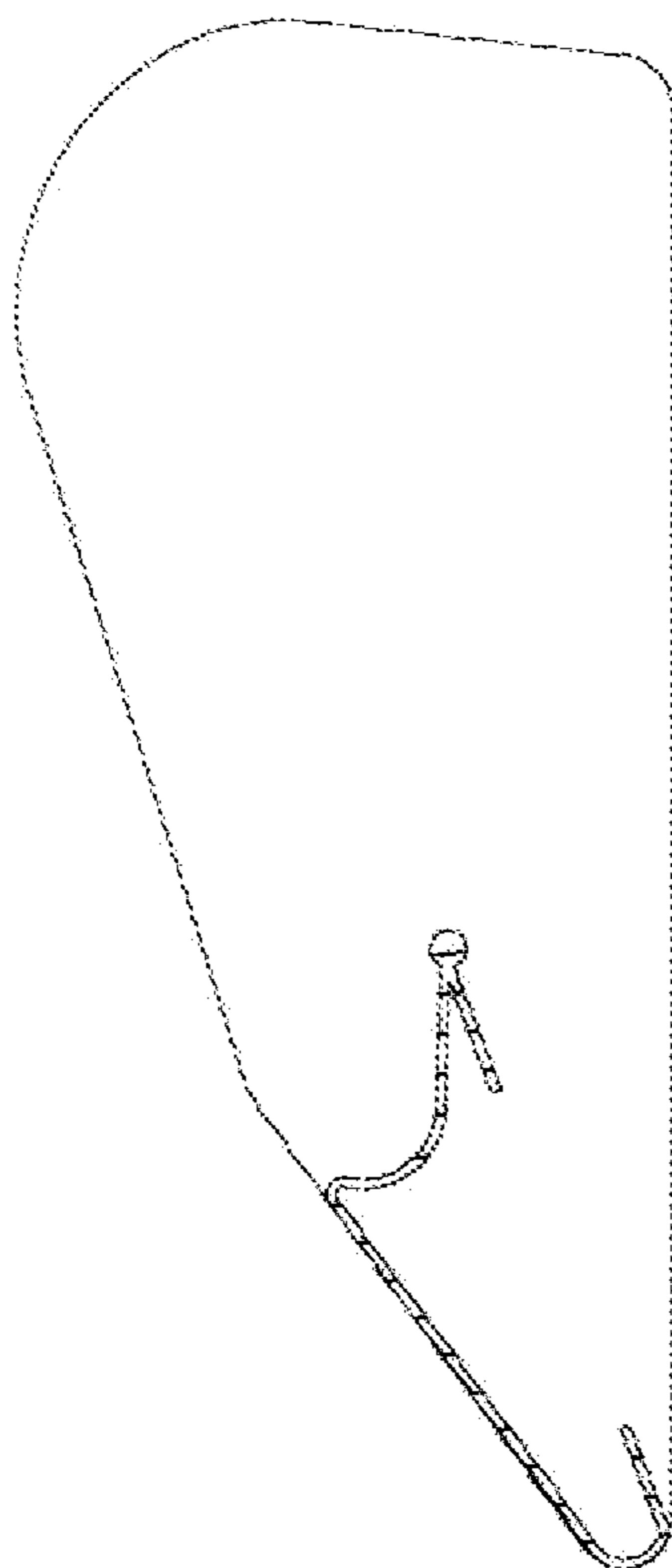
