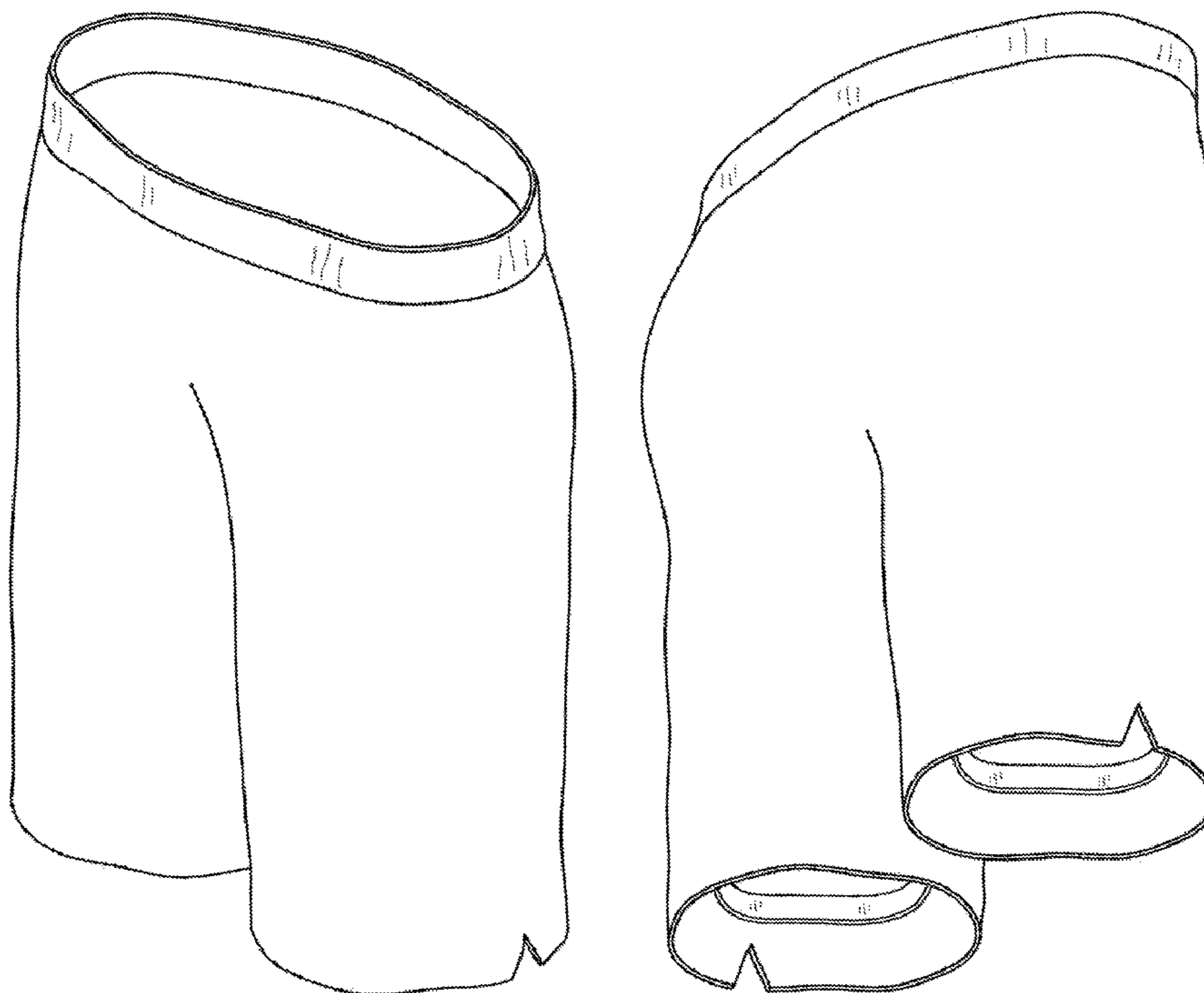
(57) **CLAIM**

The ornamental design for athletic shorts, as shown and described.

DESCRIPTION

FIG. 1 is a front, right perspective view of athletic shorts showing my new design; the shorts having a loose inner short with a nonslip band at the lower portion of the inner short; FIG. 2 is a rear left, bottom perspective view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a side elevational view thereof; FIG. 5 is a front elevational view thereof; the rear elevational view being a mirror image thereof; FIG. 6 is a cross sectional view thereof, taken at line 6, in FIG. 3; and, FIG. 7 is a cross-sectional view thereof, taken at line 7, in FIG. 3.

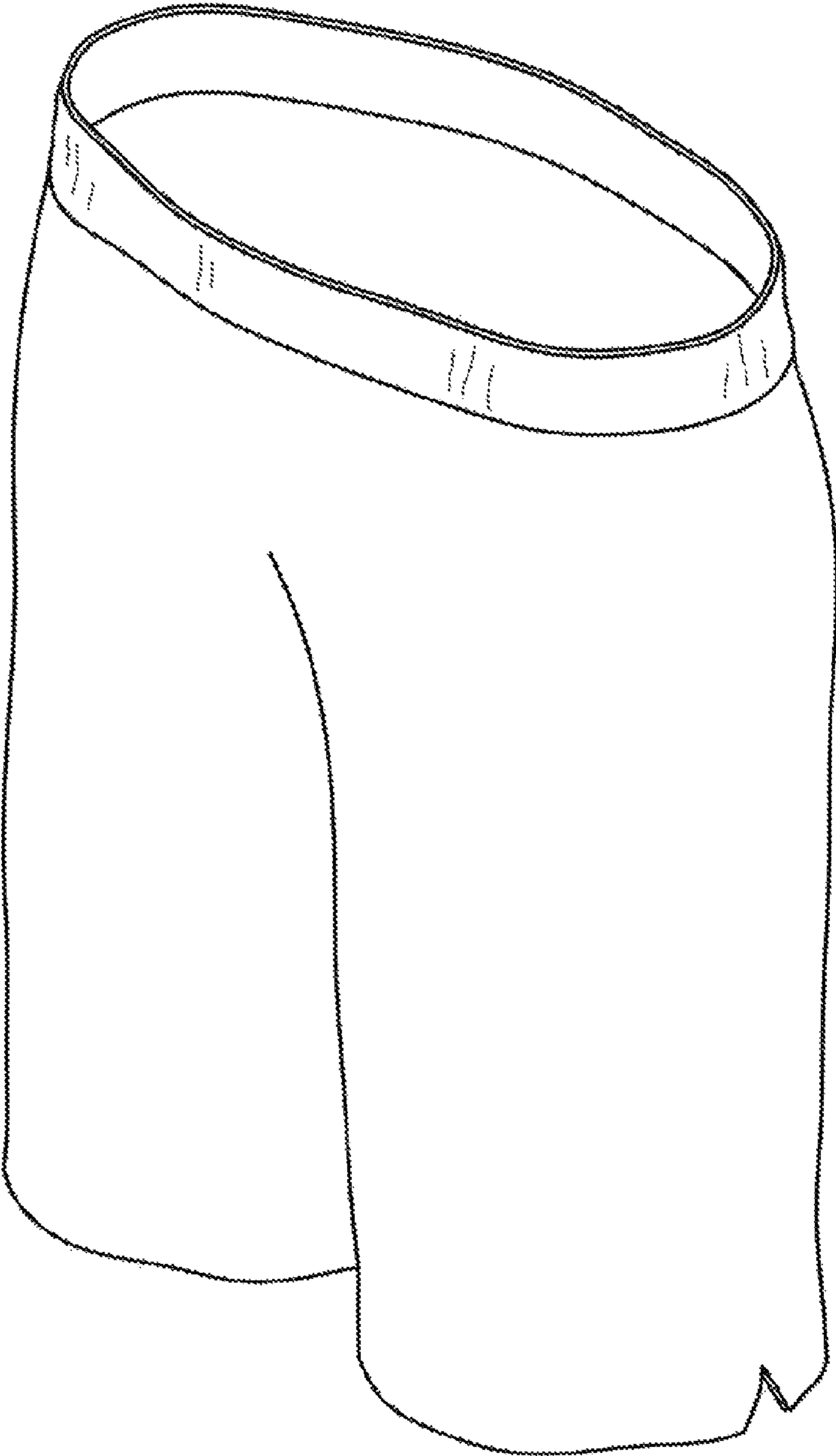

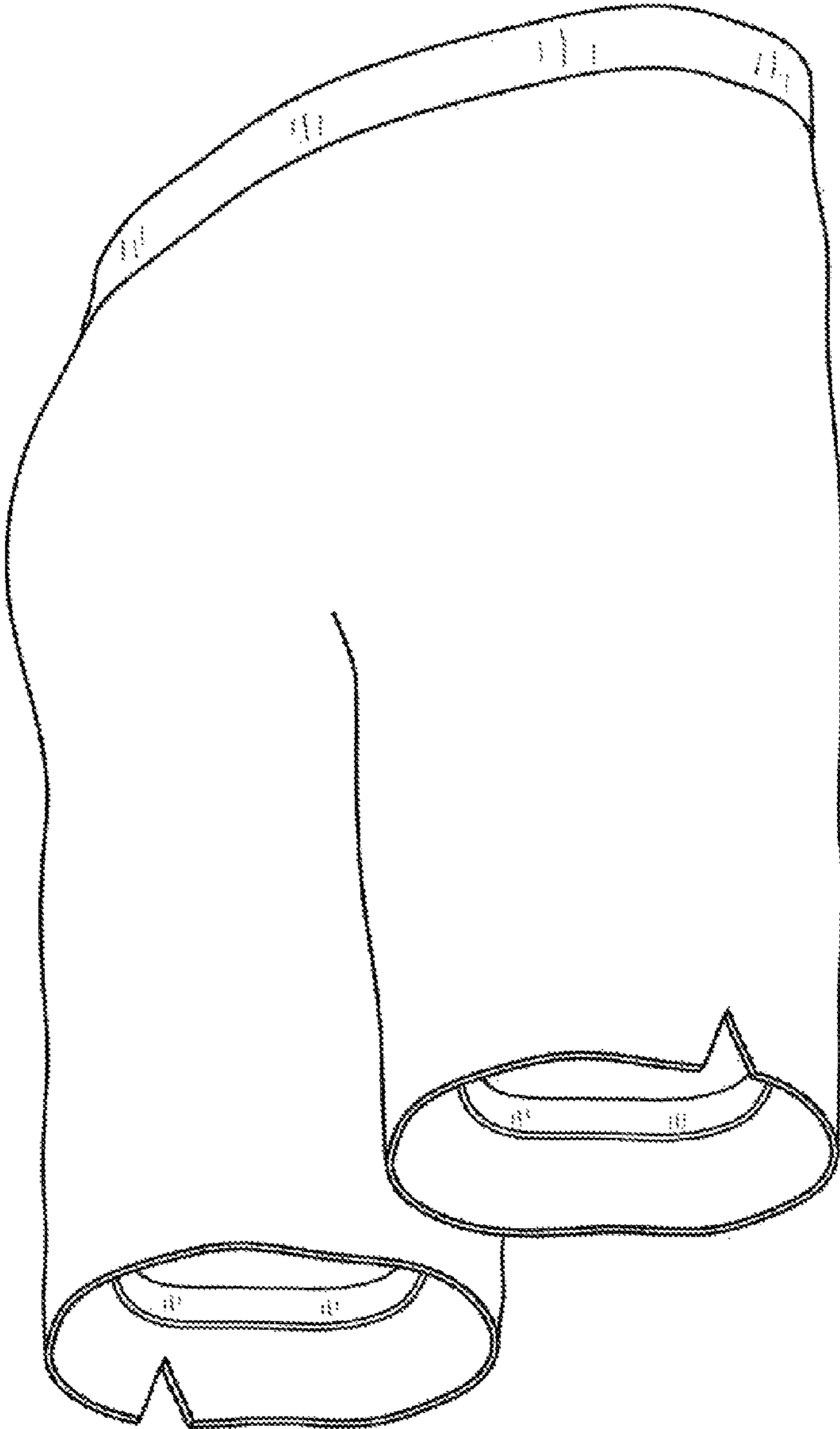

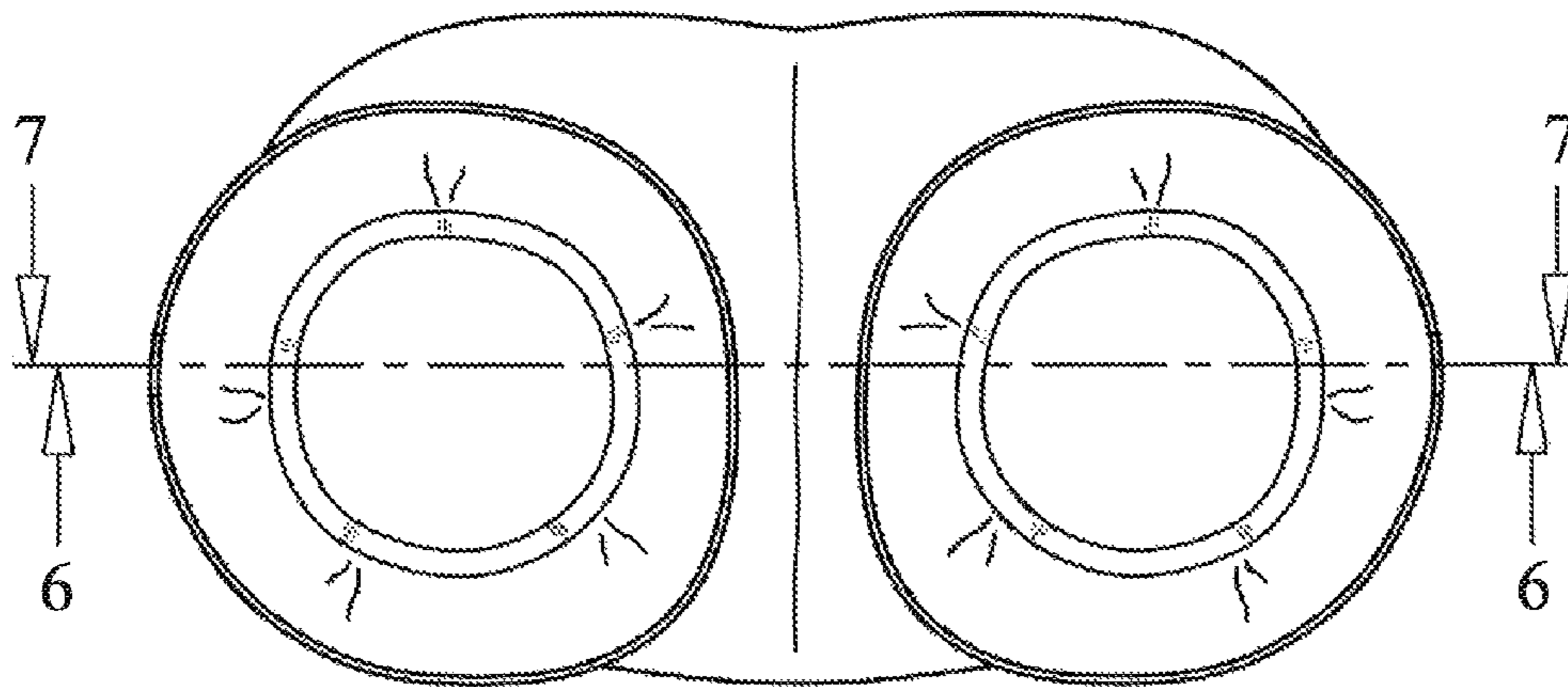

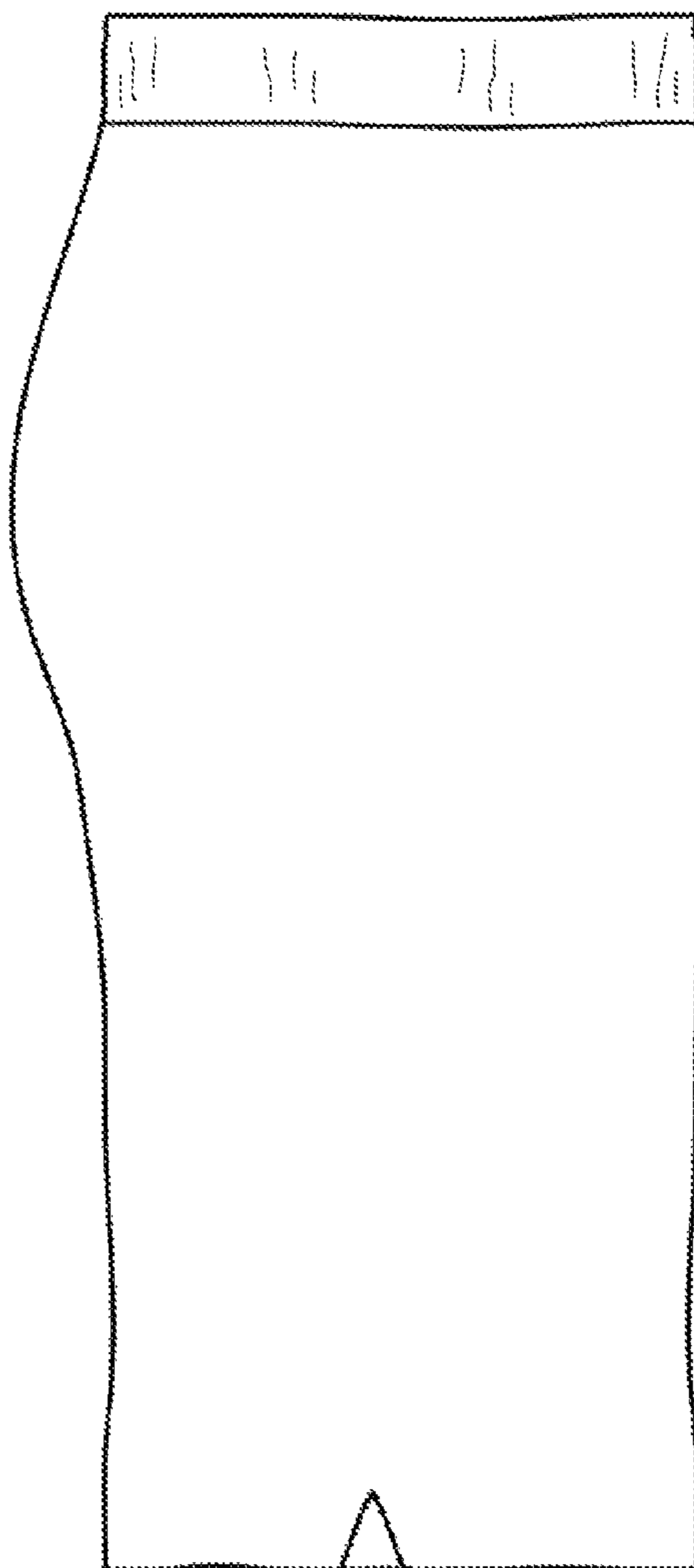

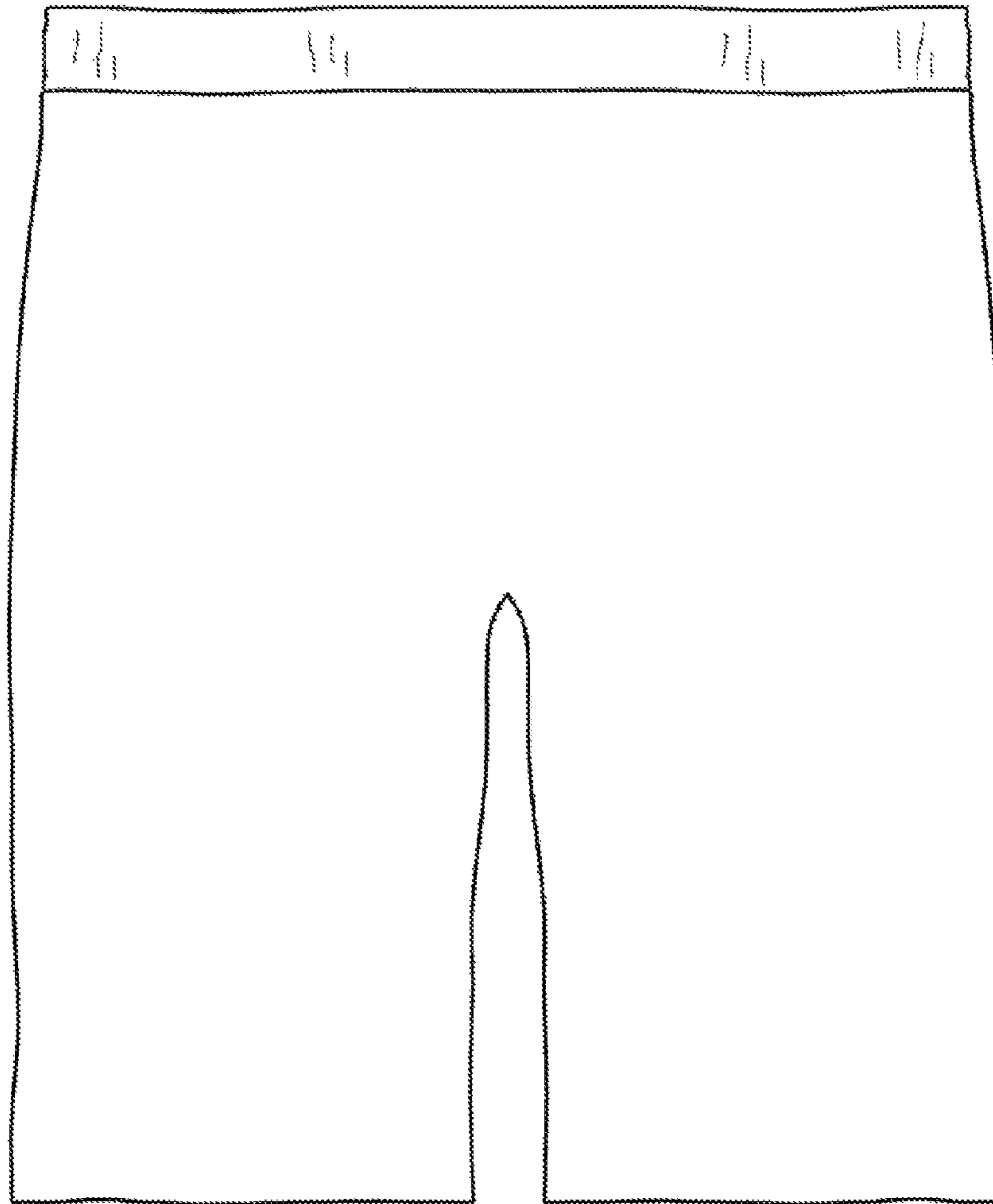

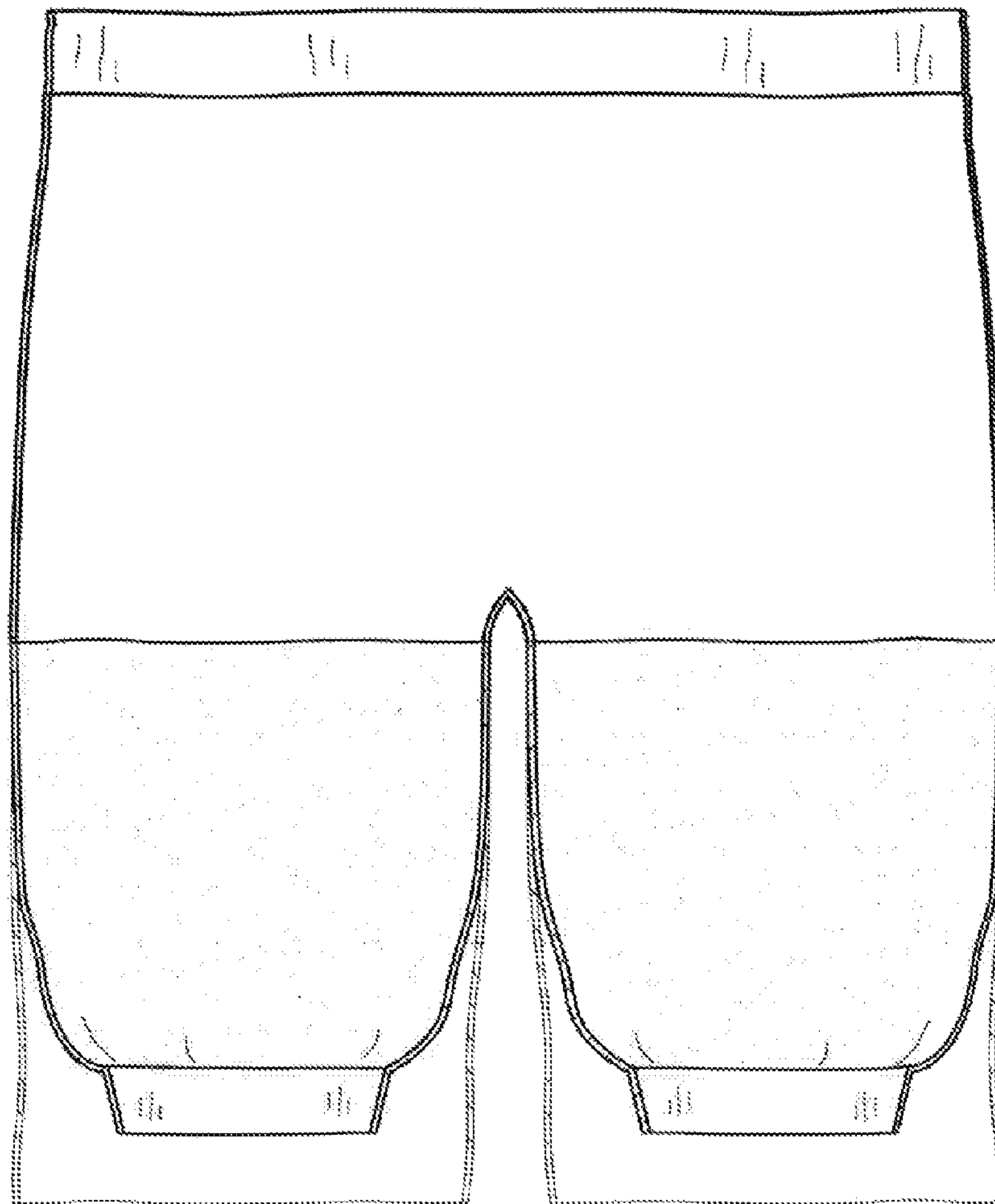

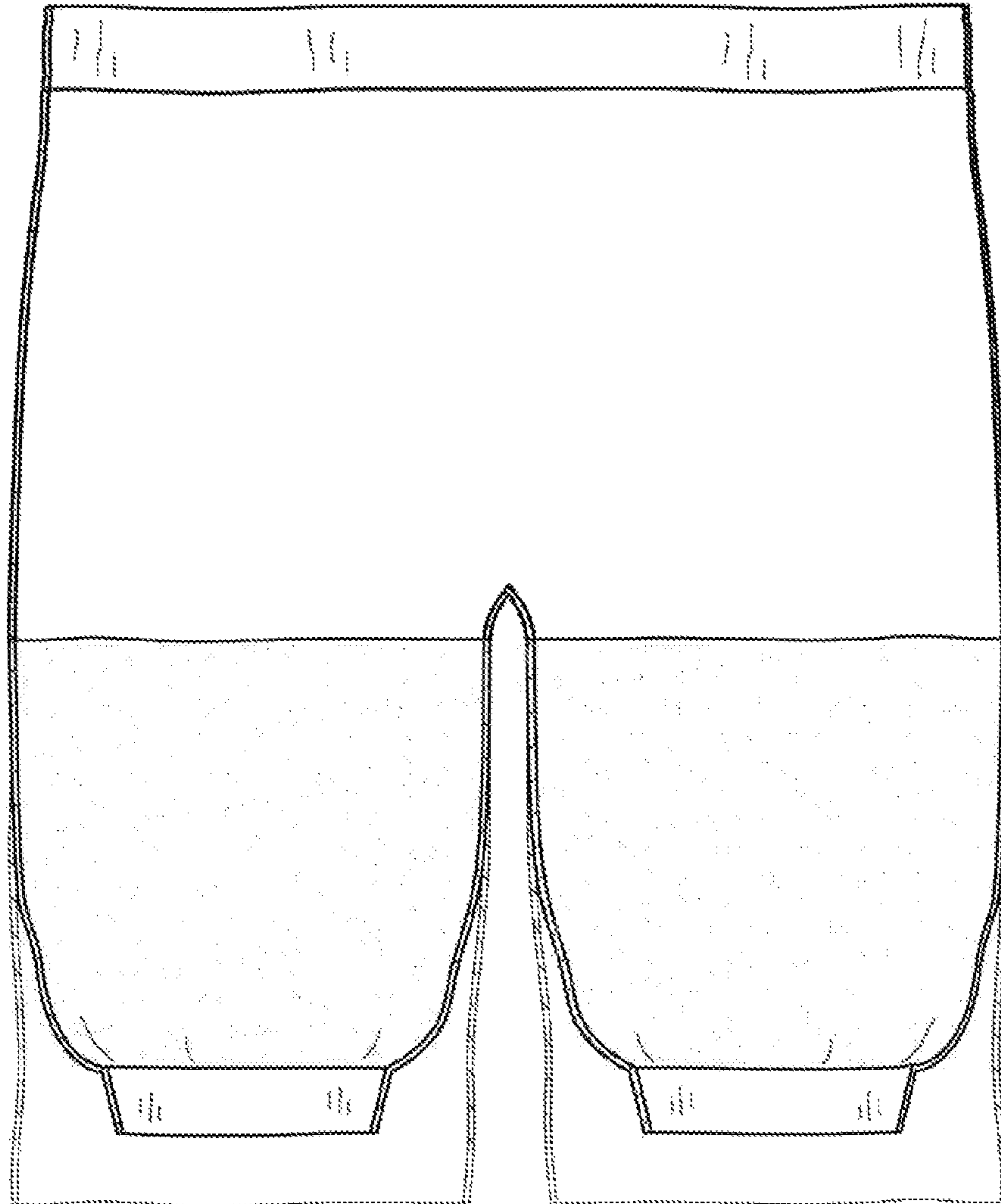
