The ornamental design for shorts, as shown and described.

**DESCRIPTION**

FIG. 1 is a left rear perspective view of shorts showing my new design;

FIG. 2 is a right rear perspective view thereof;

FIG. 3 is a rear view thereof;

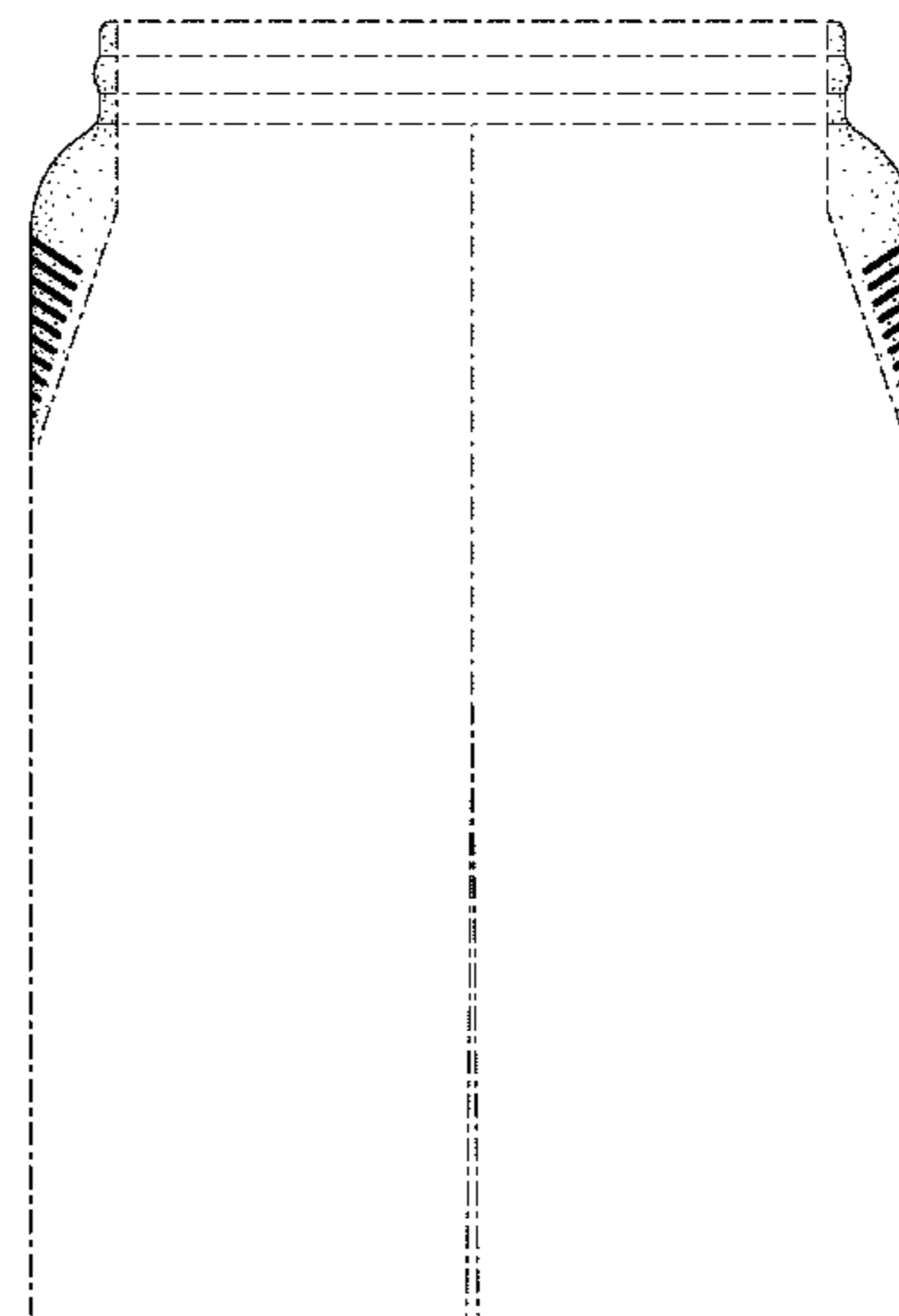
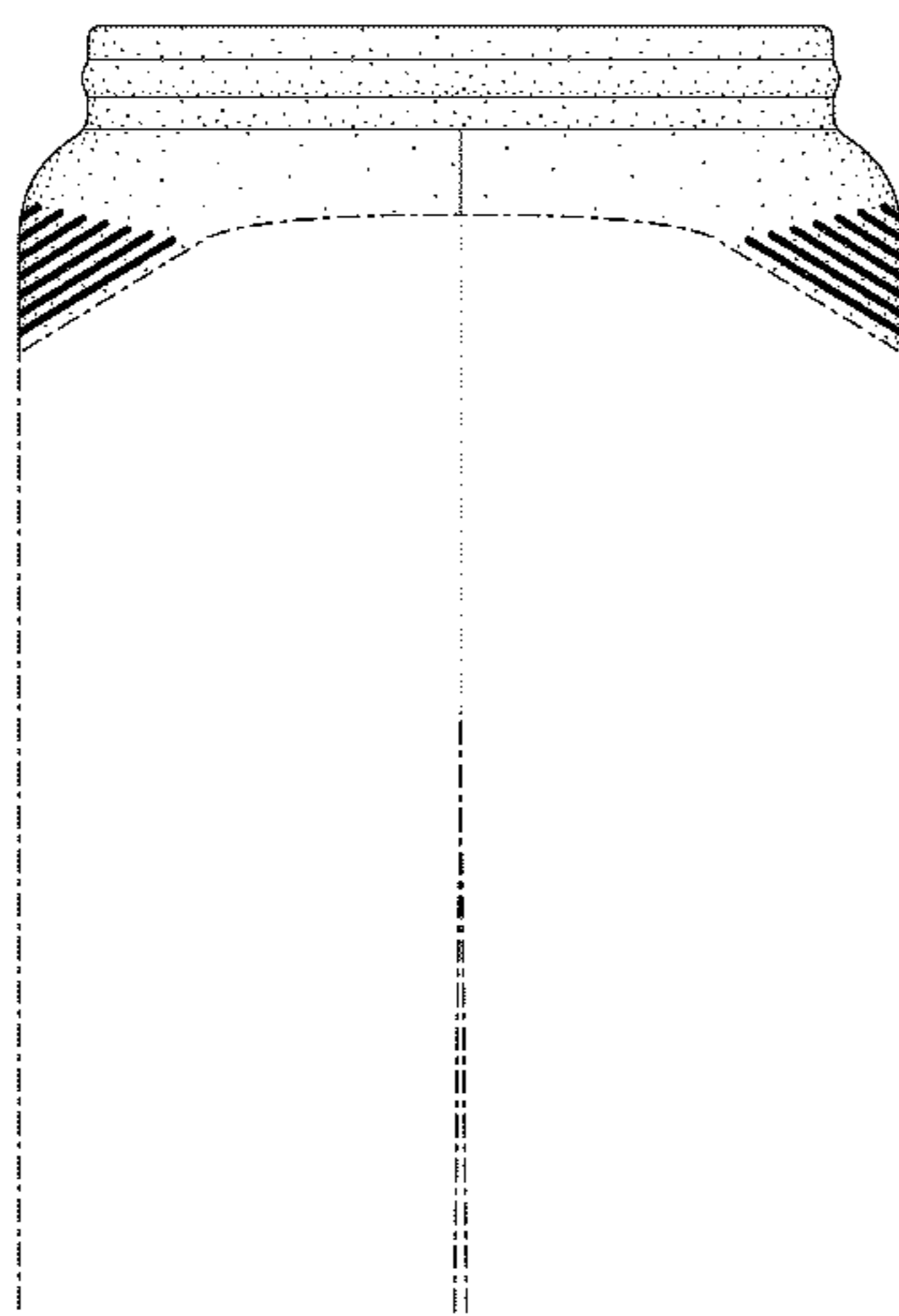
FIG. 4 is a front view thereof;

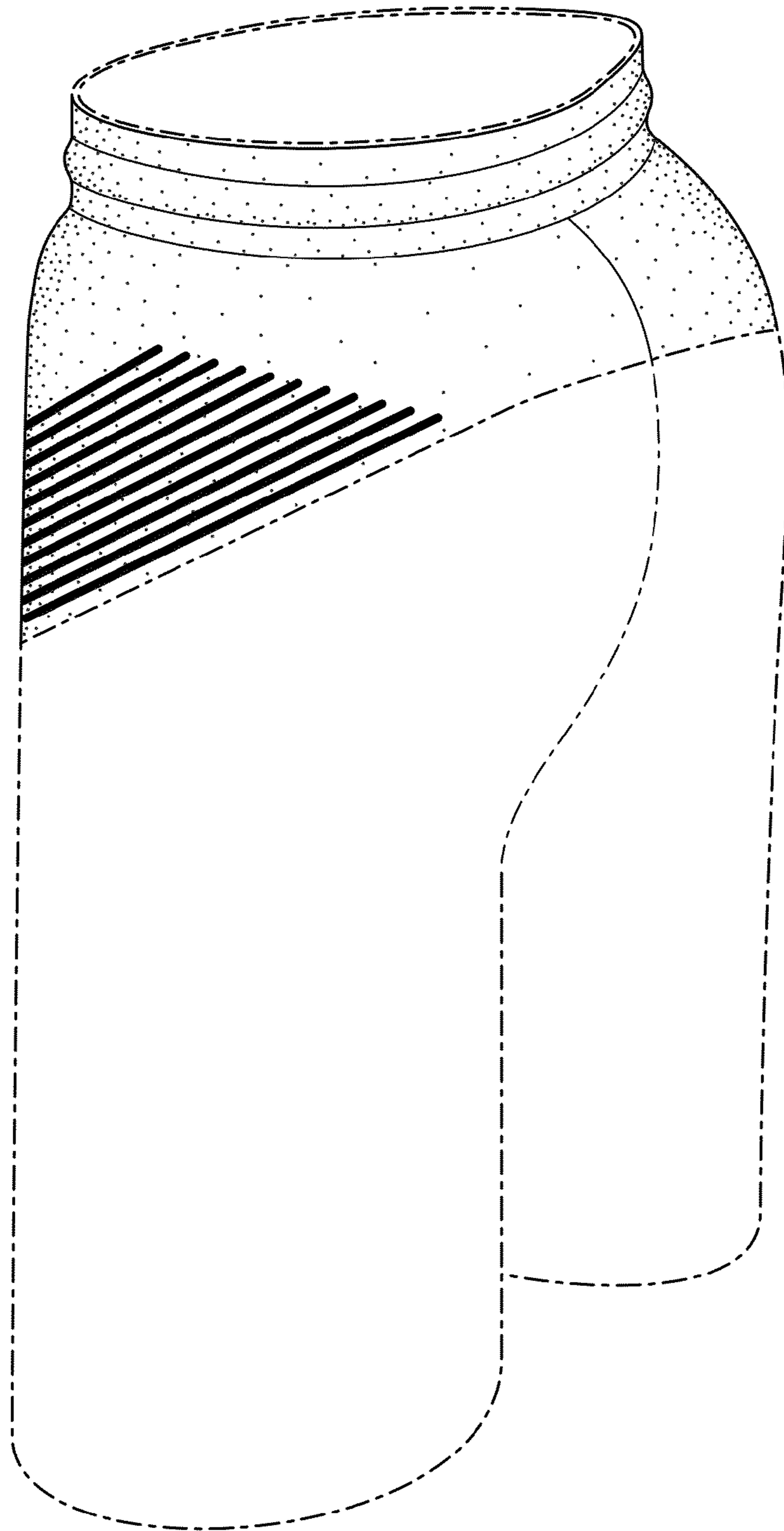

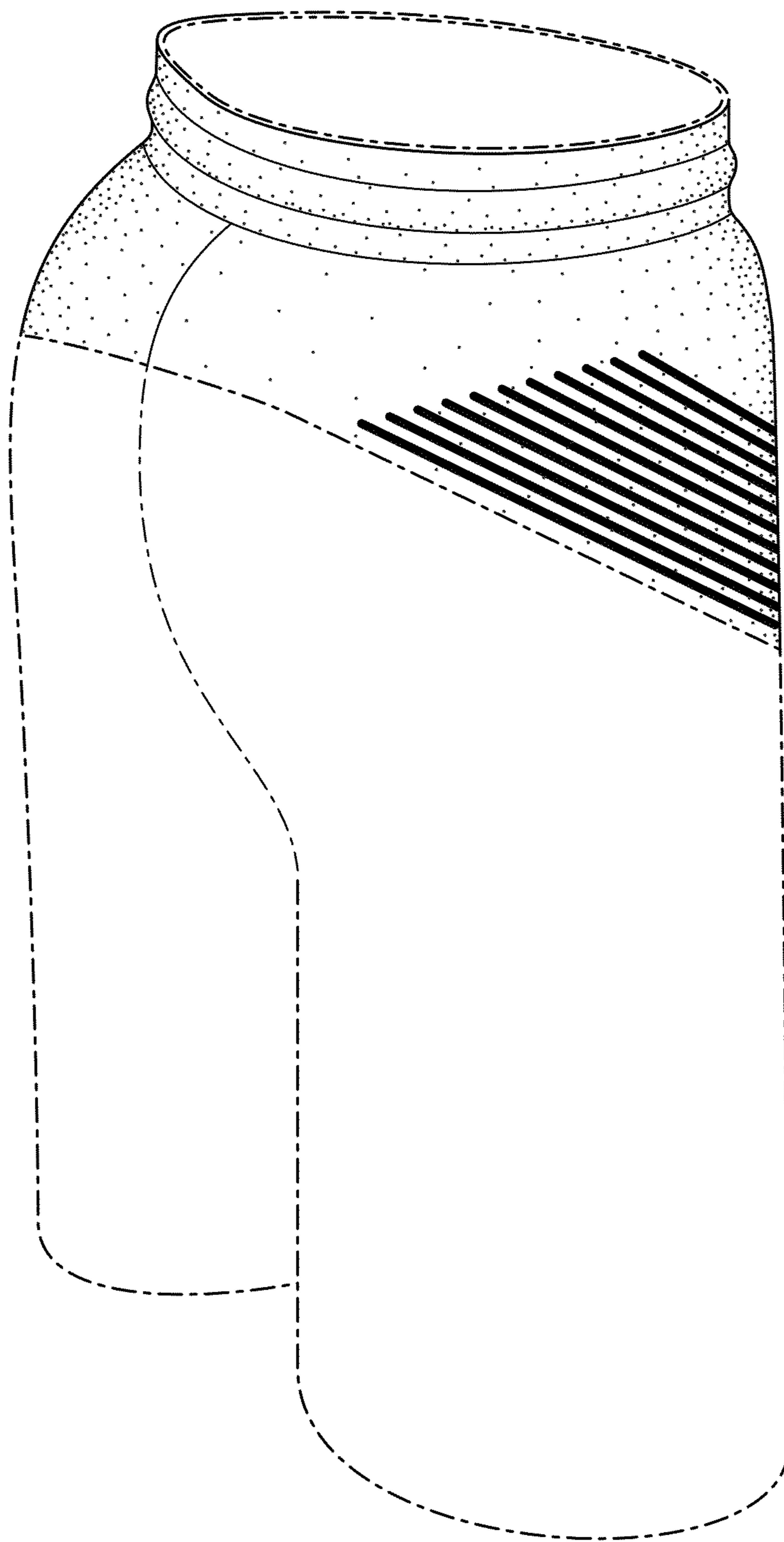

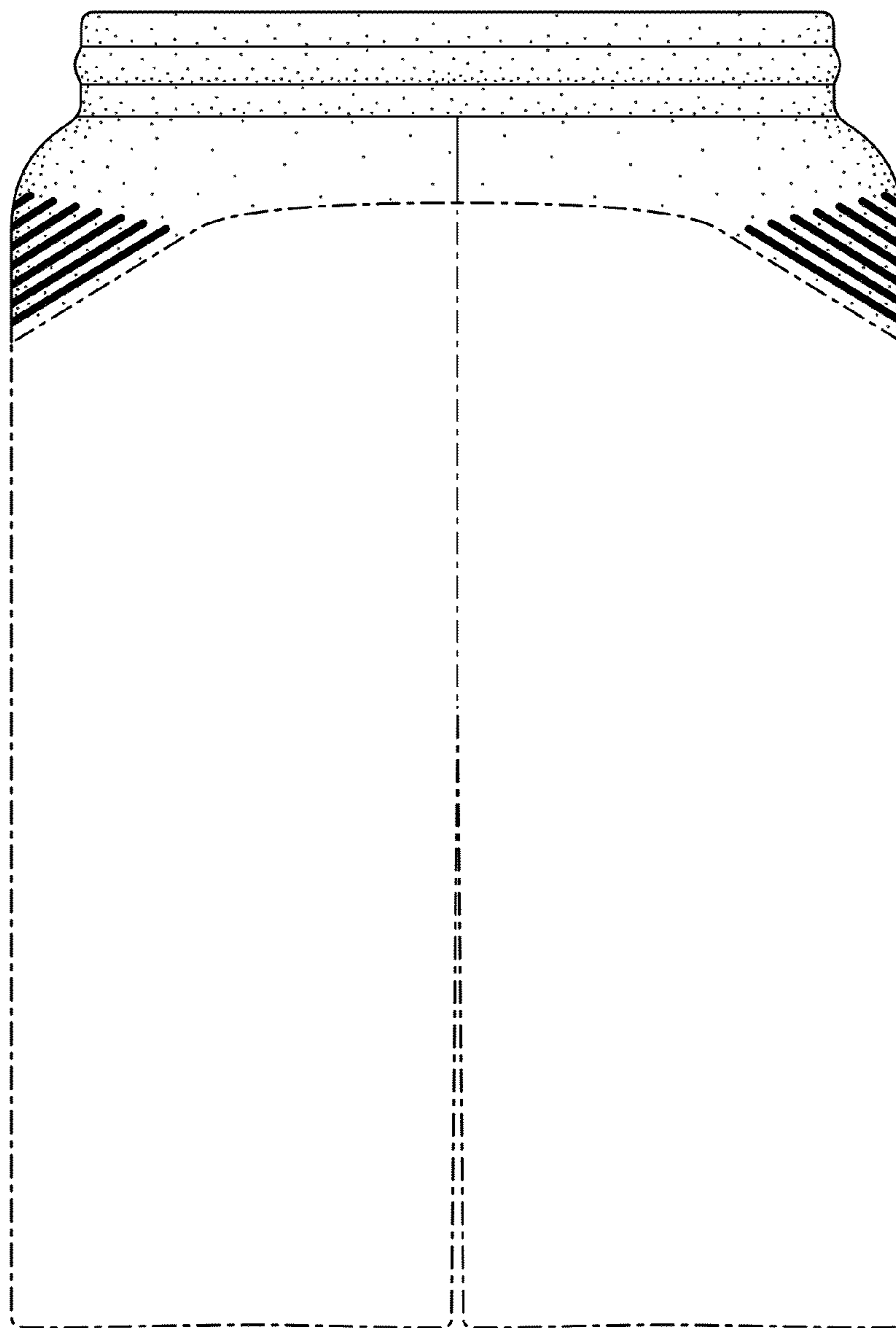

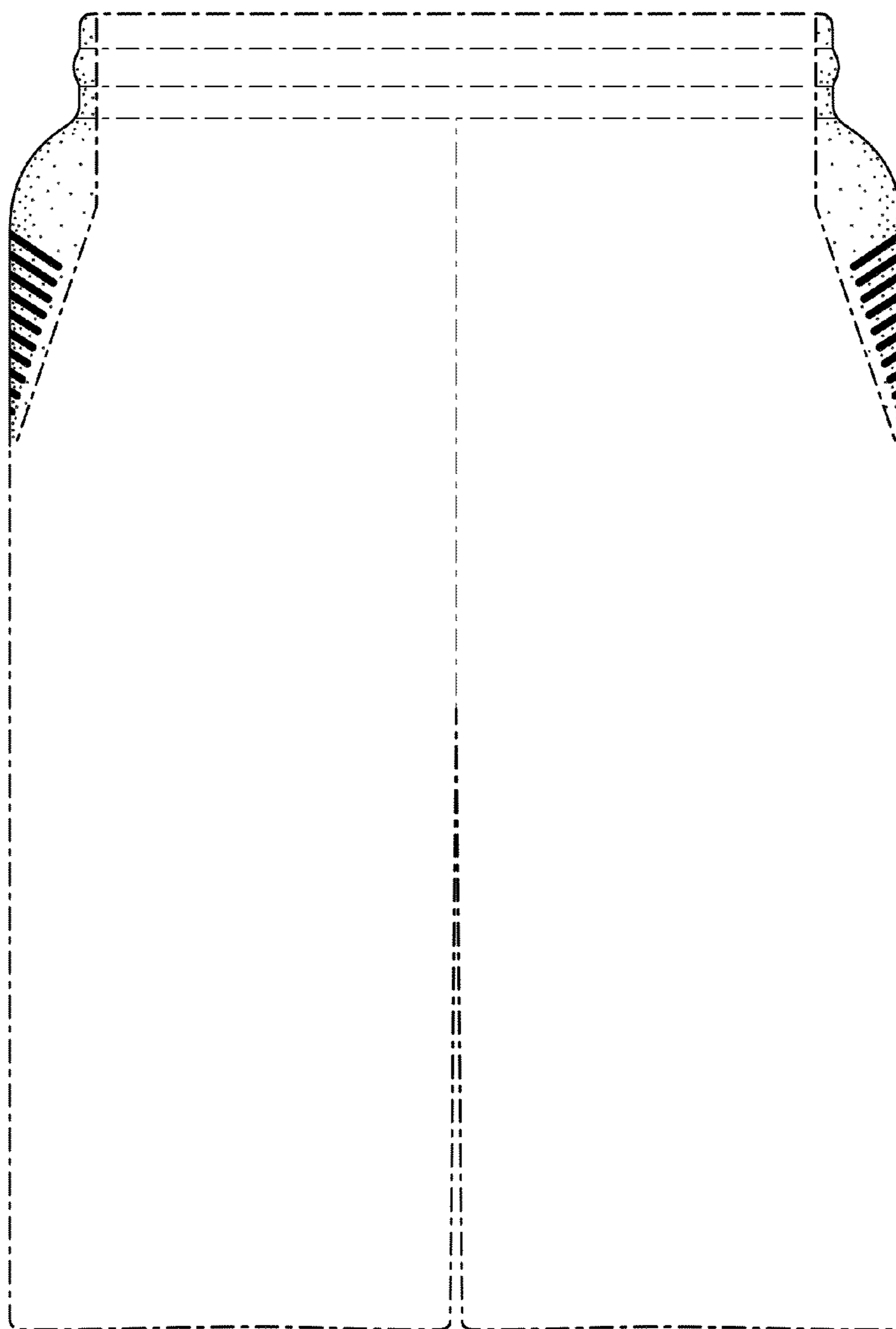

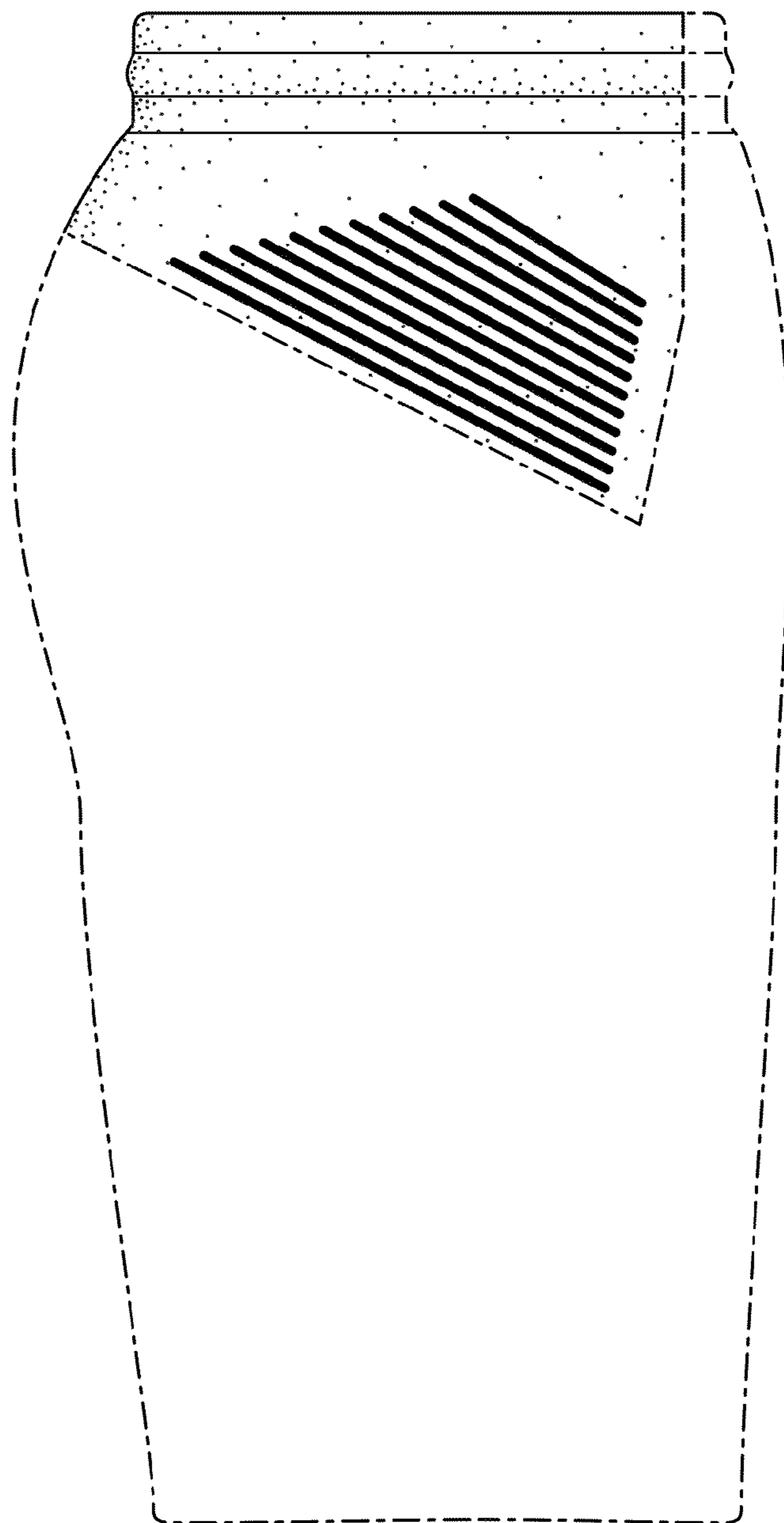

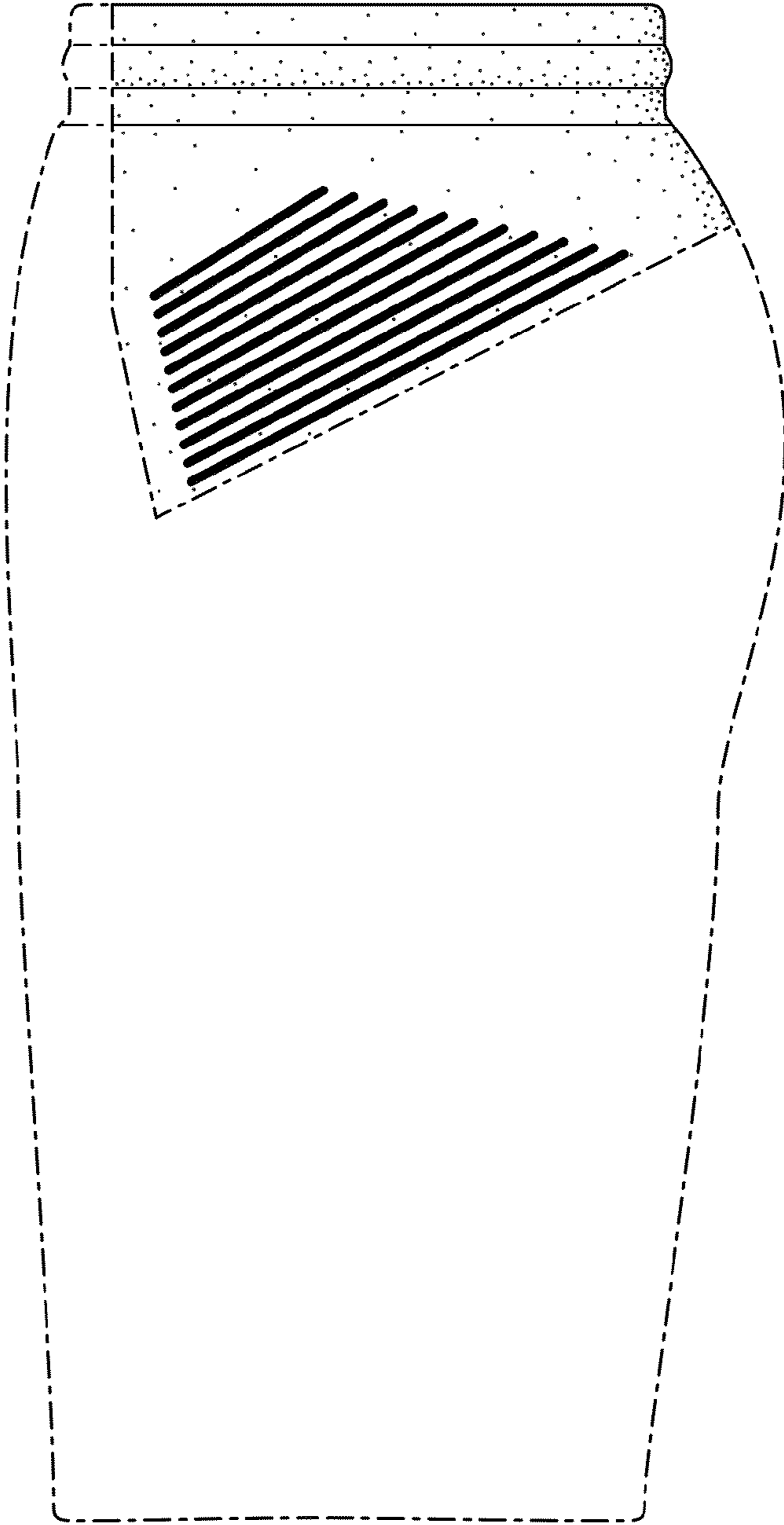
