(57) **CLAIM**

The ornamental design for a sneaker sock with rubber sole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sneaker sock with rubber sole showing my new design;

FIG. 2 is a side view thereof;

FIG. 3 is opposite side view thereof;

FIG. 4 is a back view thereof;

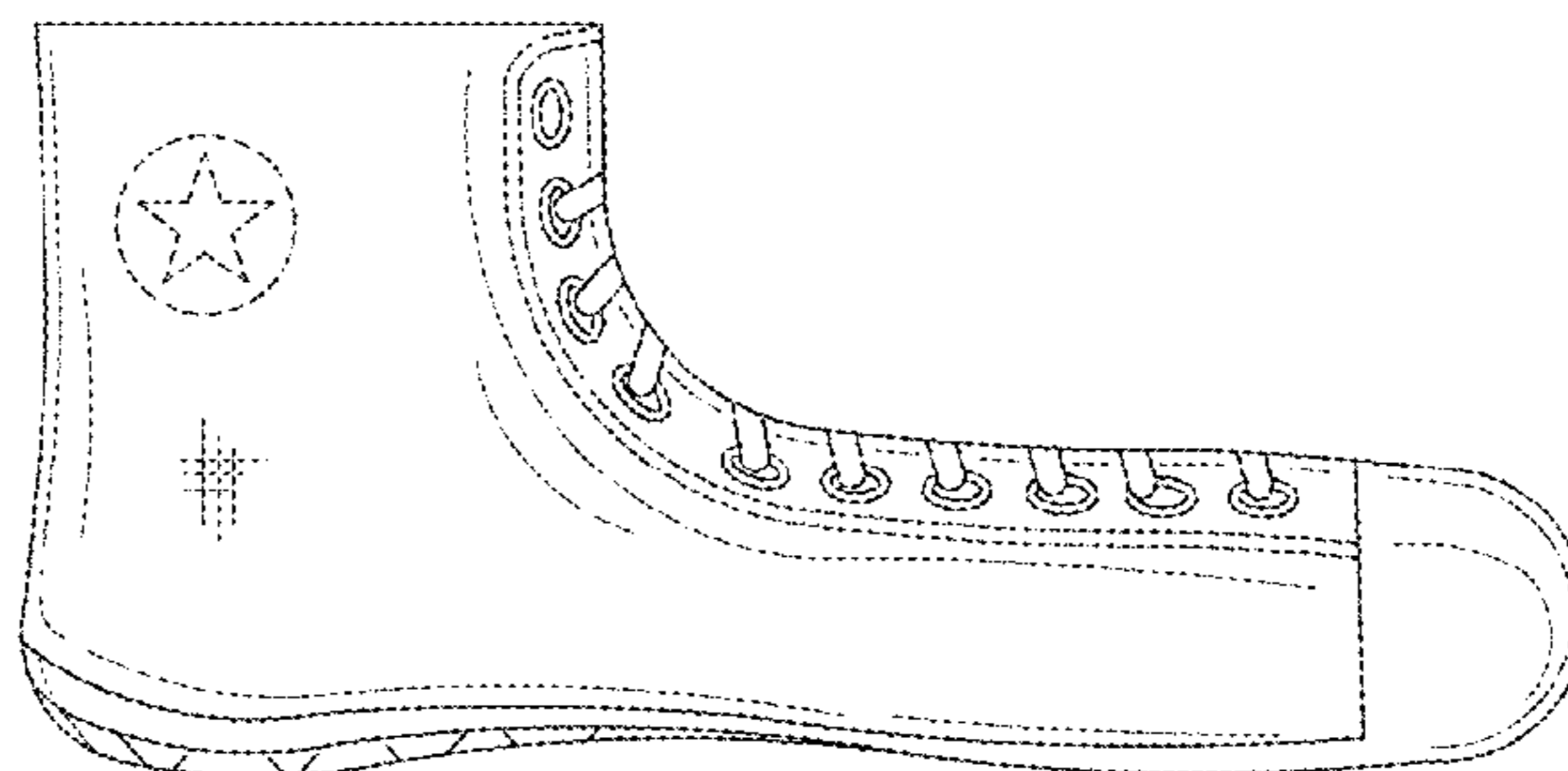
FIG. 5 is a front view thereof;

FIG. 6 is a top view thereof; and,

FIG. 7 is a bottom view thereof.

The short, closely spaced dashed lines that surround the eyelets and laces represent stitching and form part of the claim. The broken lines showing a five-pointed star centered within a circle on FIGS. 1, 2, 4 and 5 represent portions of the sneaker sock with rubber sole and form no part of the claimed design.

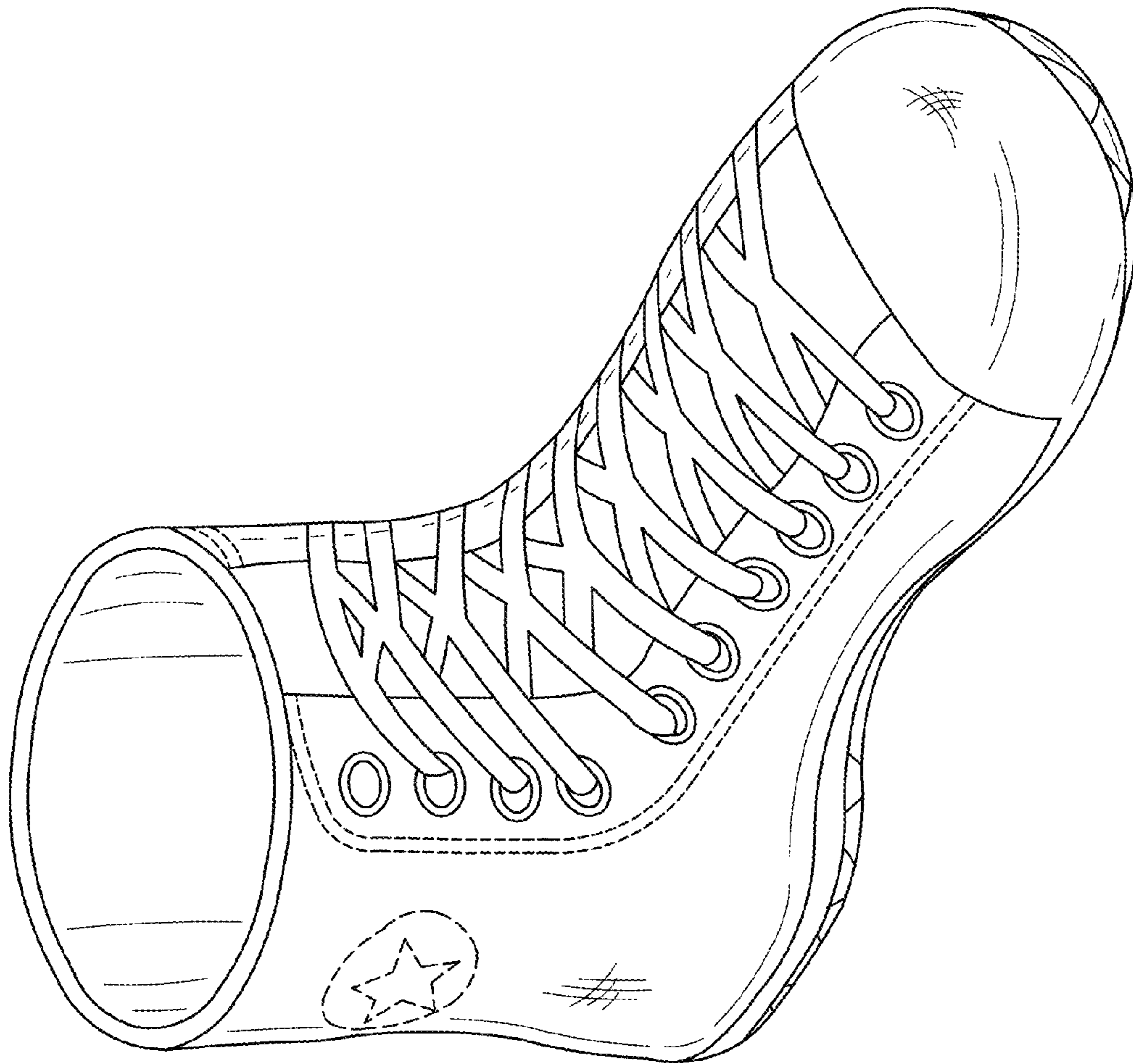

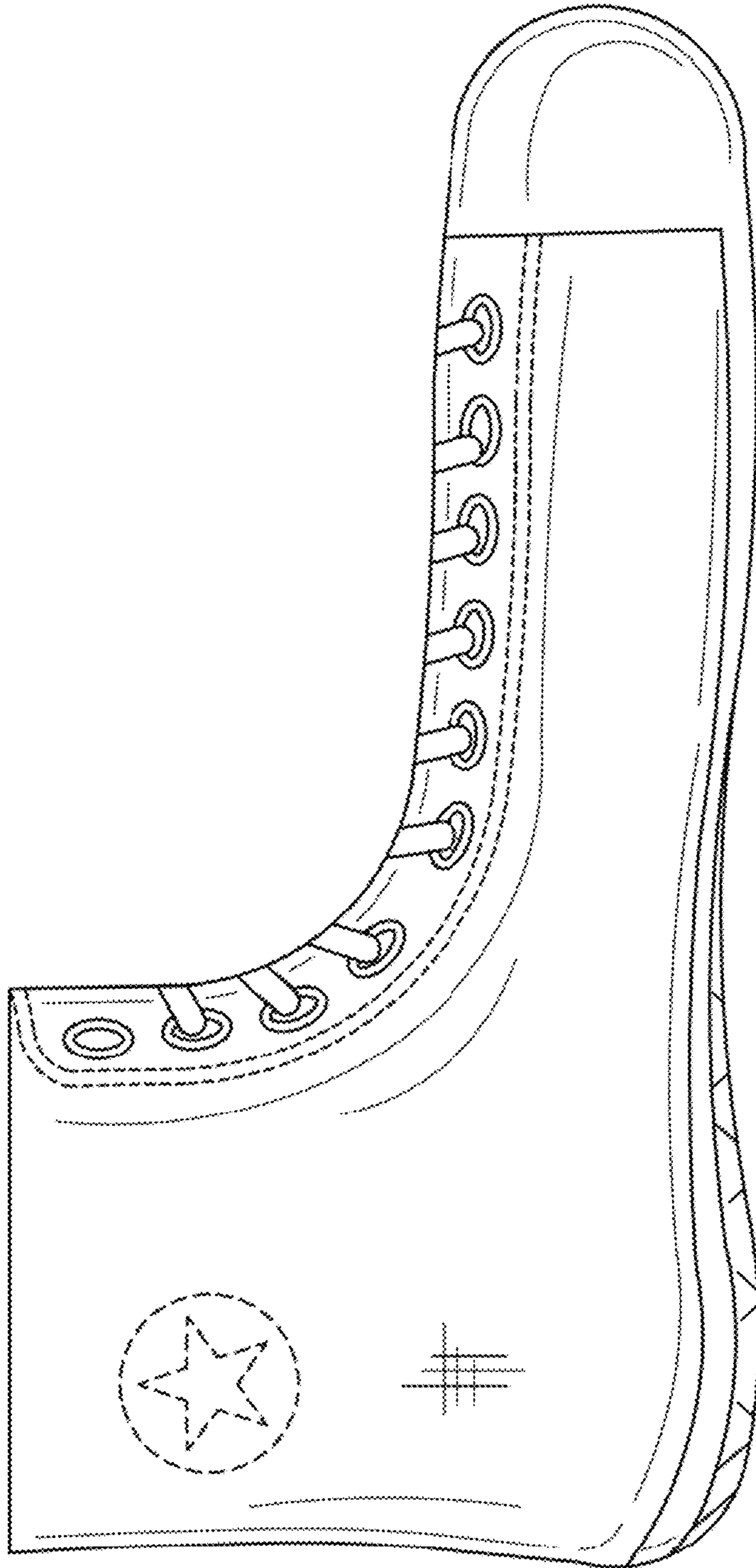

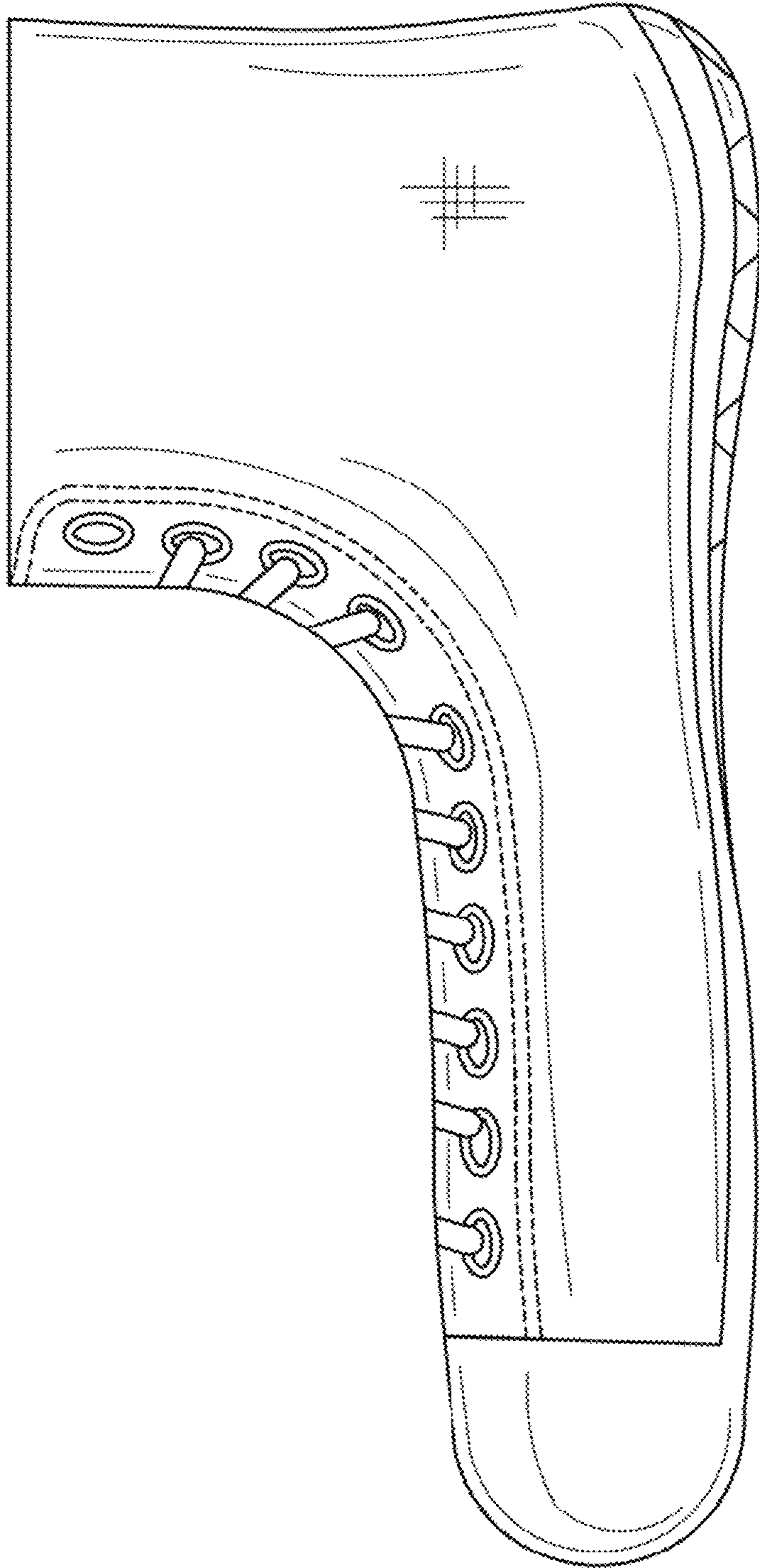

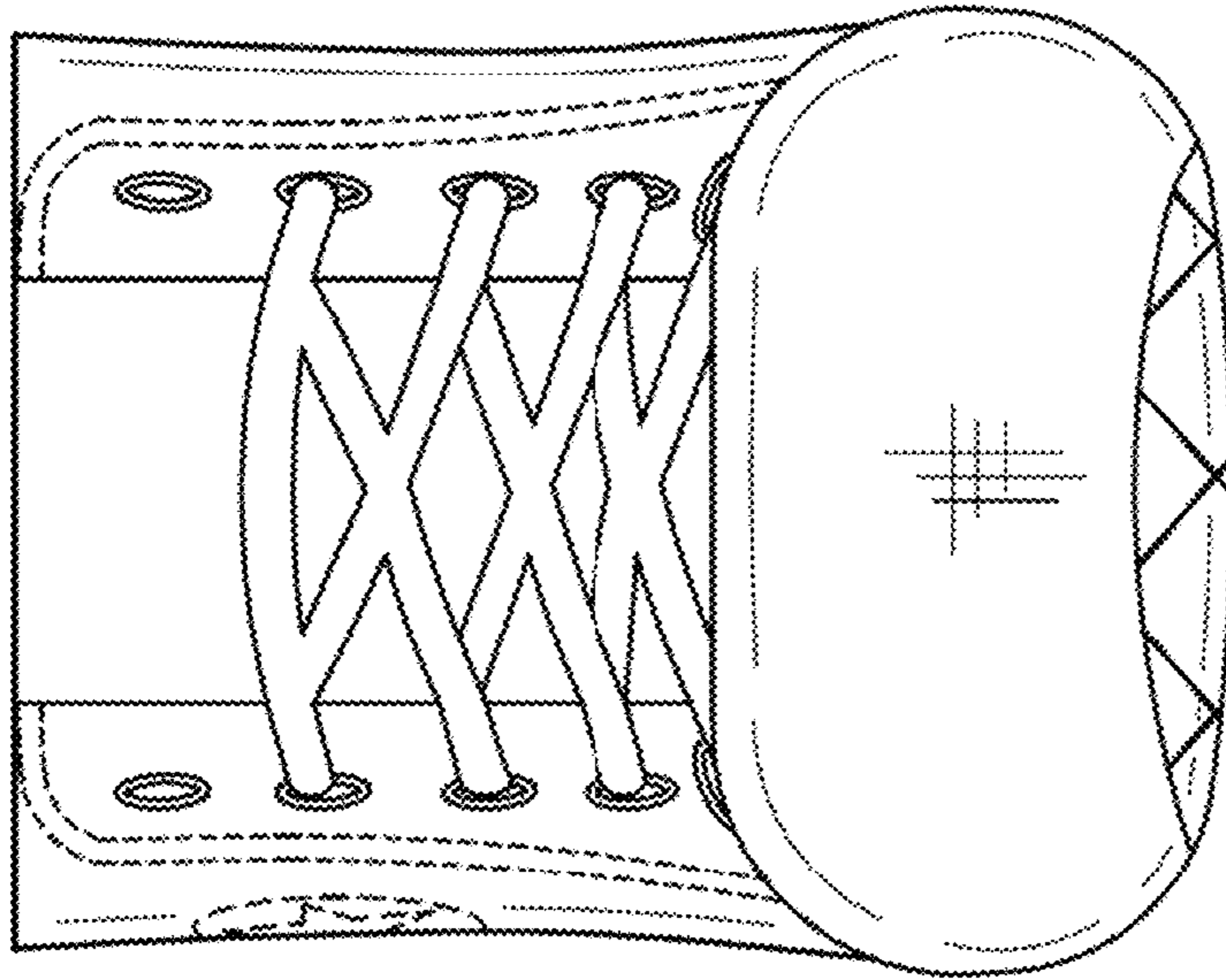

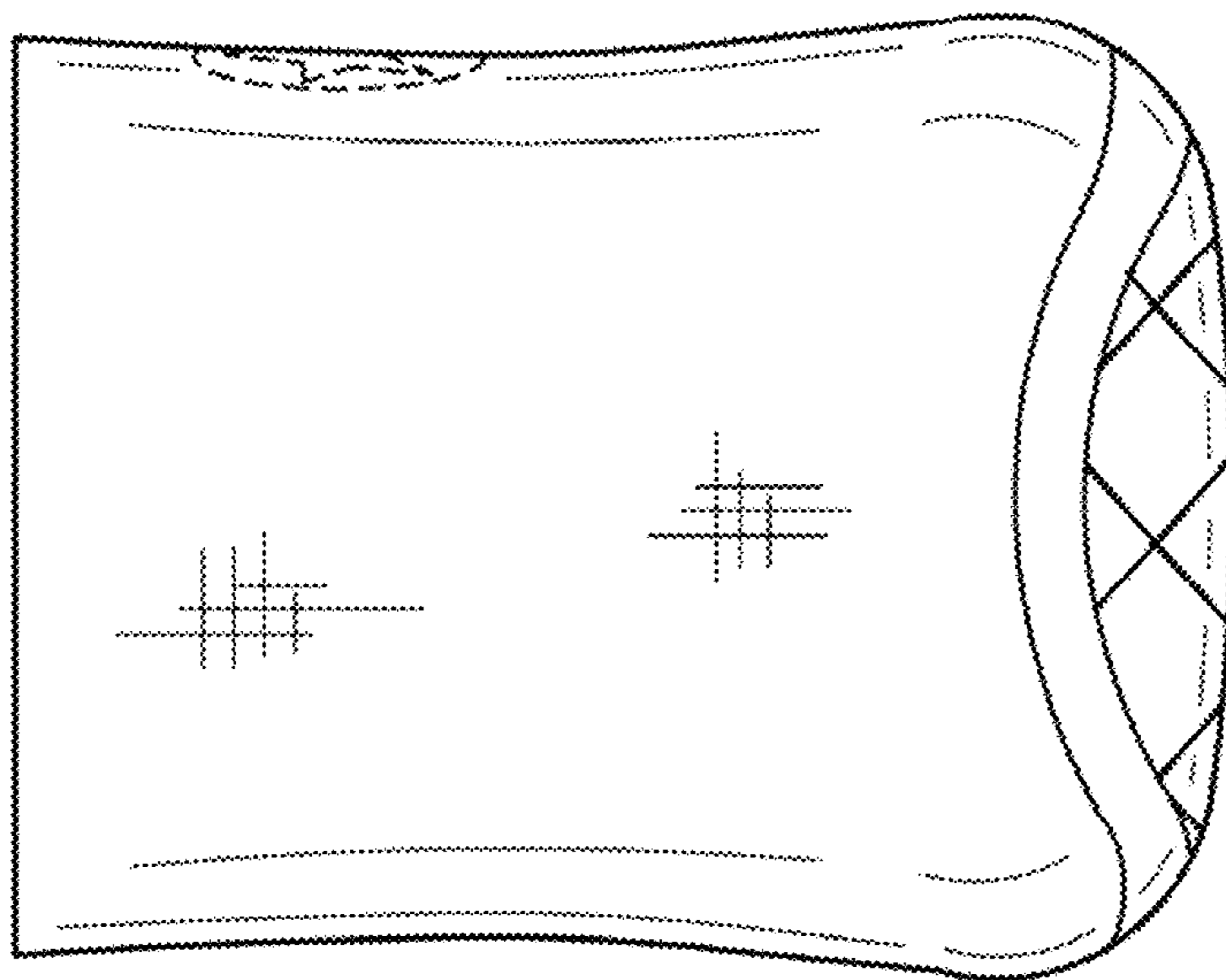

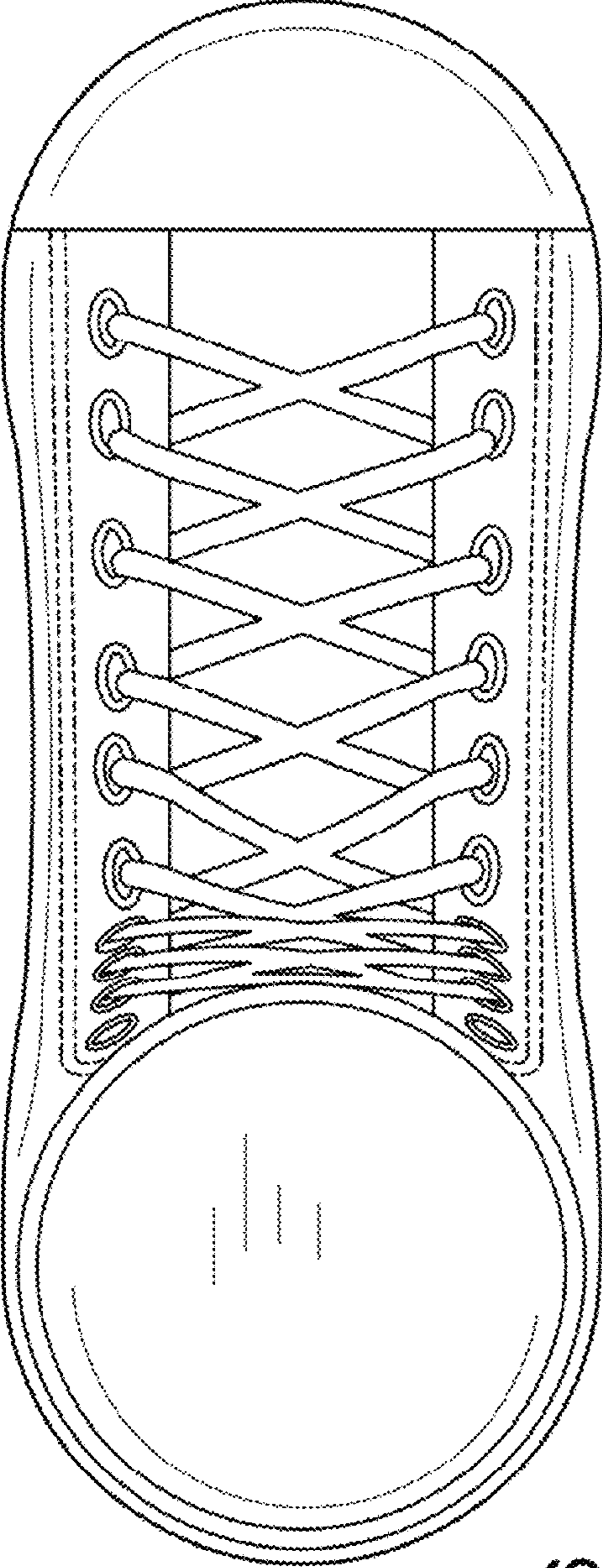

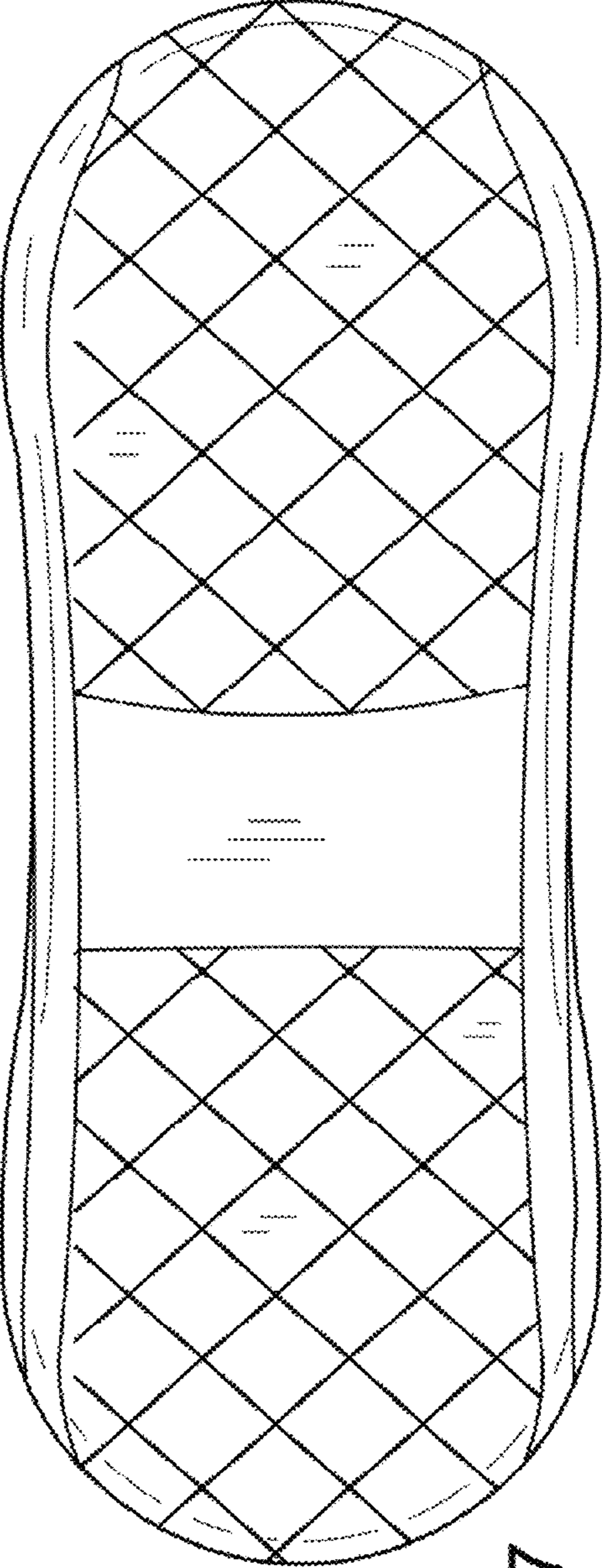
