(57) **CLAIM**

The ornamental design for a tool pouch with rotatable cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view (as seen from the front view) of the tool pouch with rotatable cover in a closed position.

FIG. 2 is a front view (as seen from the side view with rotatable cover in a closed position) thereof.

FIG. 3 is a rear view thereof.

FIG. 4 is a right side view (with rotatable cover in a closed position) thereof.

FIG. 5 is a left side view (with rotatable cover in a closed position) thereof.

FIG. 6 is a top view (with rotatable cover in a closed position) thereof.

FIG. 7 is a bottom view (with rotatable cover in a closed position) thereof.

FIG. 8 is a perspective view (as seen from the rear view with rotatable cover in a closed position) thereof.

FIG. 9 is a perspective view (as seen from the front view) of the tool pouch with rotatable cover in an open position.

FIG. 10 is a front view (with rotatable cover in an open position) thereof.

FIG. 11 is a rear view thereof.

FIG. 12 is a right side view (with rotatable cover in an open position) thereof.

FIG. 13 is a left side view (with rotatable cover in an open position) thereof.

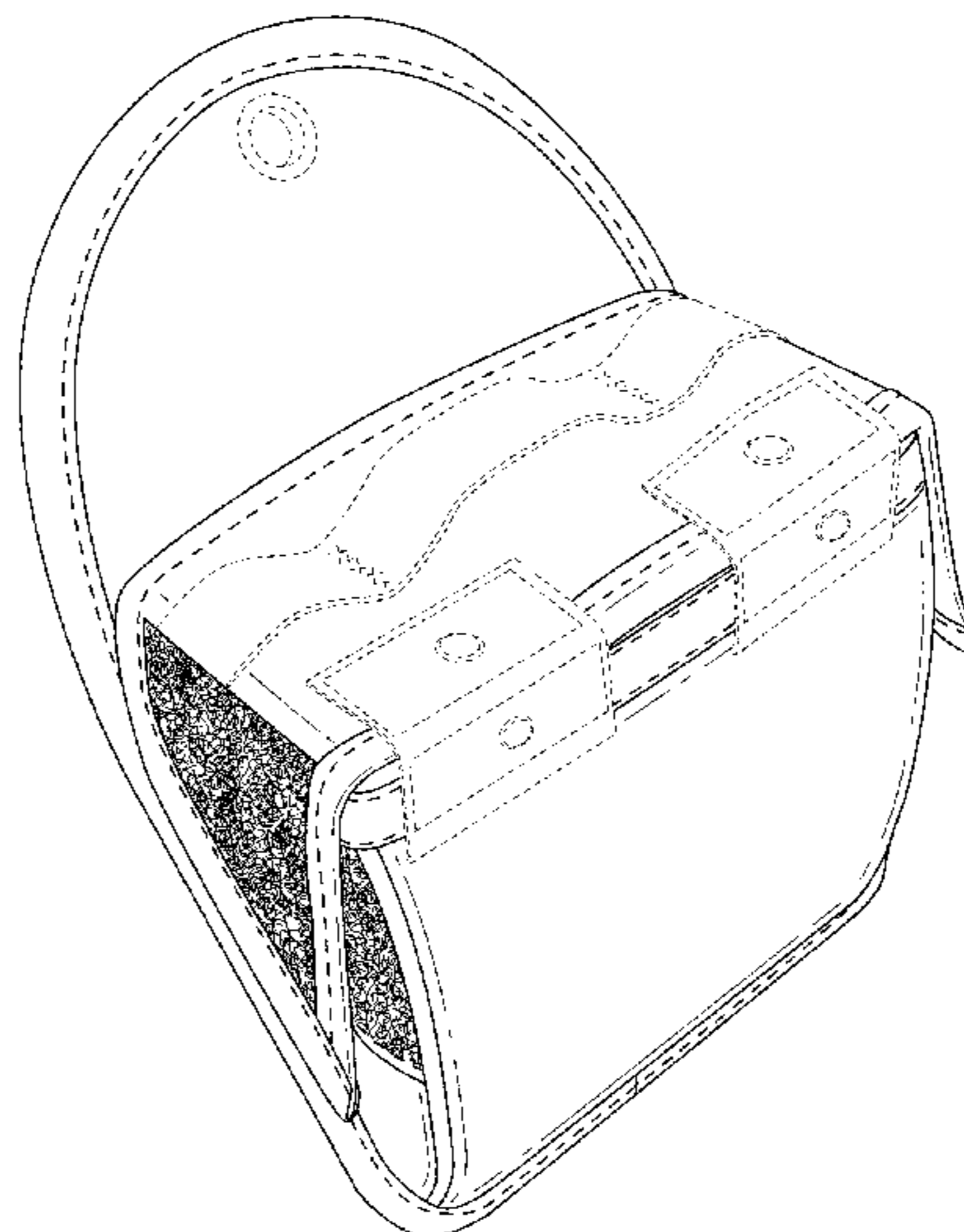
FIG. 14 is a top view (with rotatable cover in an open position) thereof.

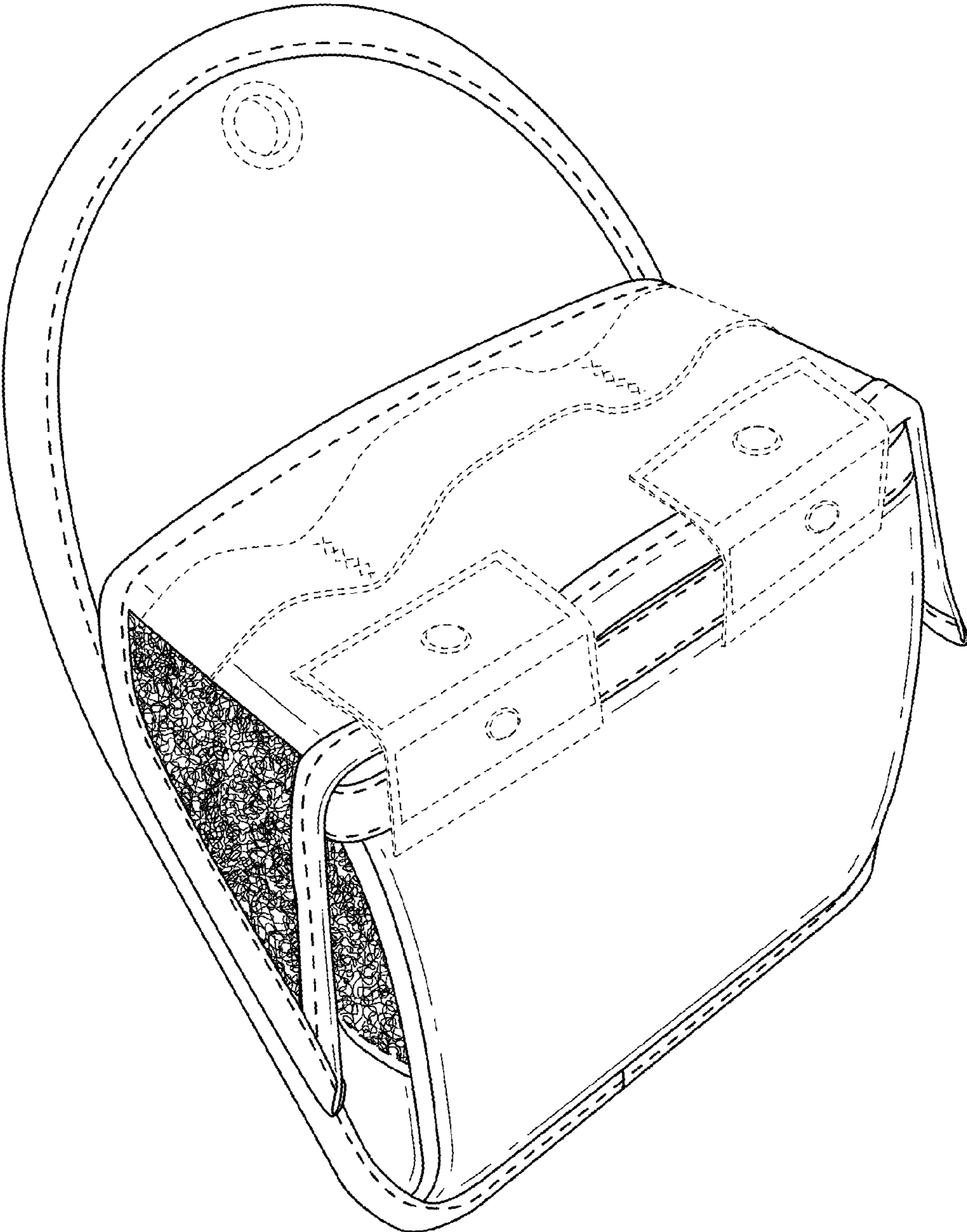

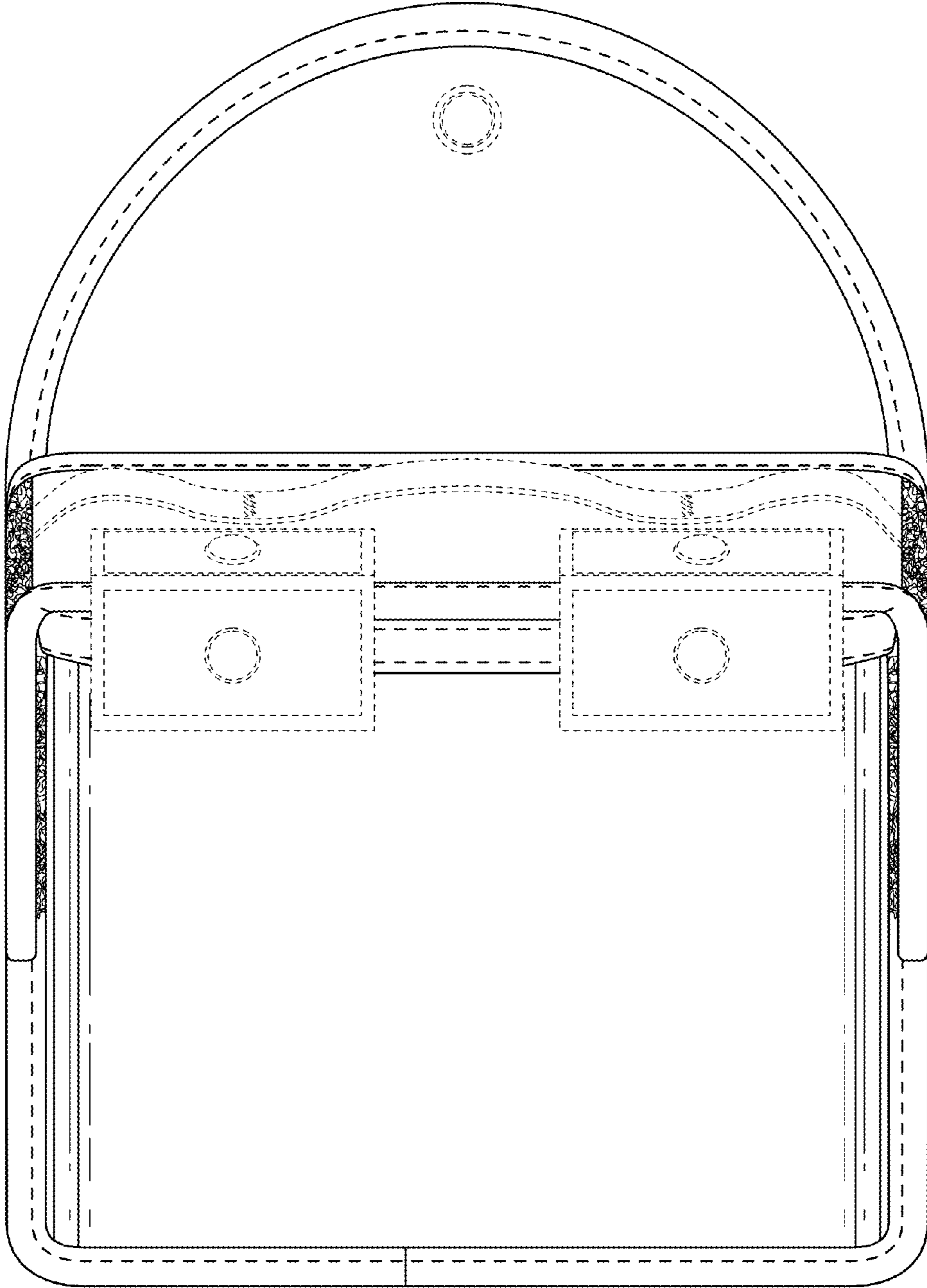

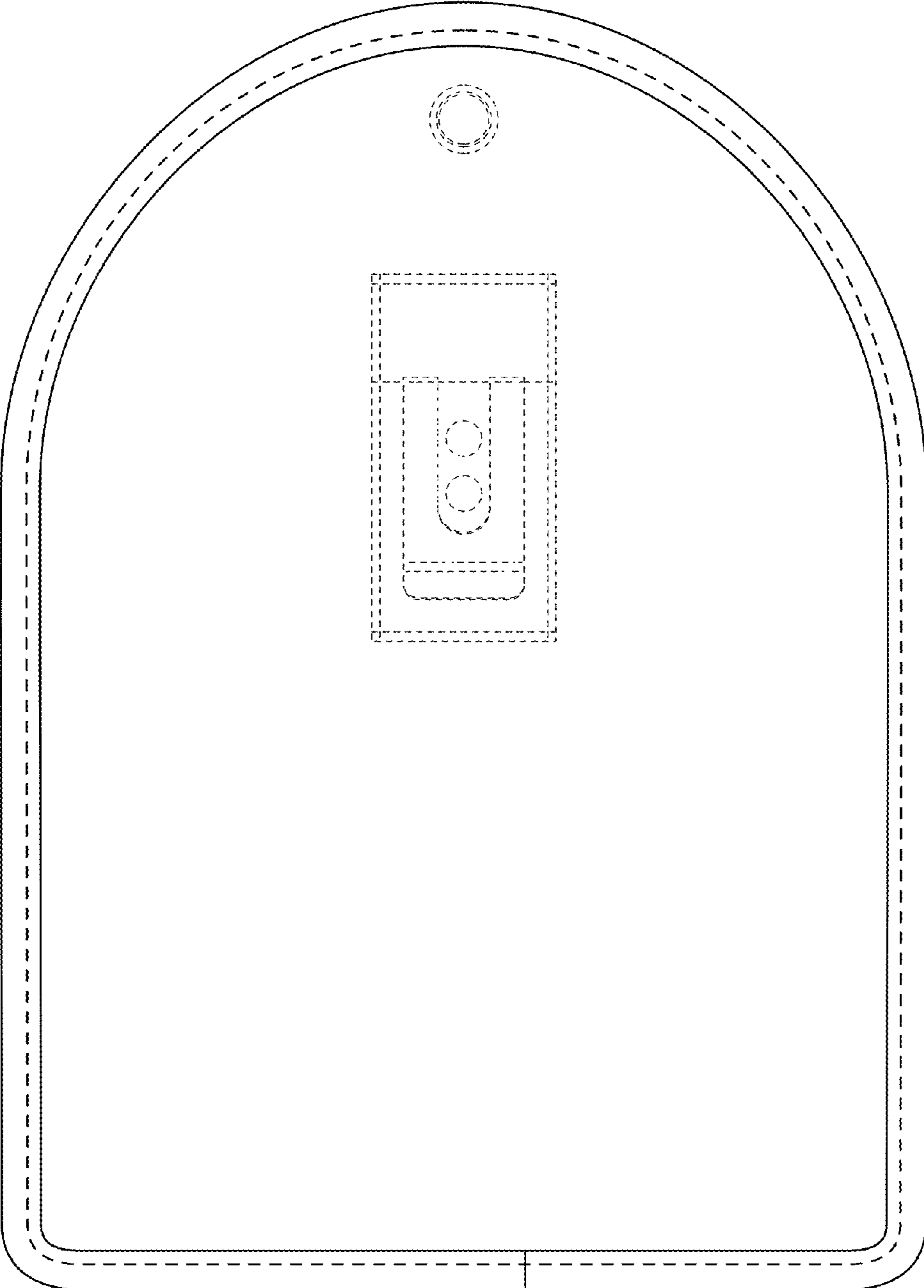

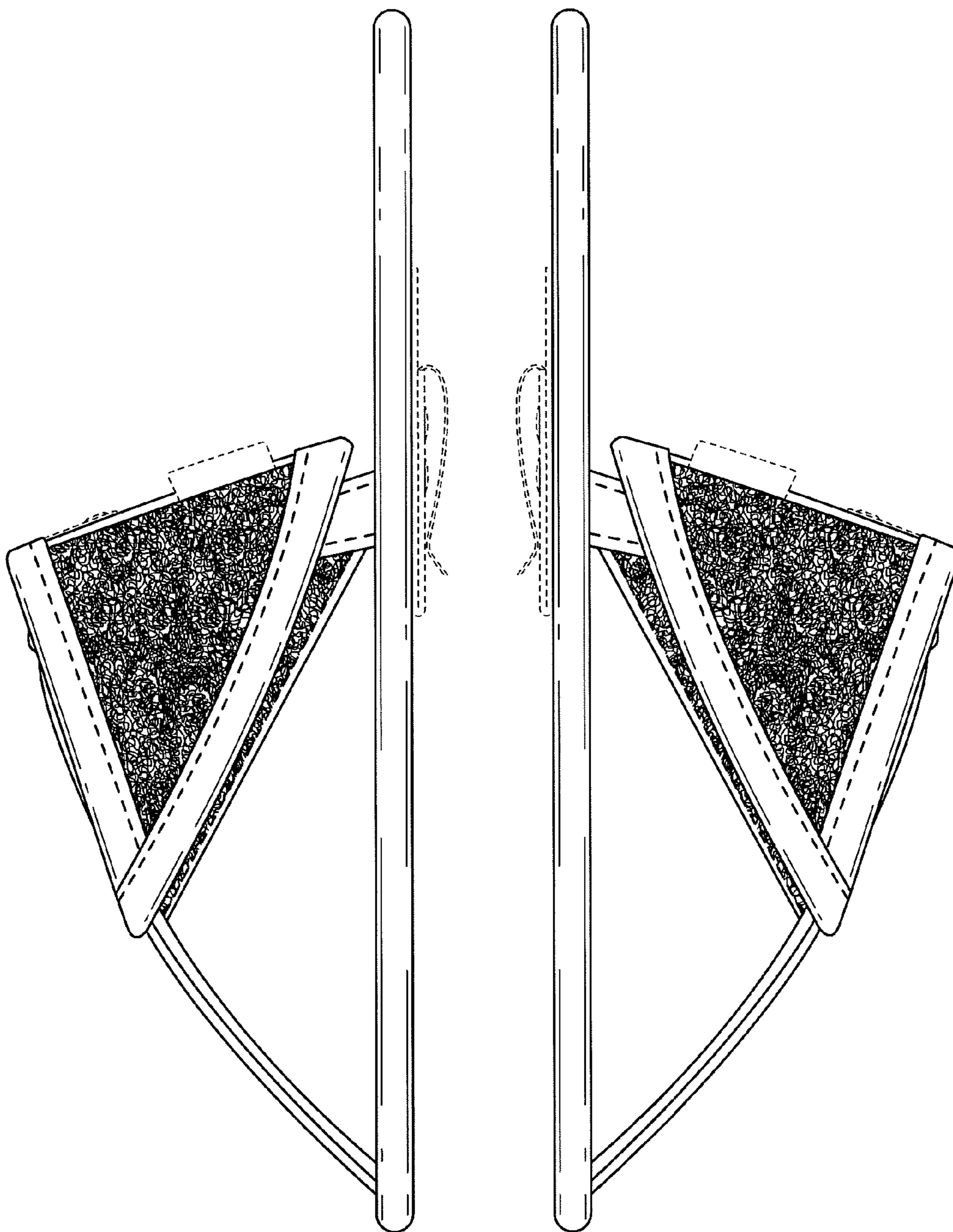

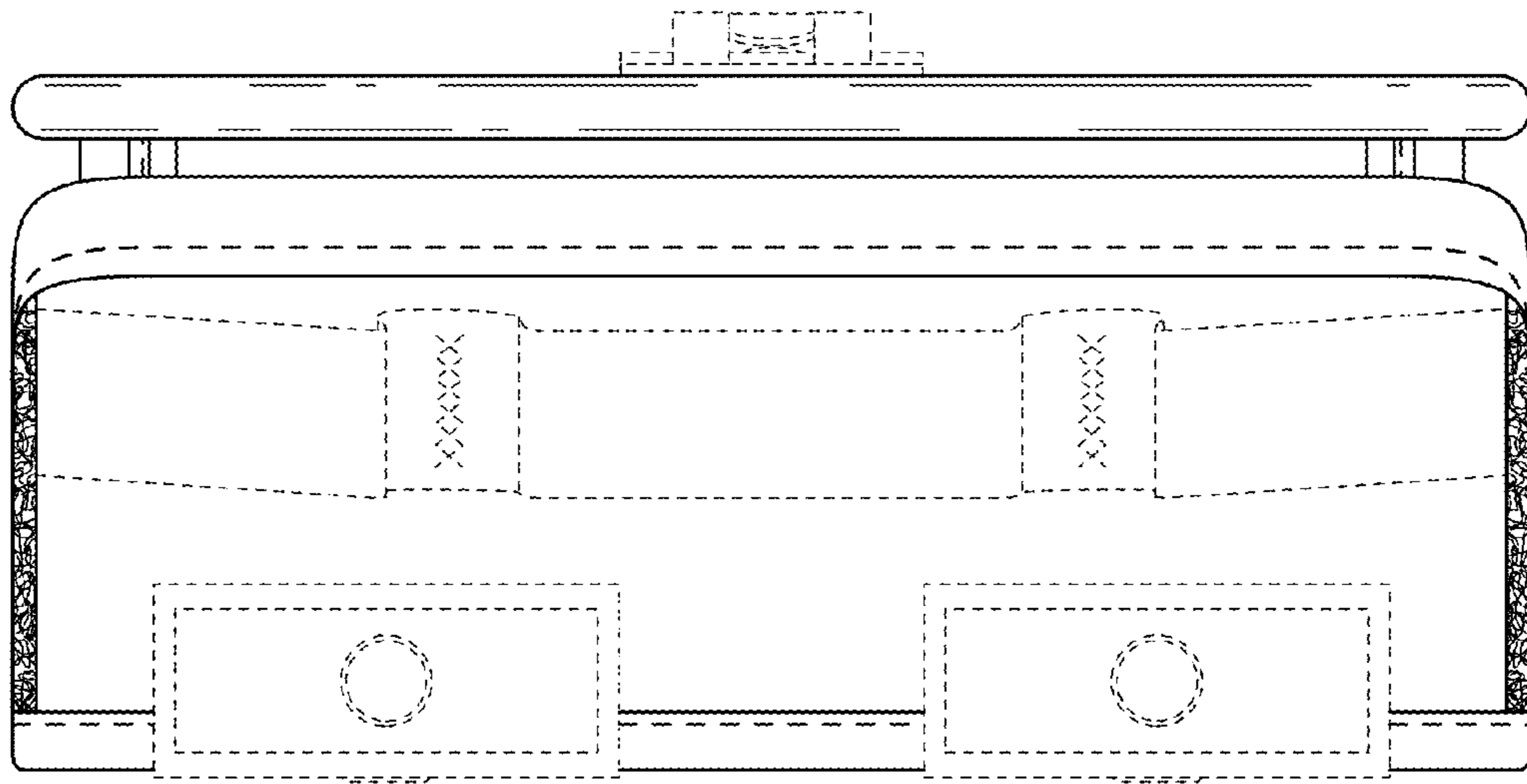

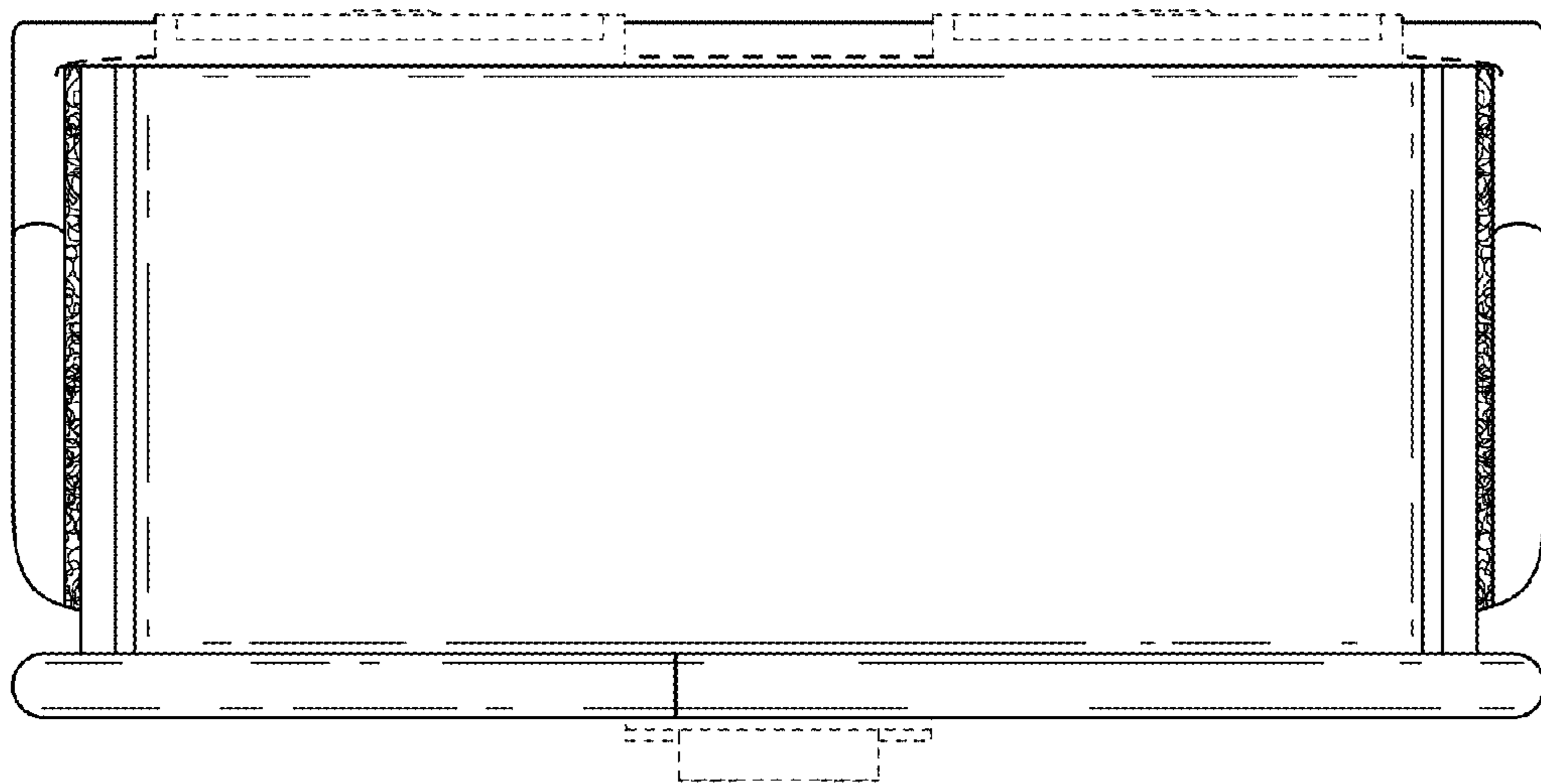

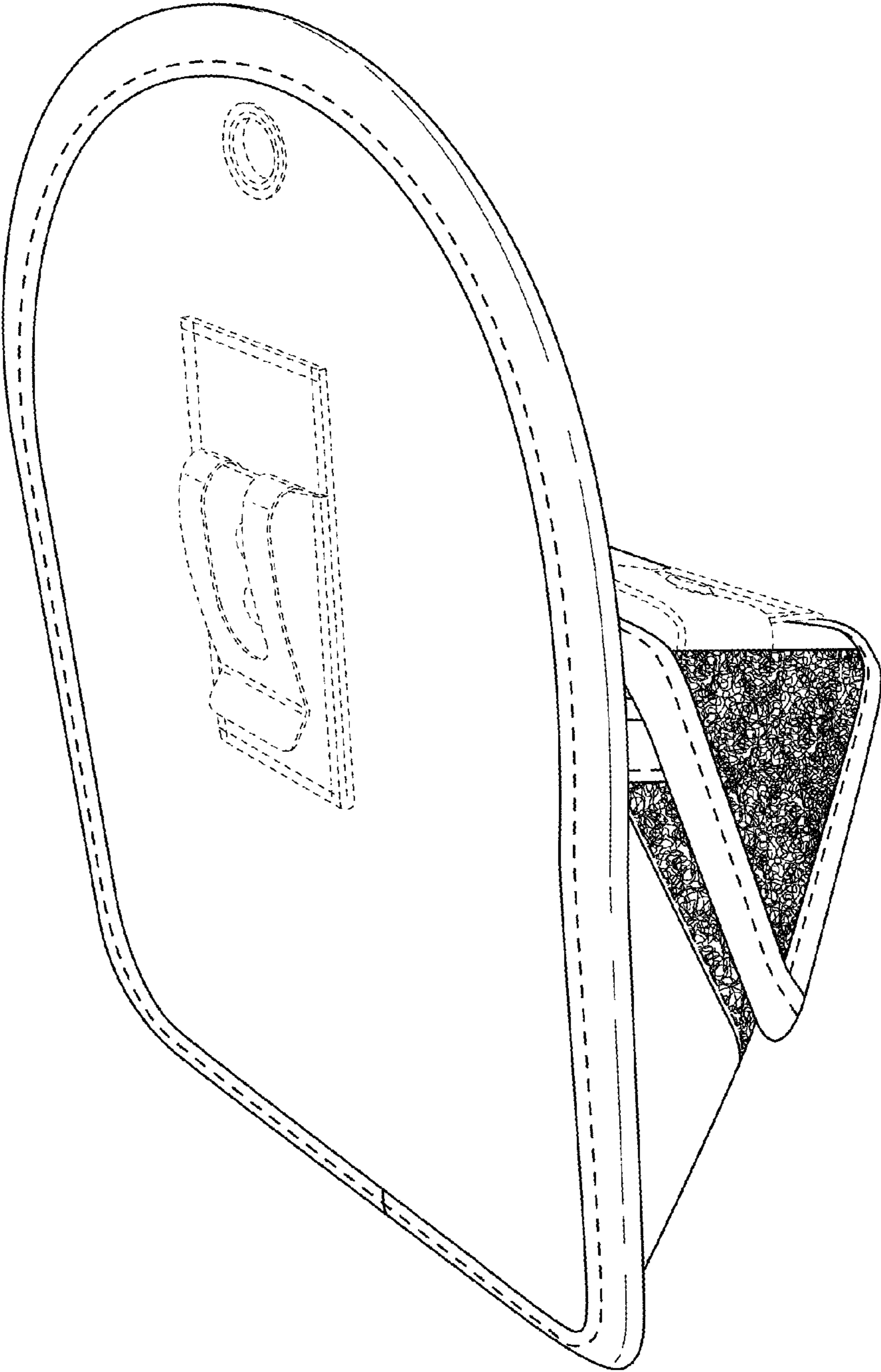

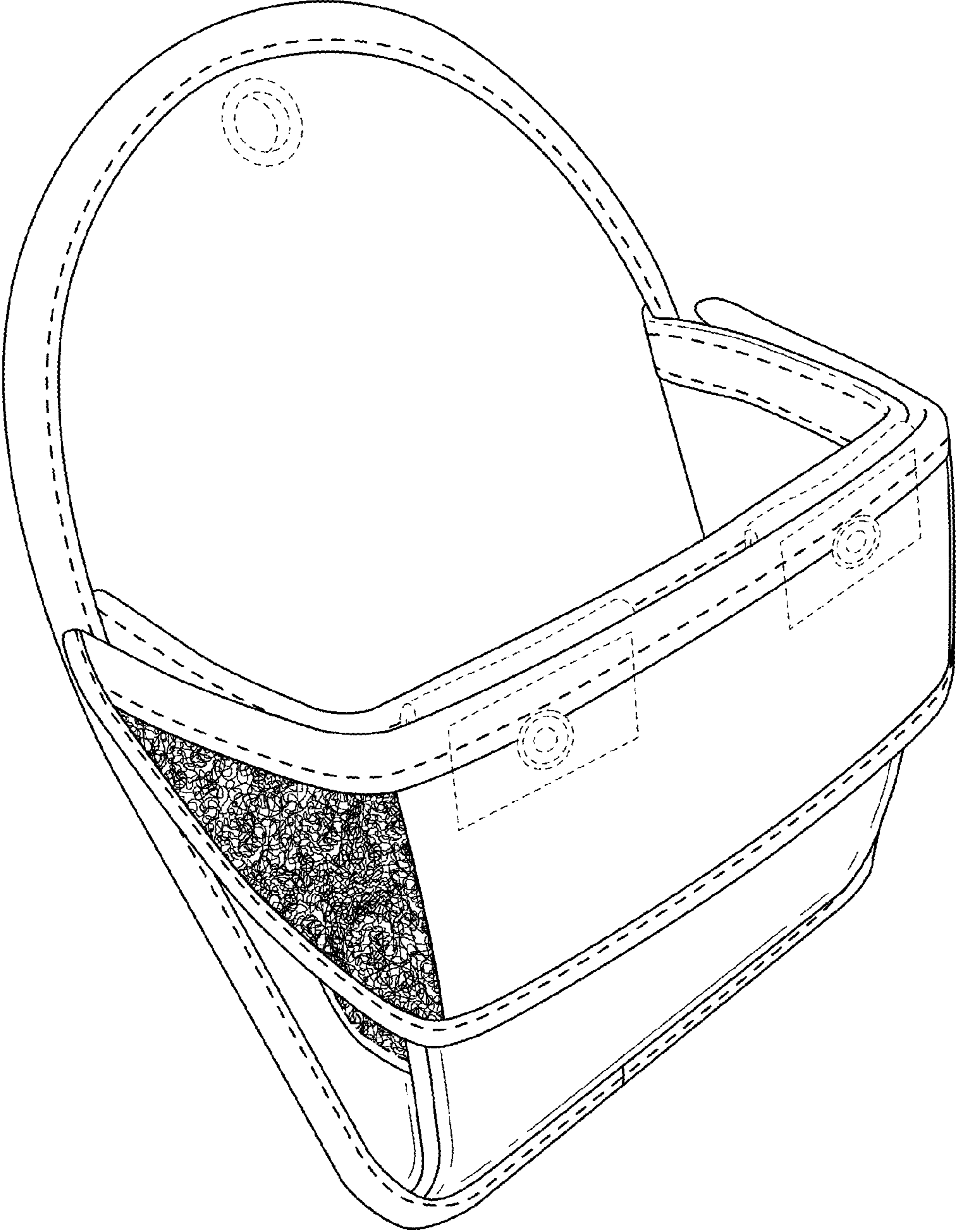

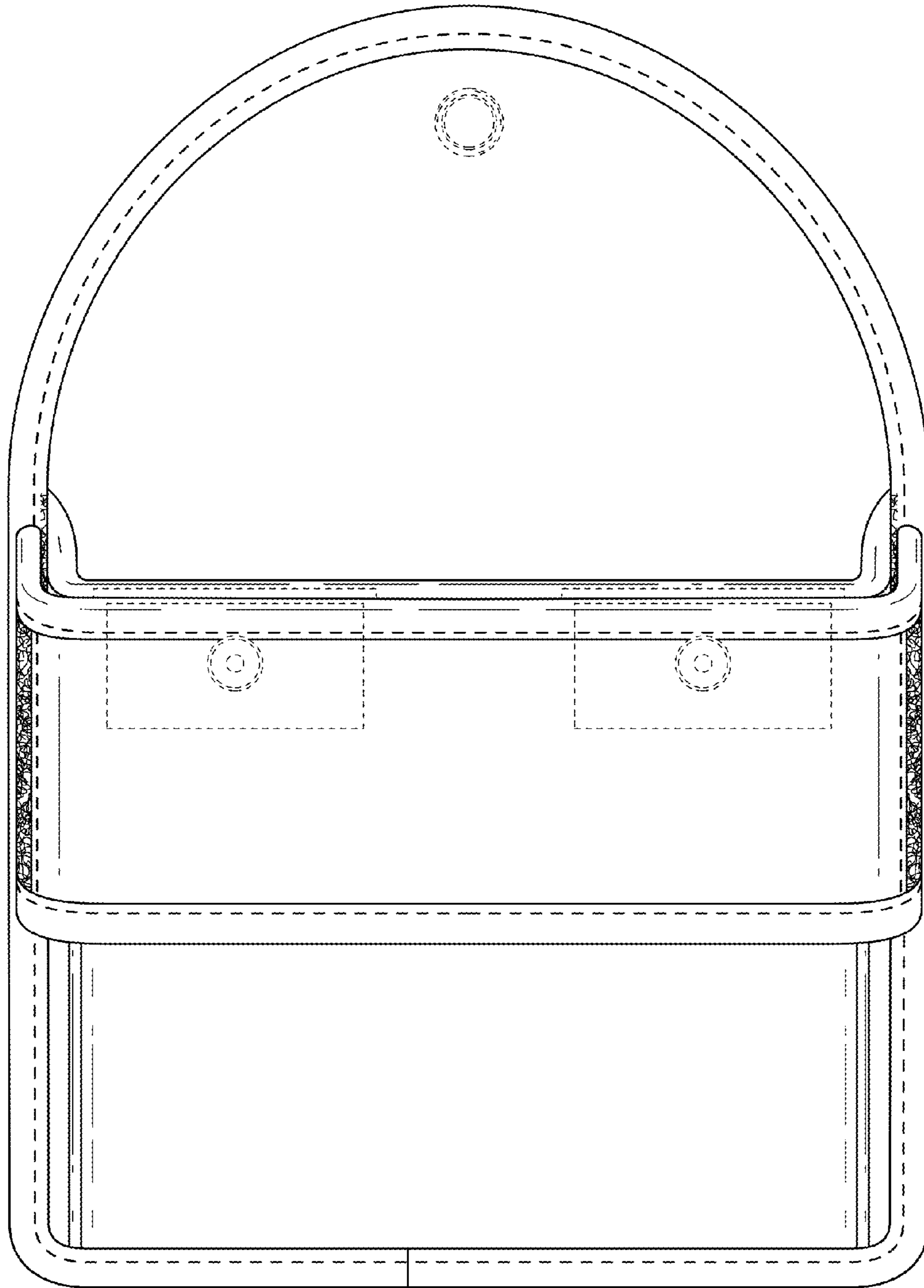

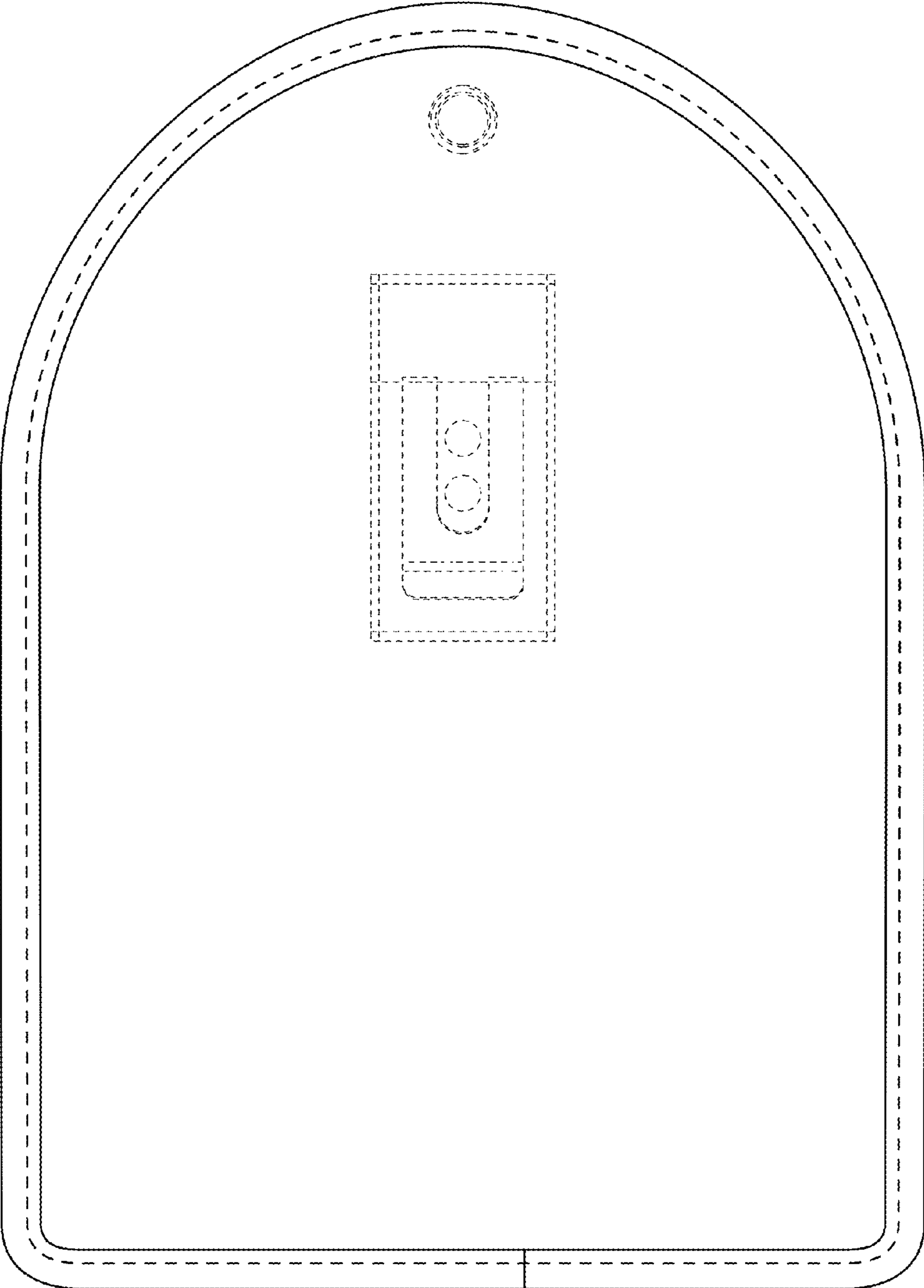

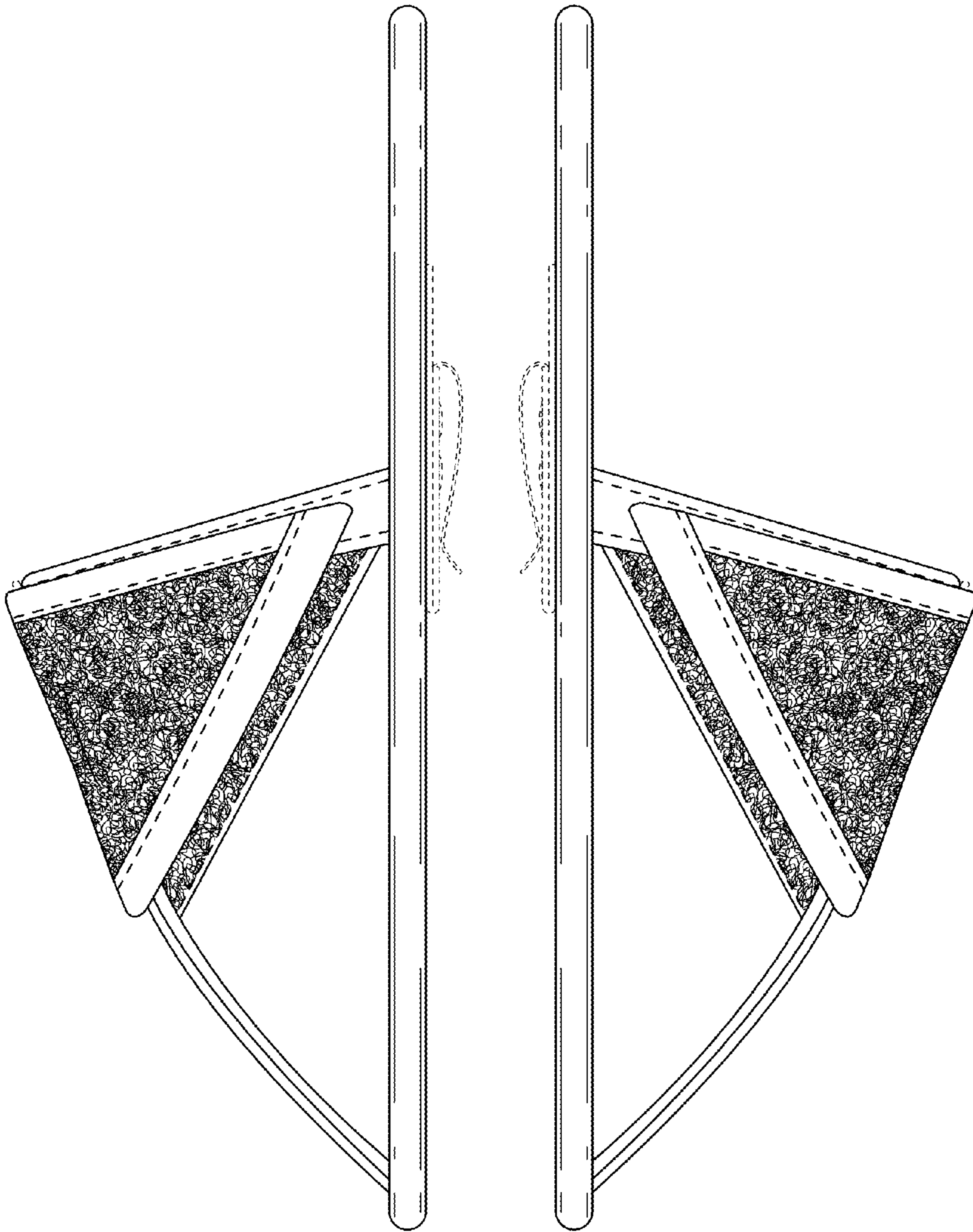

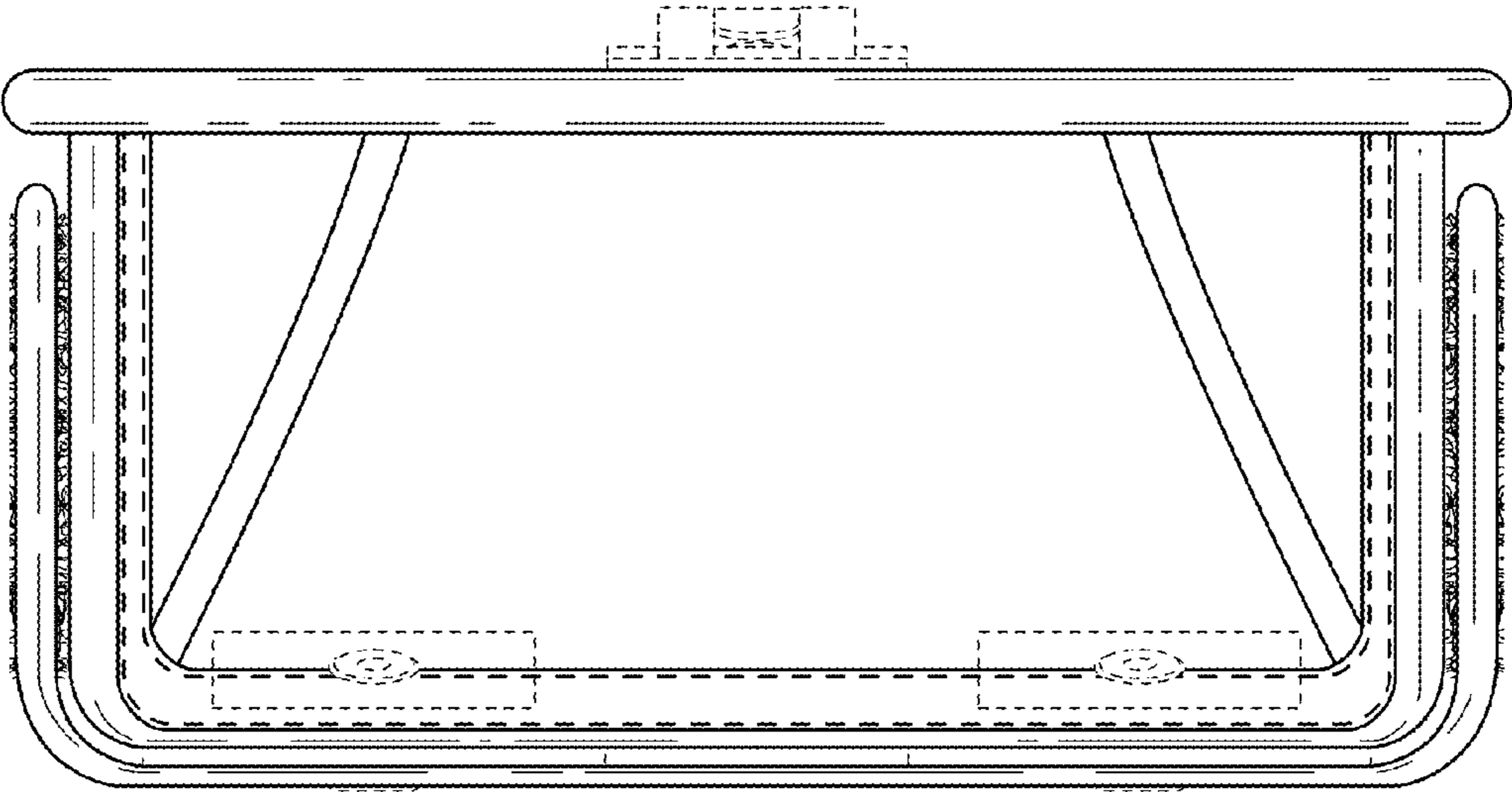

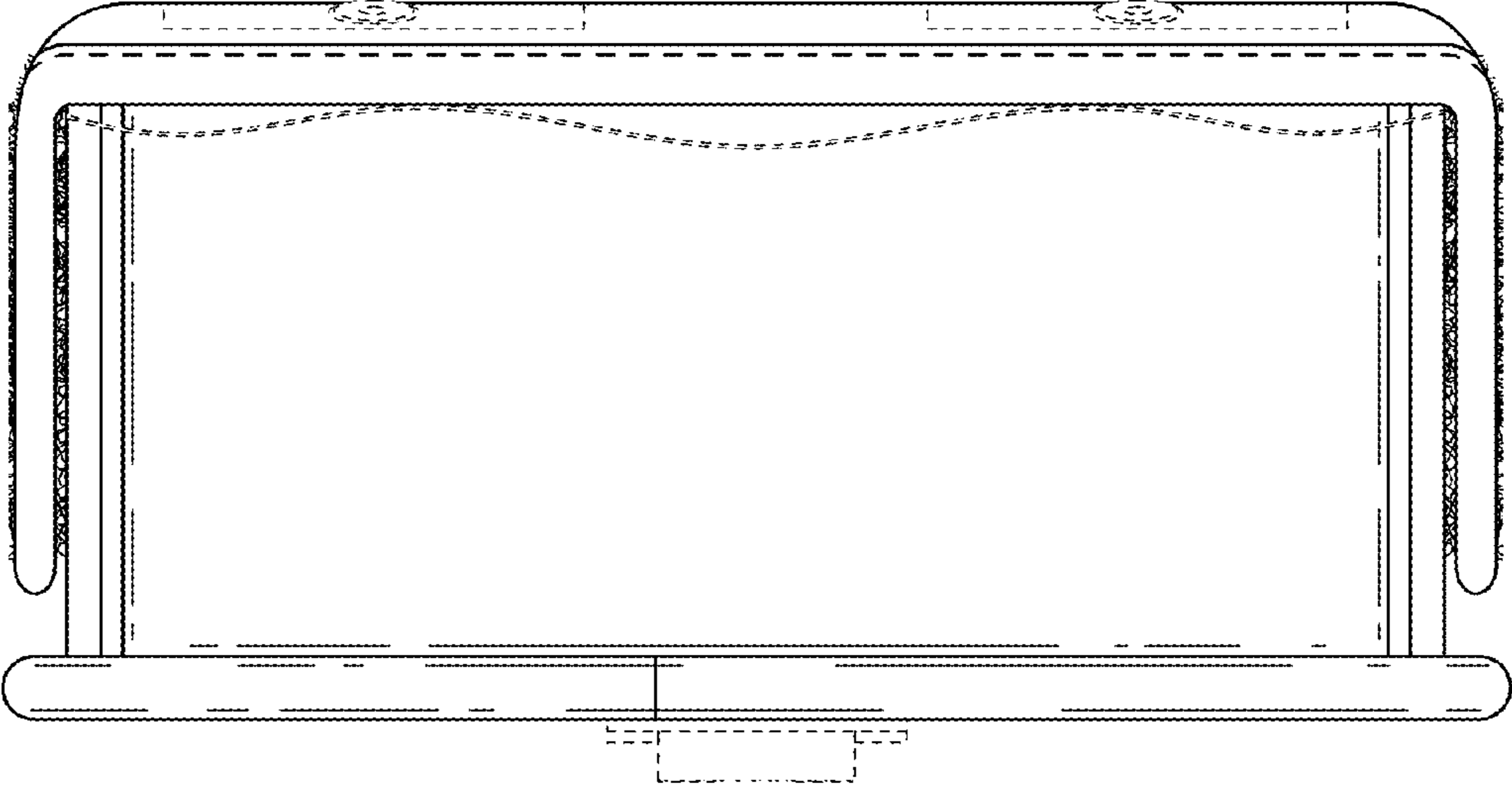

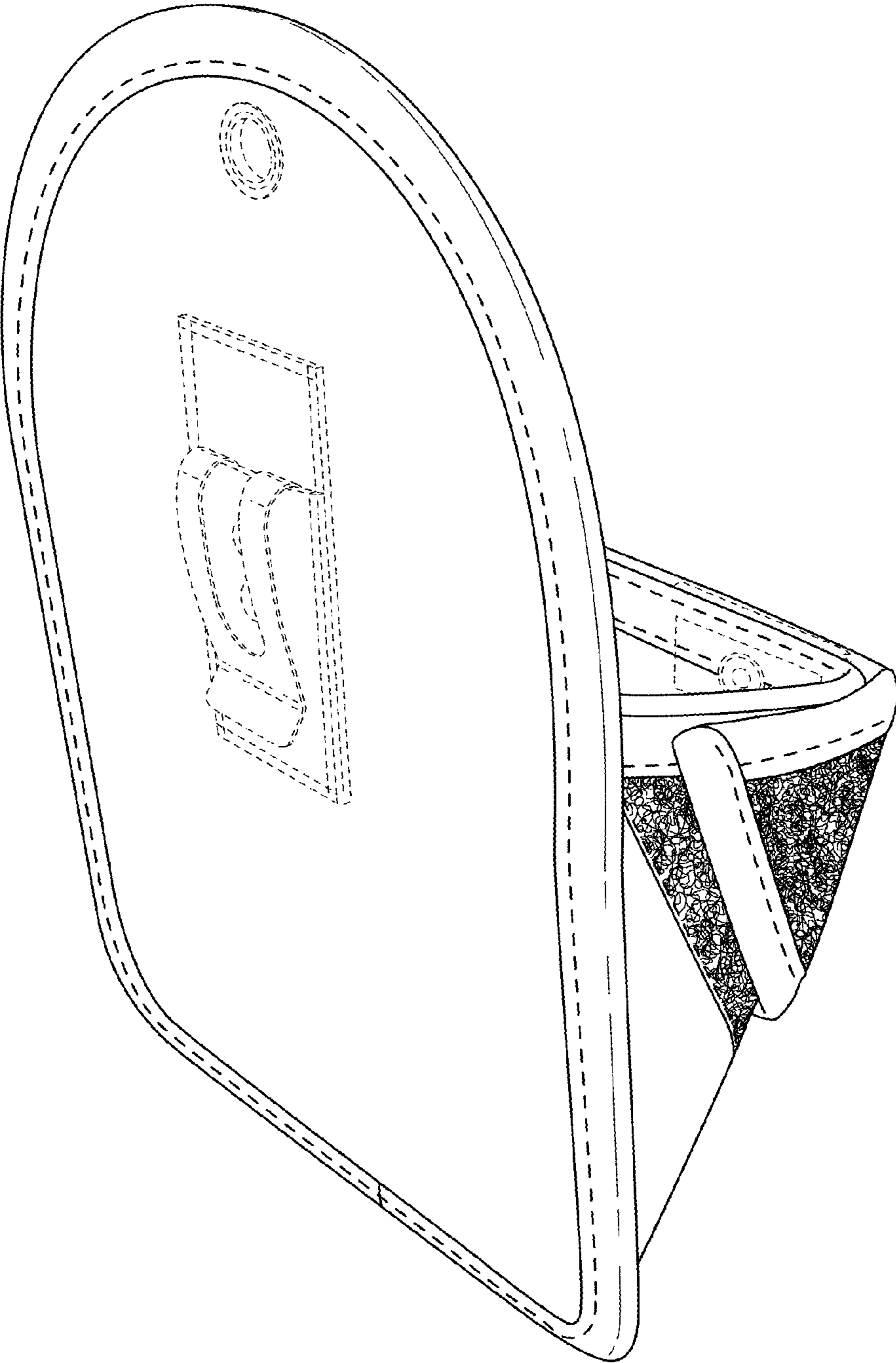
