**DESCRIPTION**

FIG. 1 shows a front perspective view of luggage;

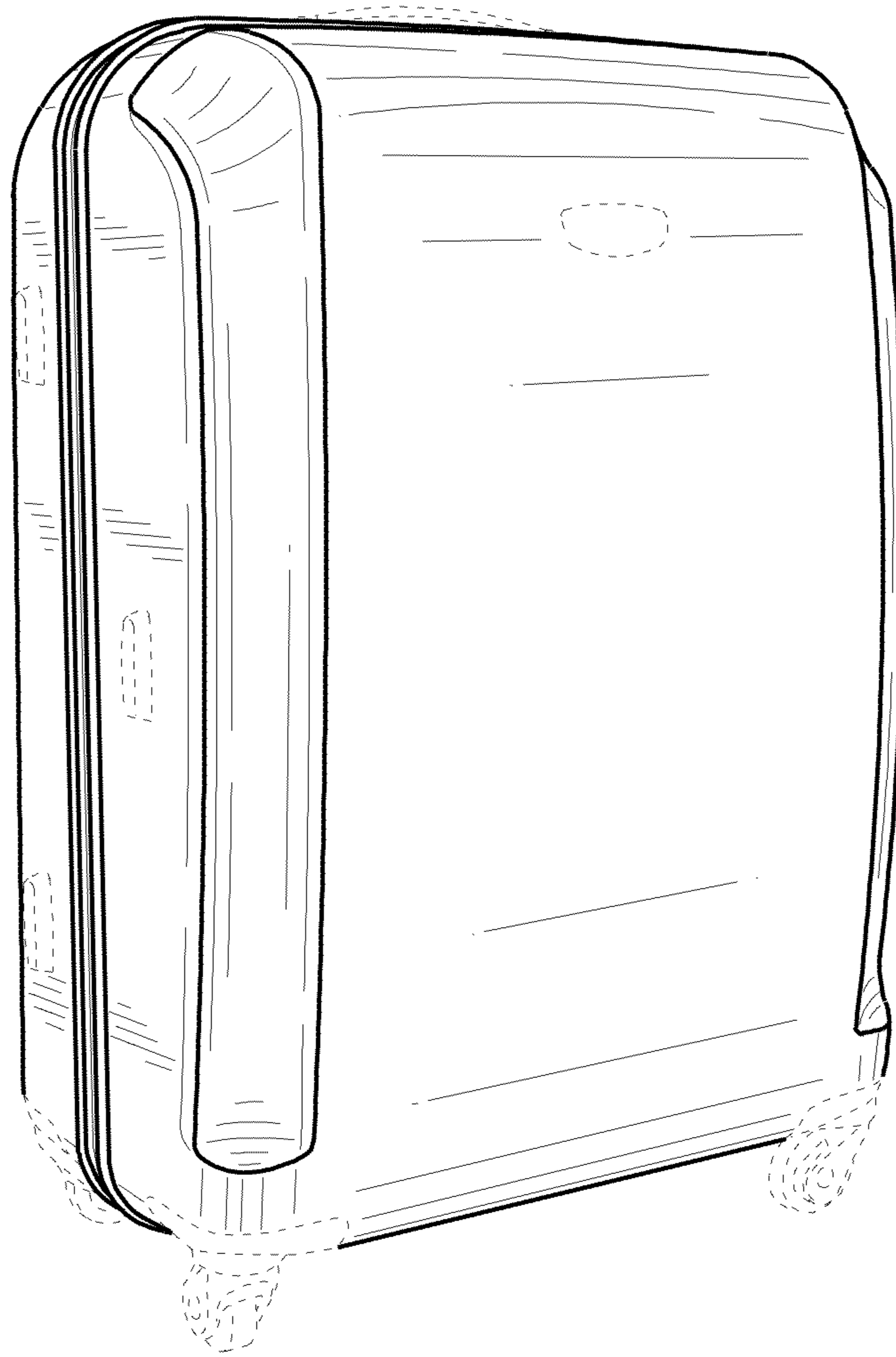

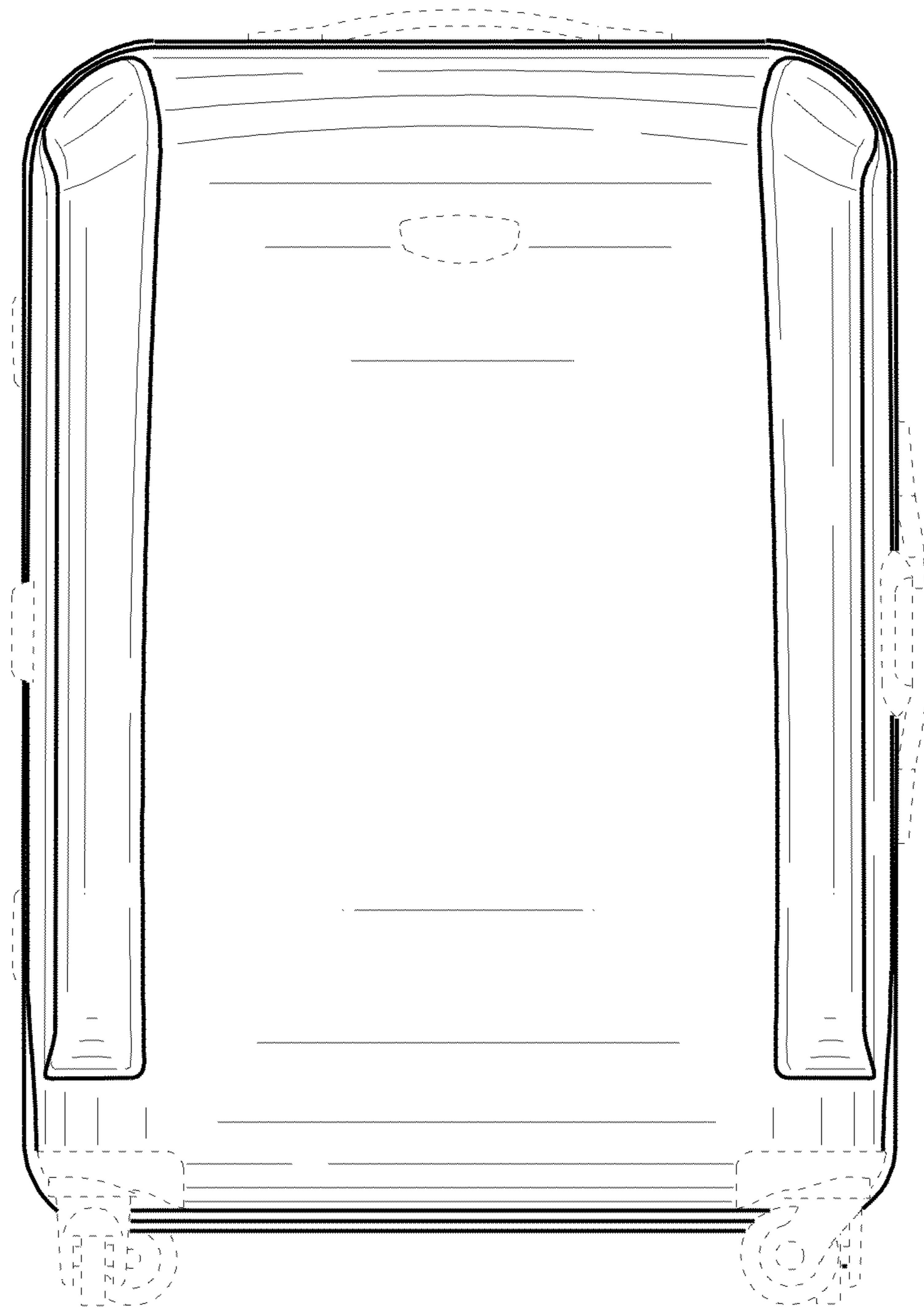

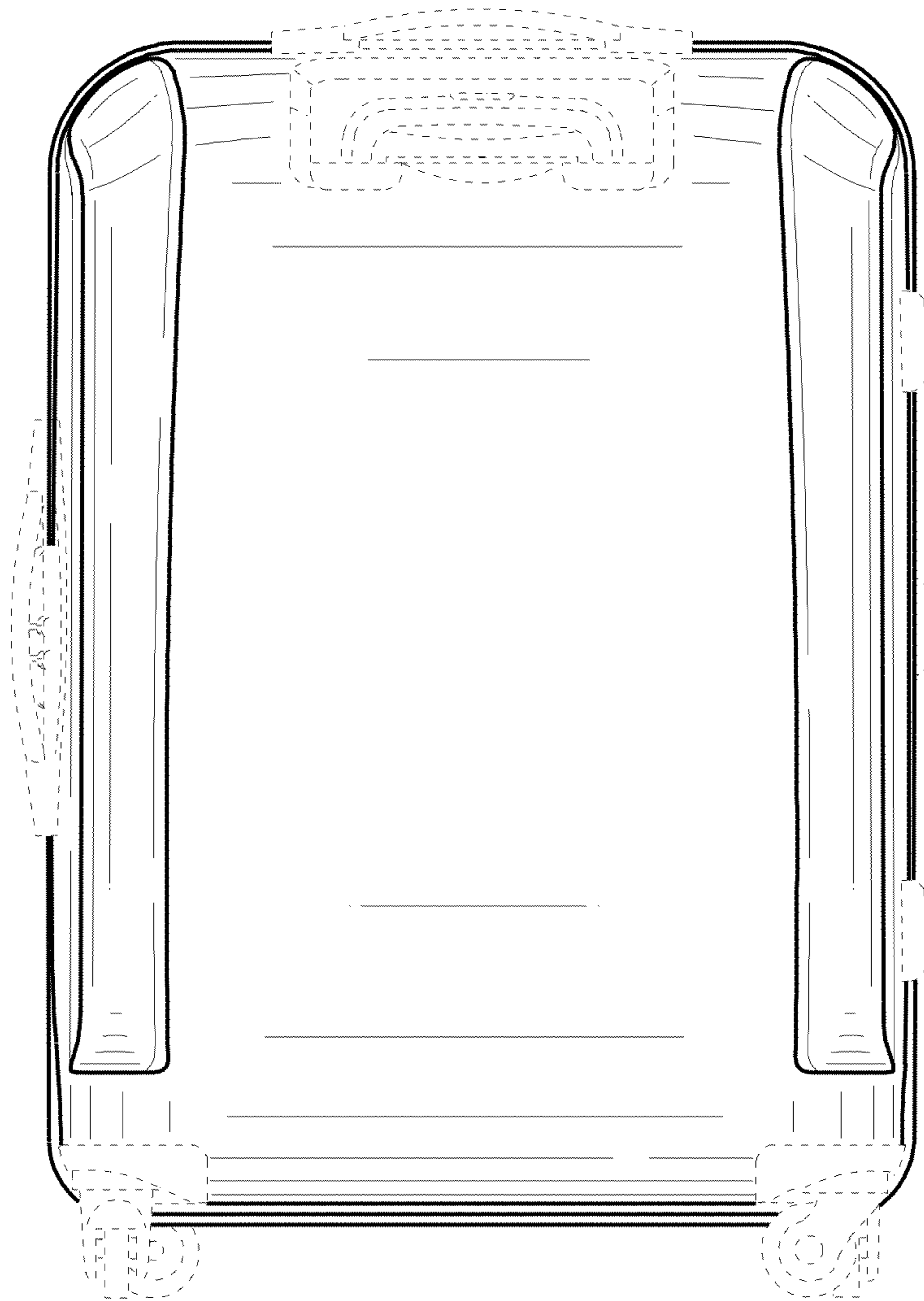

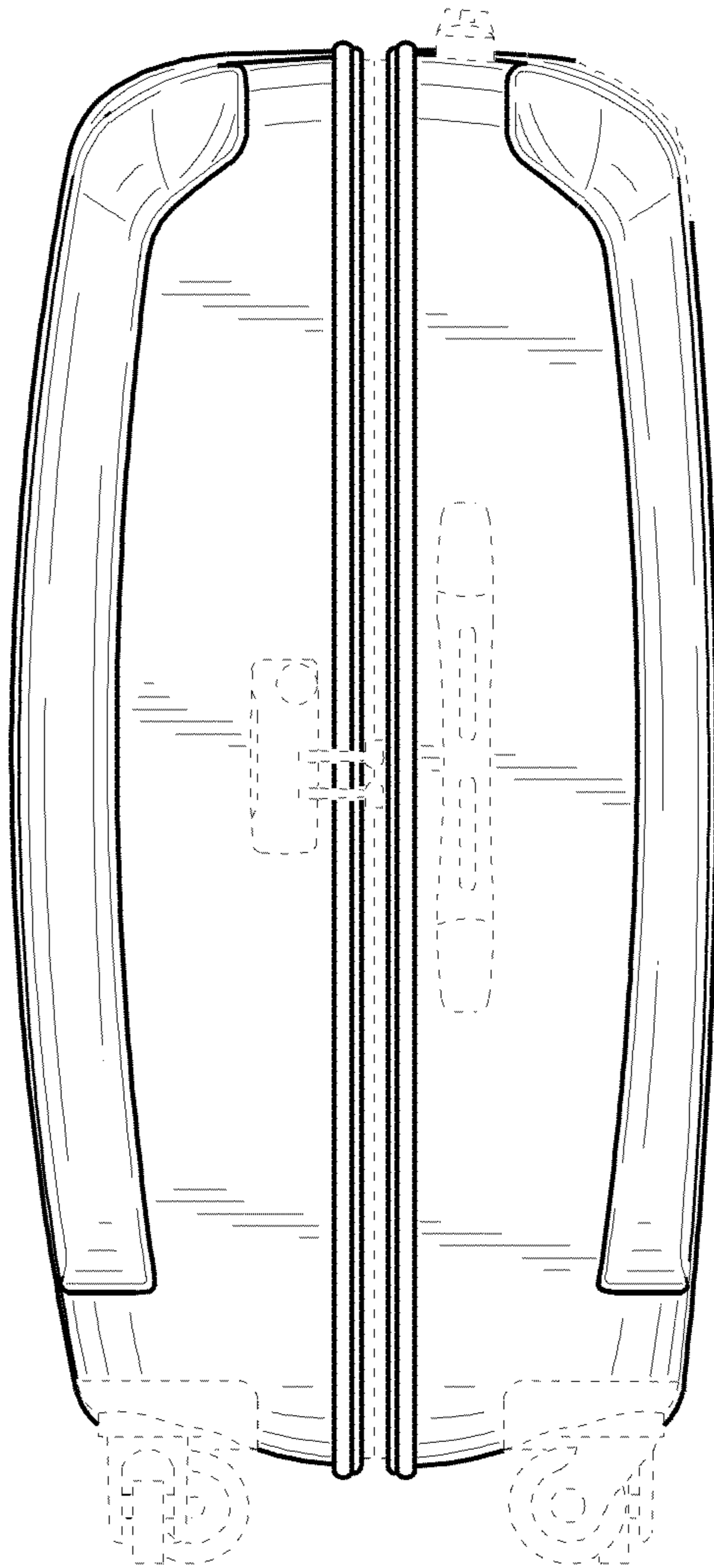

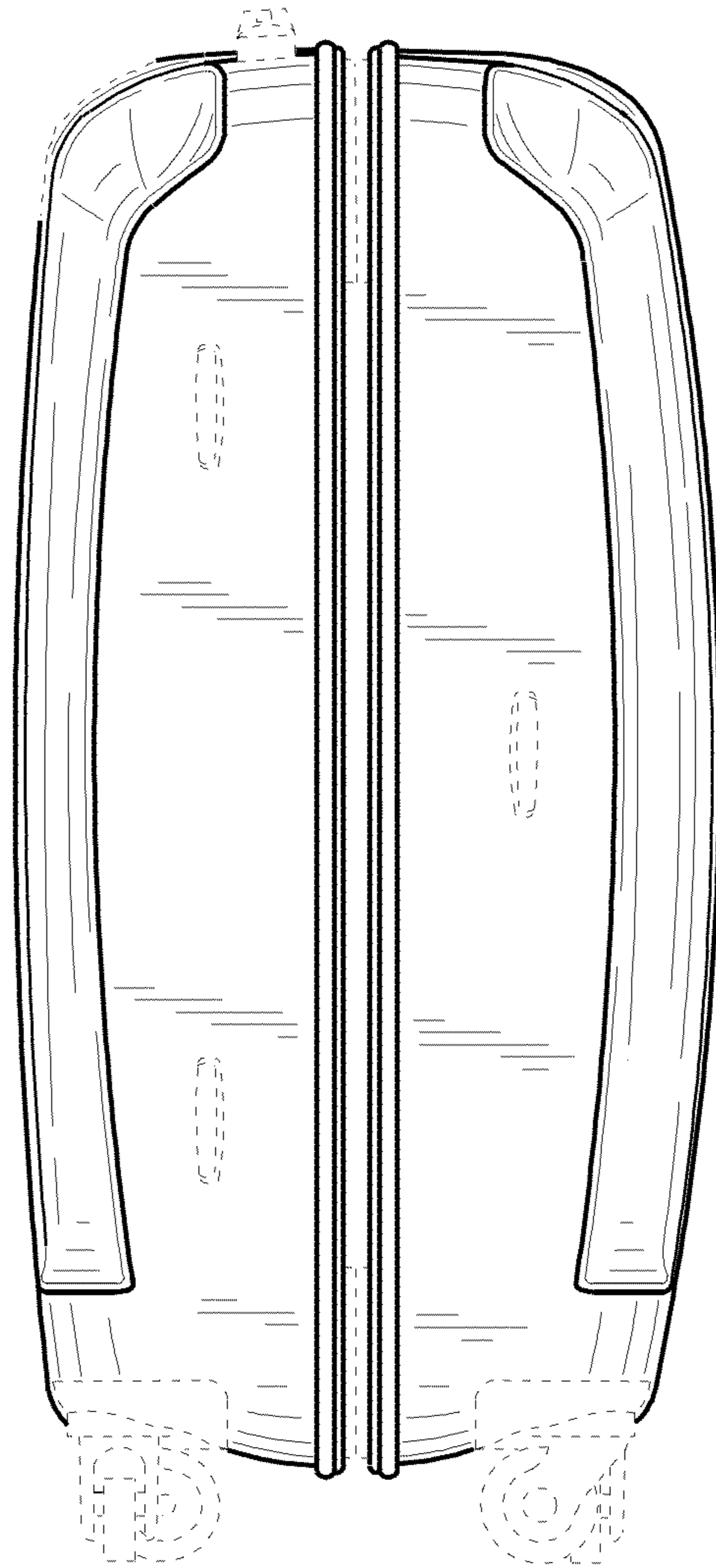

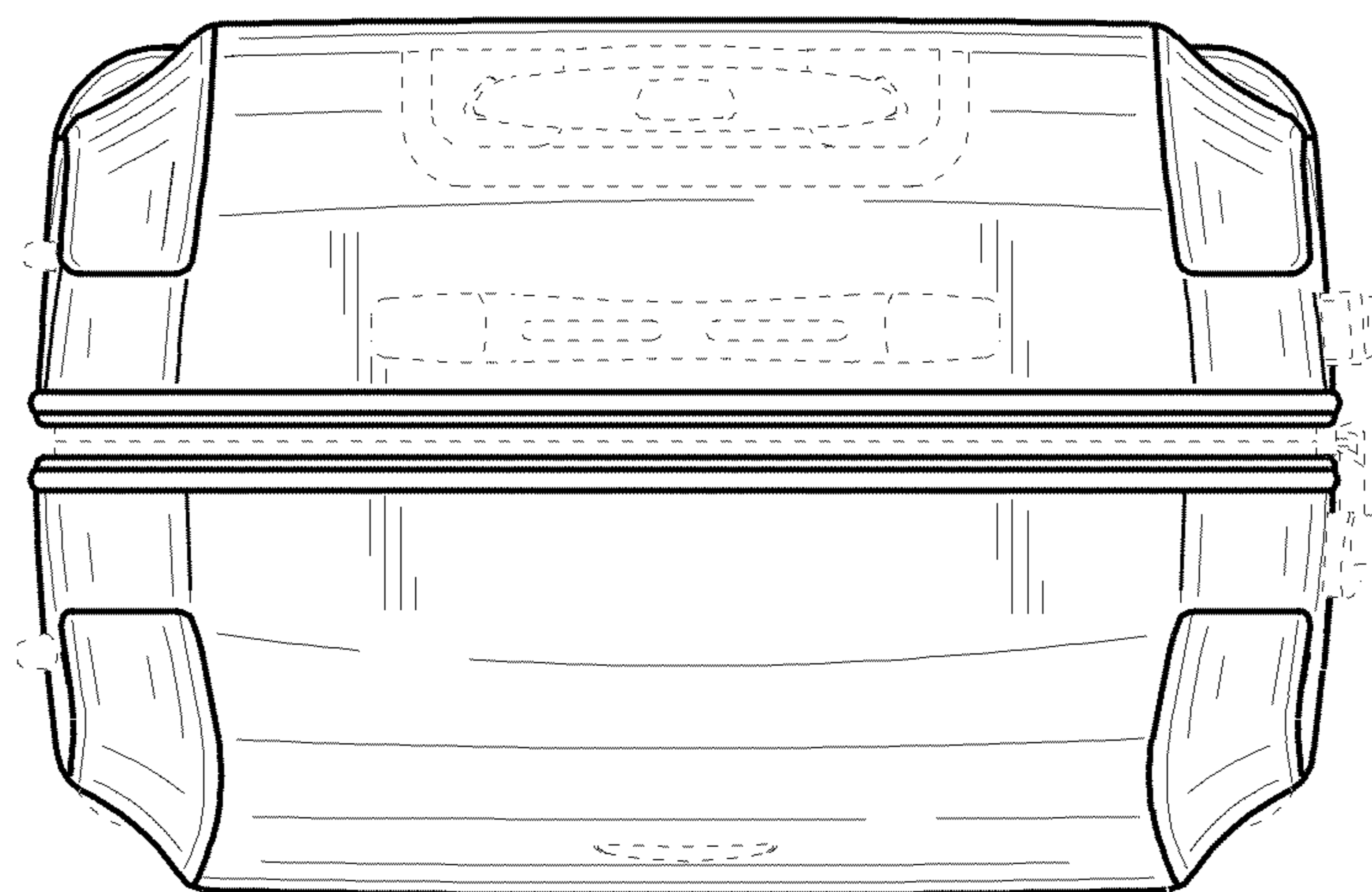

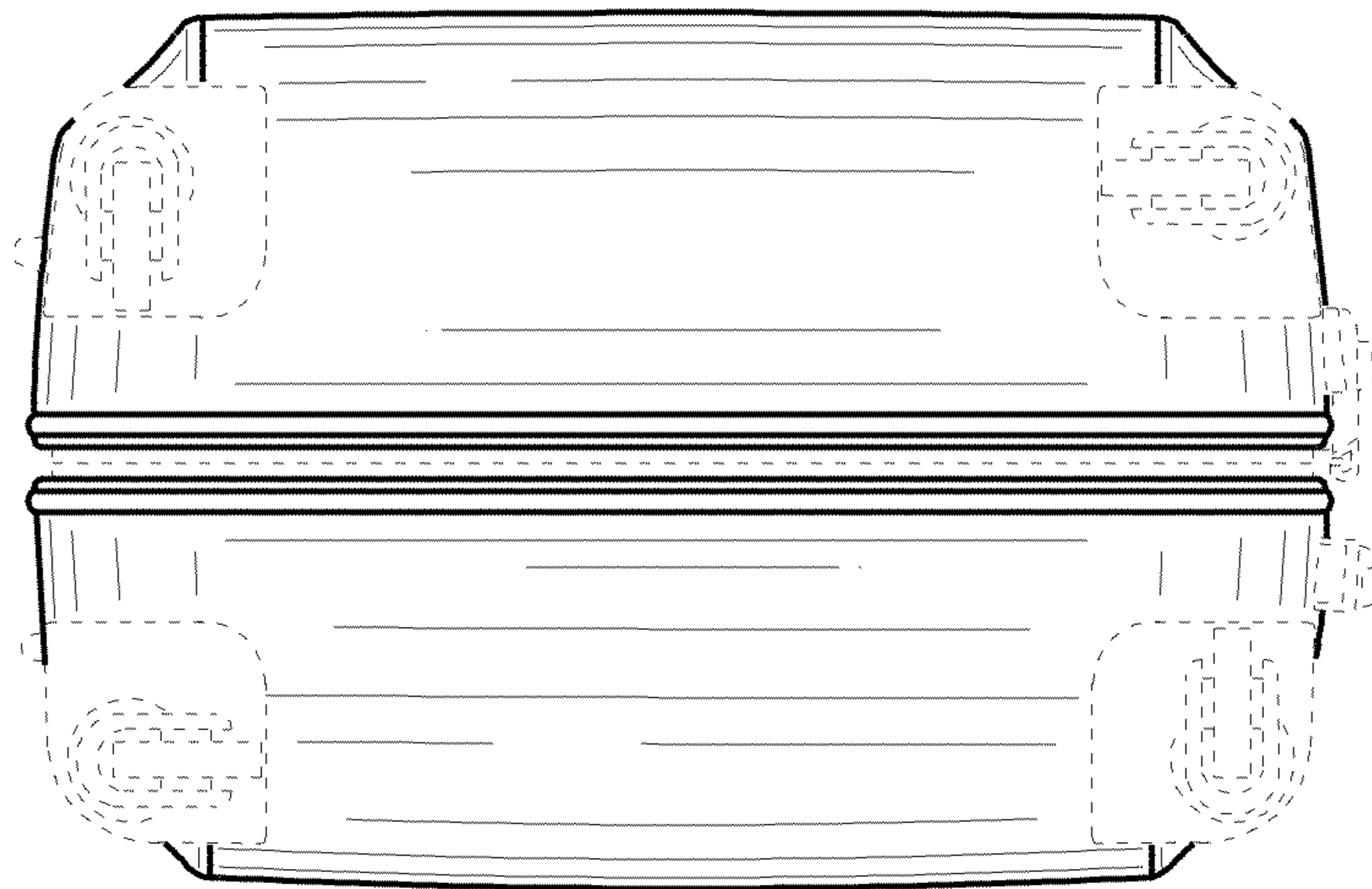
