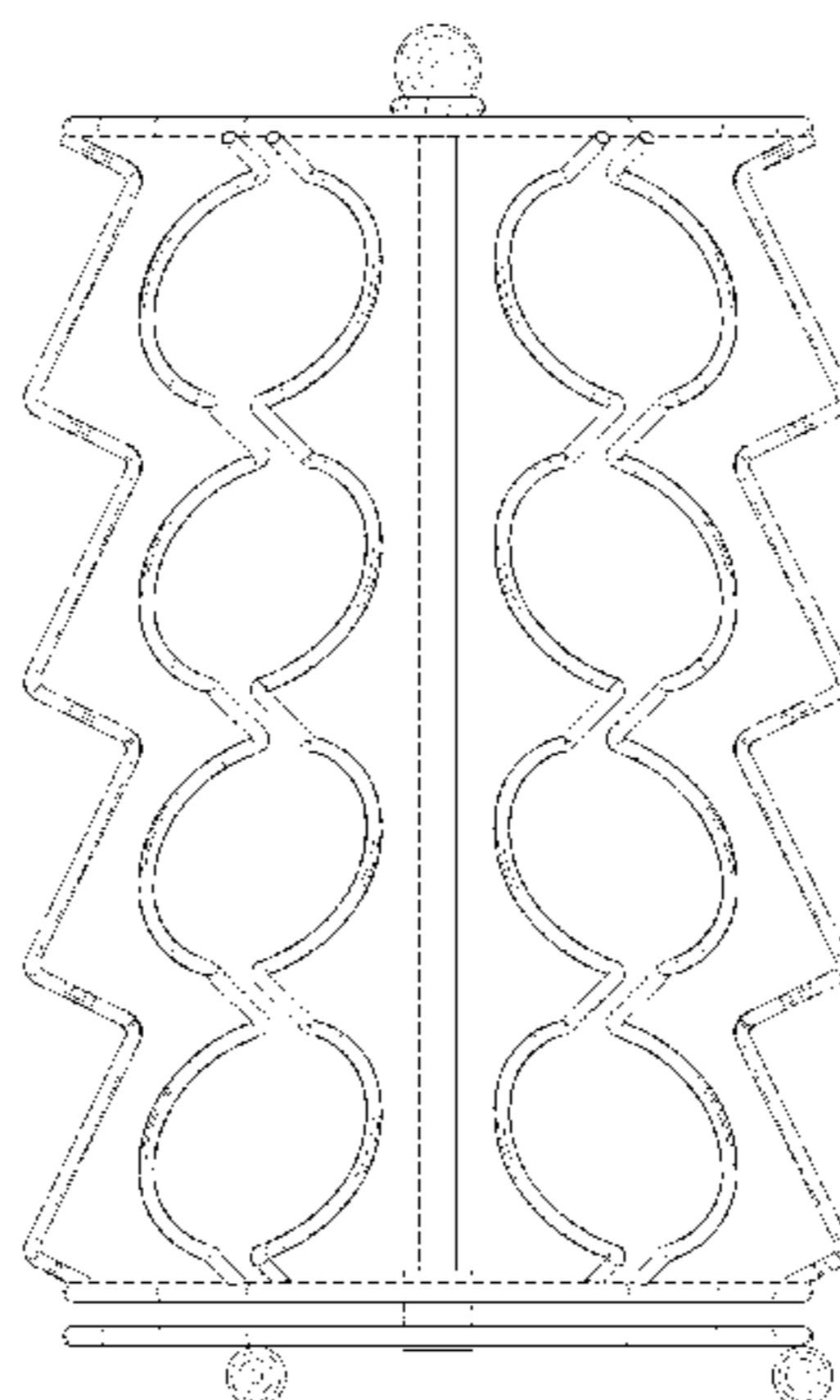
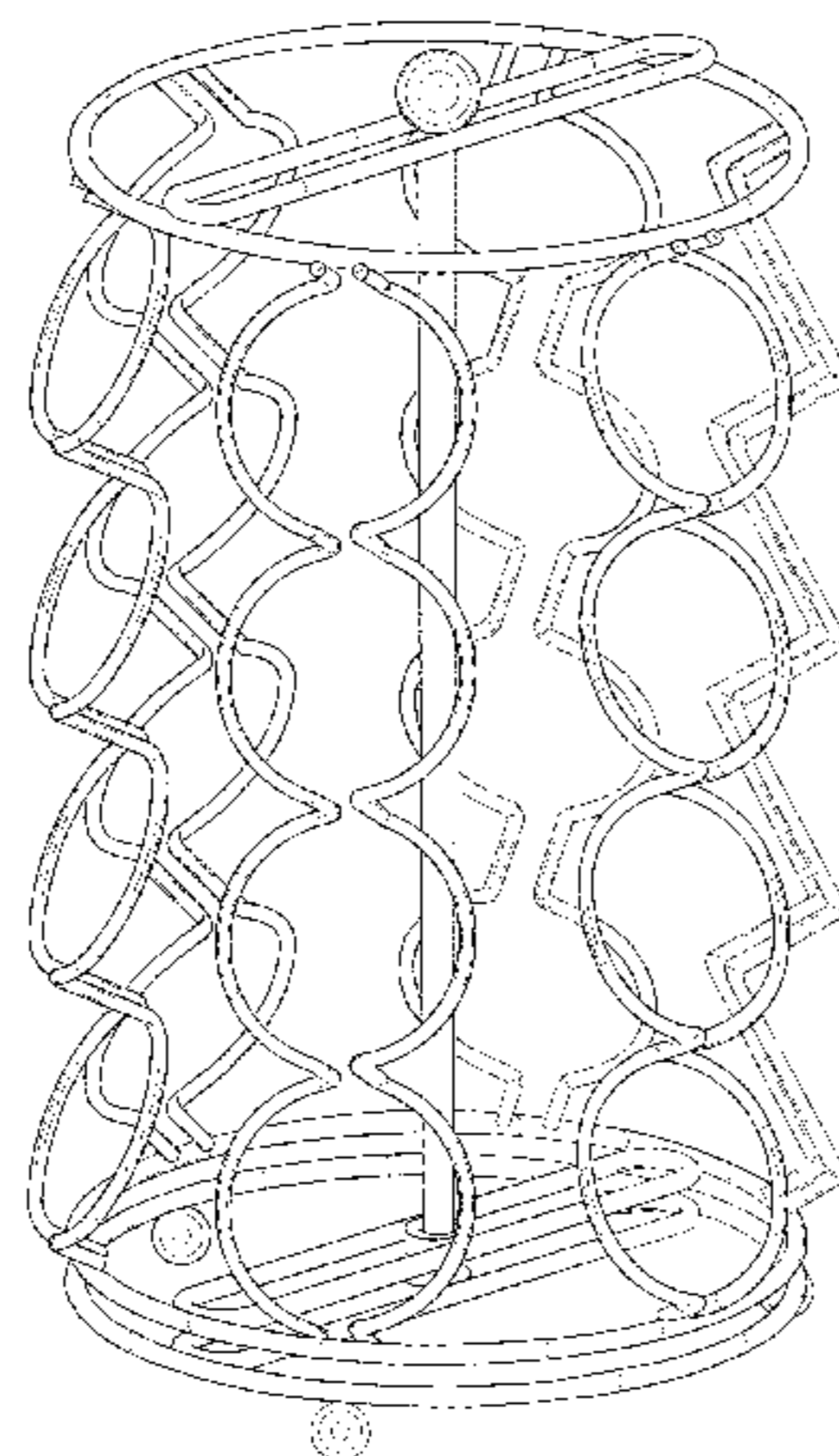
(57) **CLAIM**

The ornamental design for a coffee pod carousel, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a coffee pod carousel showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a right elevational view thereof;  
FIG. 5 is a left side elevational view thereof;

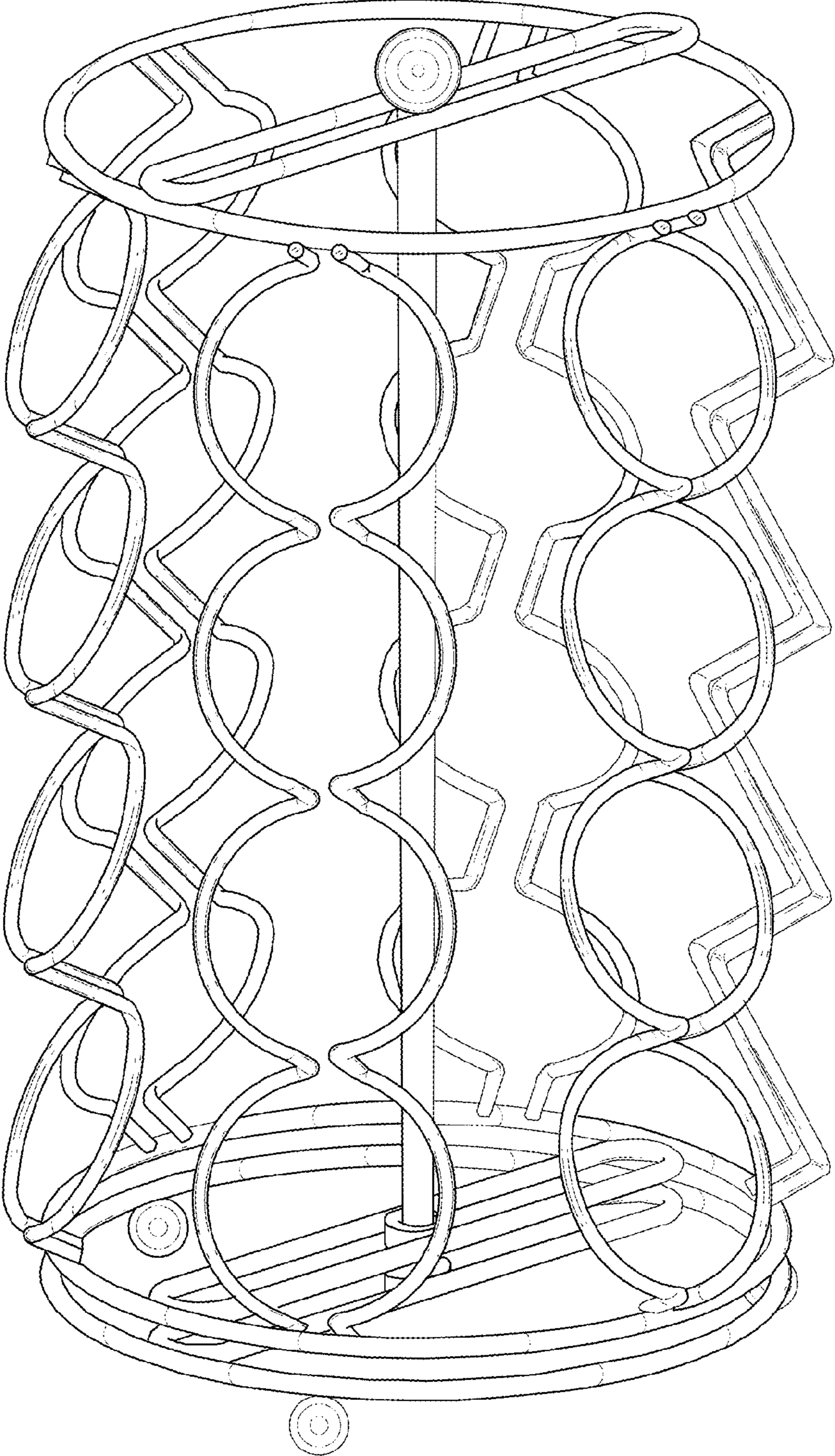

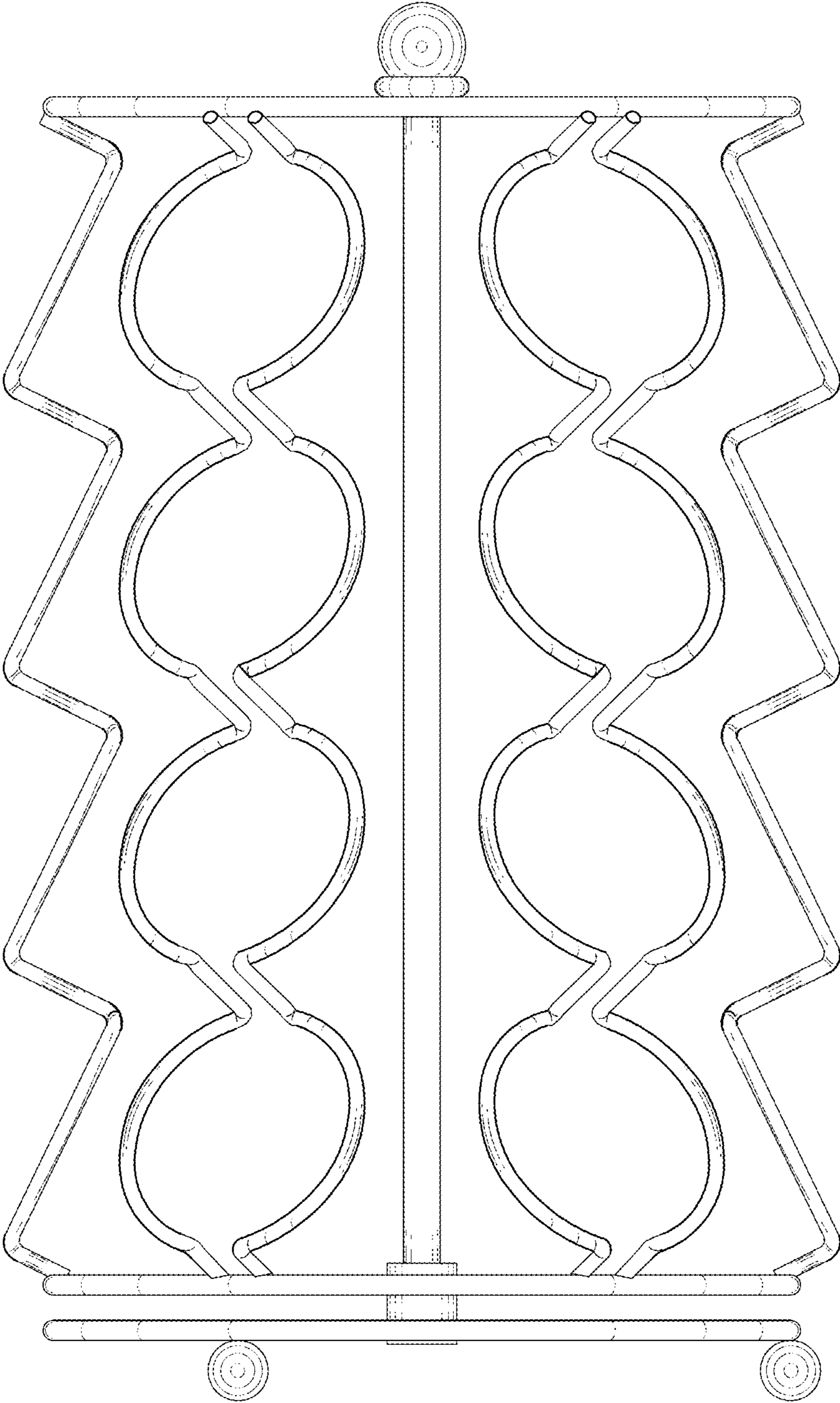

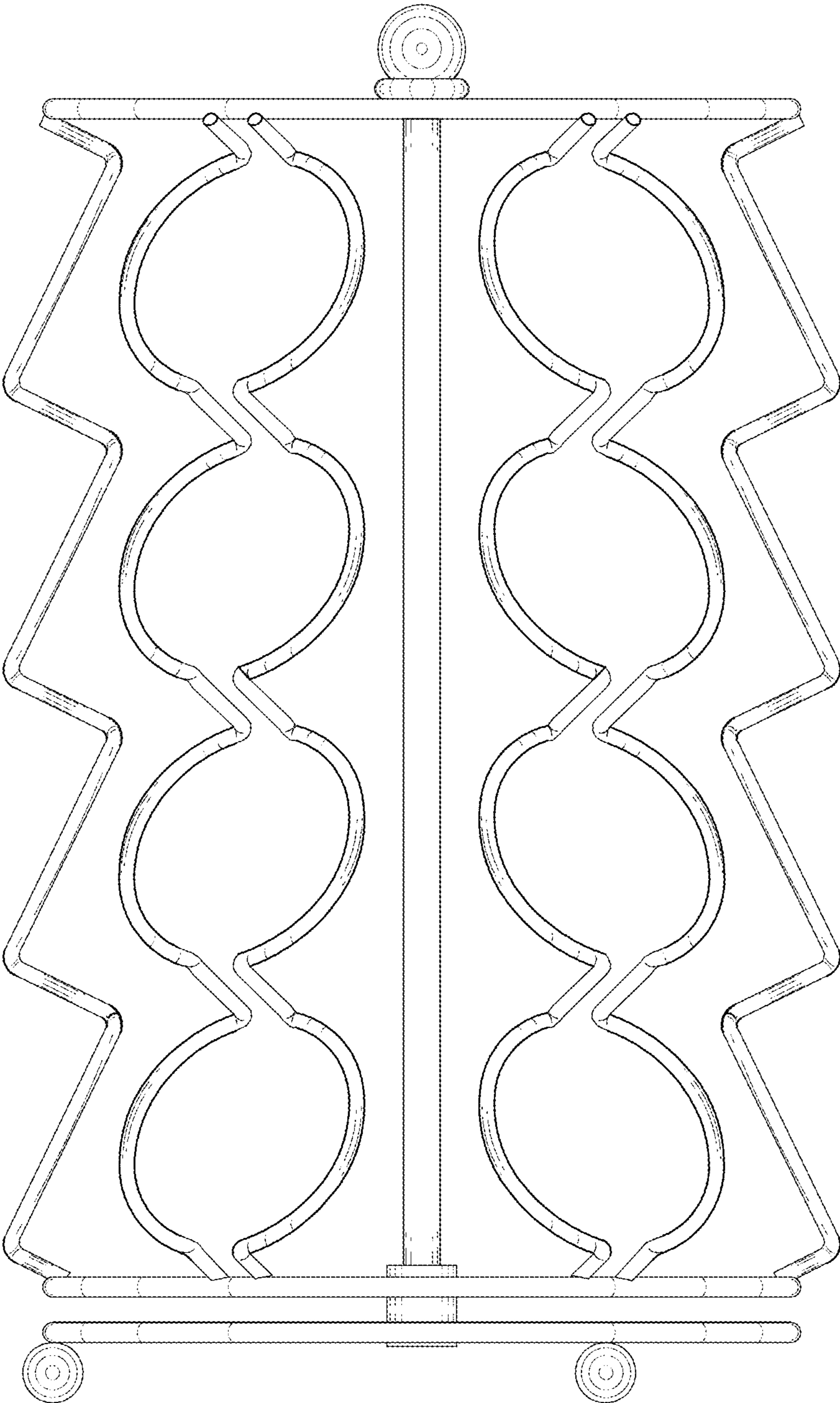

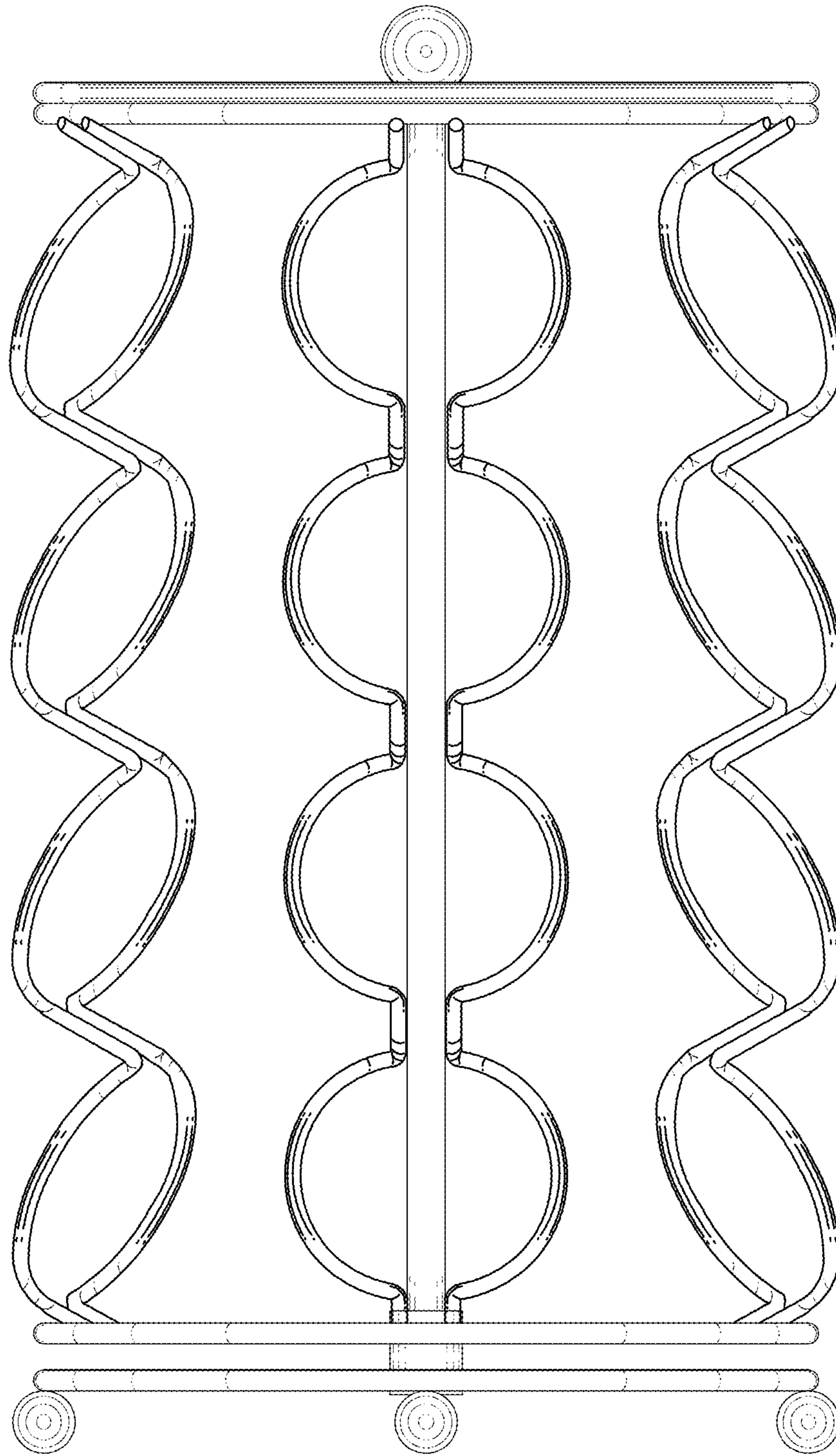

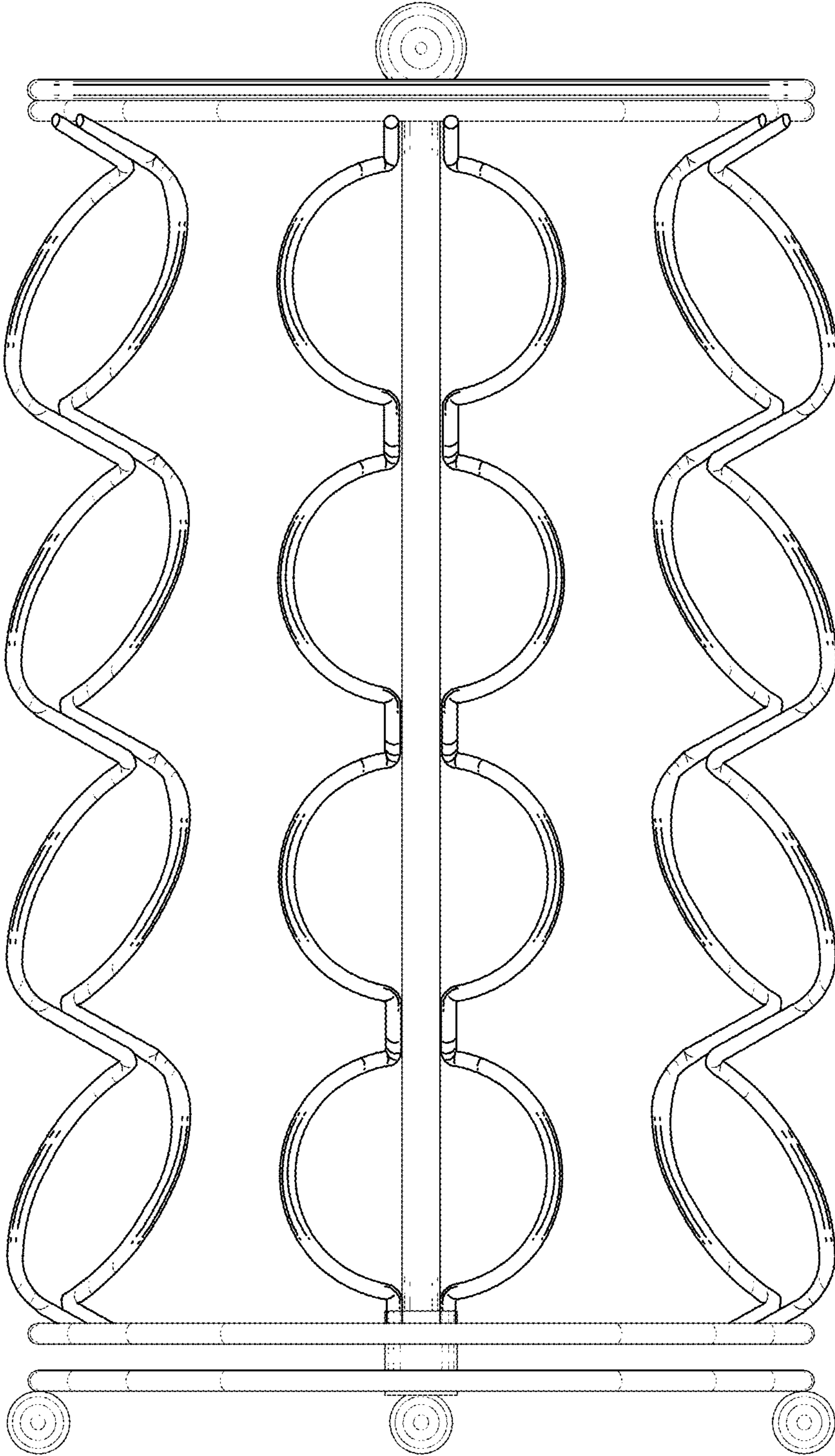

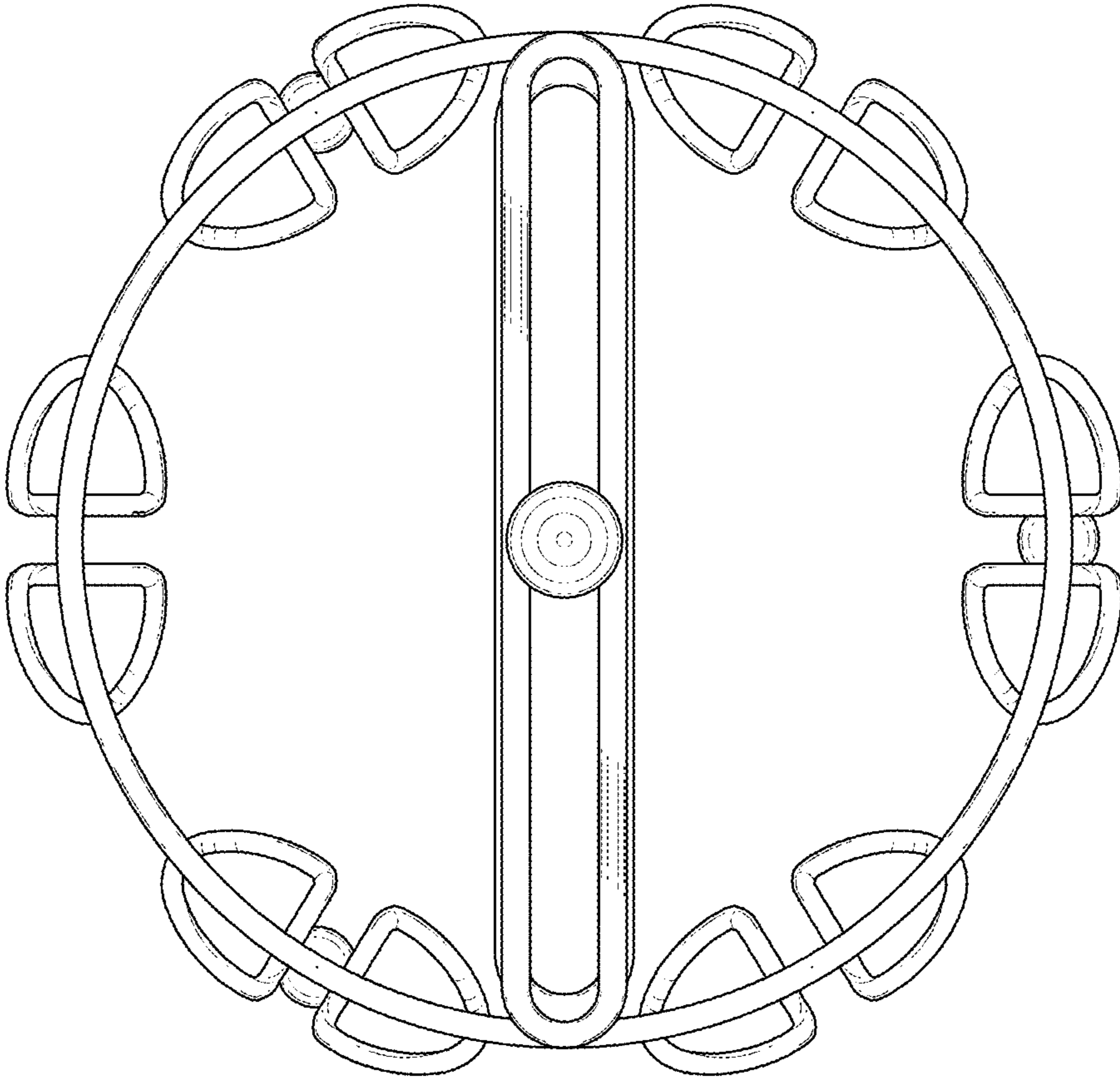

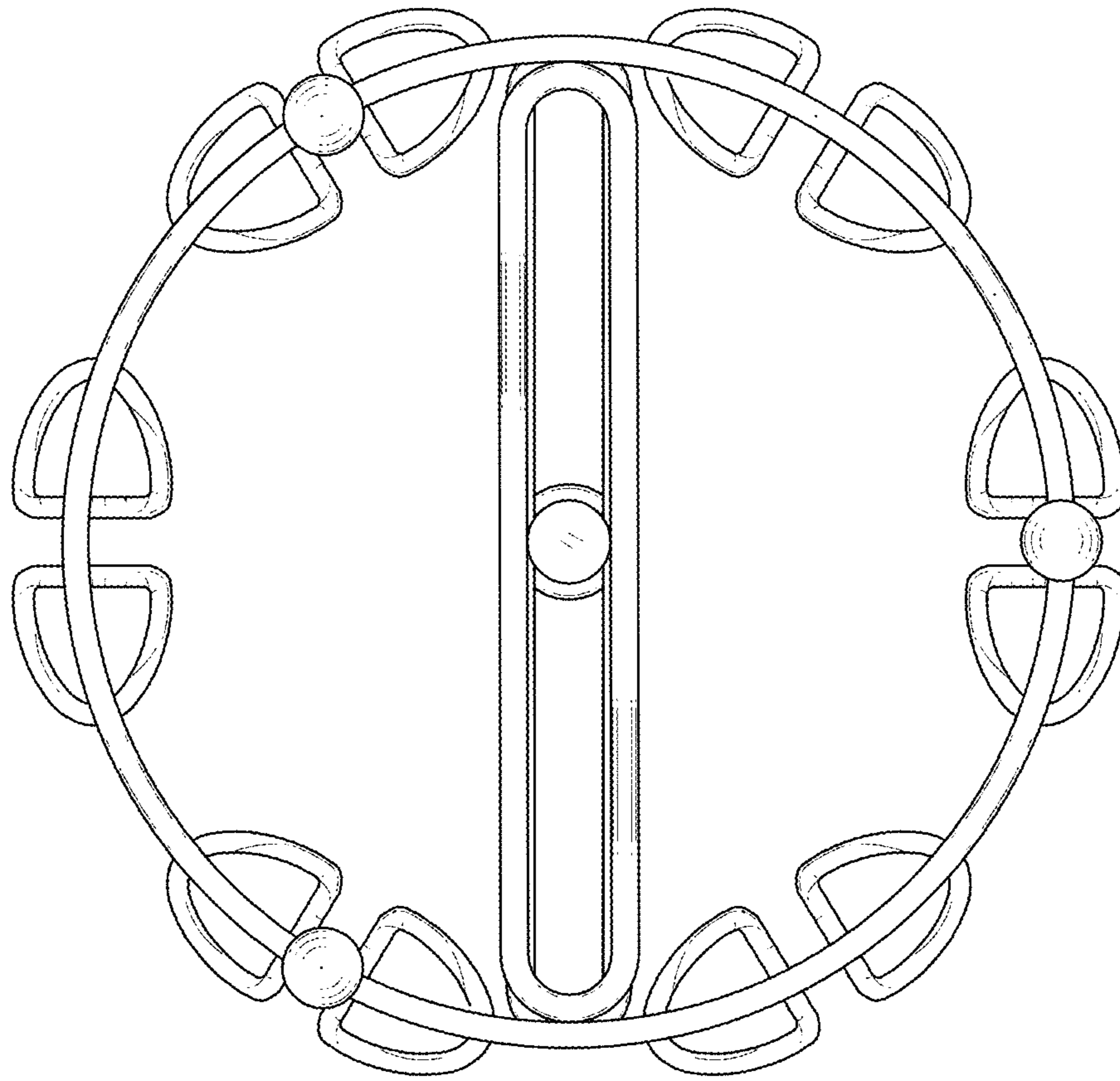

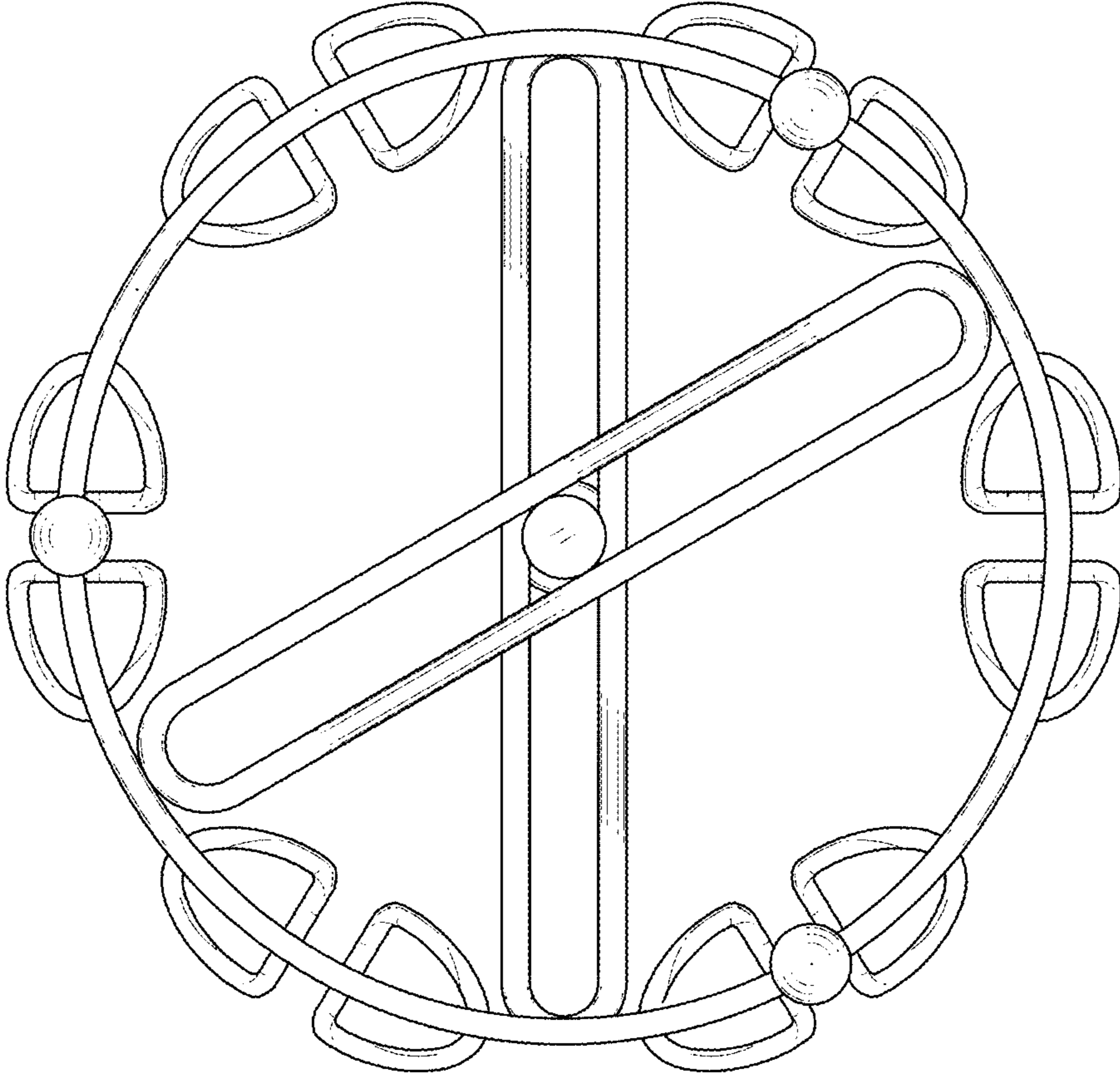

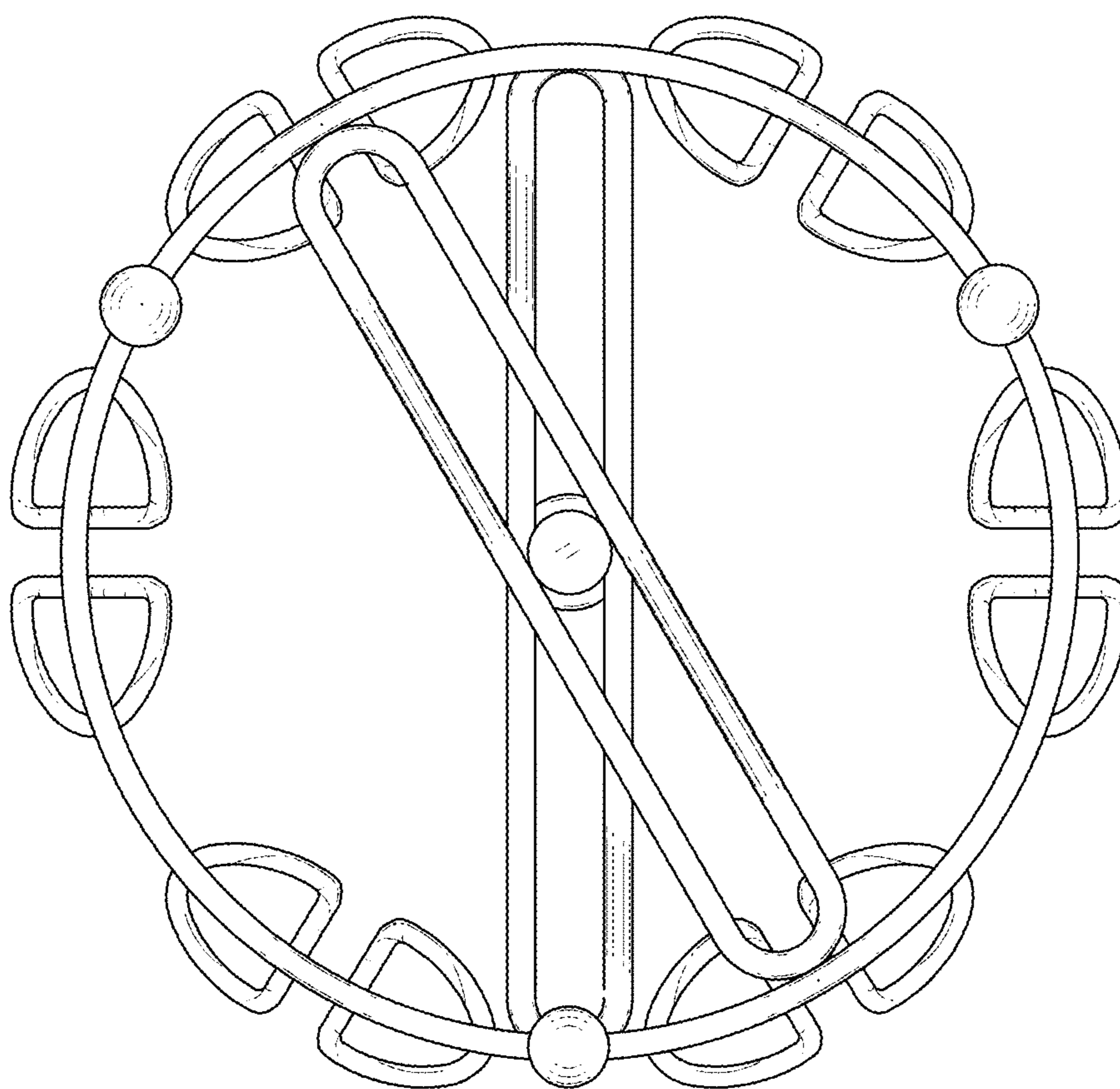
