FIG. 8 is a cross-sectional view of the hinge for building through line 8-8 shown in FIG. 2; and

FIG. 9 is a cross-sectional view of the hinge for building through line 9-9 shown in FIG. 2.

FIG. 10 is a cross-sectional view of the hinge for building through line 10-10 shown in FIG. 2;

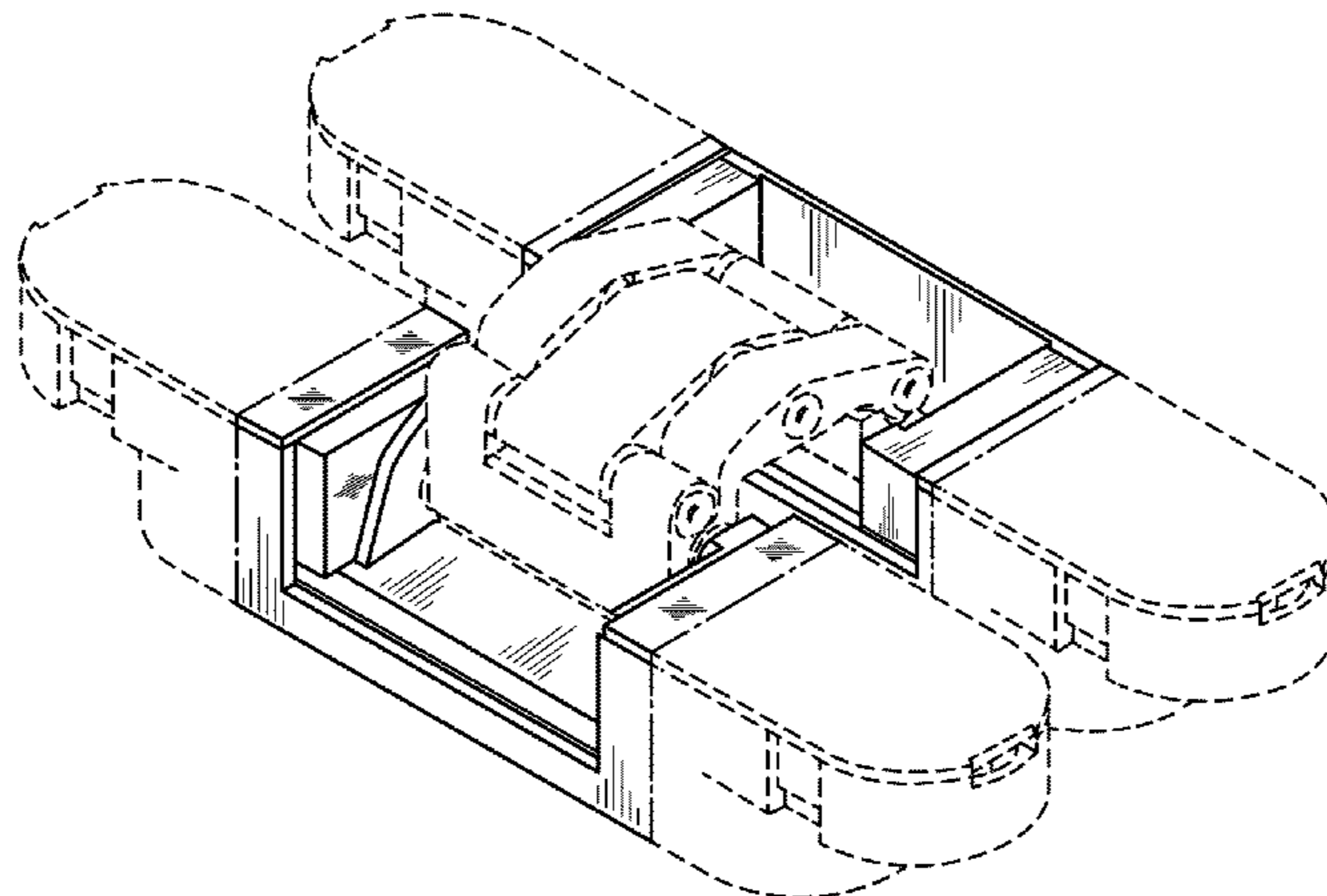
FIG. 11 is a cross-sectional view of the hinge for building through line 11-11 shown in FIG. 2; and,

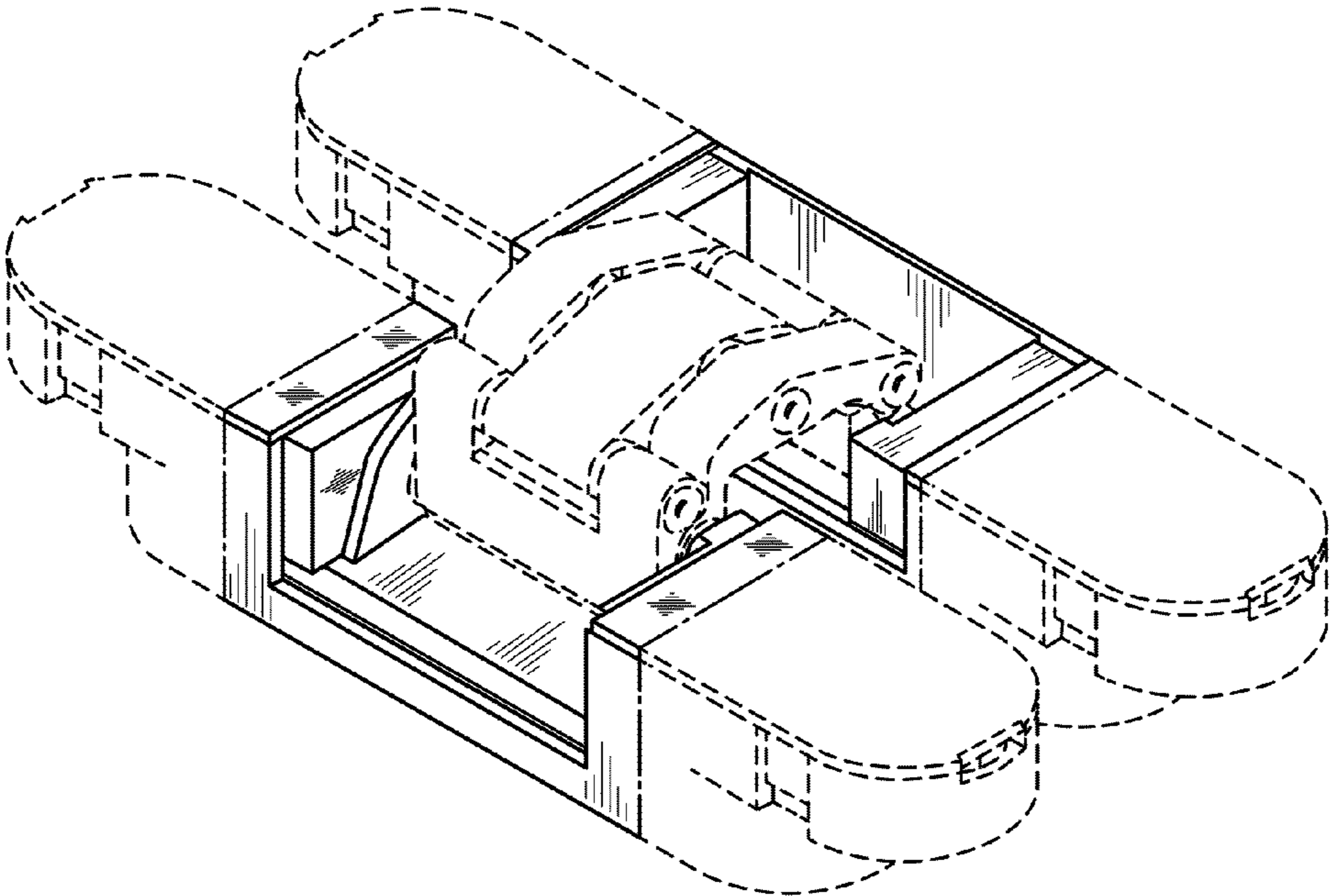

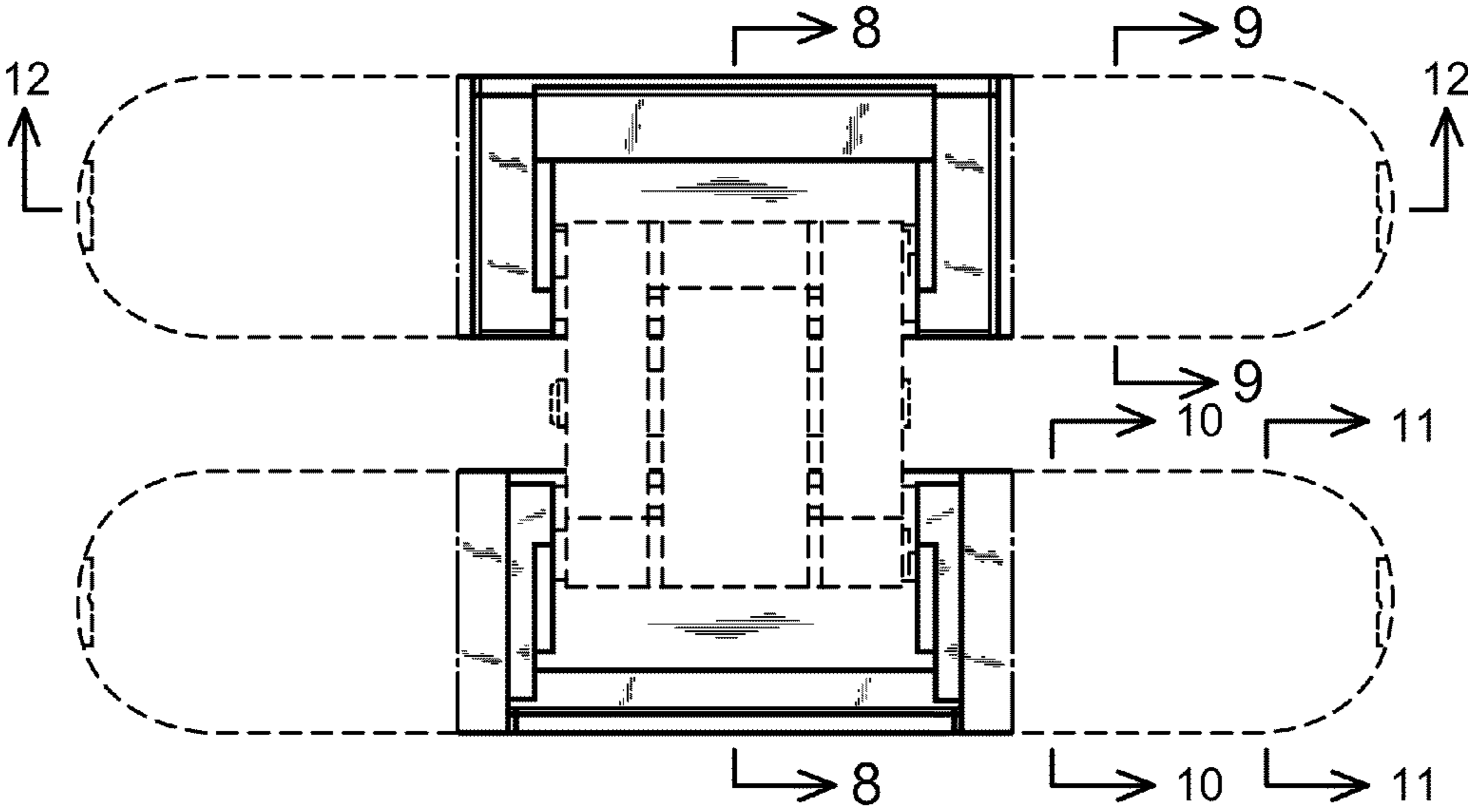

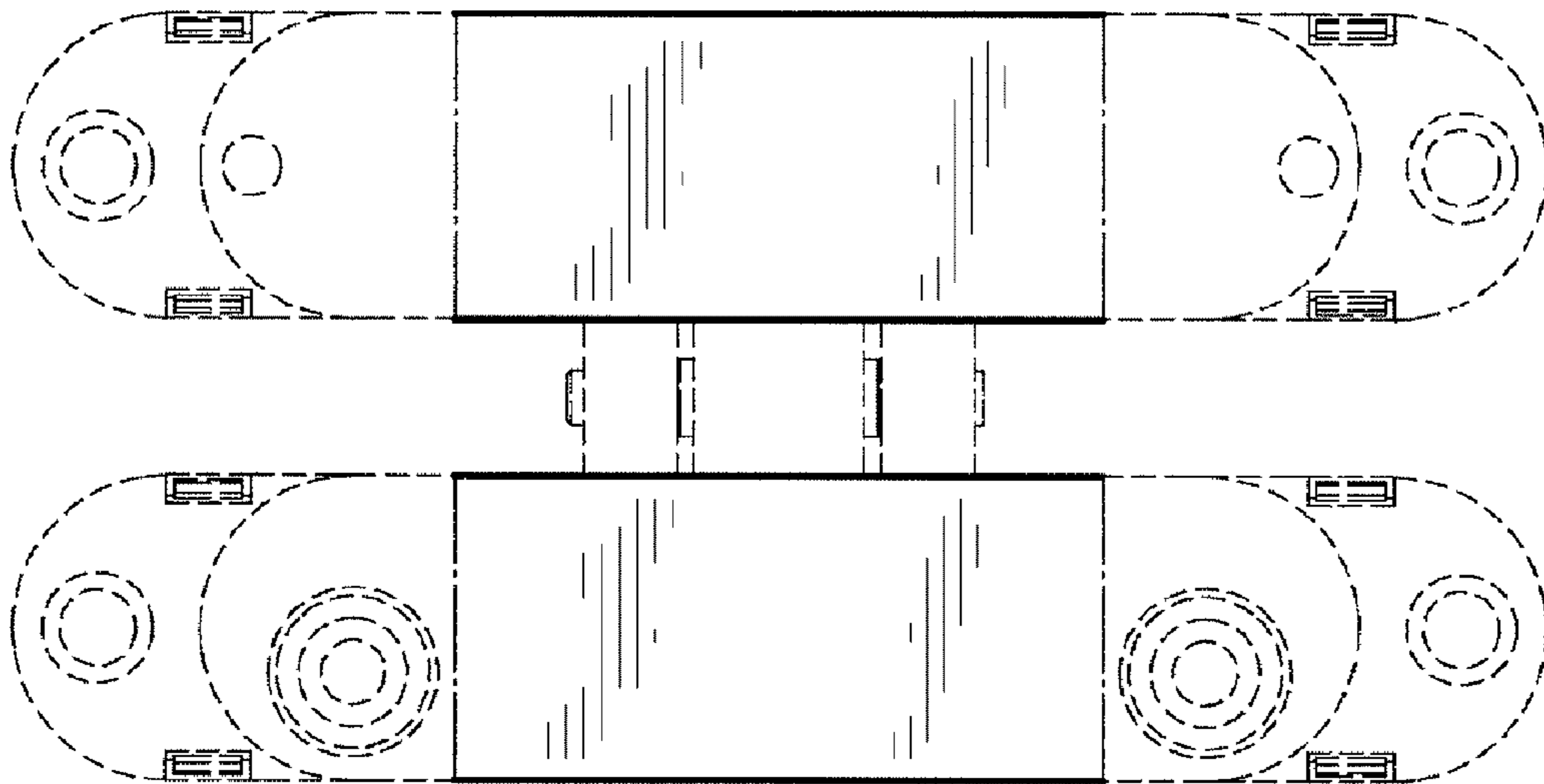

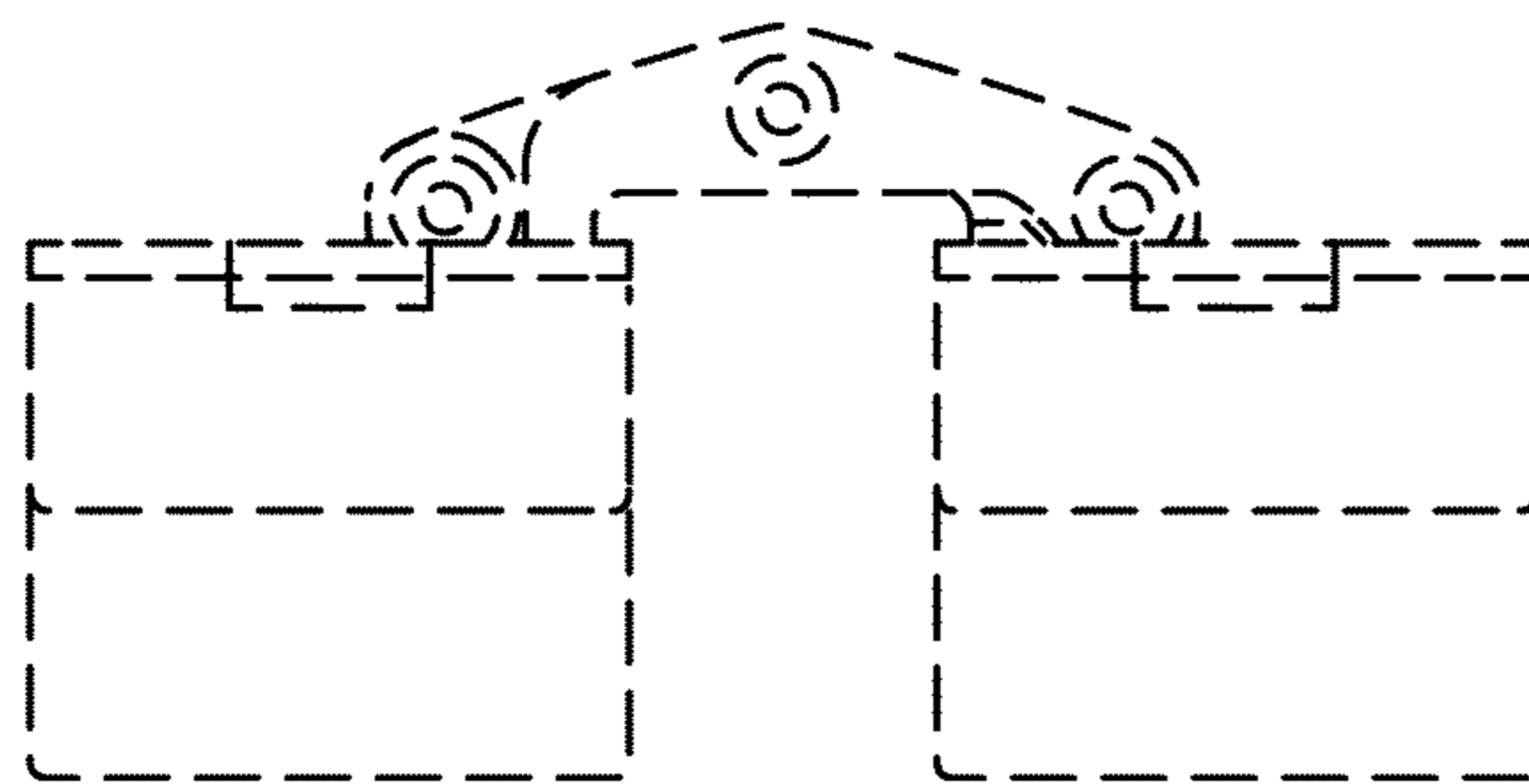

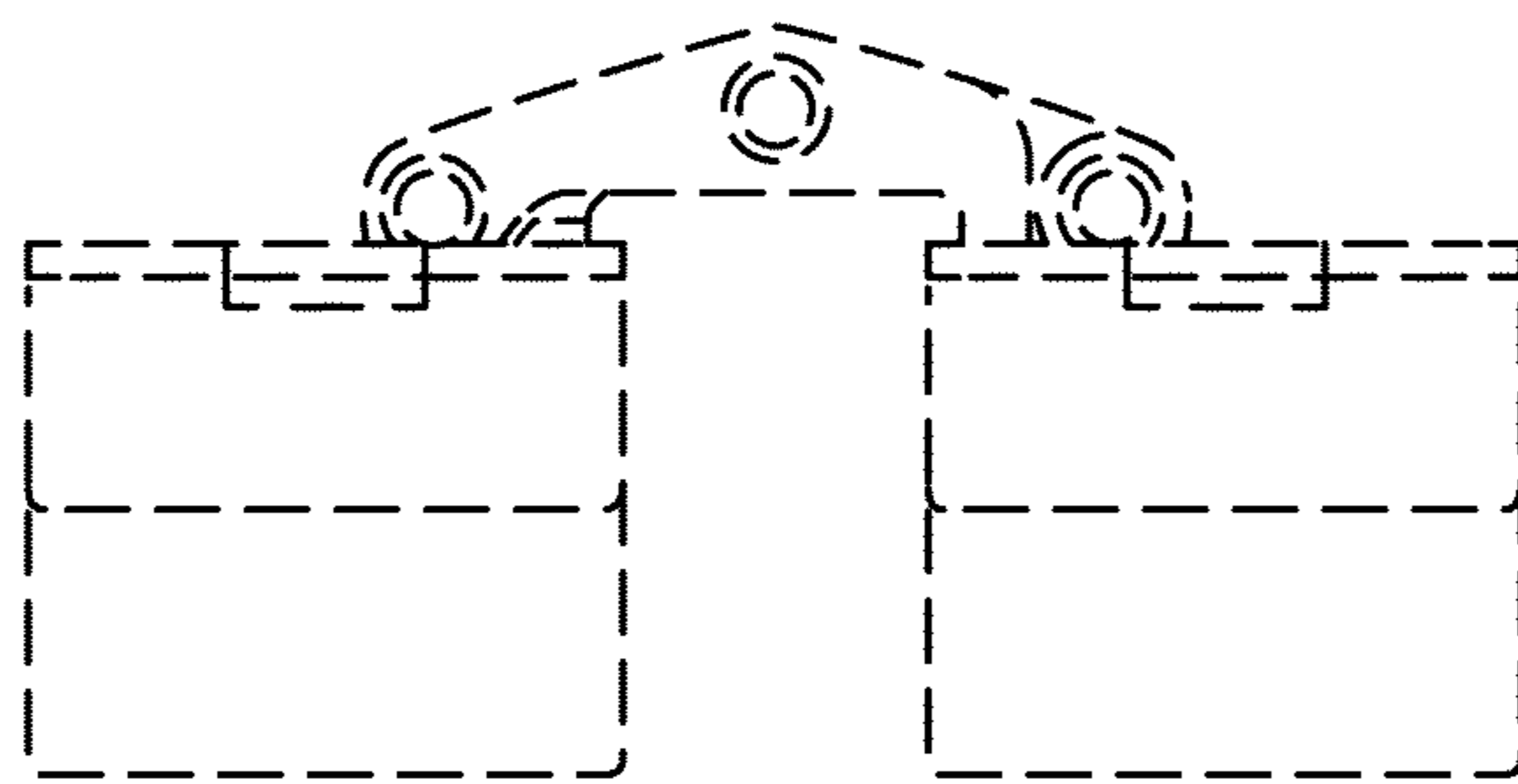

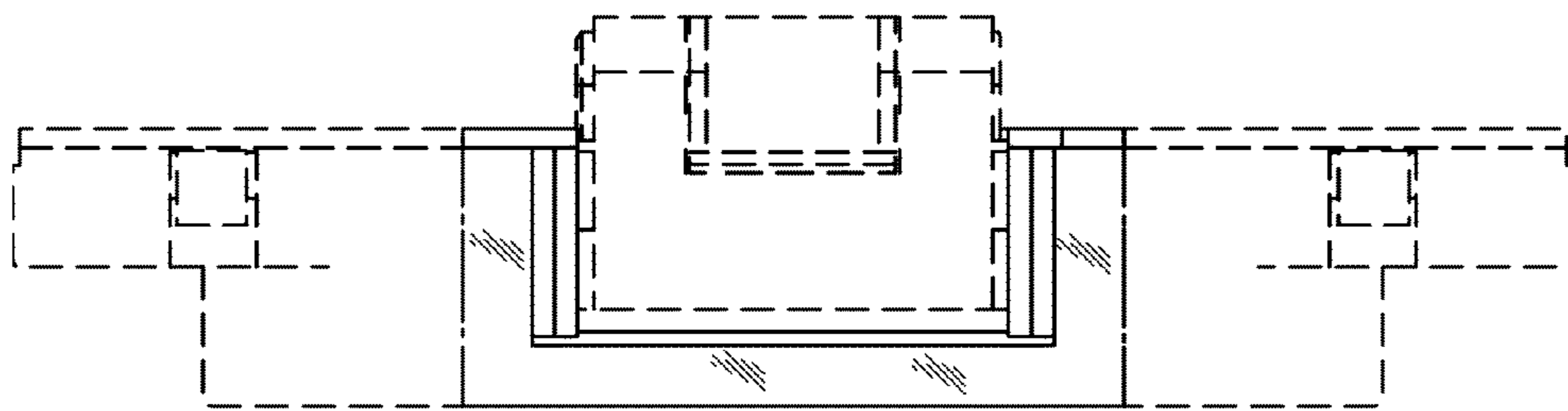

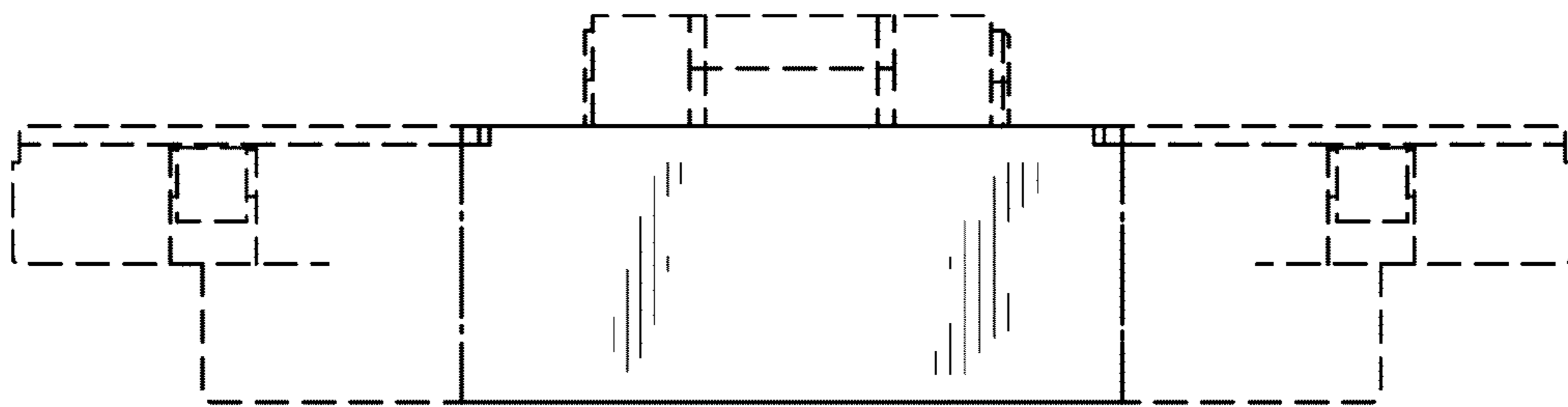

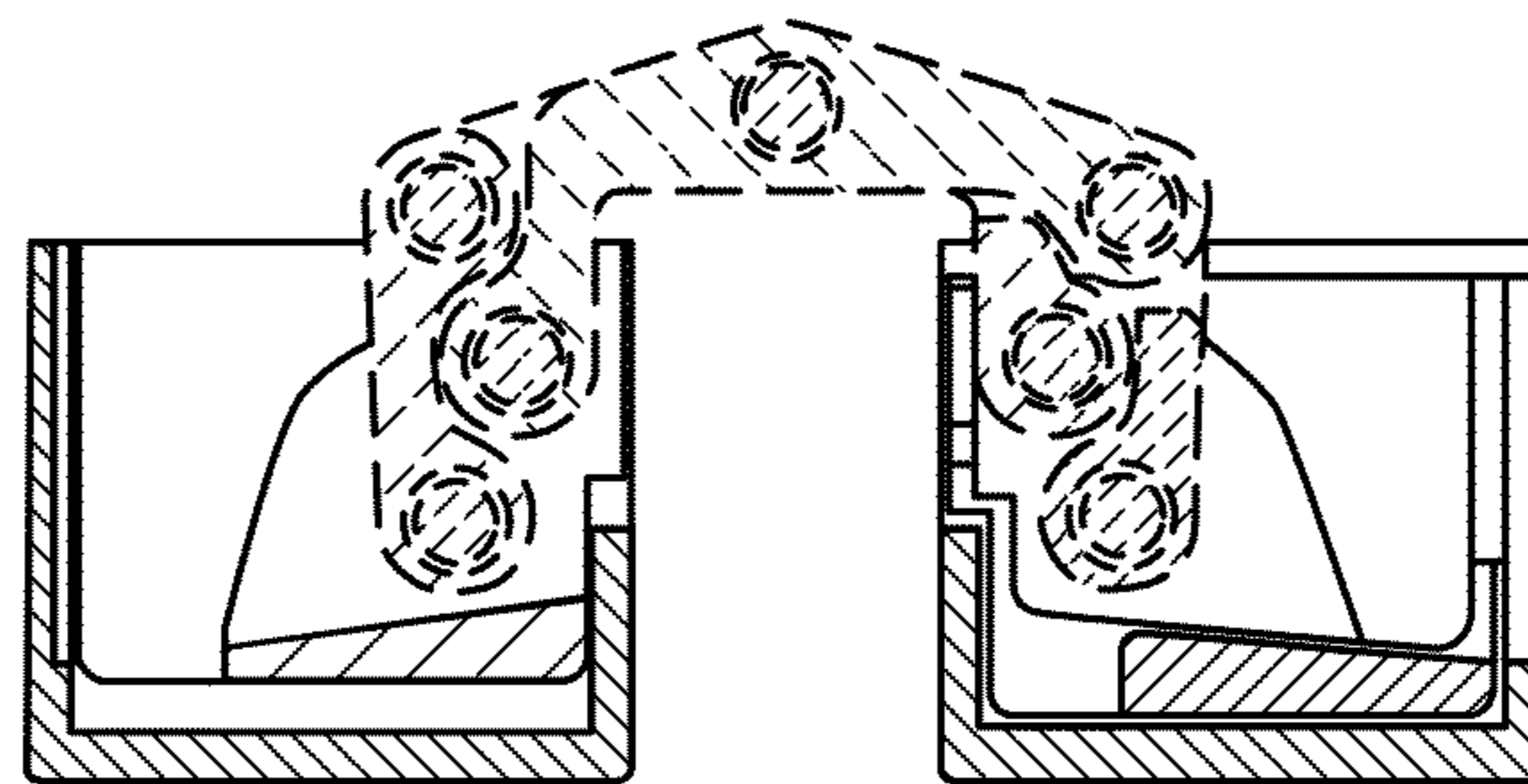

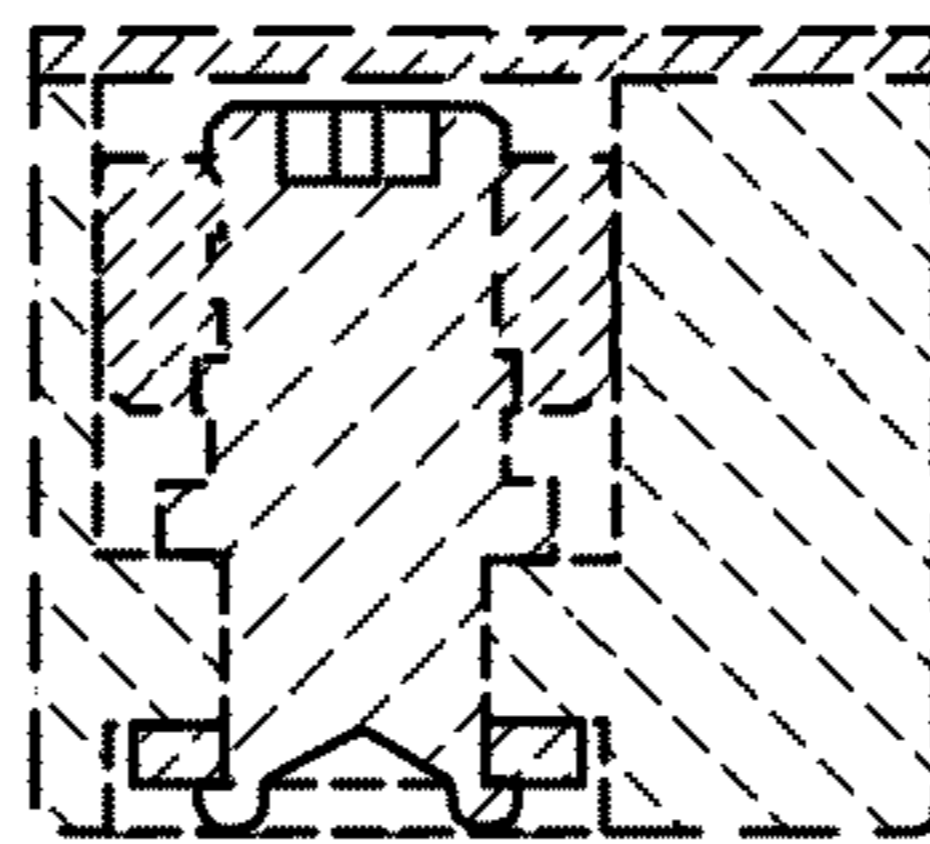

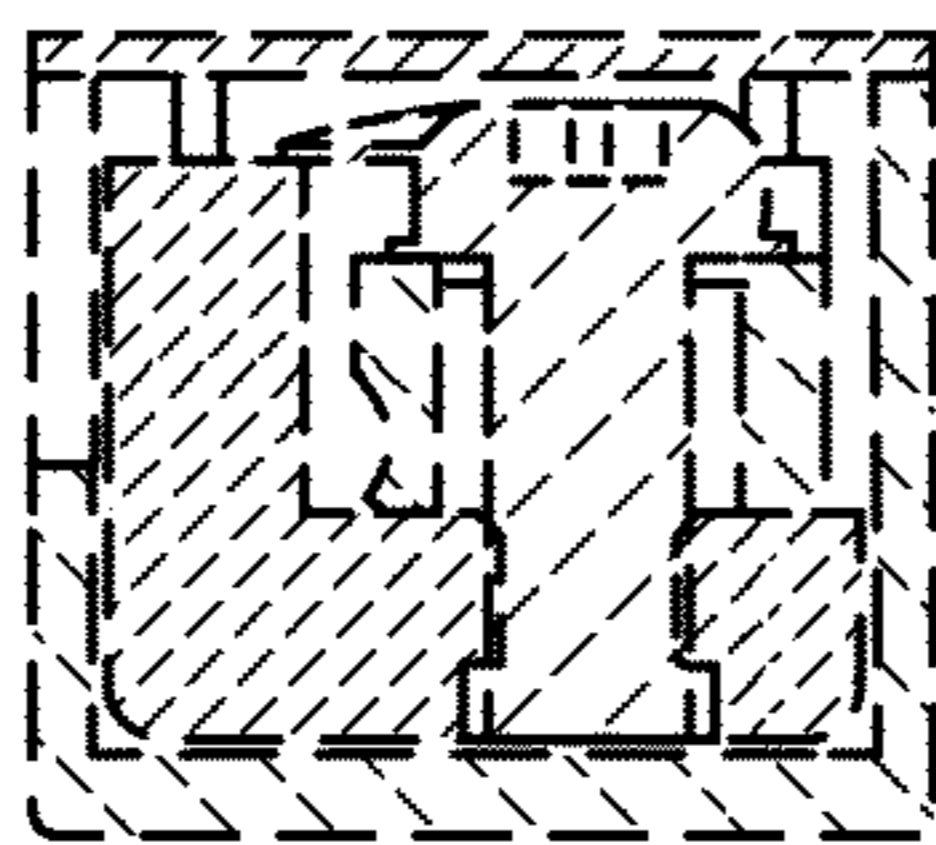

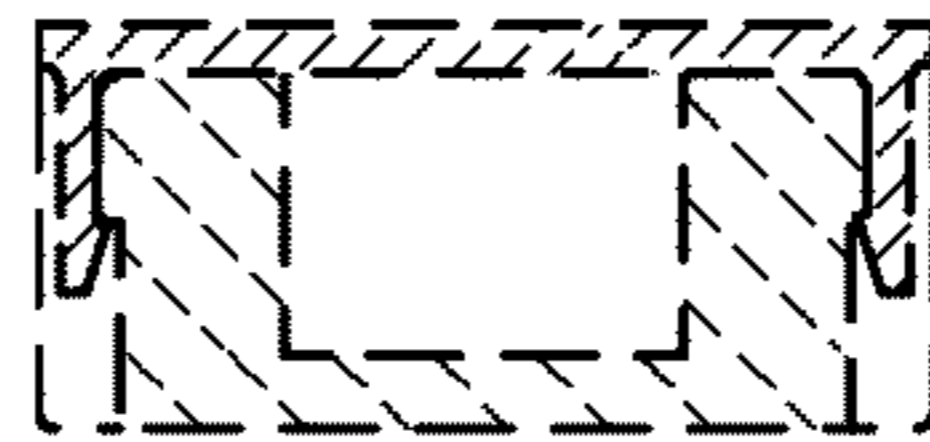
