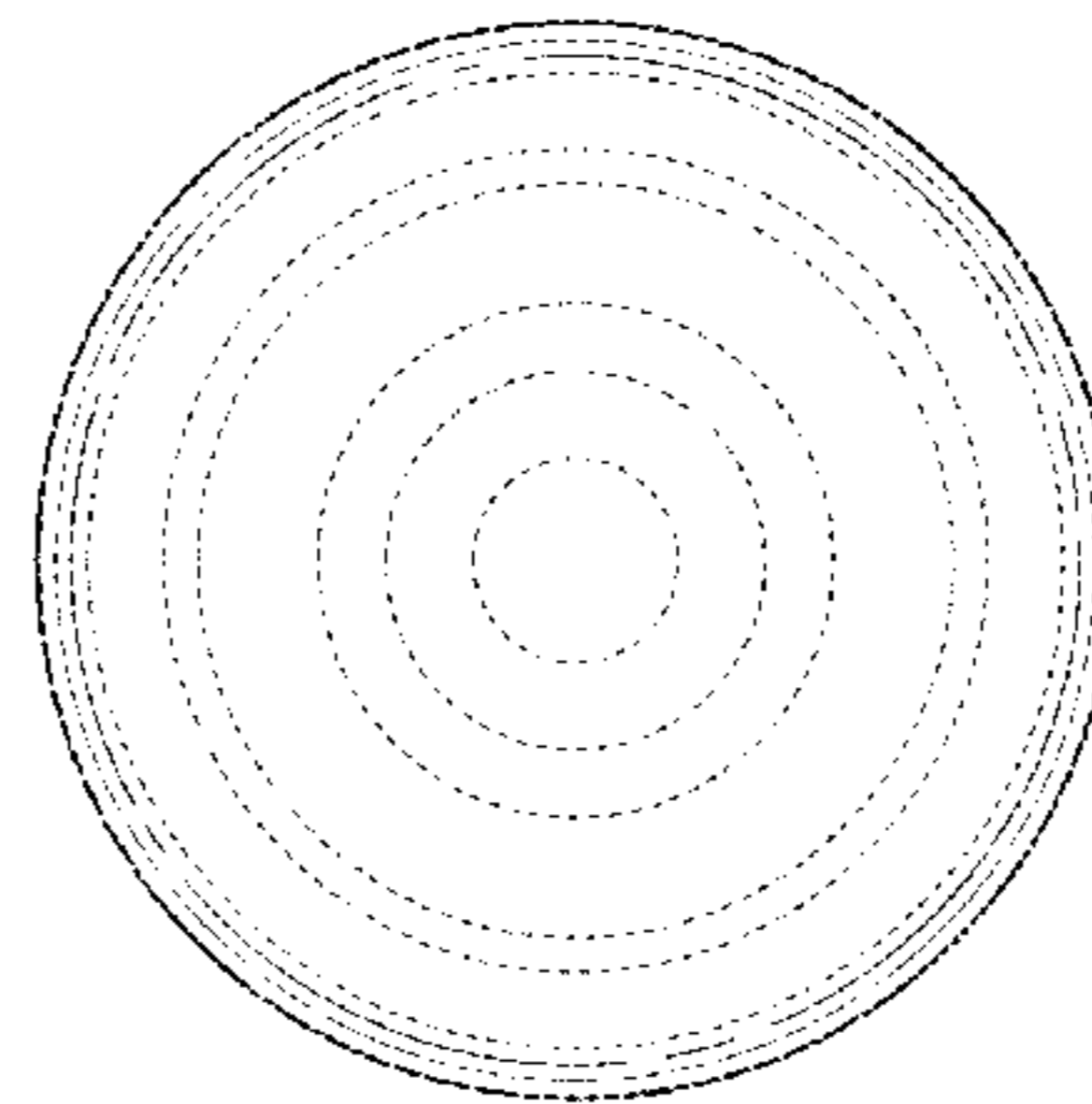
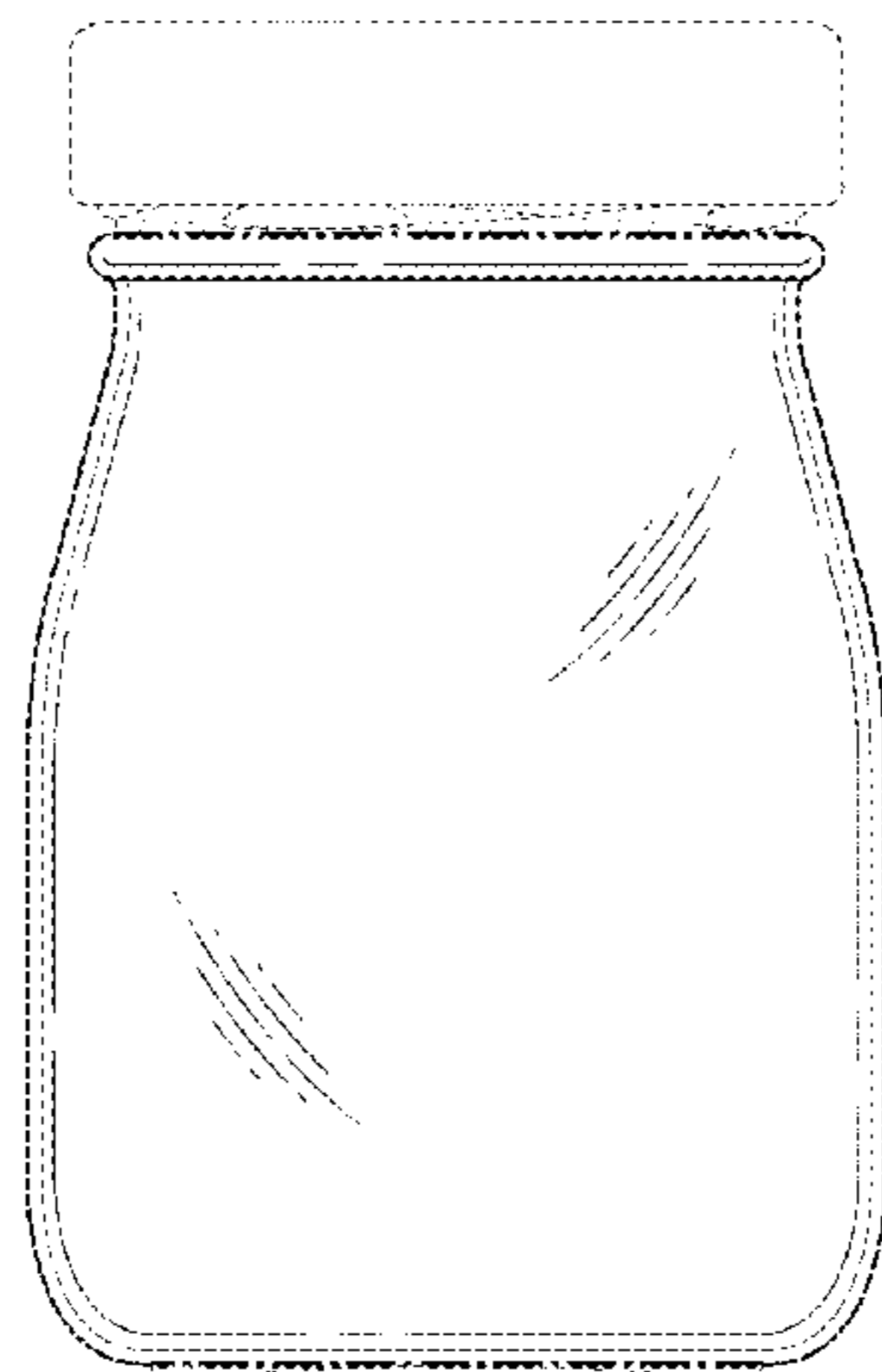
(57) **CLAIM**

The ornamental design for a jar, as shown and described.

DESCRIPTION

FIG. 1 is a front, perspective view of a jar showing a first
embodiment of our new design;
FIG. 2 is a front view thereof, the rear view being identical to
the front view;
FIG. 3 is a right side view thereof, the left side view being
identical the right side view;
FIG. 4 is a top view thereof; and,
FIG. 5 is a bottom view thereof.
The evenly-dashed broken lines in the drawings illustrate the
portions of the jar that form no part of the claim. The bolded
dot-dash broken lines in the drawings define the bounds of the
claim and form no part thereof.

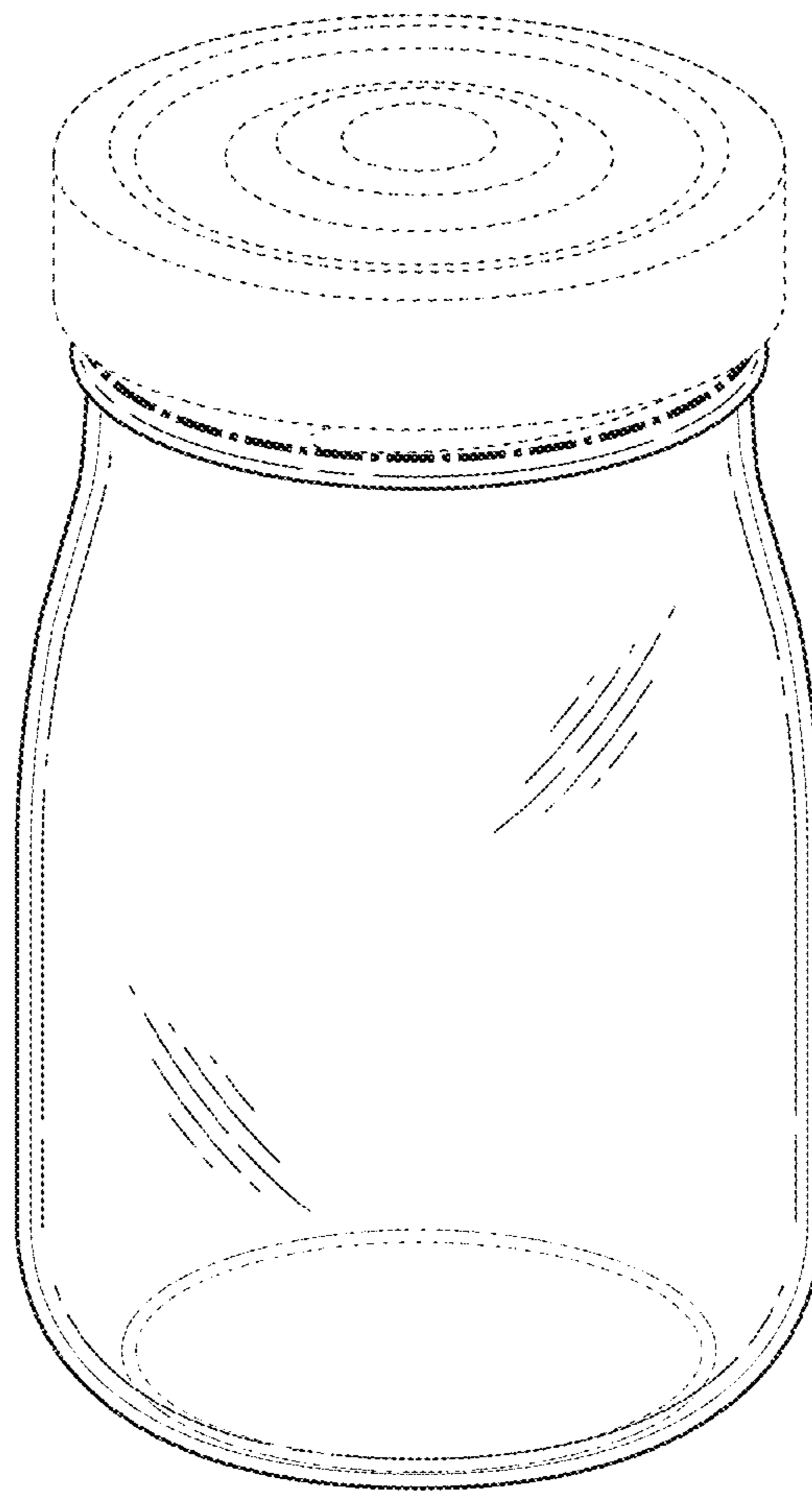

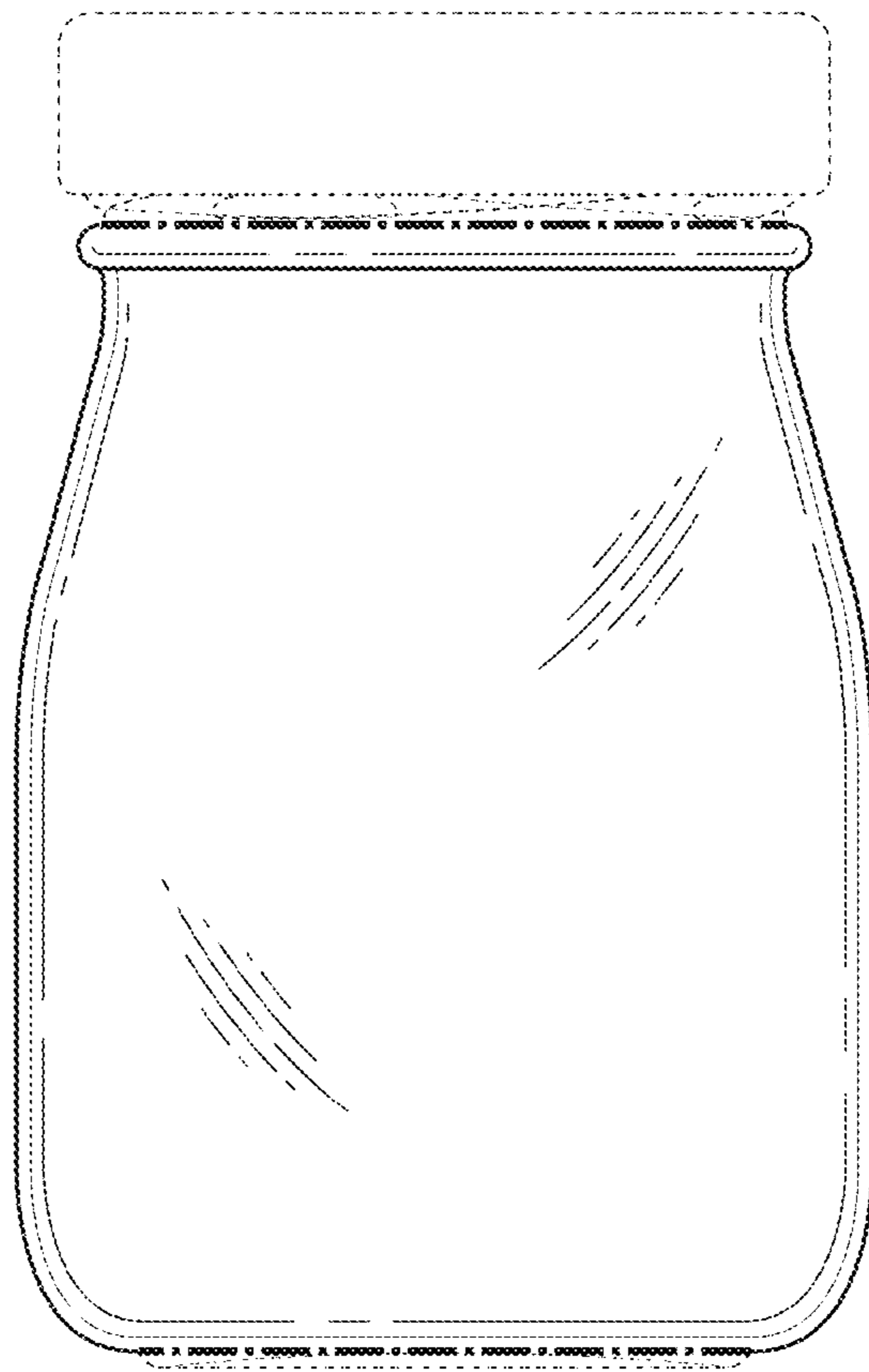

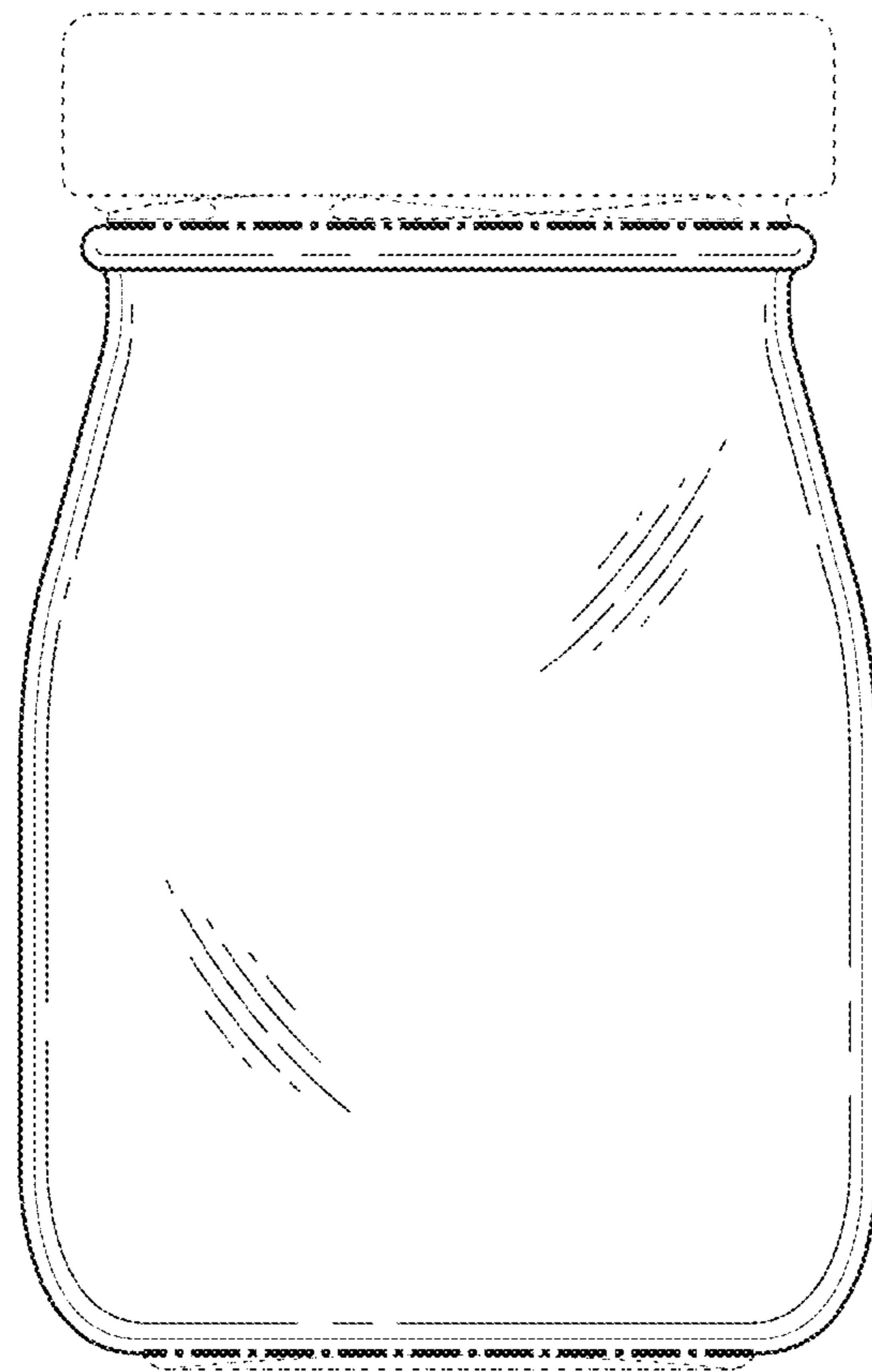

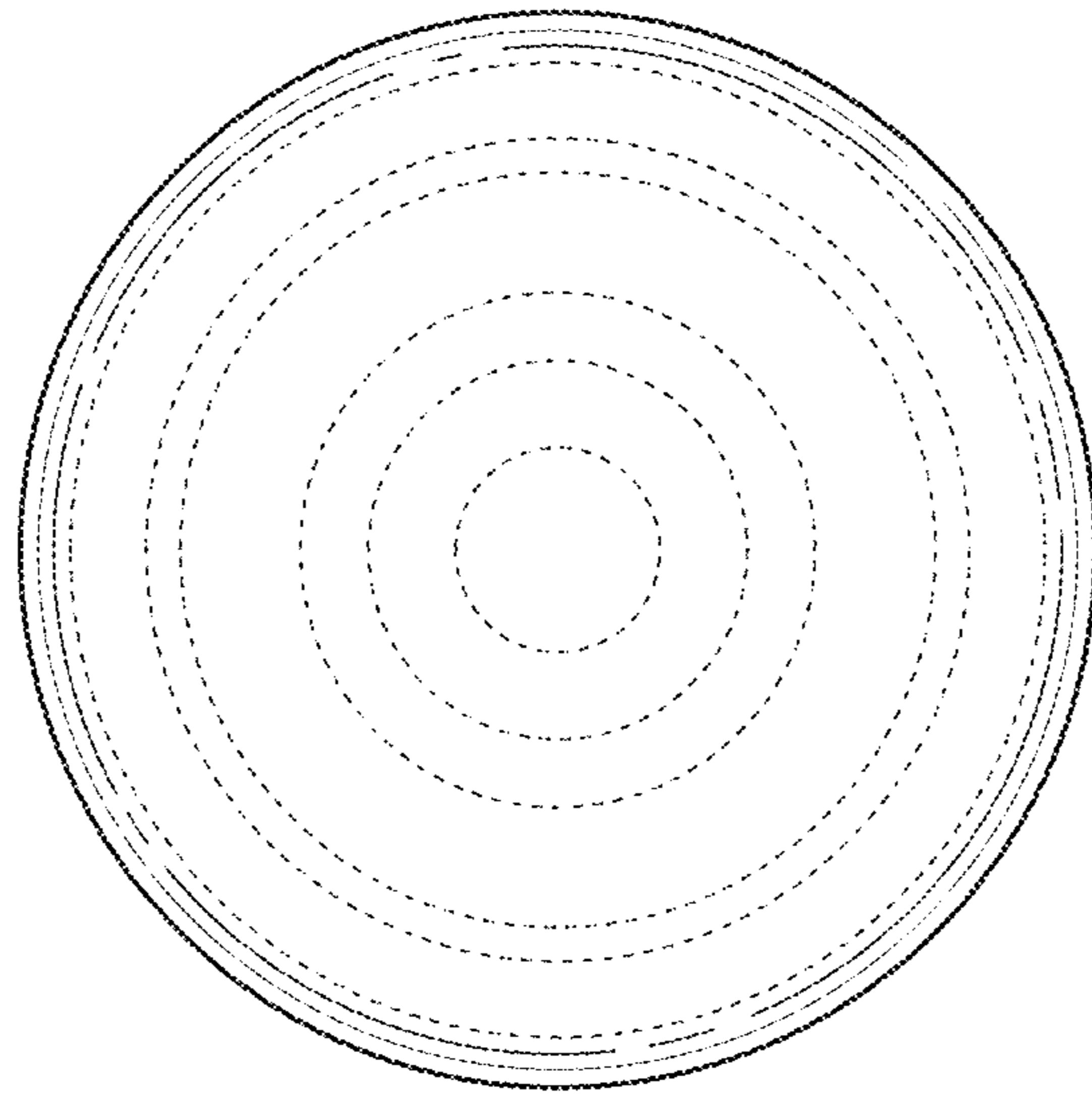

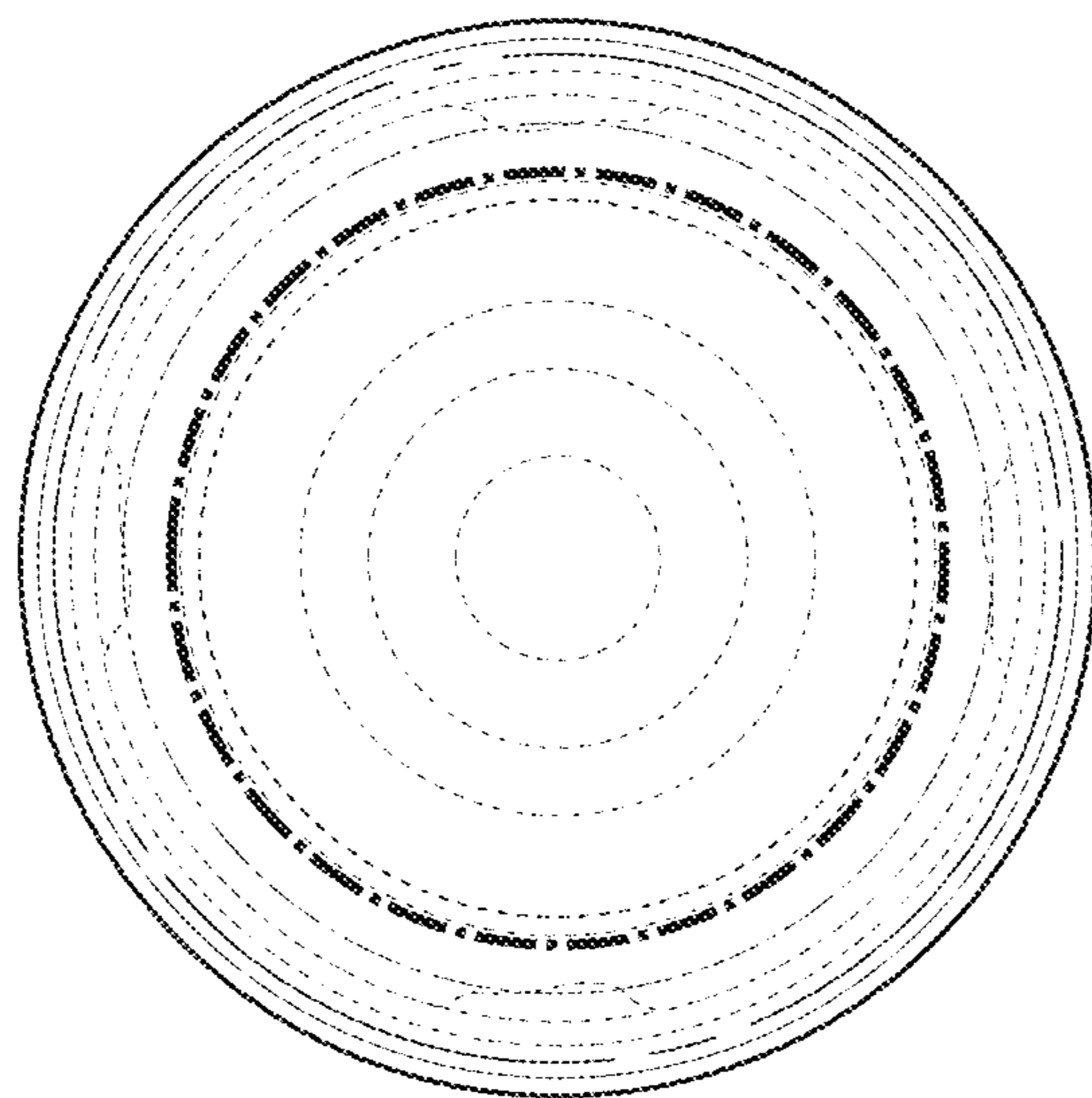
