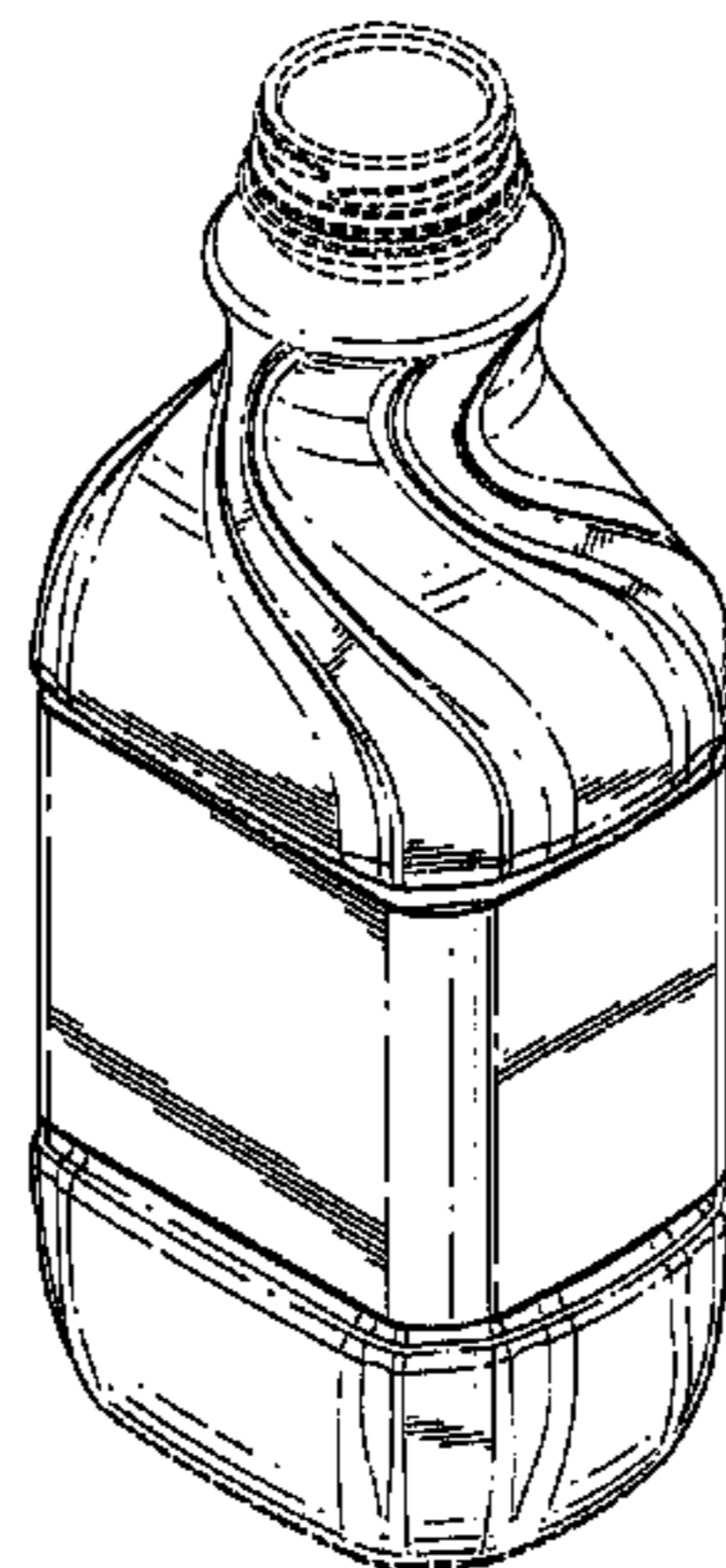
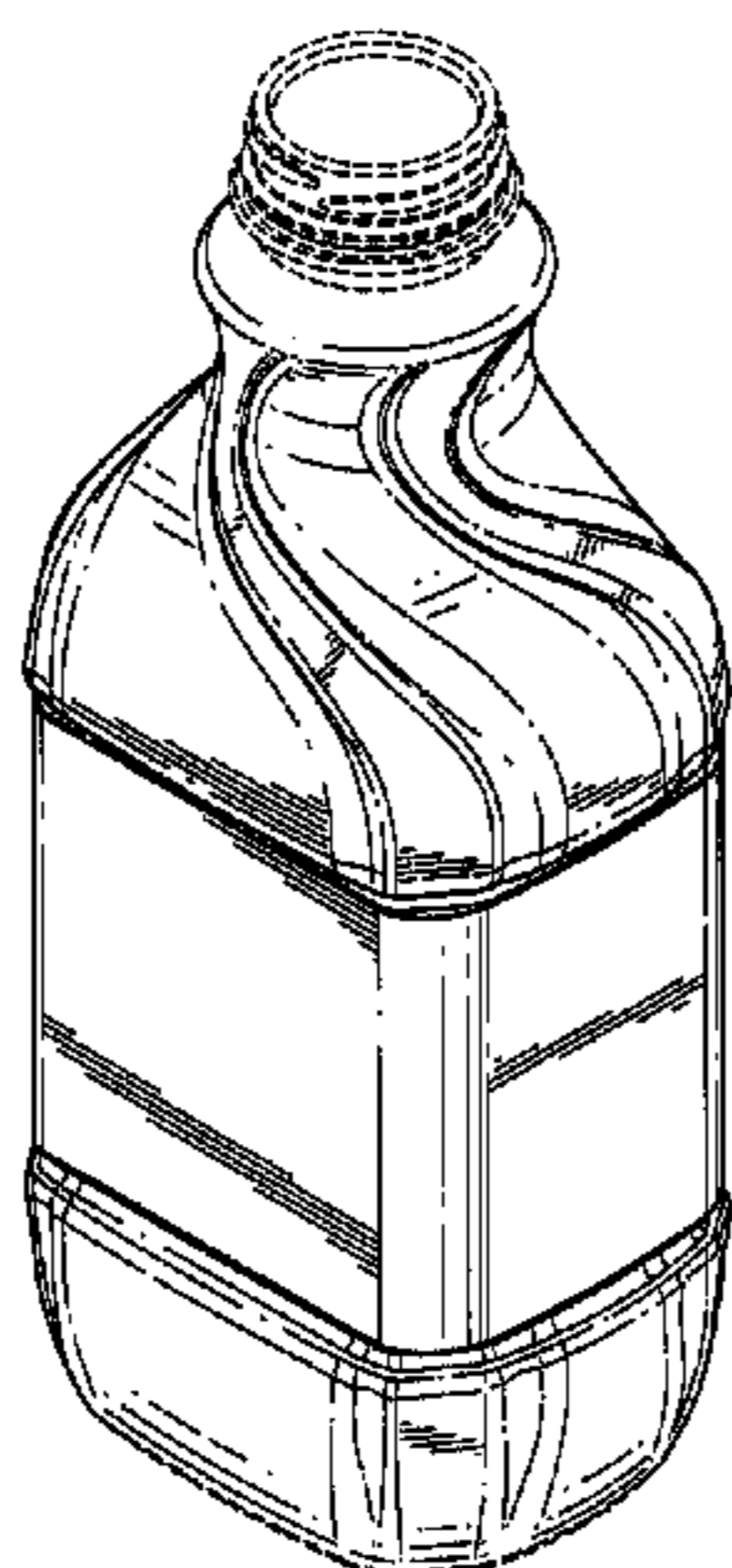

DESCRIPTION

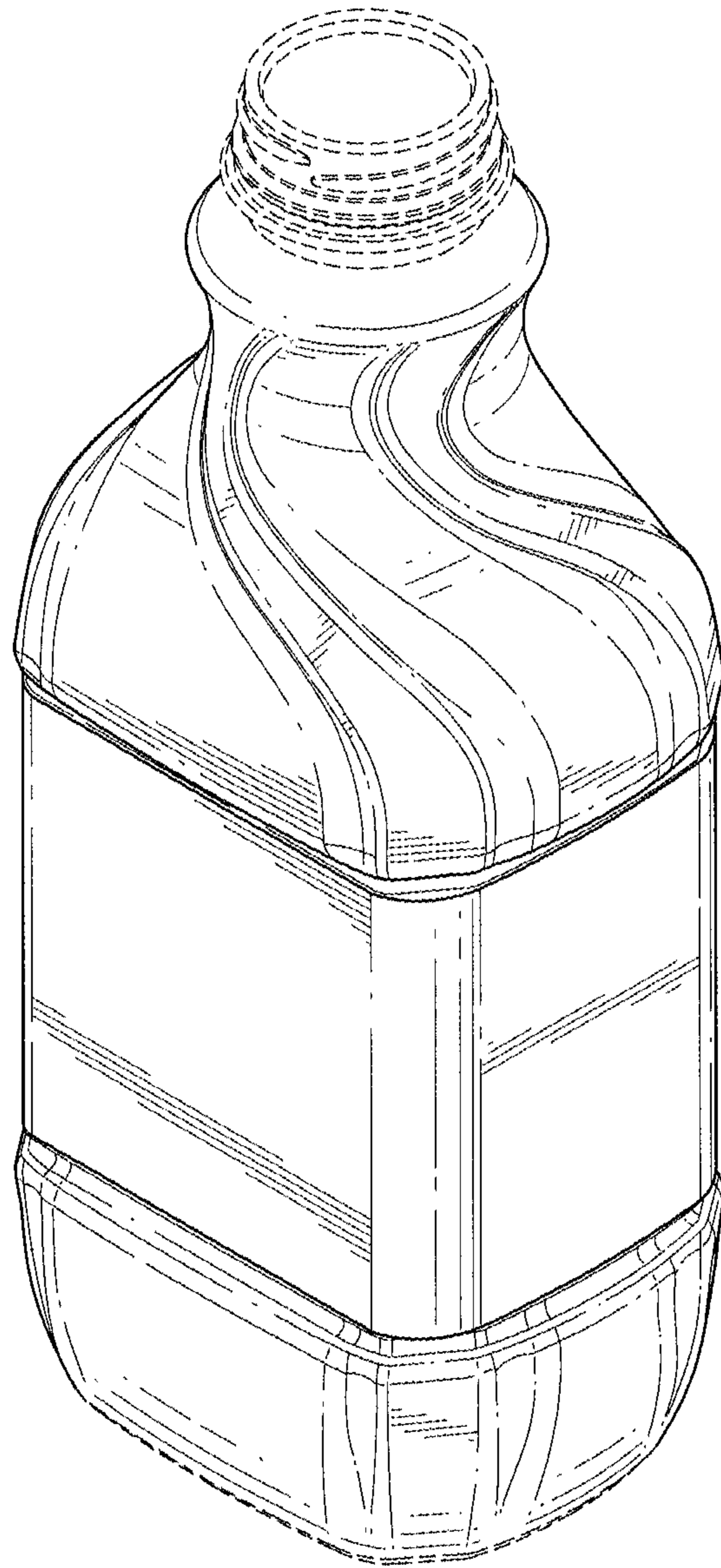

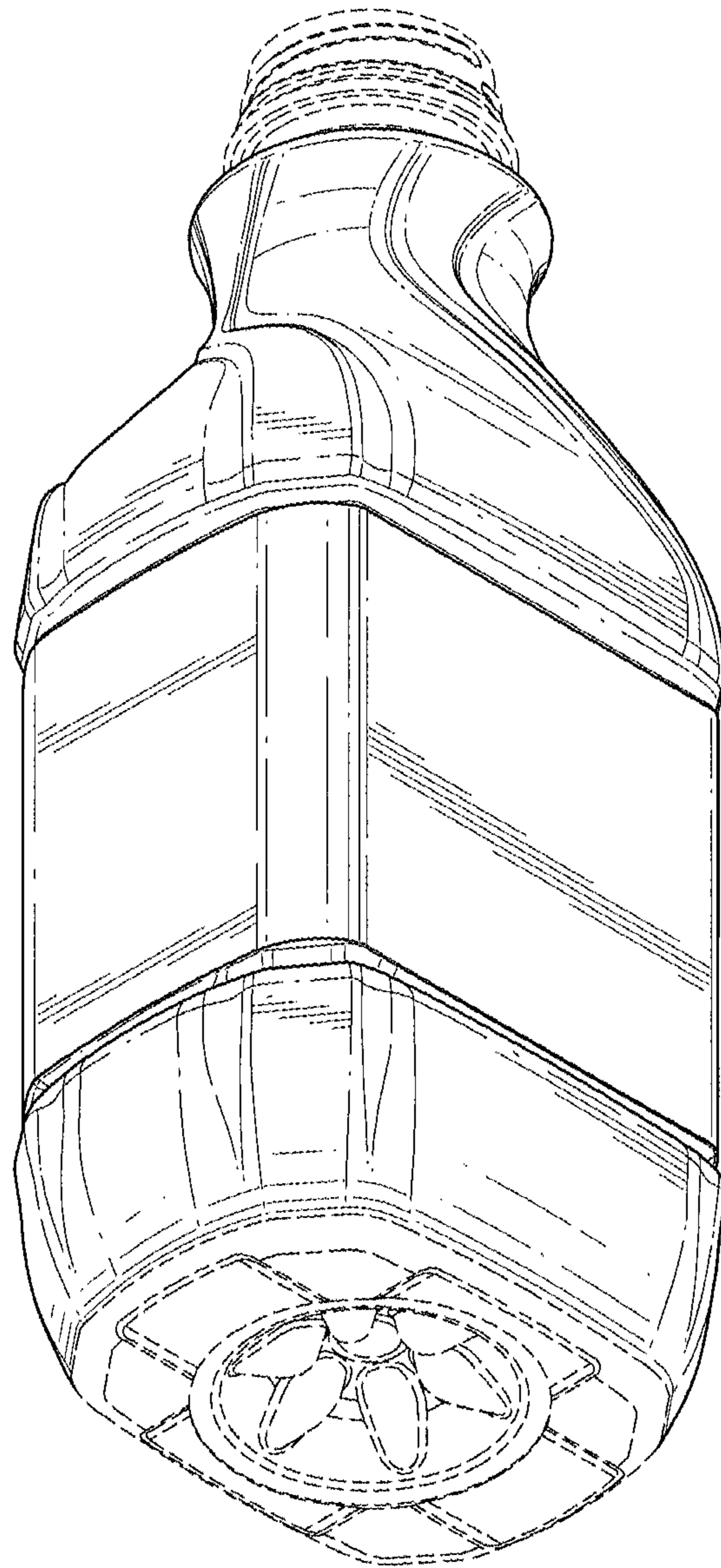

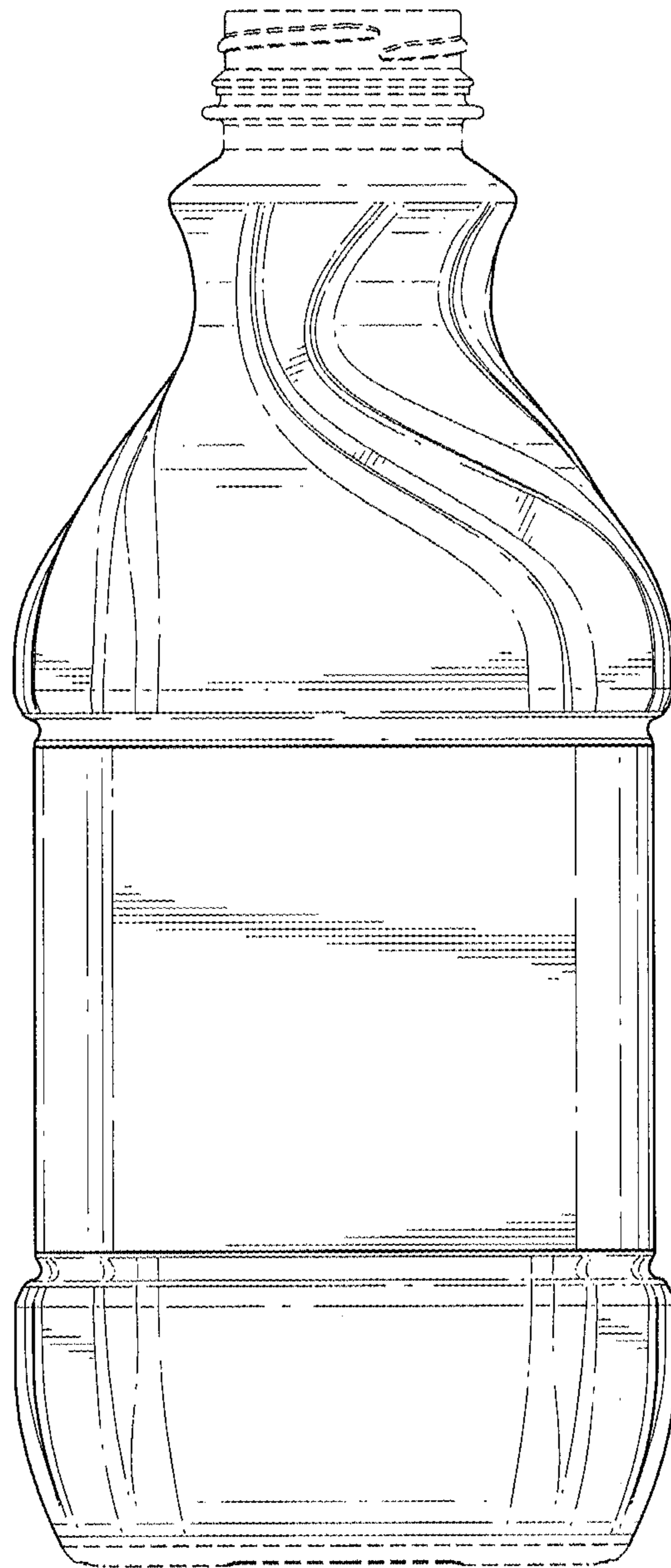

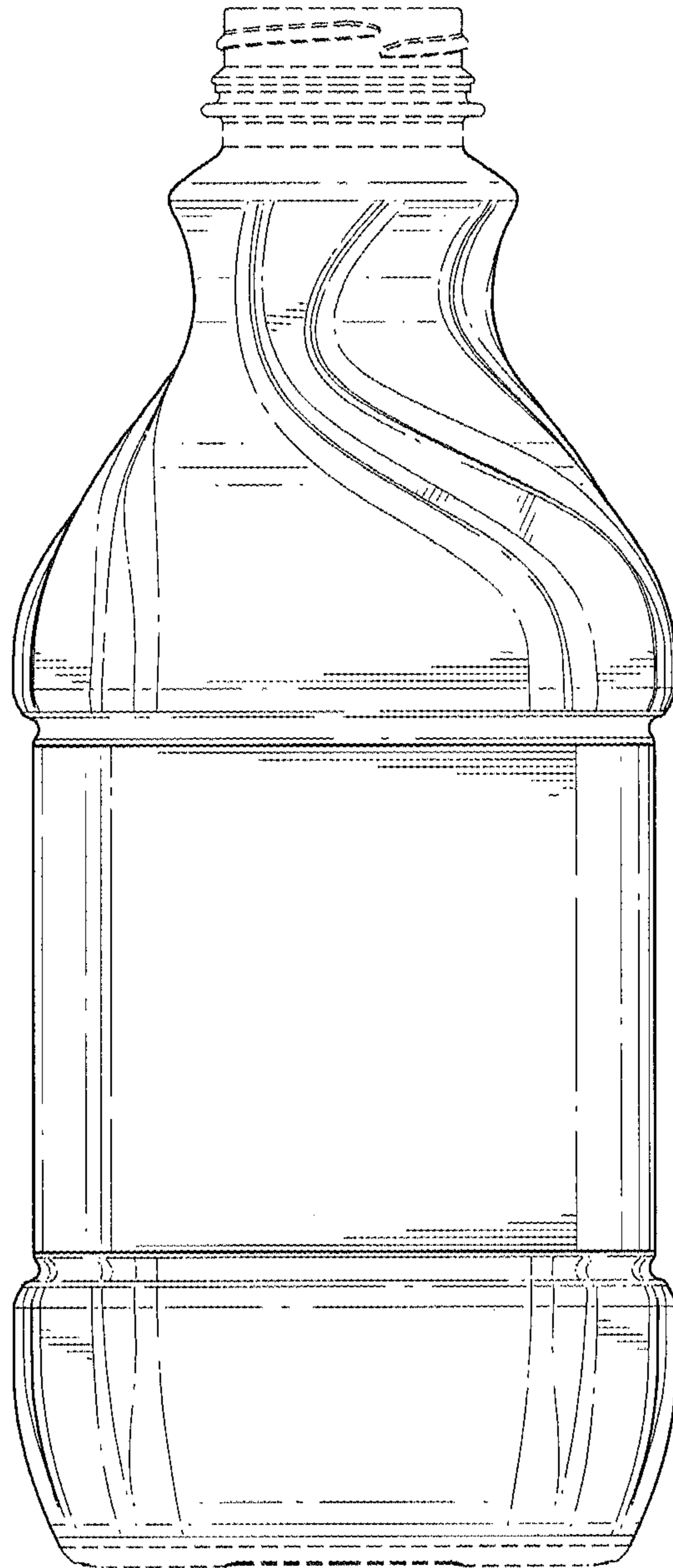

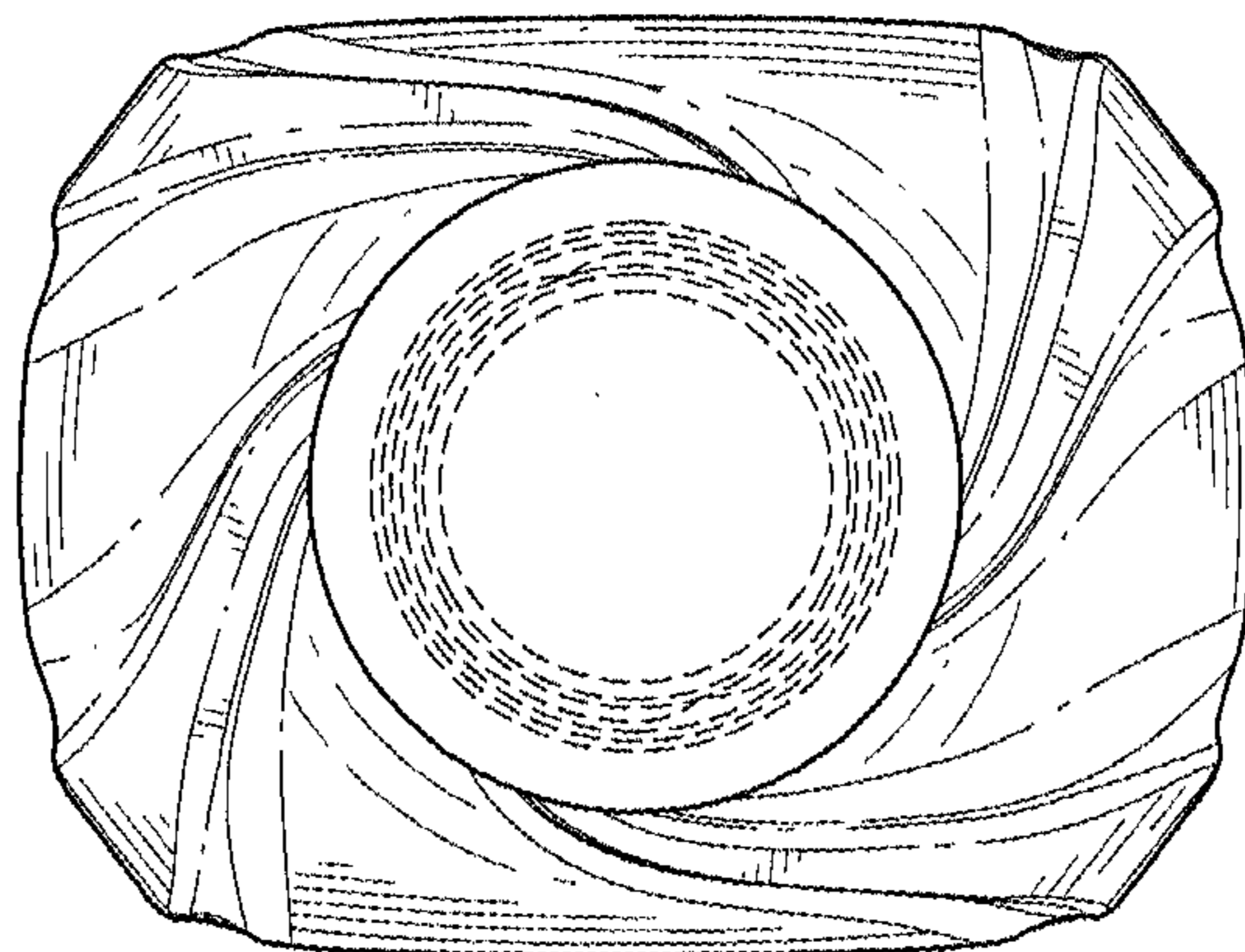

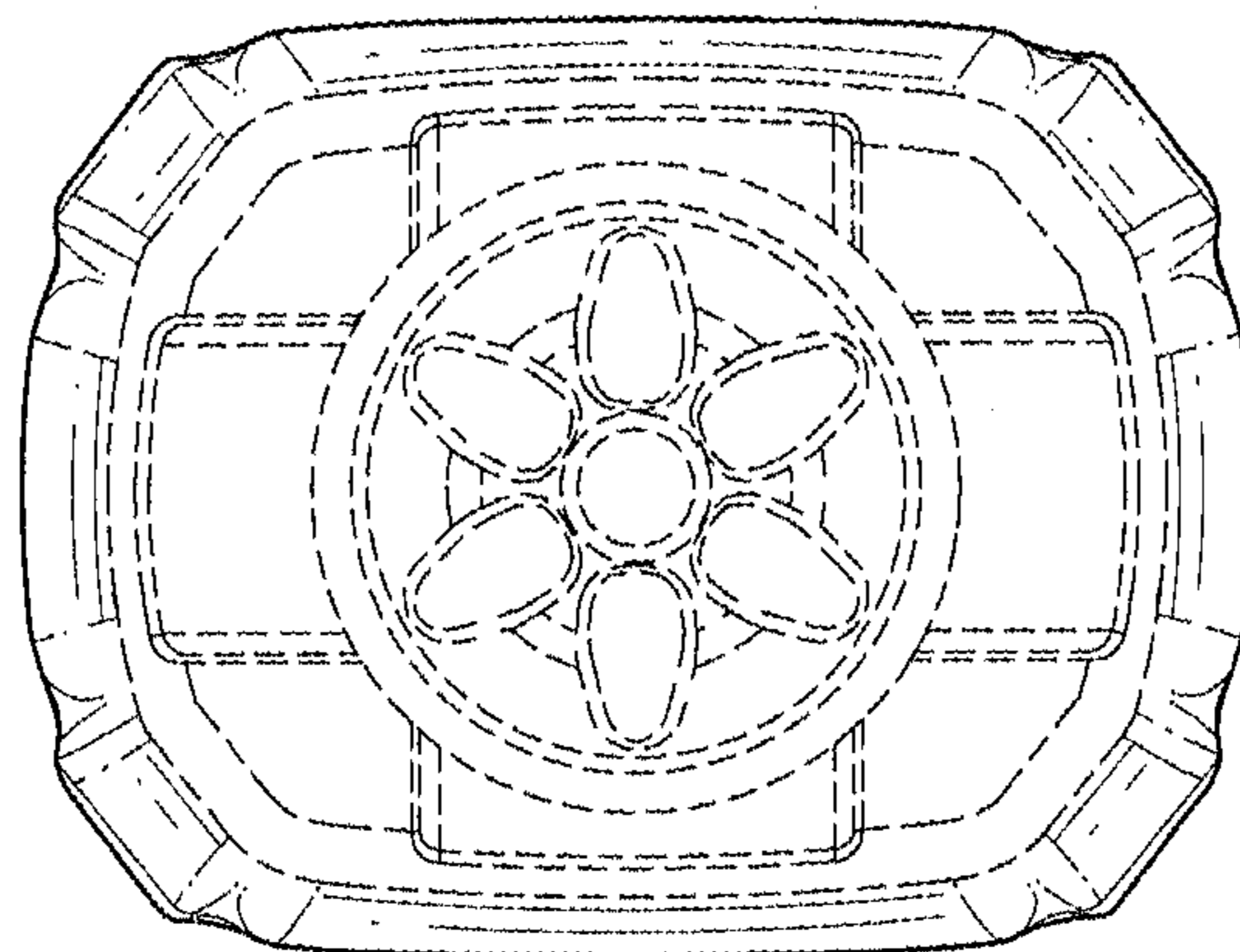

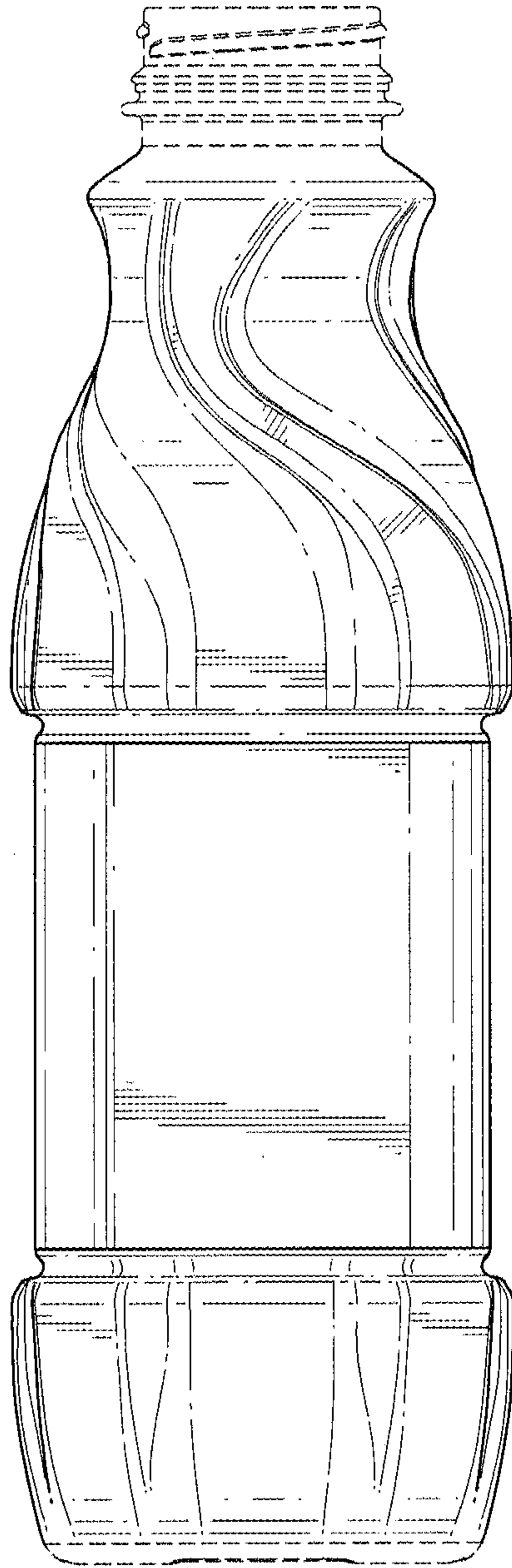

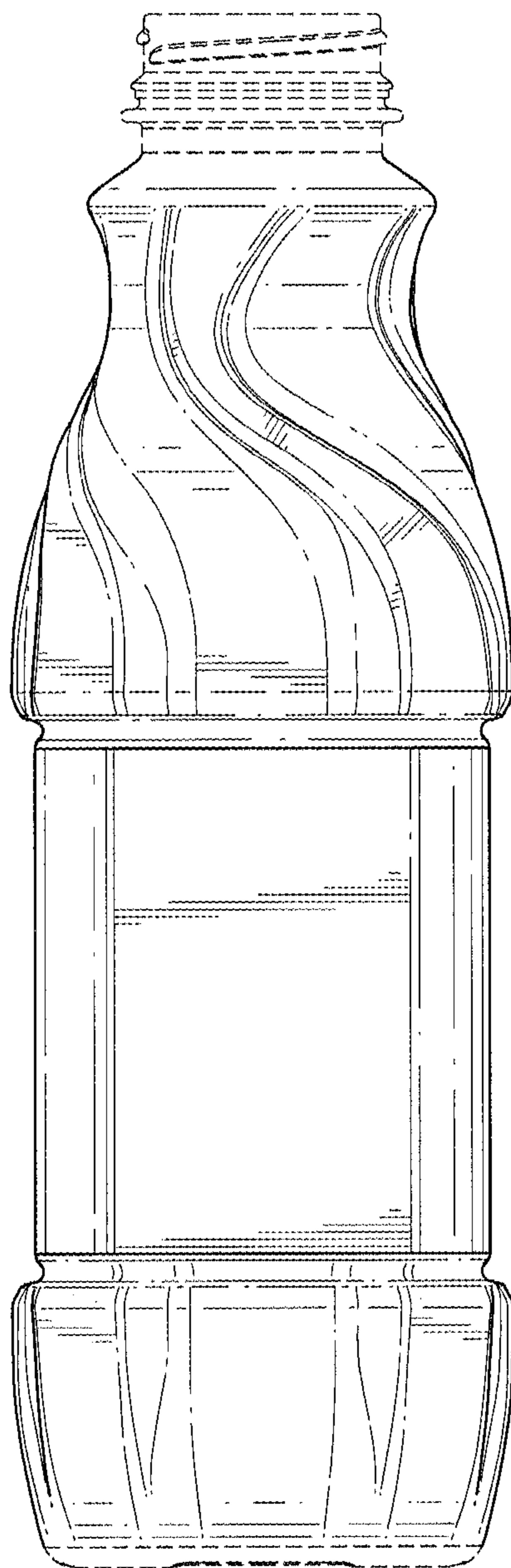

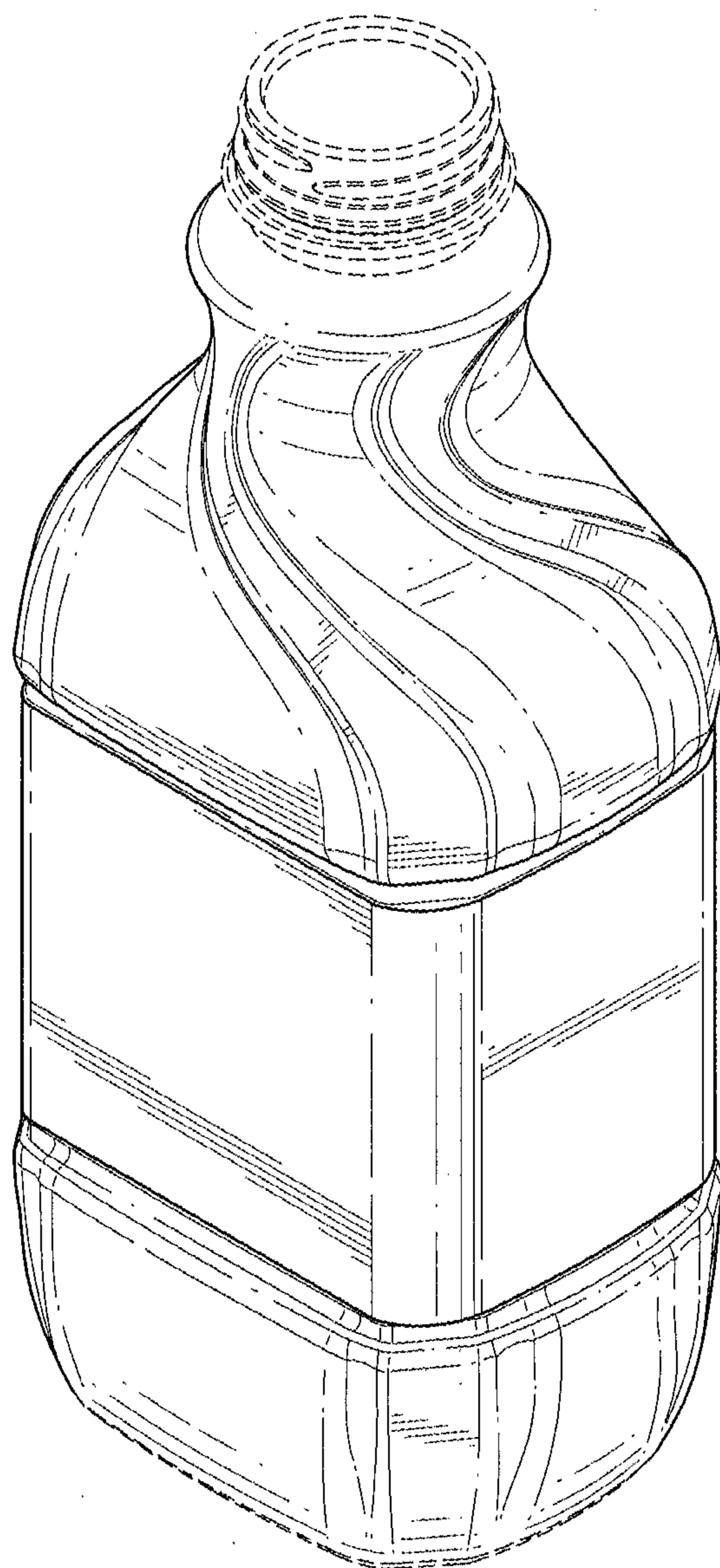

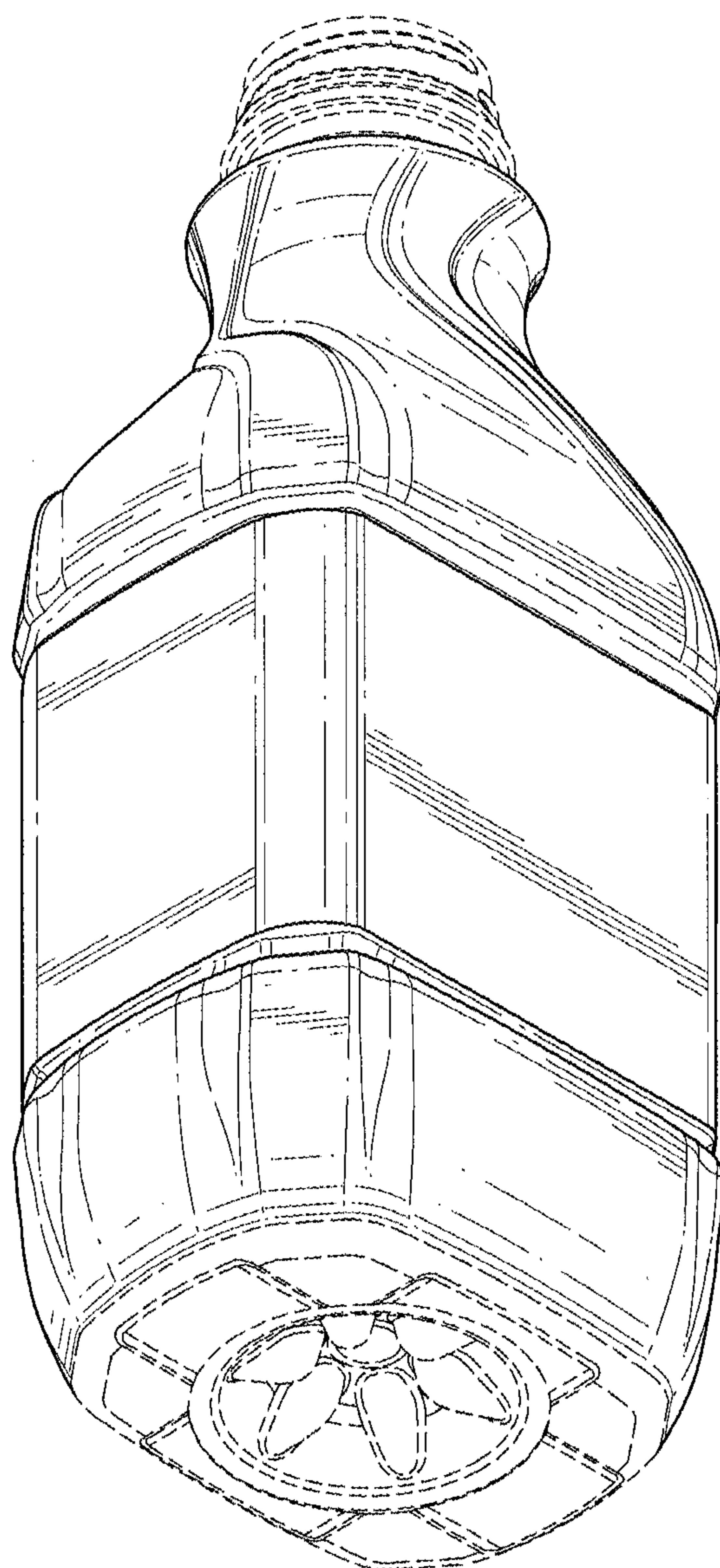

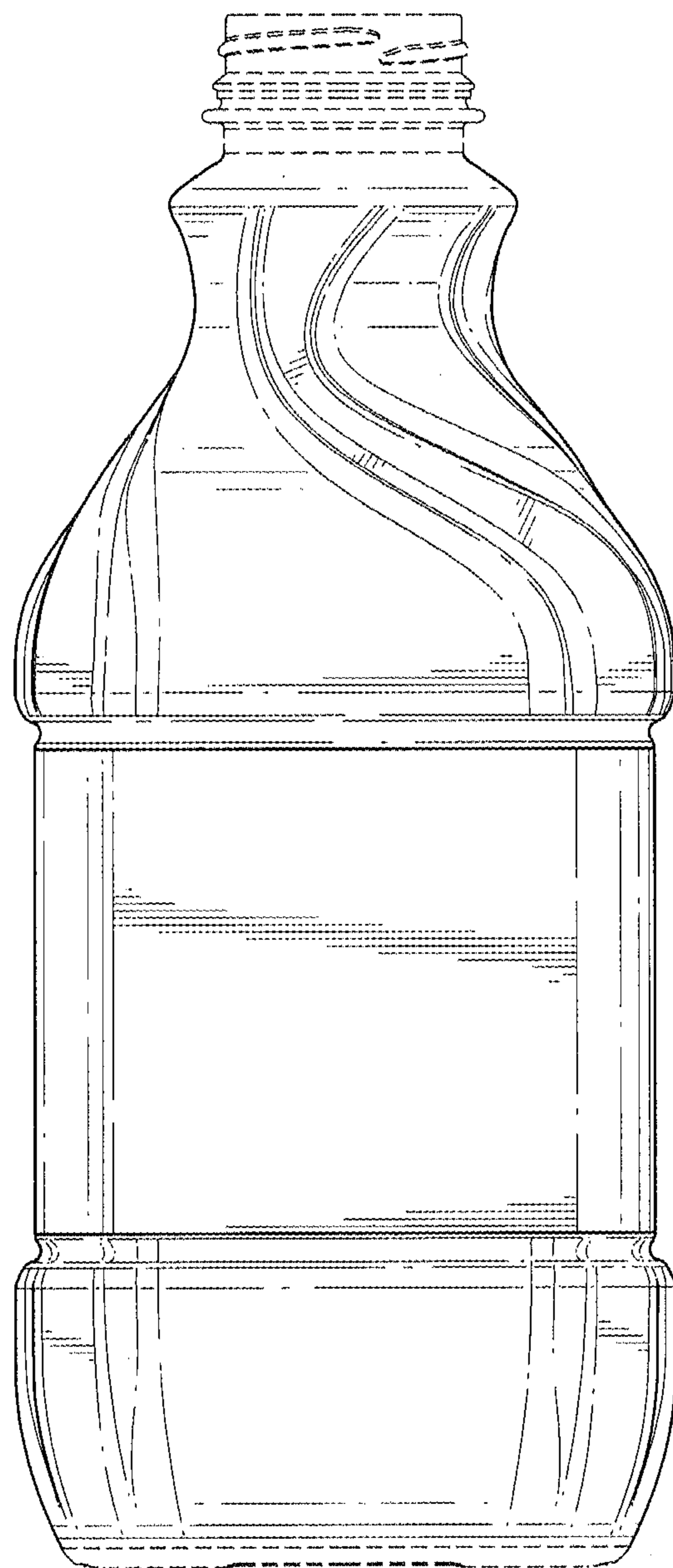

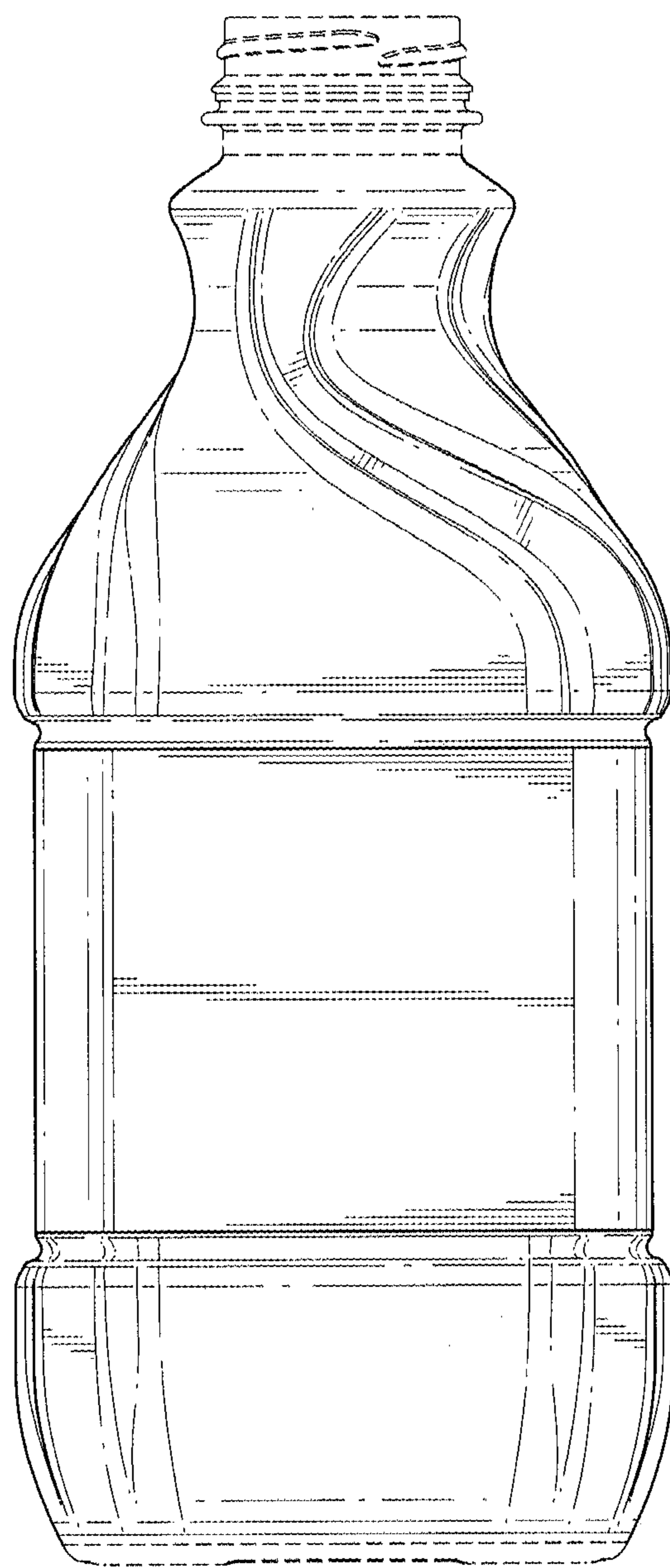

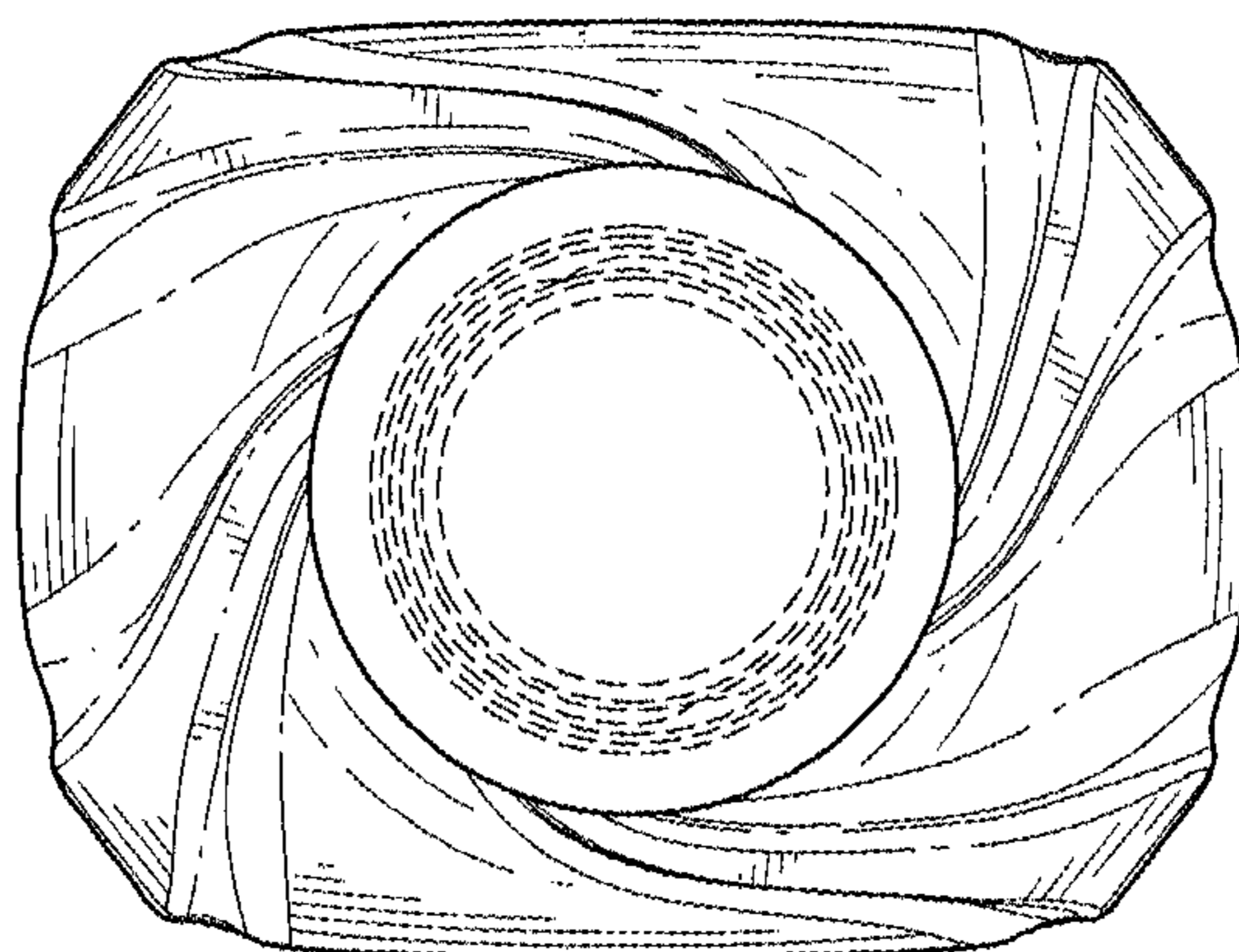

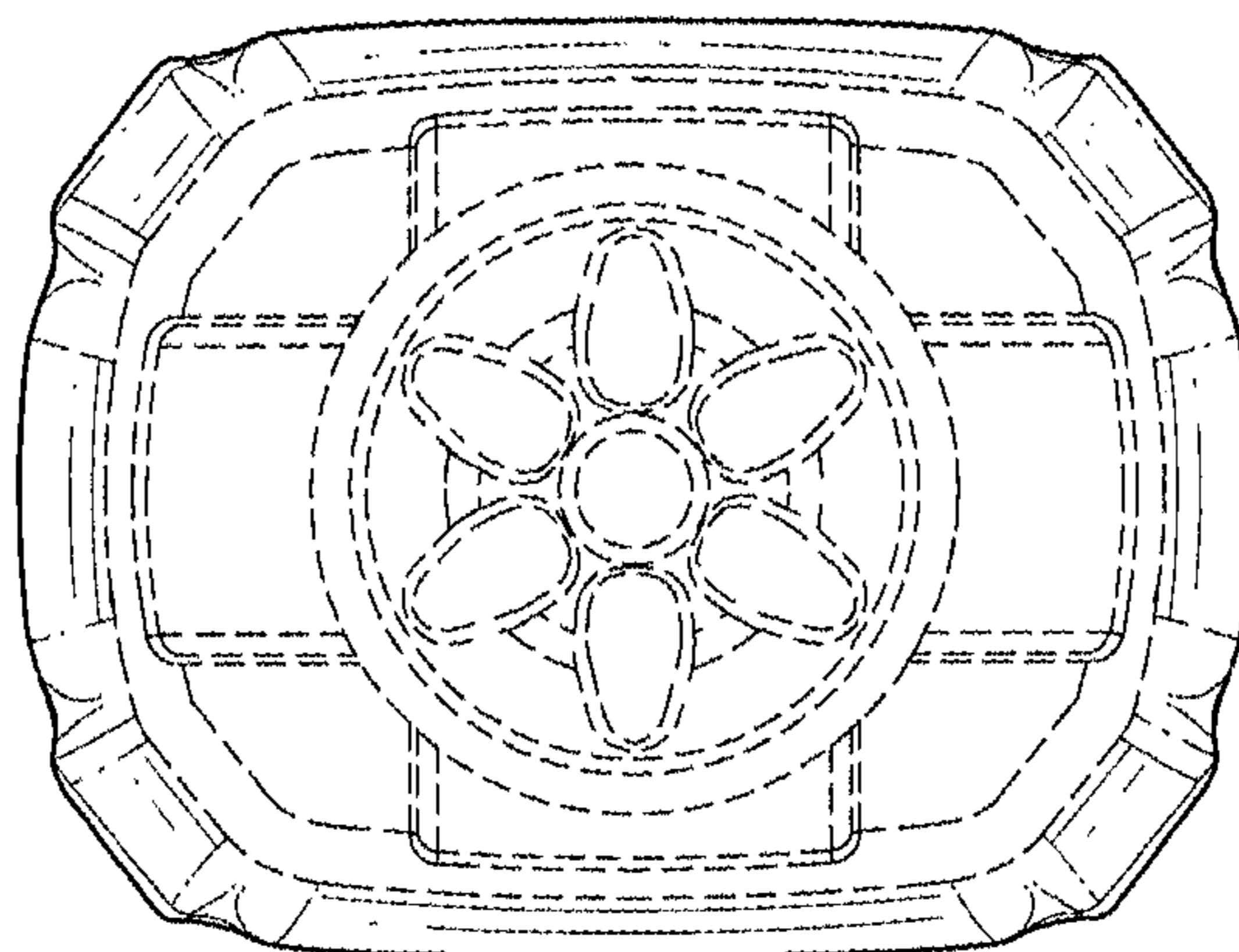

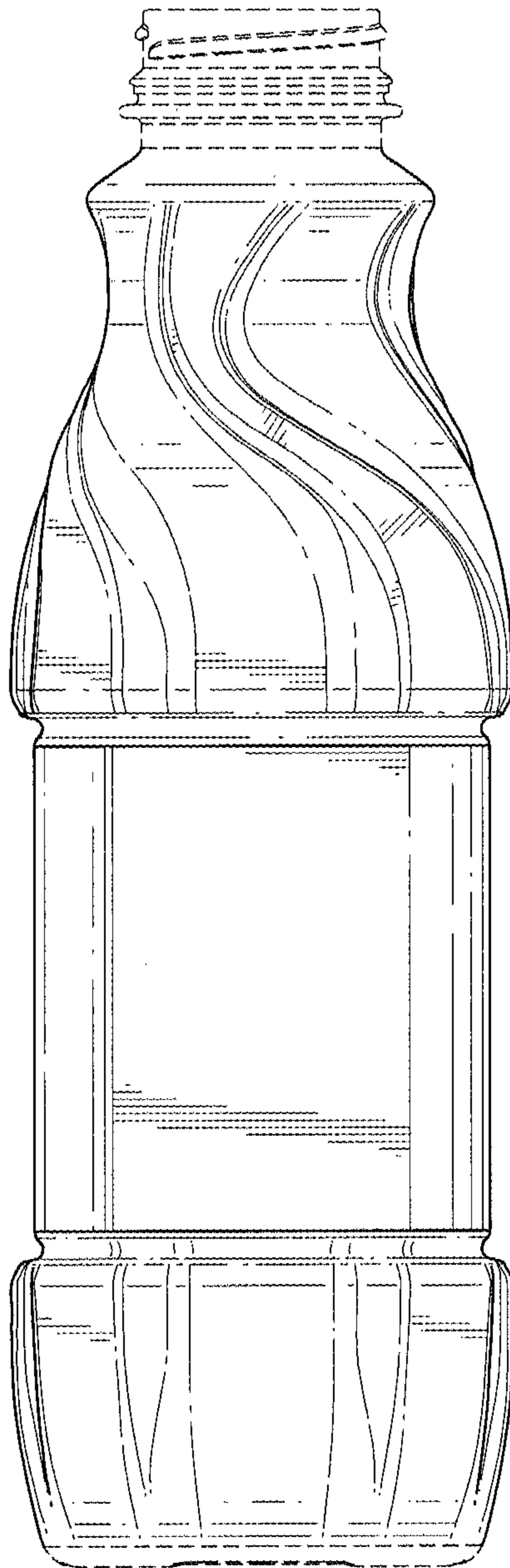

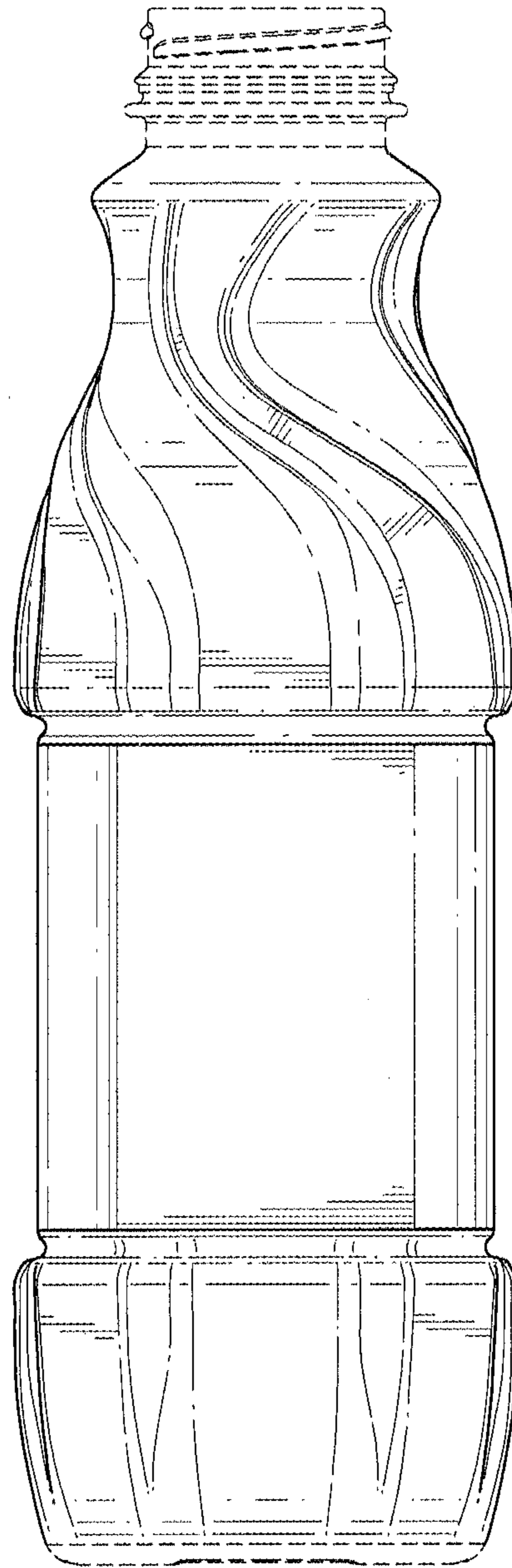

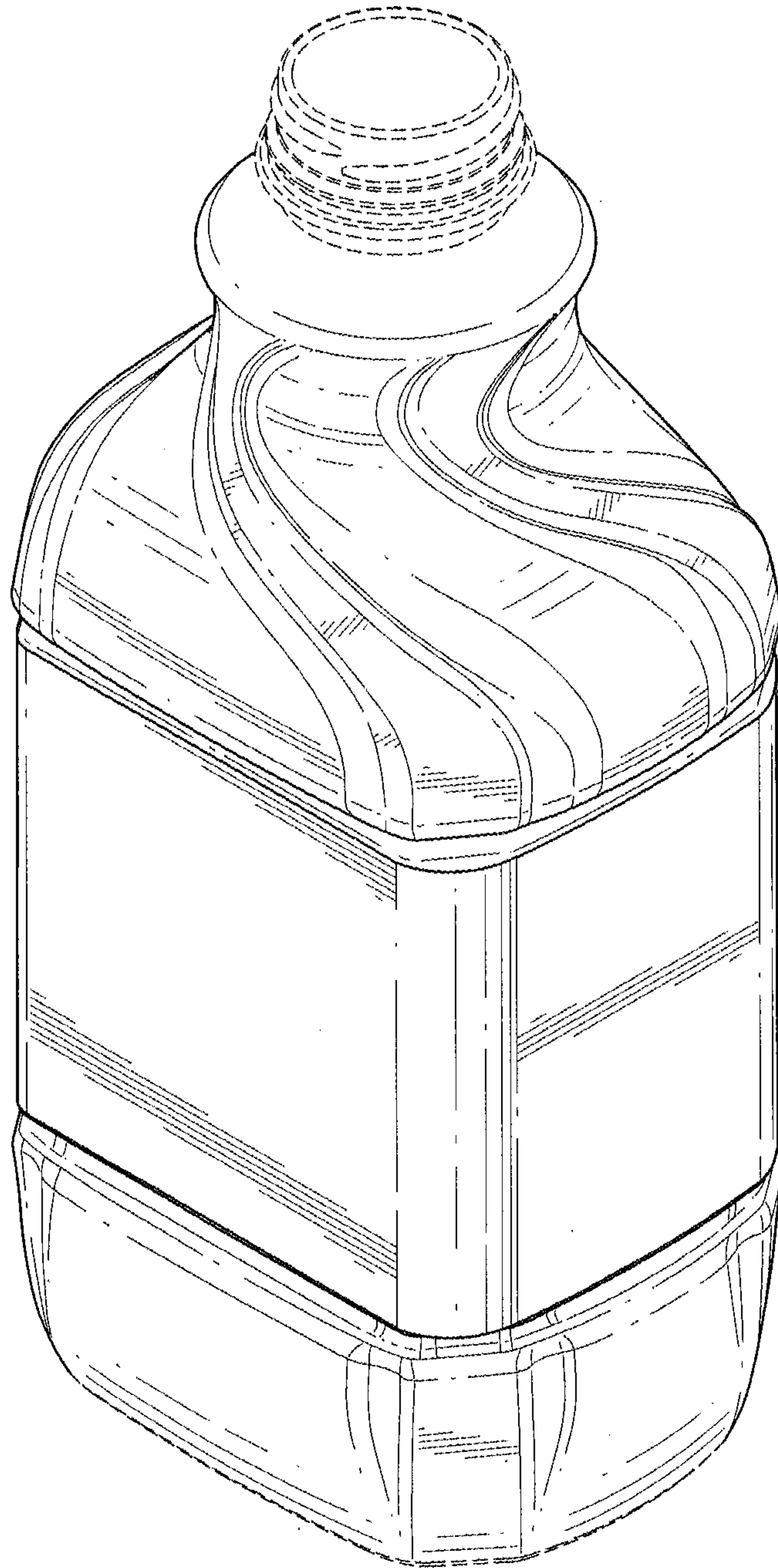

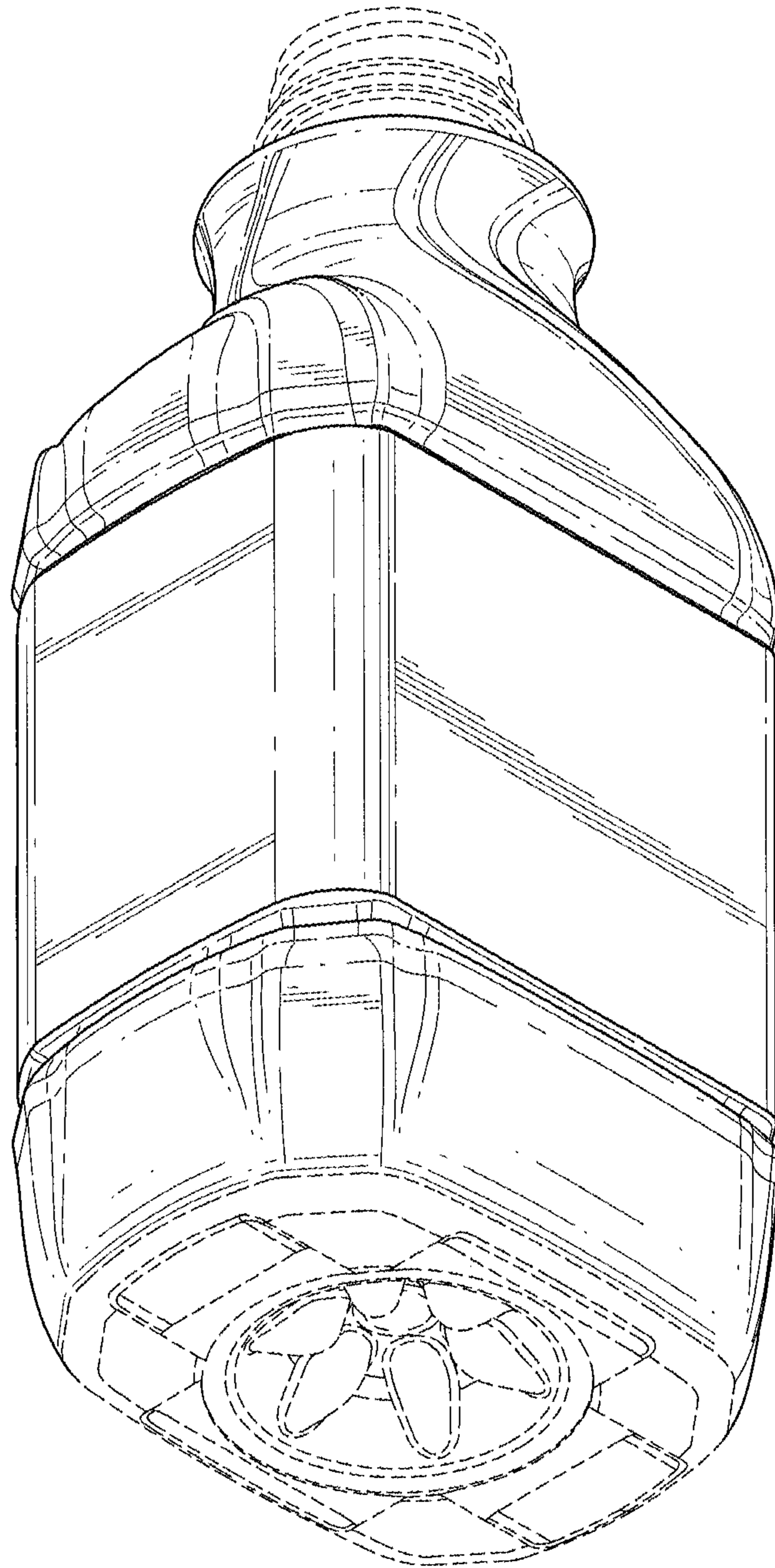

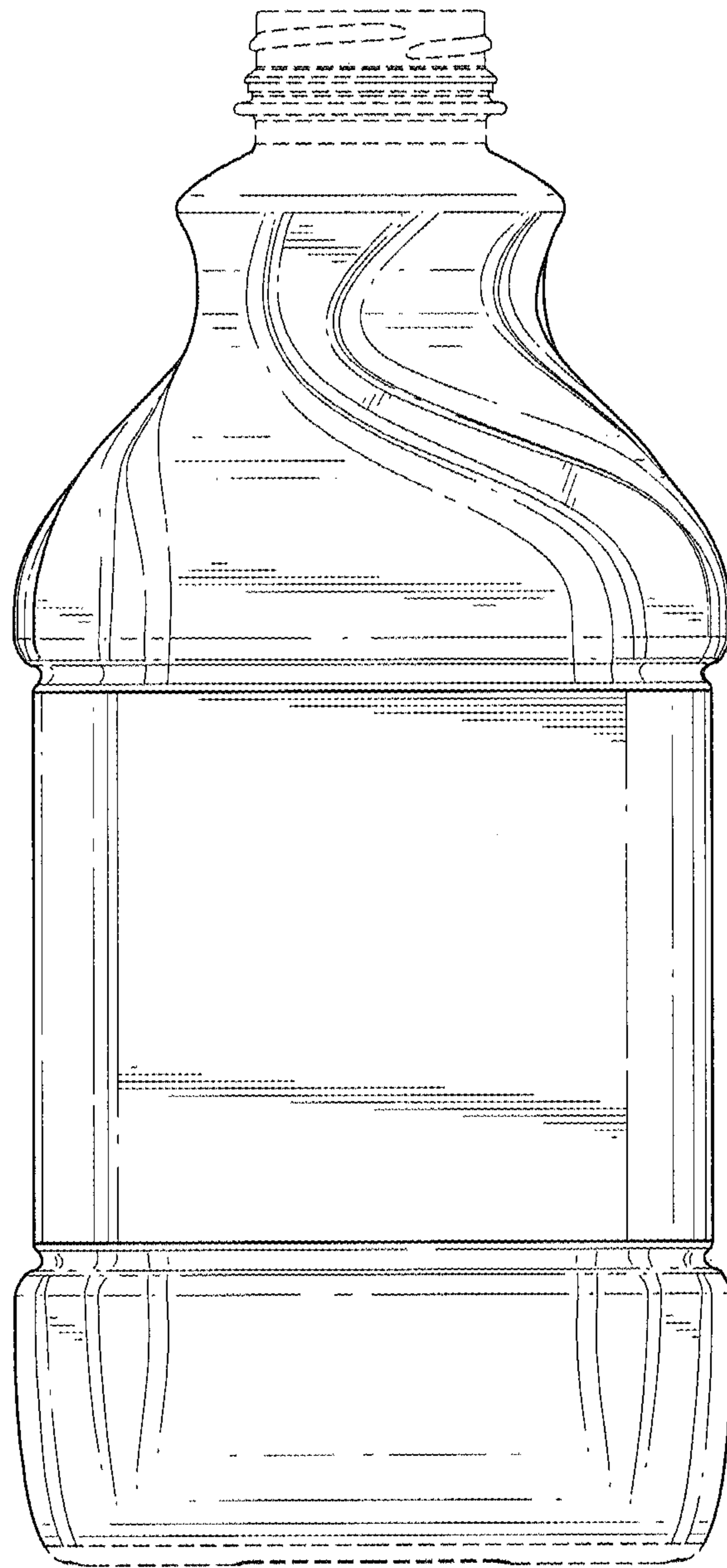

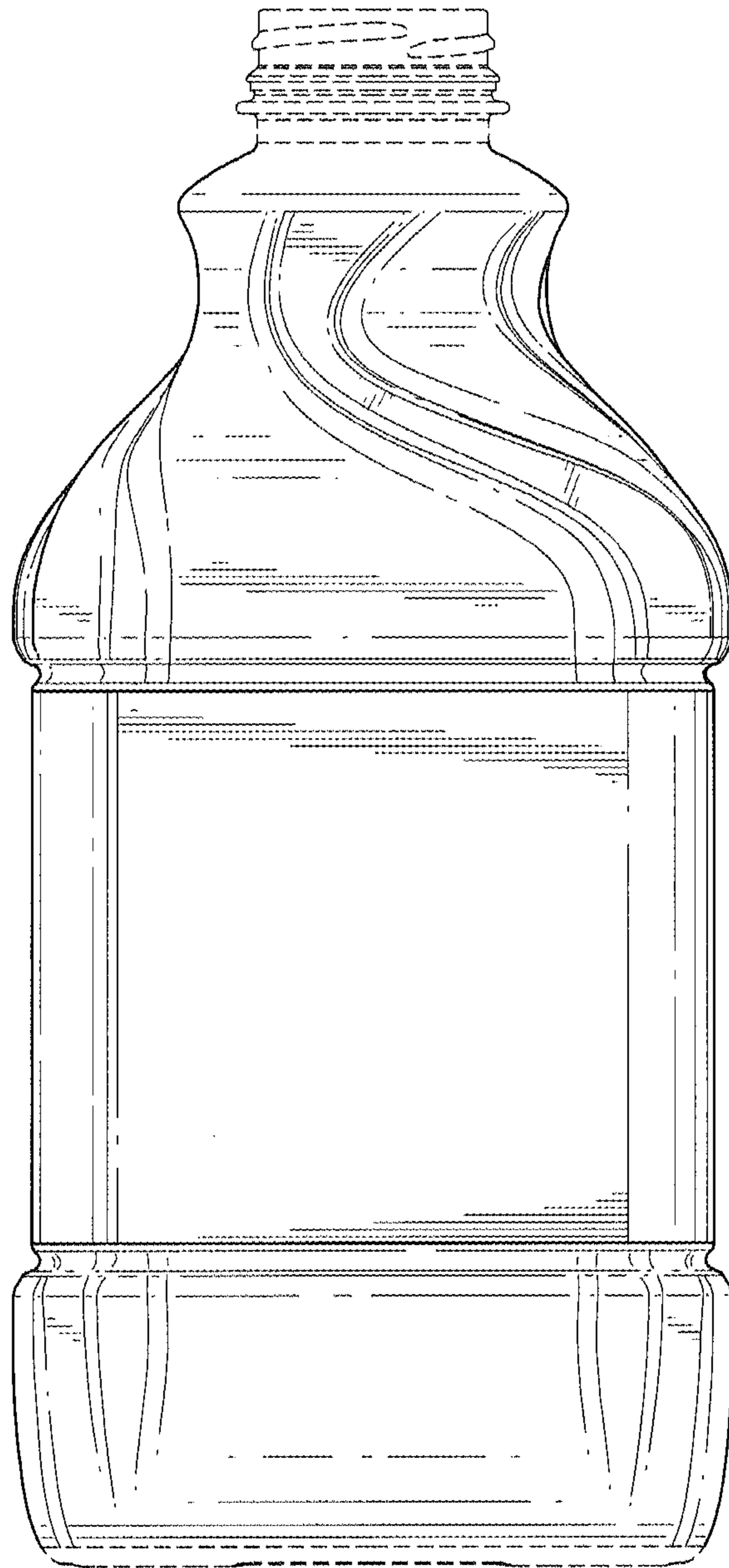

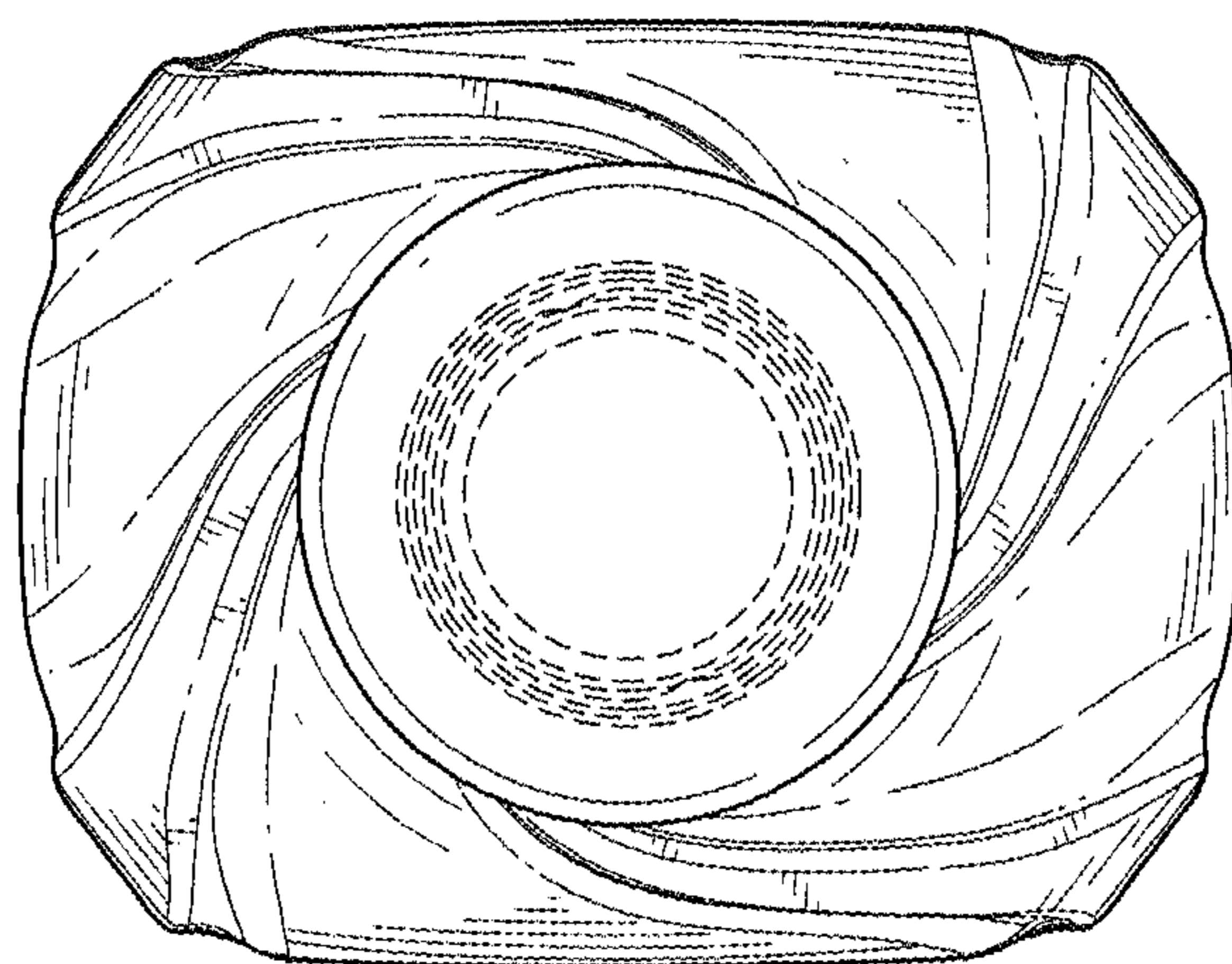

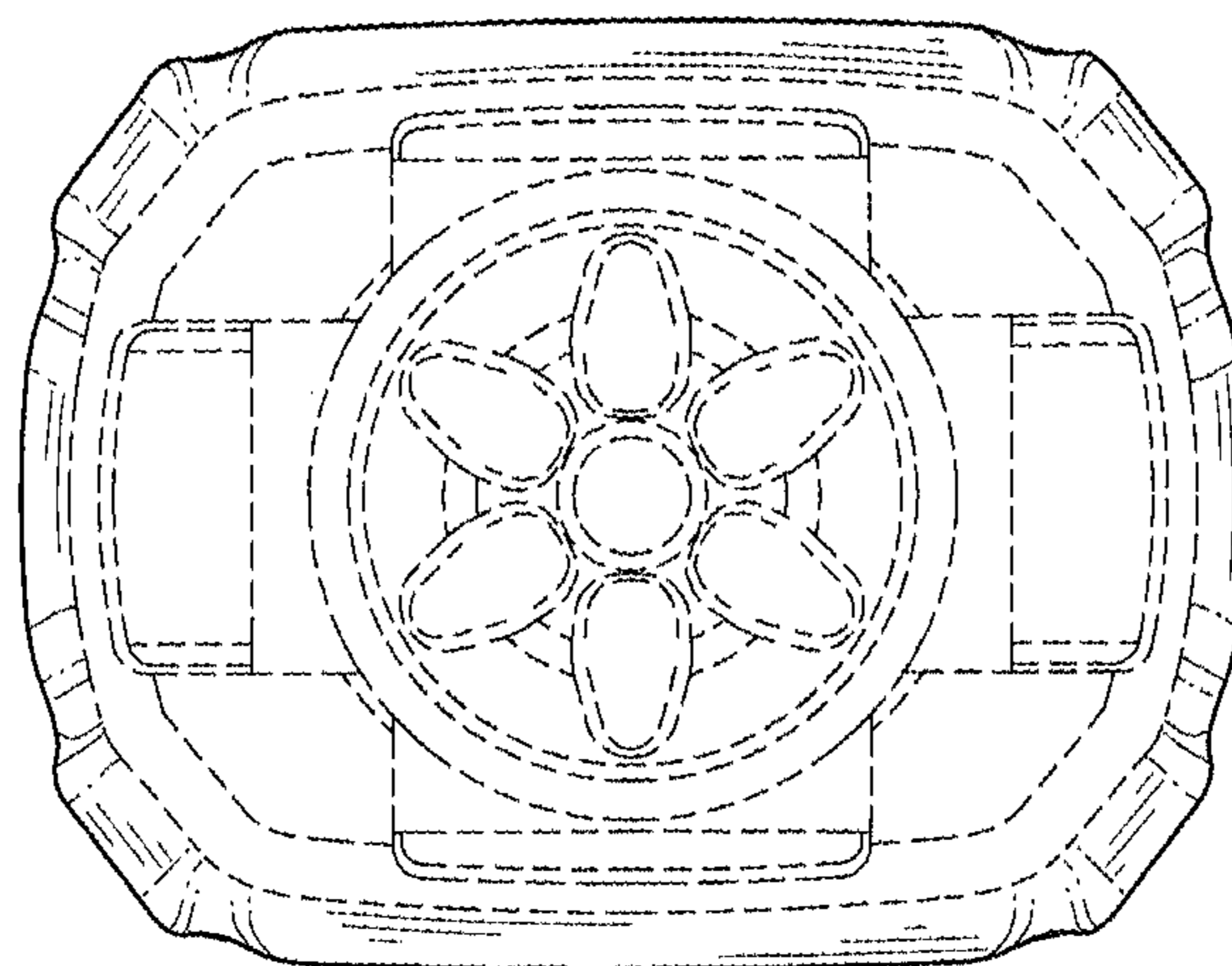

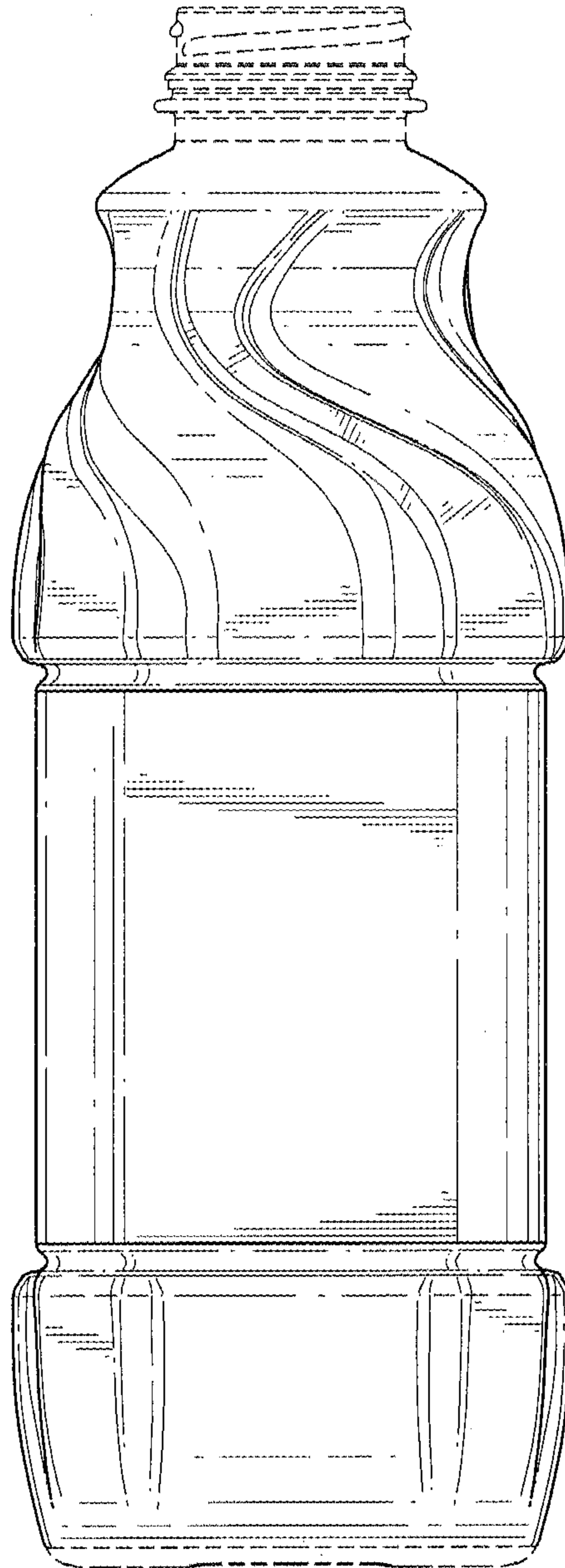

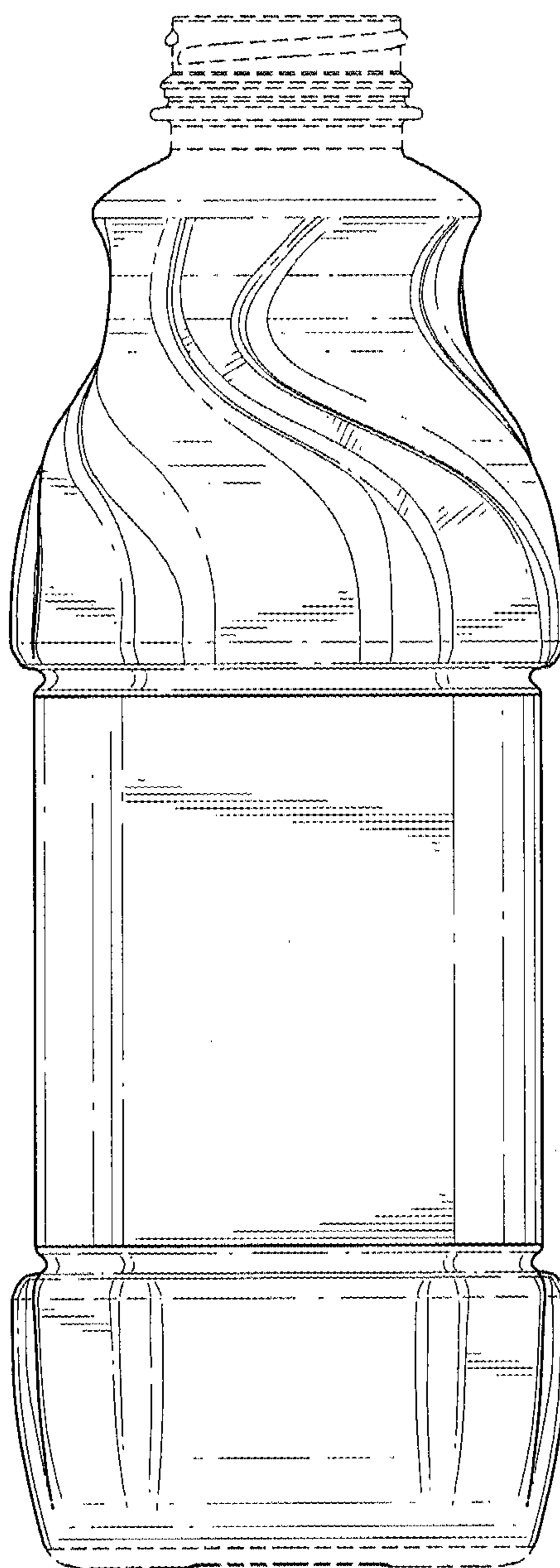

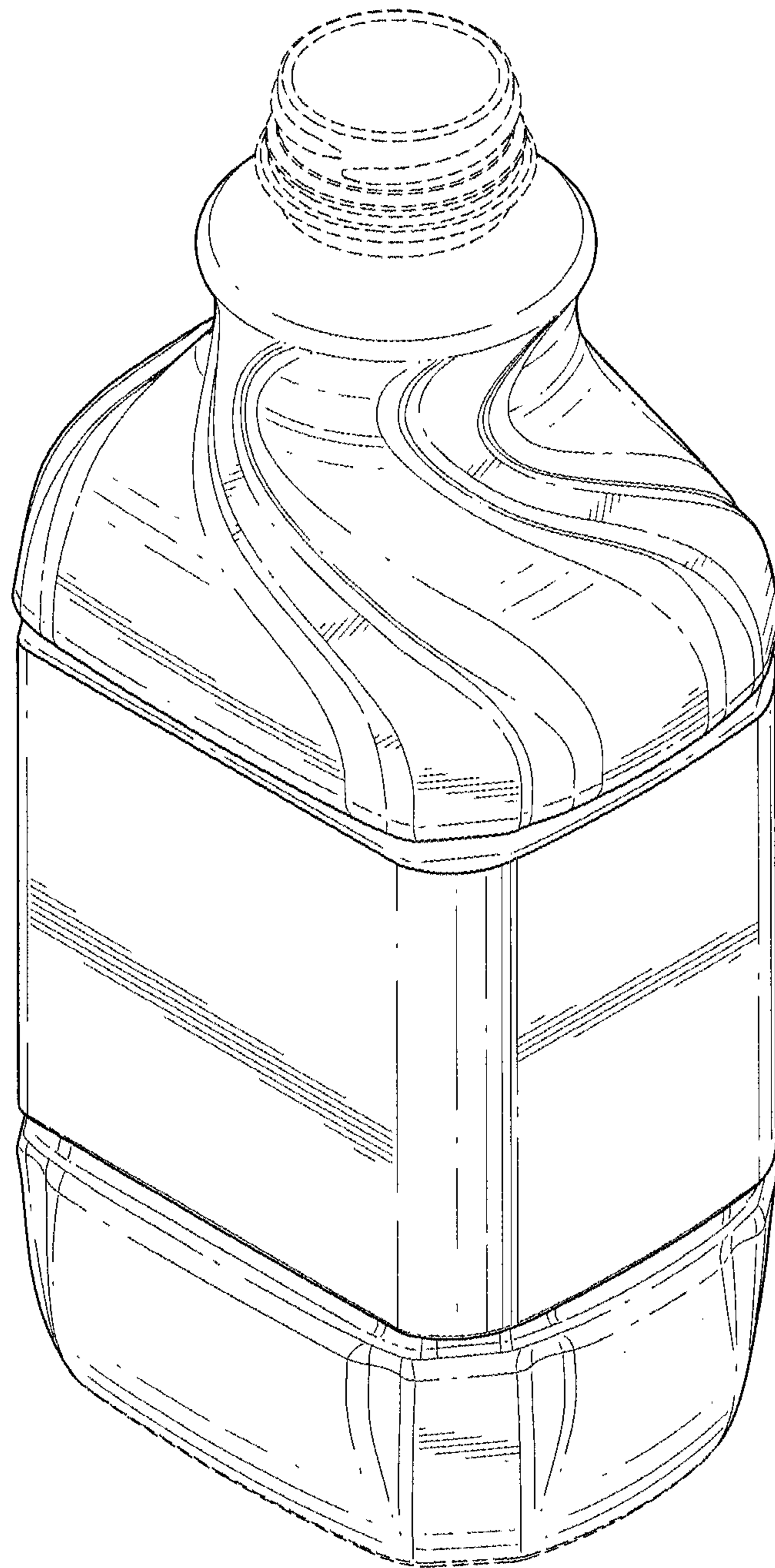

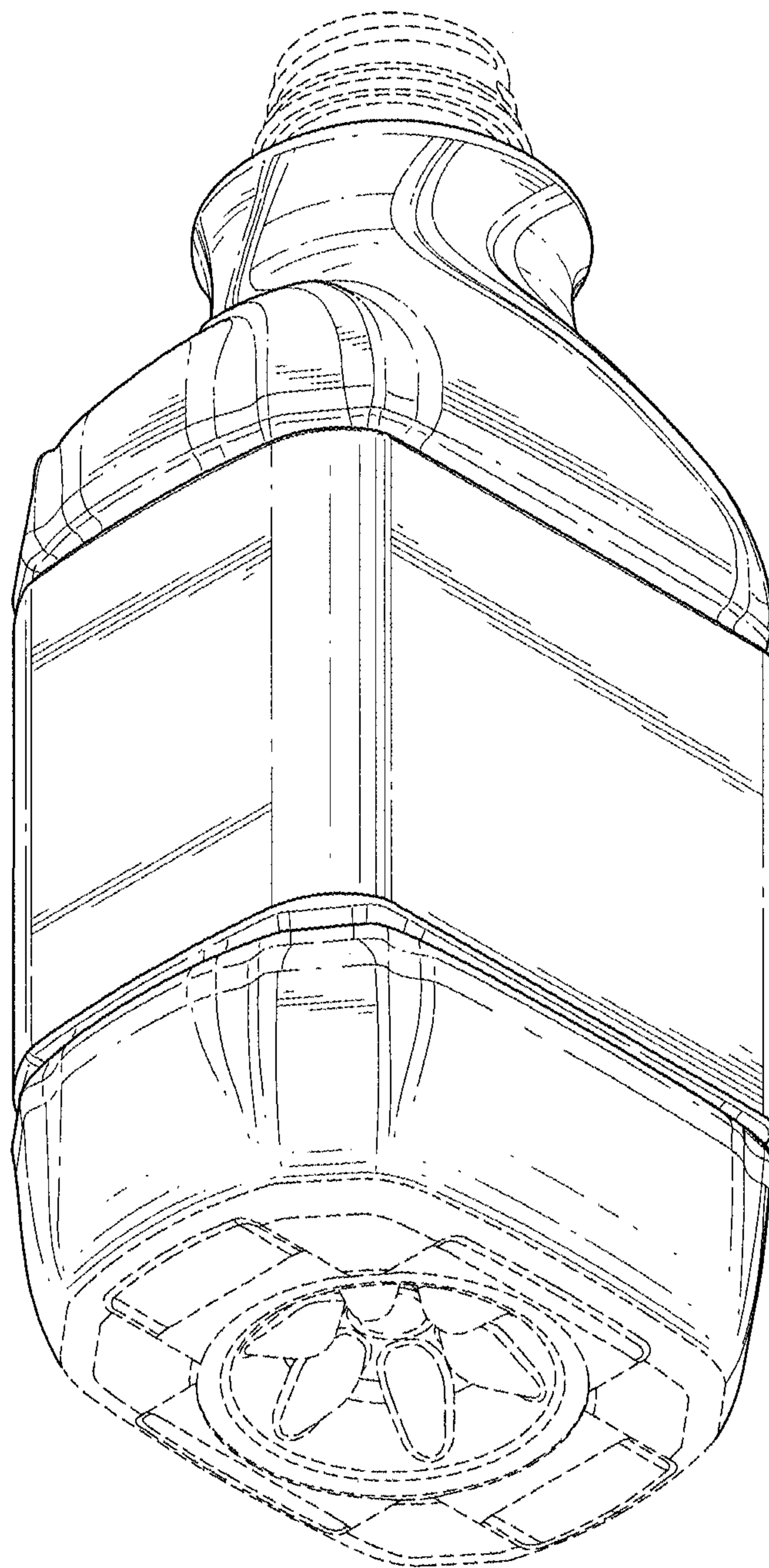

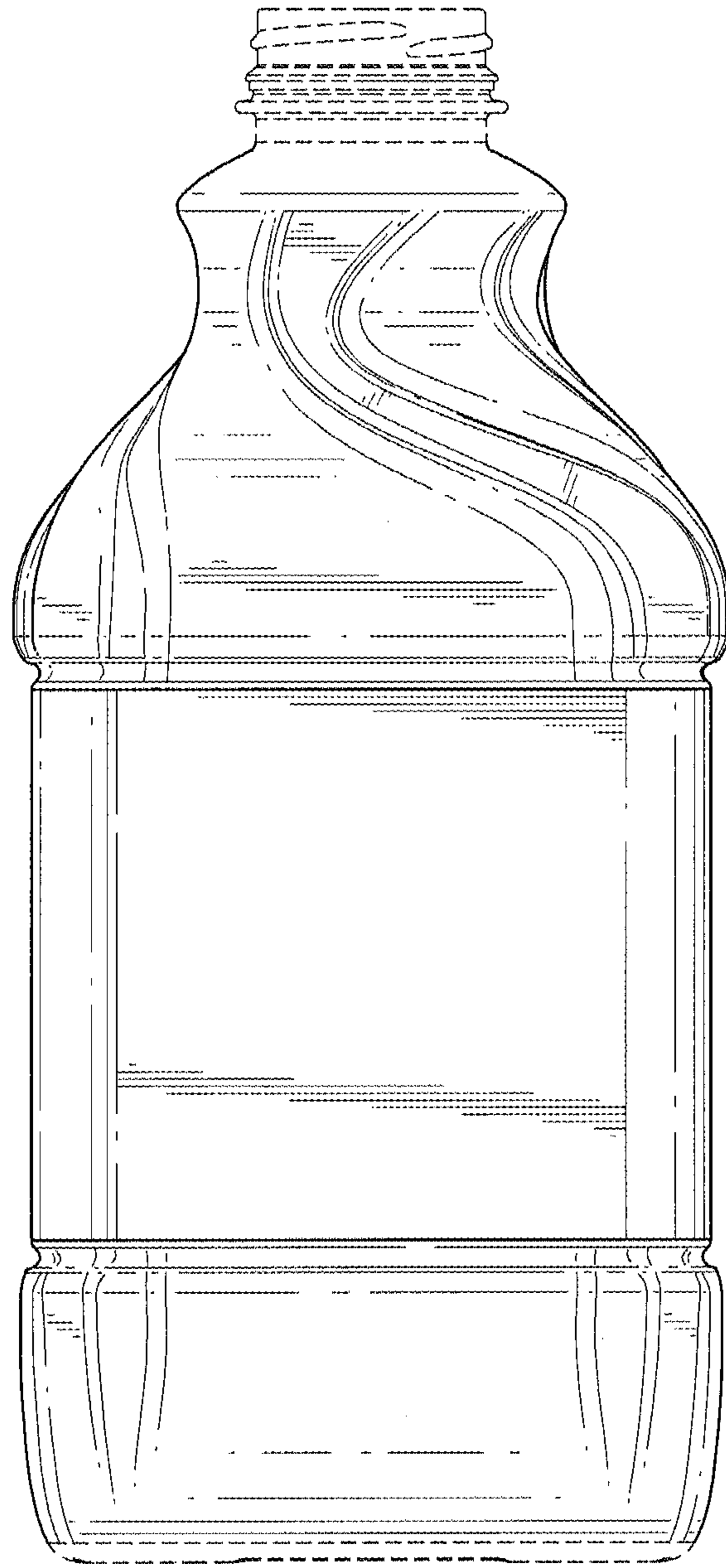

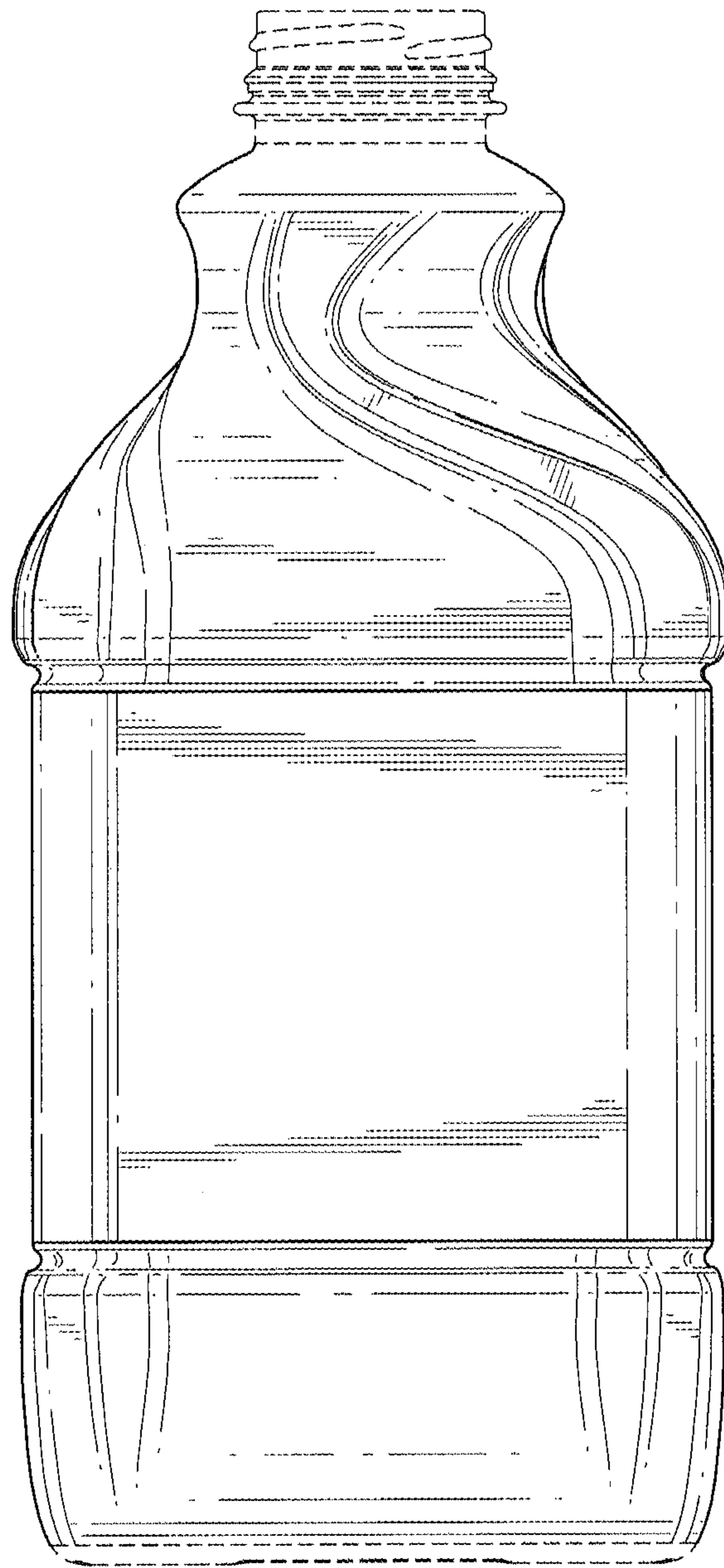

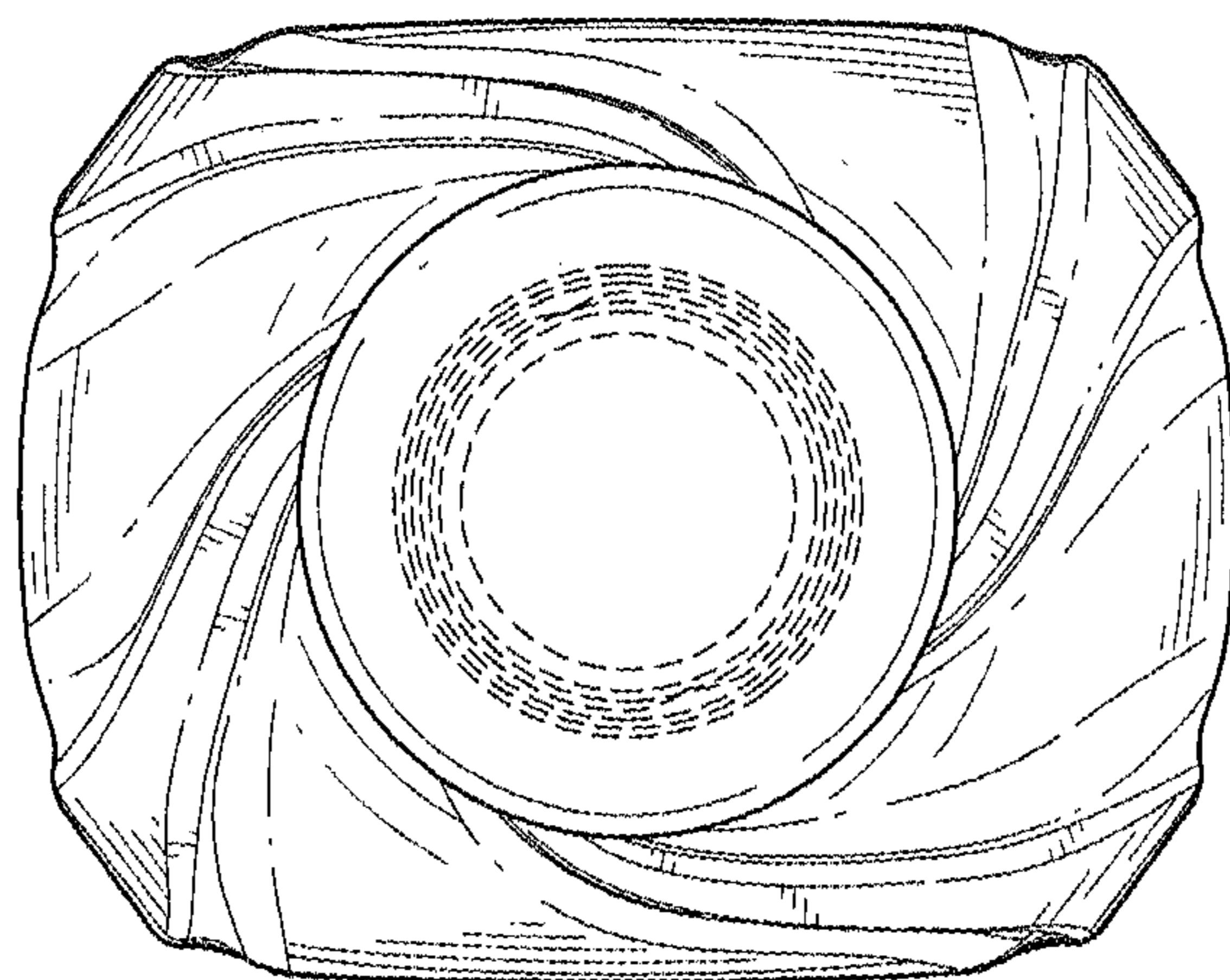

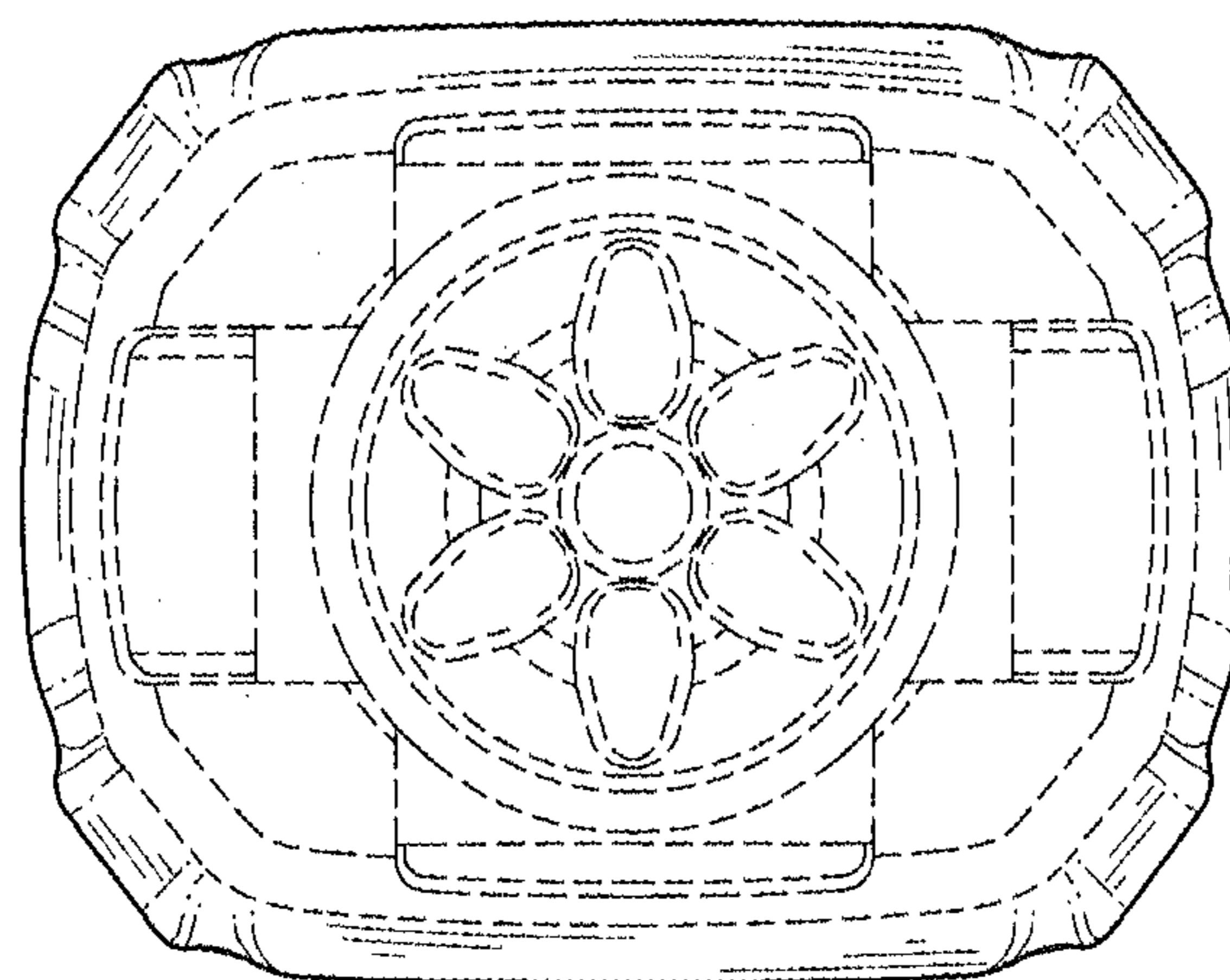

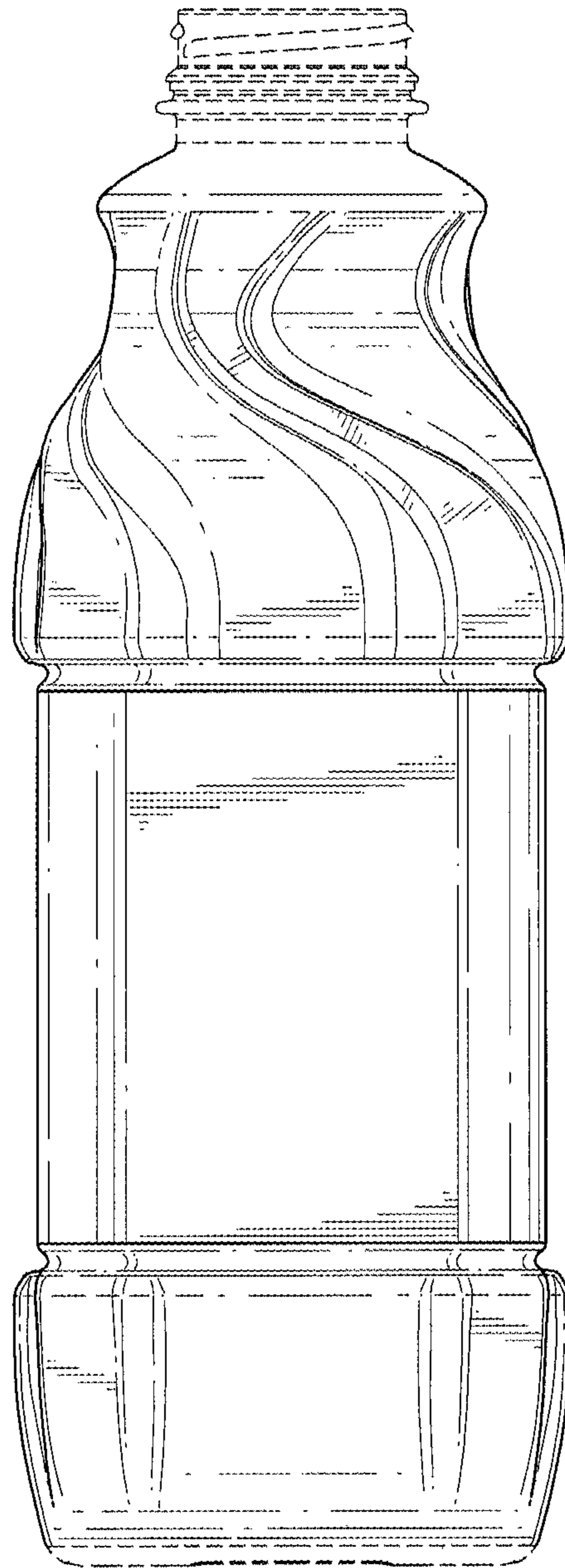

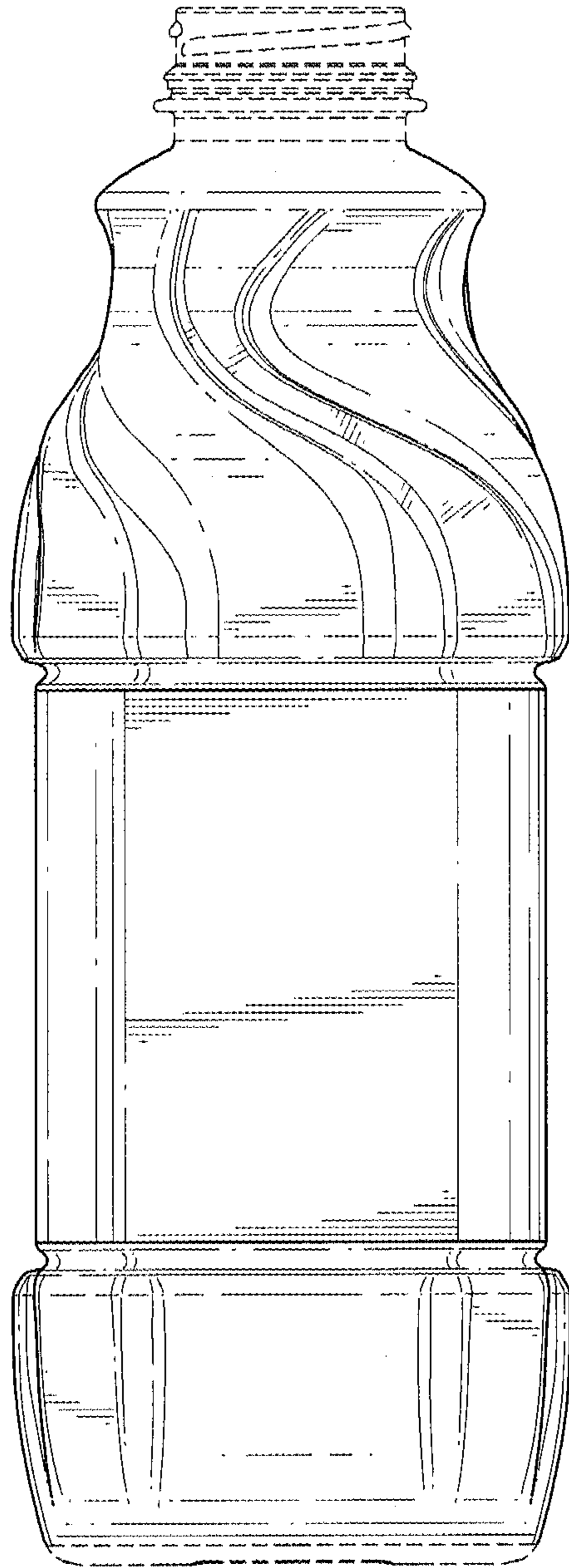
