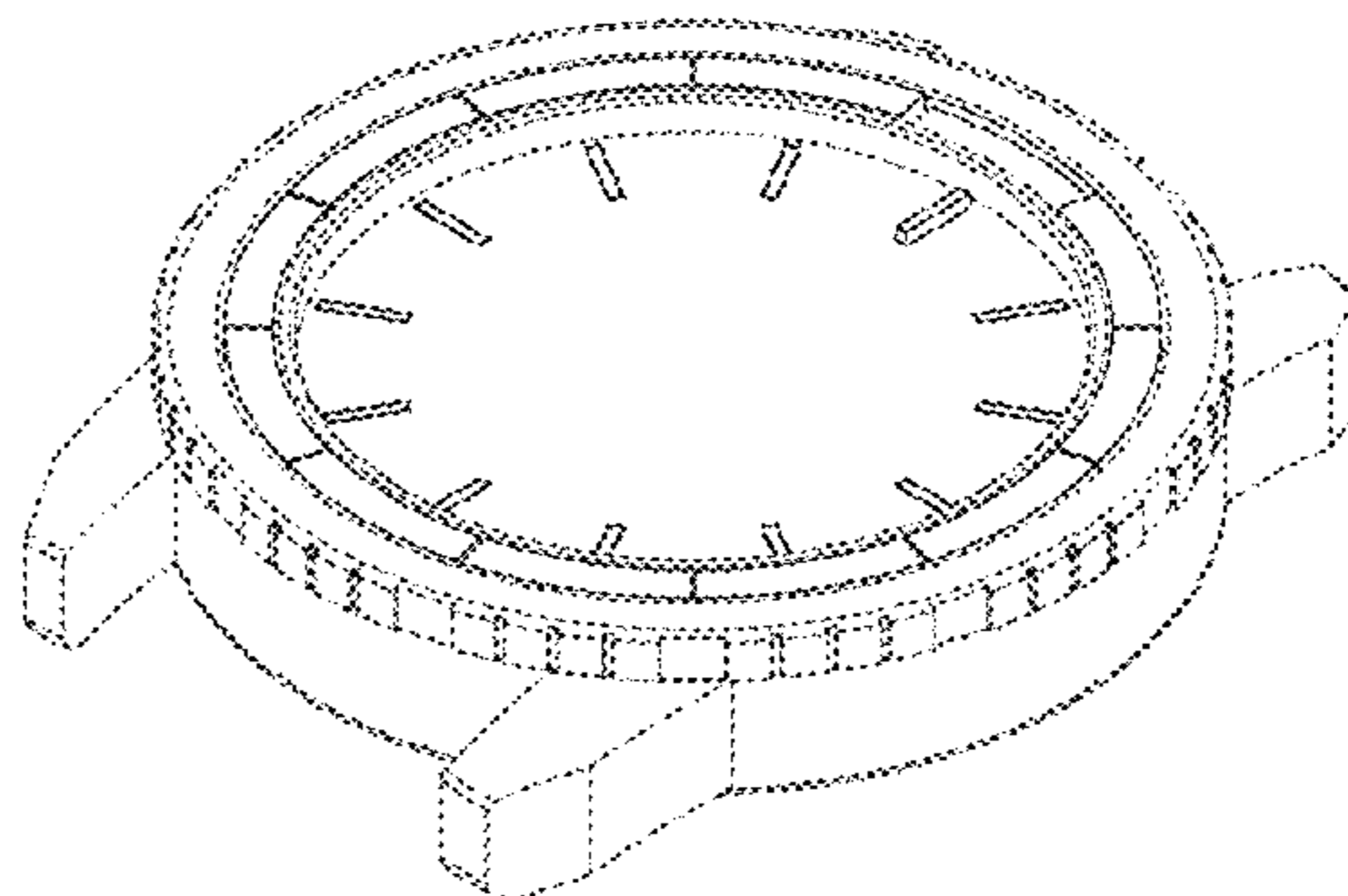
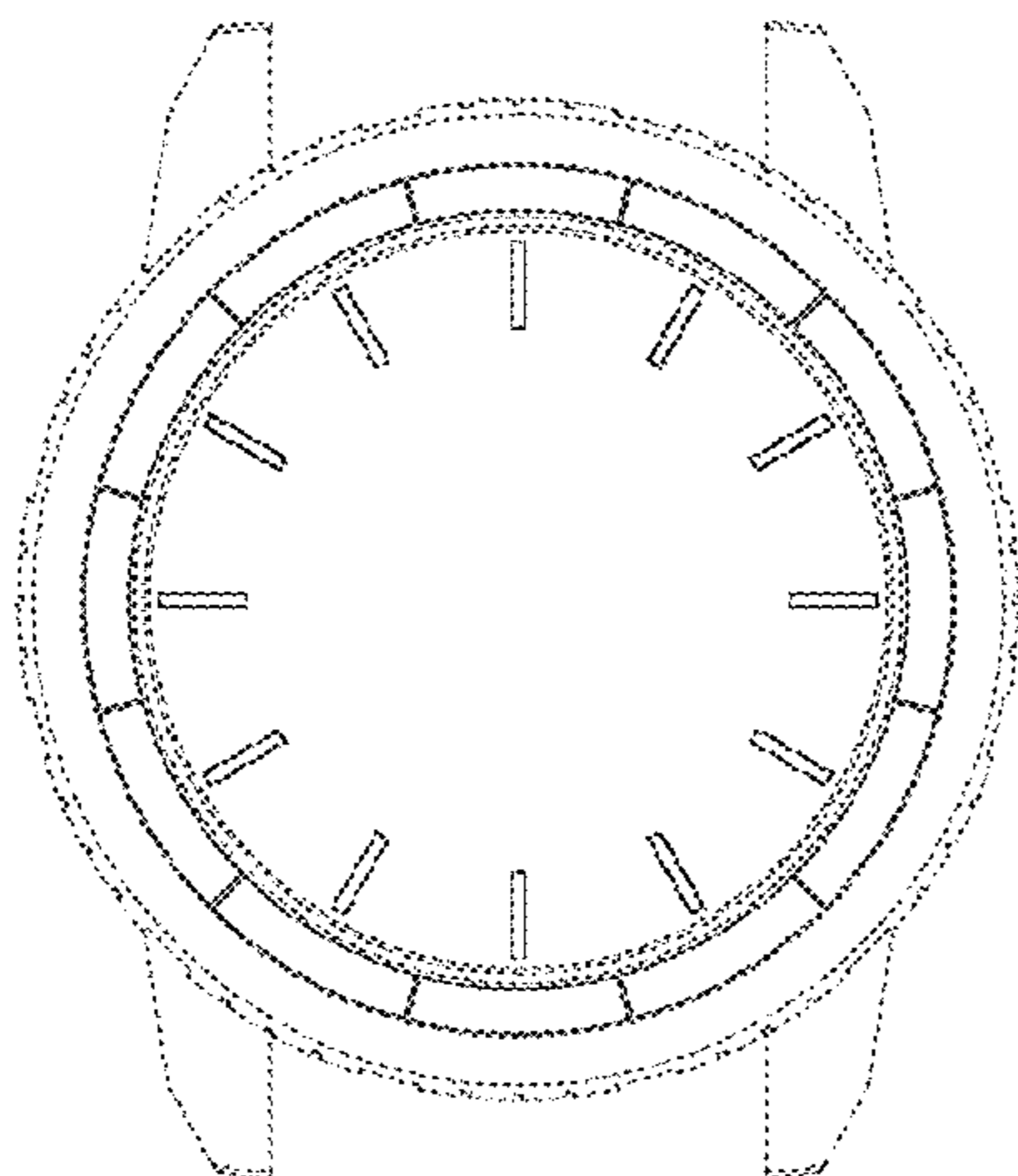
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevational view of a first embodiment of a watch face showing our new design;

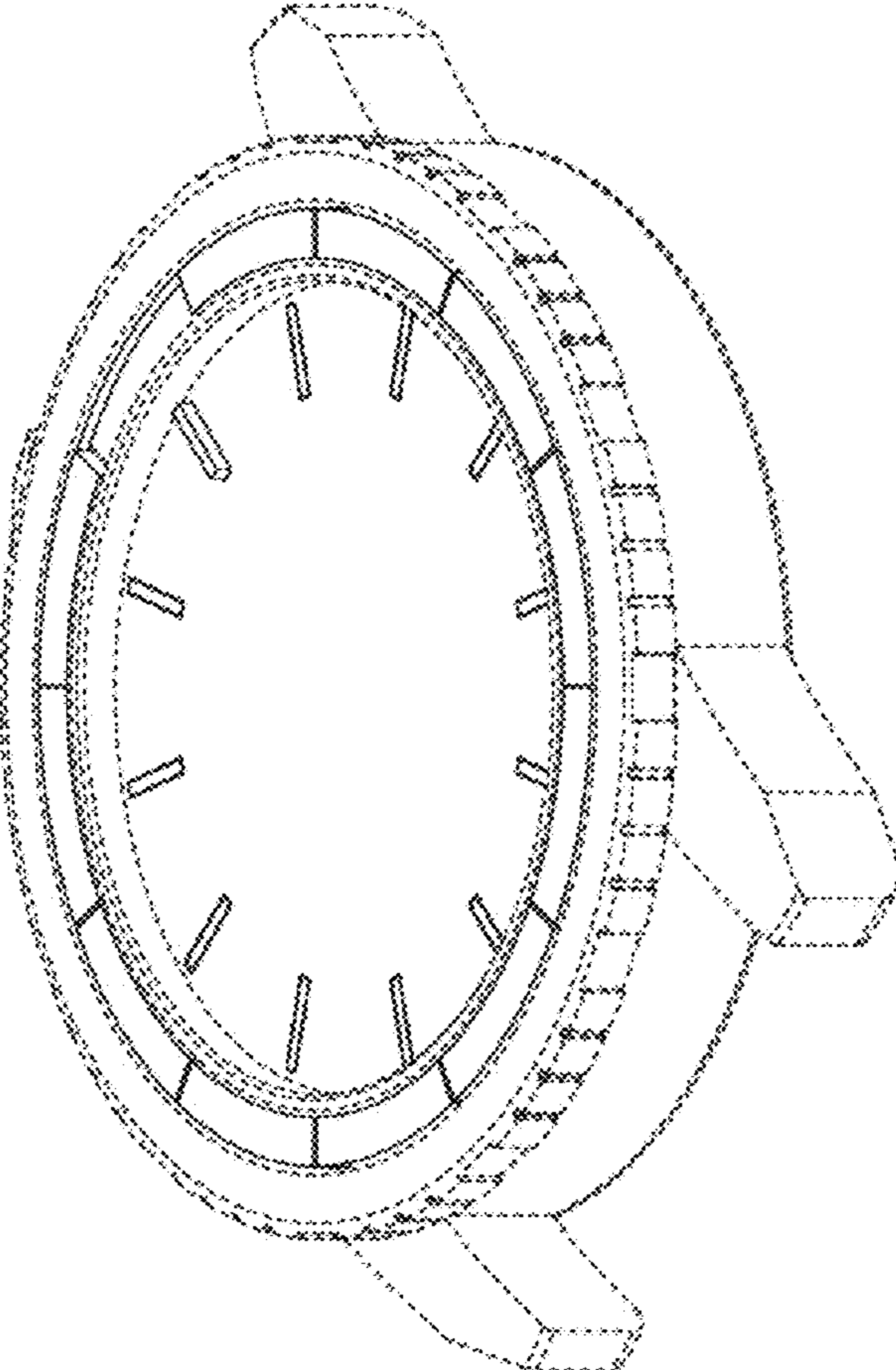

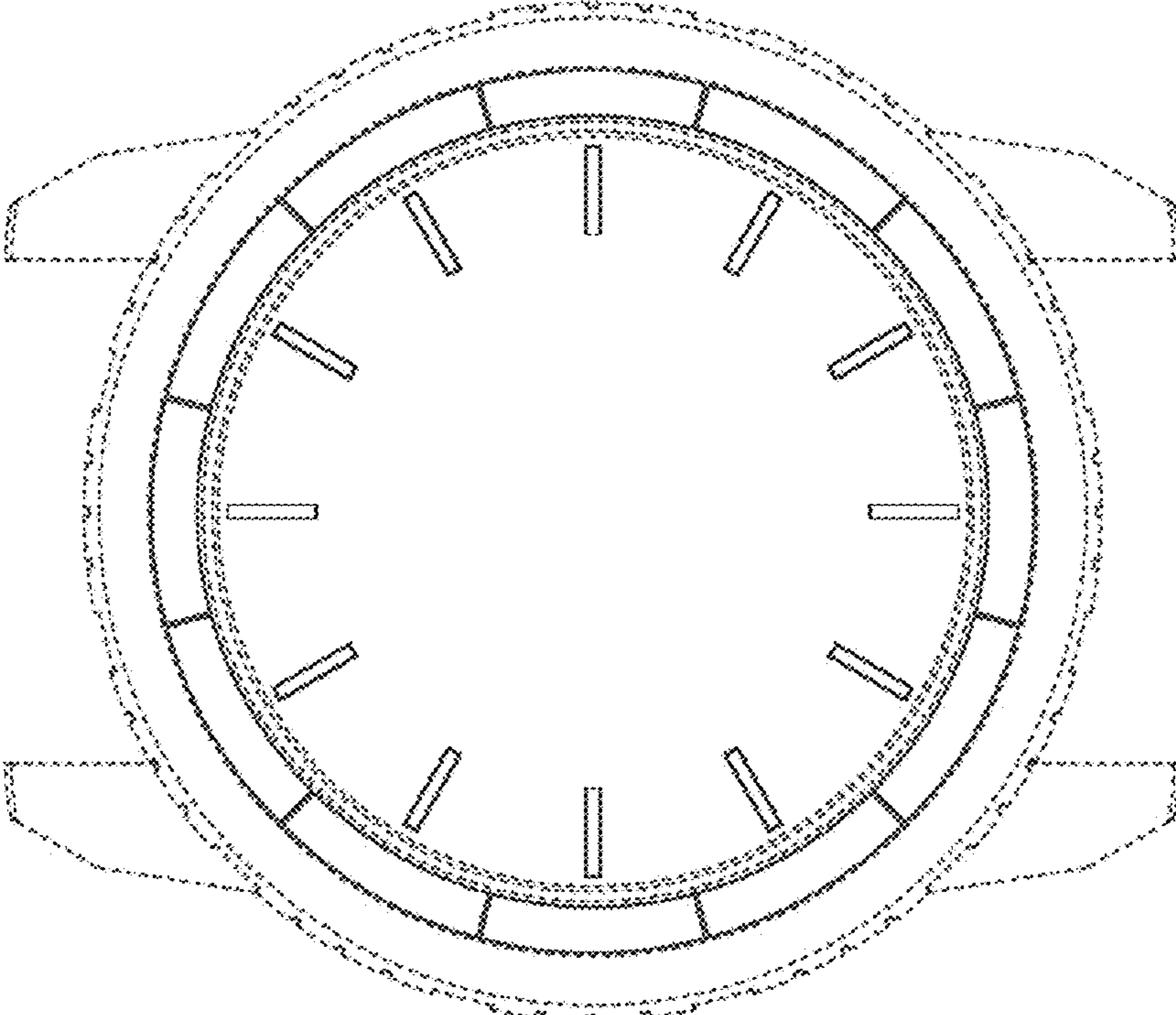

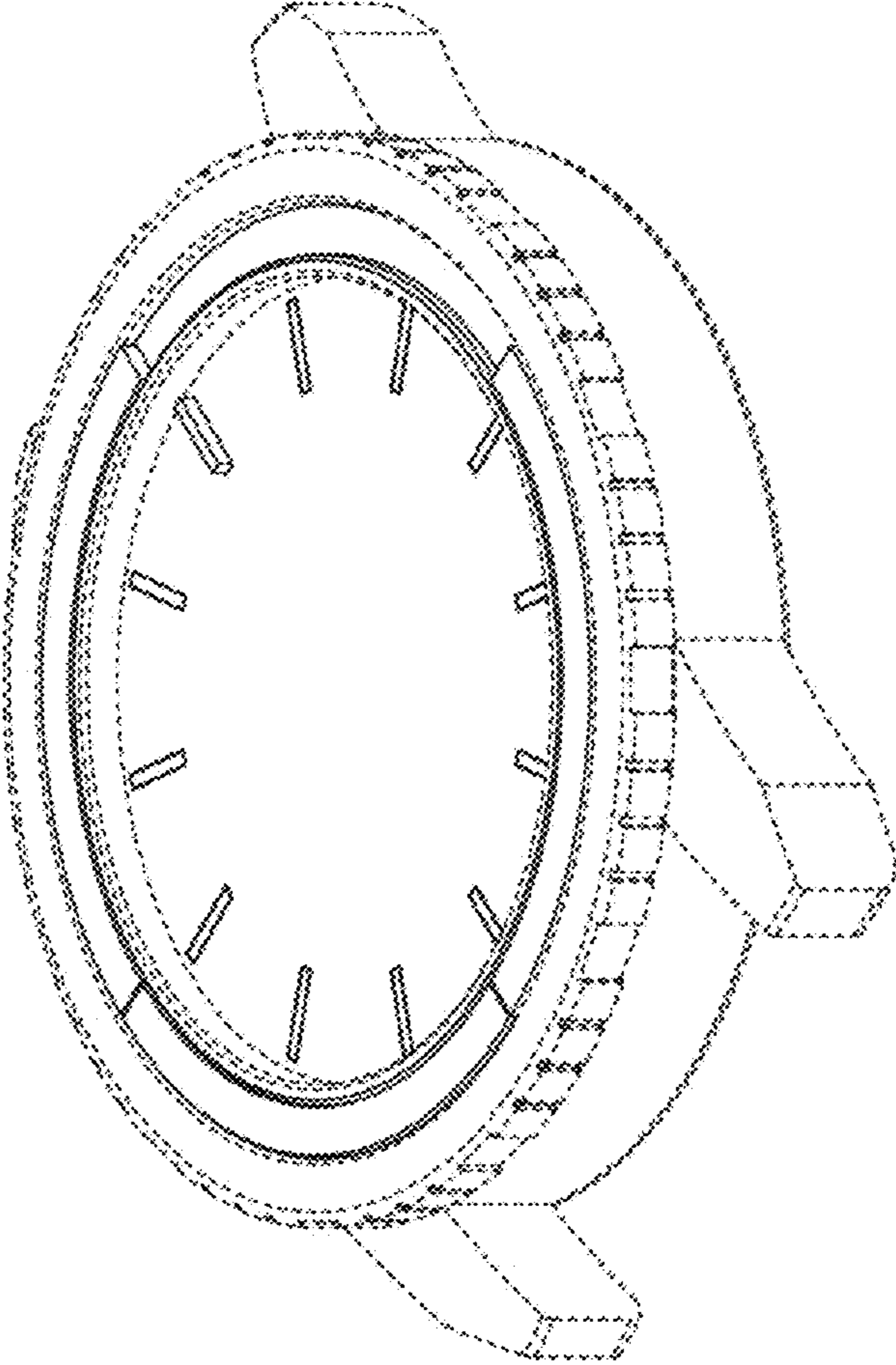

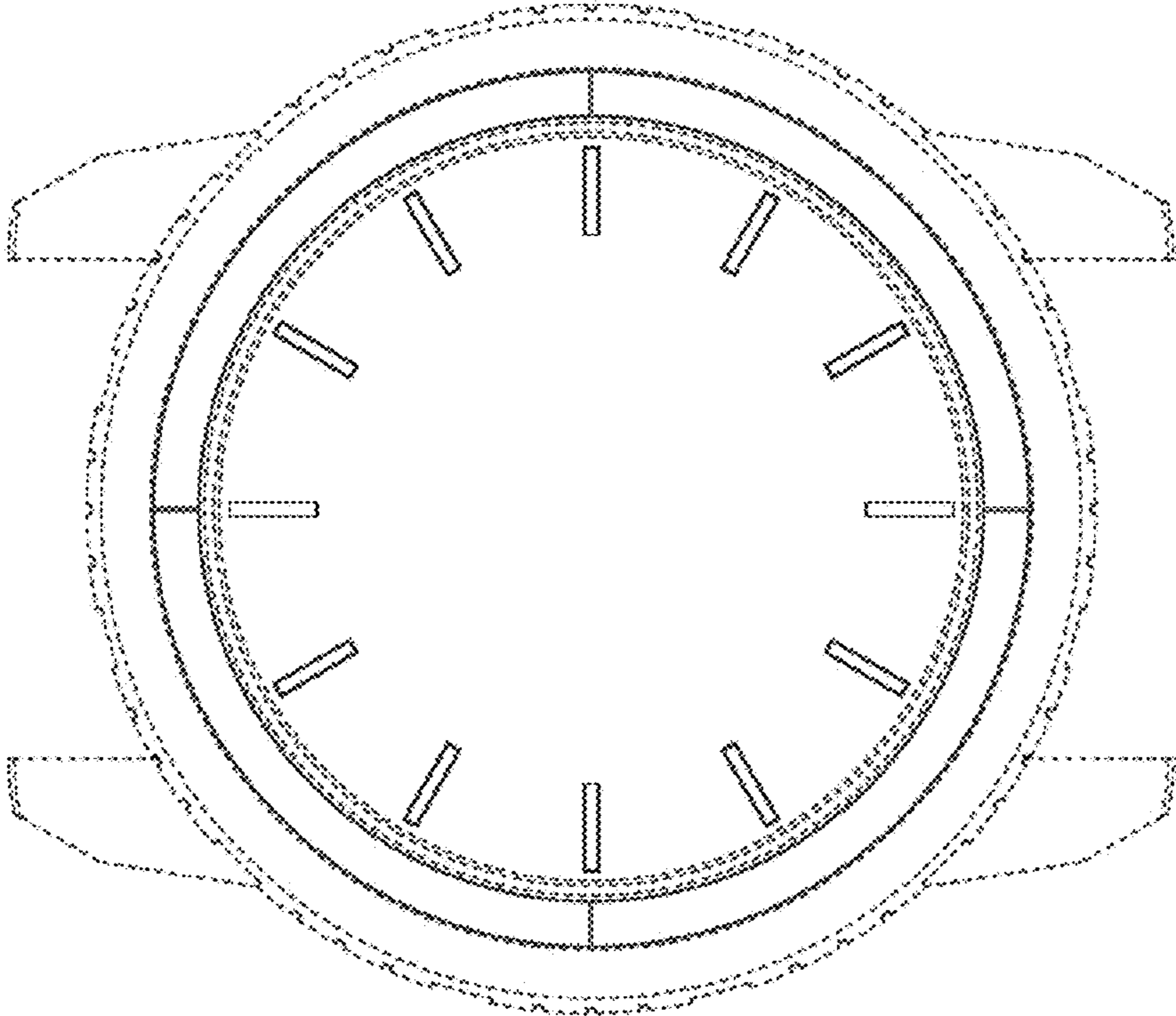

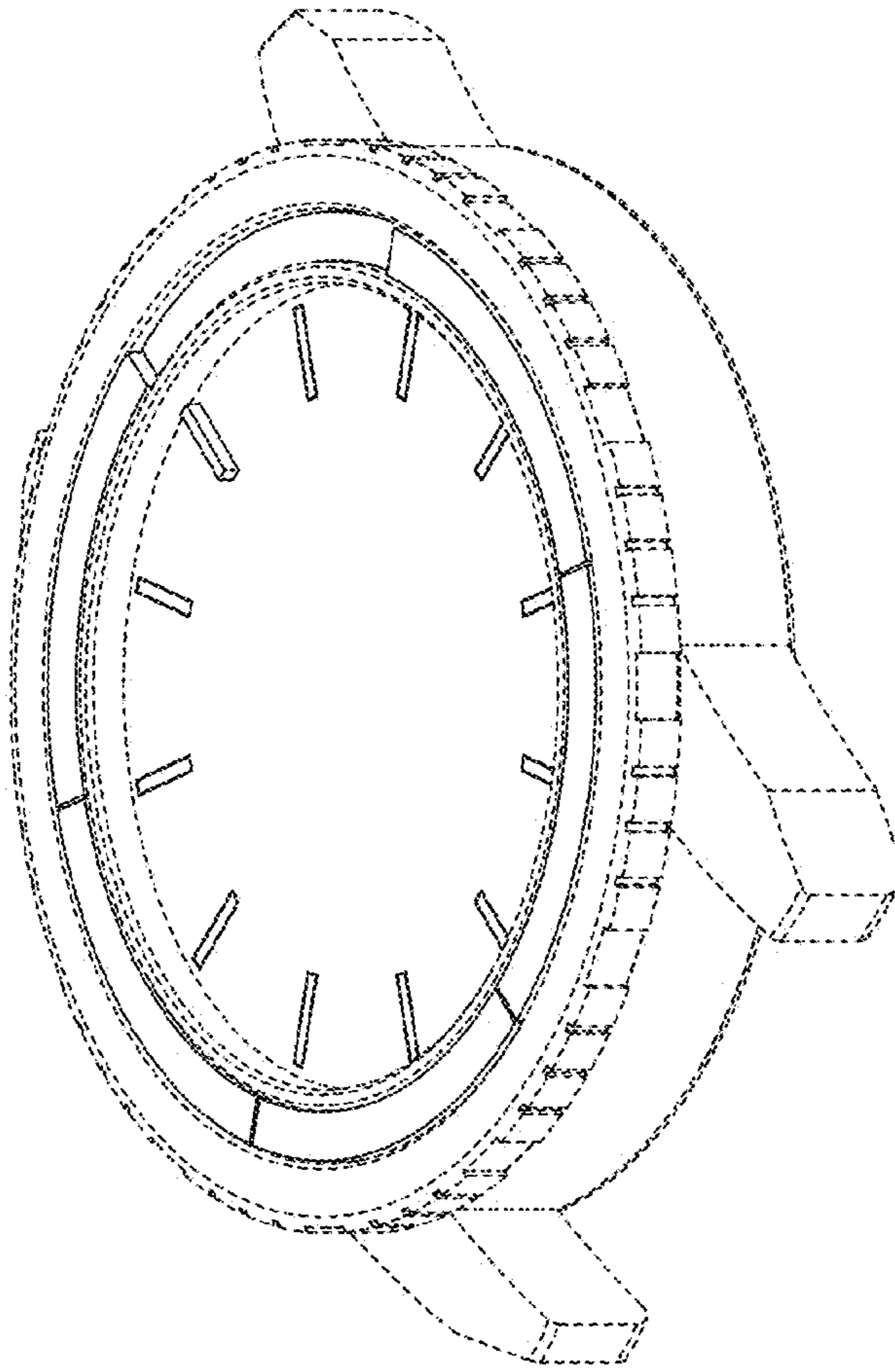

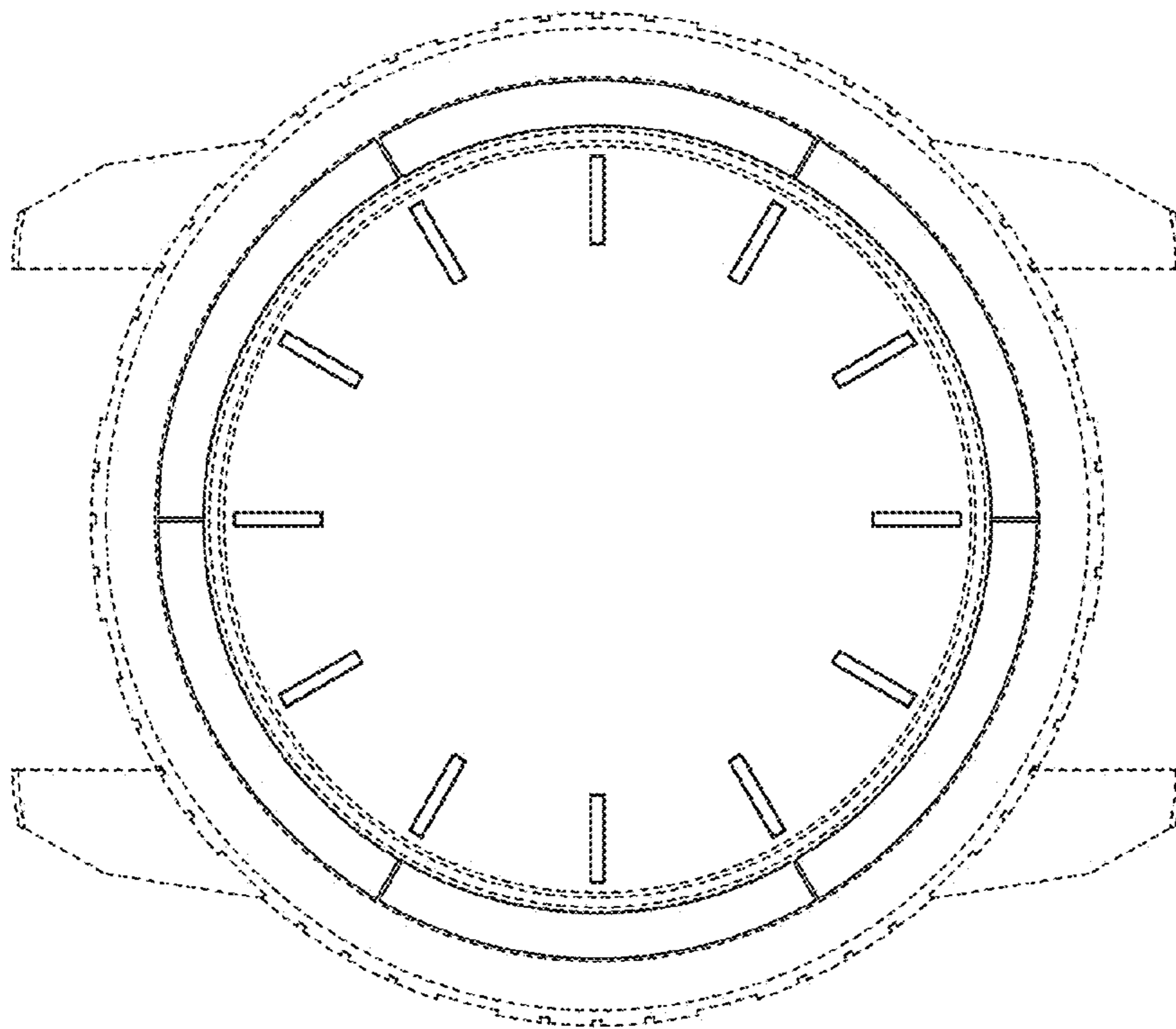

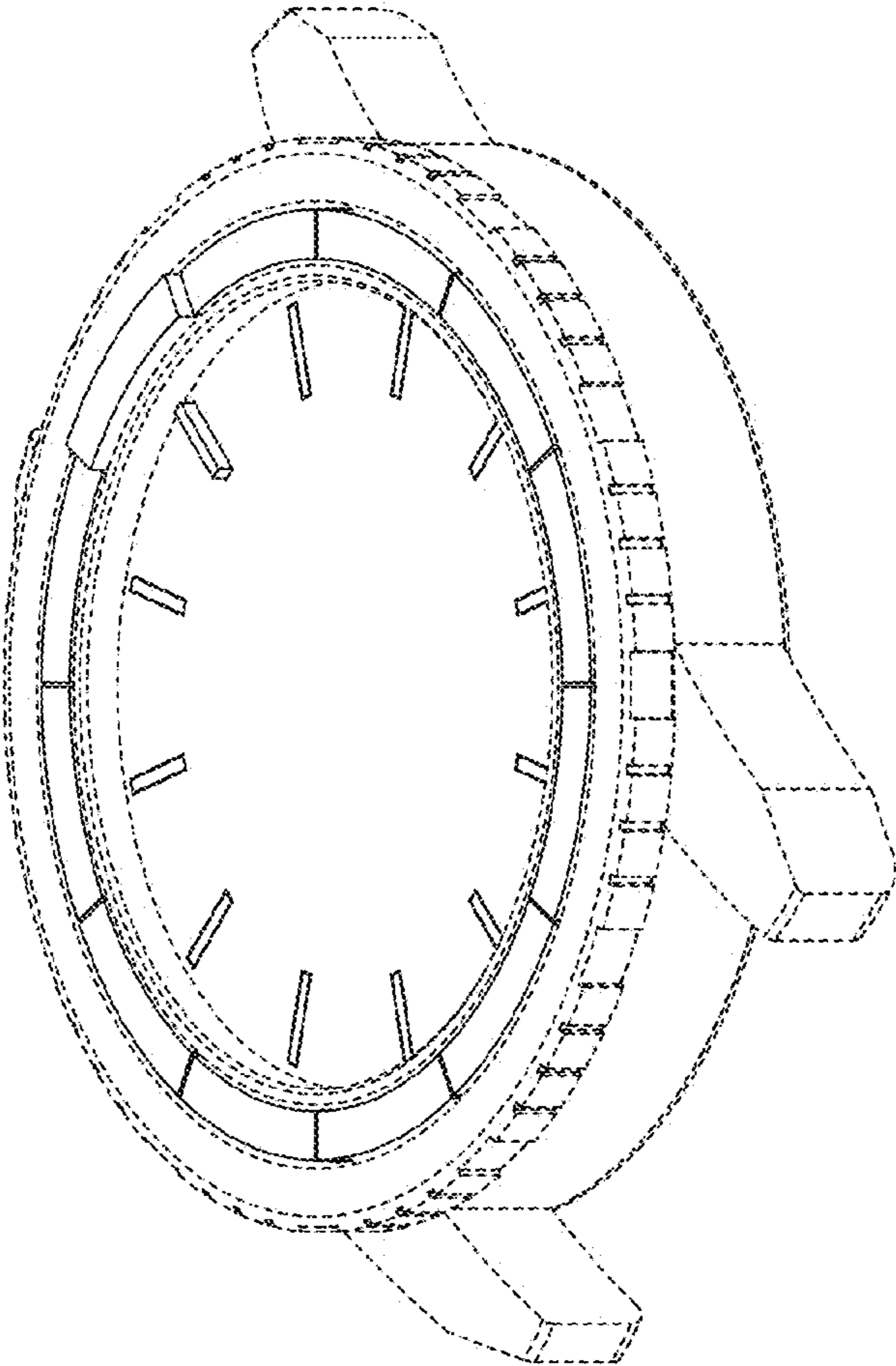

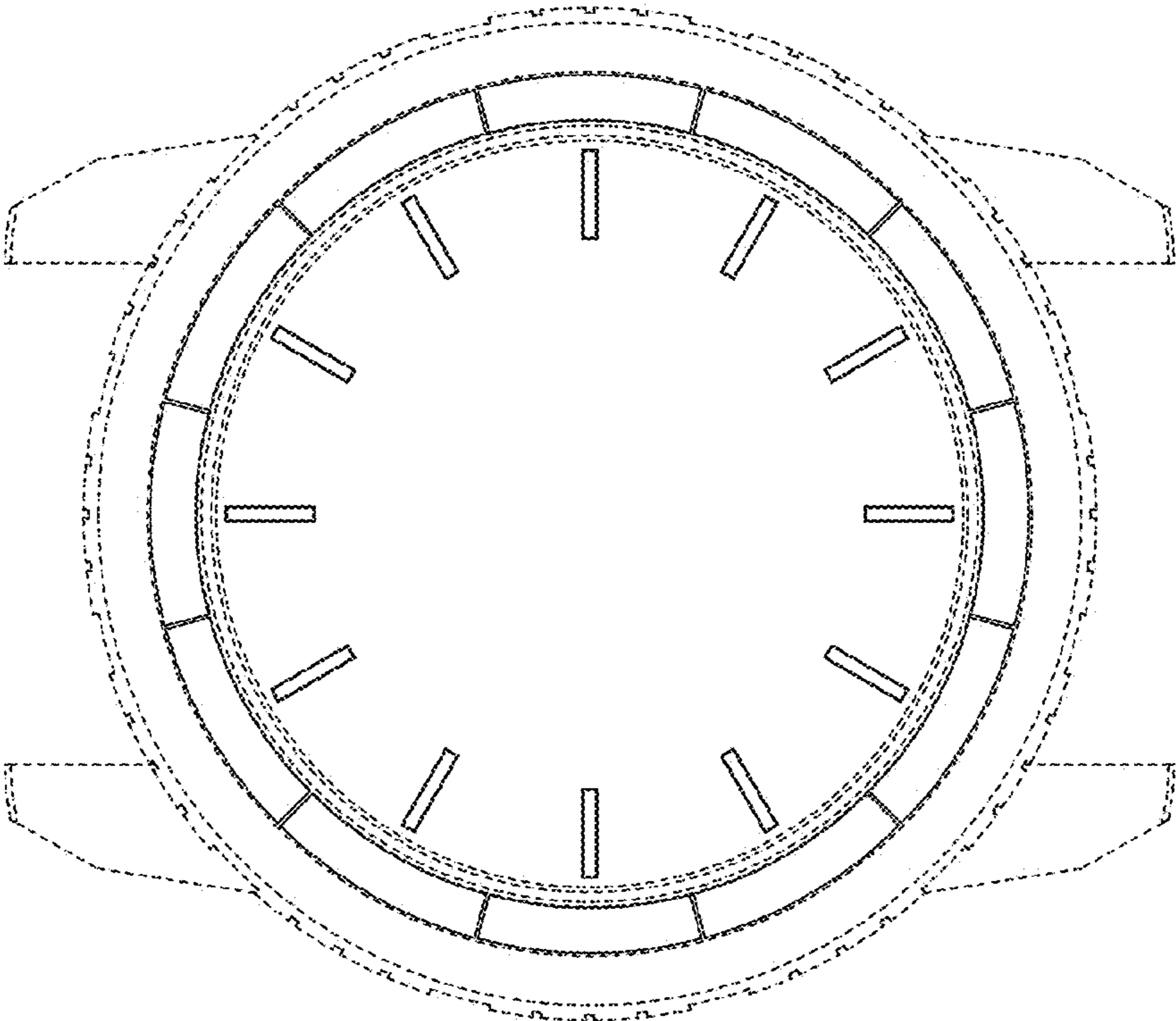

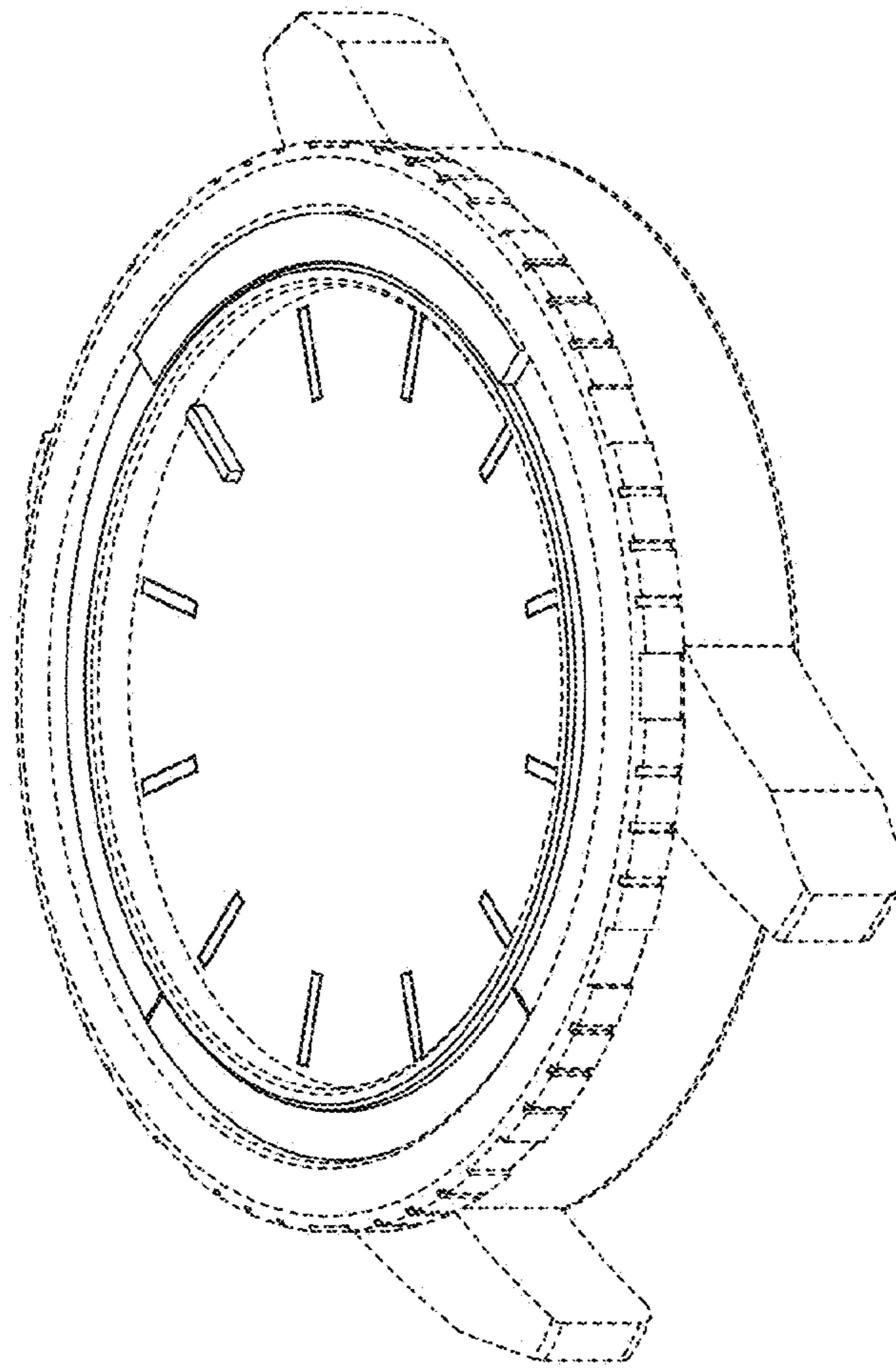

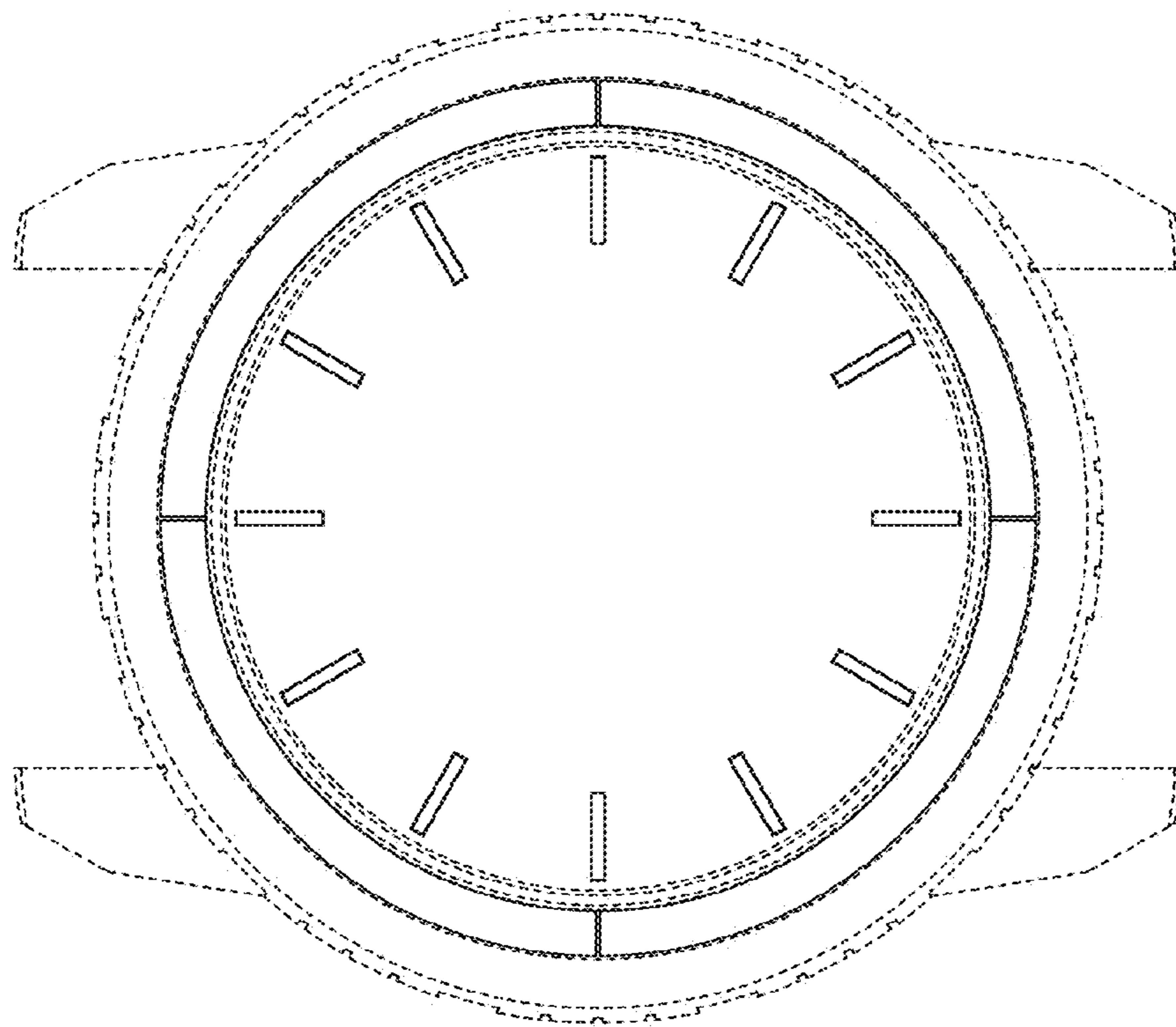

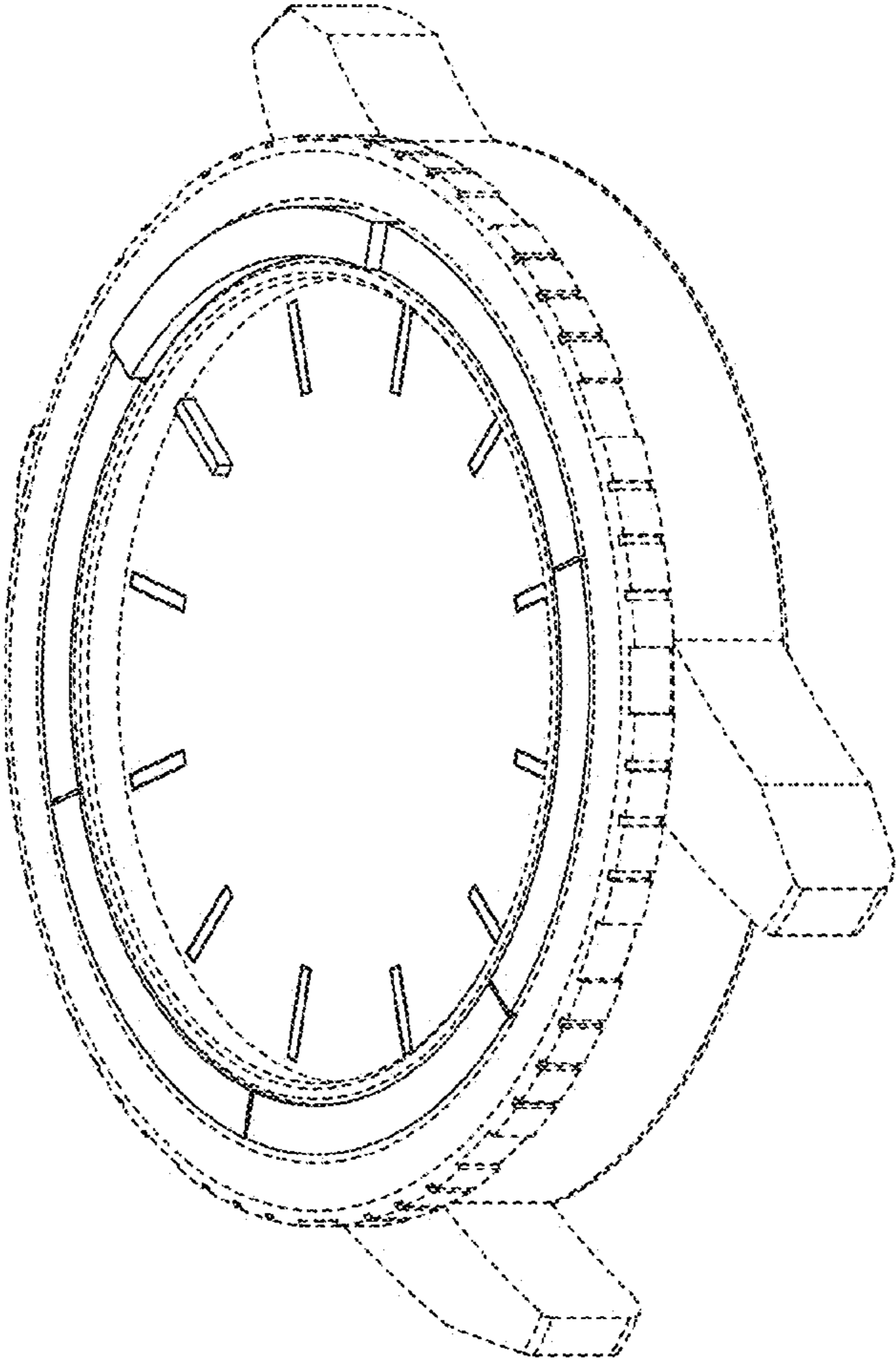
