(57) **CLAIM**

The ornamental design for a vertical takeoff and landing airplane, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view illustrating the top, right side and front a vertical takeoff and landing airplane which forms our new design, wherein the wings, propellers and tail thereof are shown in a horizontal orientation, the broken line representations of wheels and propeller blades in this and other figures showing environmental structure and forming no part of the claimed design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;

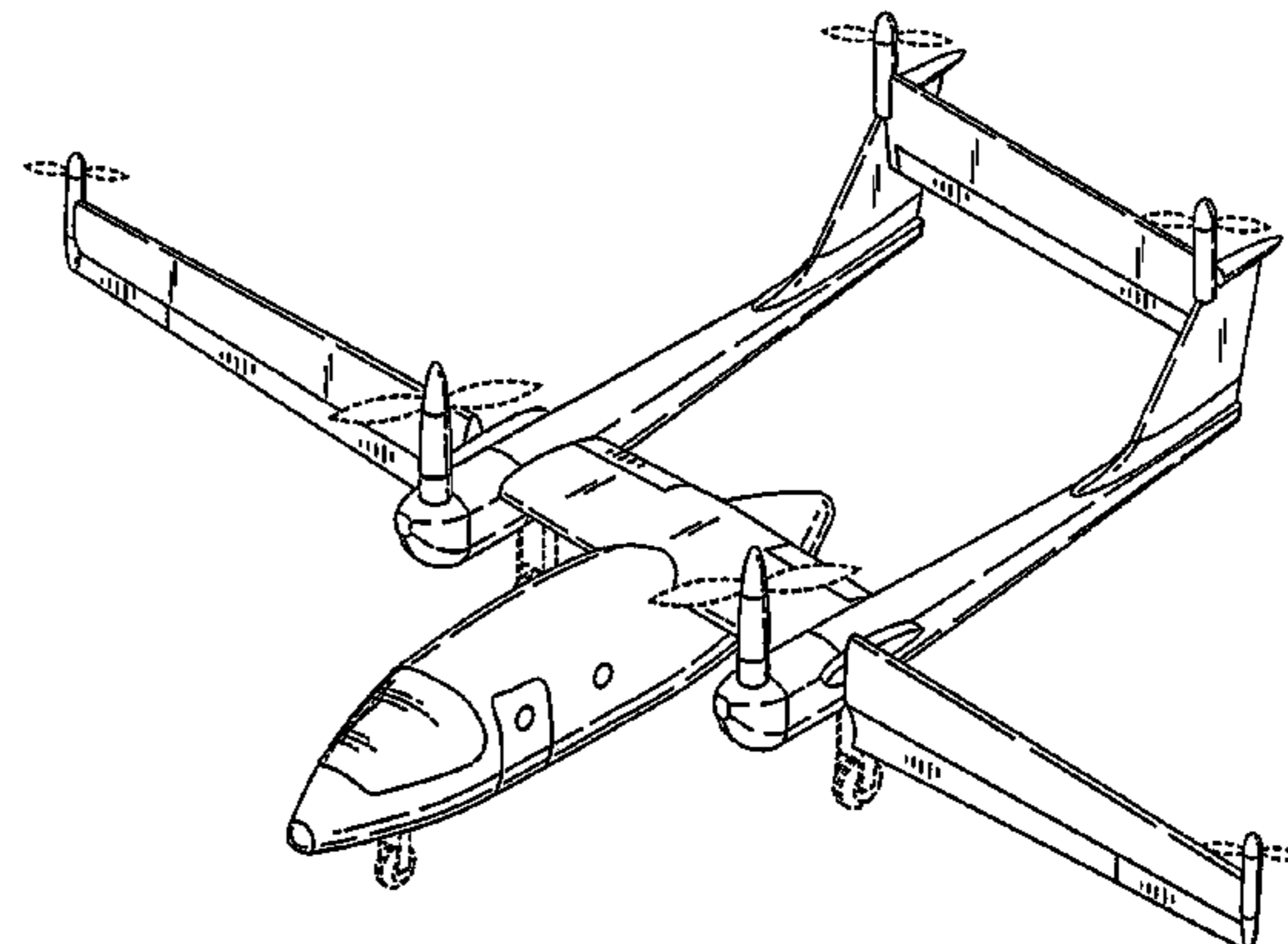
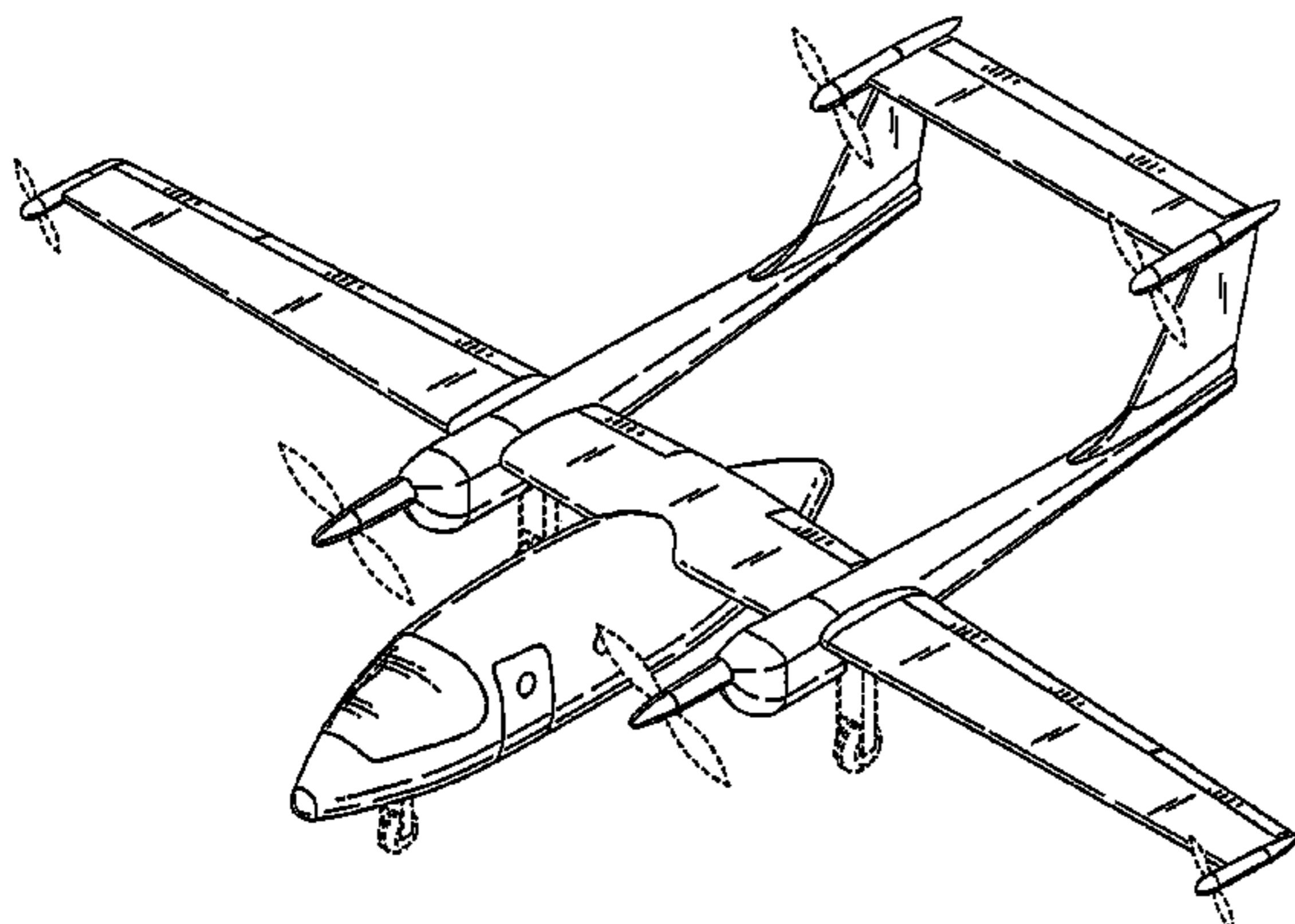
FIG. 5 is a left side elevational view thereof;

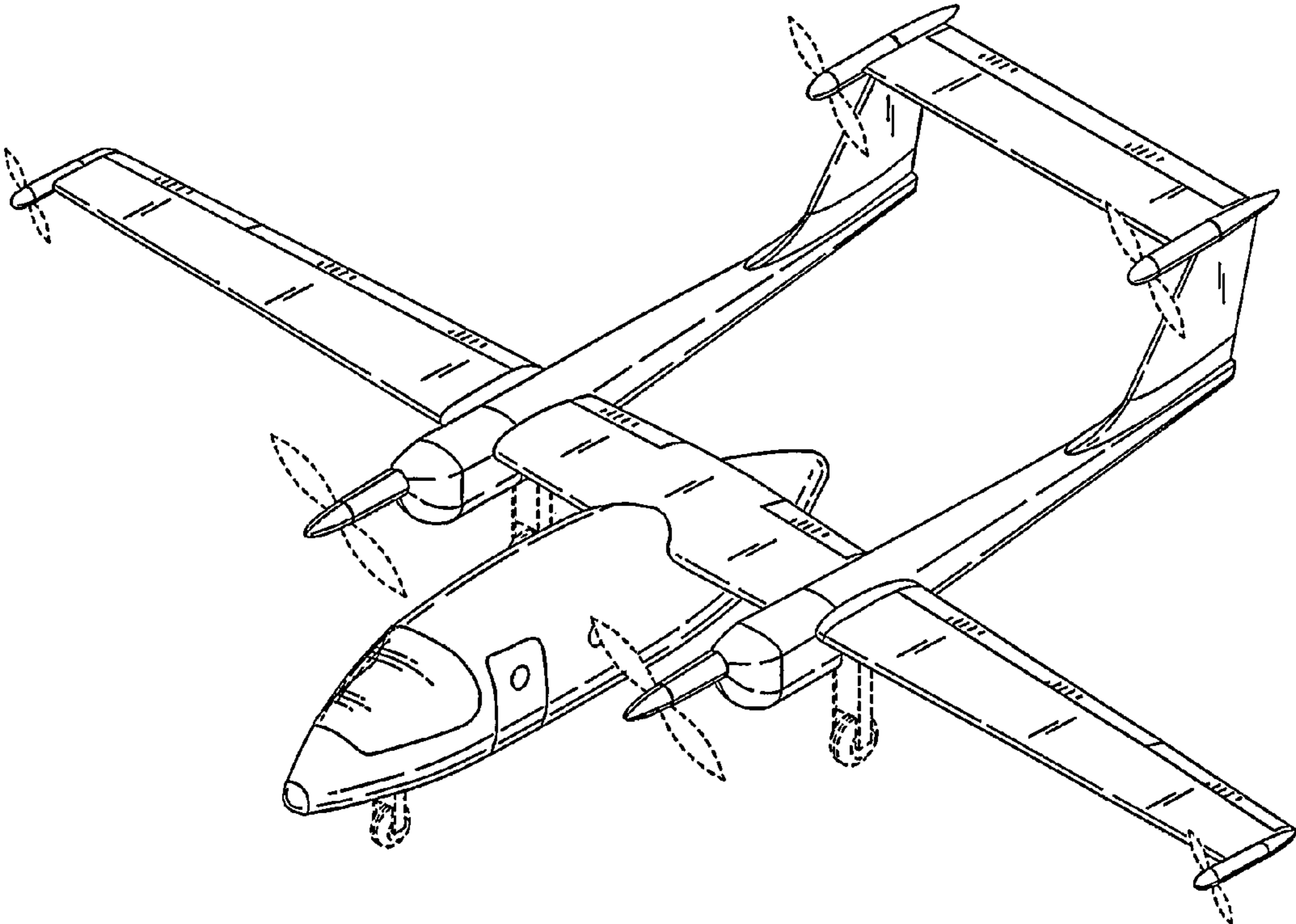

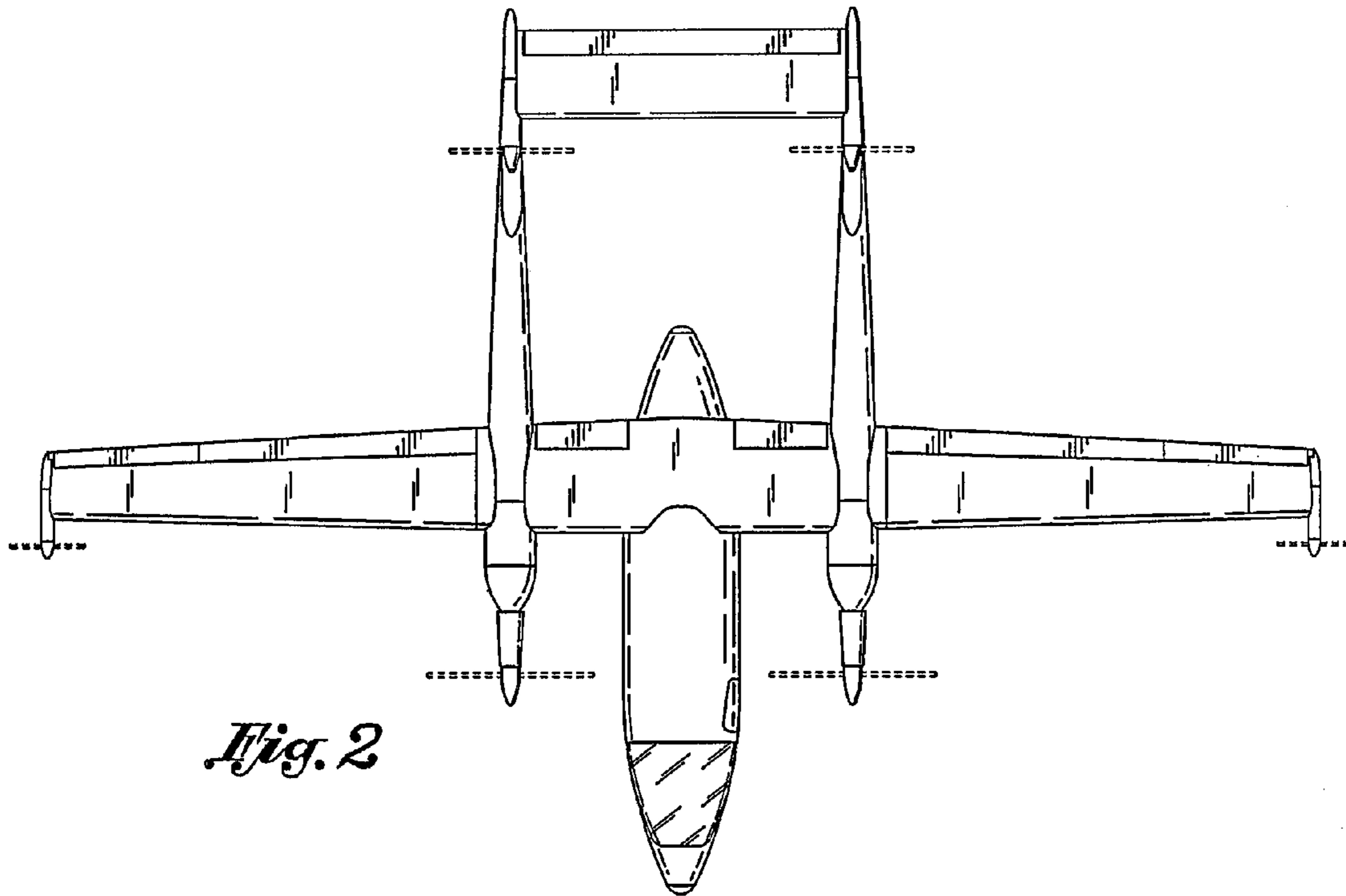

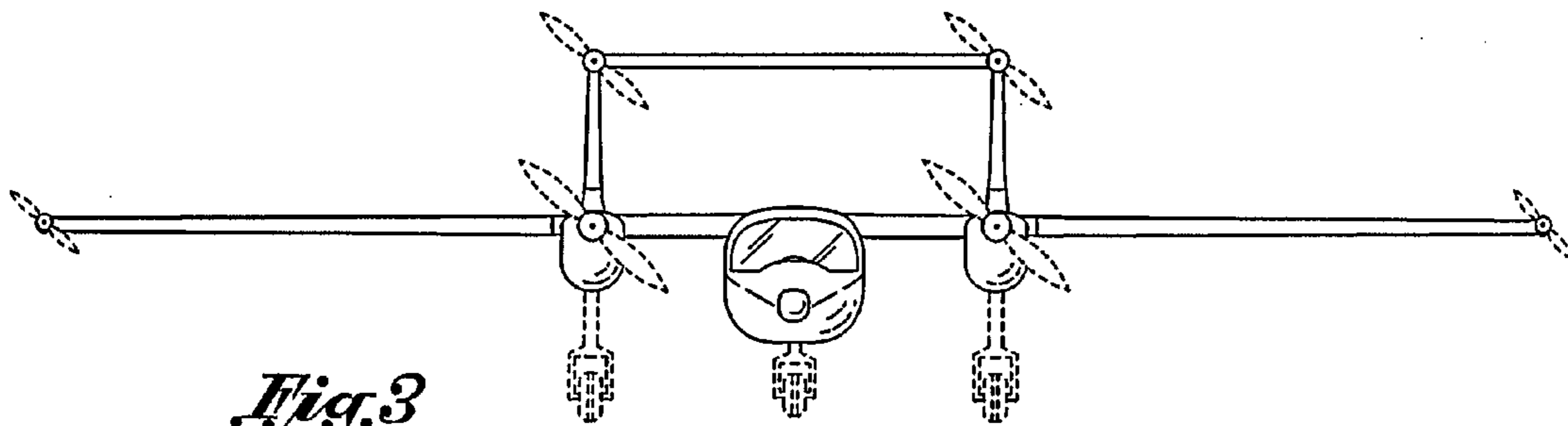

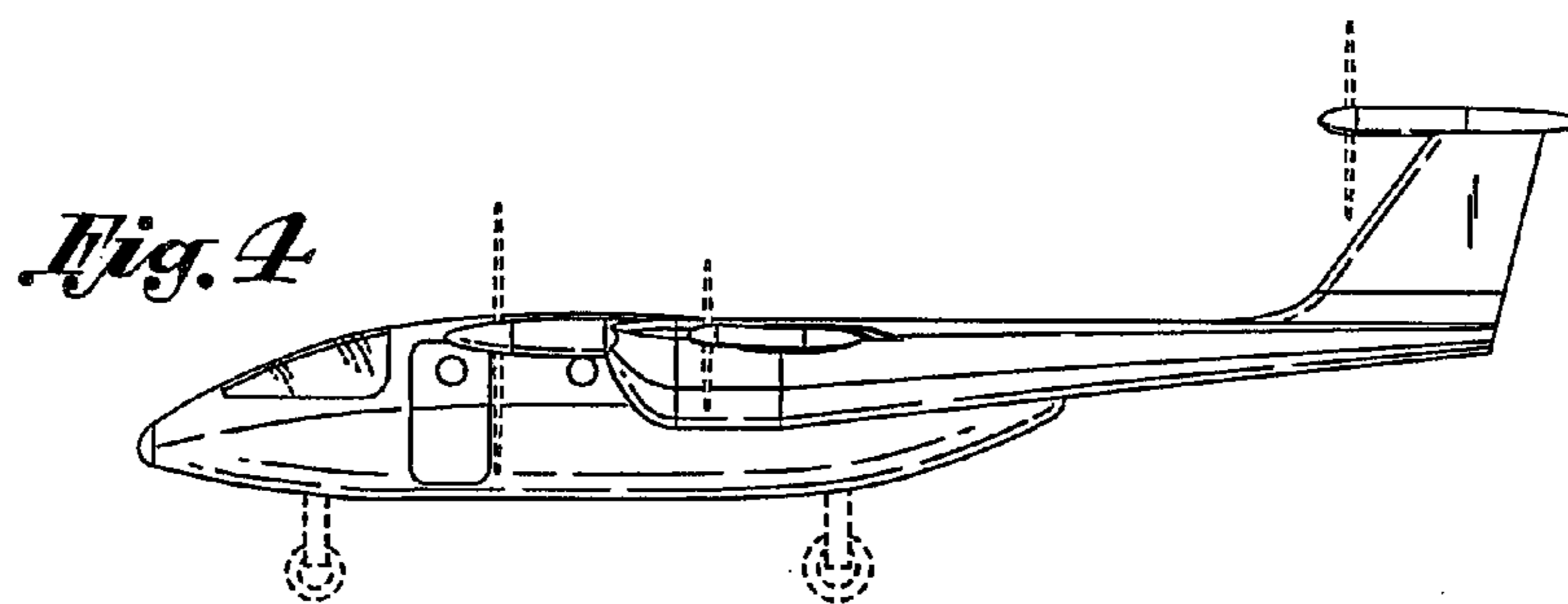

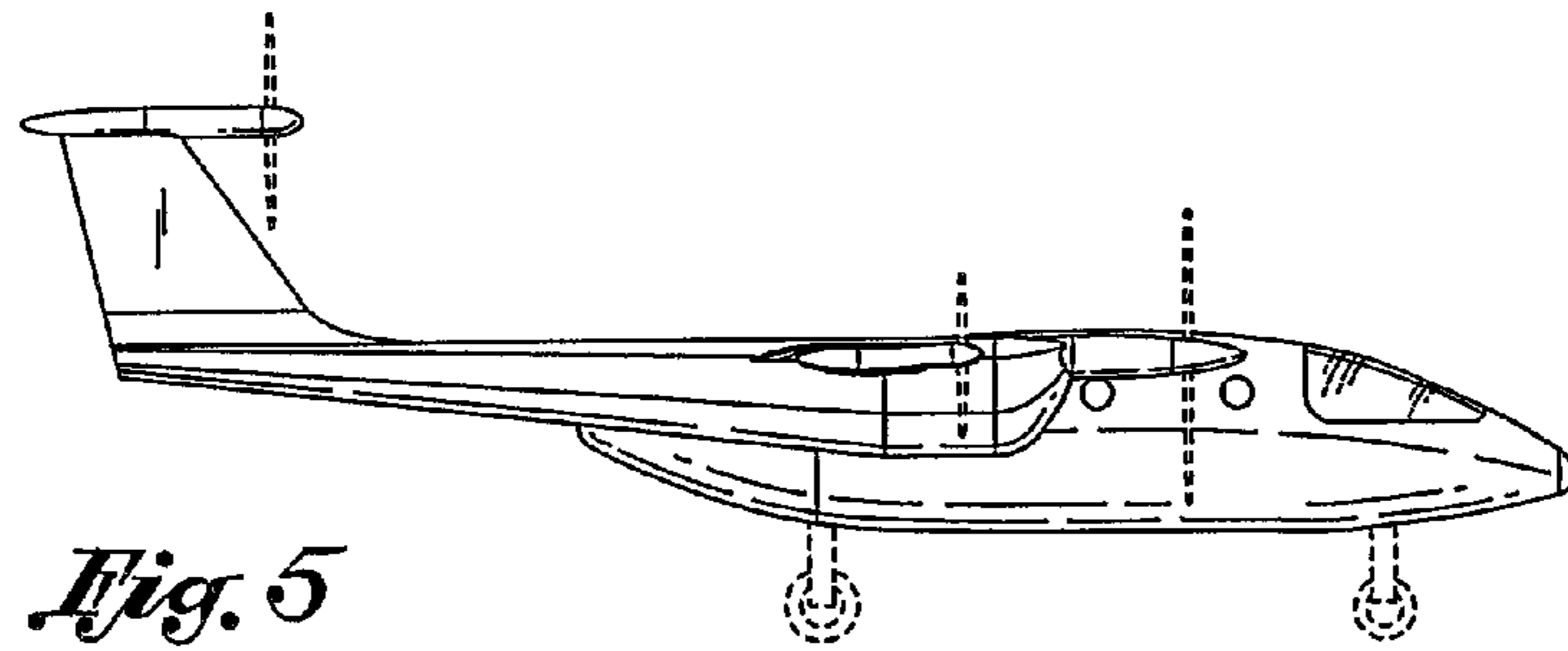

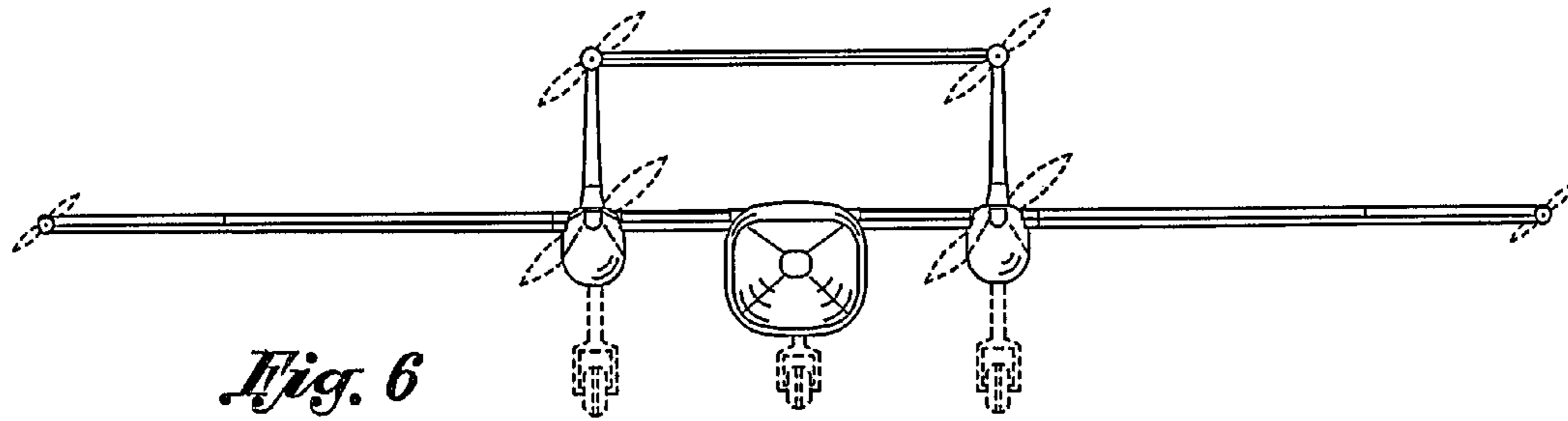

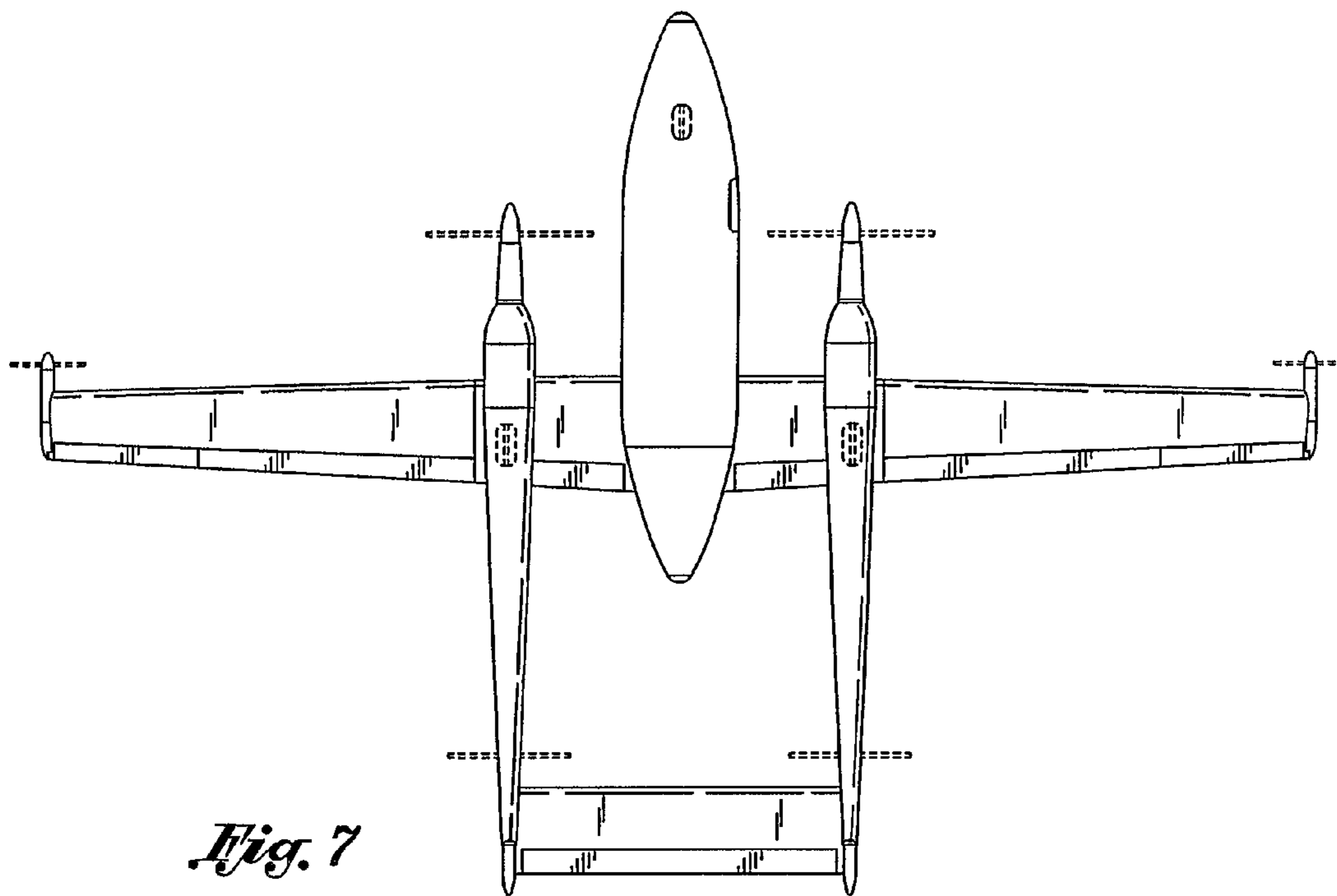

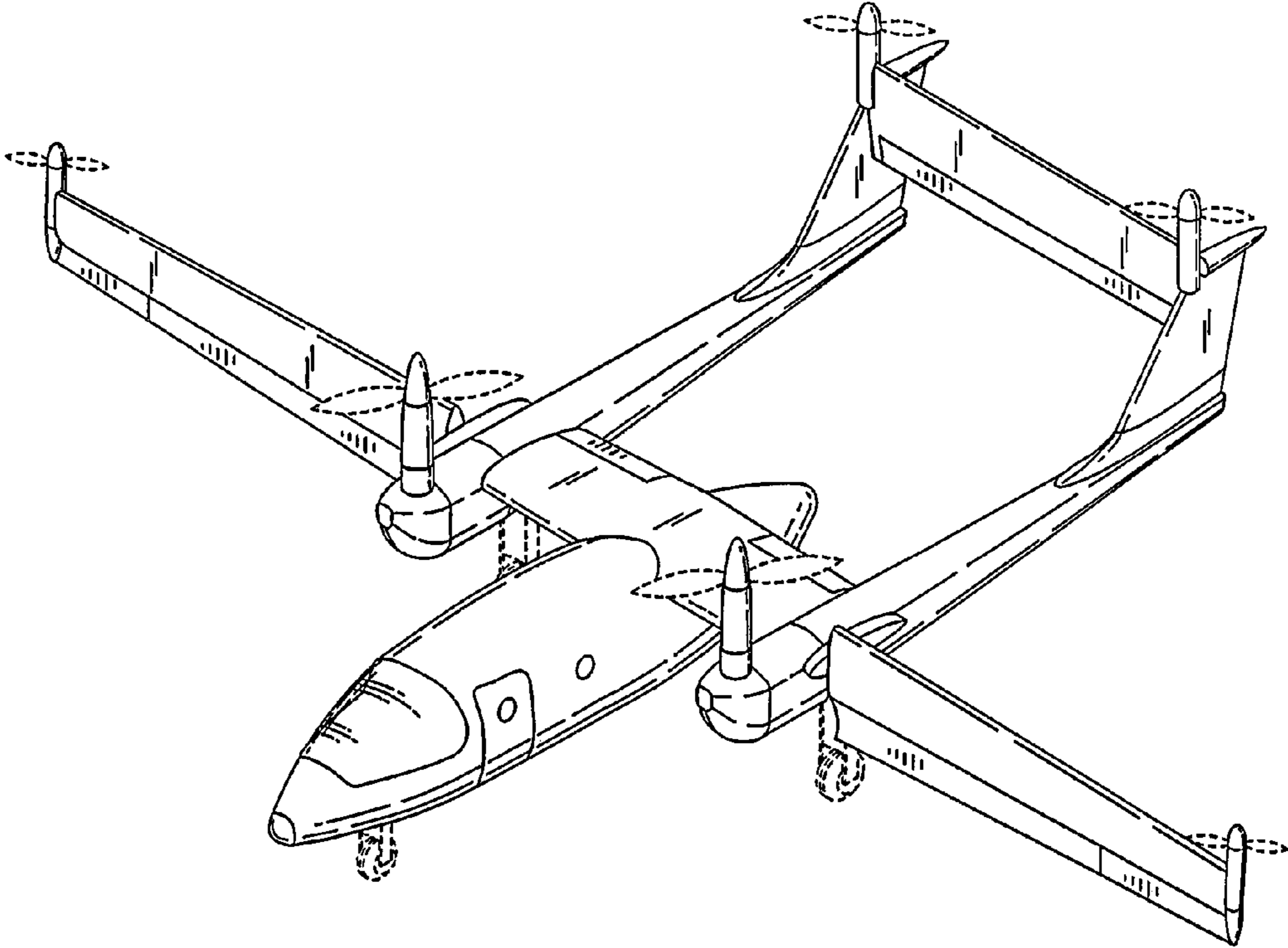
