The ornamental design for a tire, as shown.

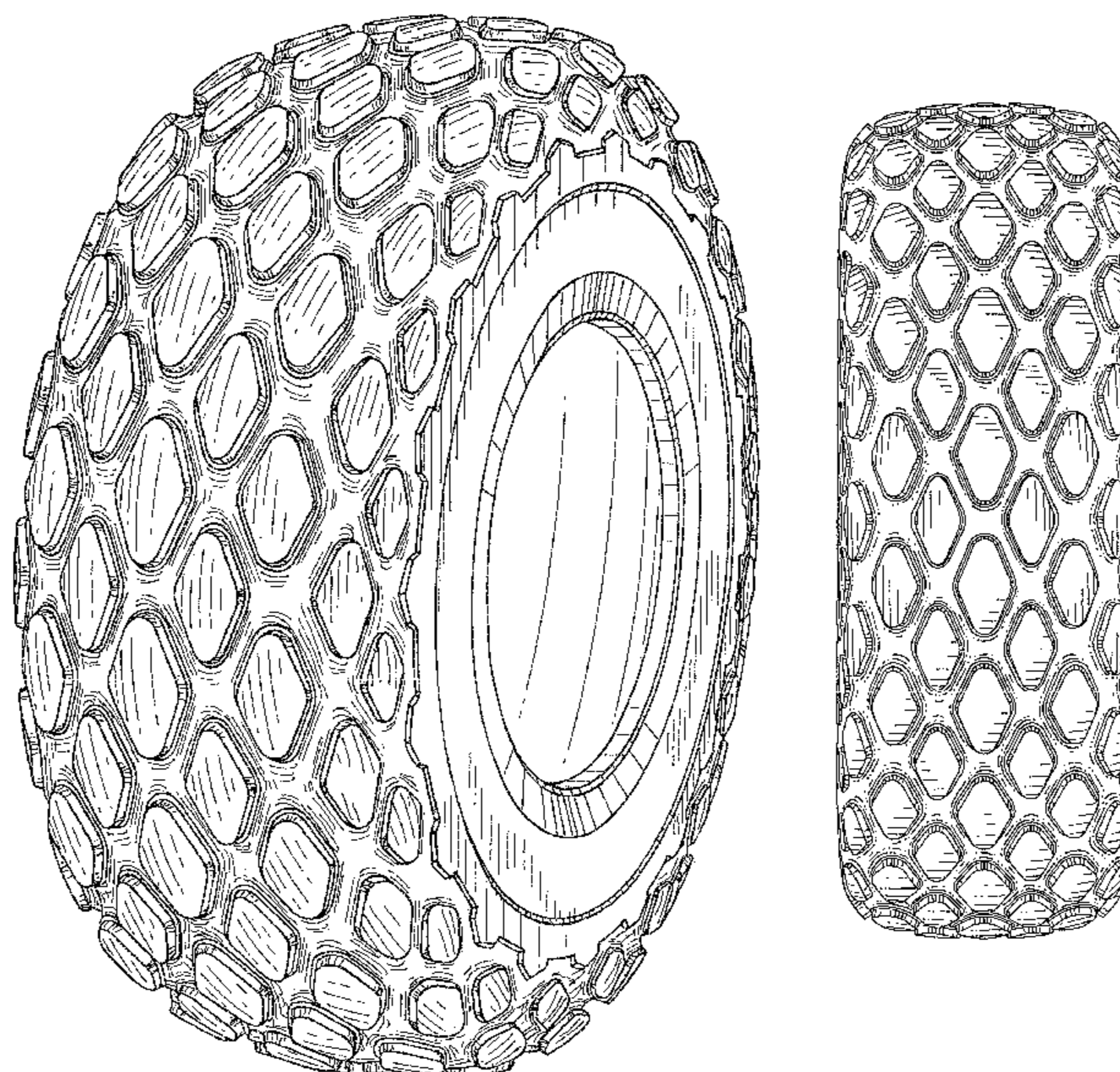
**DESCRIPTION**

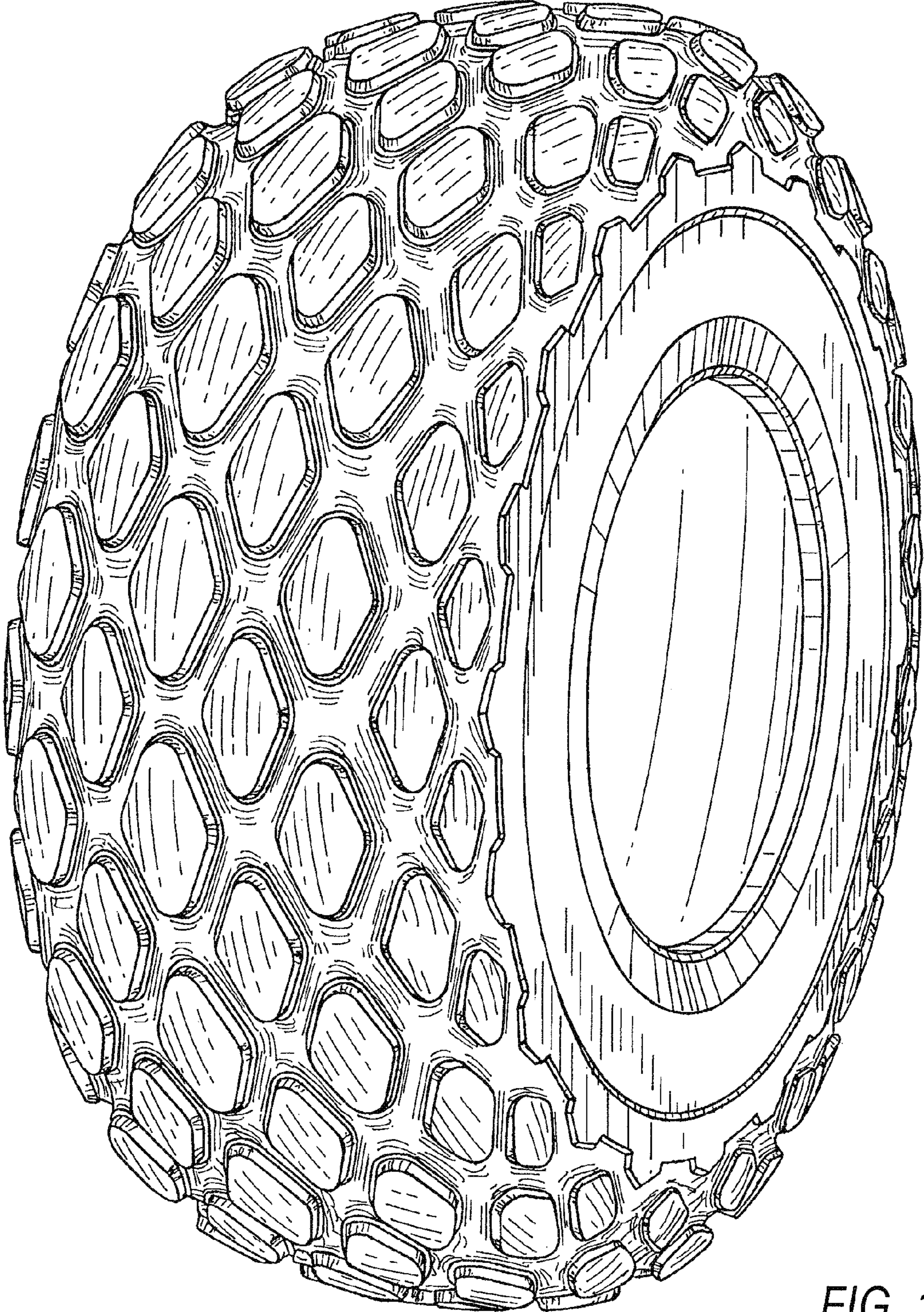

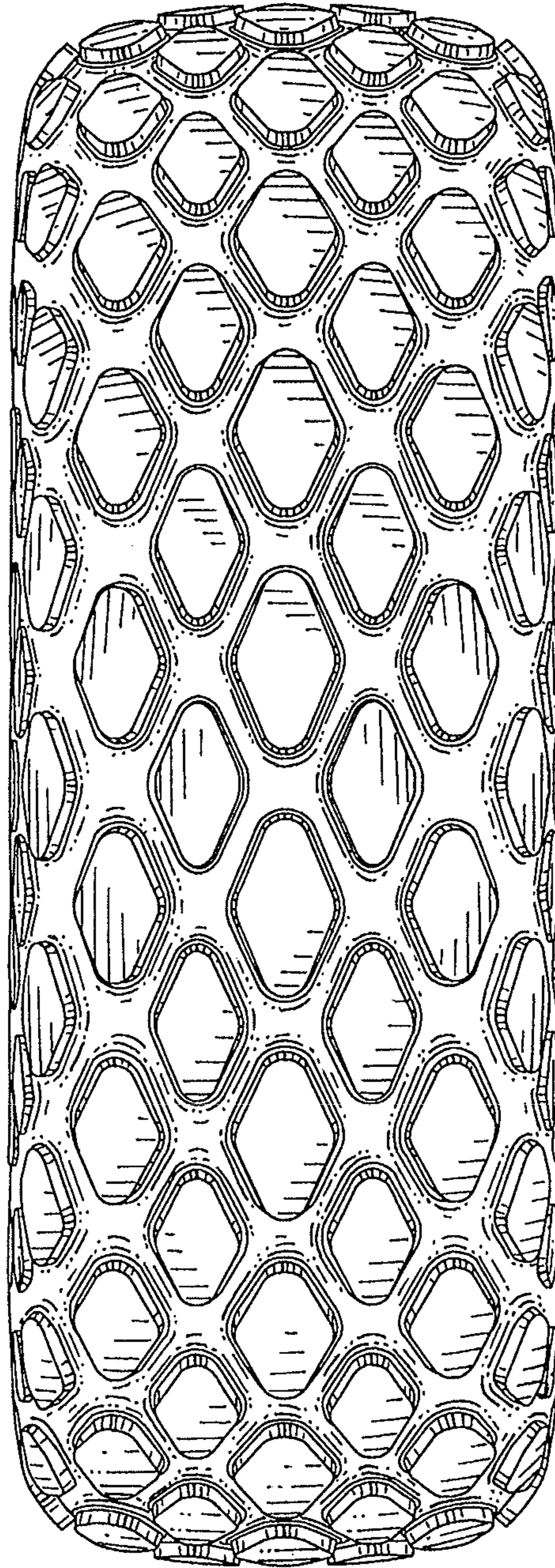

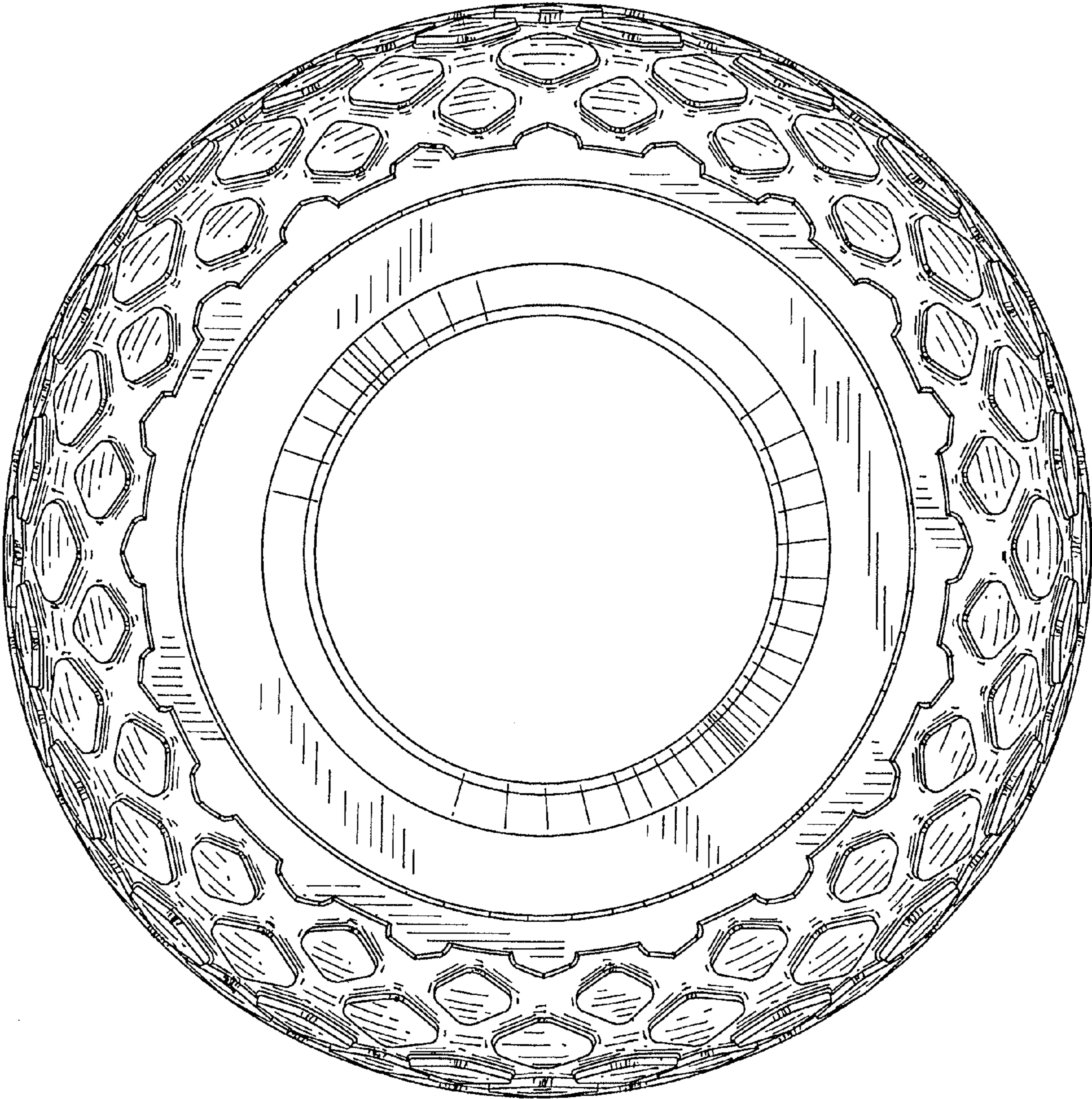
