We claim the ornamental design for a speaker for television receivers, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a speaker for television receivers showing our new design;
FIG. 2 is a front elevation view thereof;

FIG. 4 is a left-side elevation view thereof;

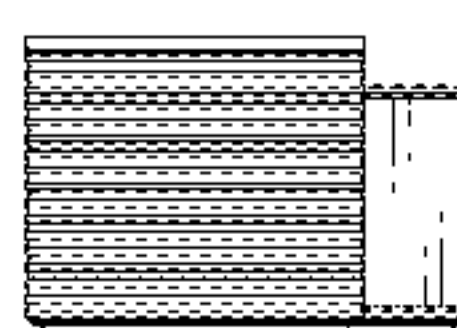
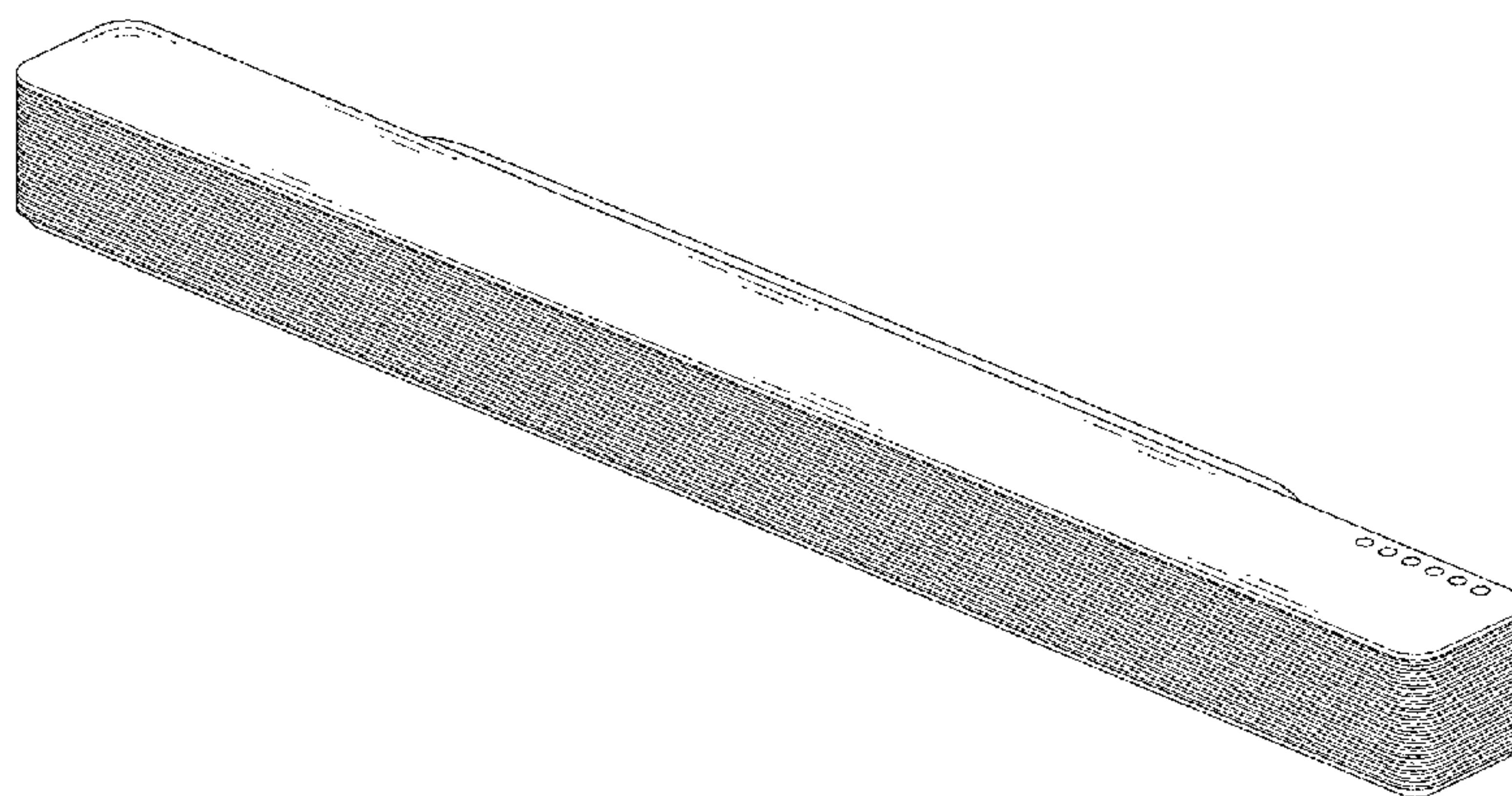

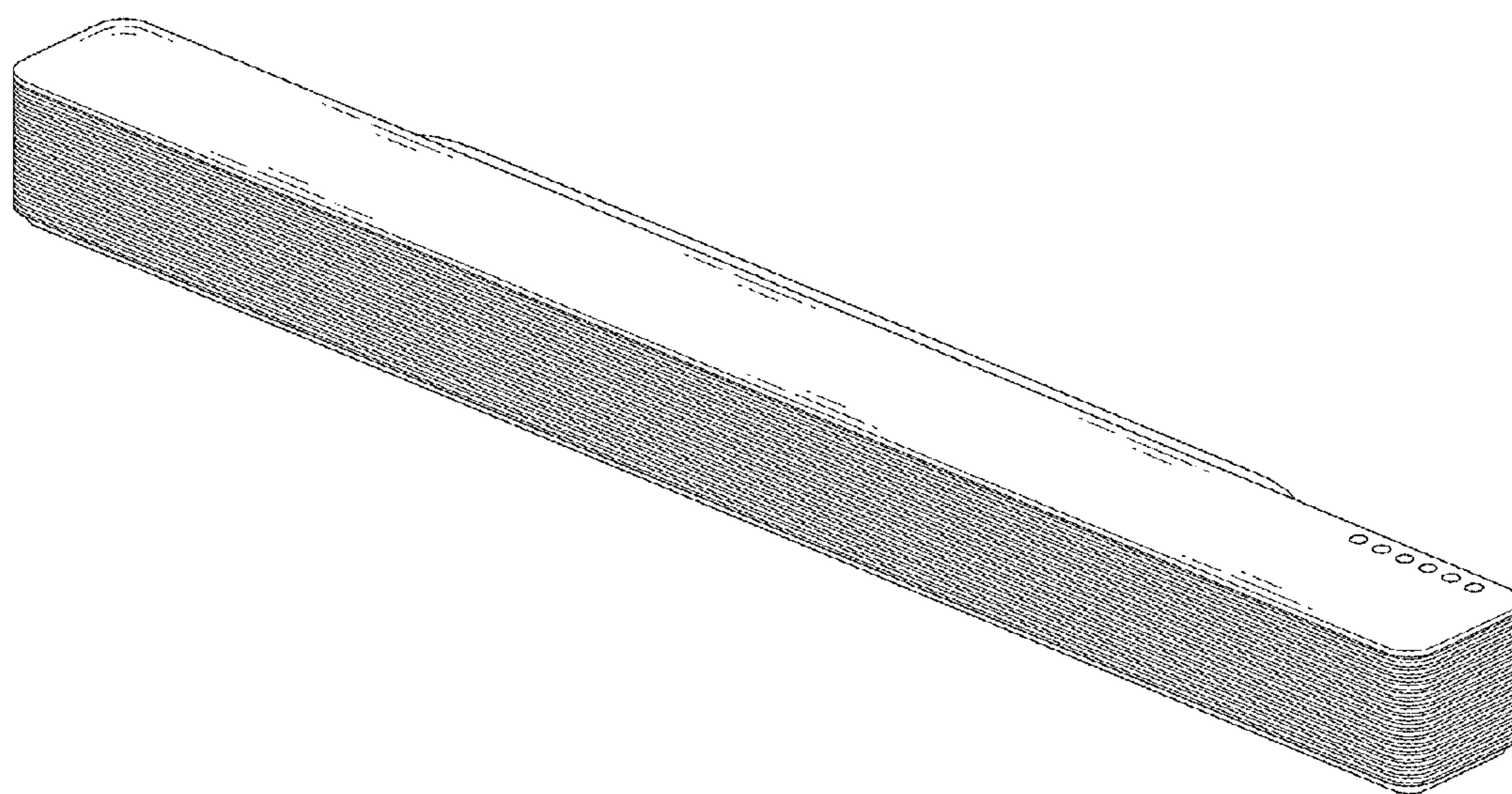

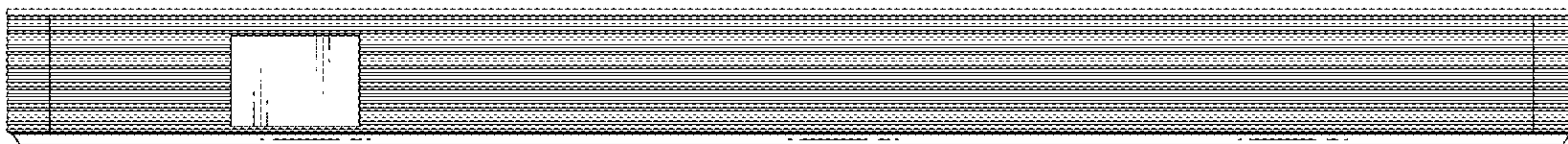

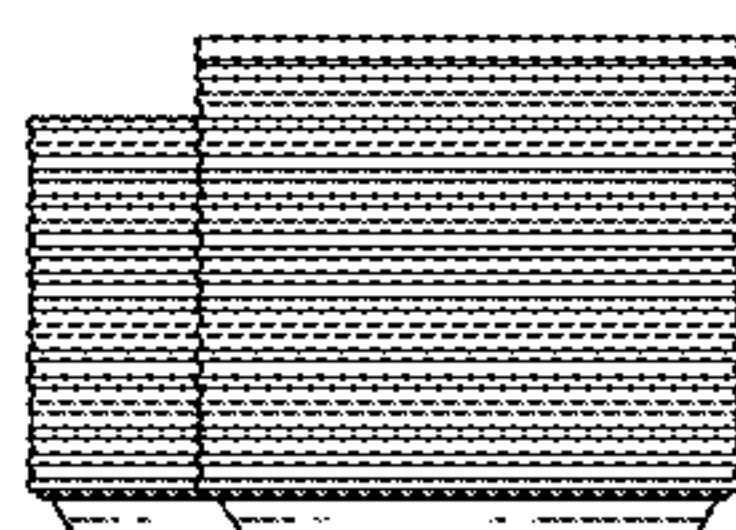

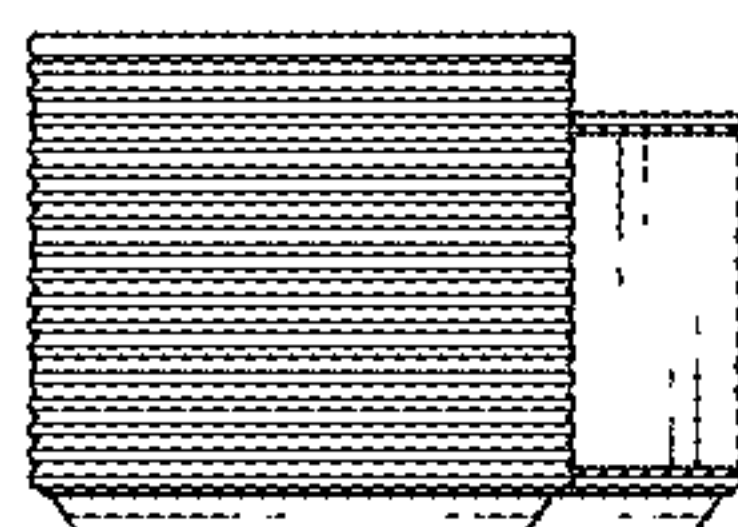

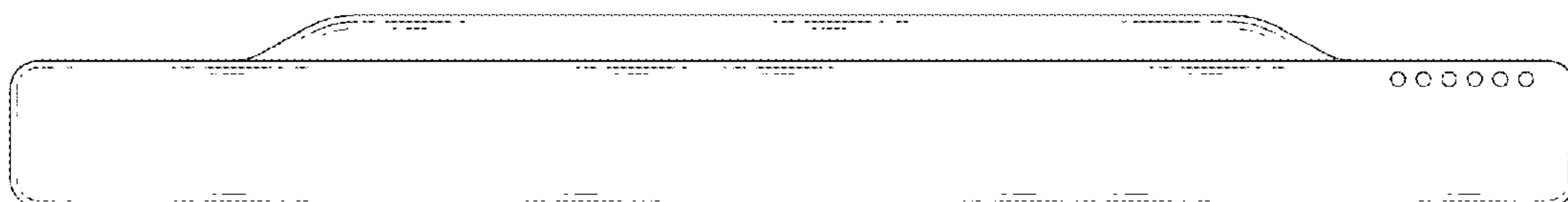
