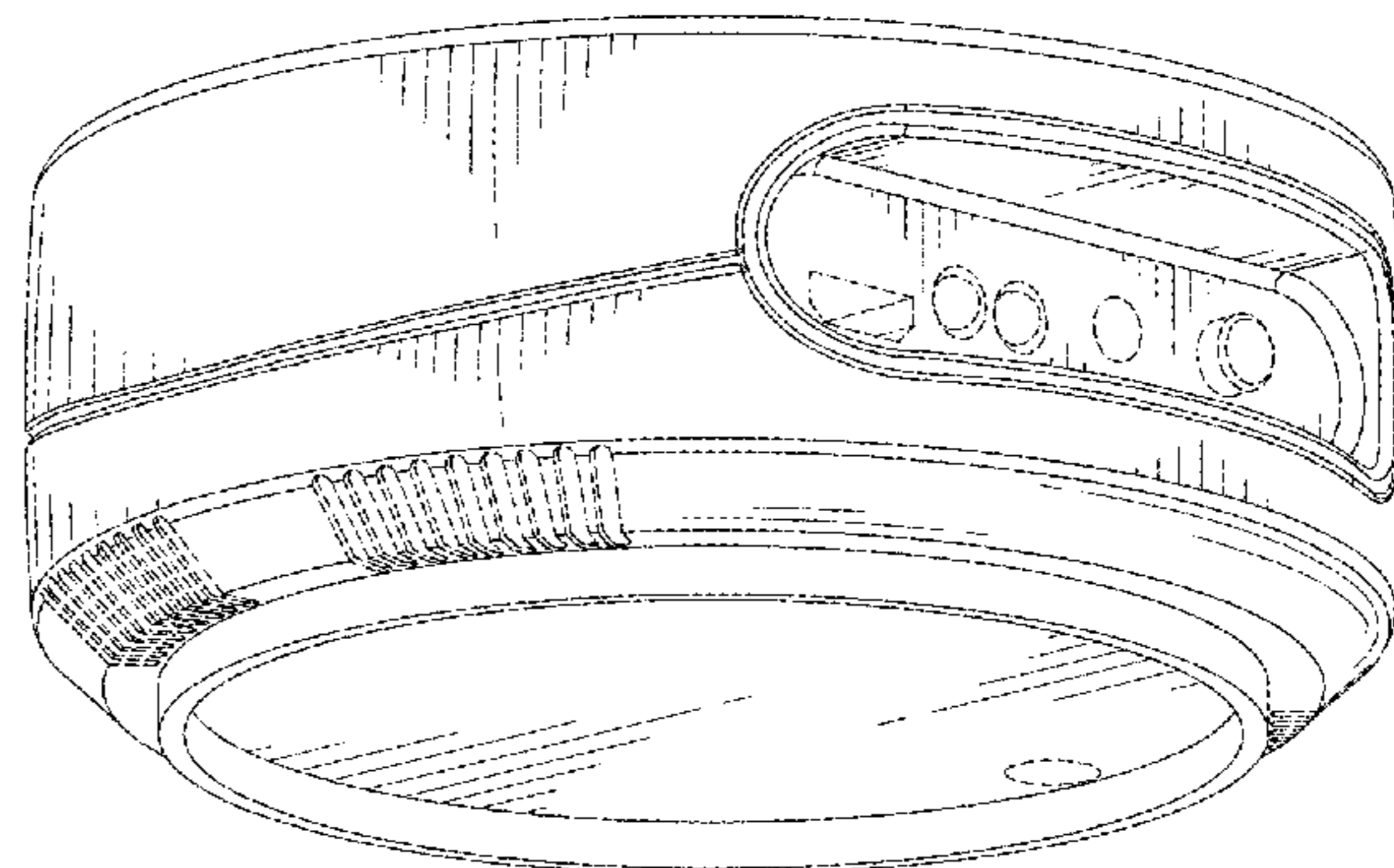
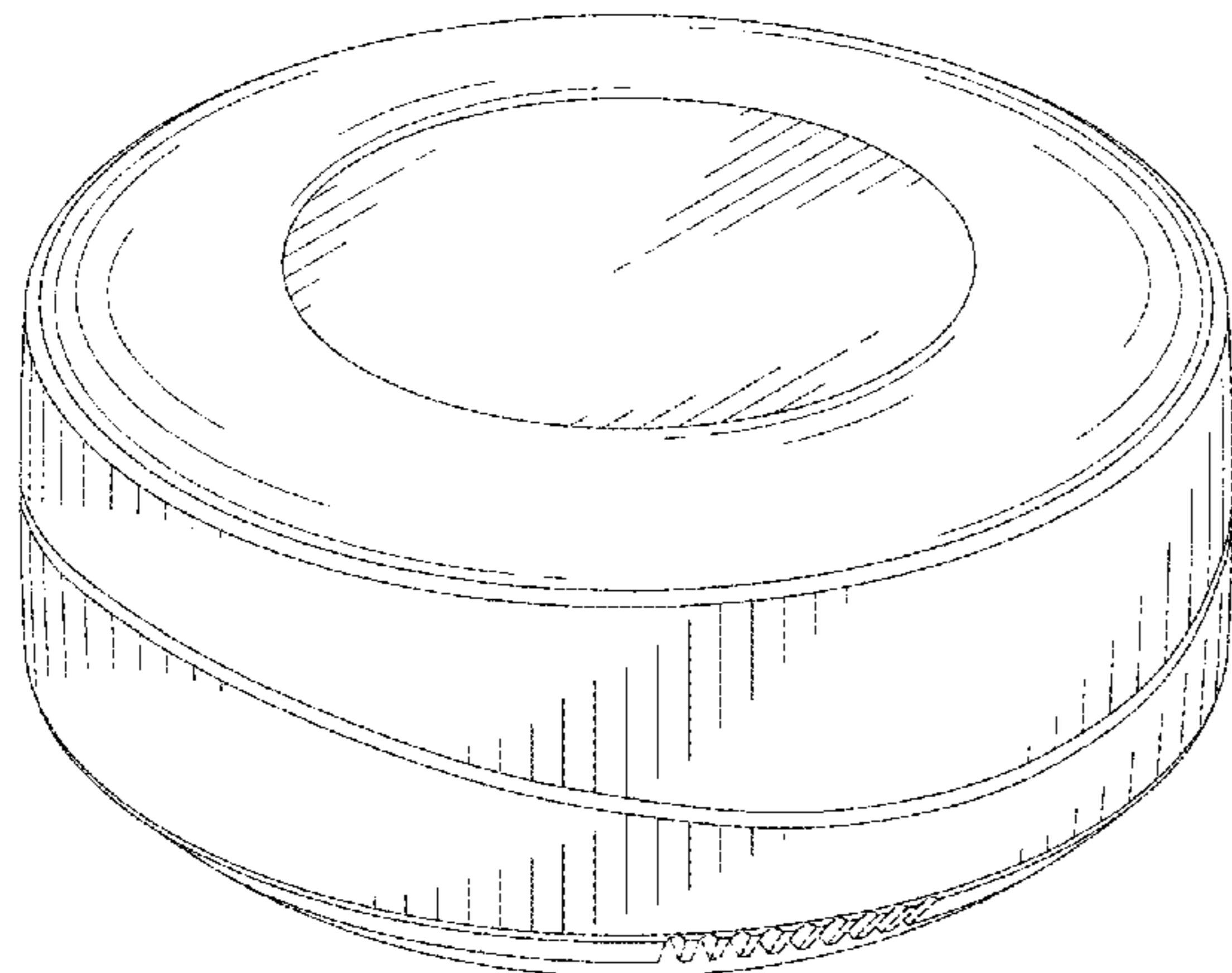
The ornamental design for a “cloud infrared controller,” as shown and described.

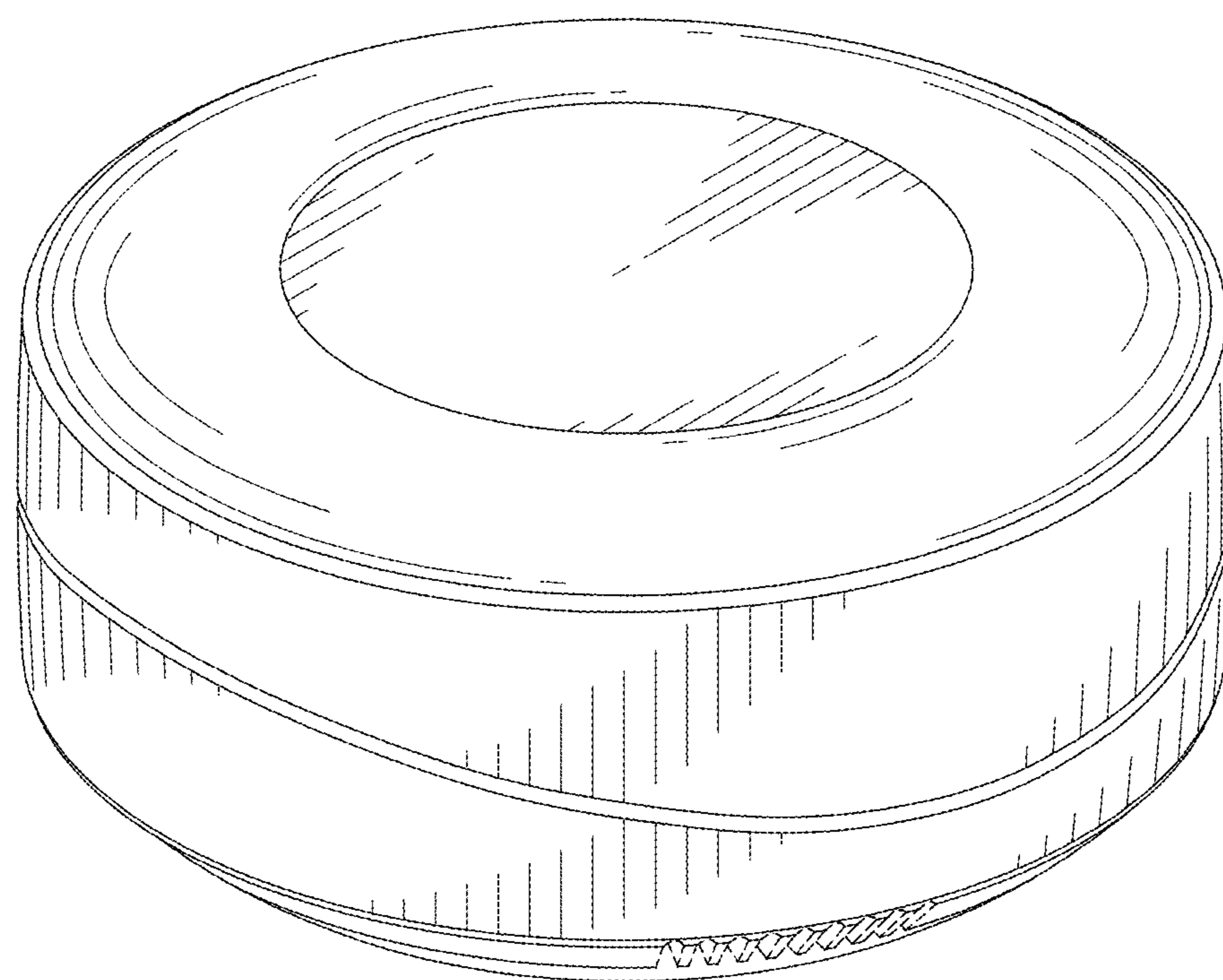

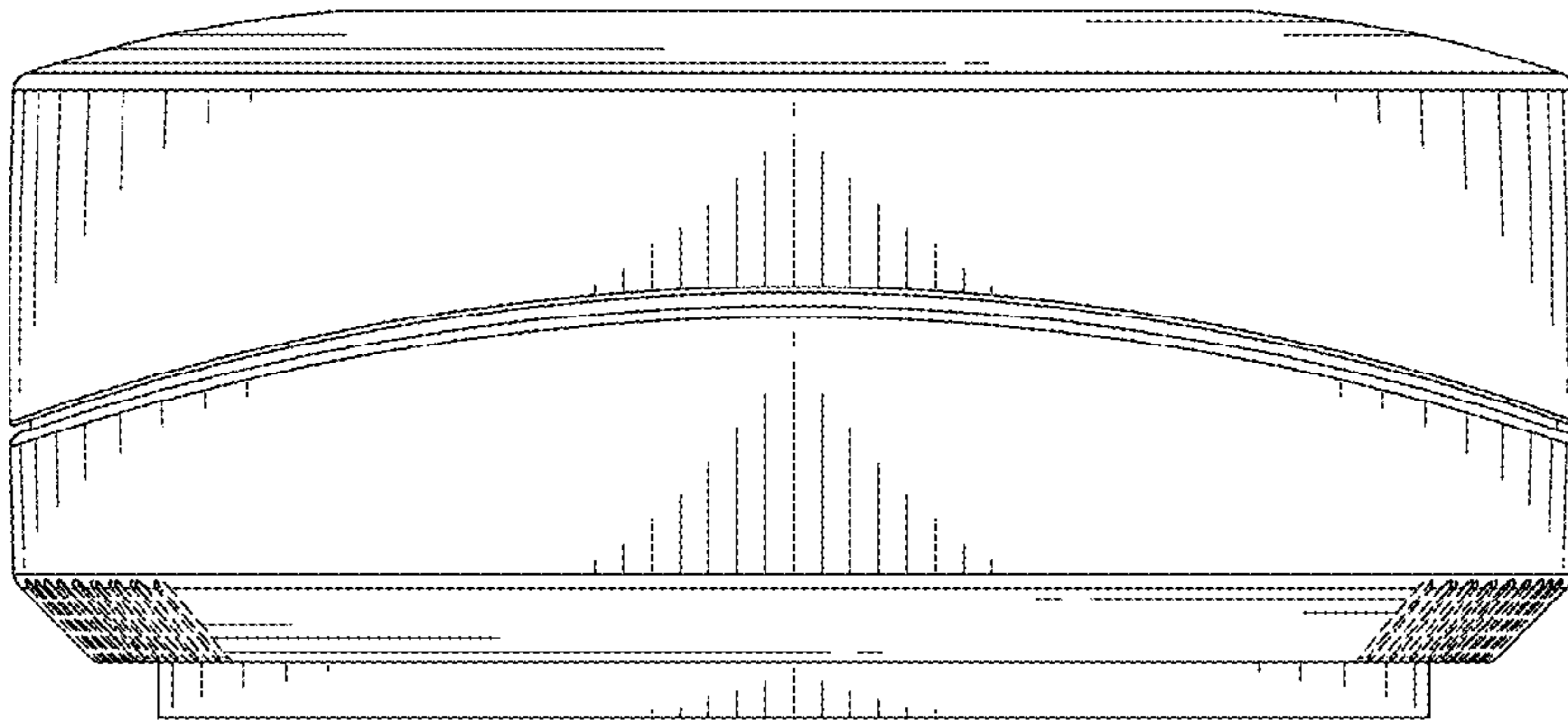

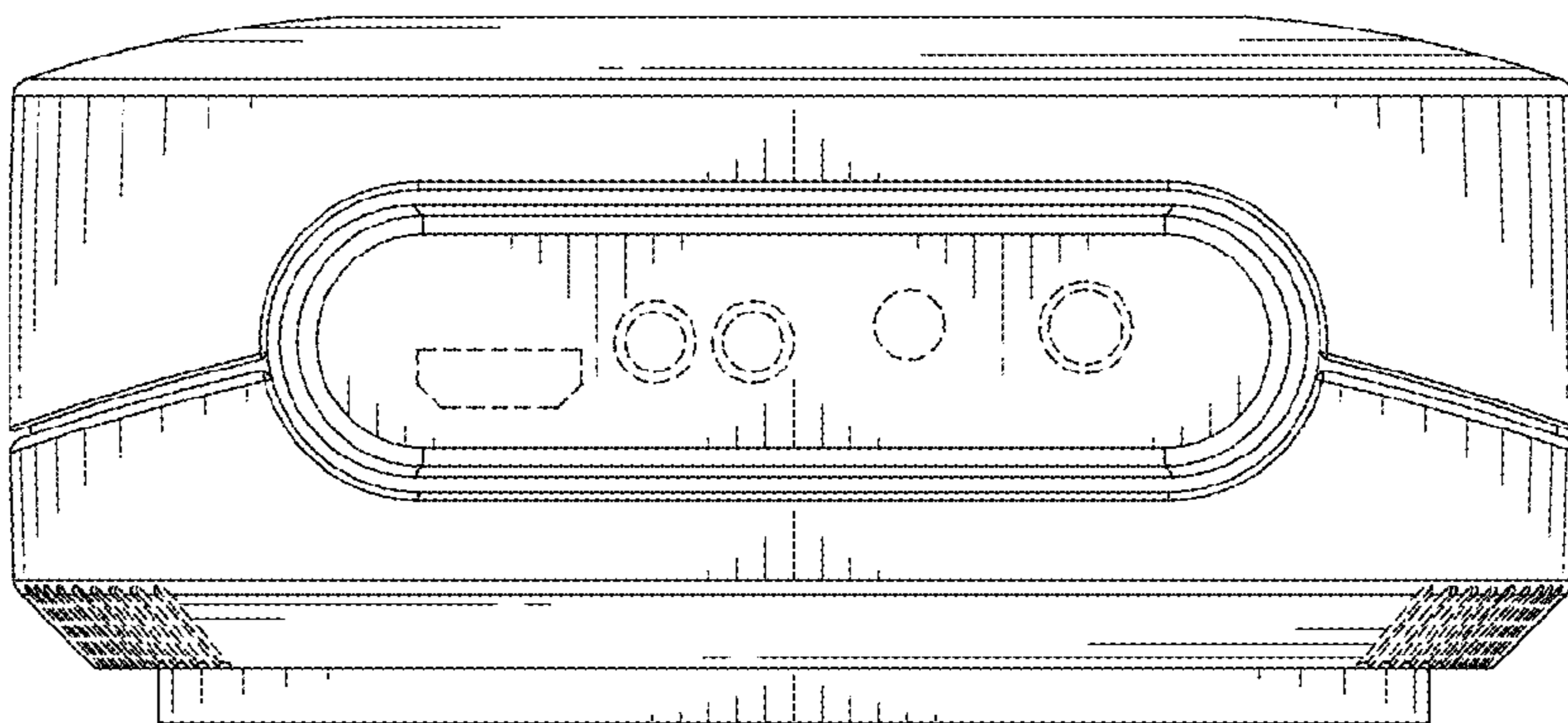

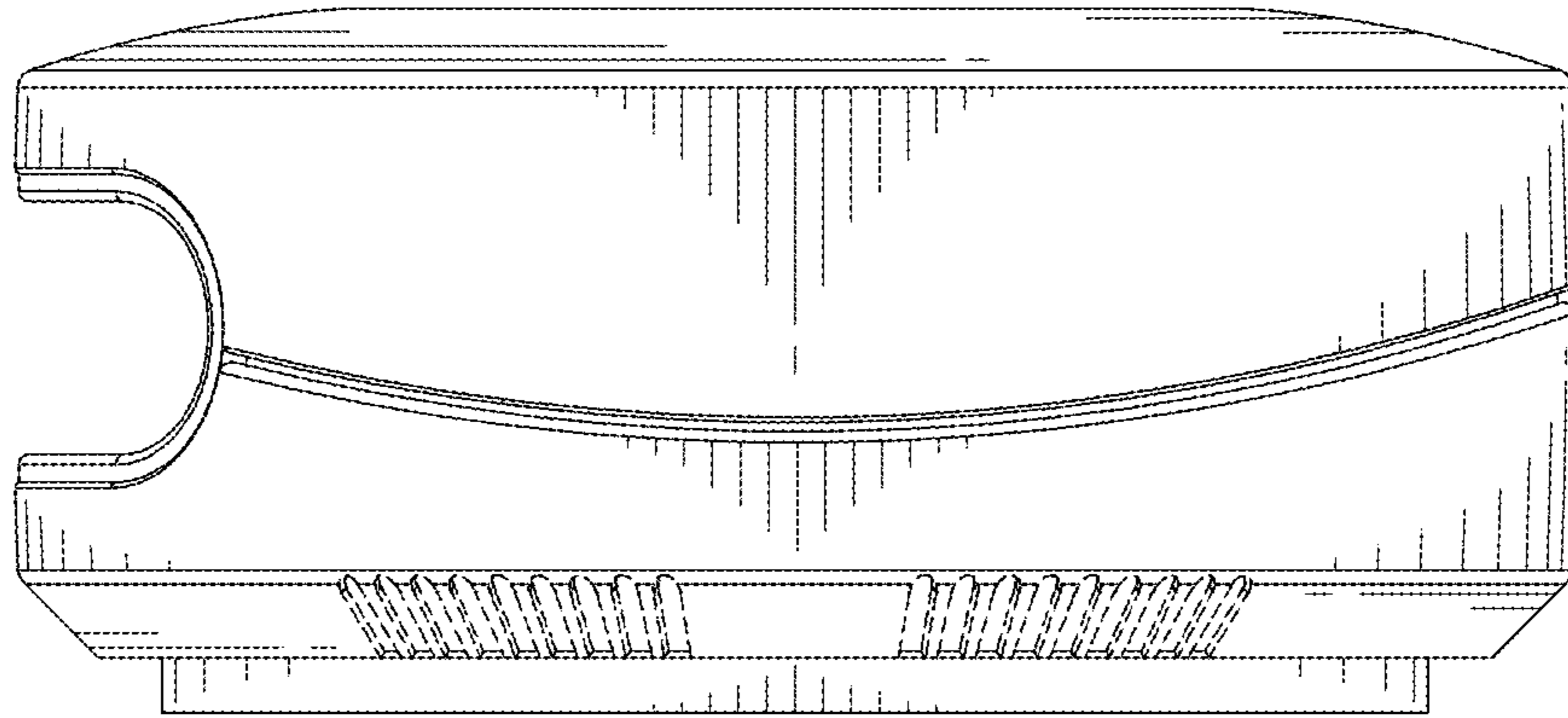

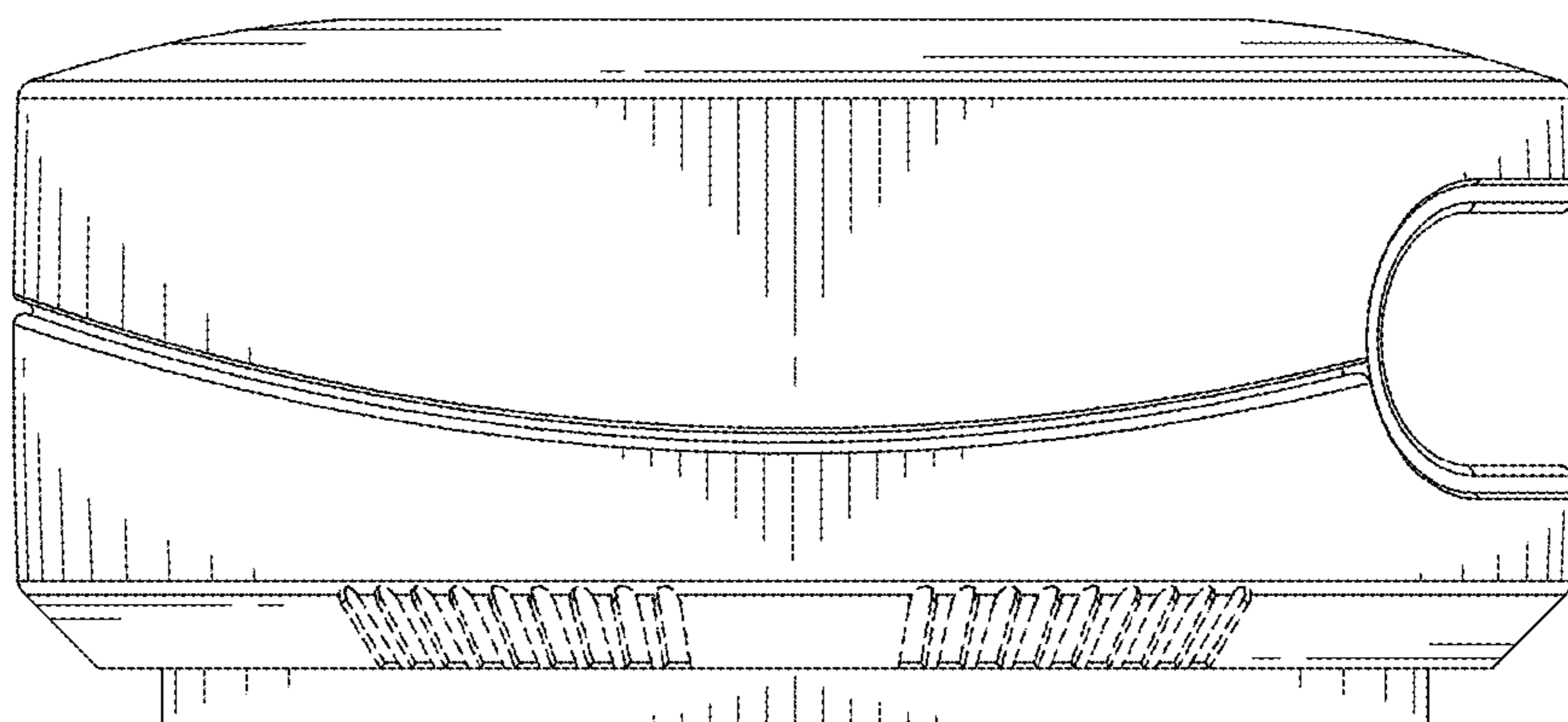

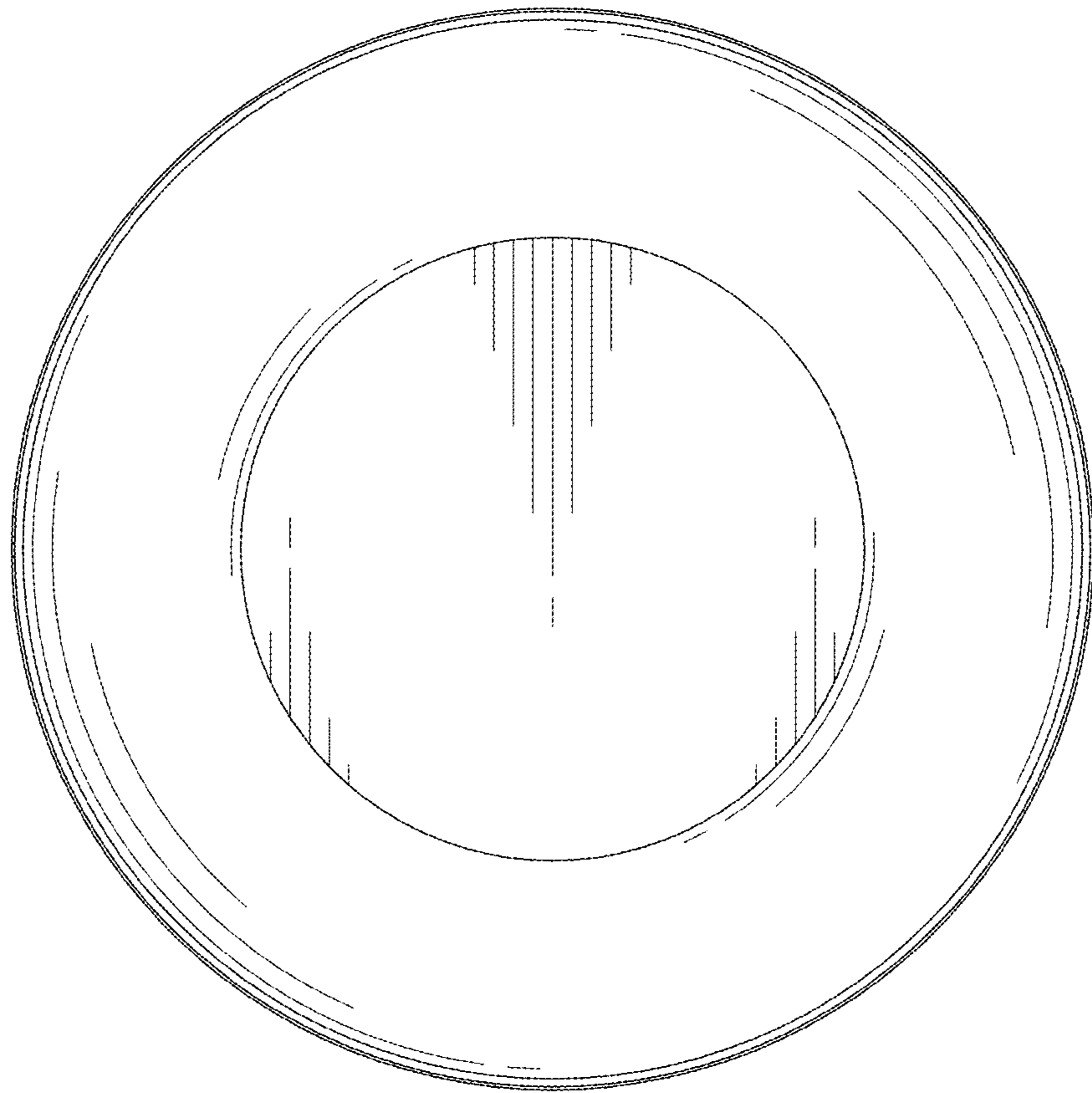

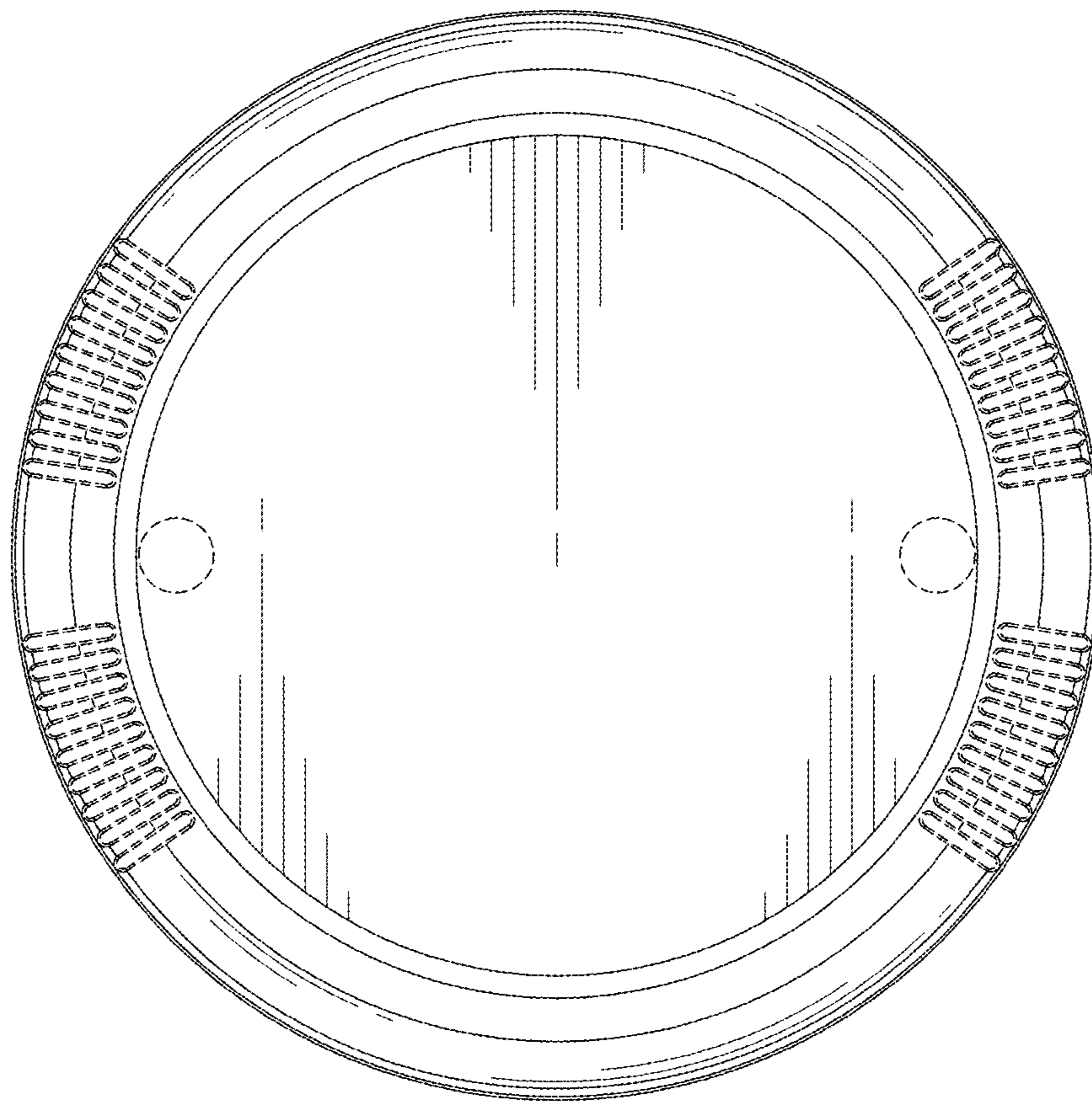

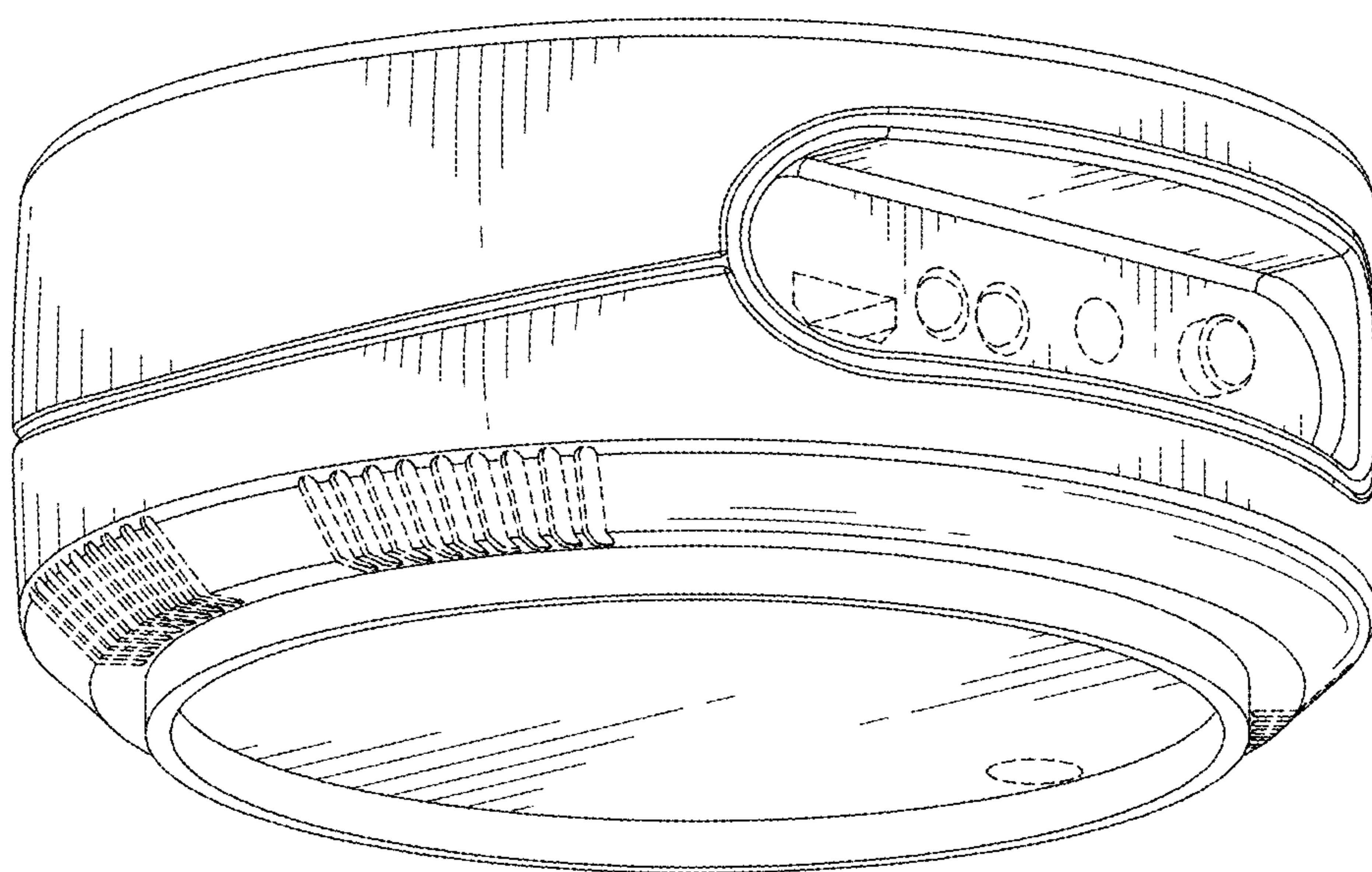
