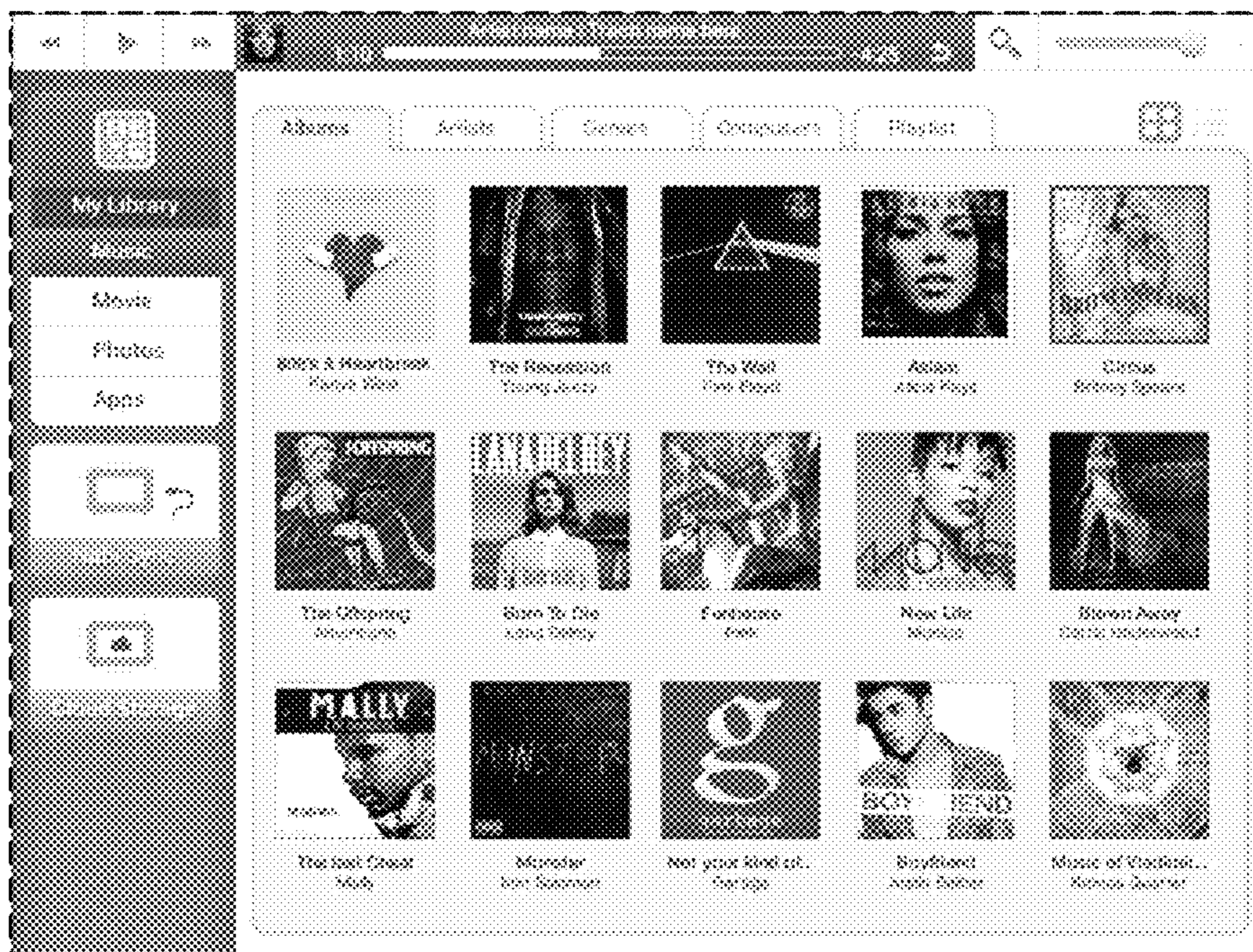

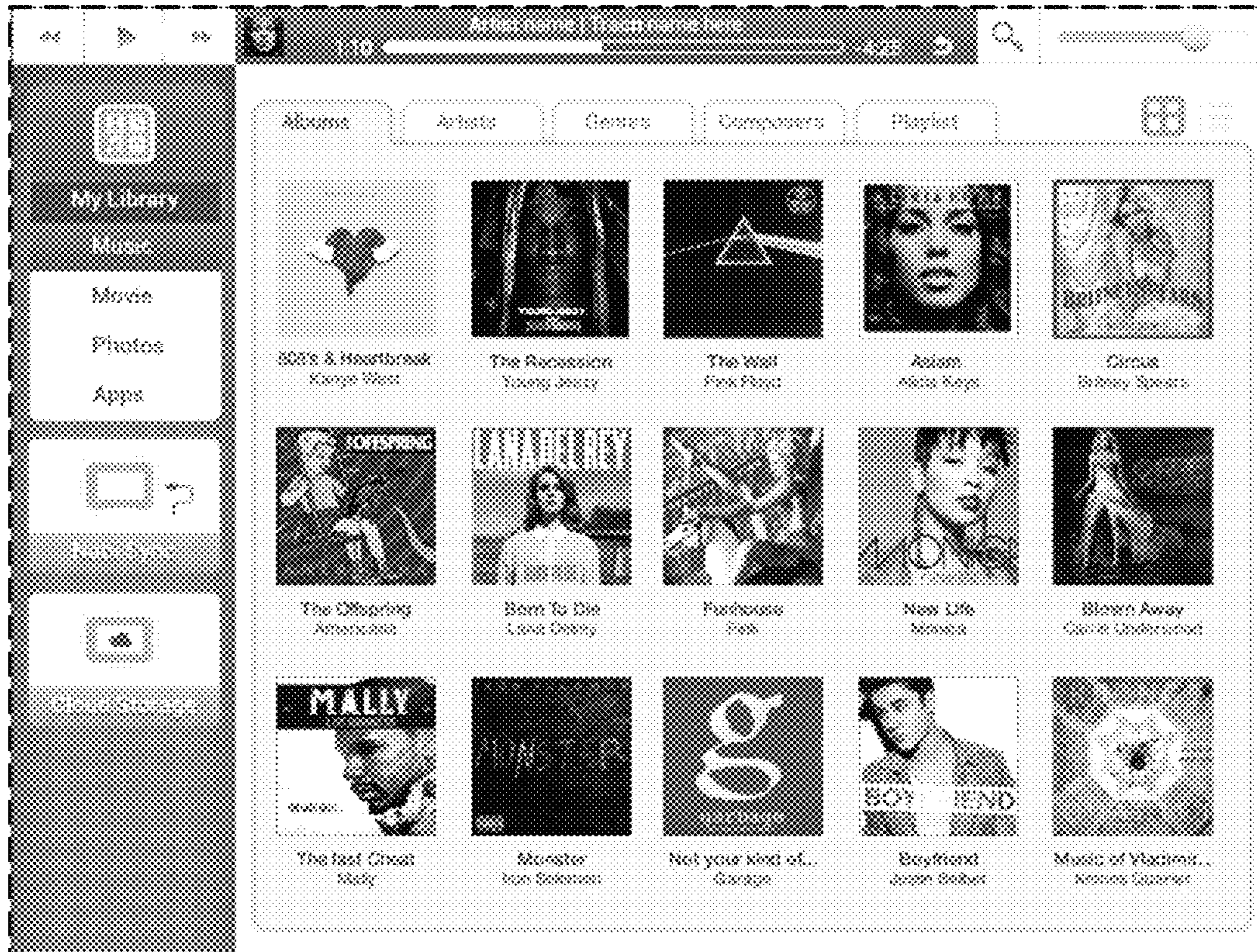
DESCRIPTION
