FIG. 5 is a top plan view;

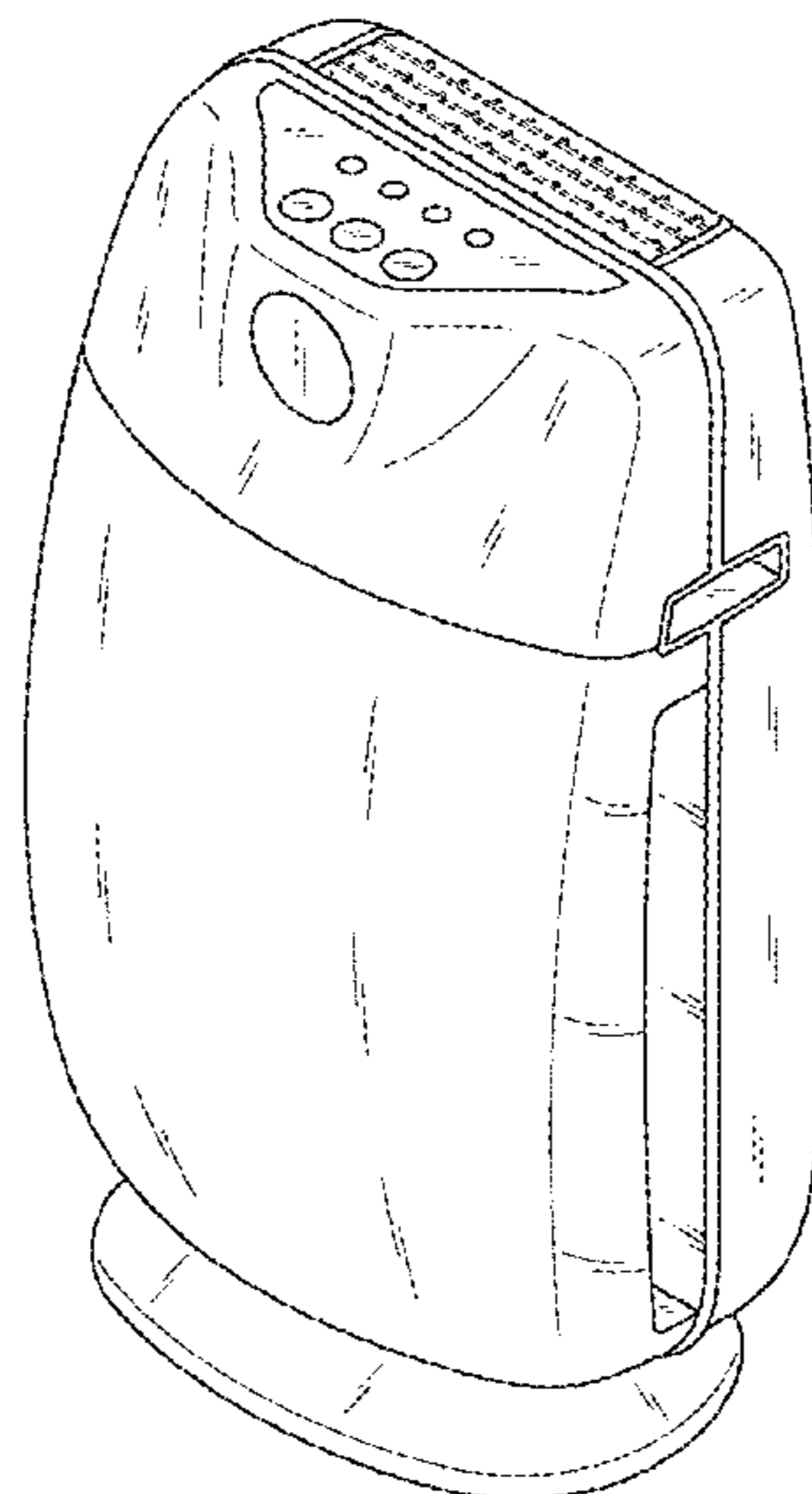
FIG. 6 is a rear view; and,

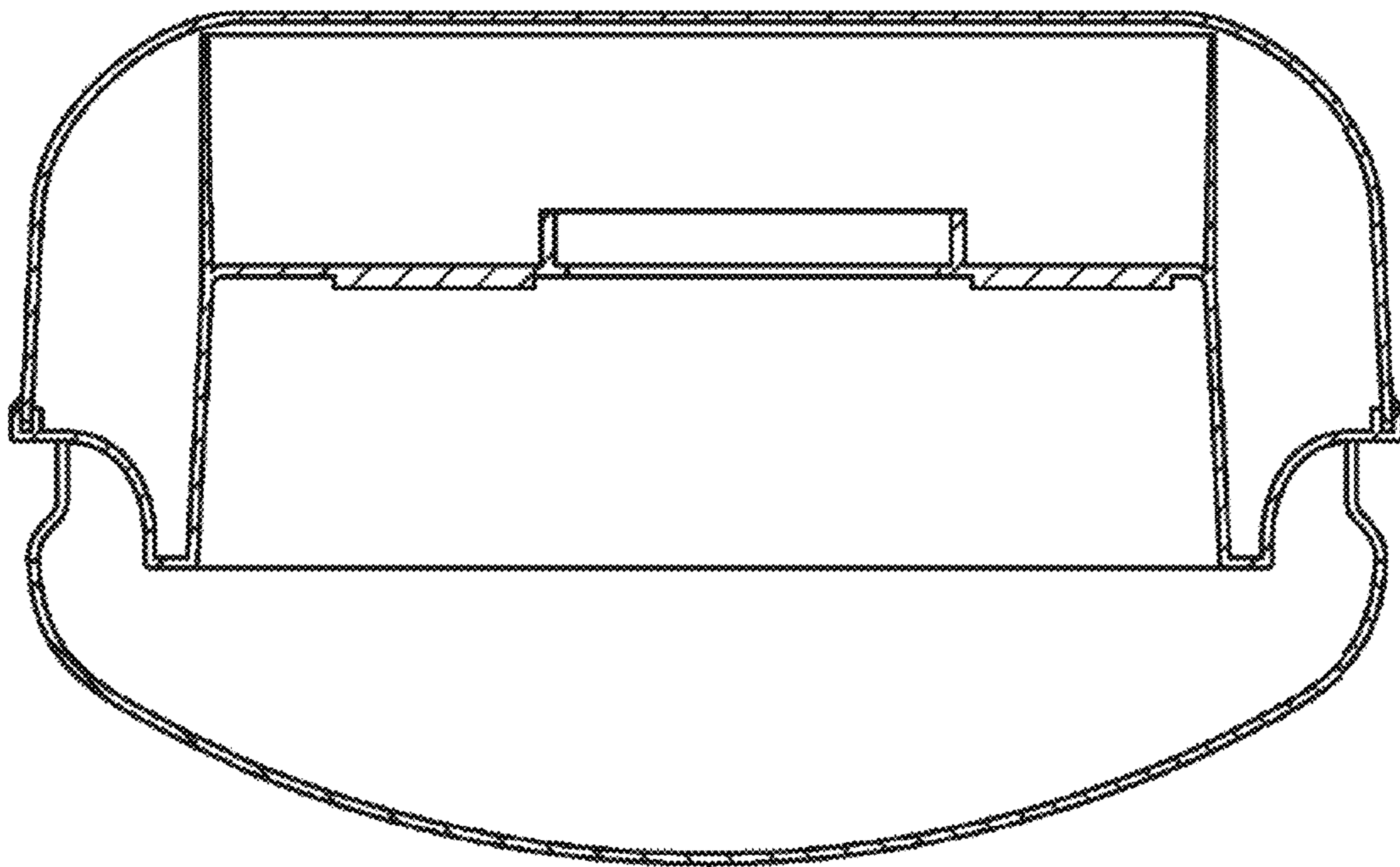
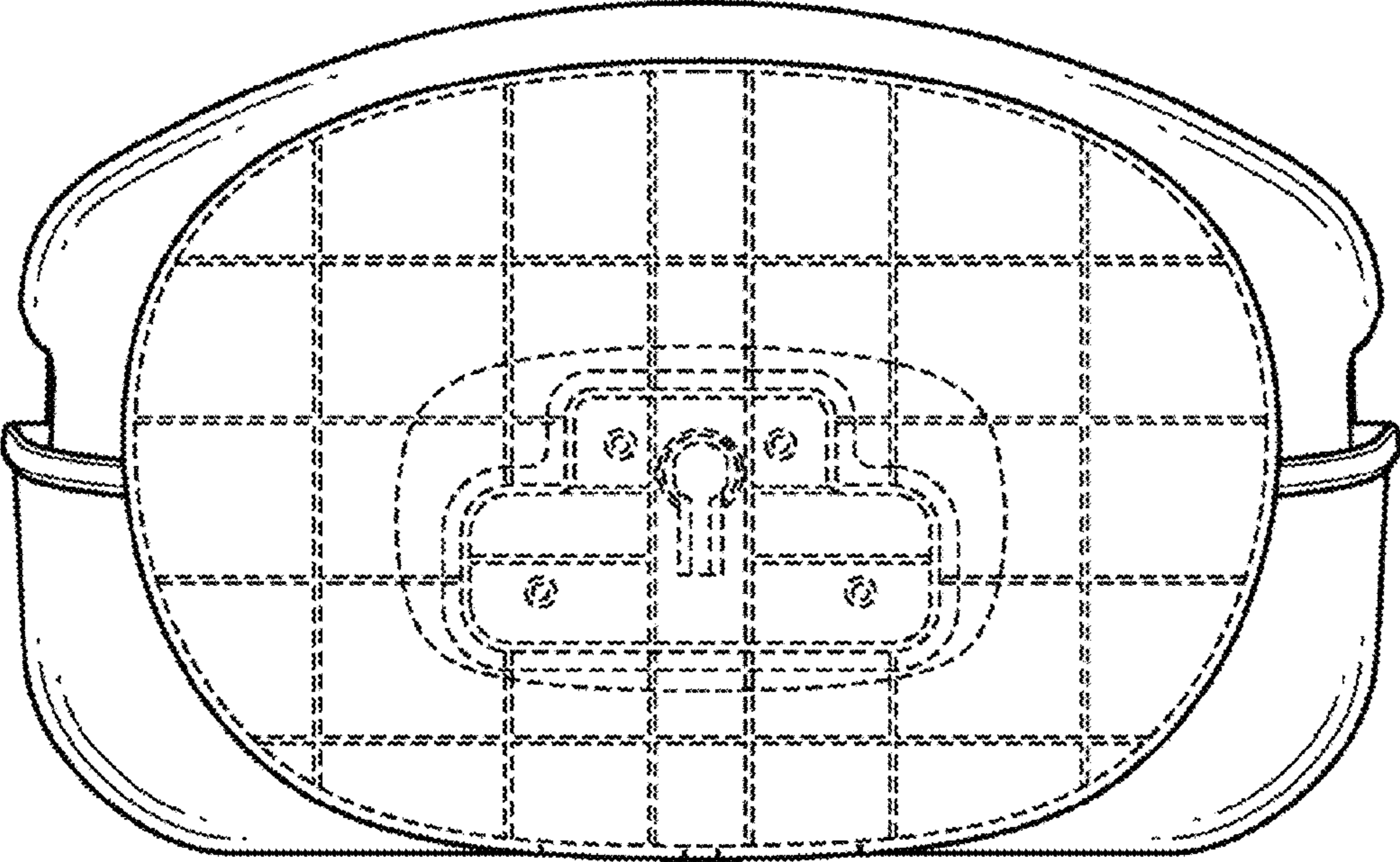

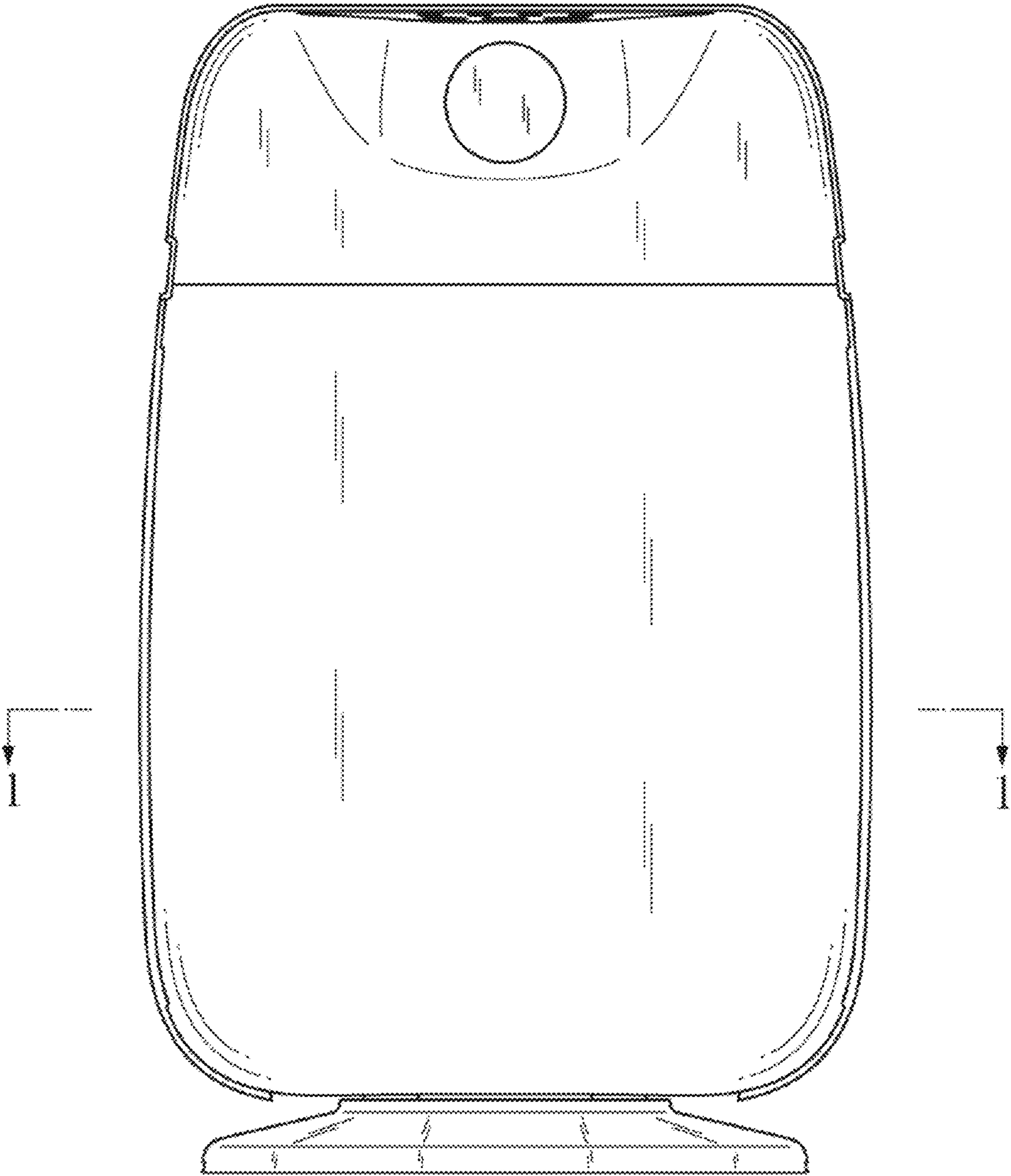

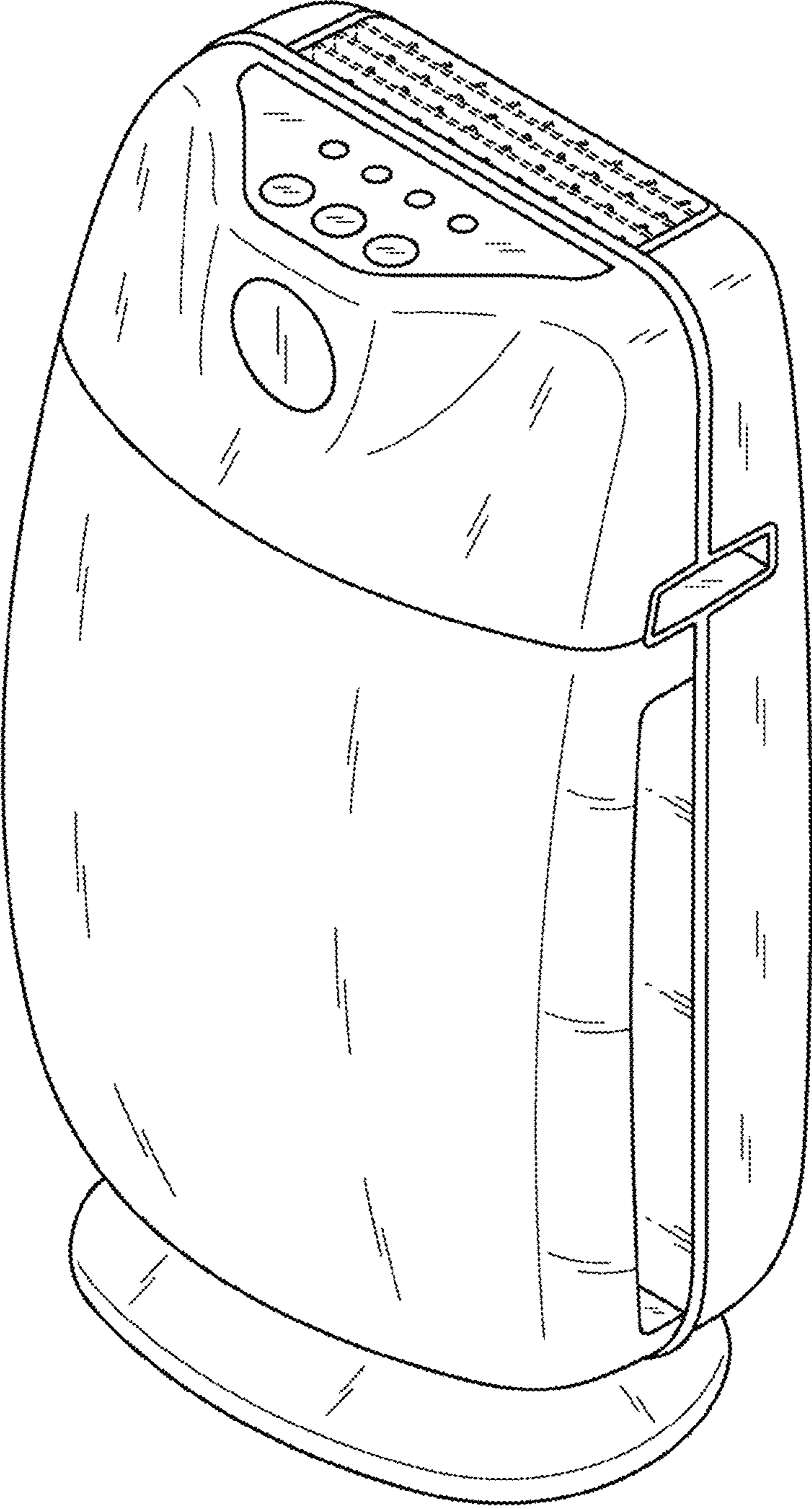

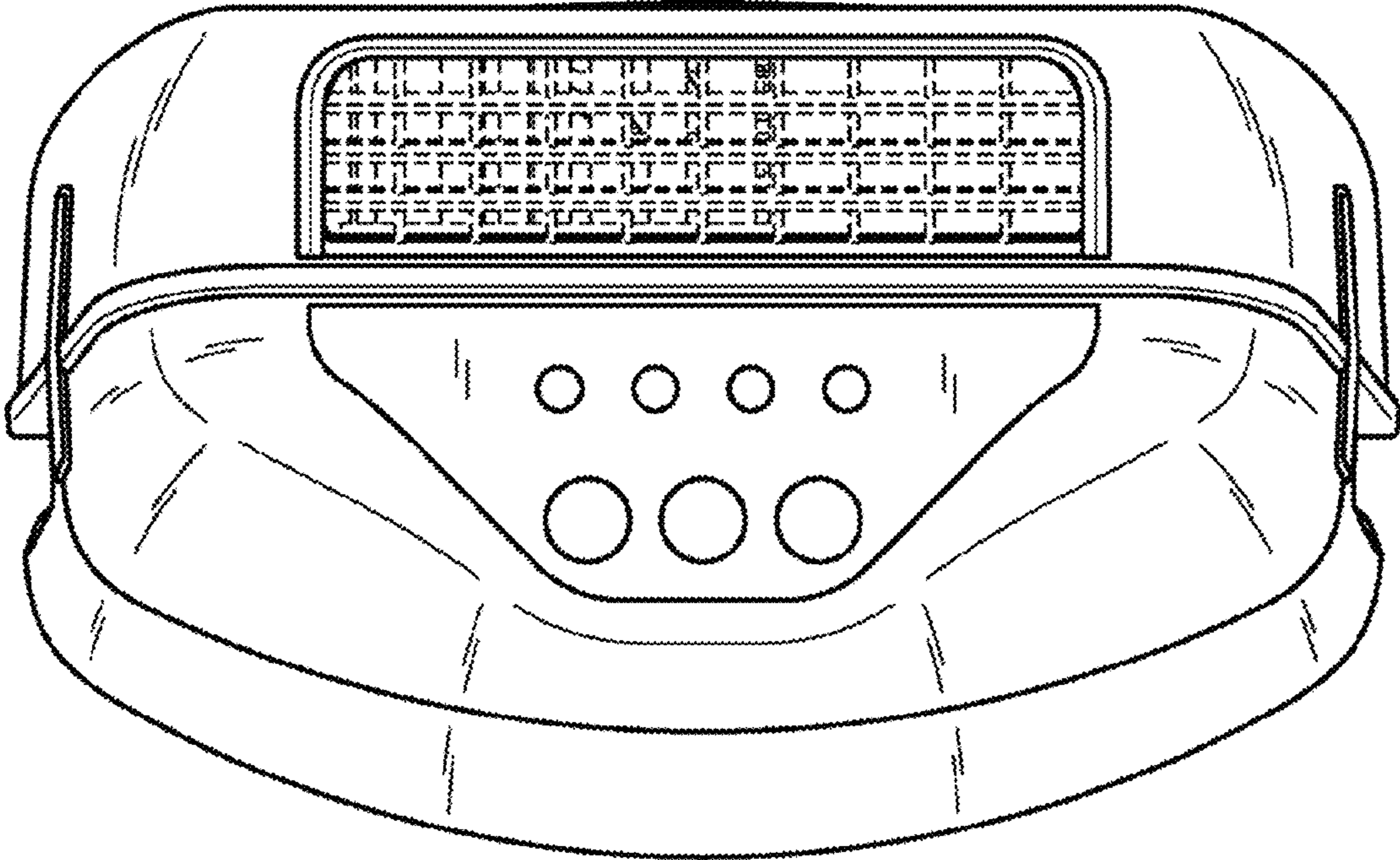

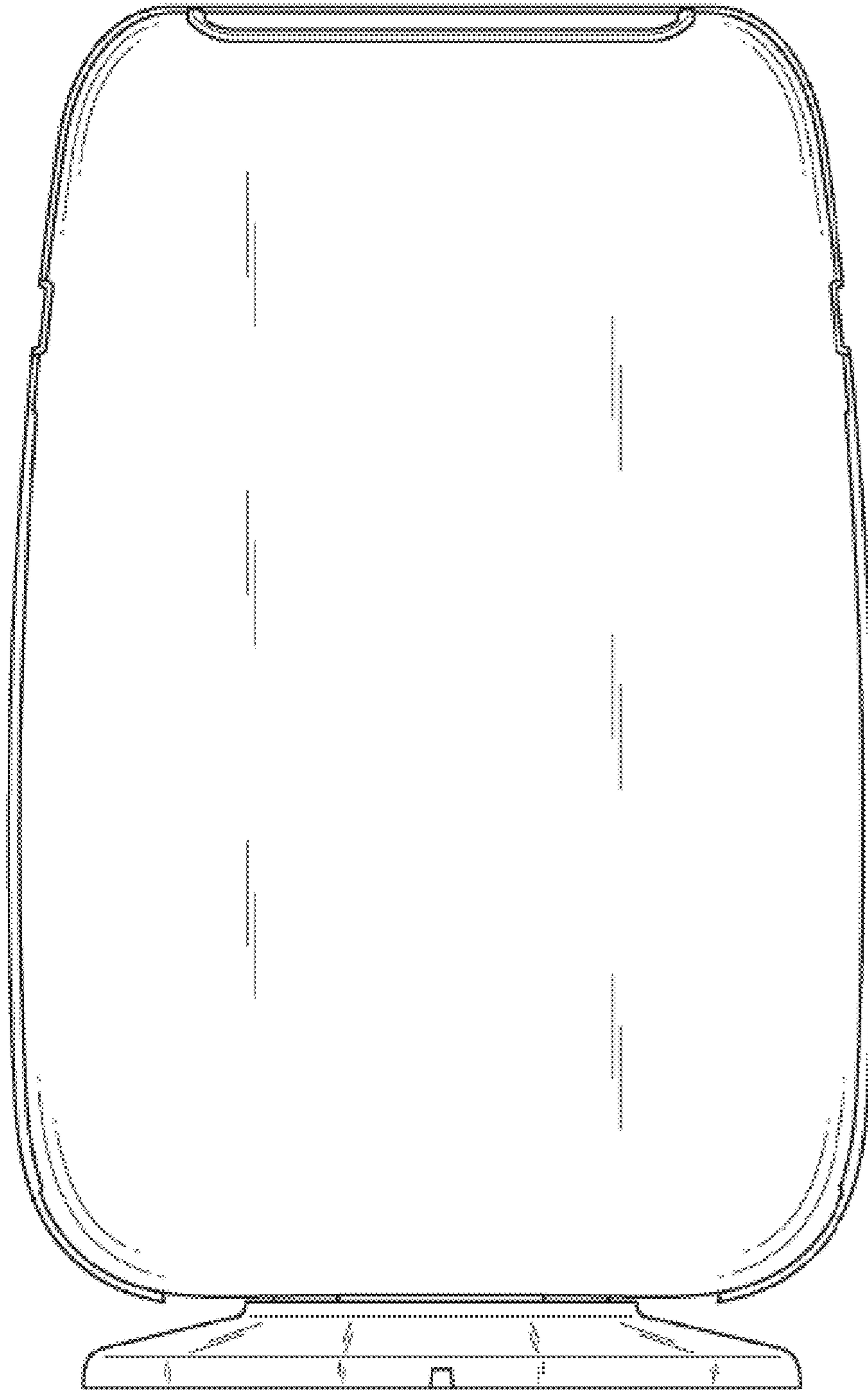
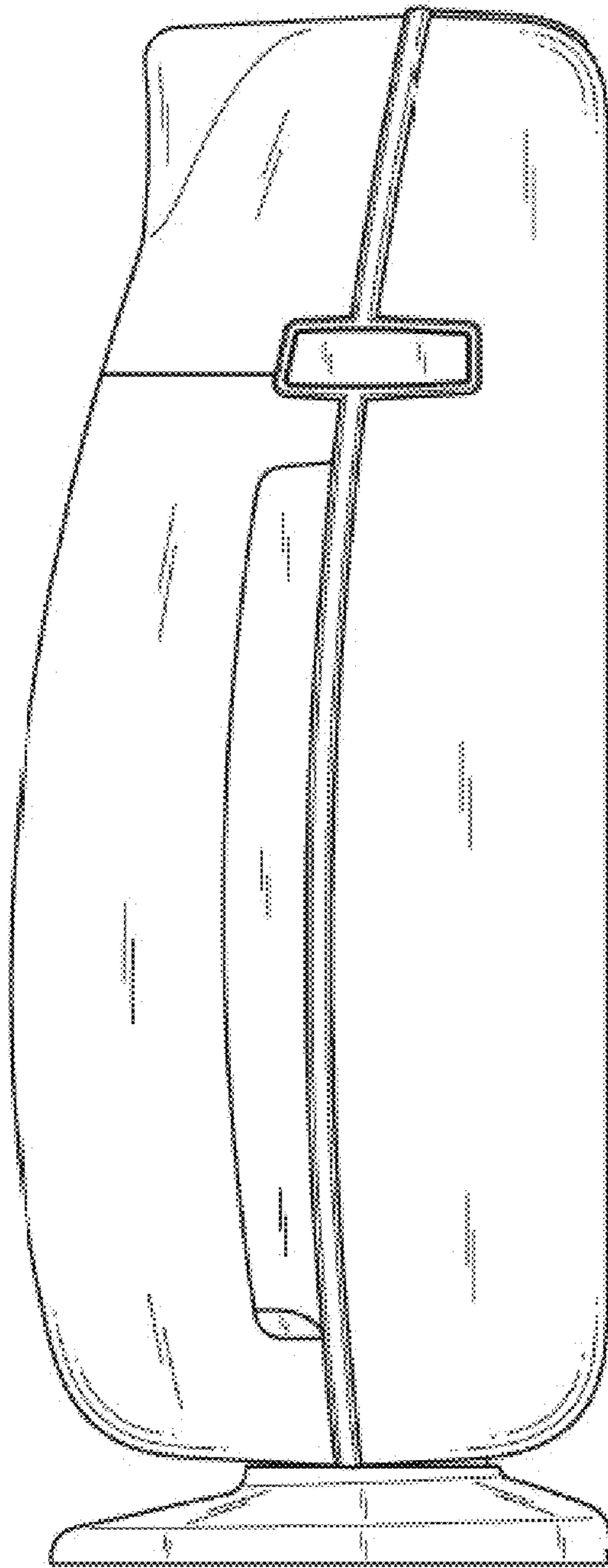
