We claim the ornamental design for a flow control device knob with indicia, as shown and described.

**DESCRIPTION**

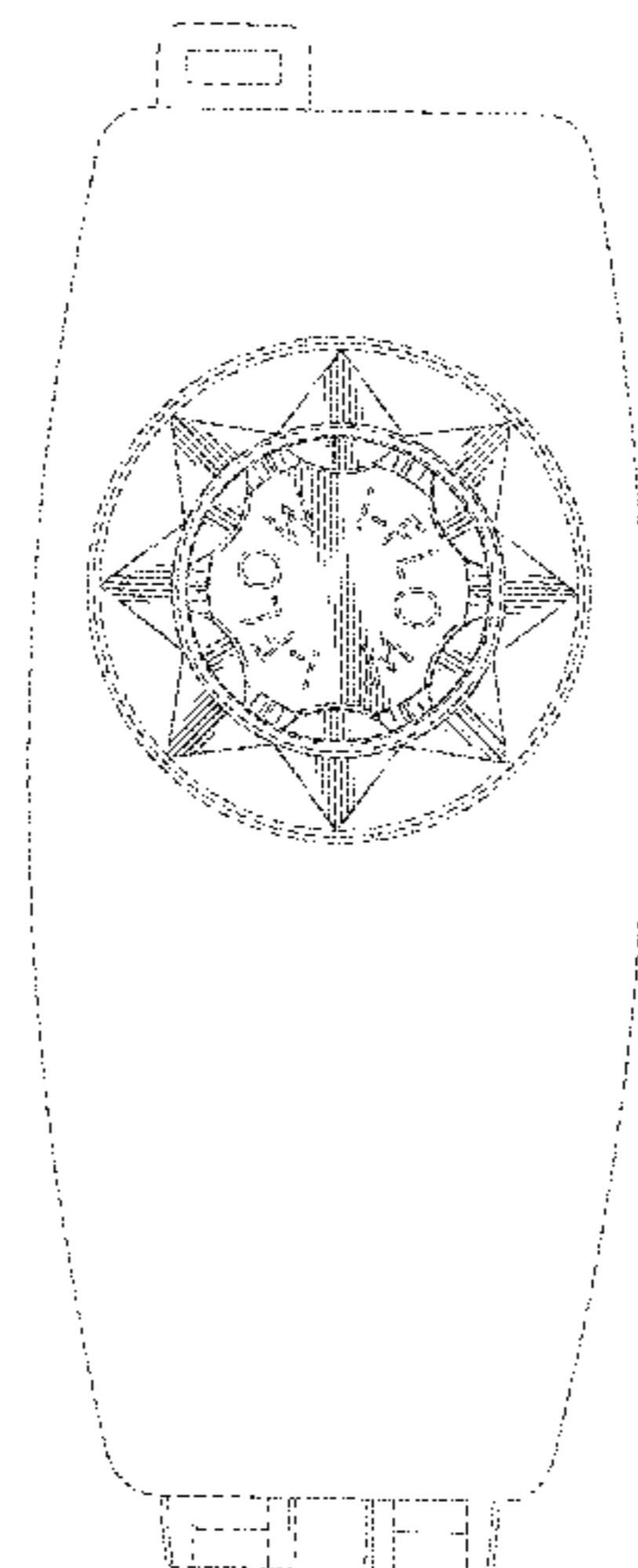
FIG. 1 is a front elevational view of a flow control device knob with indicia showing our new design; FIG. 2 is a perspective view thereof; FIG. 3 is a right side elevation view thereof; FIG. 4 is a rear elevation thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken line showing of parts of the drawings is included for the purpose of illustrating use and environment and forms no part of the claimed design. The broken lines showing indicia on the knob also do not form part of the claimed design.

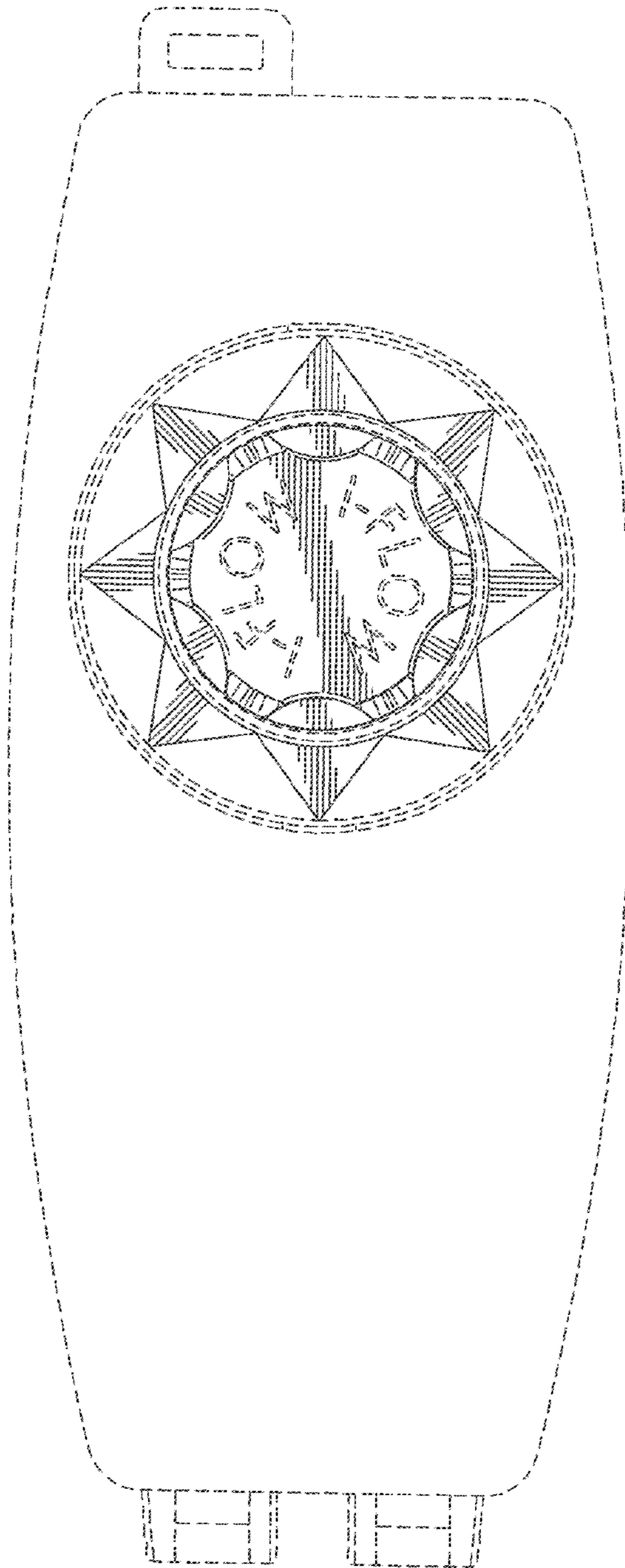

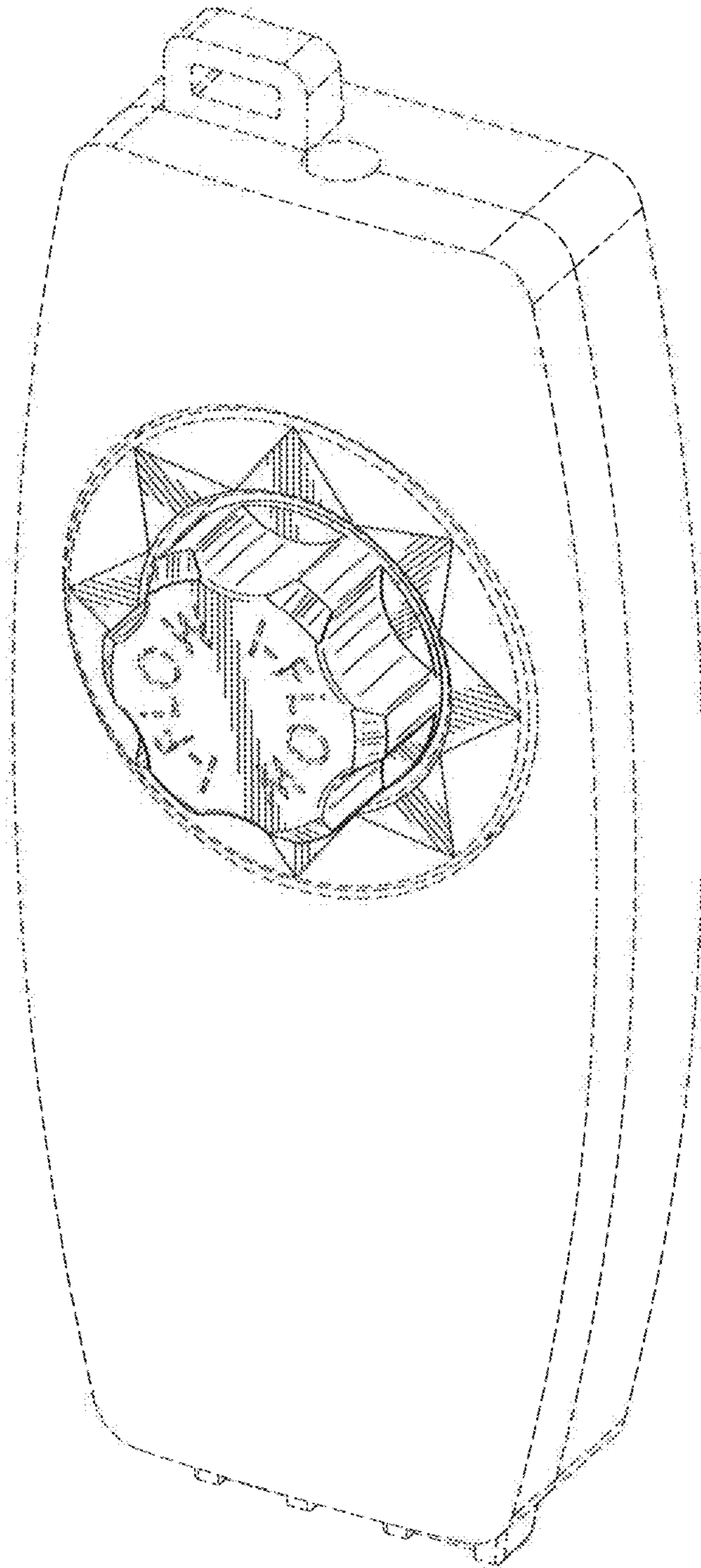

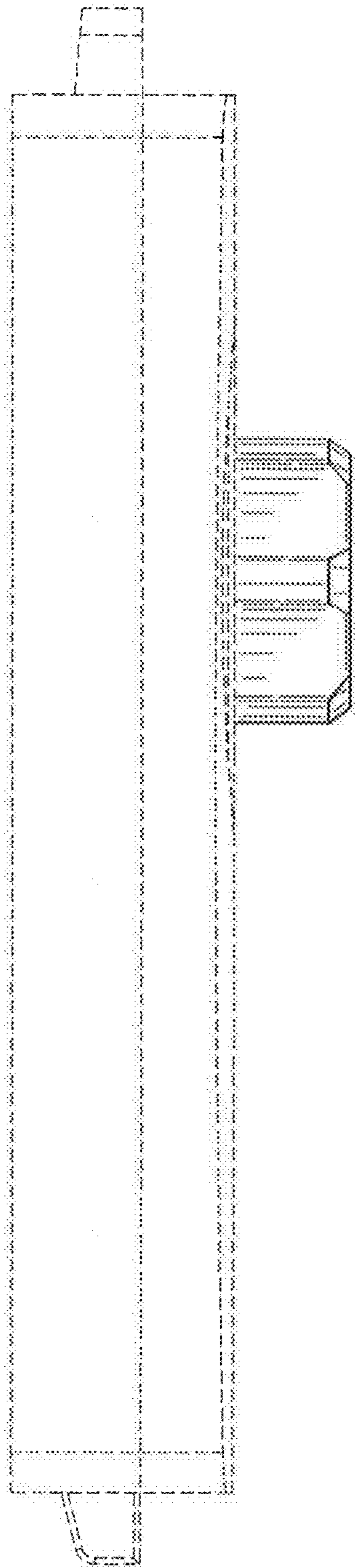

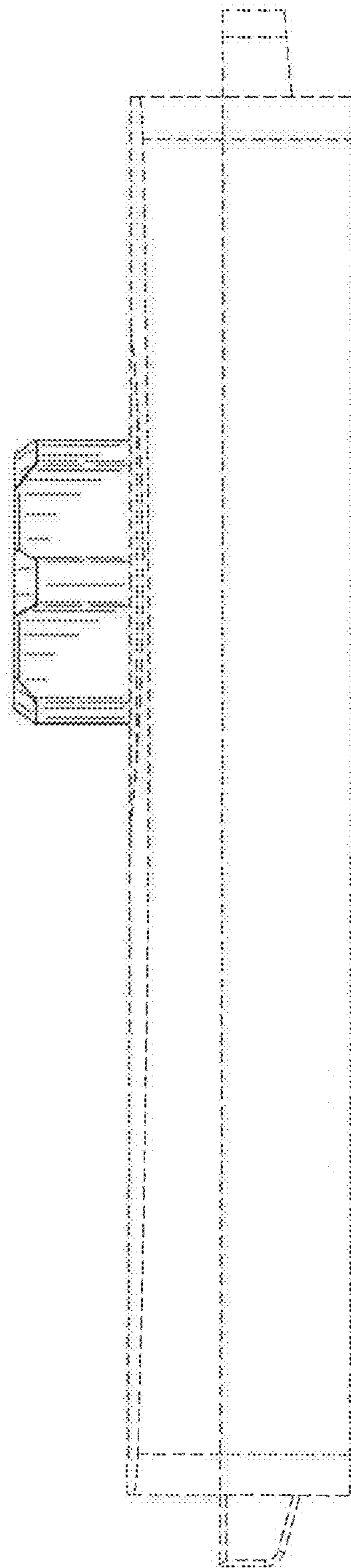

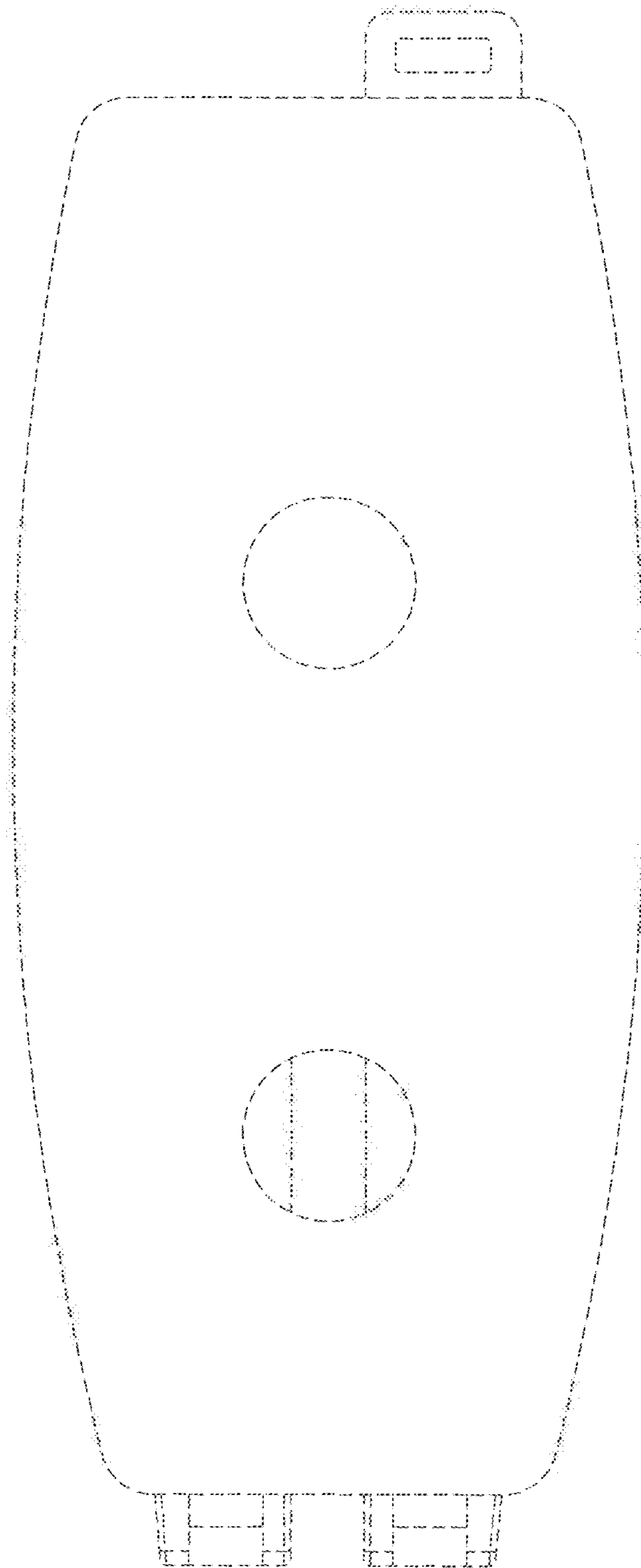

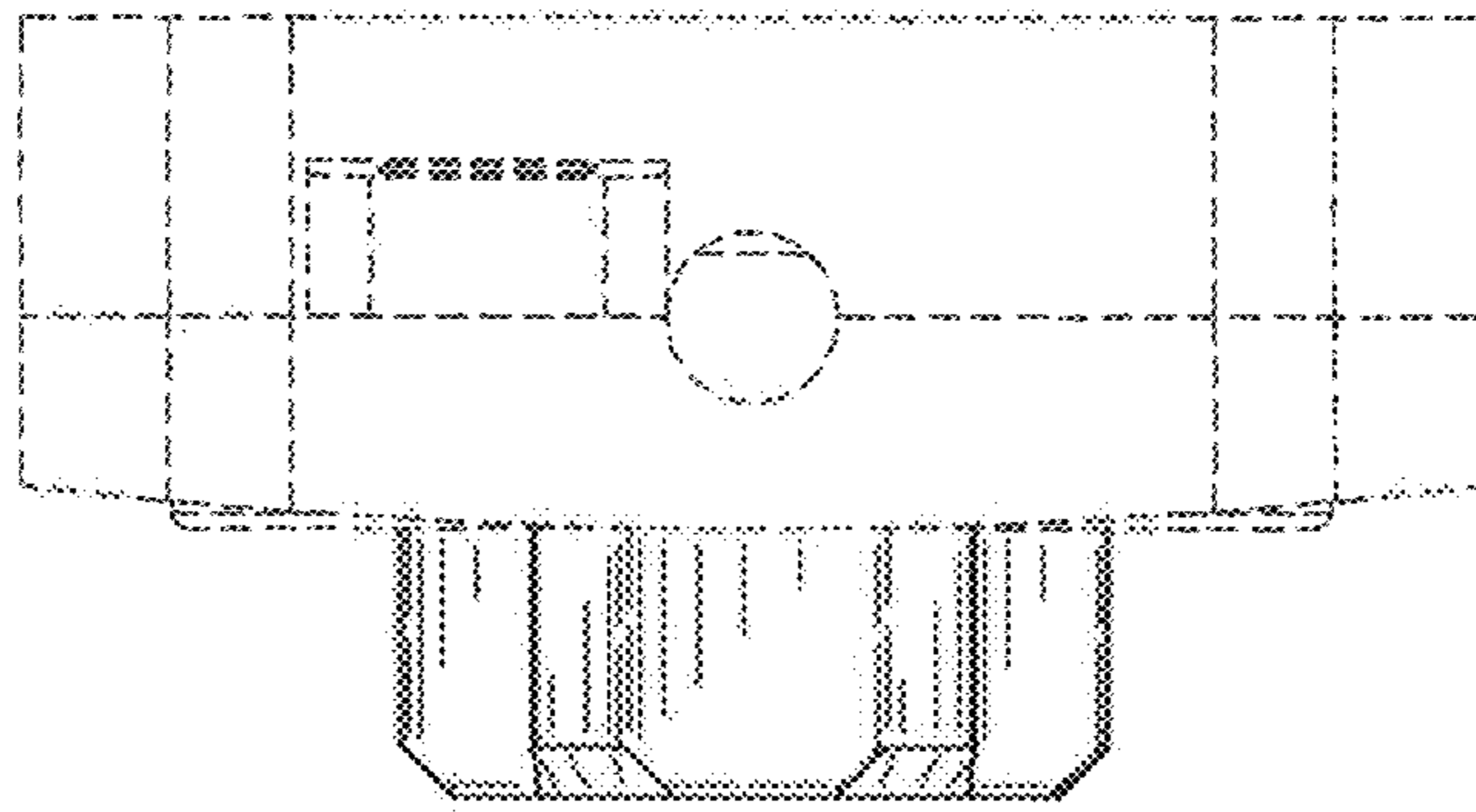

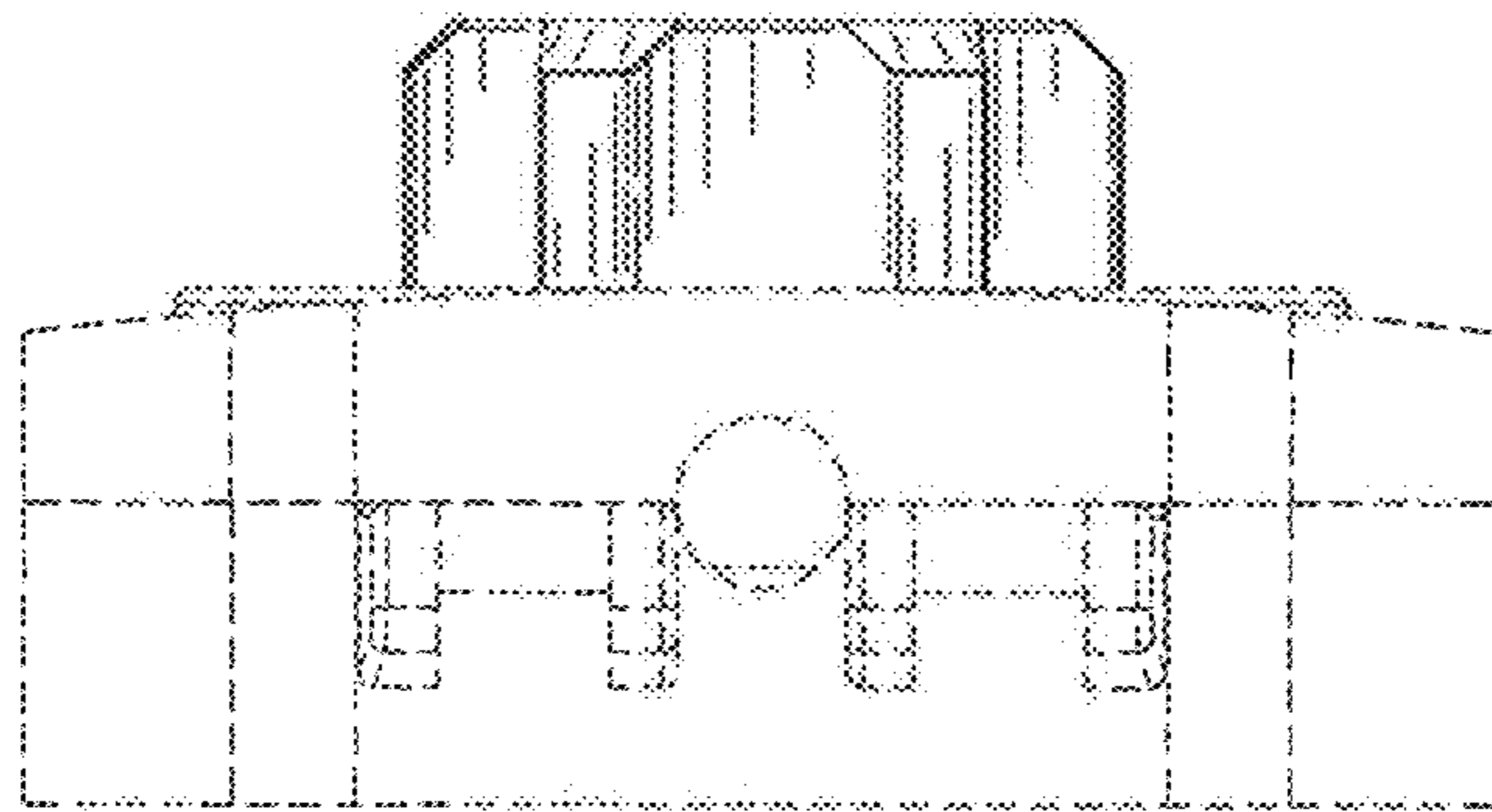
