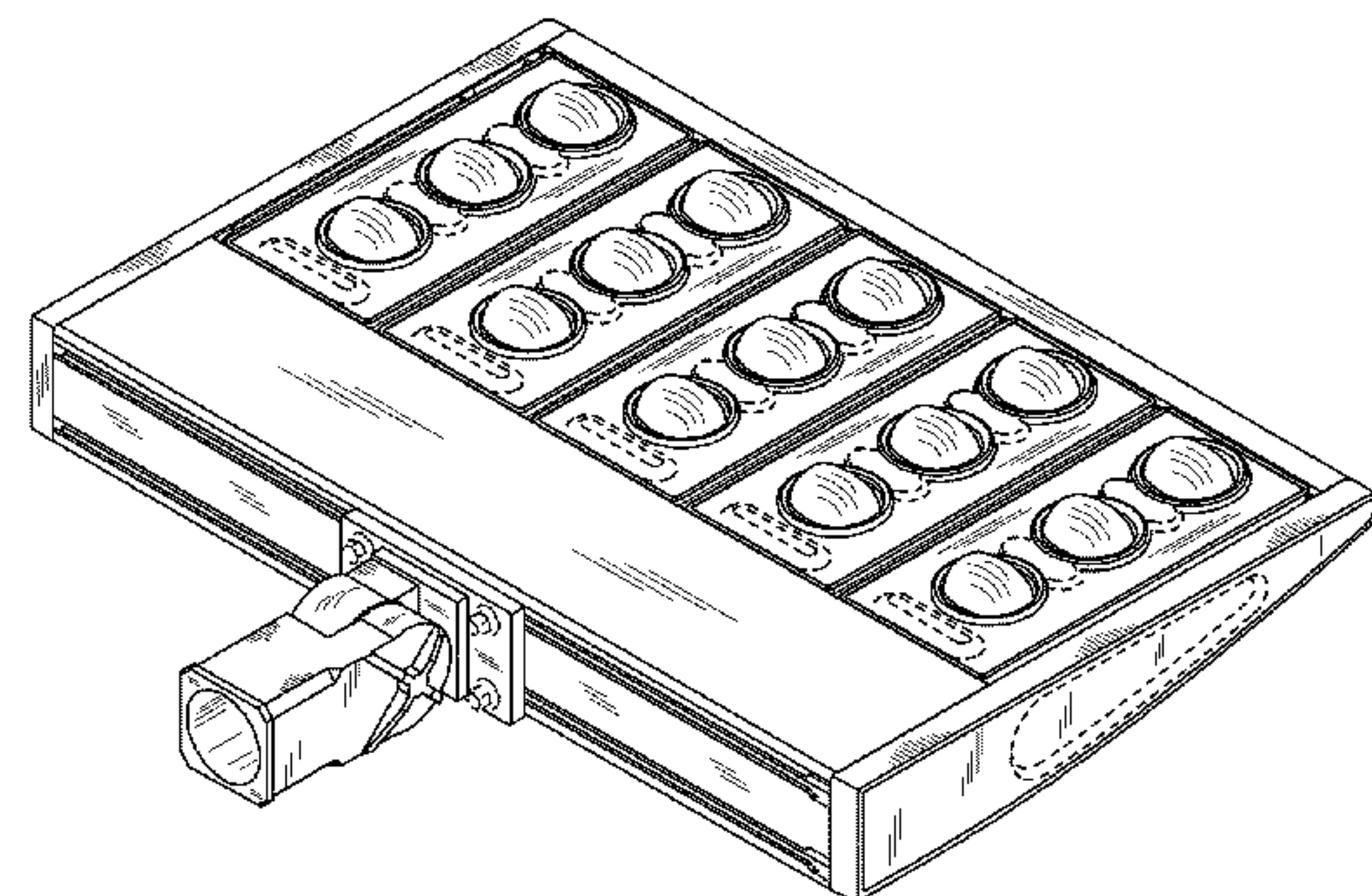
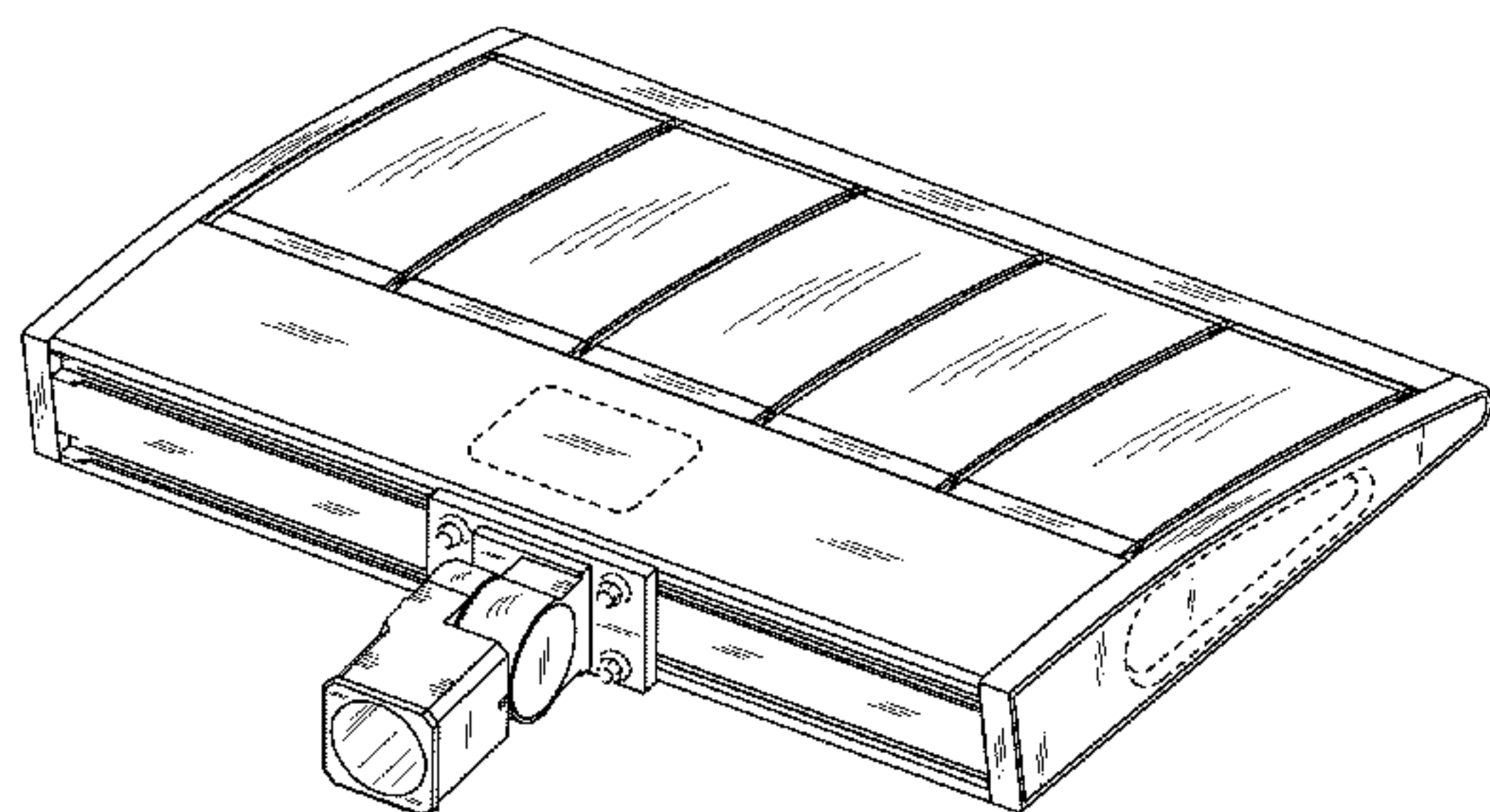
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top side view of light fixture showing the claimed design;

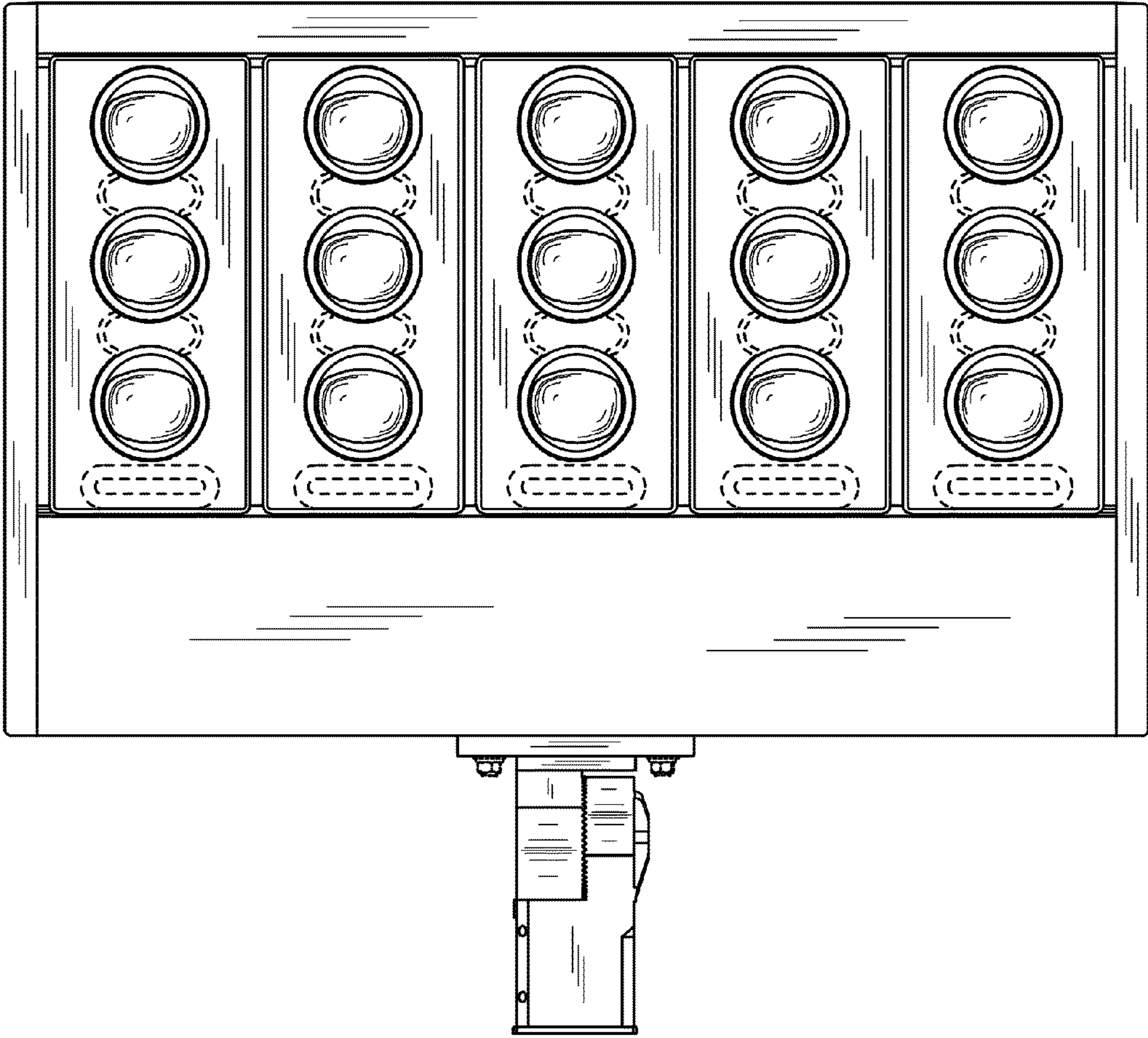

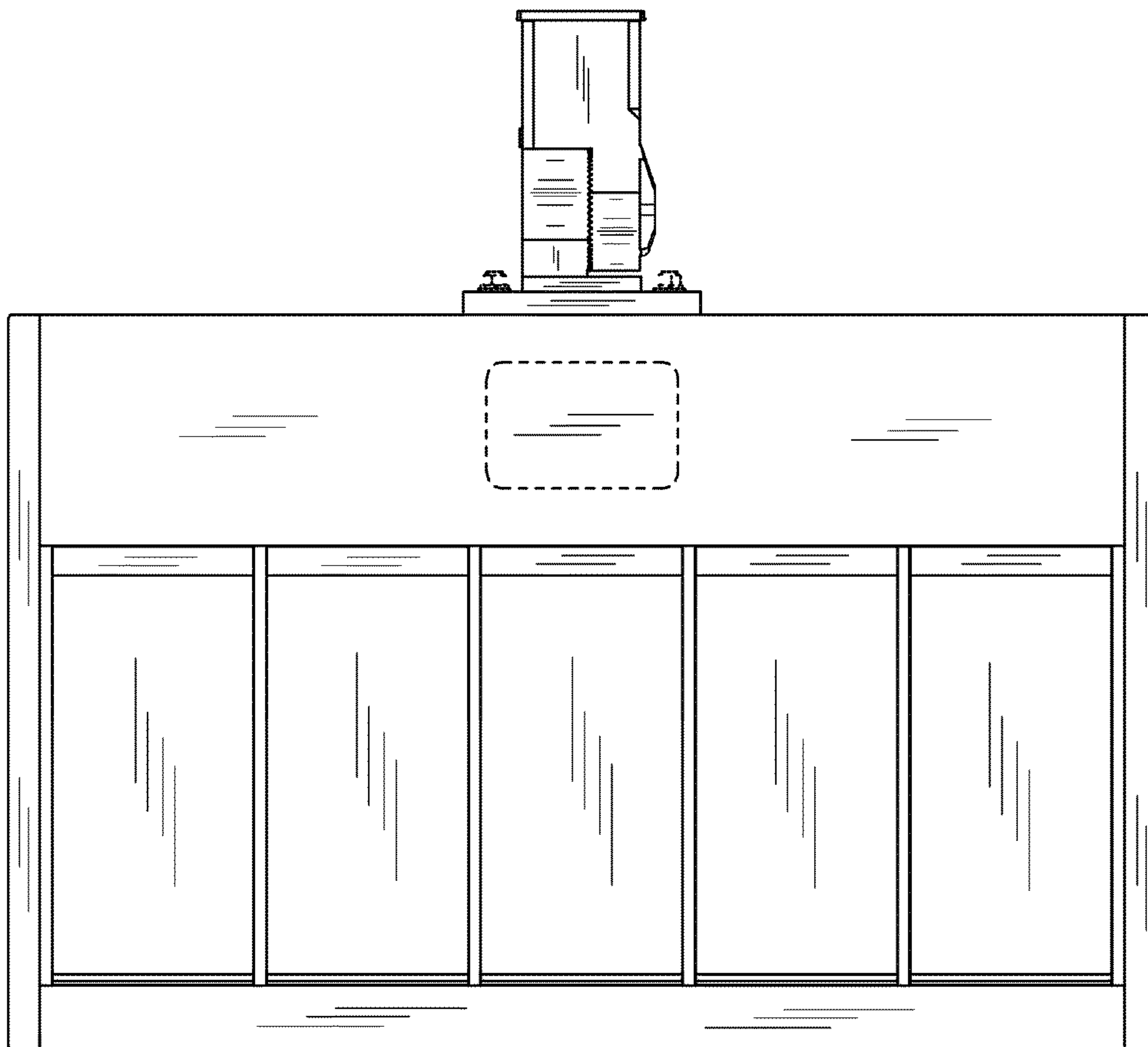

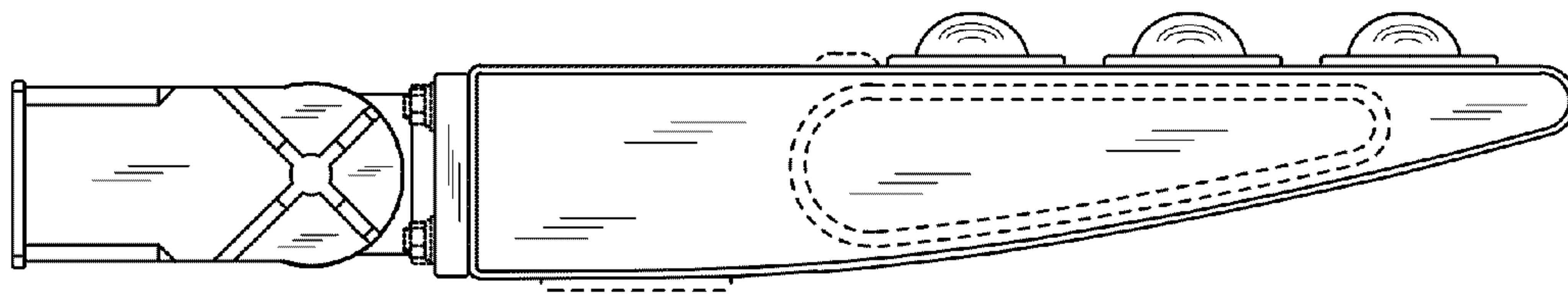

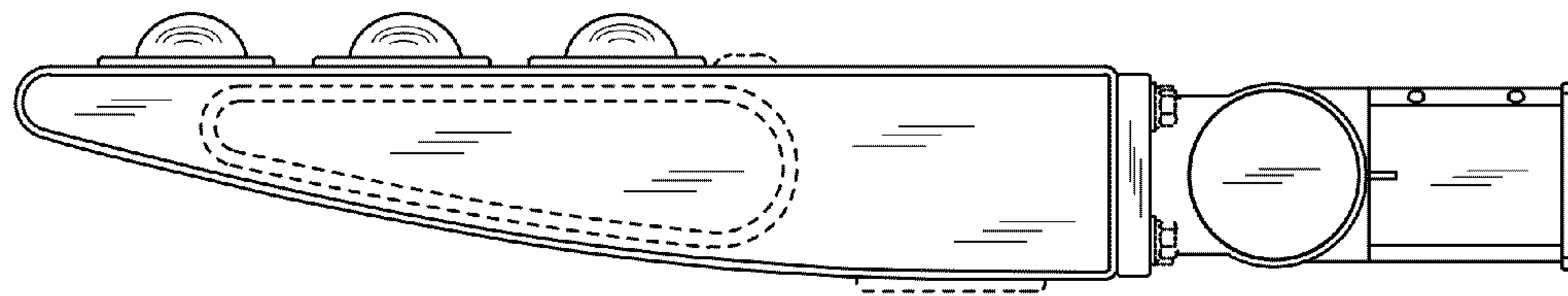

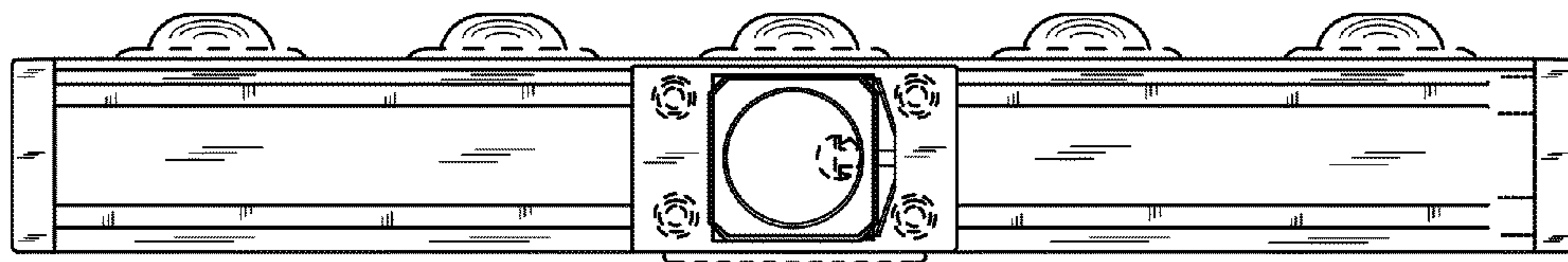

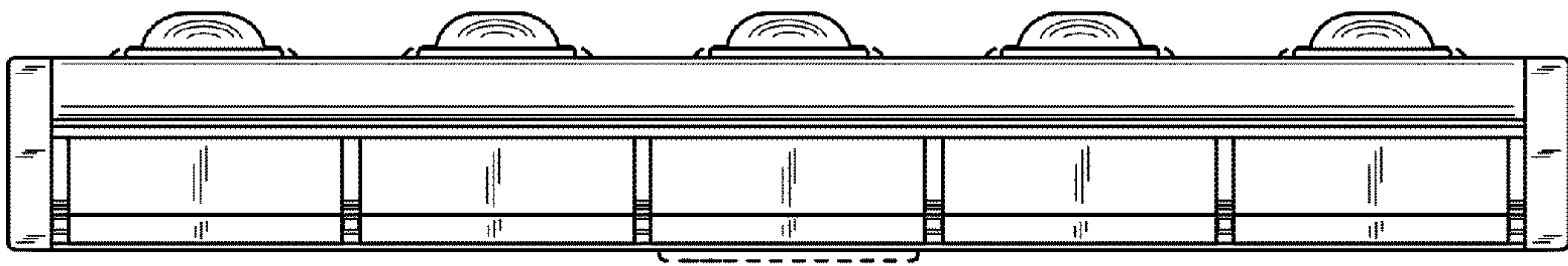

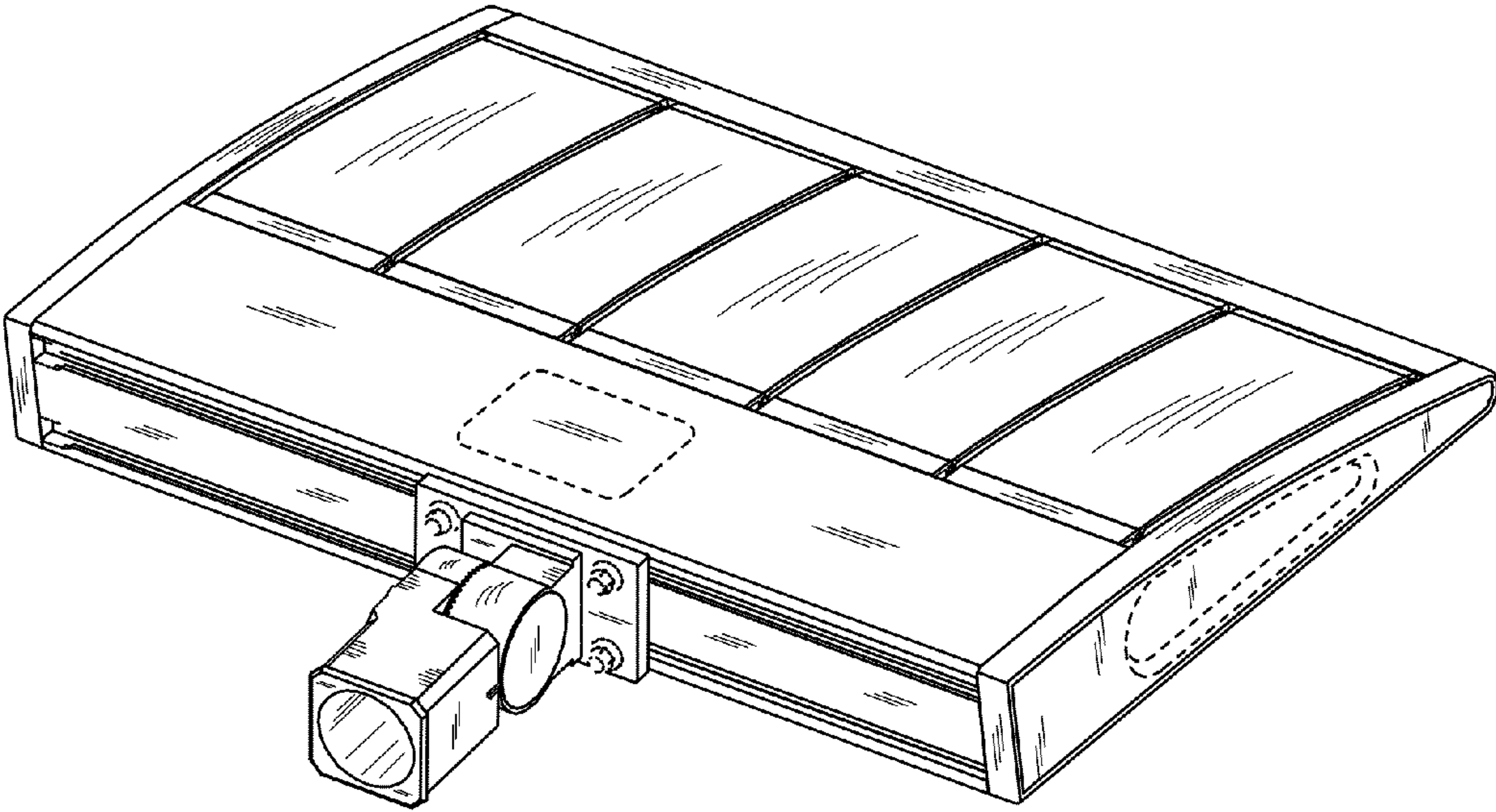

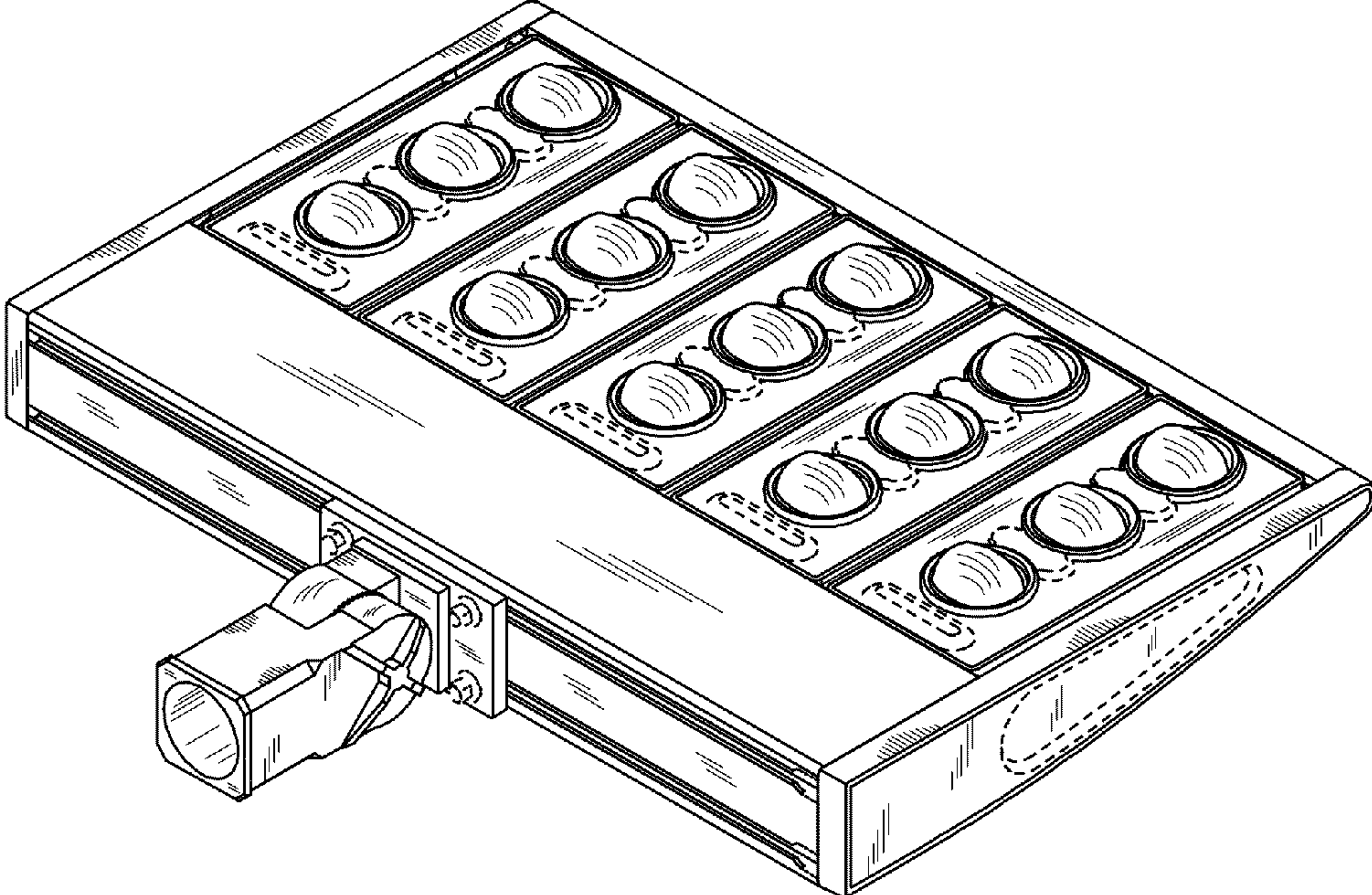
