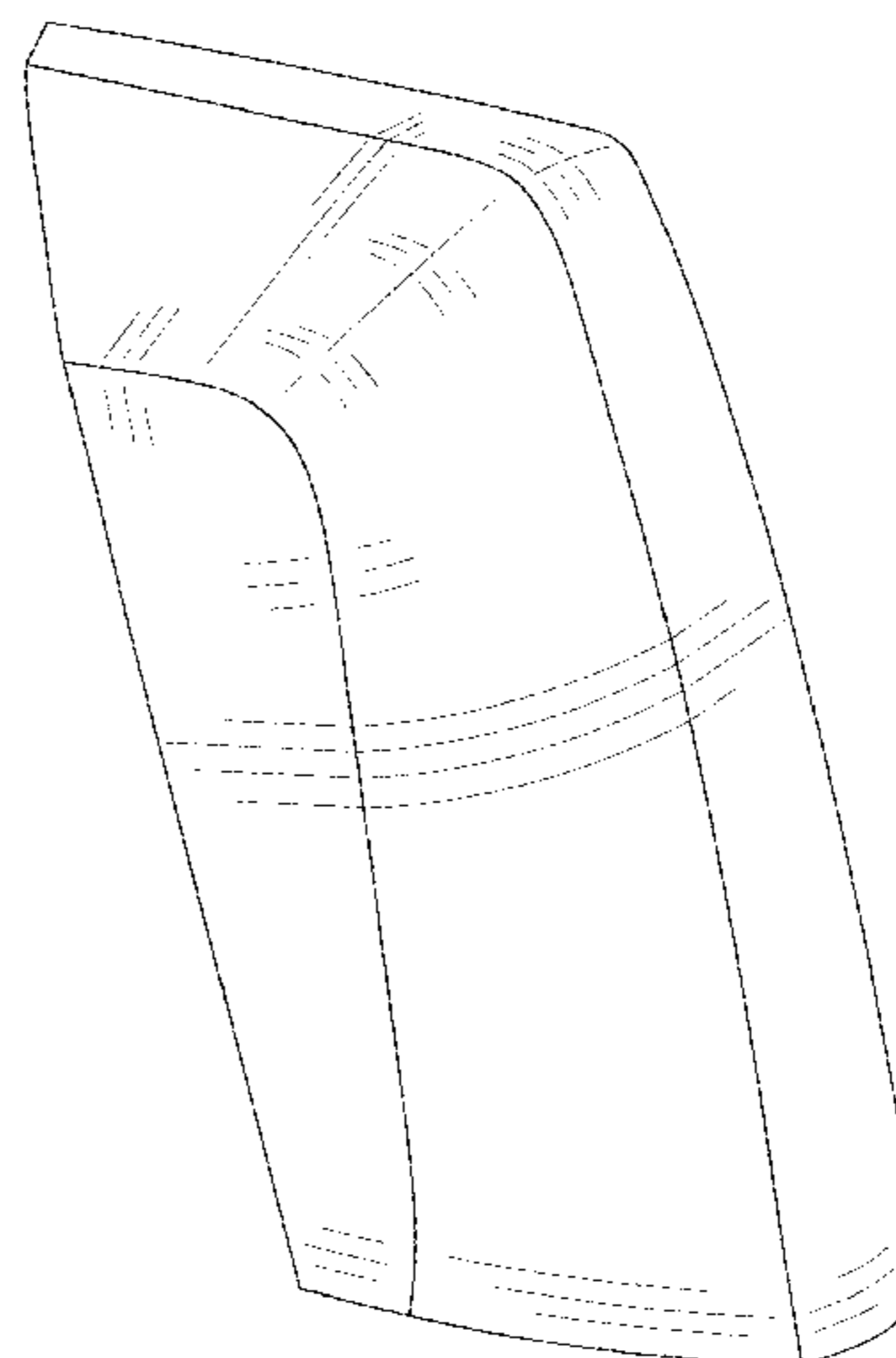
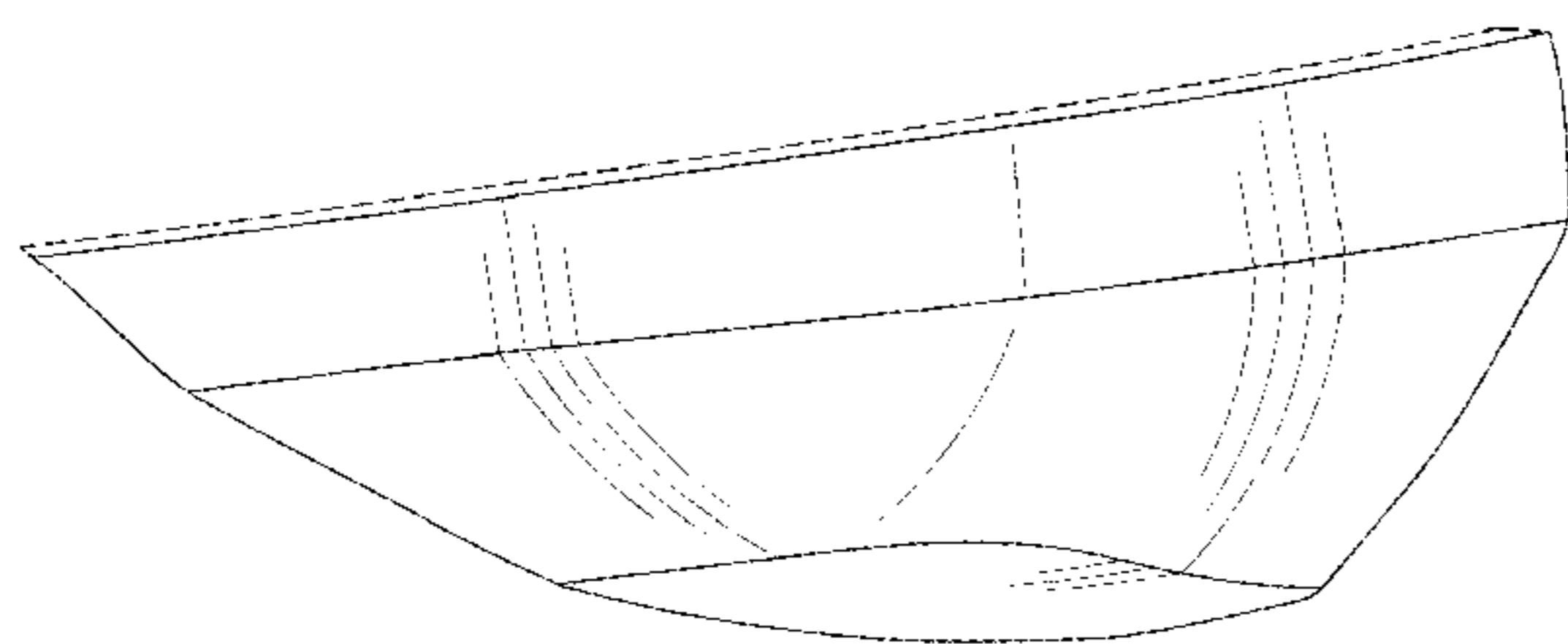

(57) **CLAIM**
The ornamental design for a vehicle rear taillamp lens, as shown and described.

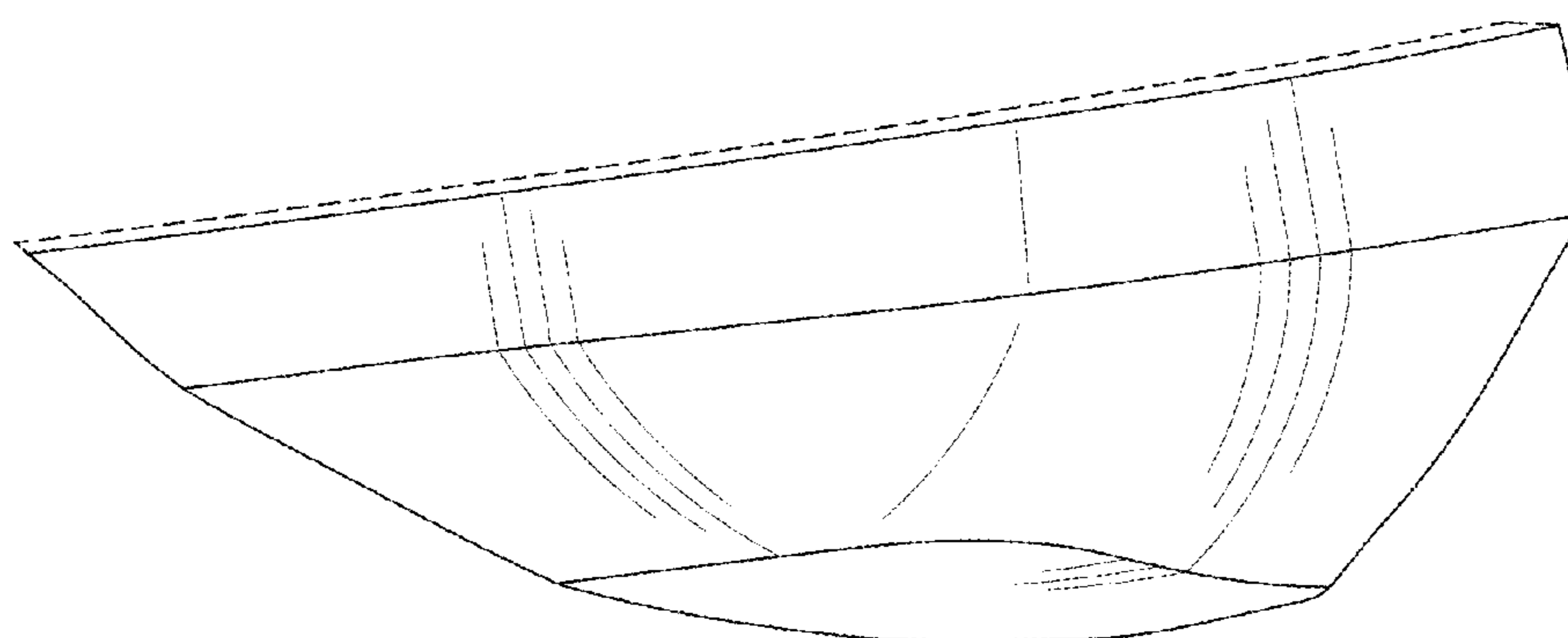

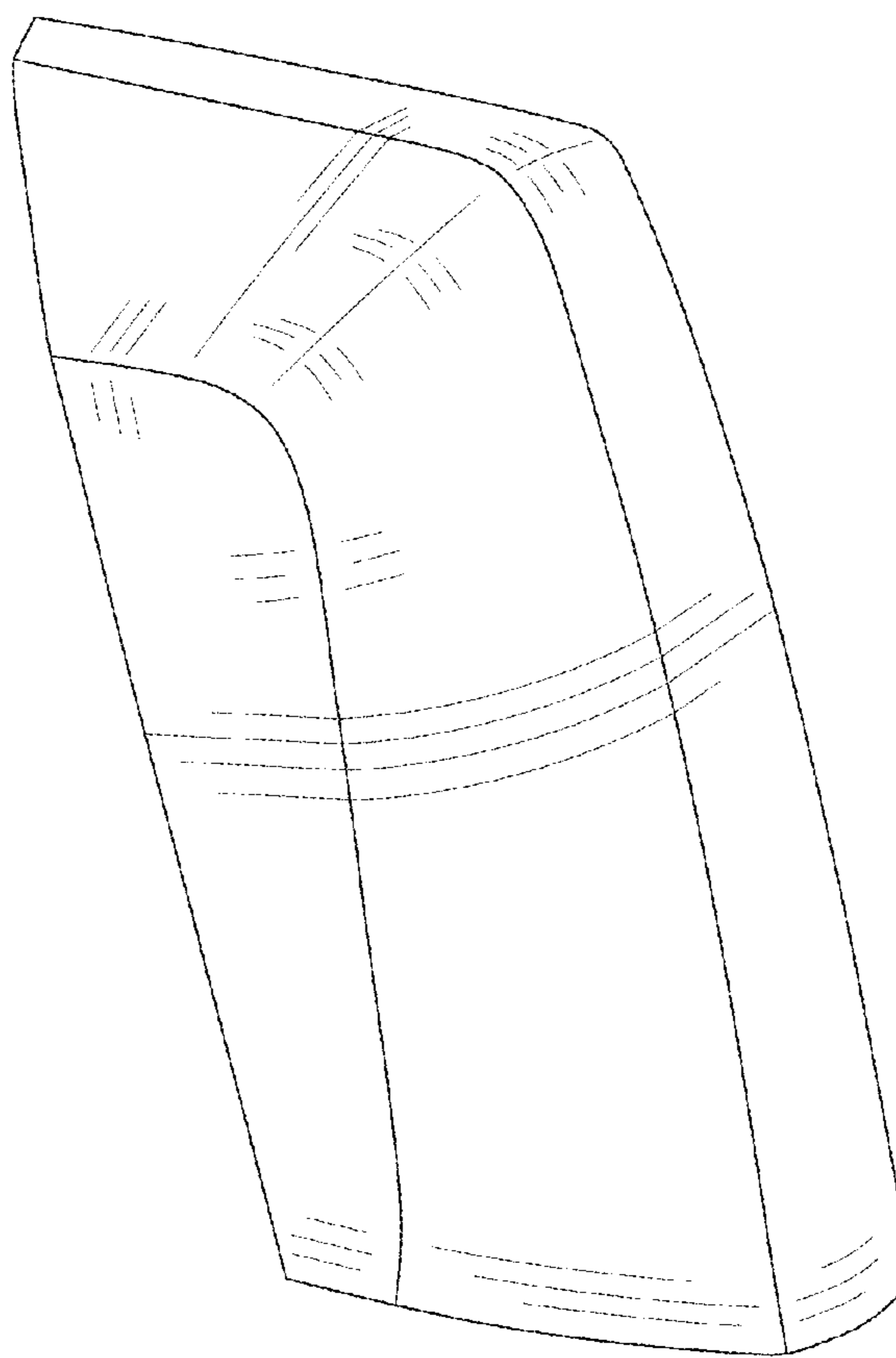

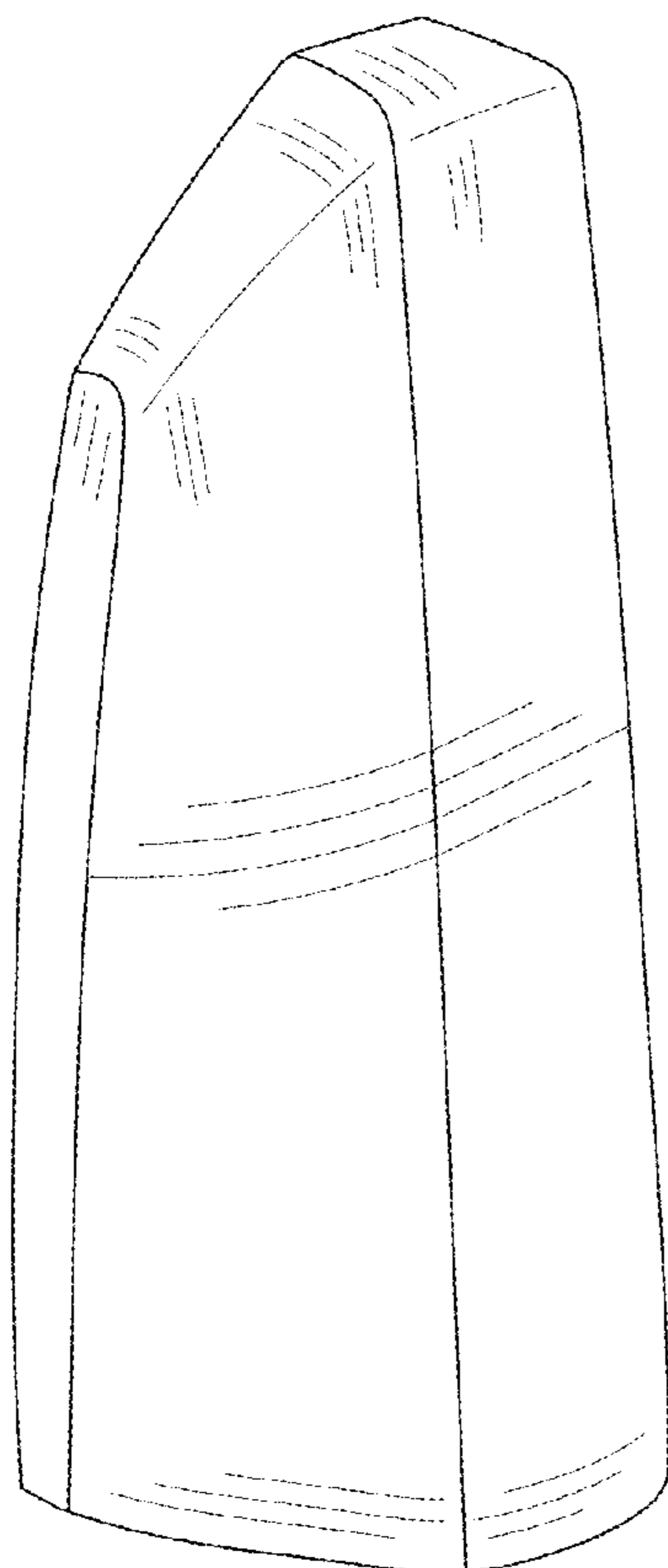
