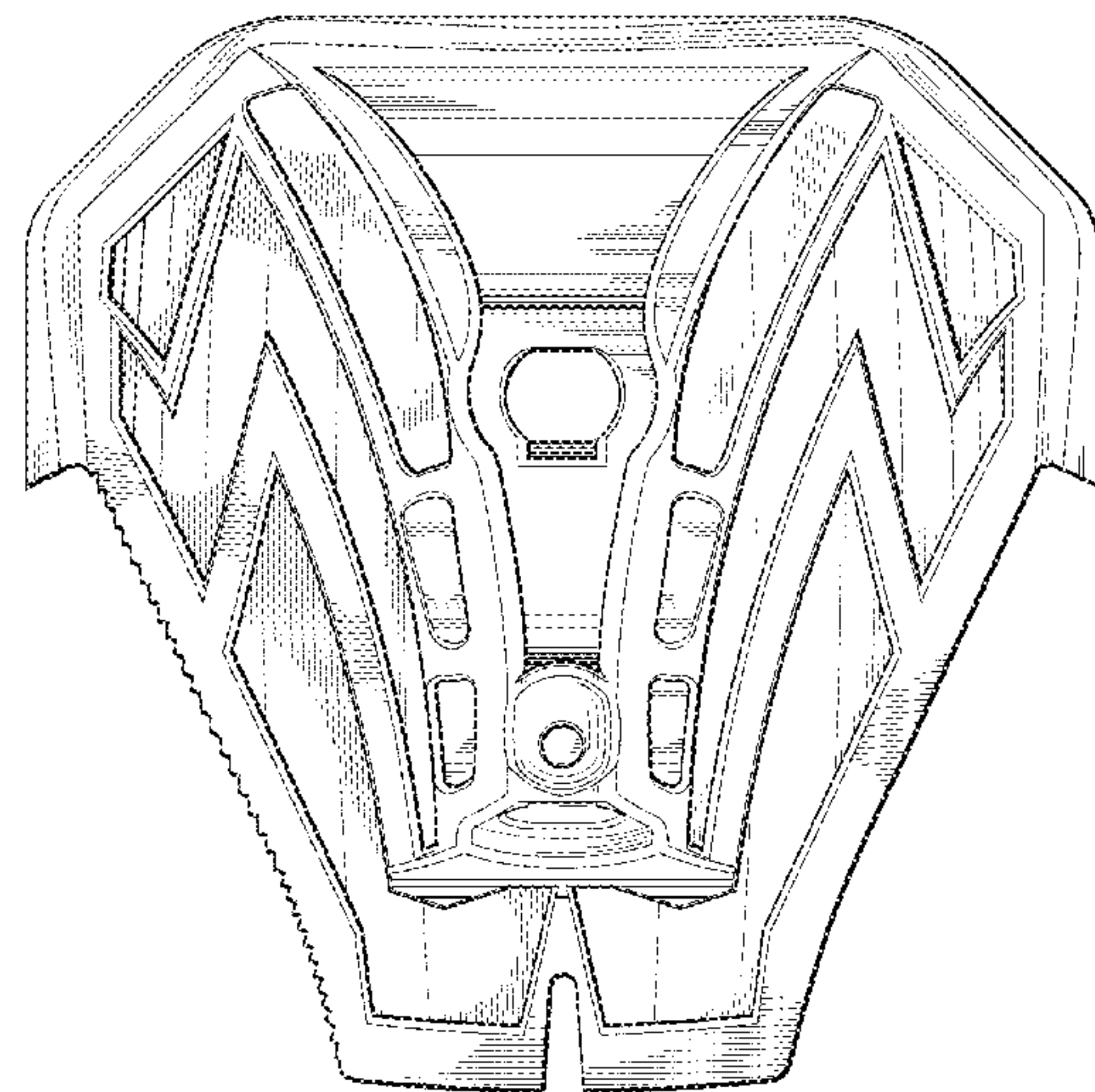
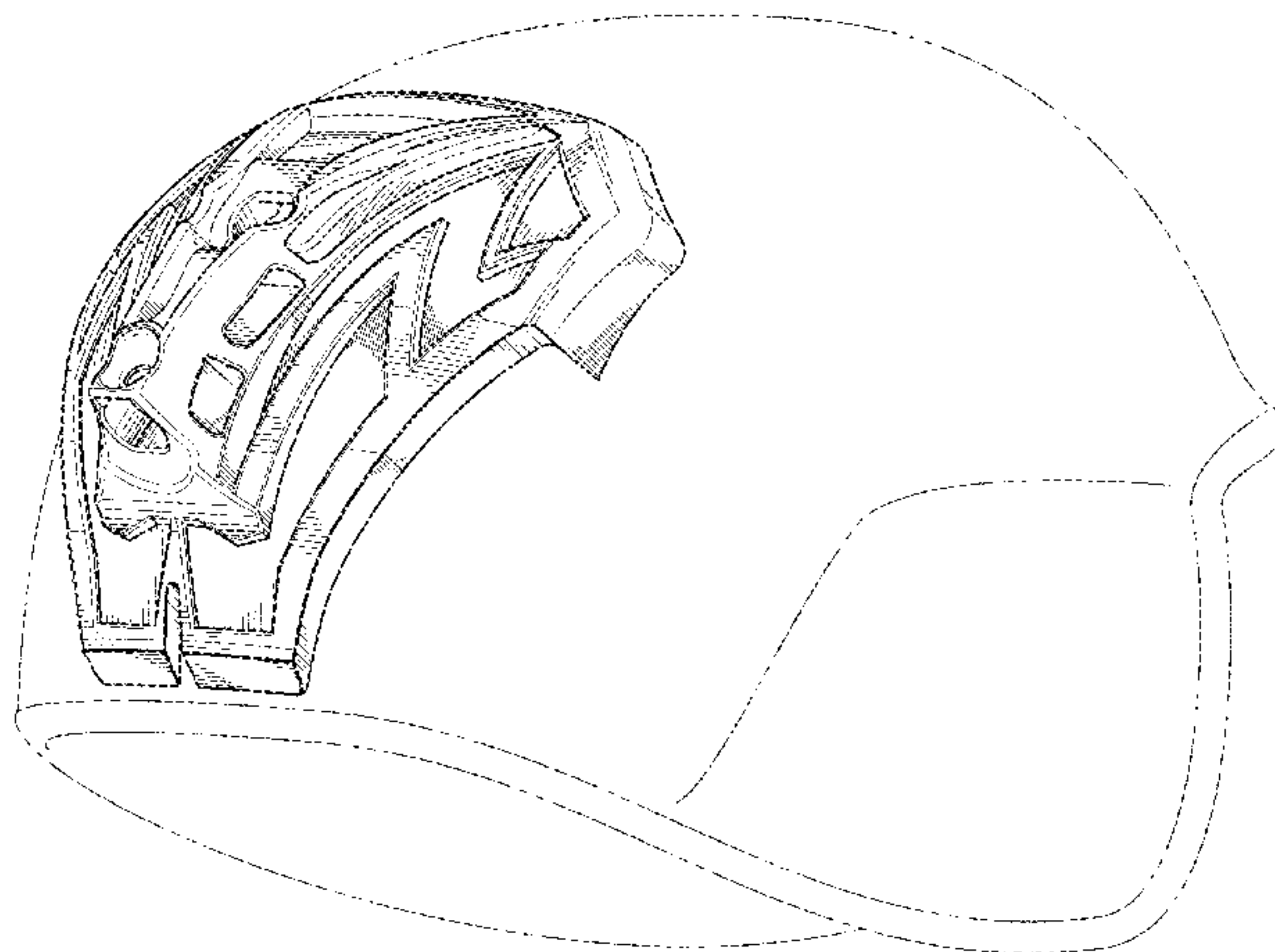
(57) **CLAIM**

I claim the ornamental design for a helmet counterweight shovel head, as shown and described.

DESCRIPTION

FIG. 1 is a top, rear and right side perspective view of a helmet counterweight shovel head showing my new design; FIG. 2 is a top, rear and right side perspective view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a right side elevation view thereof; FIG. 7 is a rear elevation view thereof; and, FIG. 8 is a front elevation view thereof.

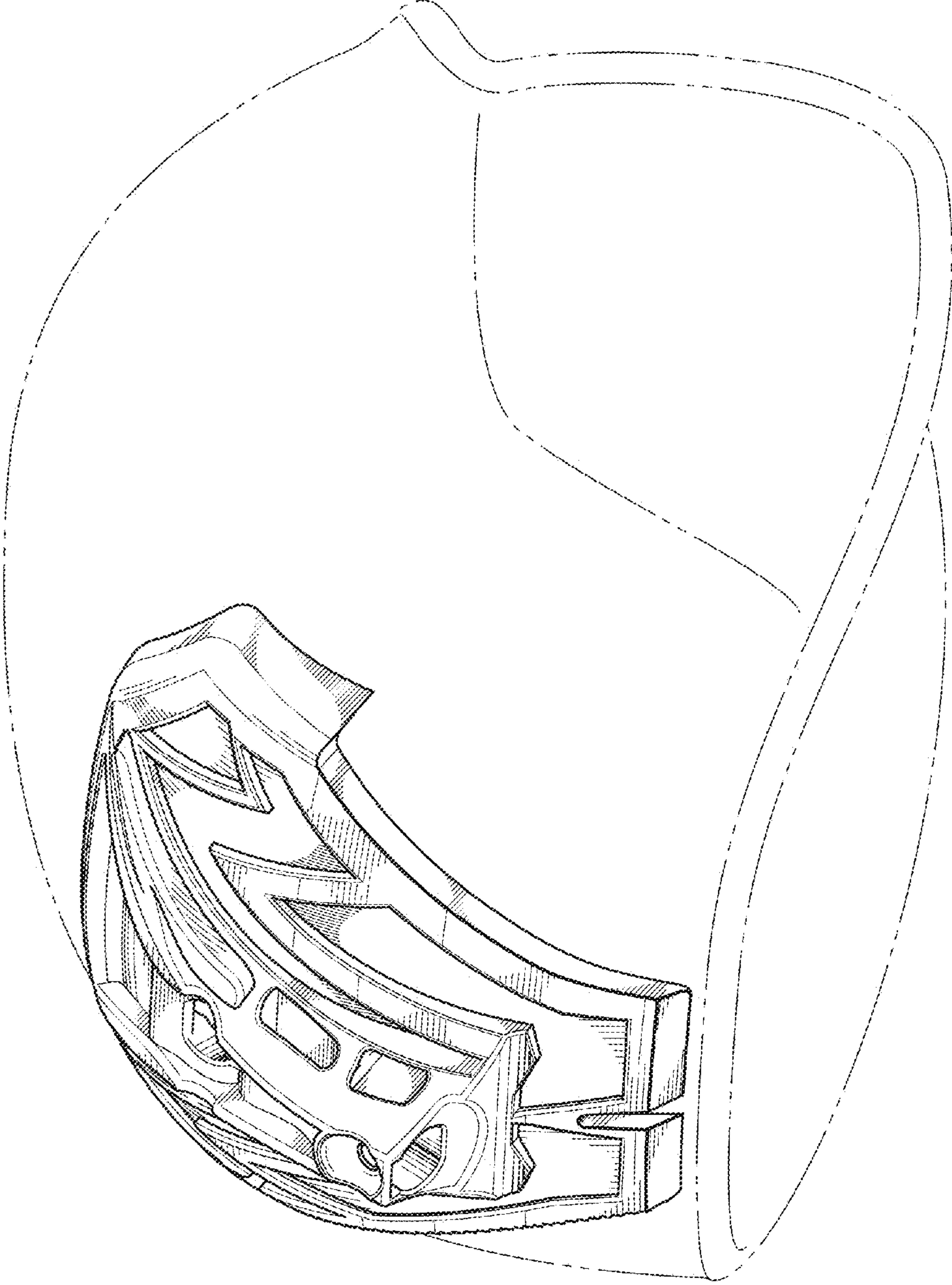

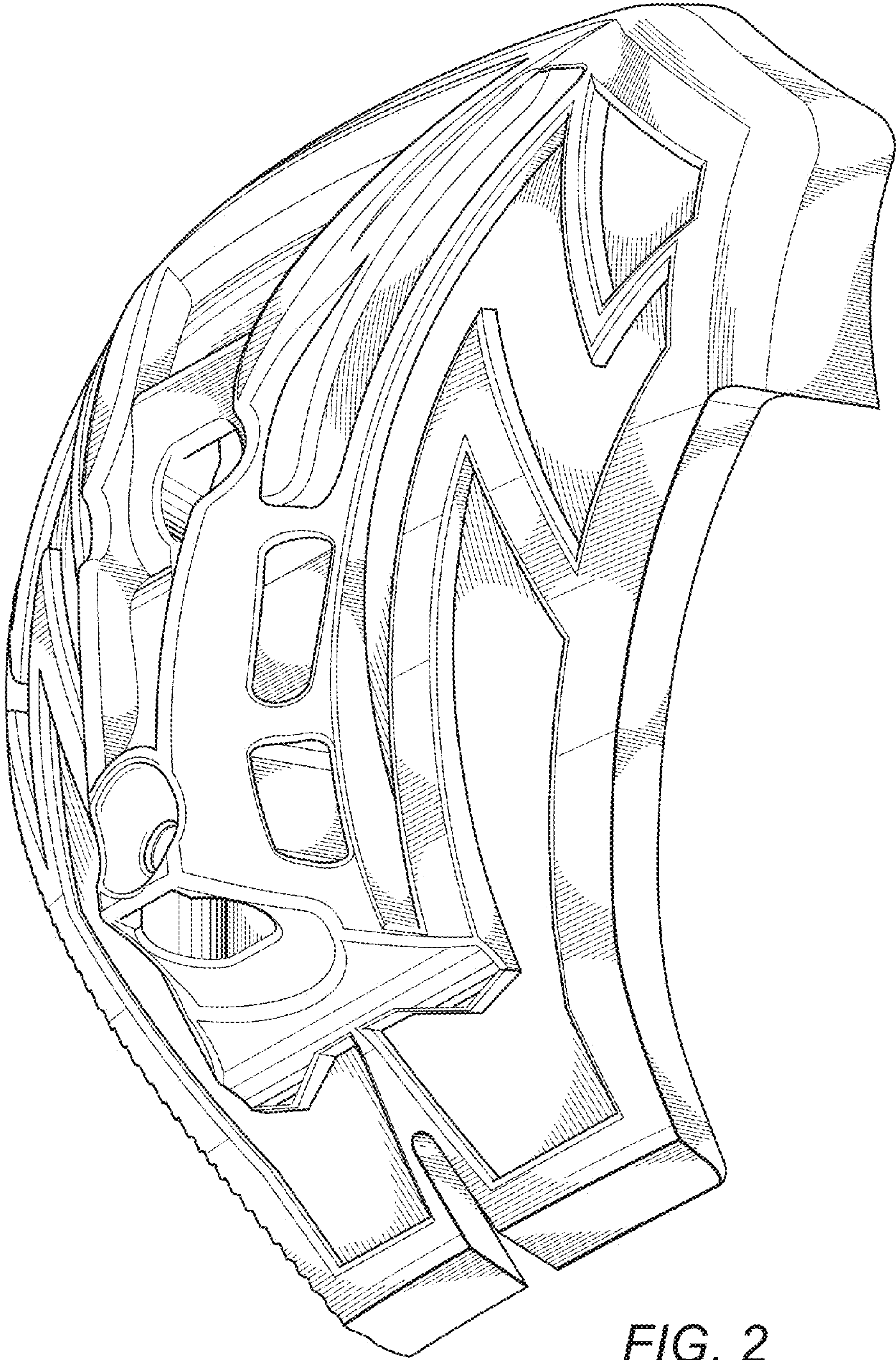

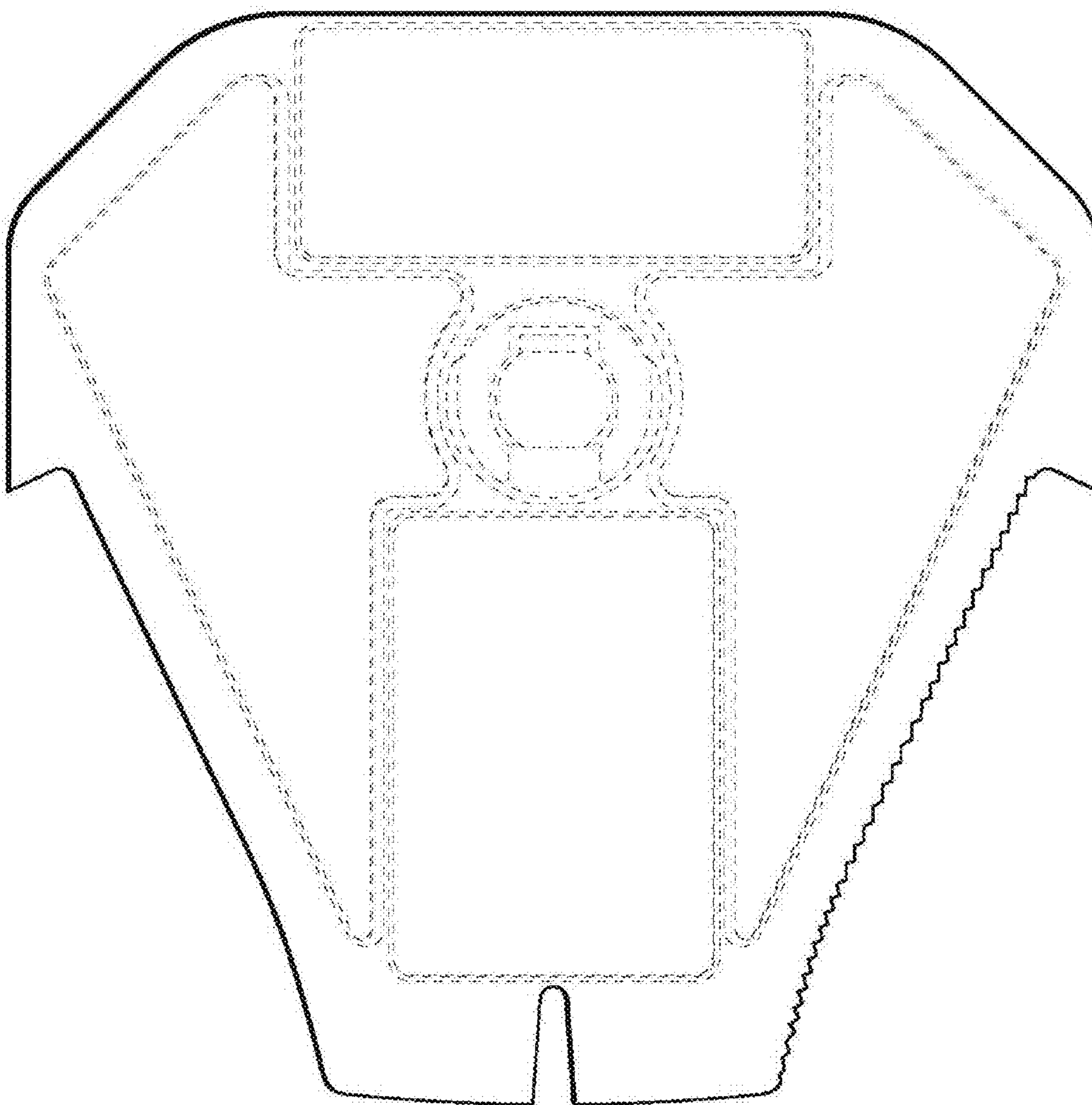

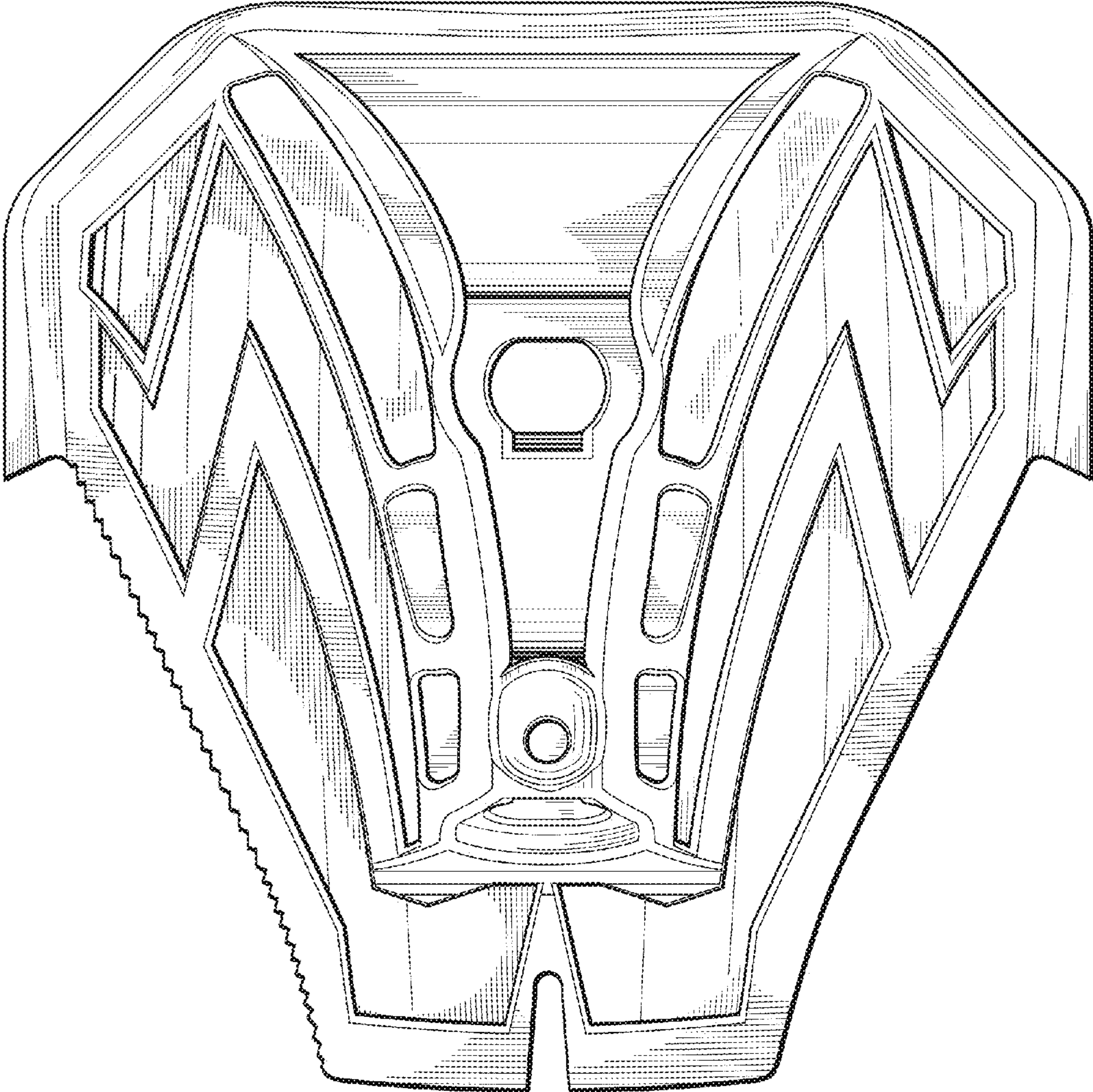

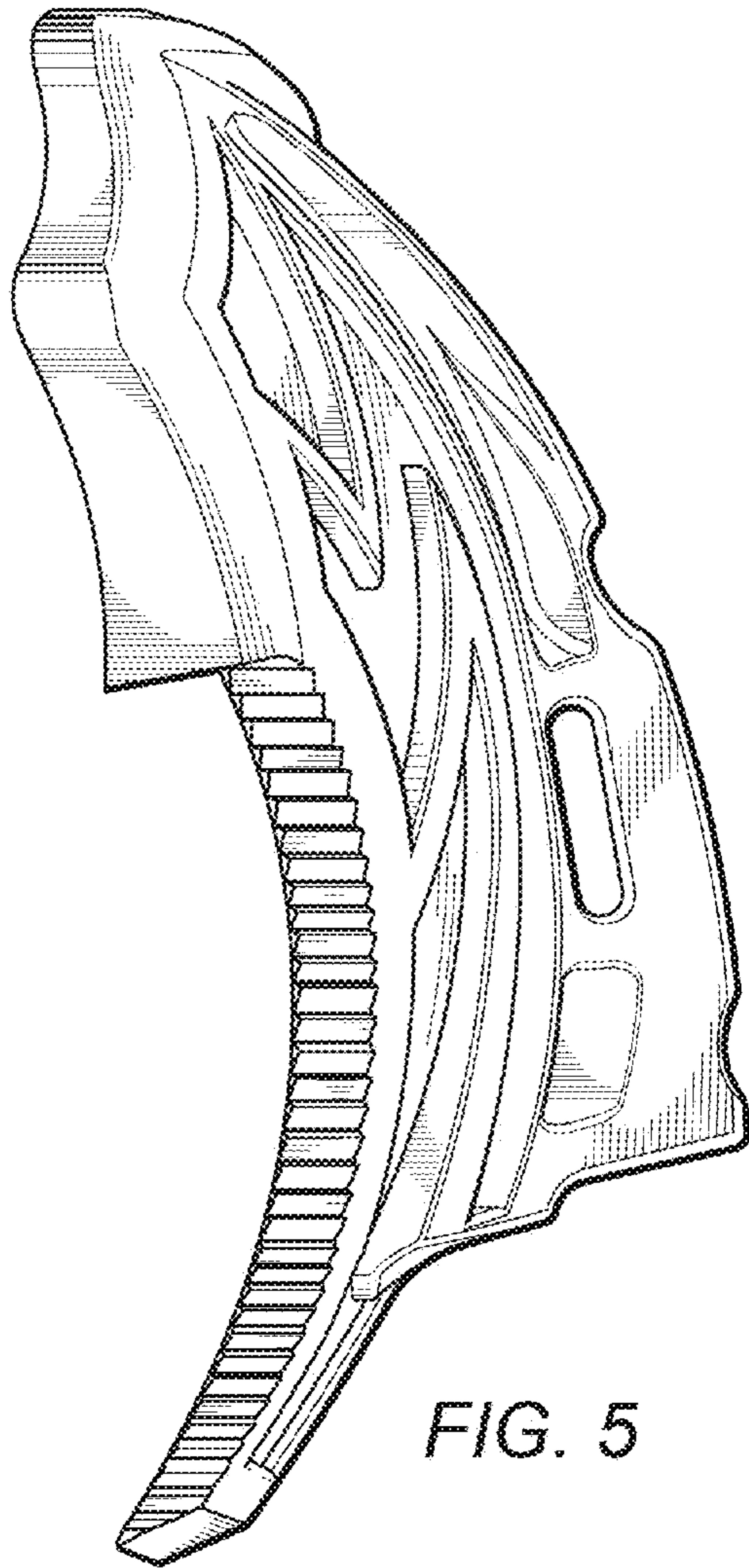

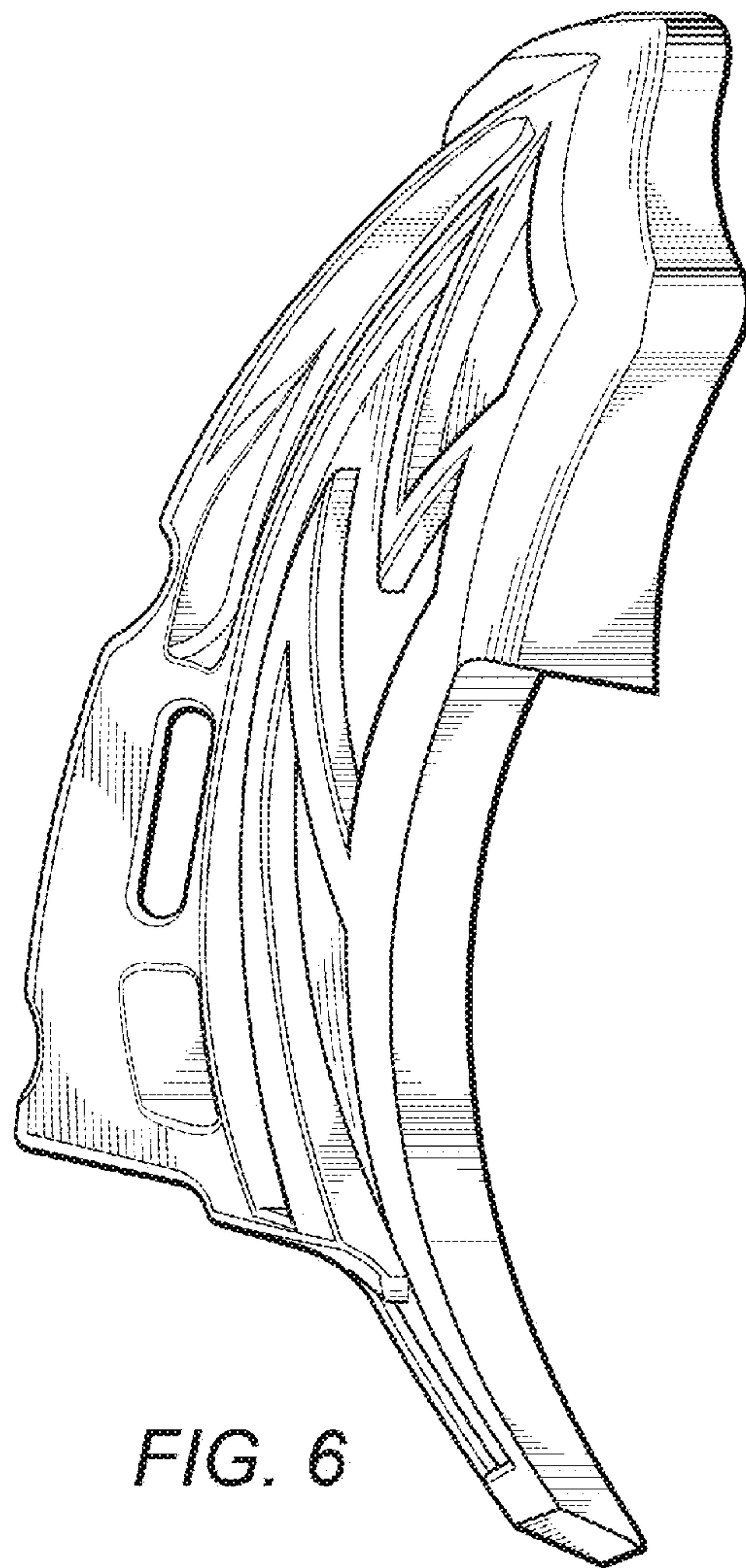

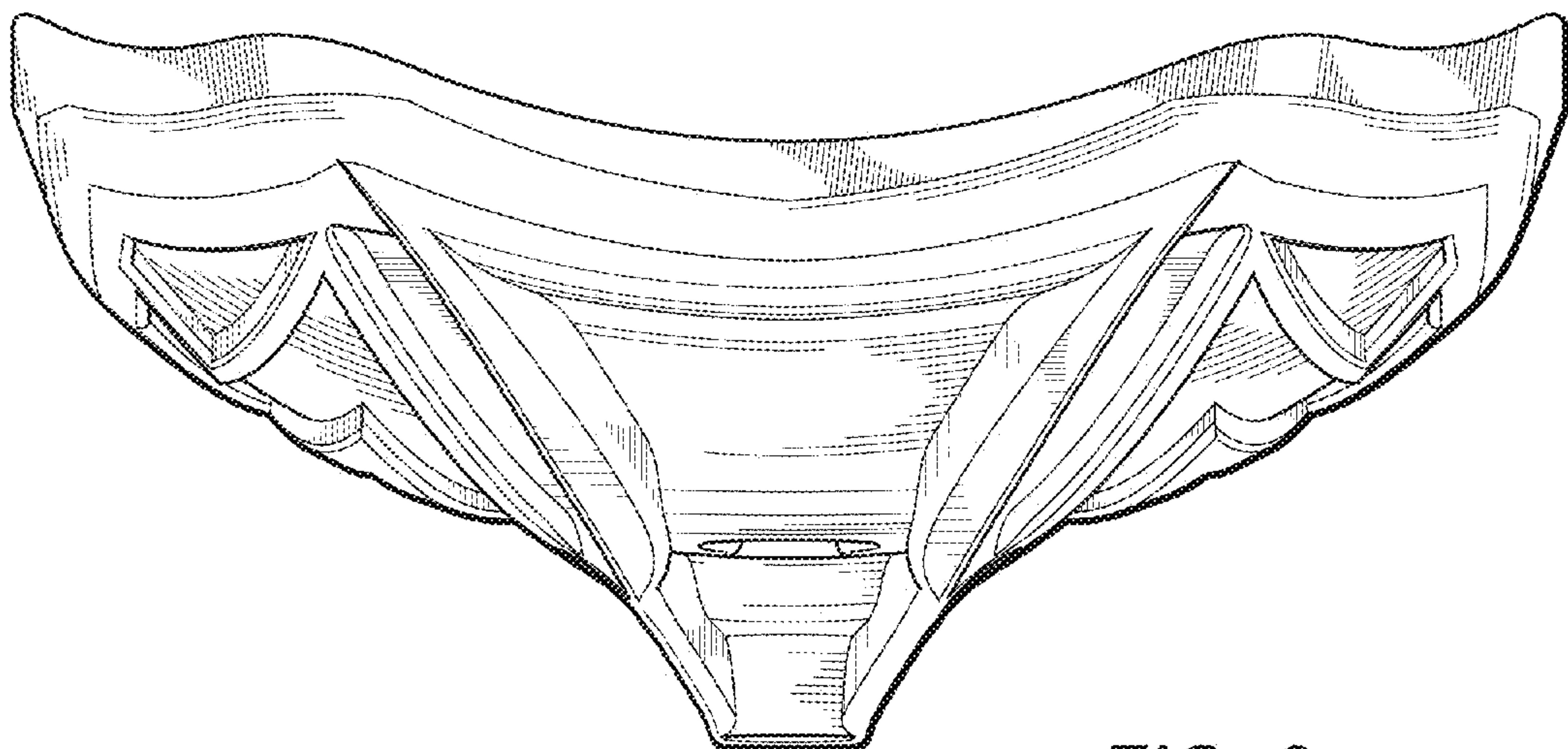
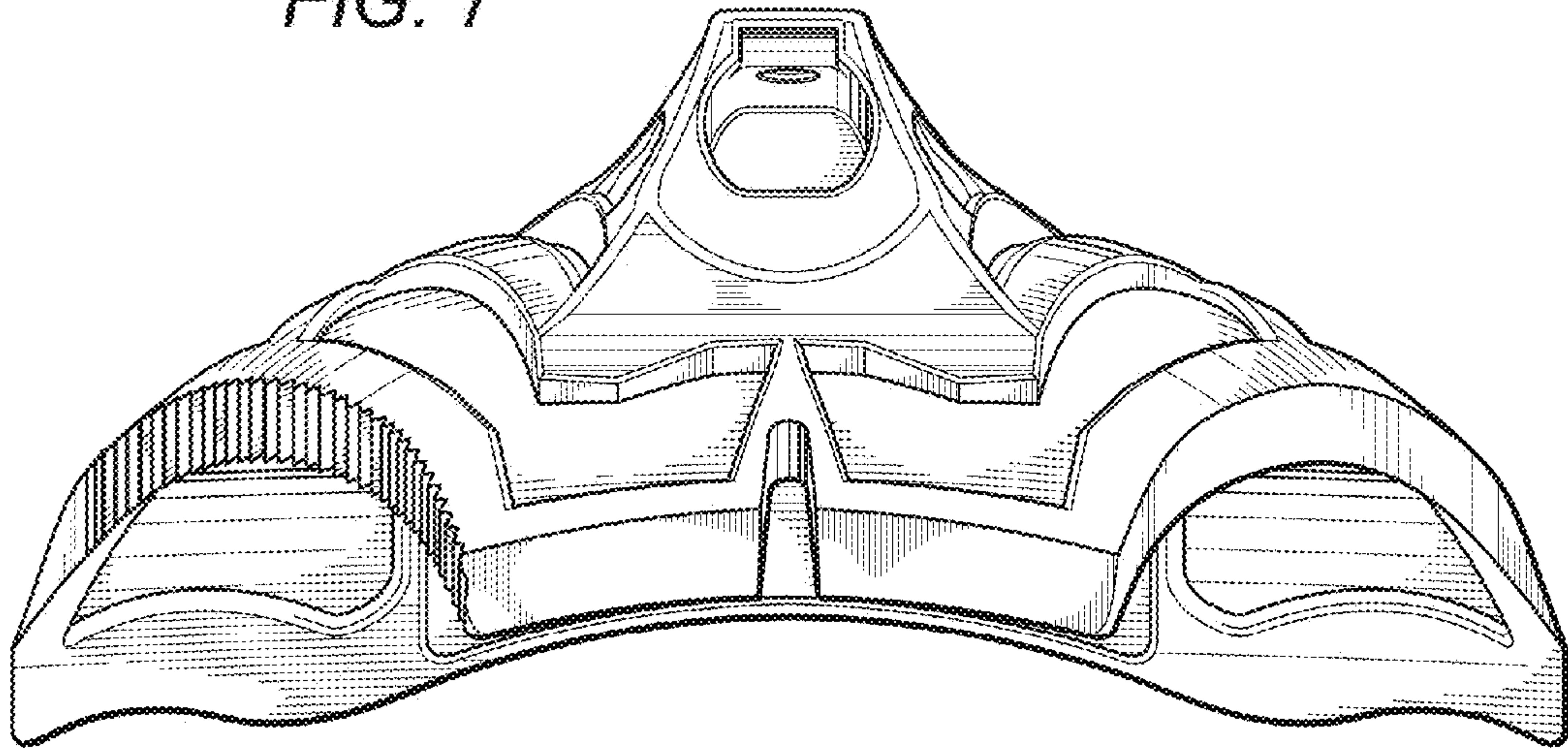
