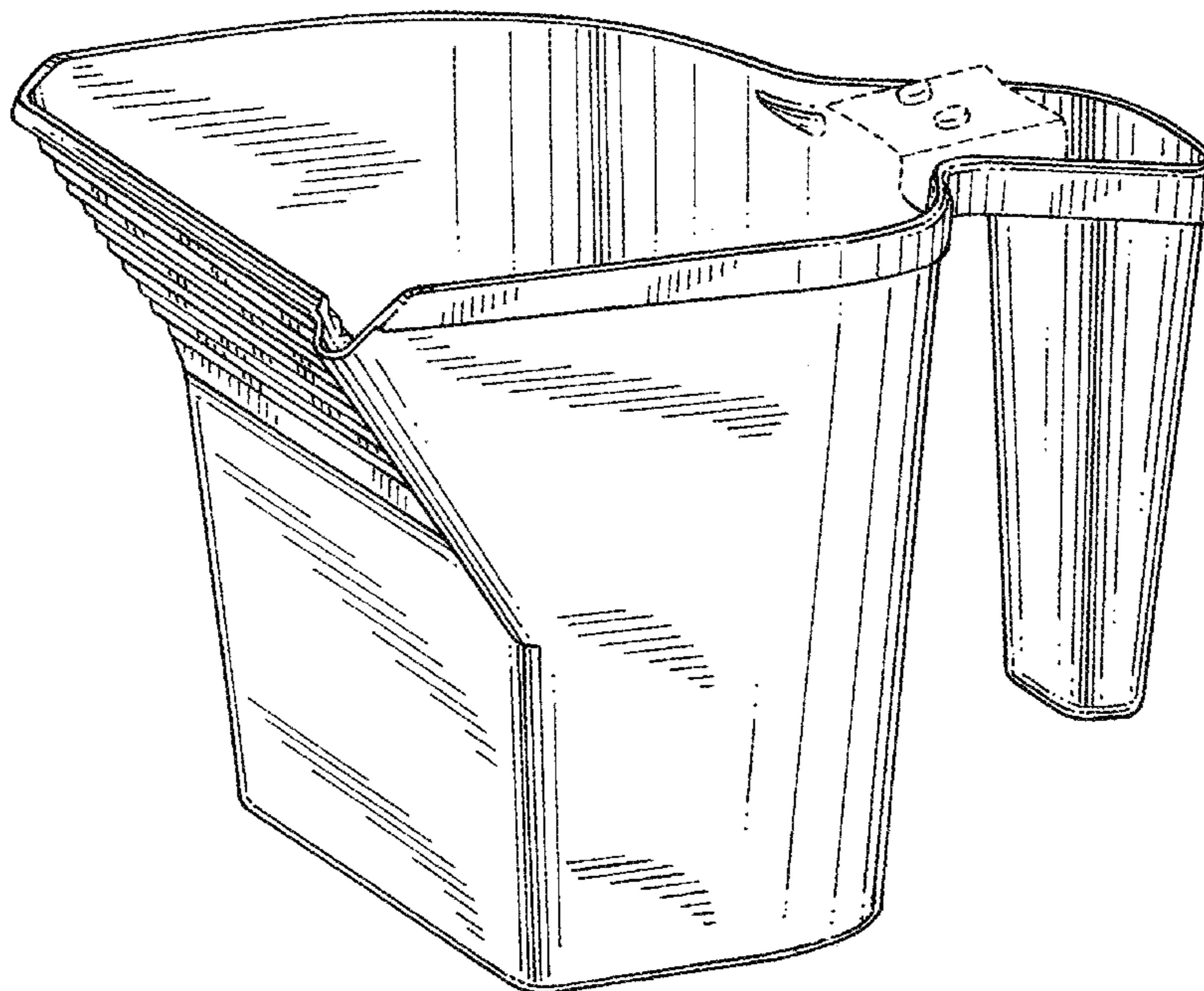
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a paint container with handle
showing my new design;

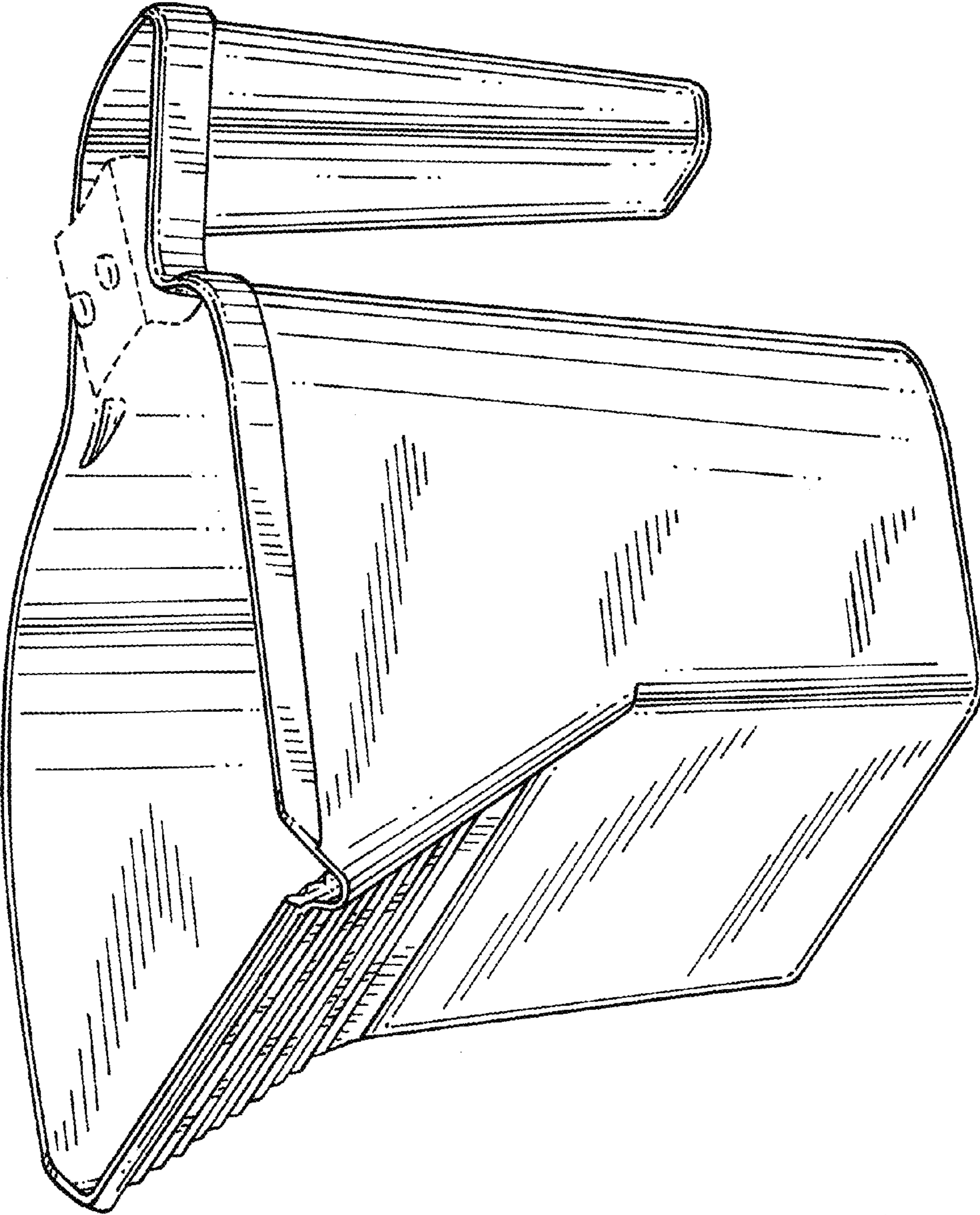

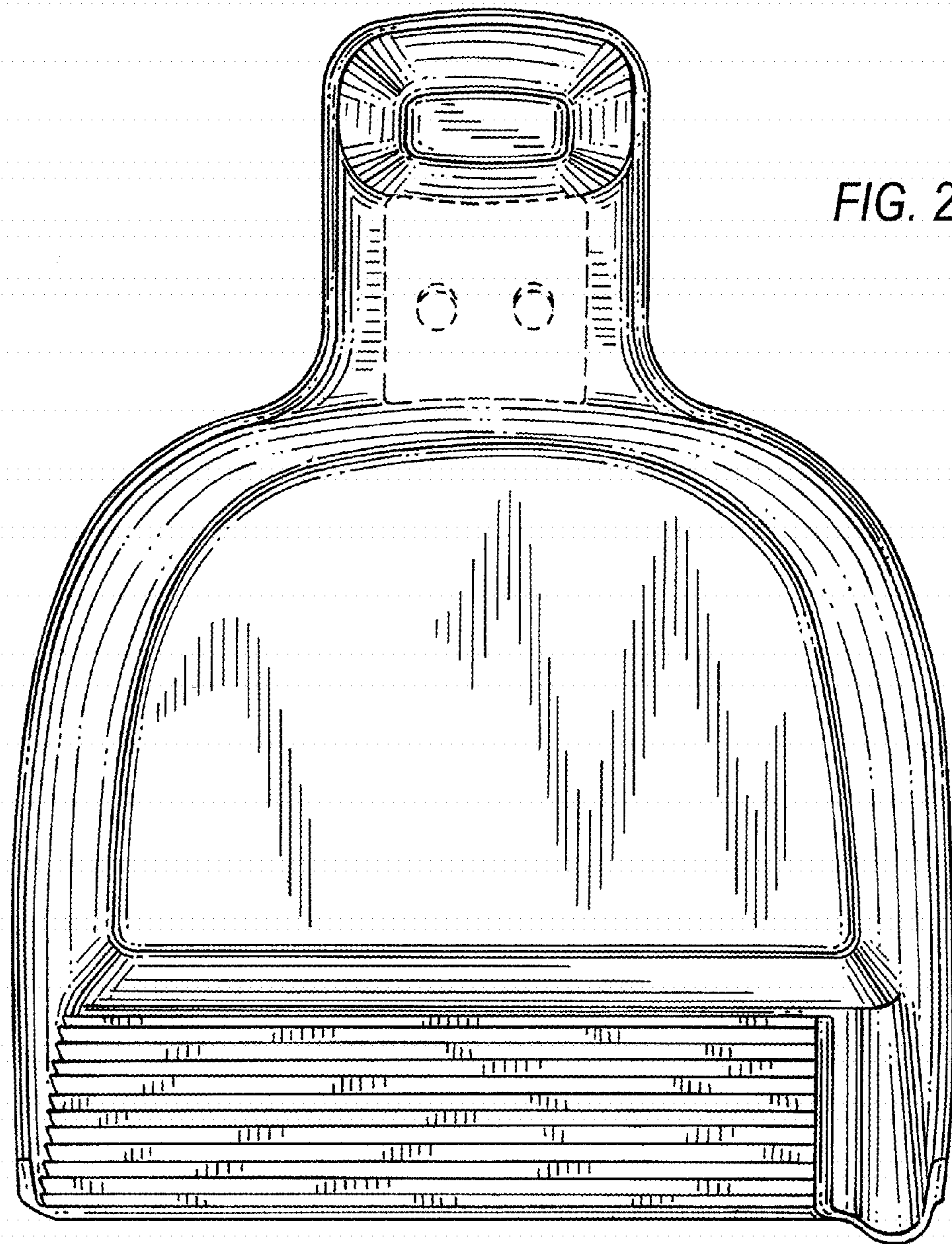

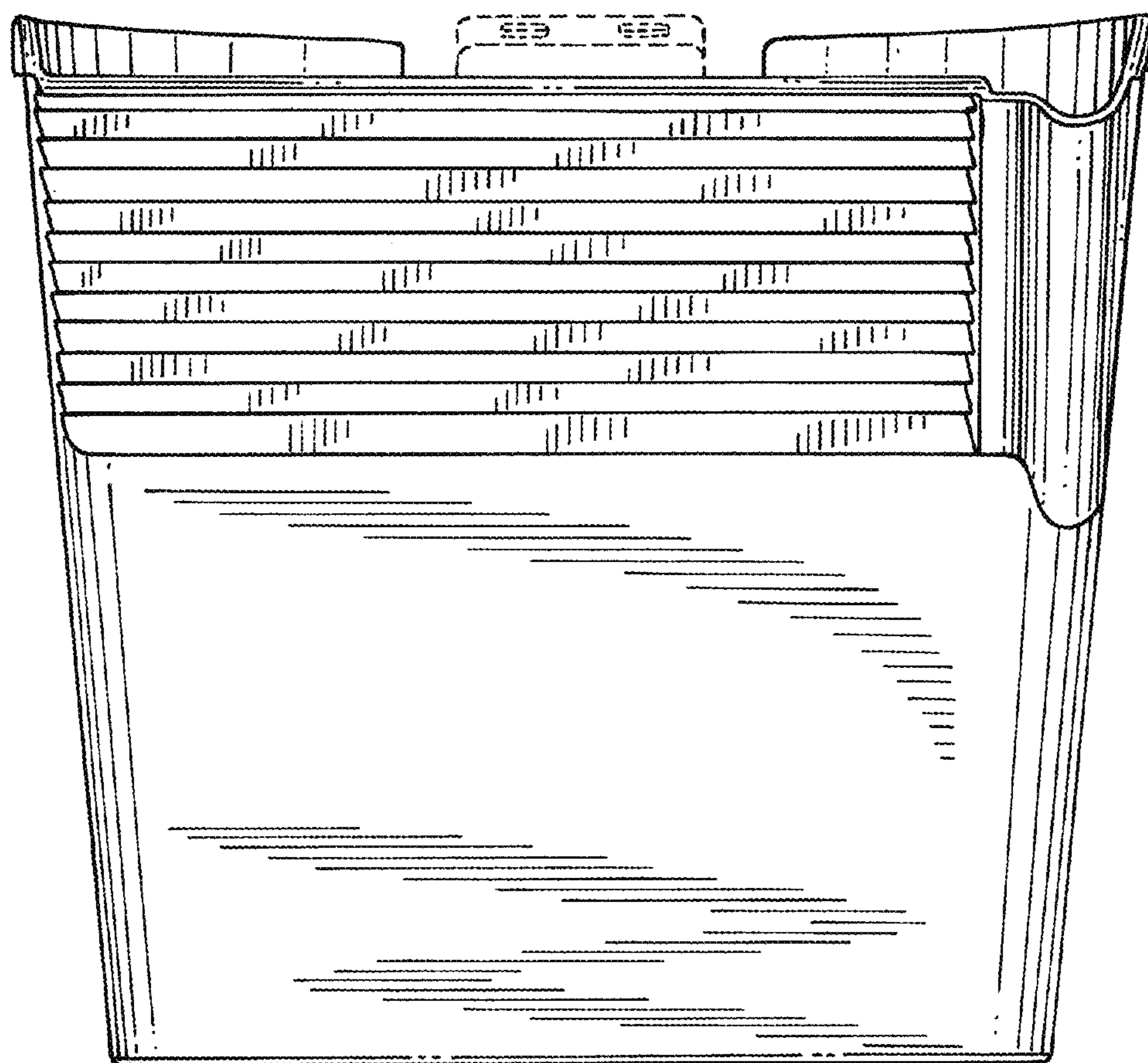

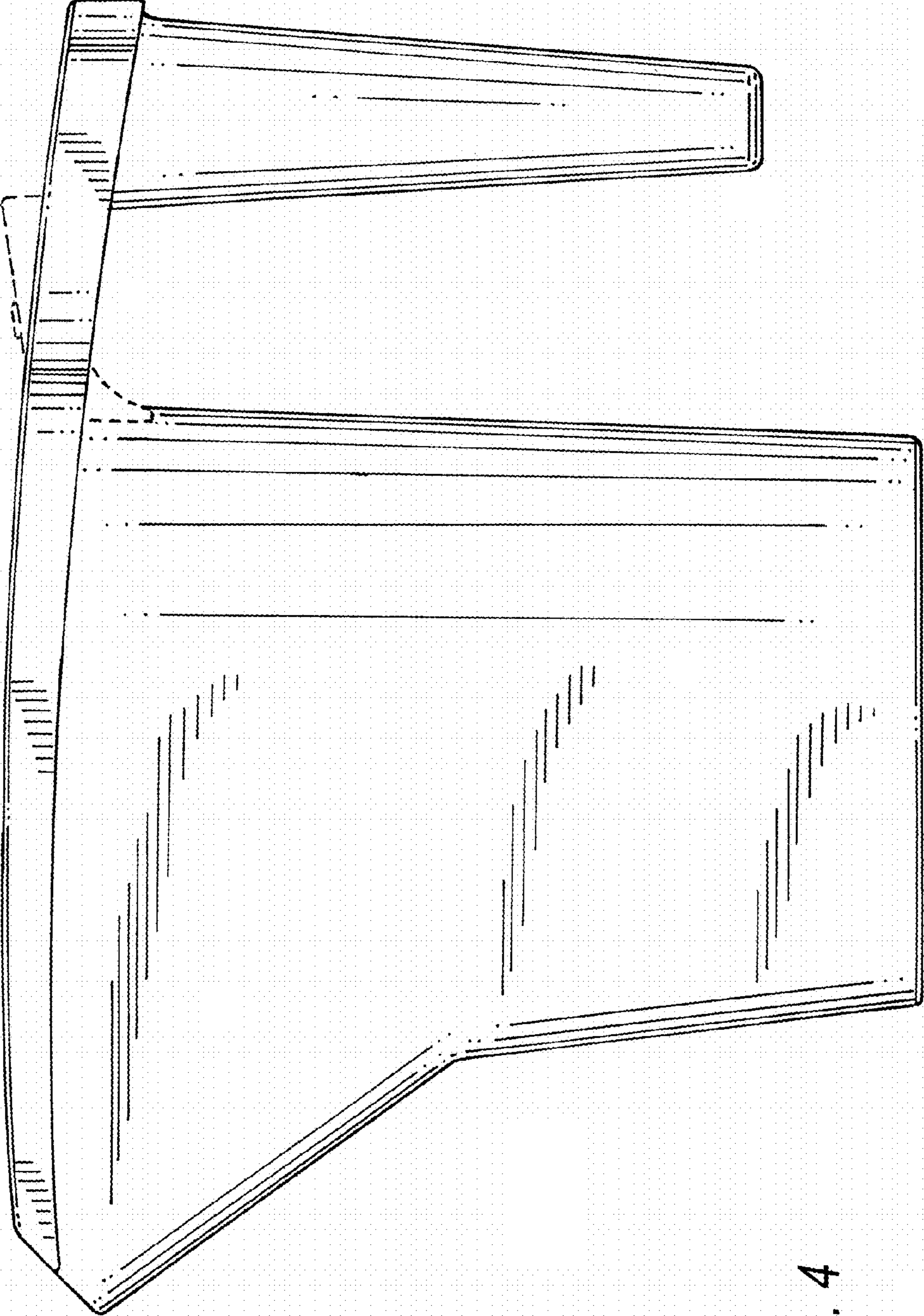
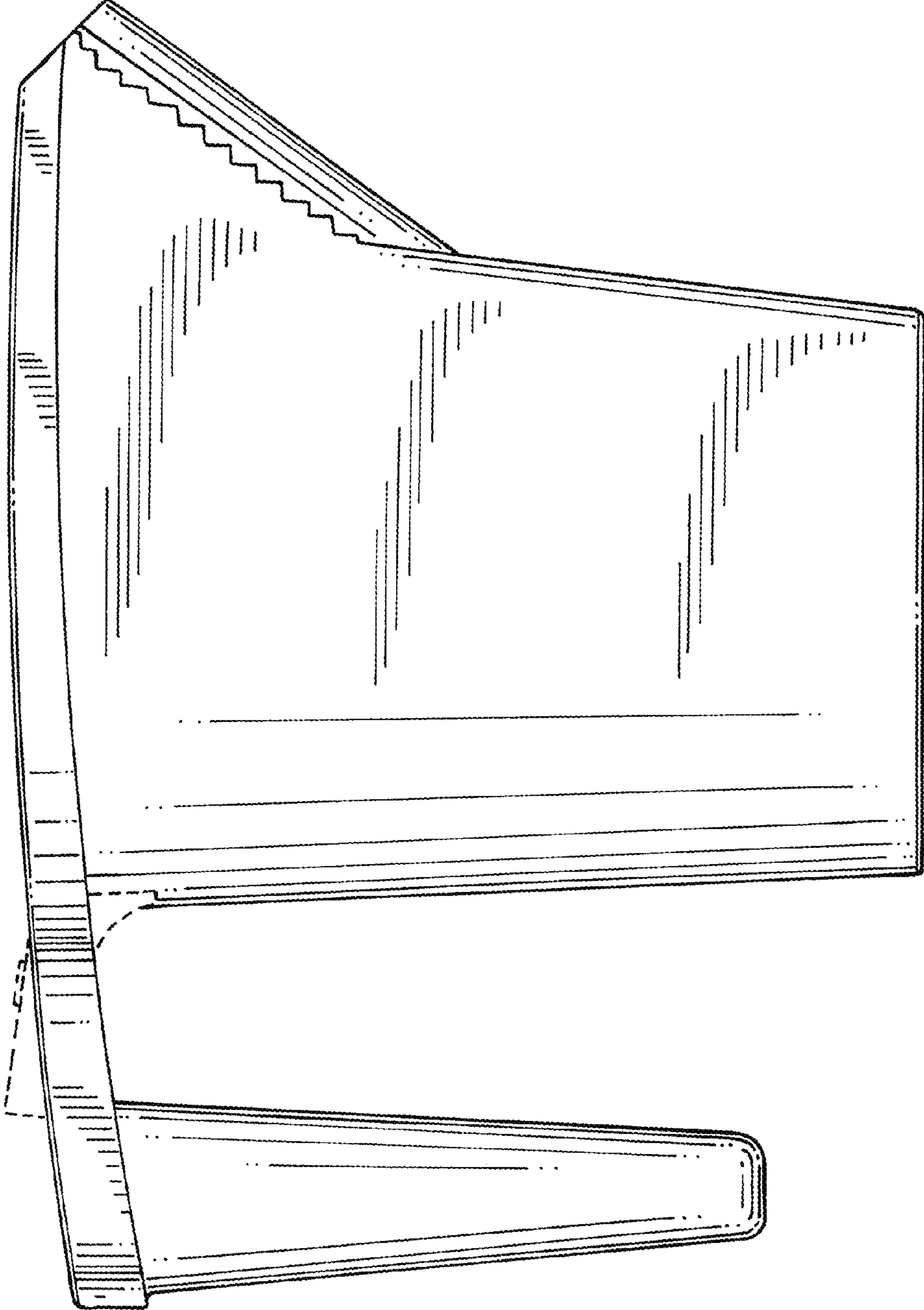

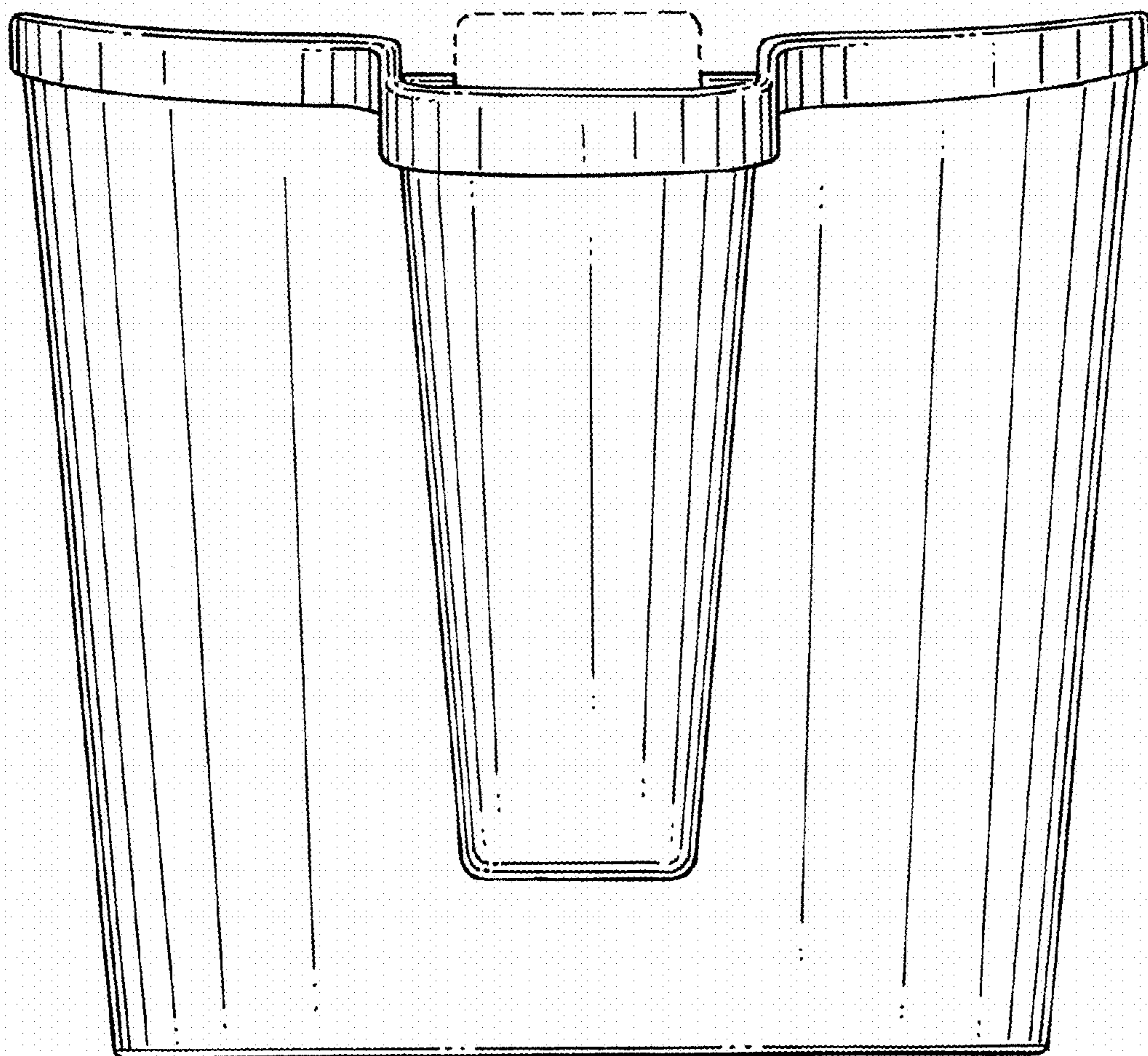

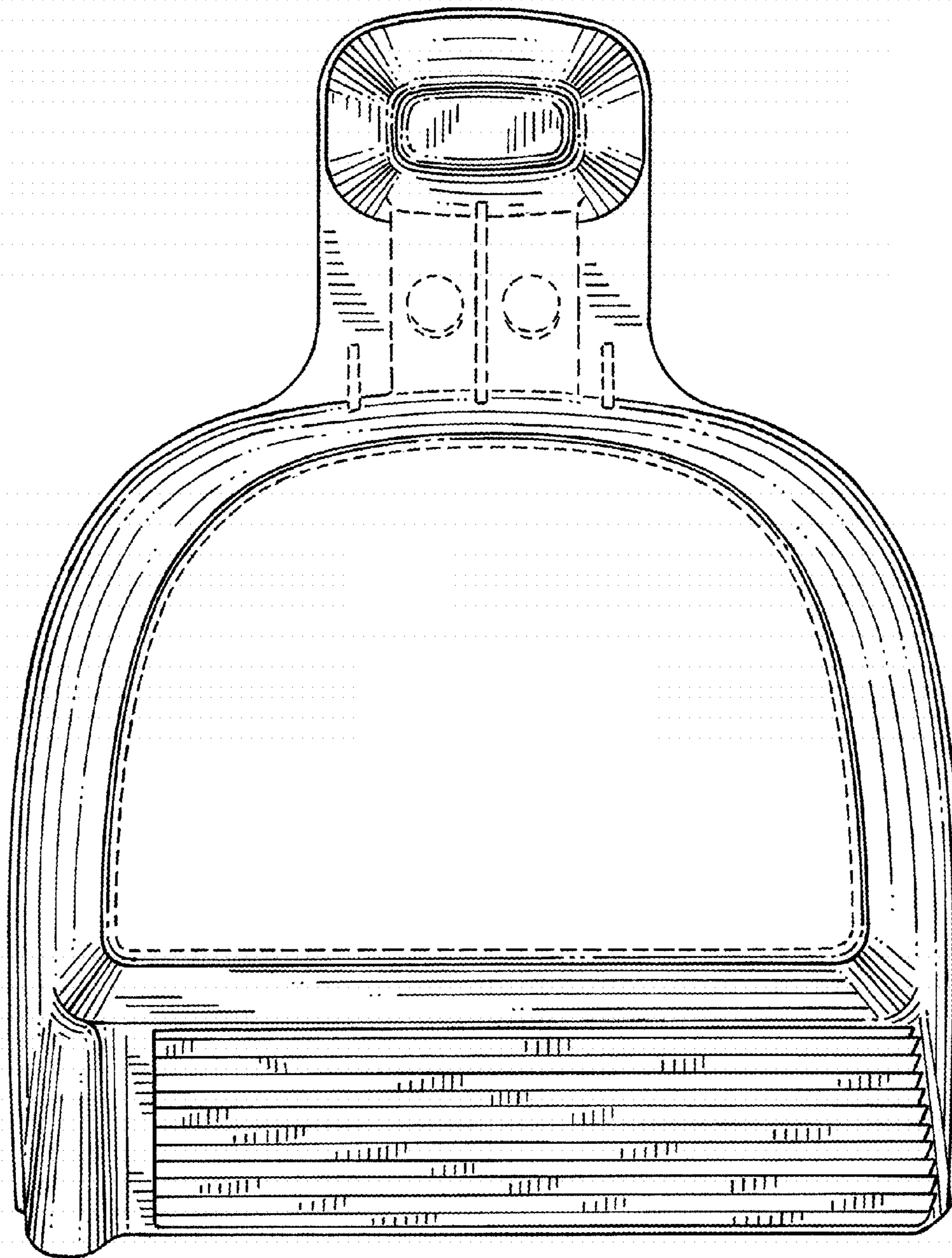
