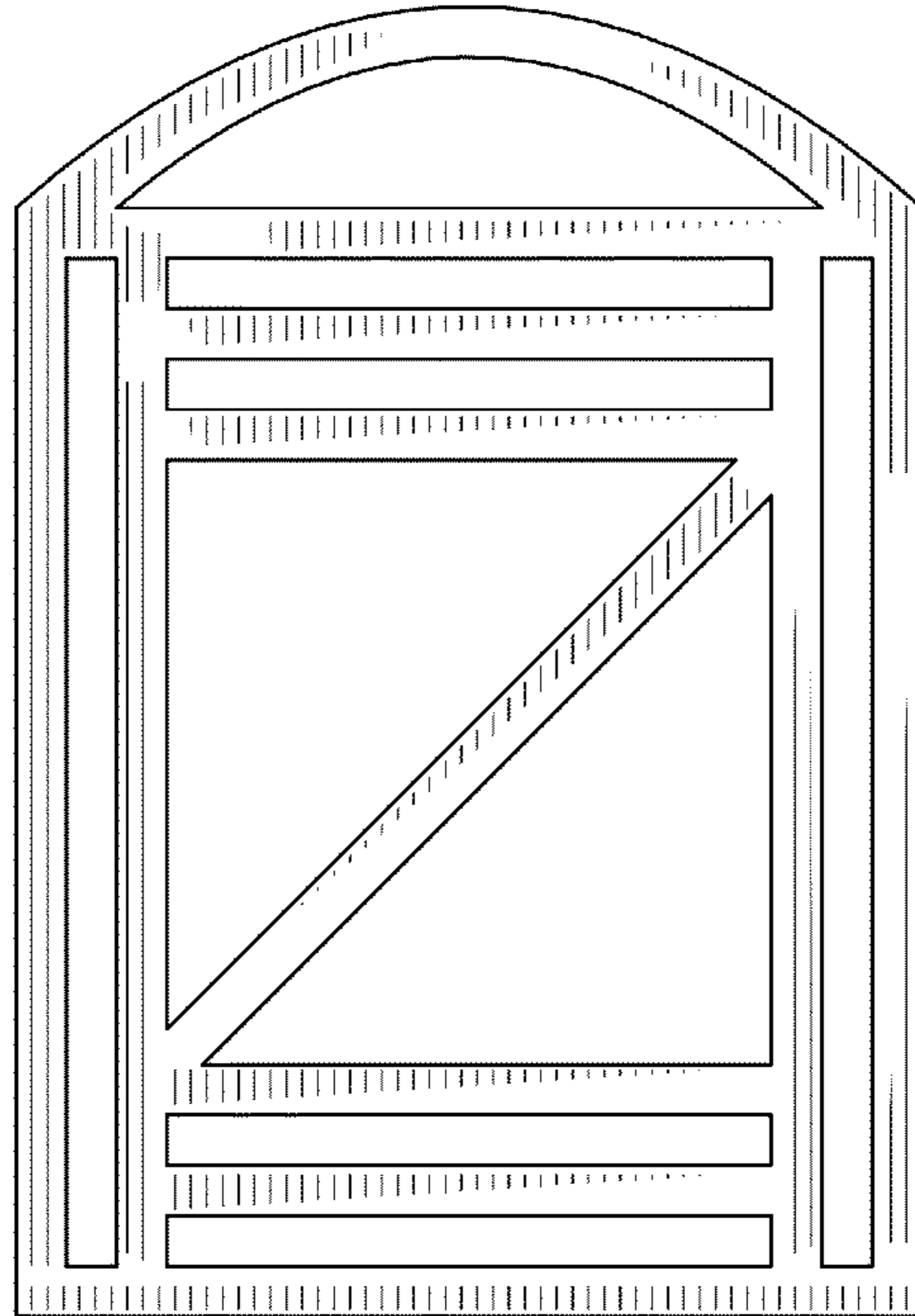
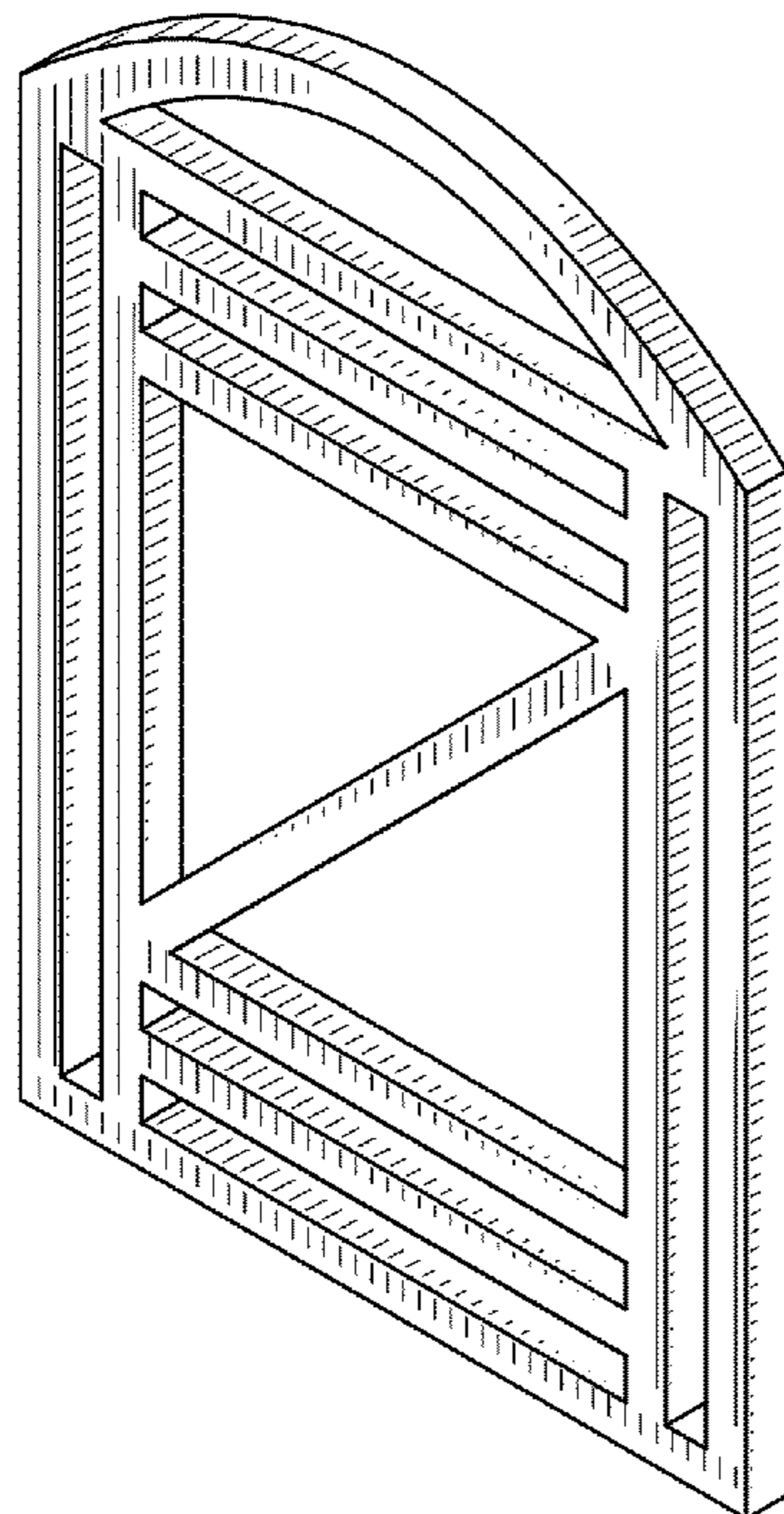
(57) **CLAIM**

The ornamental design for an N-frame pocket square holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective front view of an N-frame pocket square holder;
FIG. 2 is a front elevation view of the N-frame pocket square holder; the rear elevation view being a mirror image thereof;
FIG. 3 is a left side elevation view of the N-frame pocket square holder; the right side elevation view being a mirror image thereof;
FIG. 4 is a top plan view of the N-frame pocket square holder; and,
FIG. 5 is a bottom plan view of the N-frame pocket square holder.

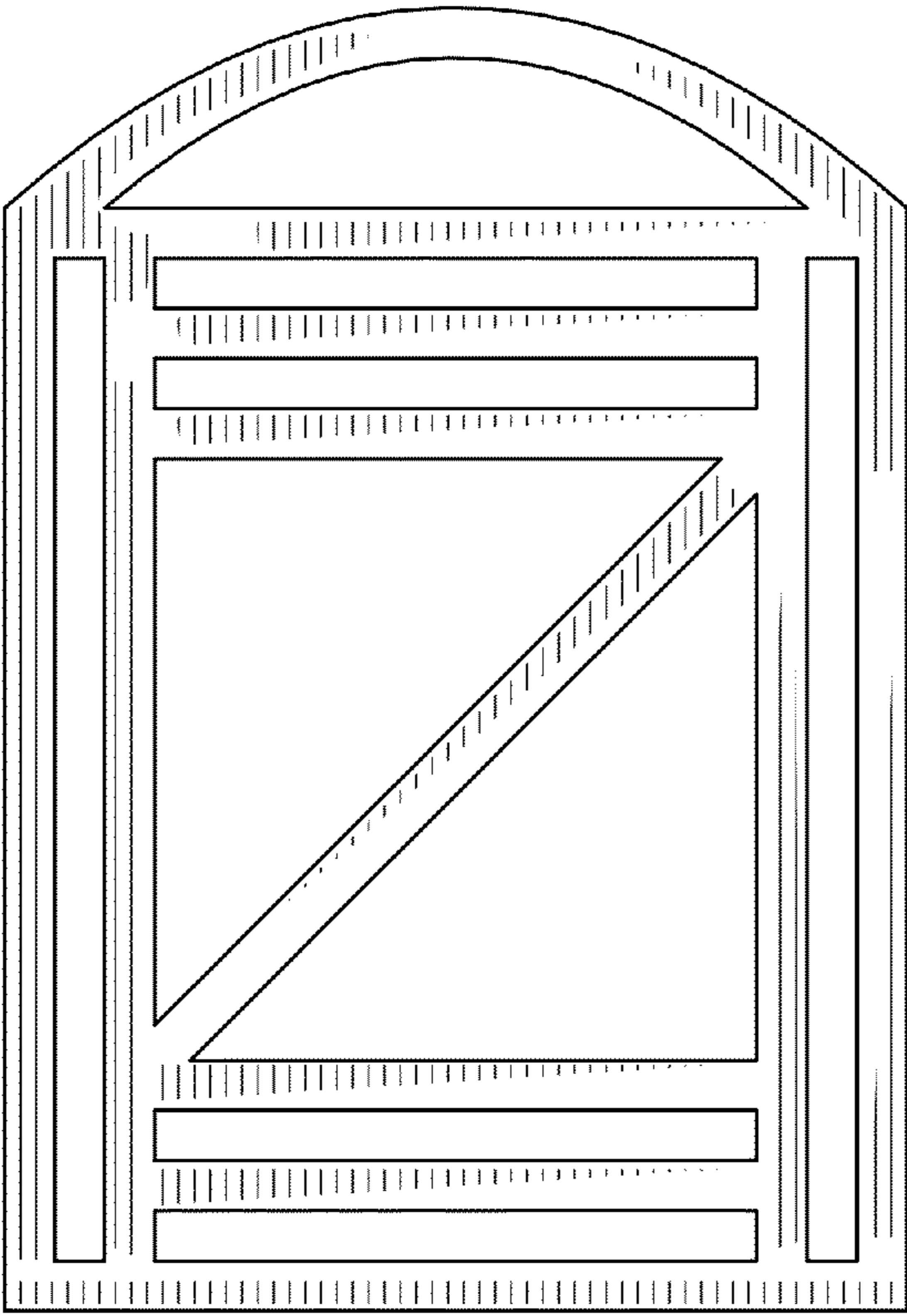

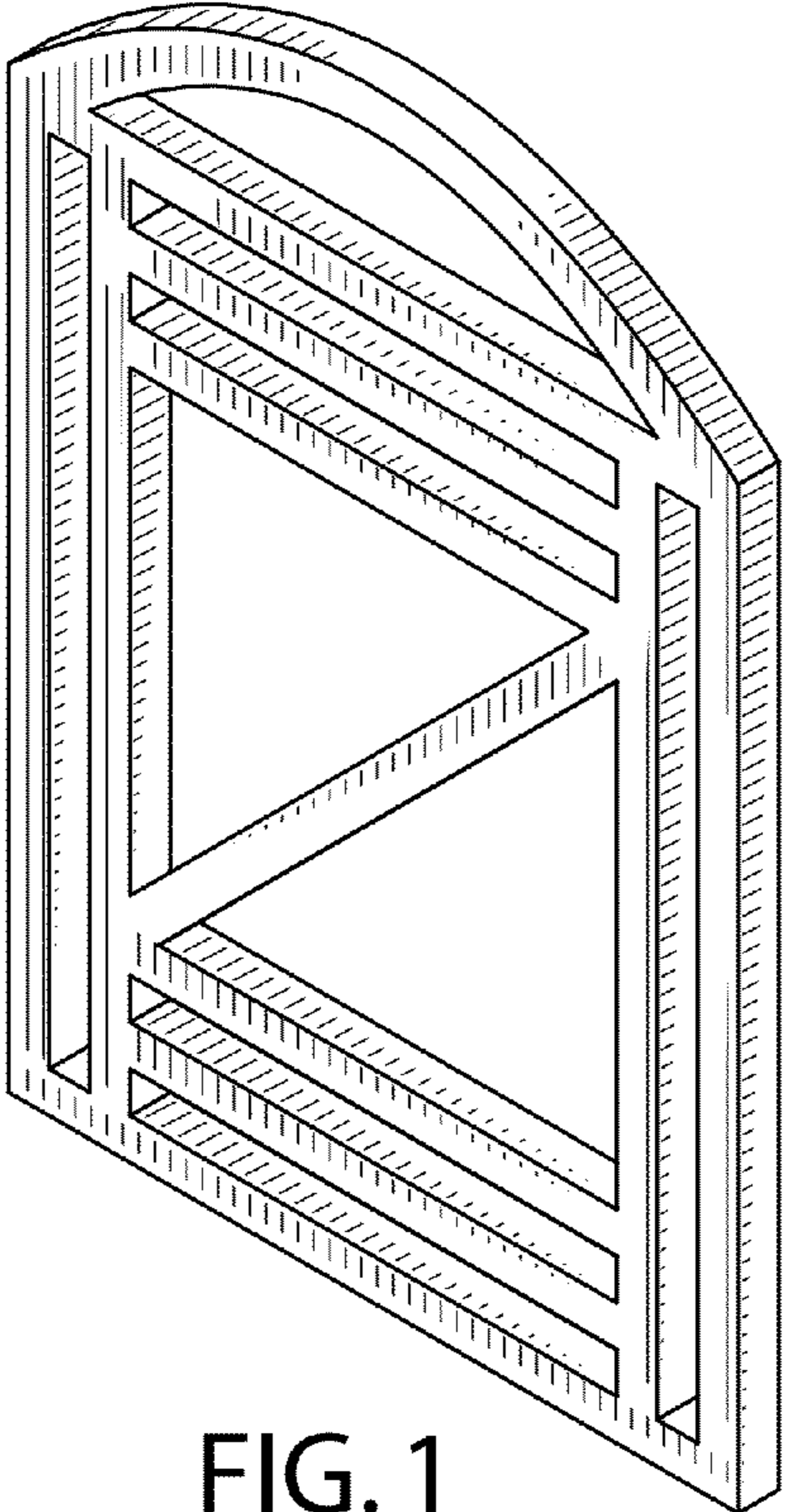
