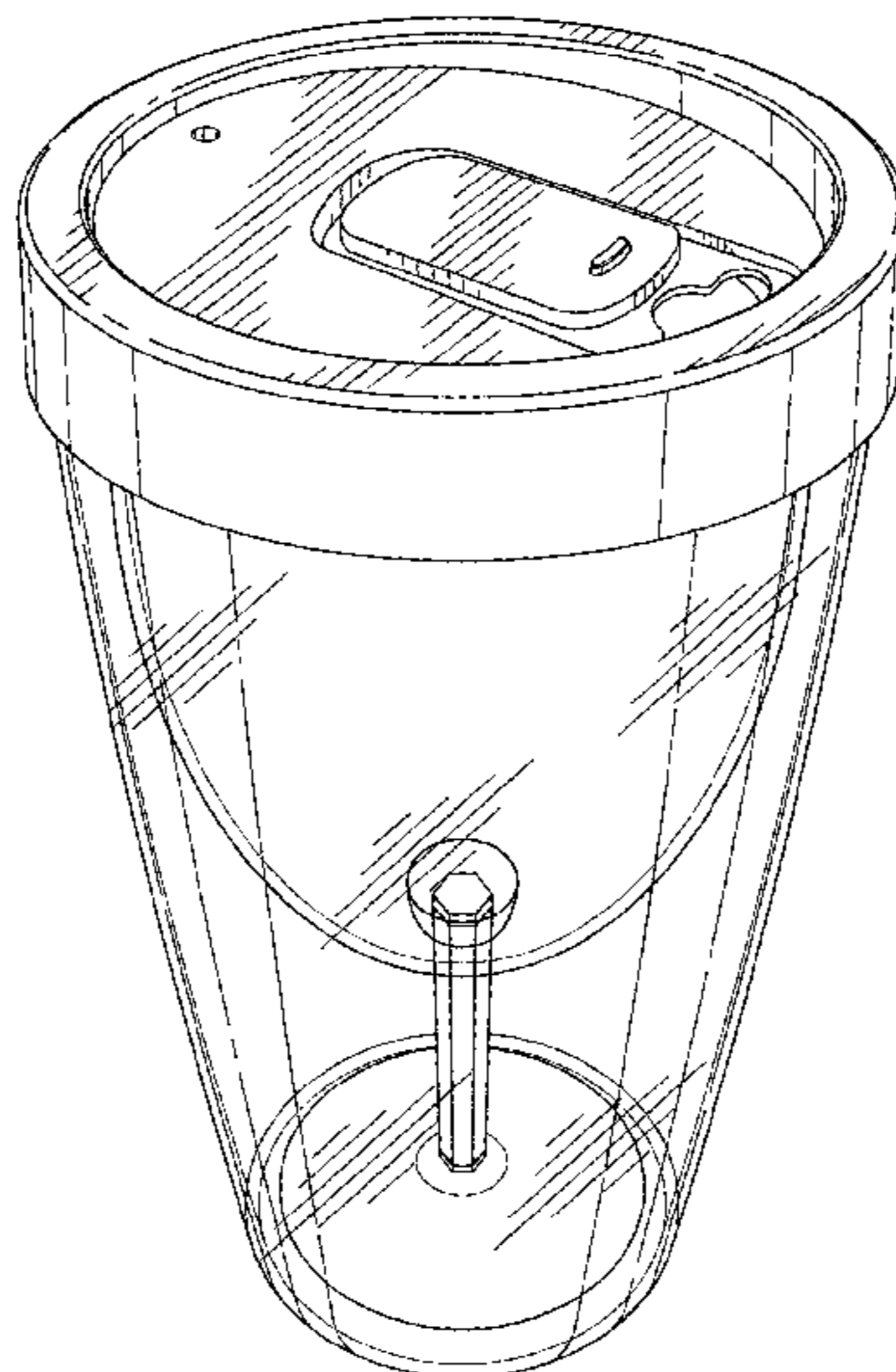
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the embodiment of the wine tumbler thereof;
 FIG. 2 is a right side elevational view thereof;

 FIG. 4 is a rear elevational view thereof;

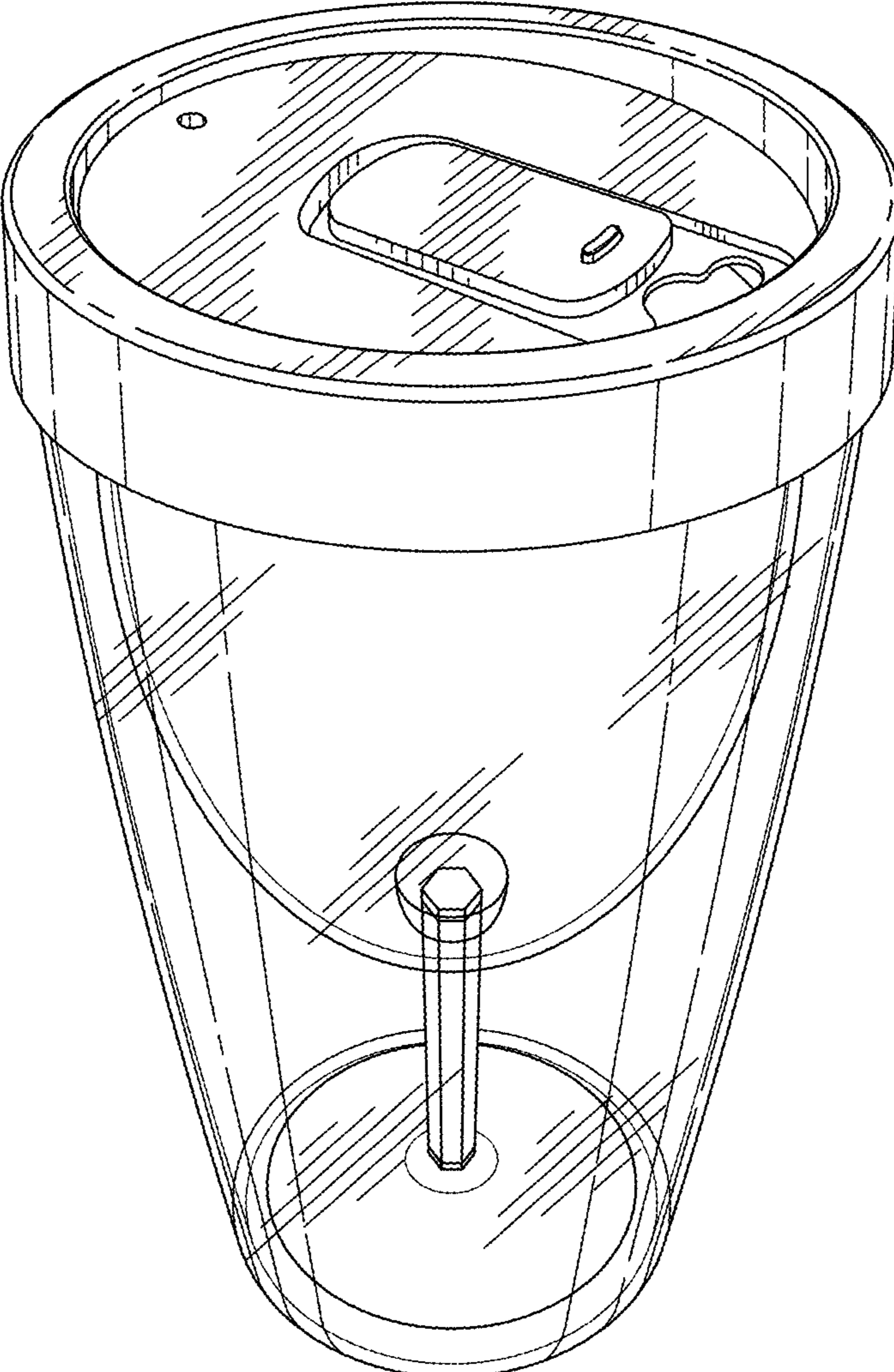

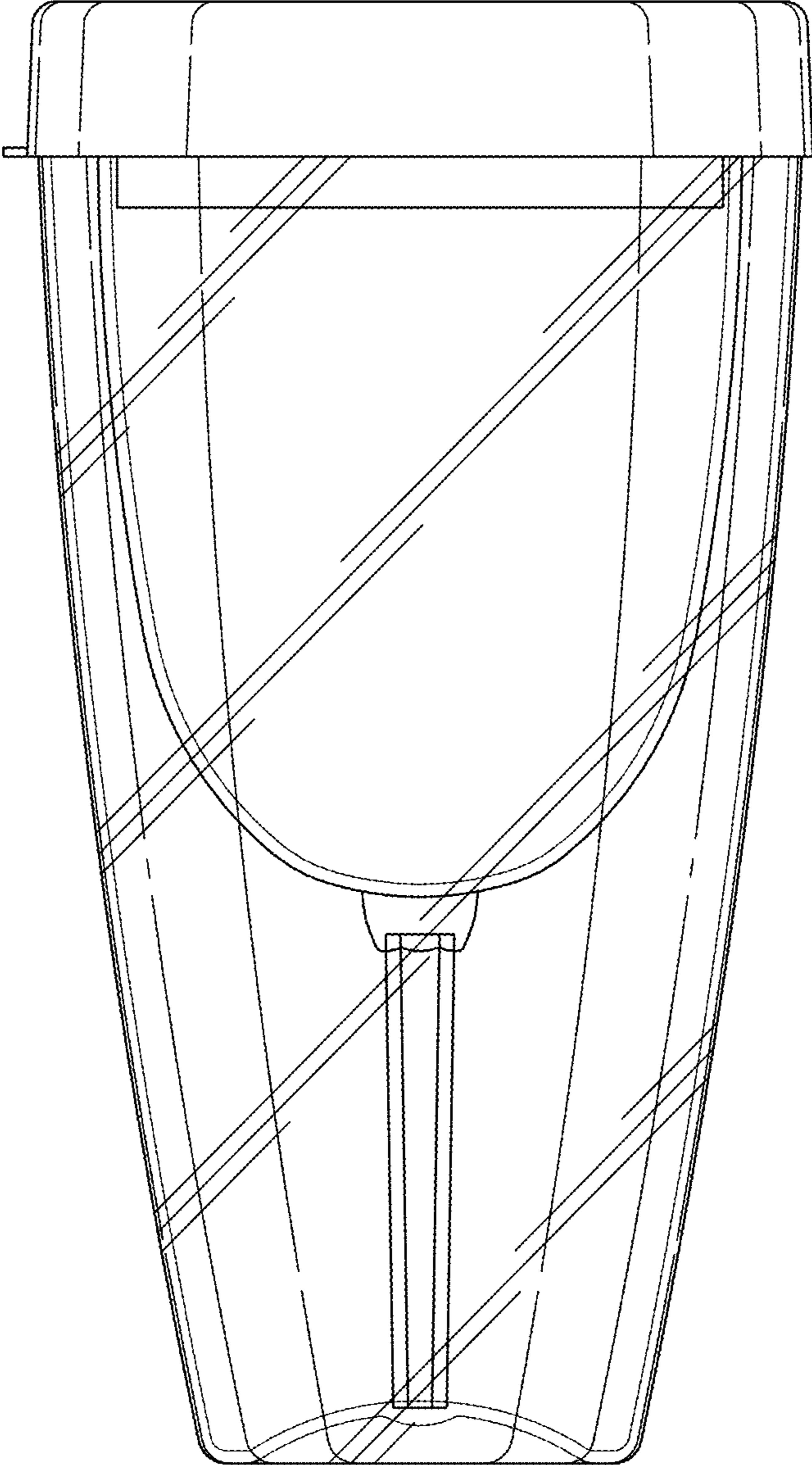

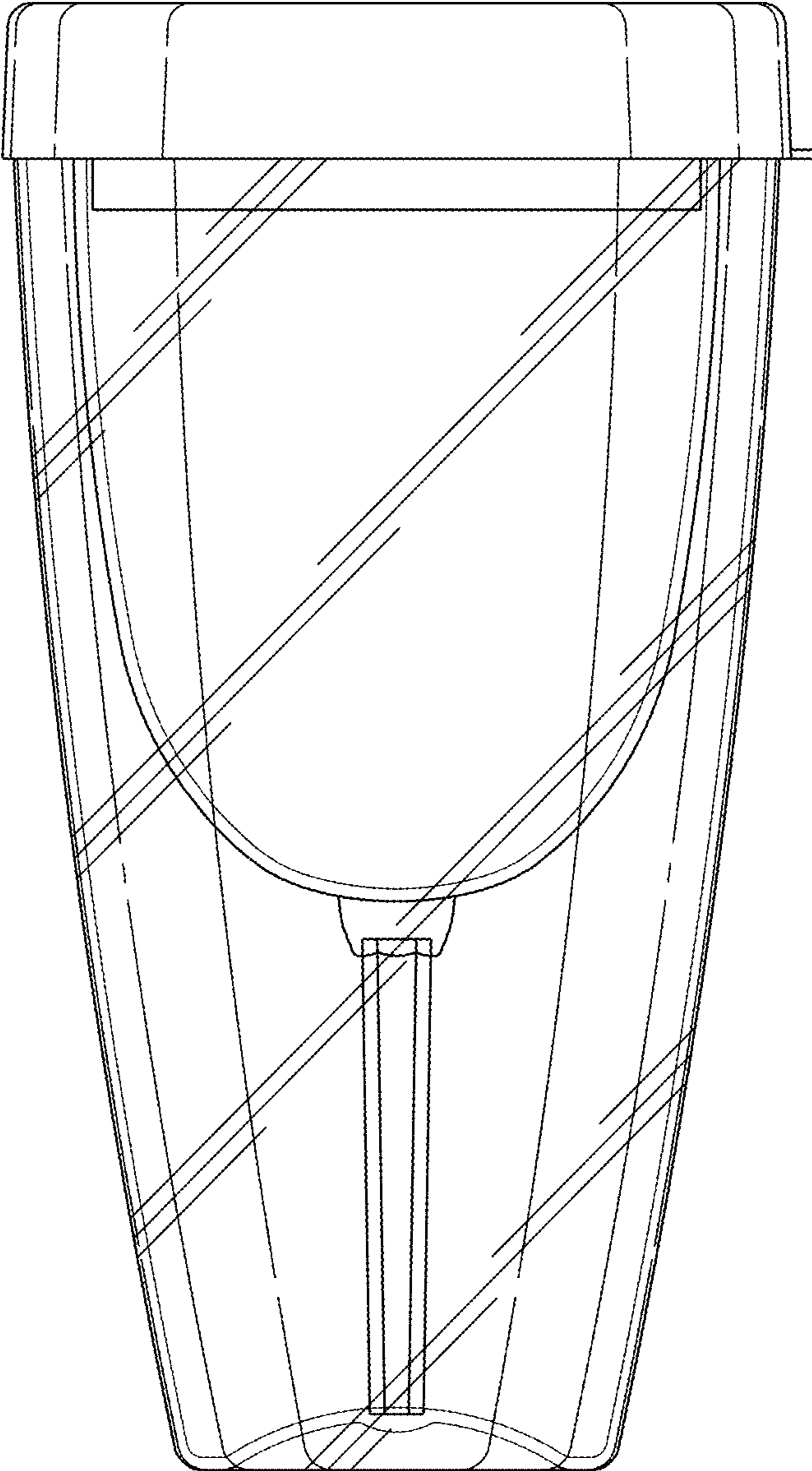

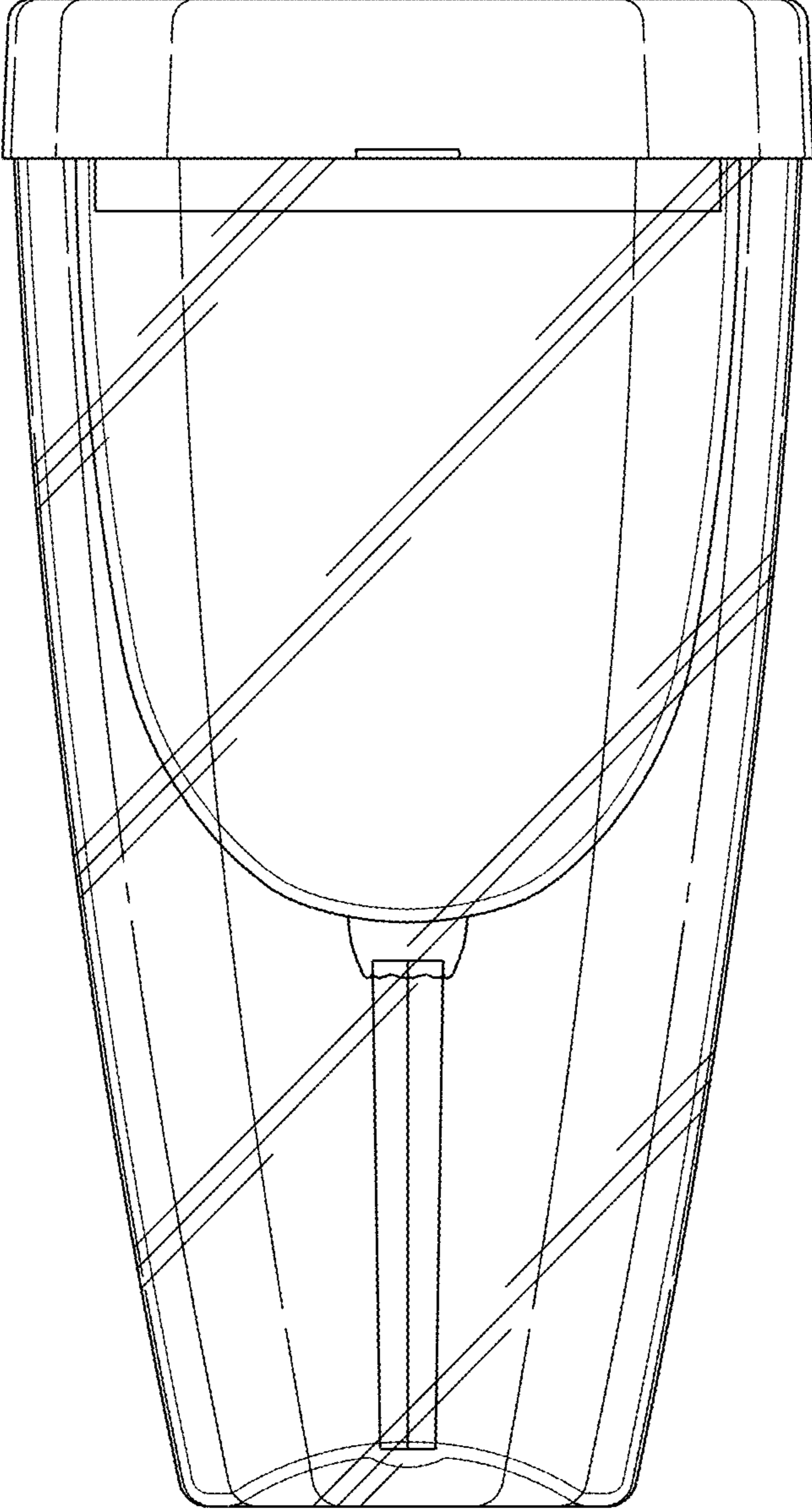

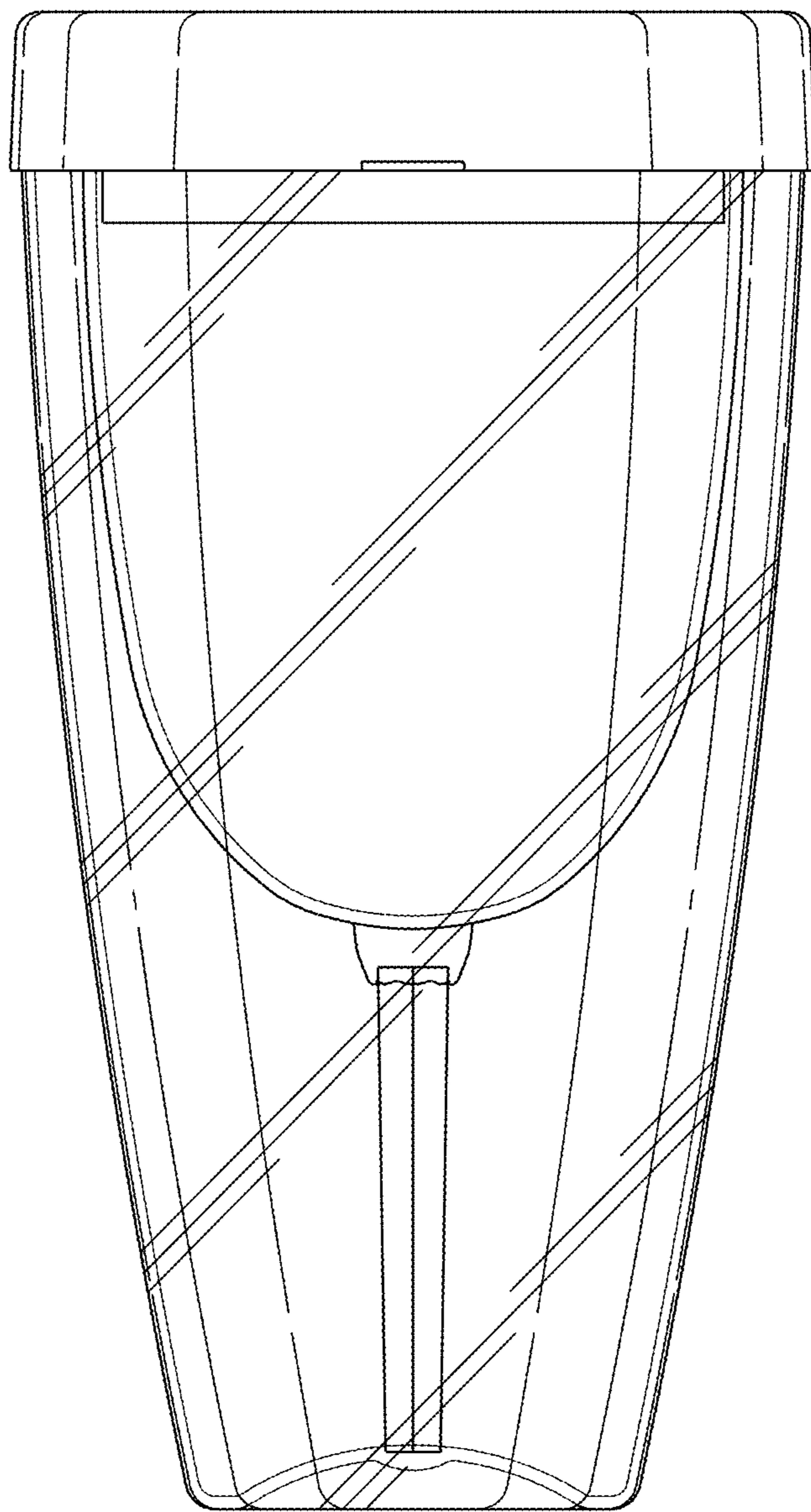

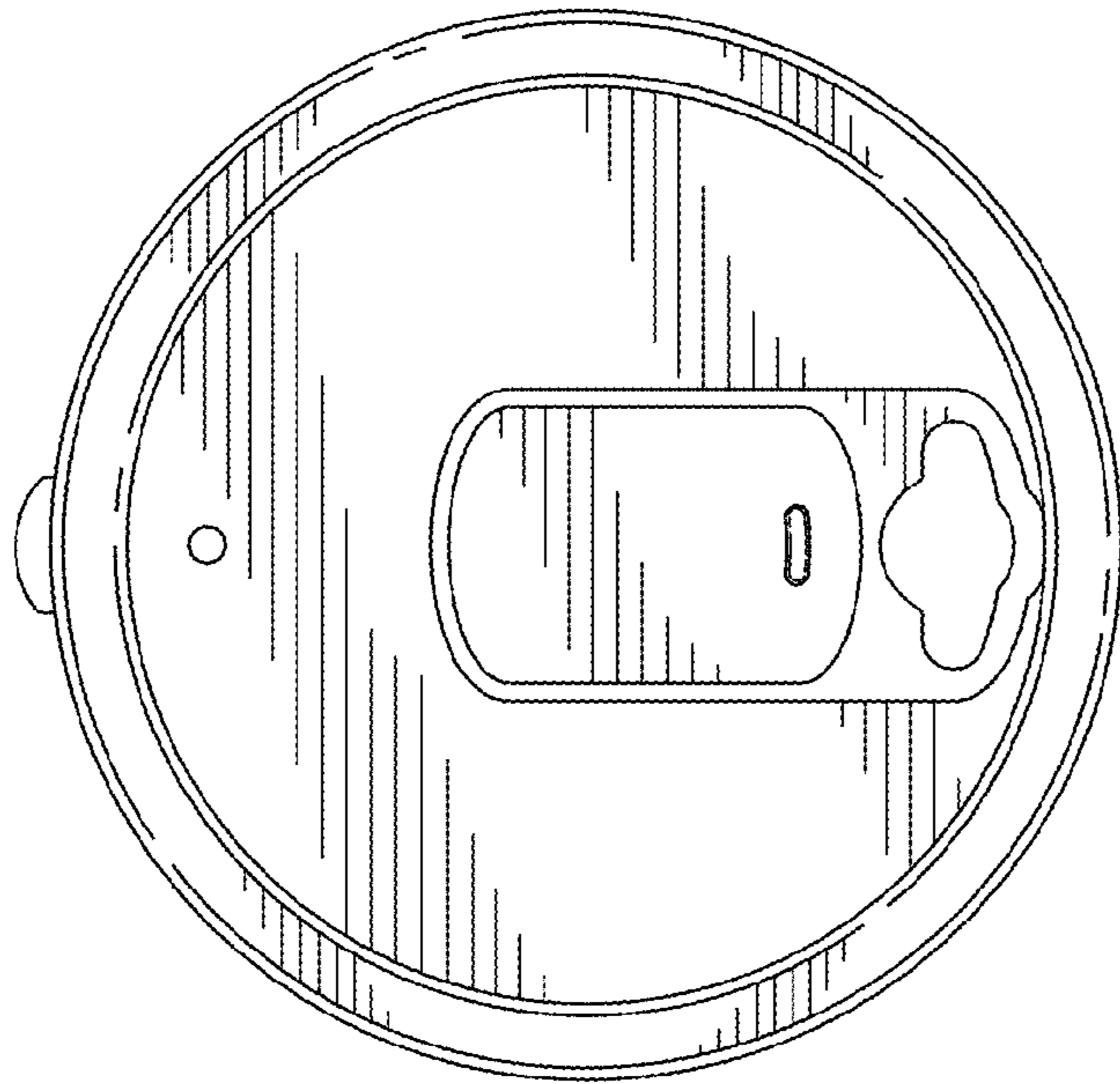

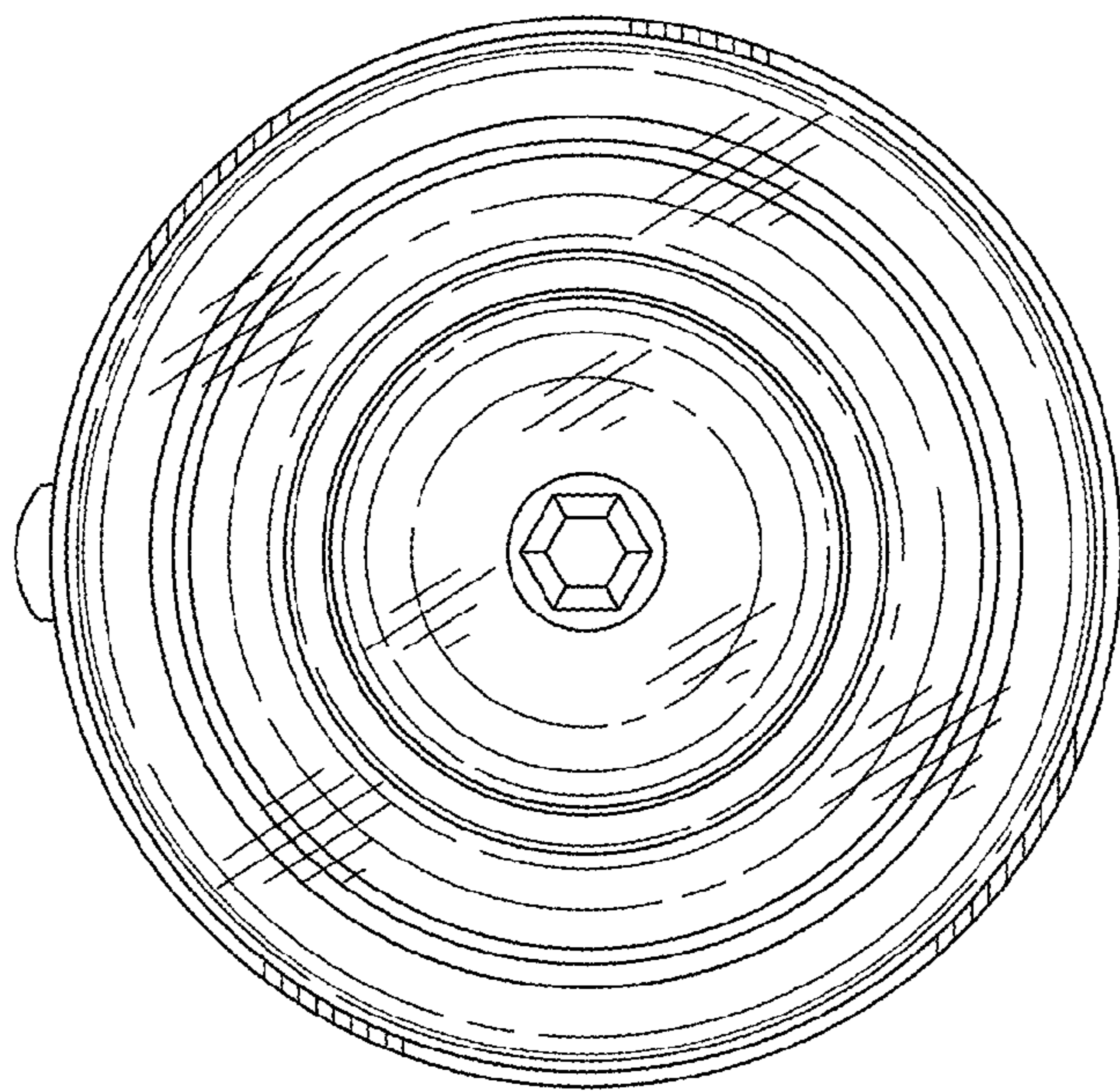
