FIG. 1 is an upper front perspective view of a container of our new design;

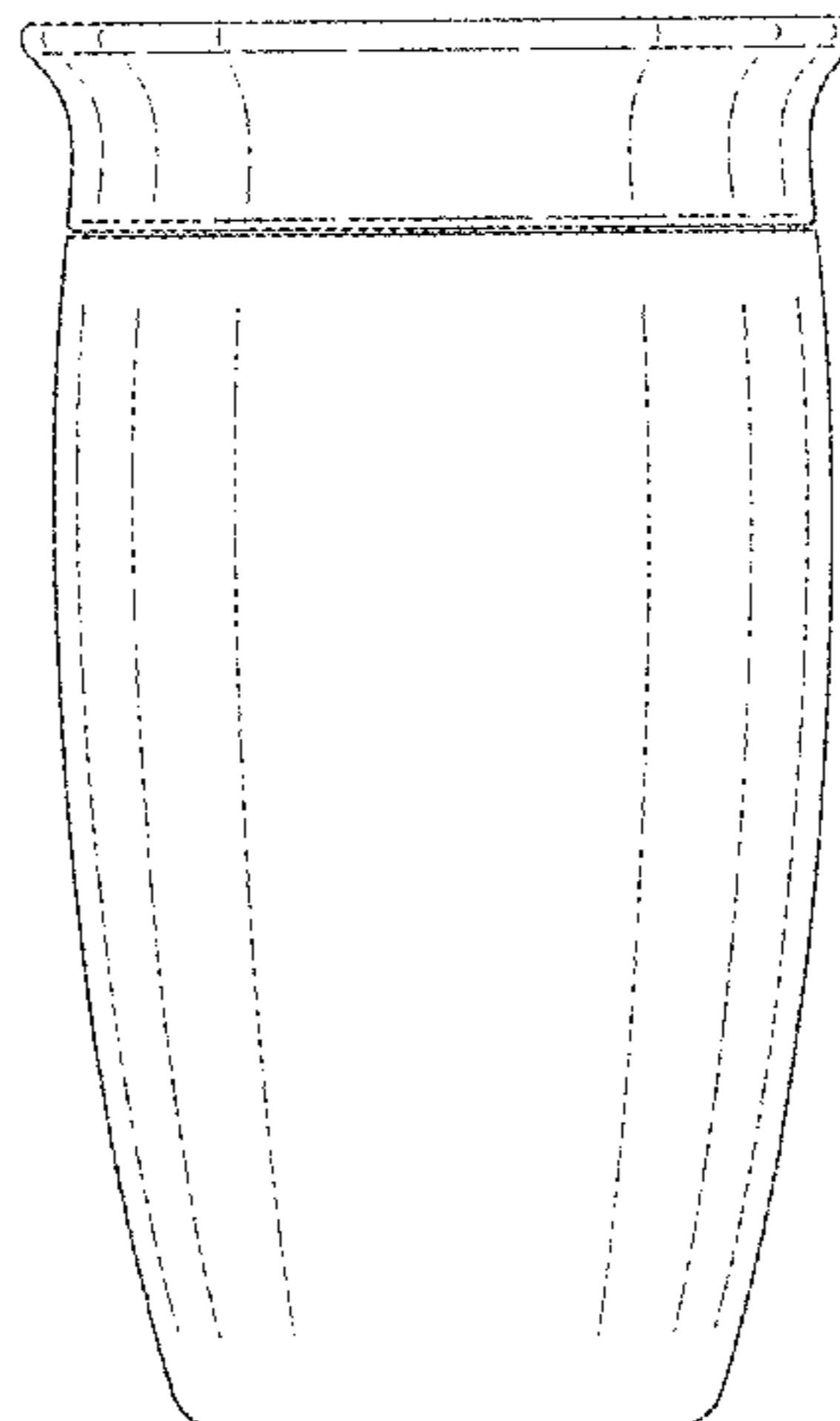
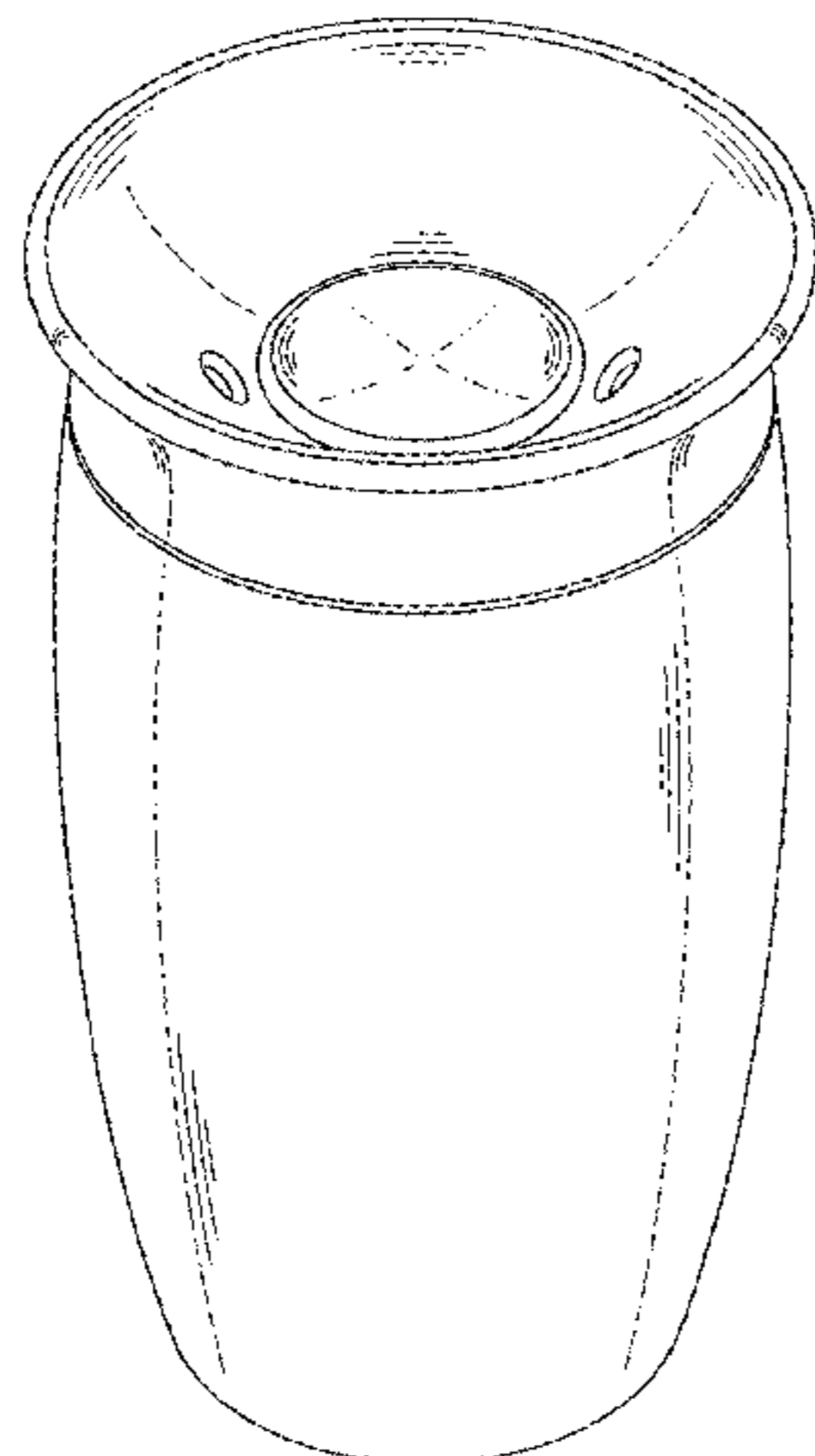
FIG. 2 is a bottom front perspective view thereof;

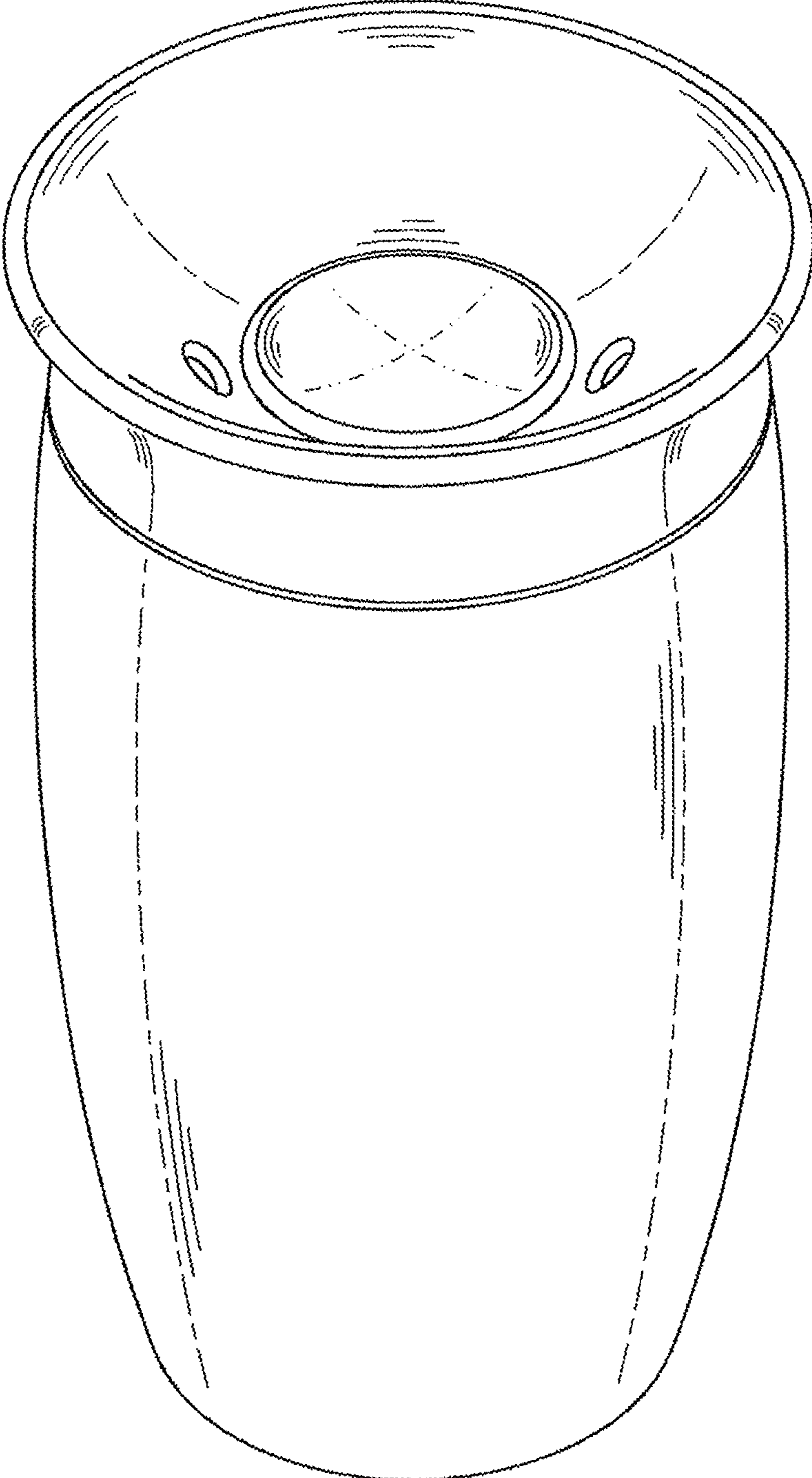

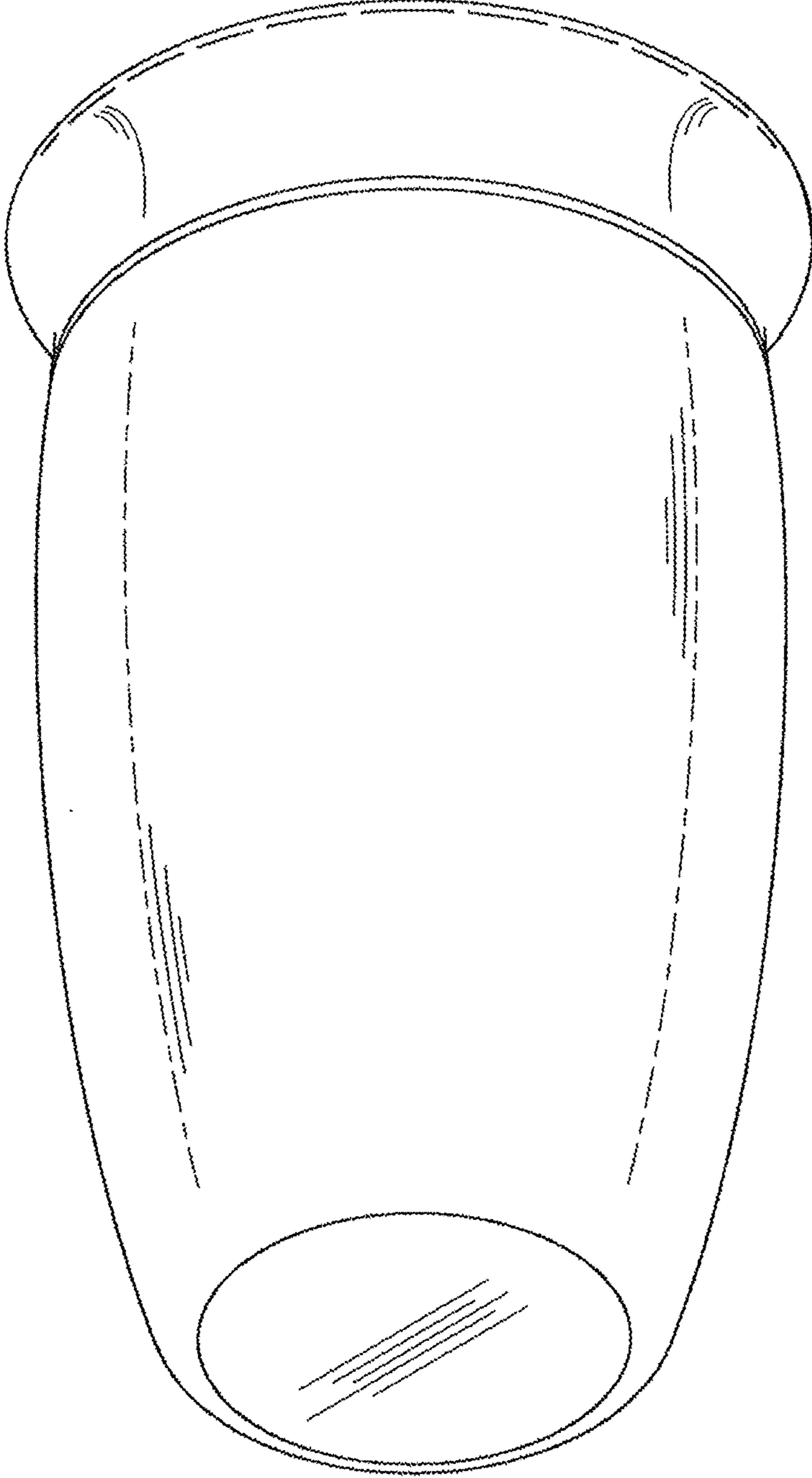

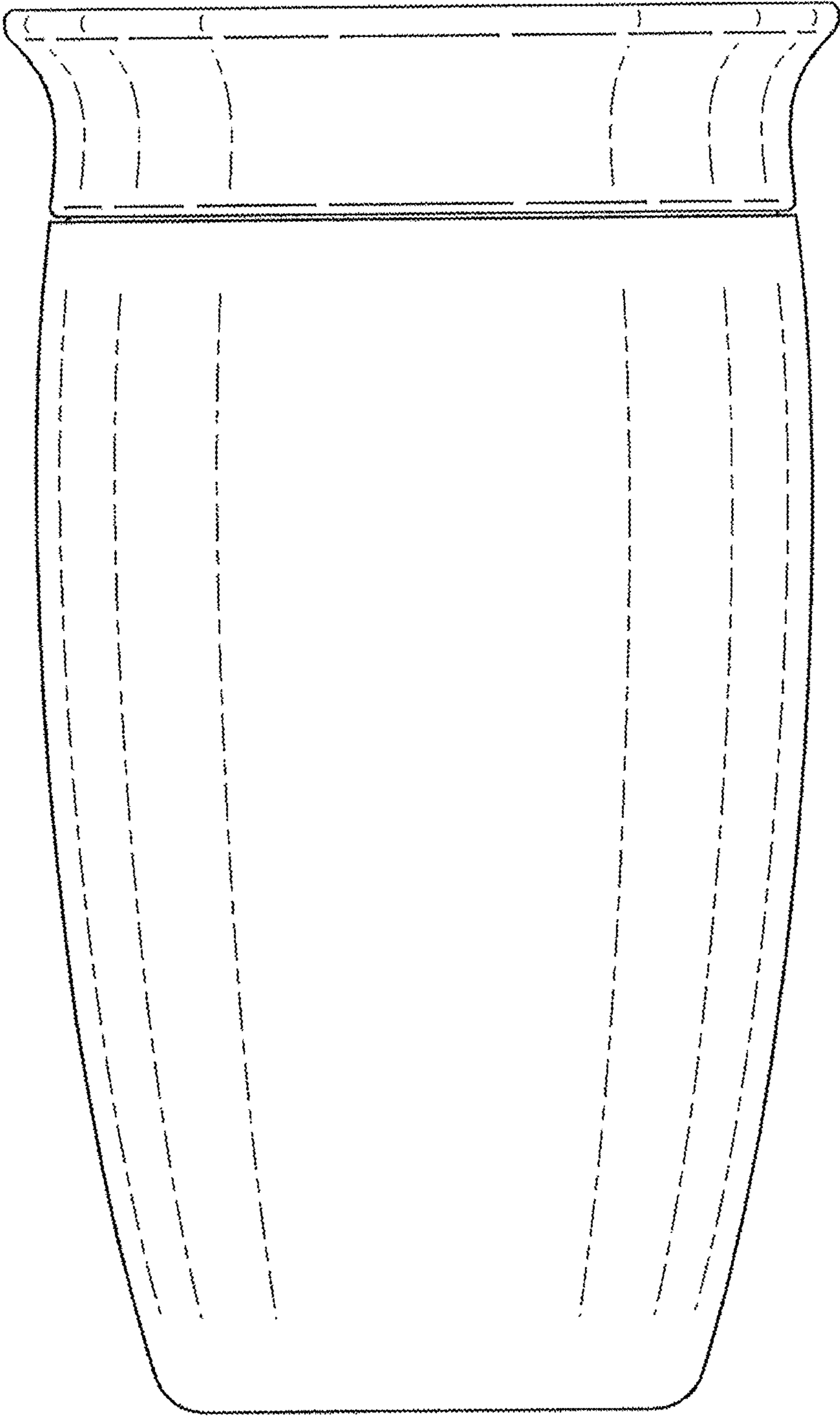

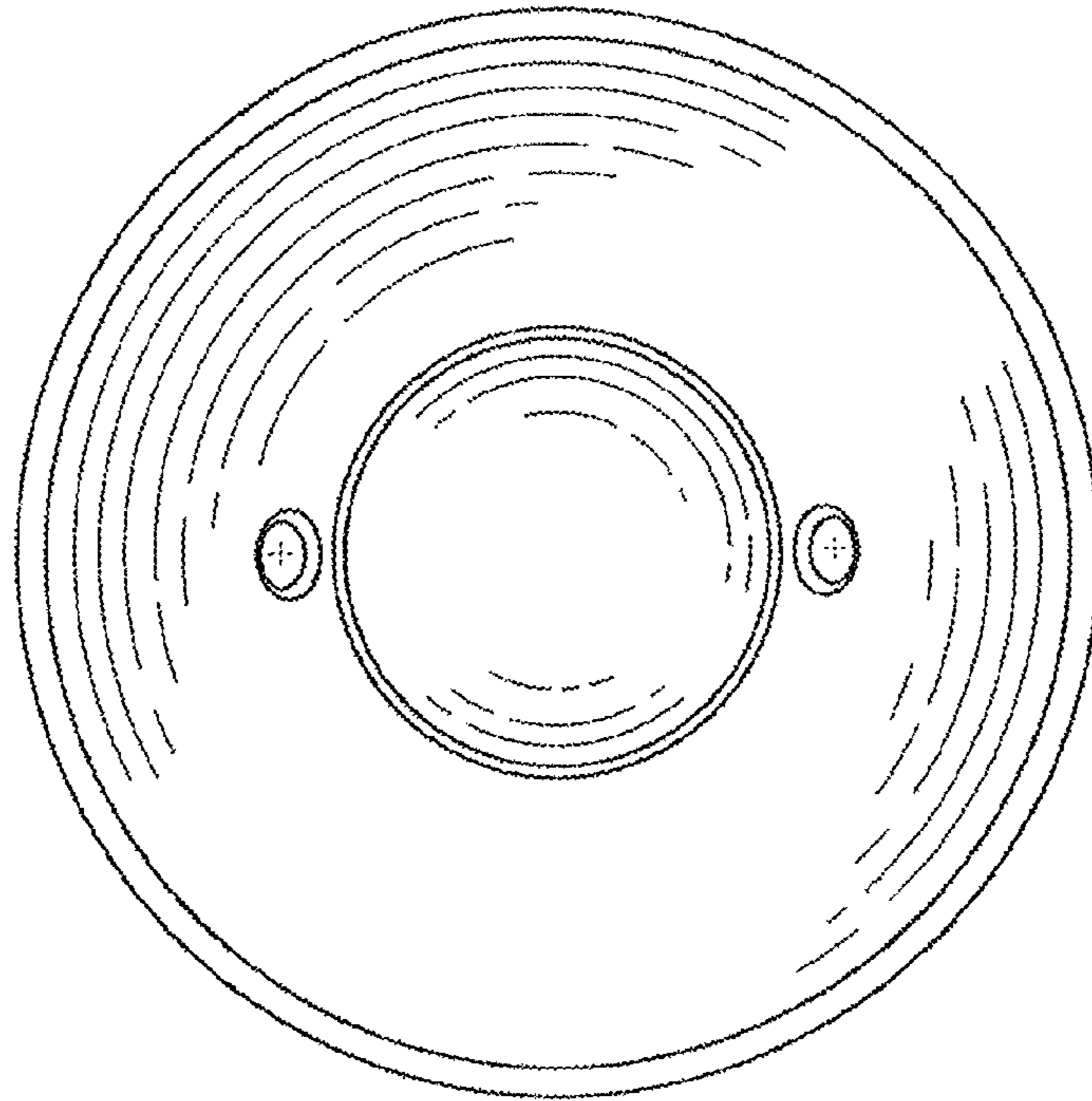
