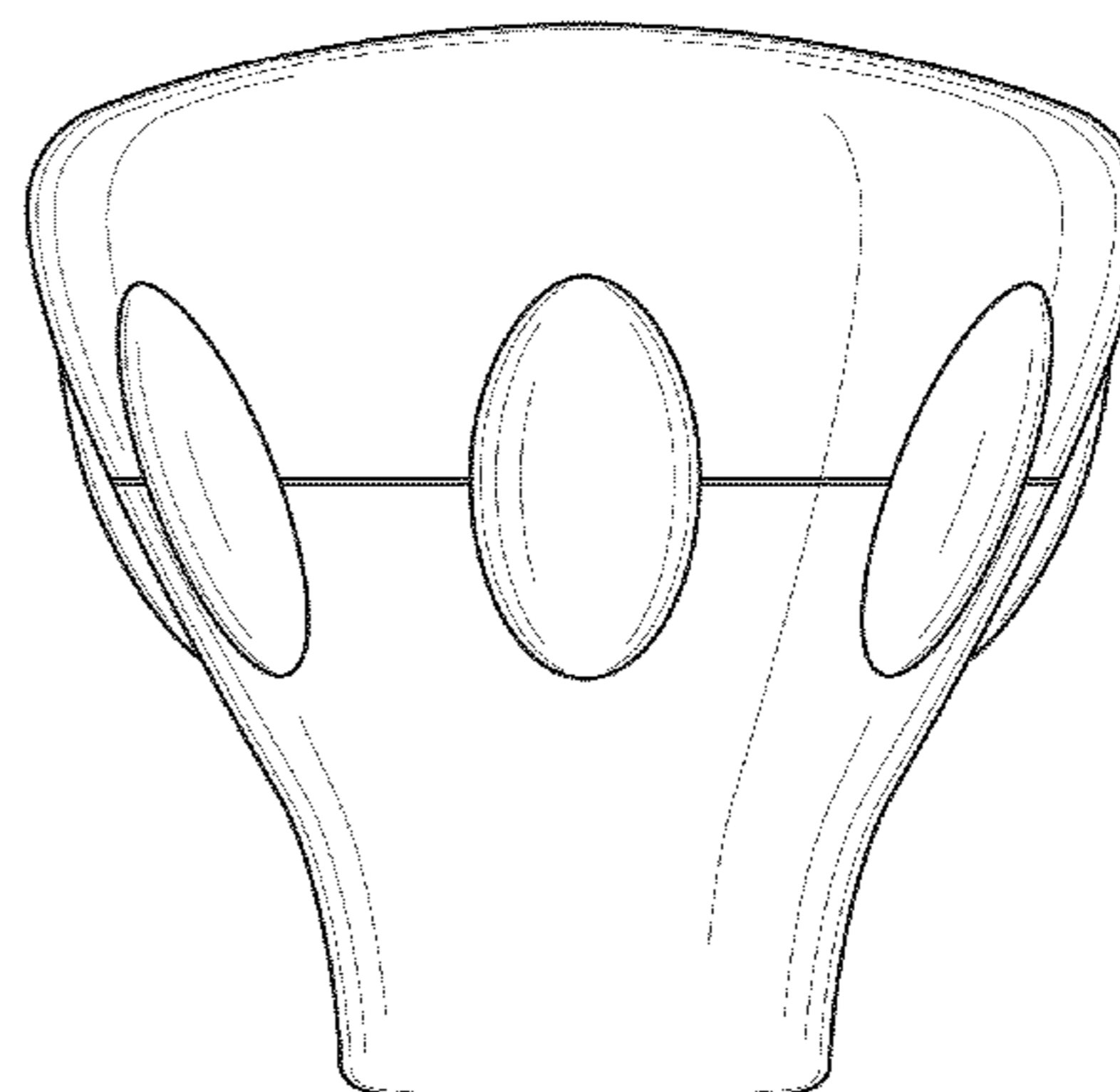
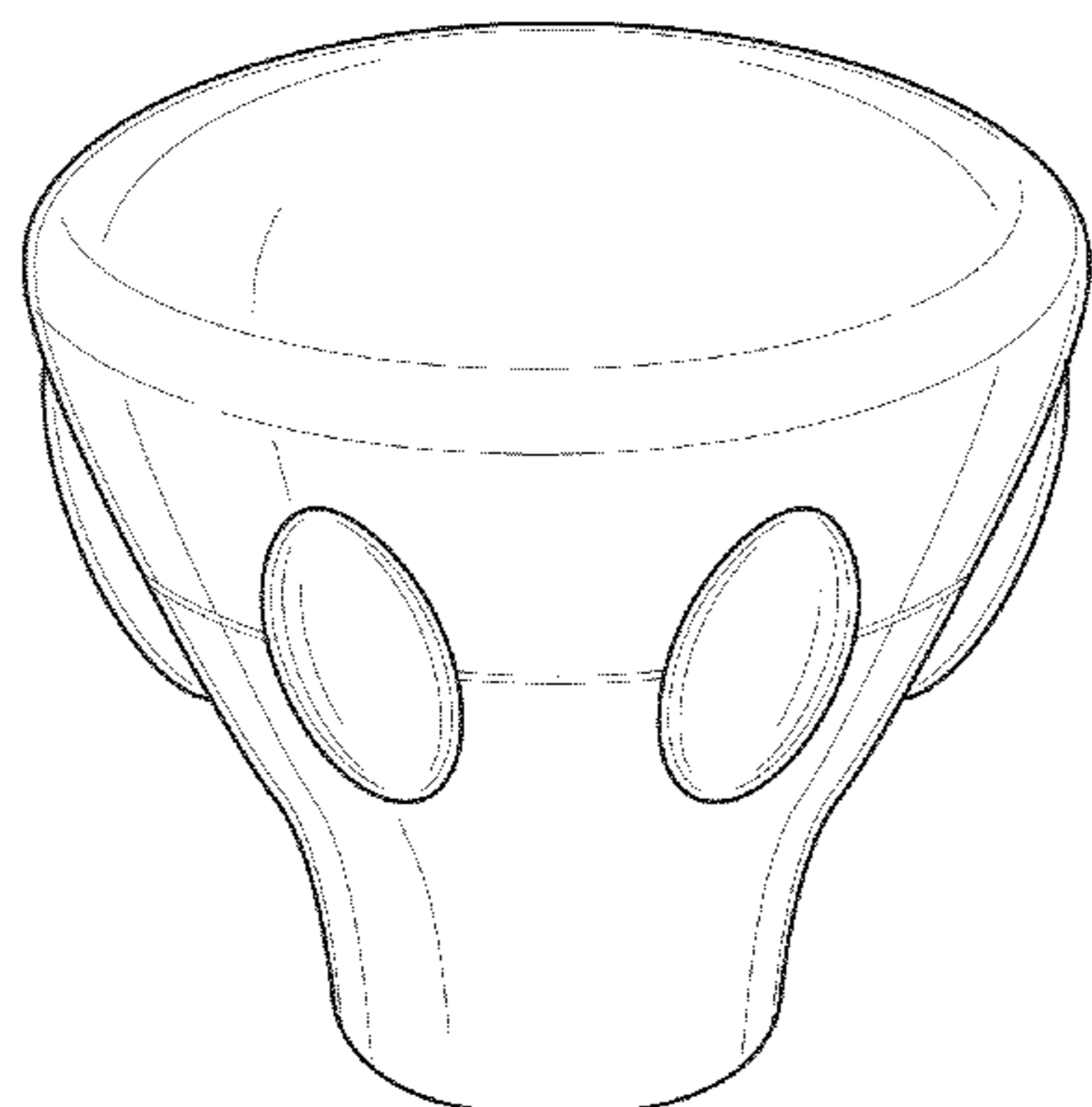
The ornamental design for a tiller knob, as shown and described.

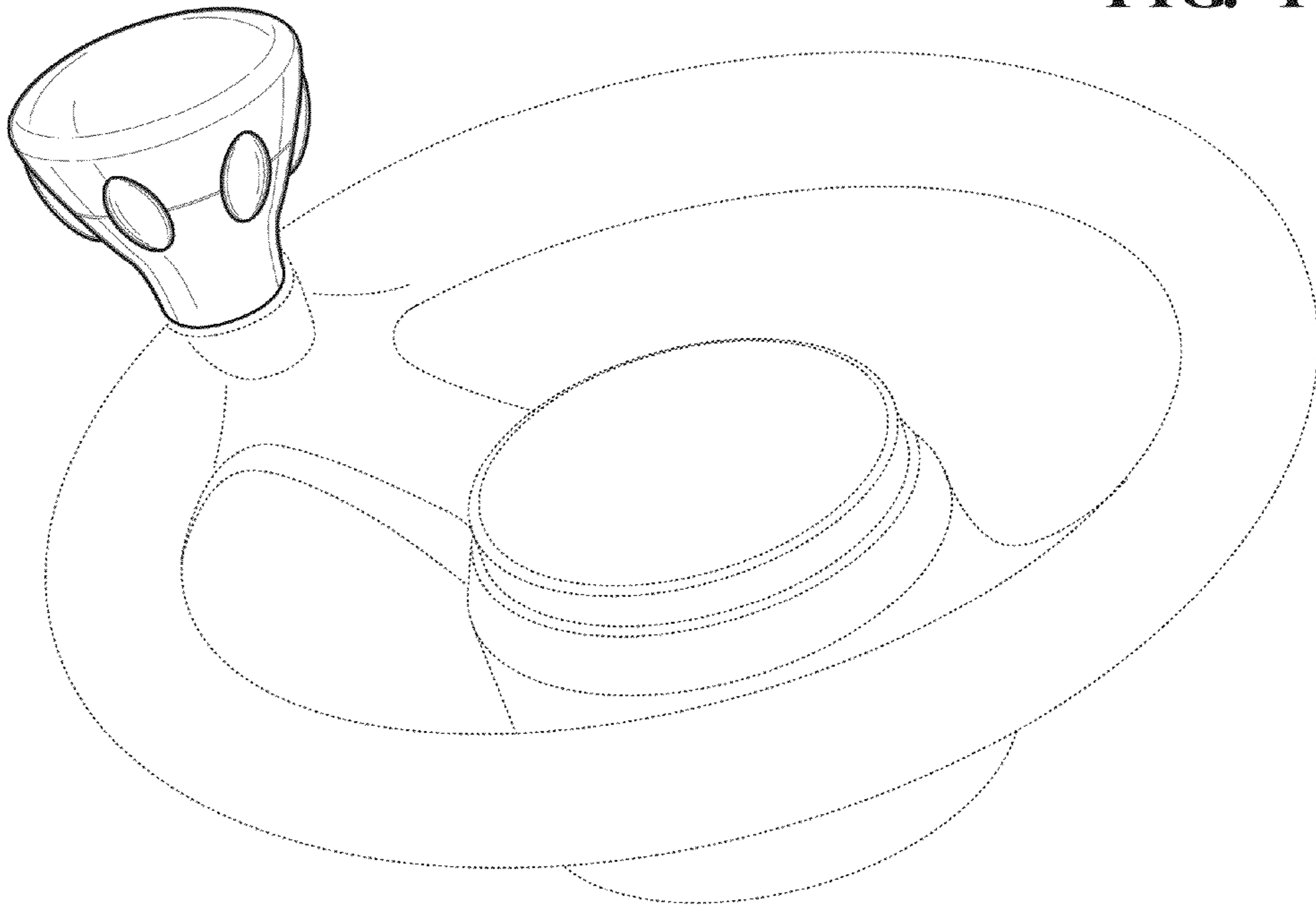

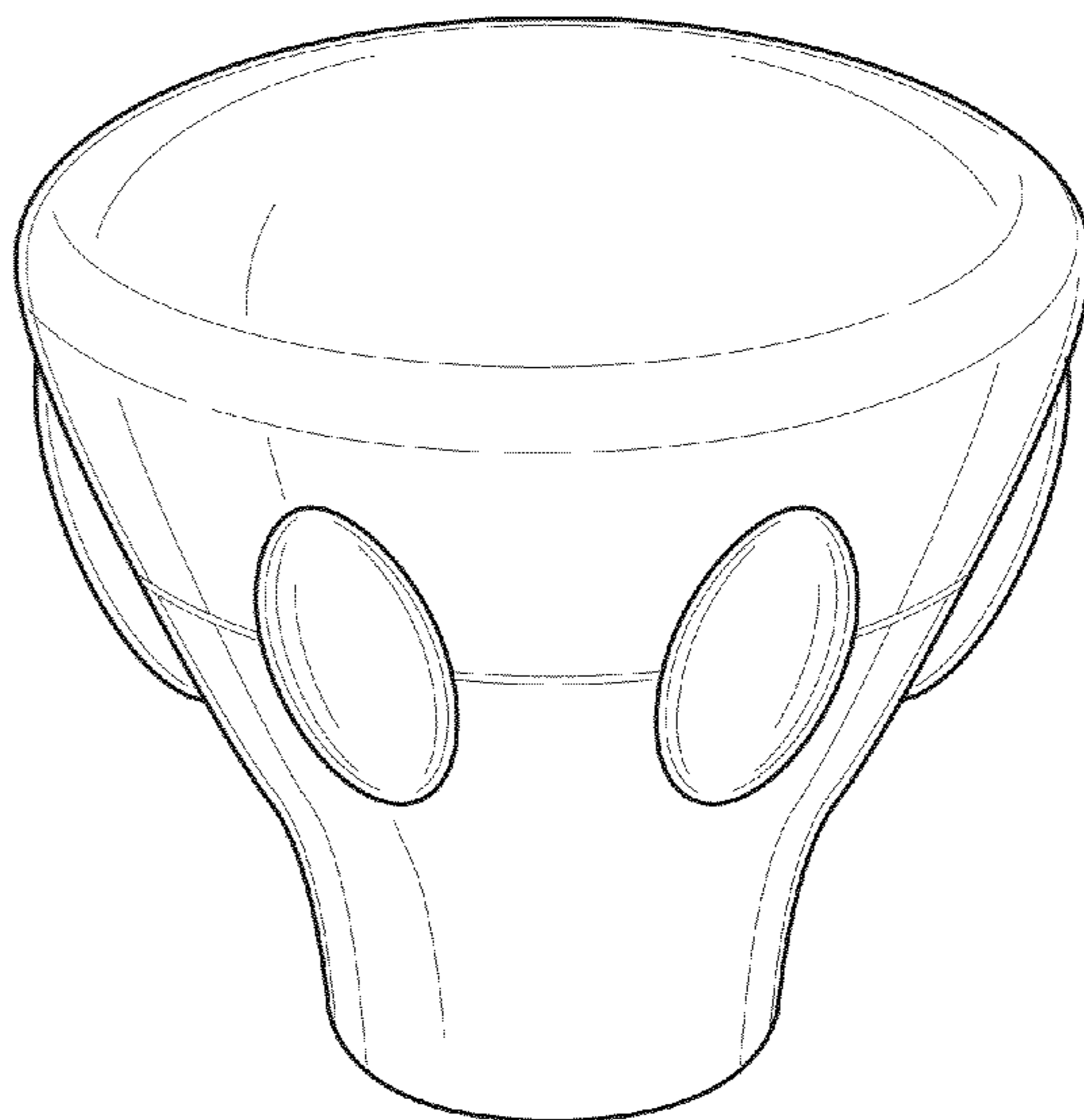

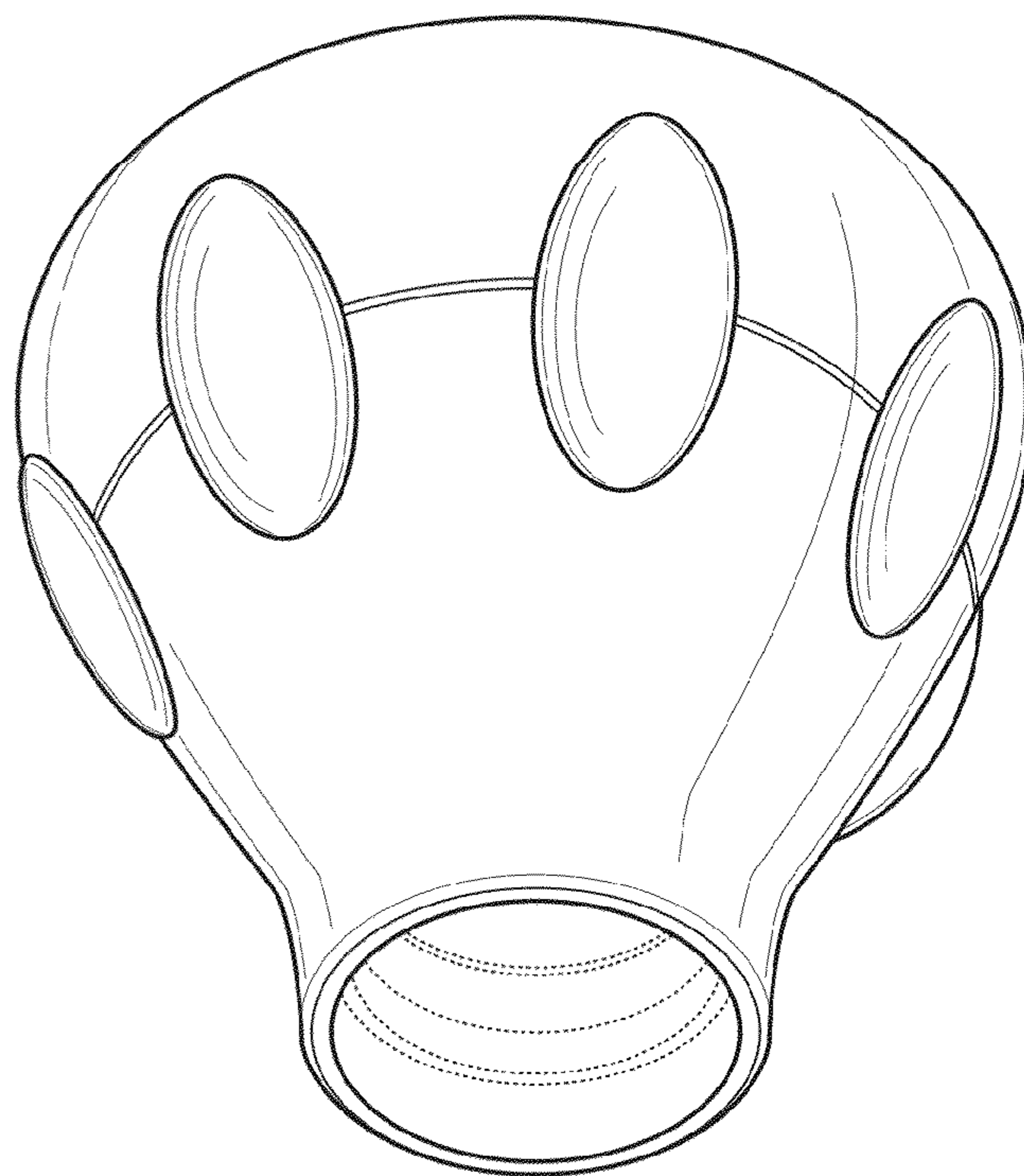

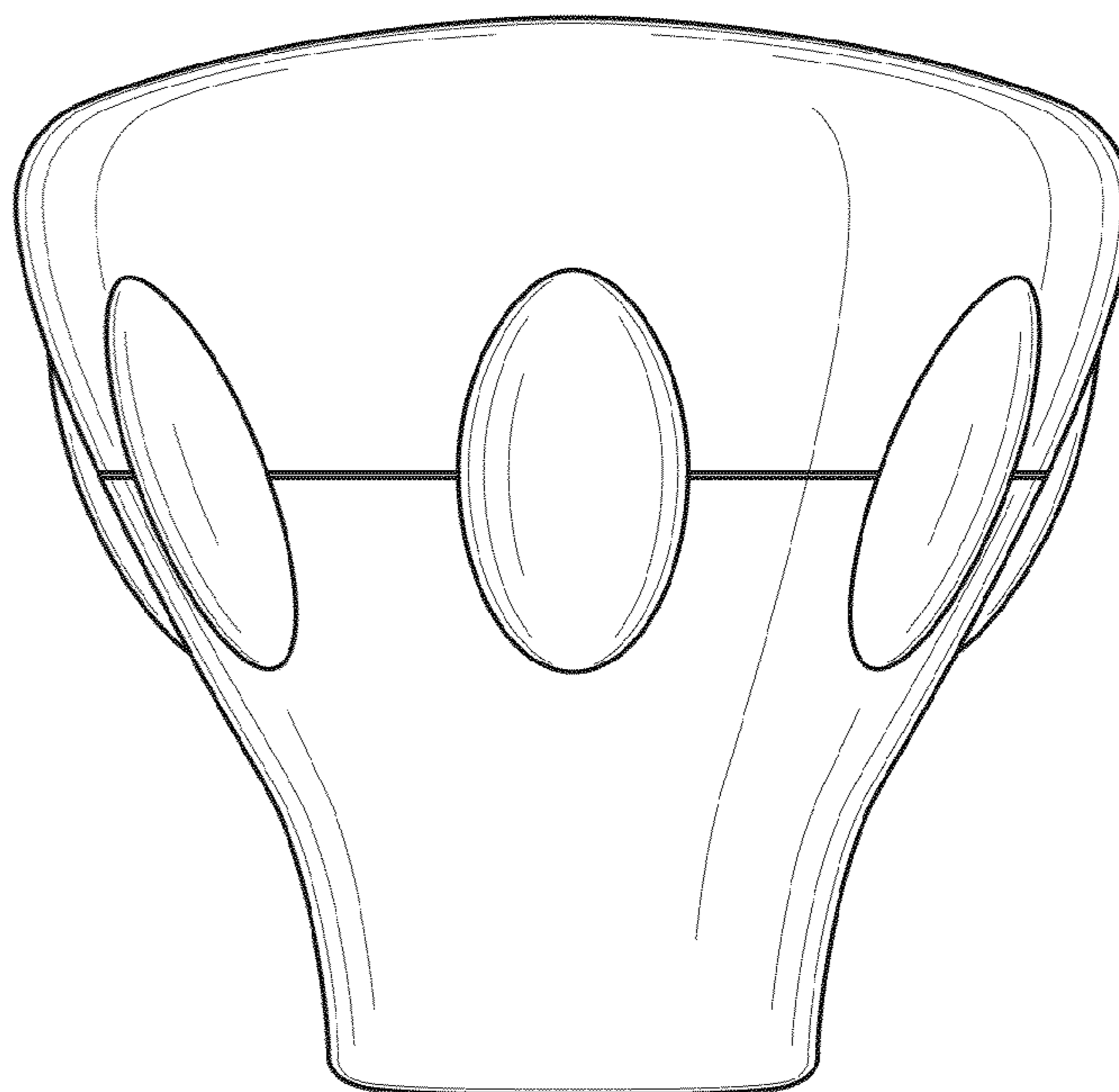

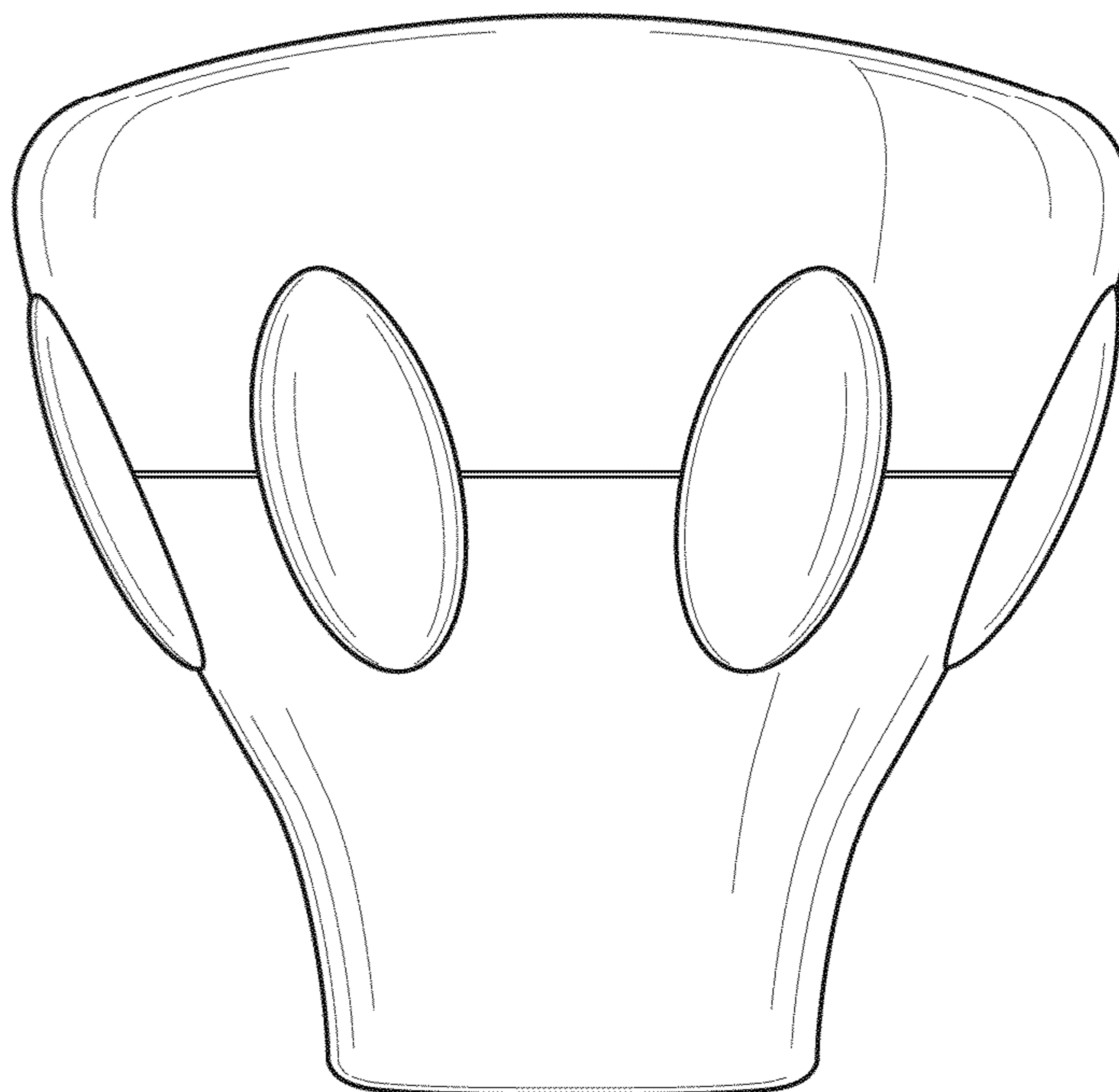

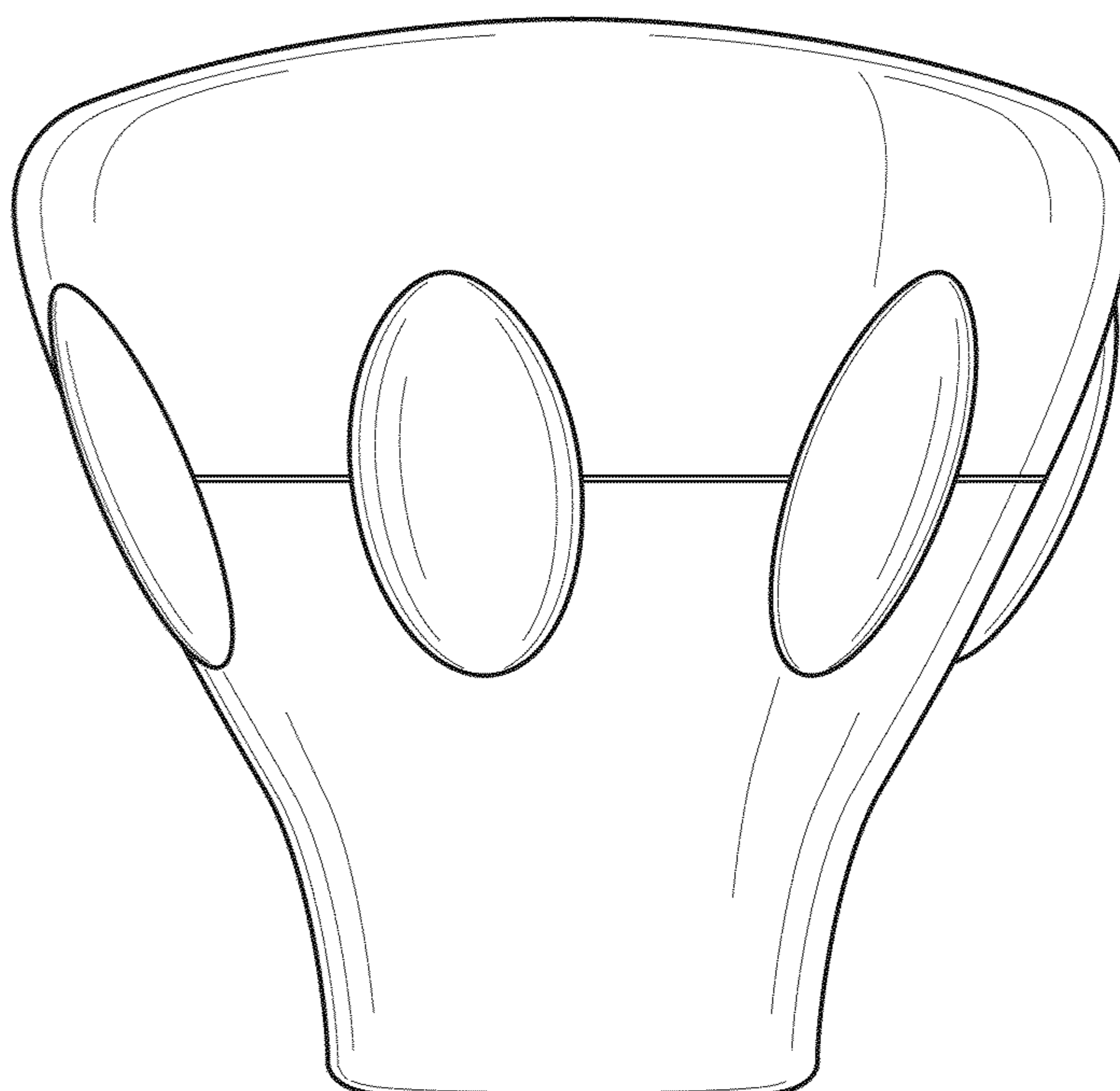

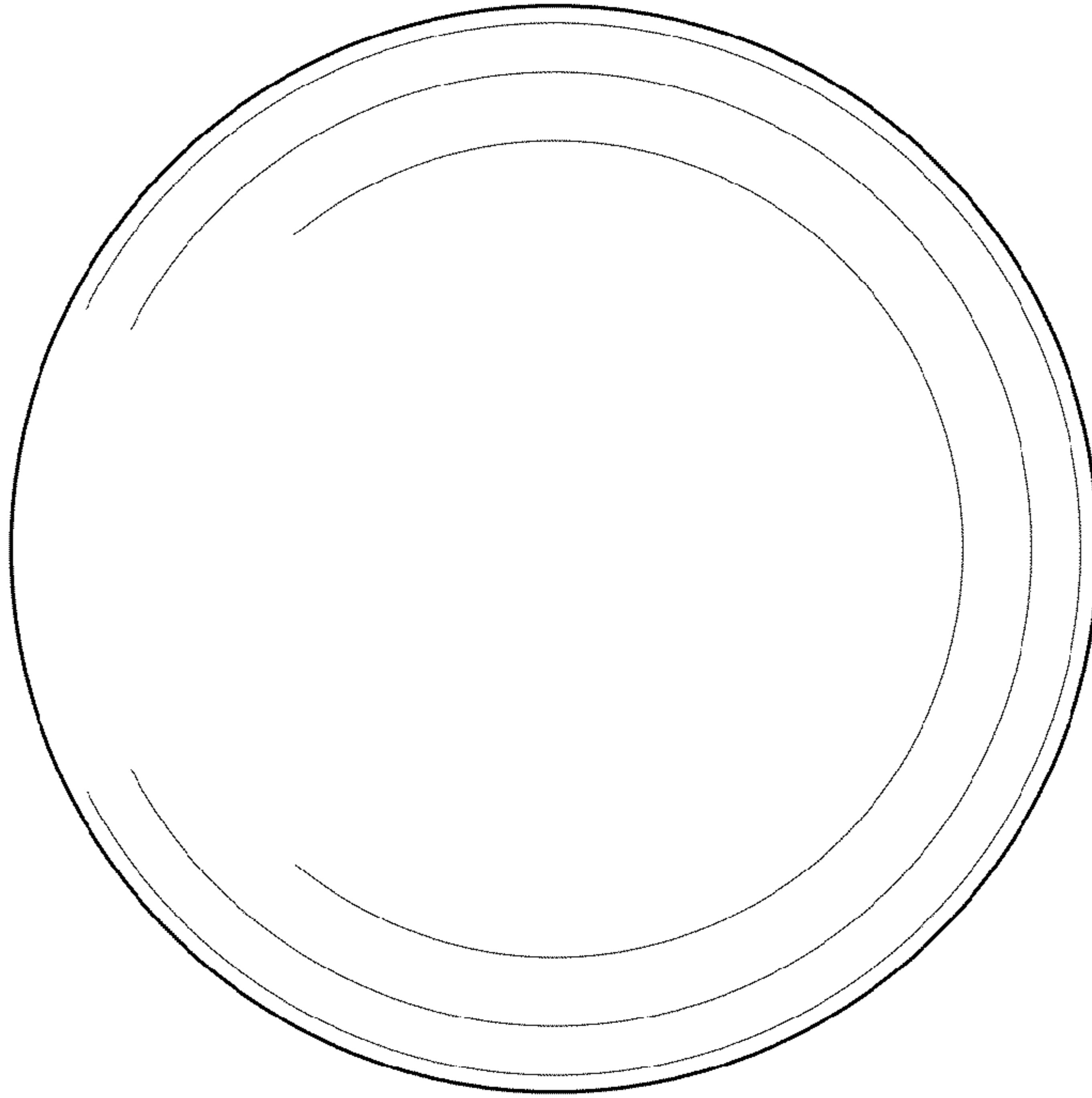
