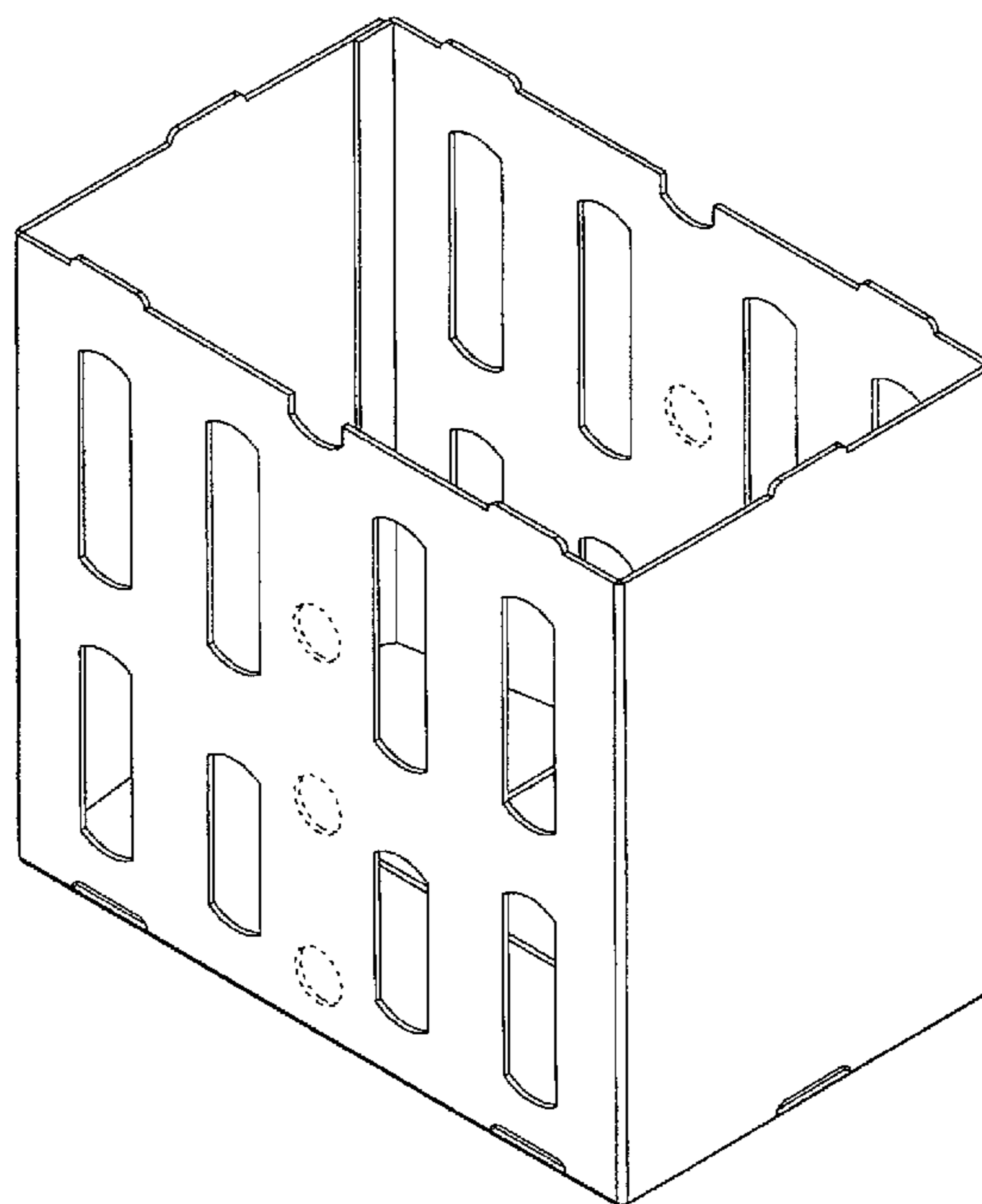
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the cardboard box showing my new design.
FIG. 2 is a front elevation view thereof.
FIG. 3 is a rear elevation view thereof.
FIGS. 4 and 5 are side elevation views thereof.
FIG. 6 is a bottom plan view thereof; and,

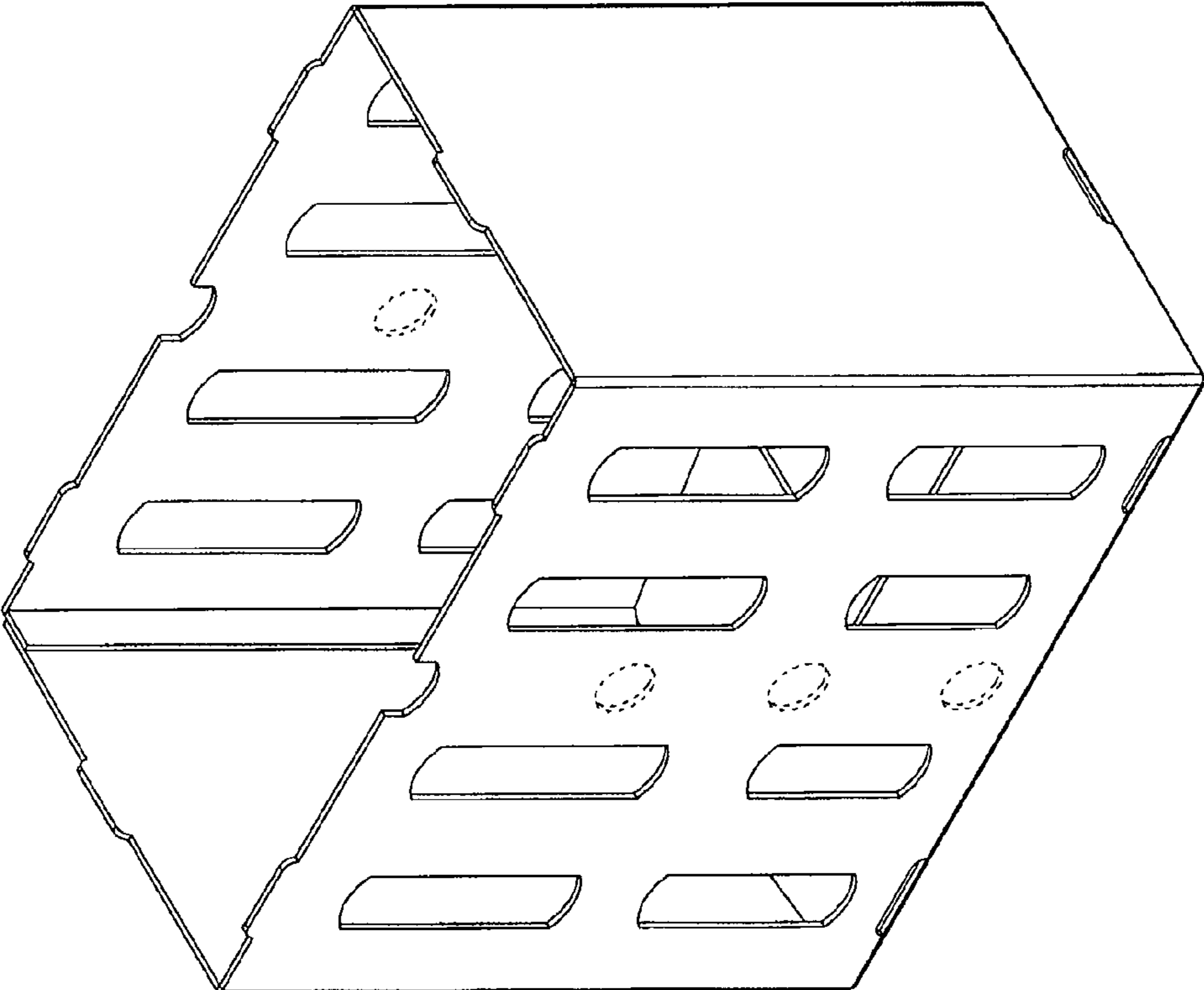

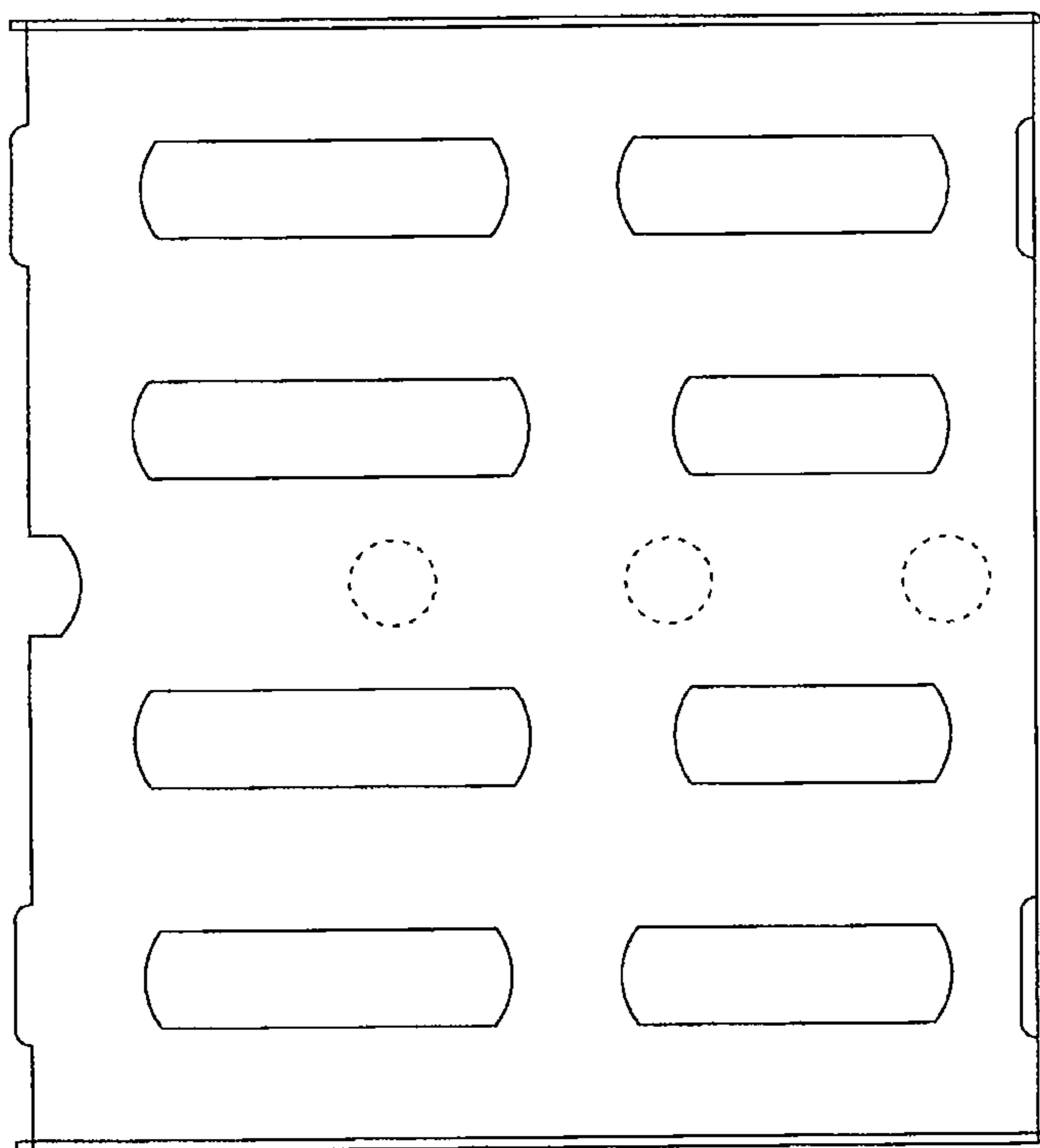

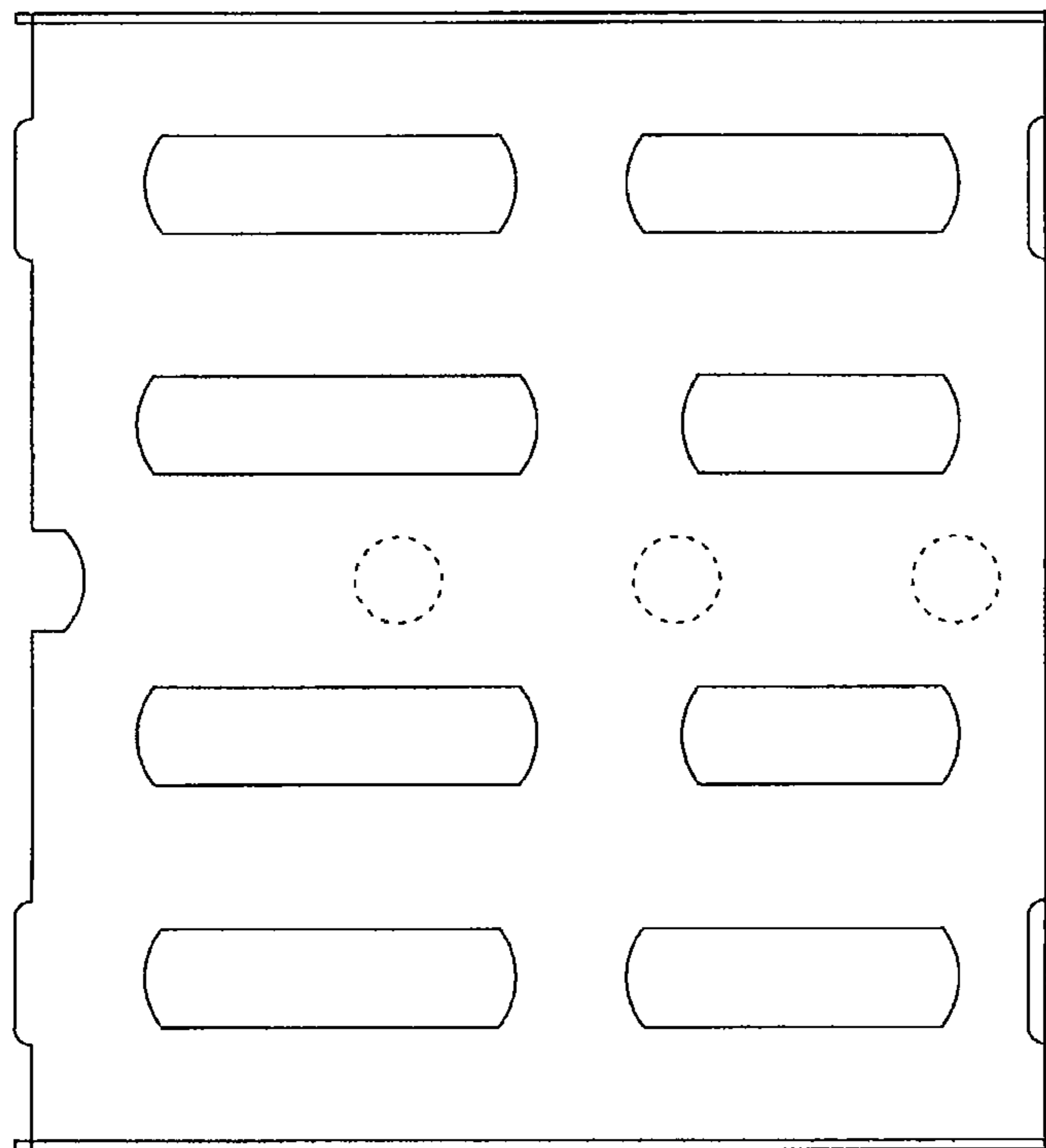

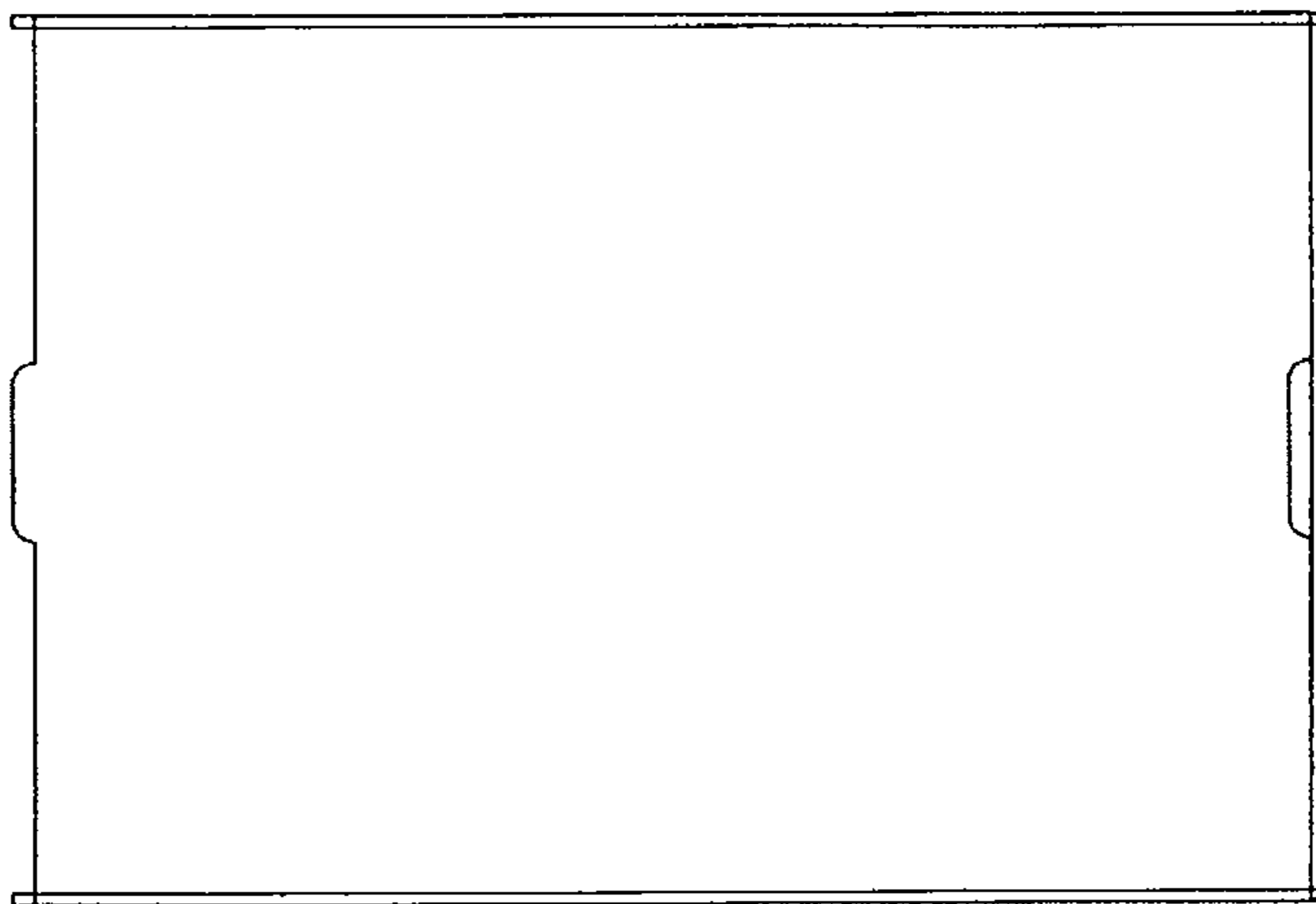

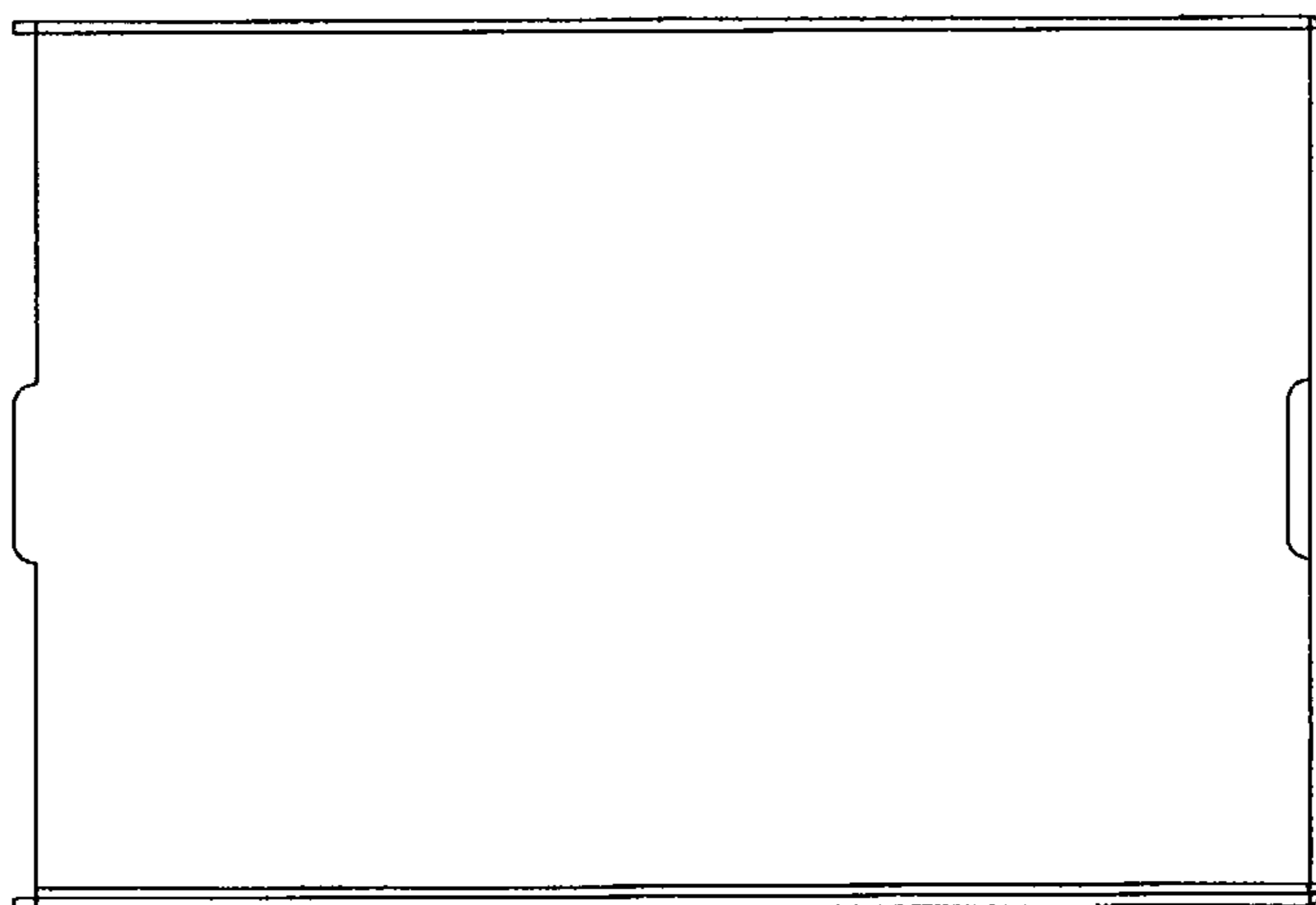

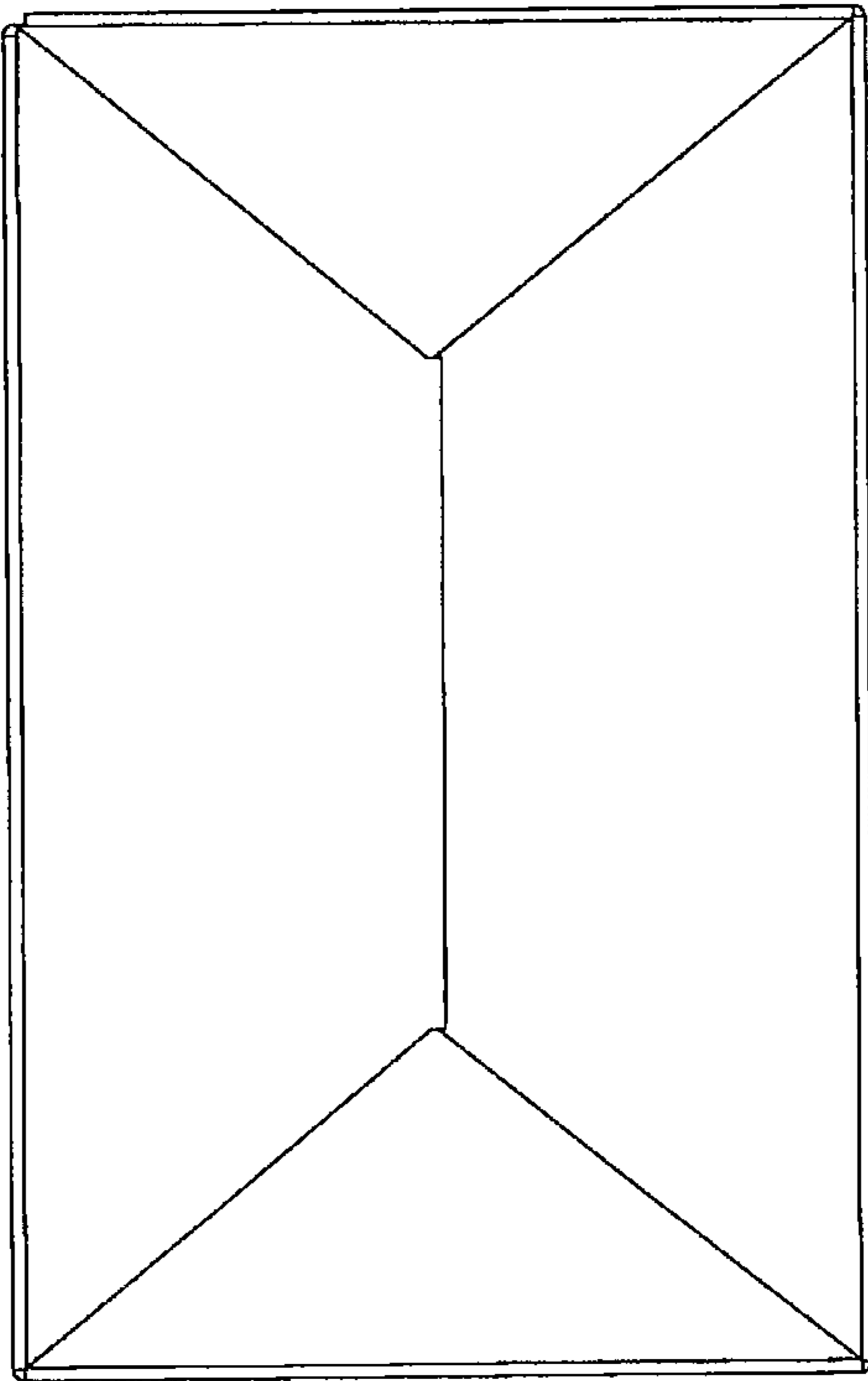

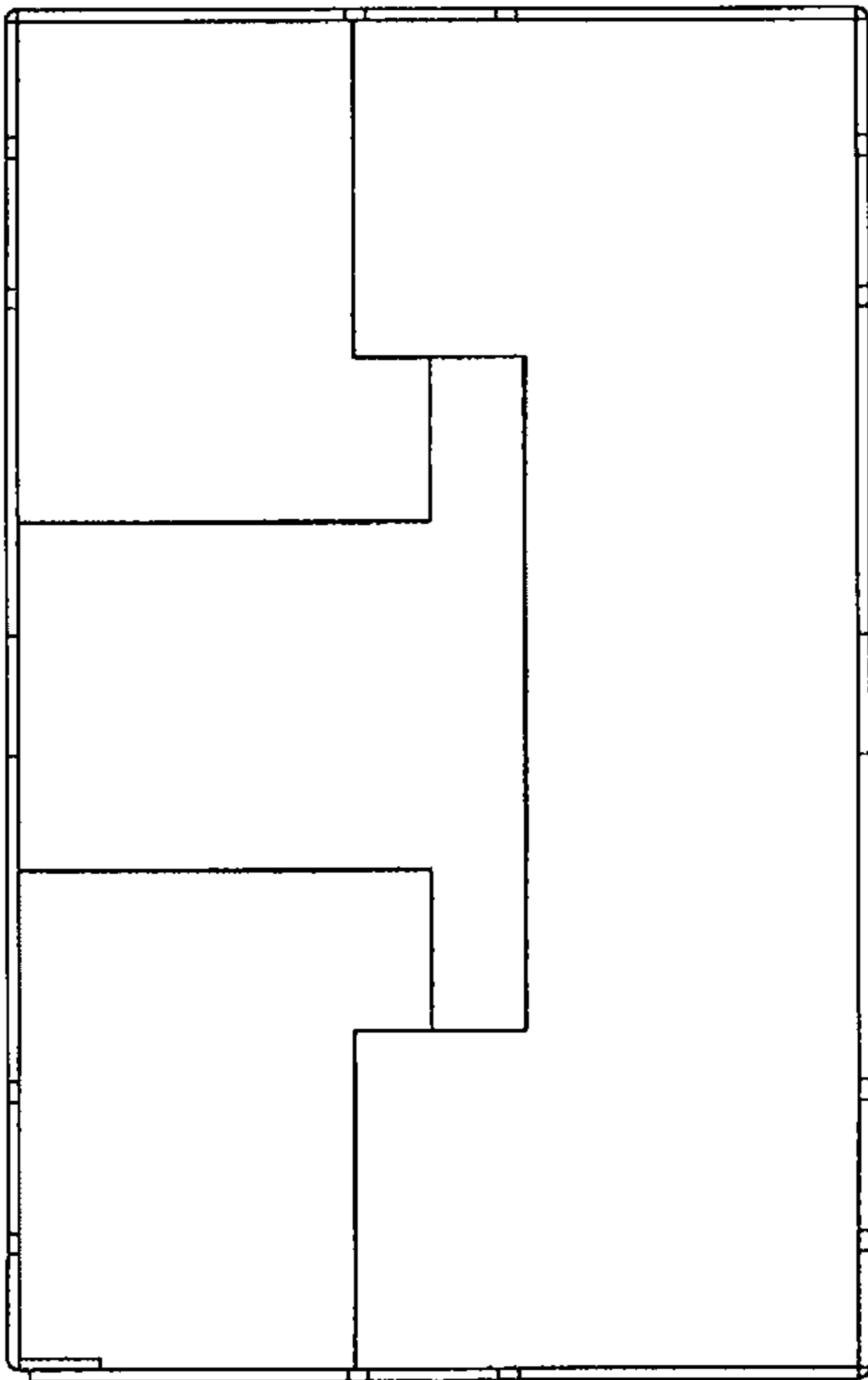
