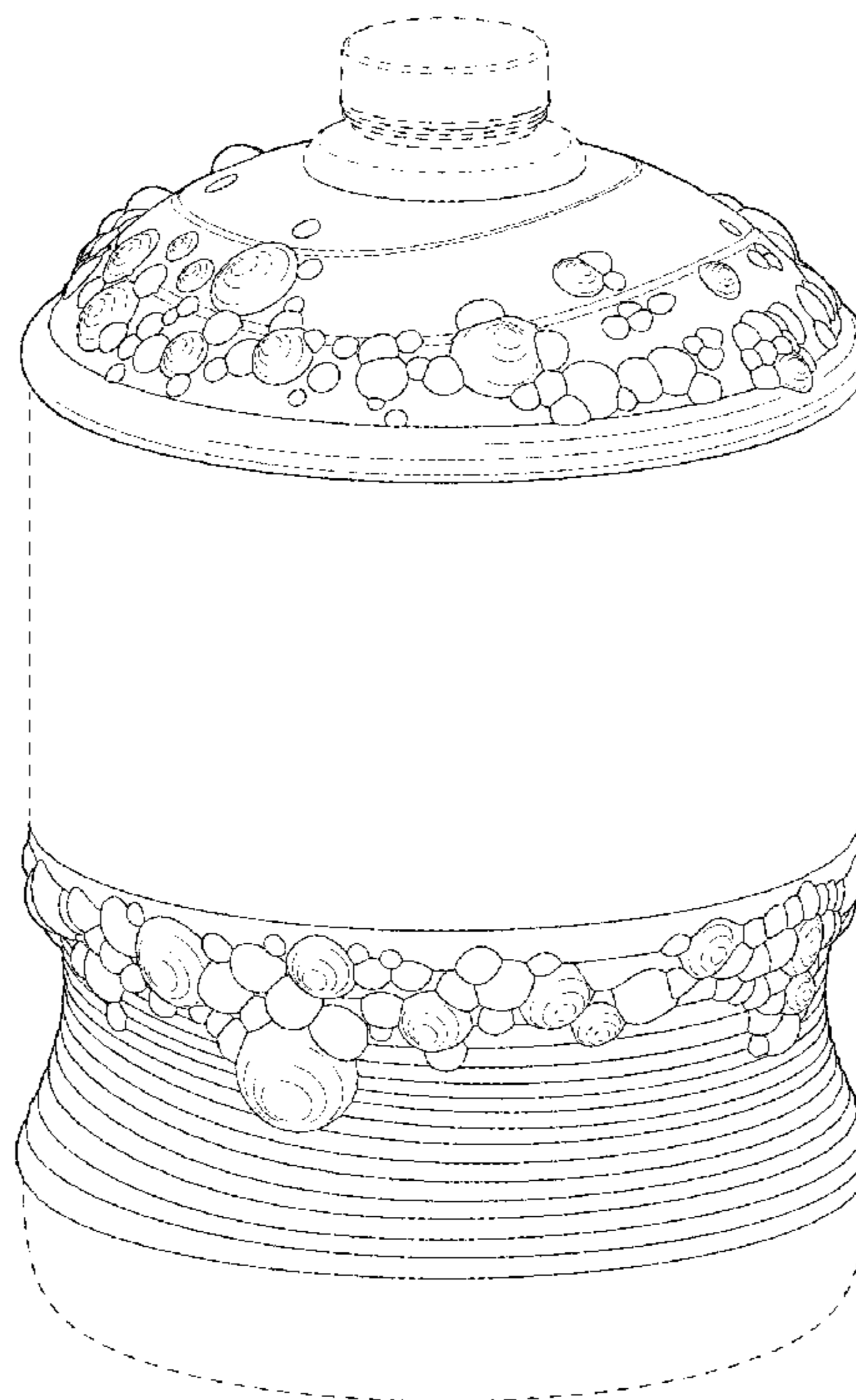
(57) **CLAIM**

I claim the ornamental design for a portion of a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a portion of a bottle according to the claimed design;
FIG. 2 is a bottom rear perspective view of the portion of a bottle of FIG. 1;
FIG. 3 is a front view of the portion of a bottle of FIG. 1;
FIG. 4 is a rear view of the portion of a bottle of FIG. 1;
FIG. 5 is a left-side view of the portion of a bottle of FIG. 1;
FIG. 6 is a right-side view of the portion of a bottle of FIG. 1;
FIG. 7 is a top view of the portion of a bottle of FIG. 1; and
FIG. 8 is a bottom view of the portion of a bottle of FIG. 1.

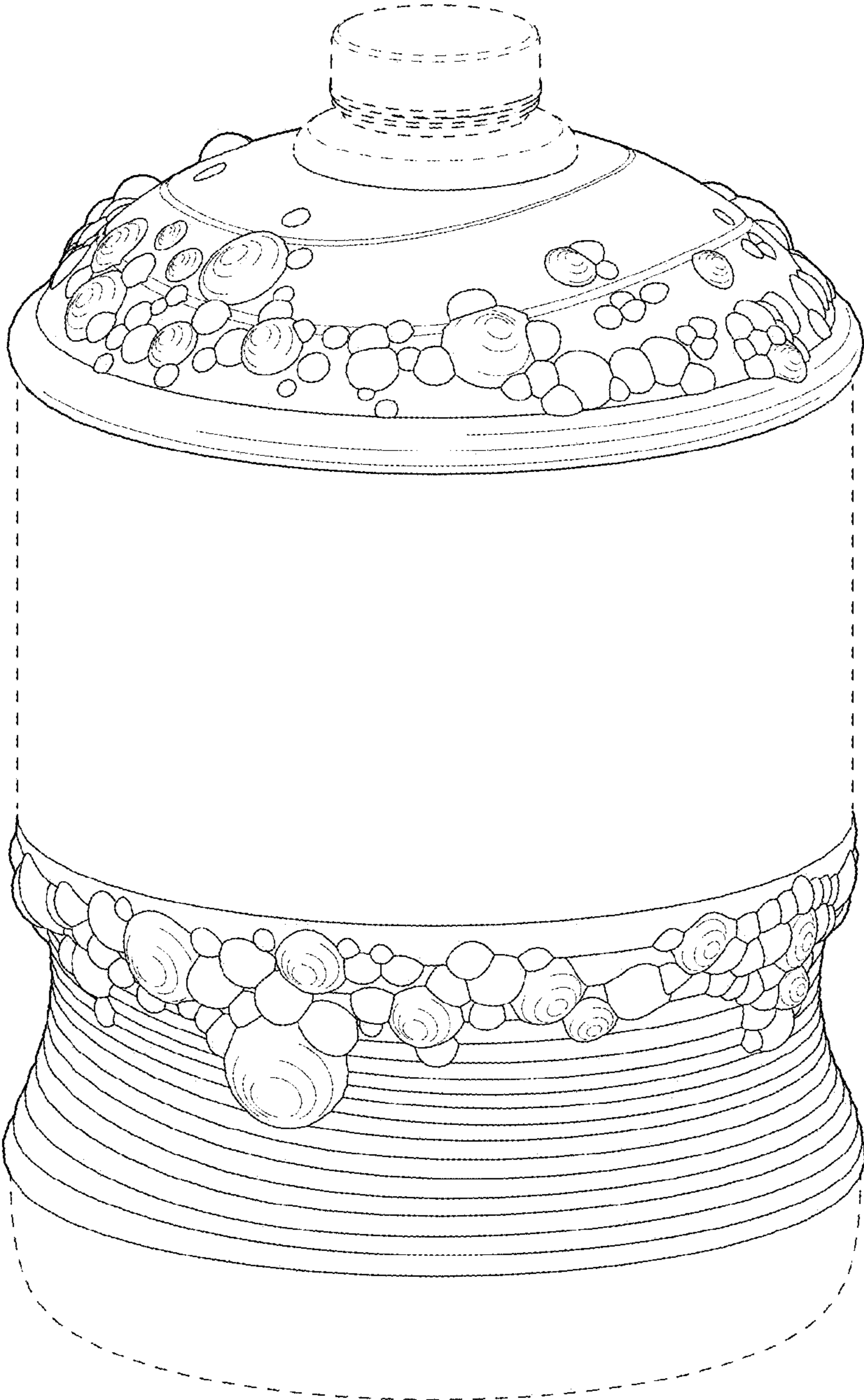

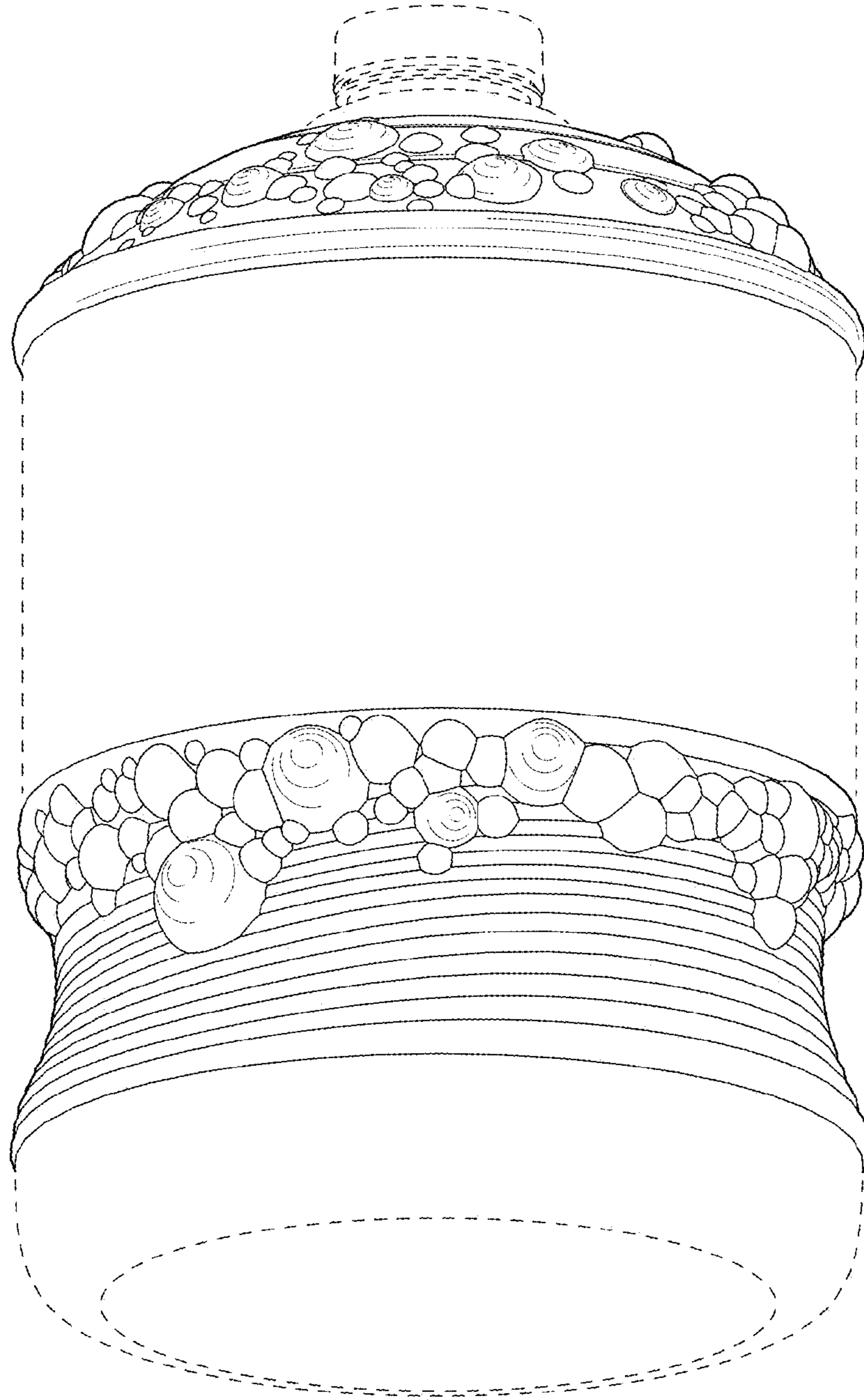

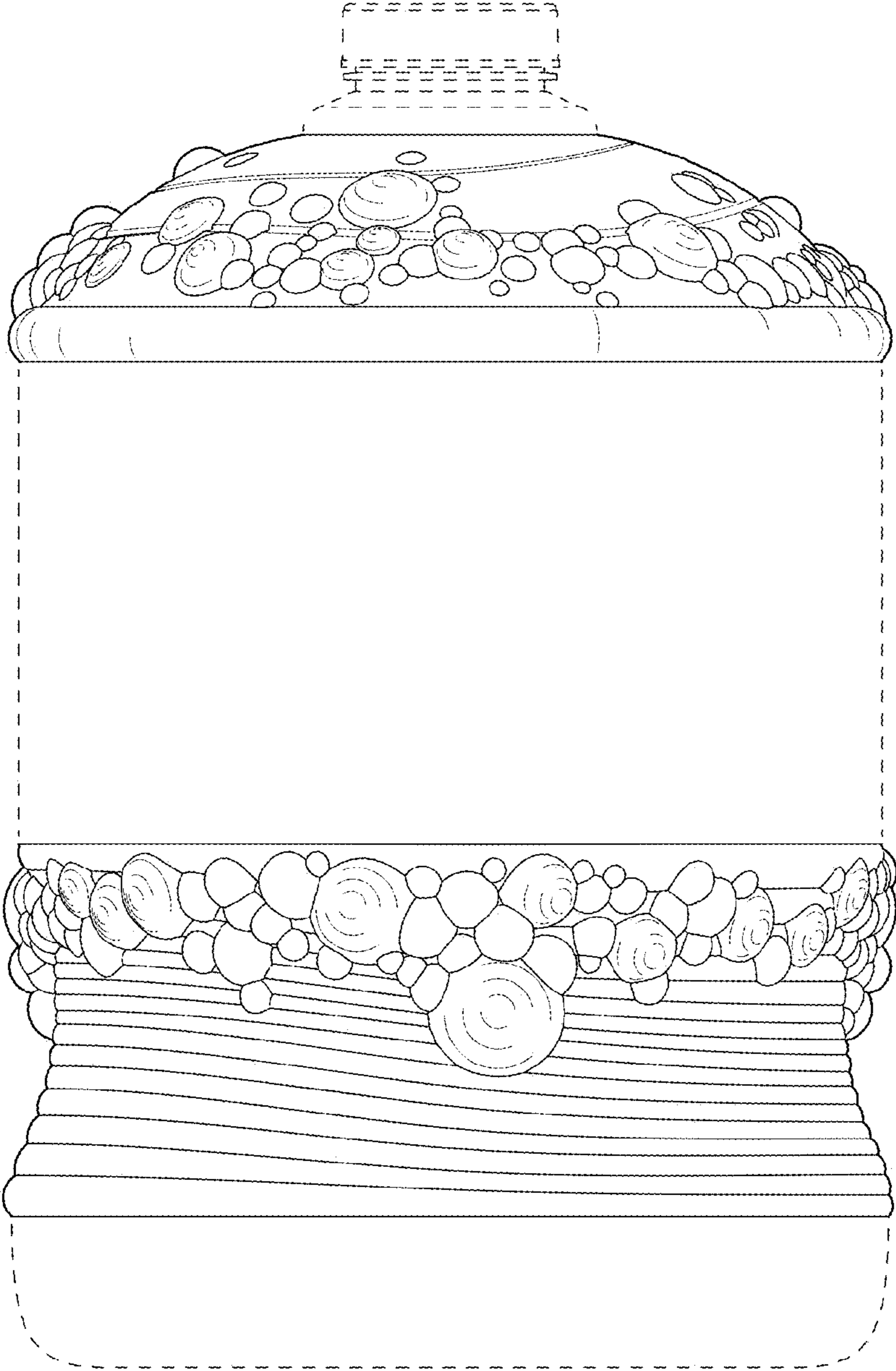

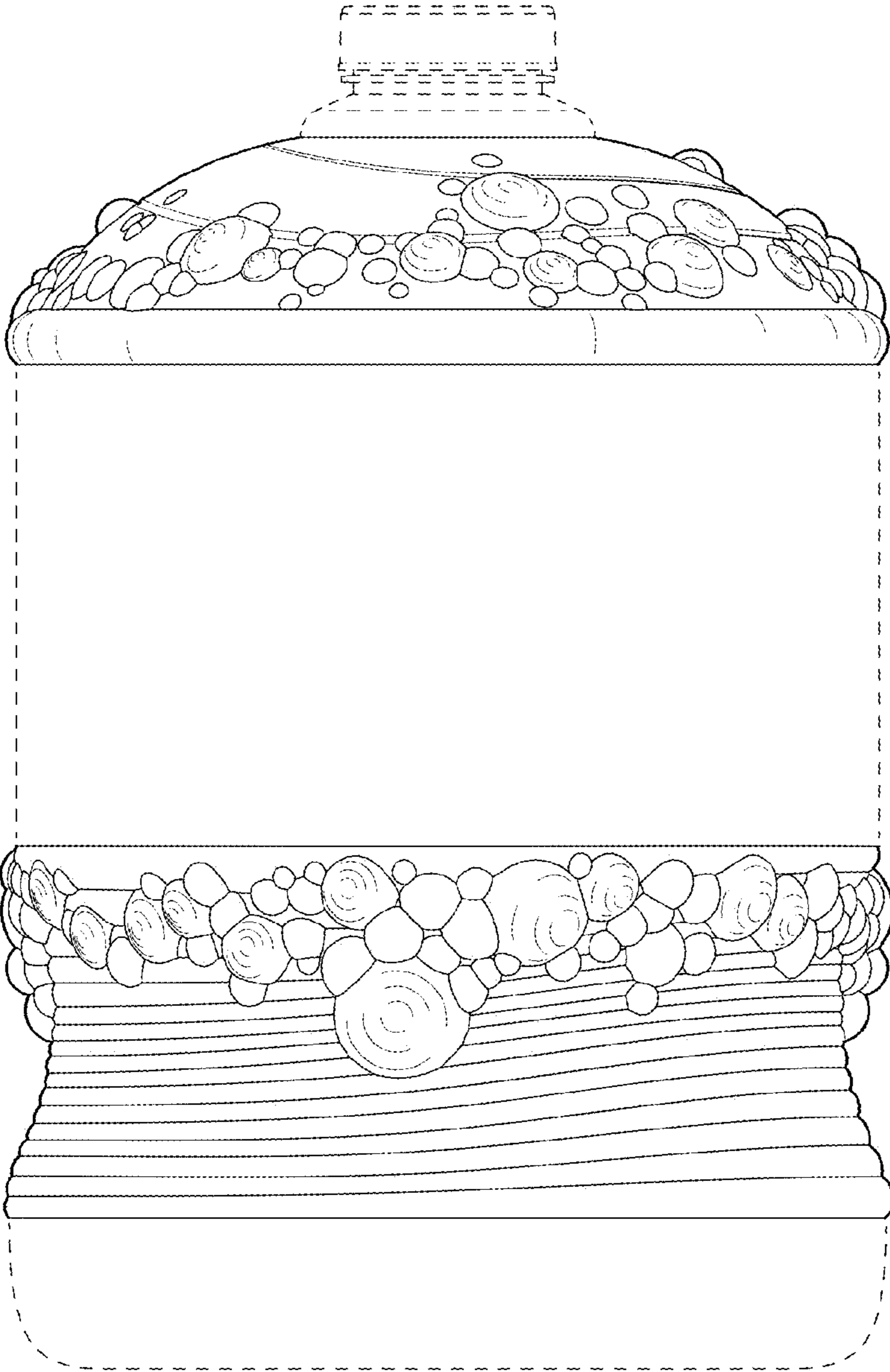

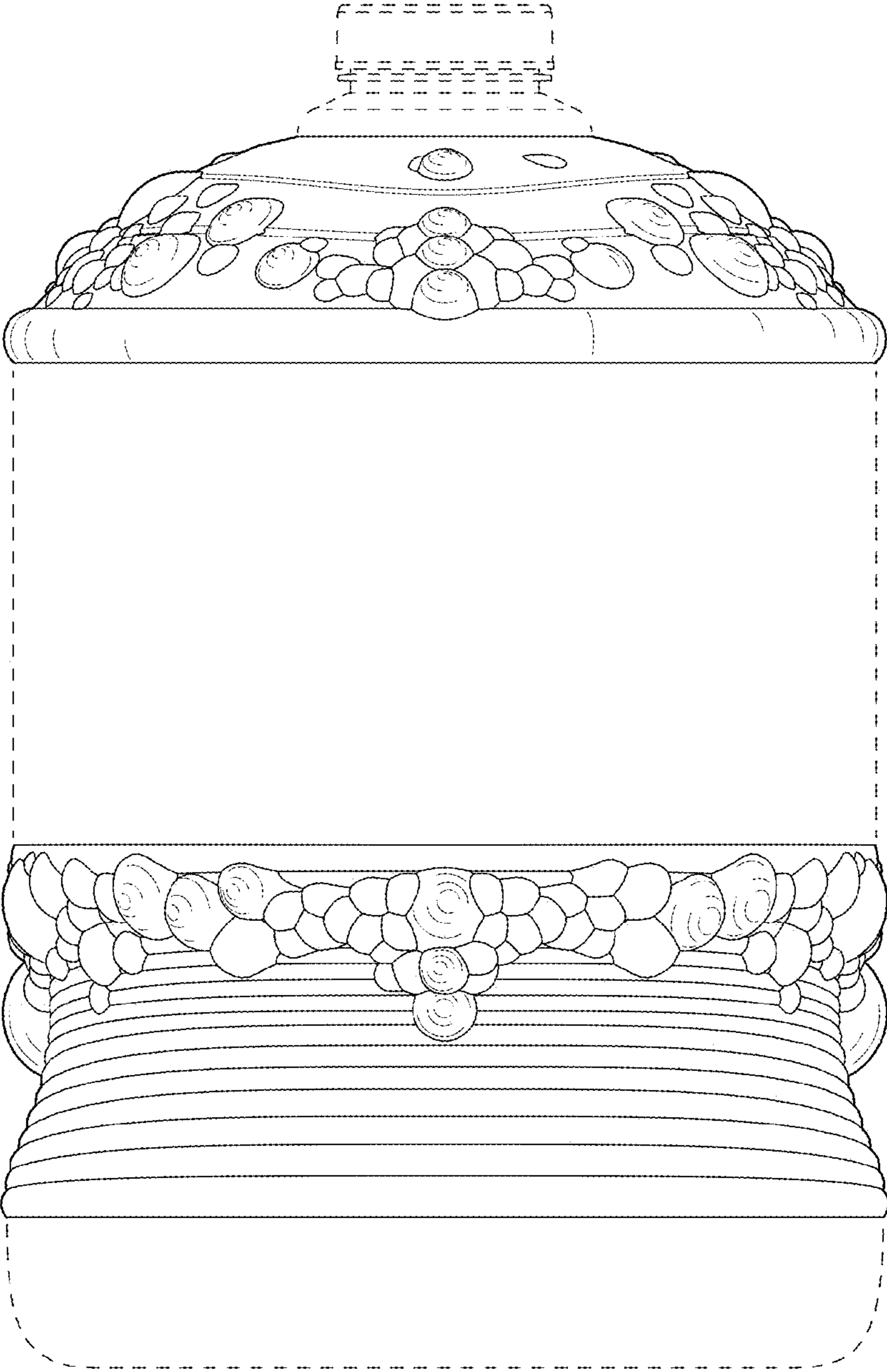

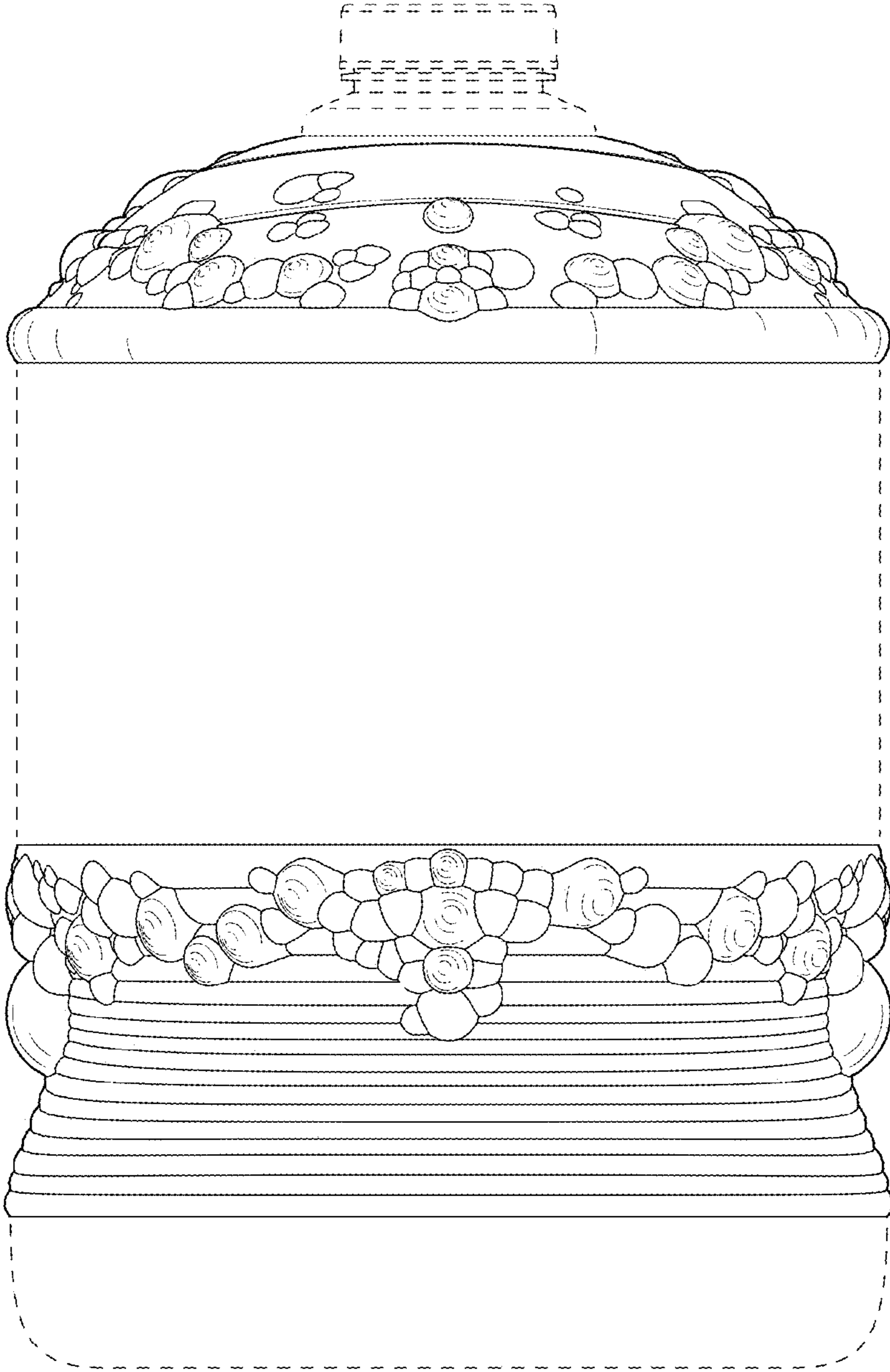

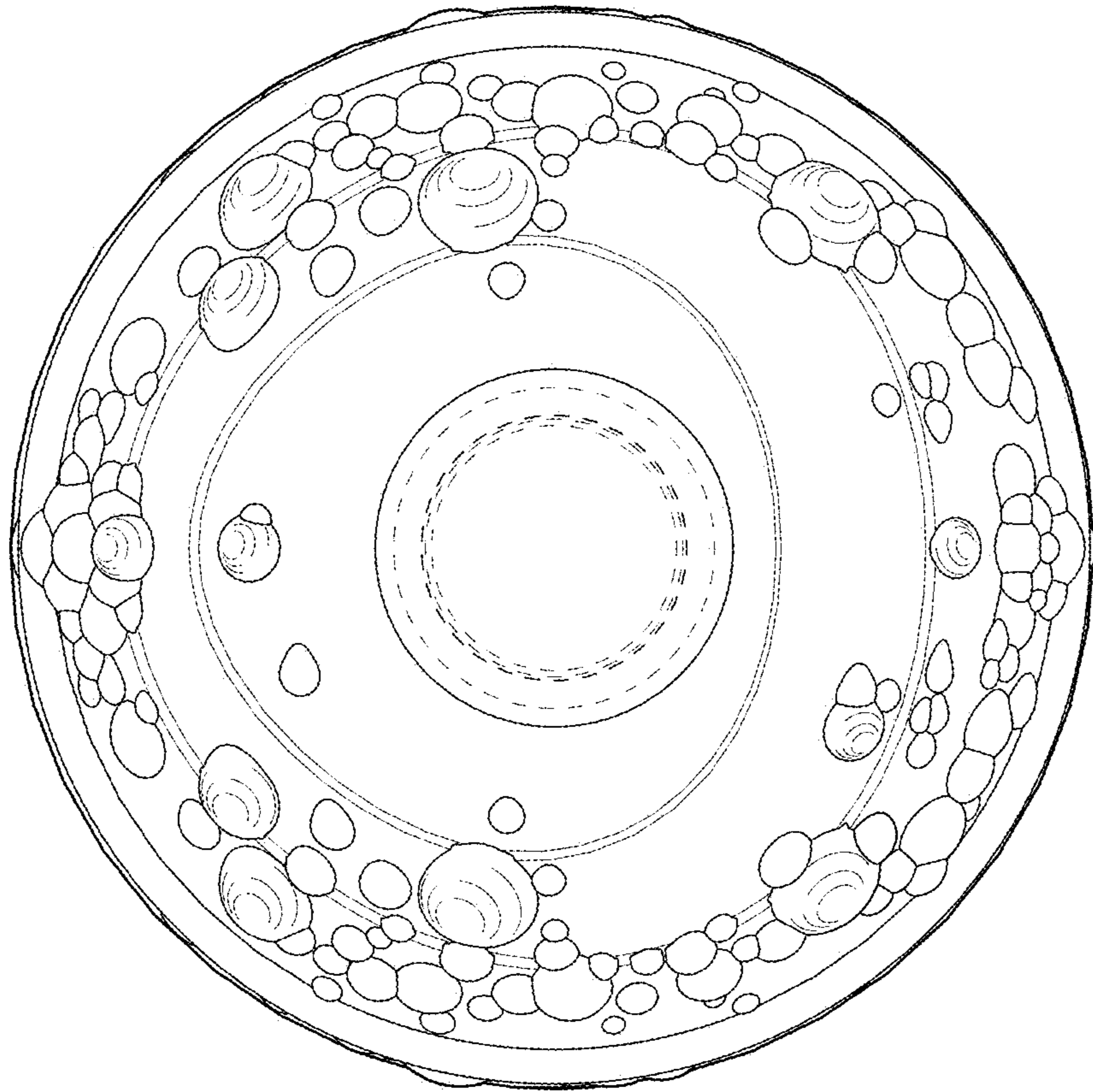

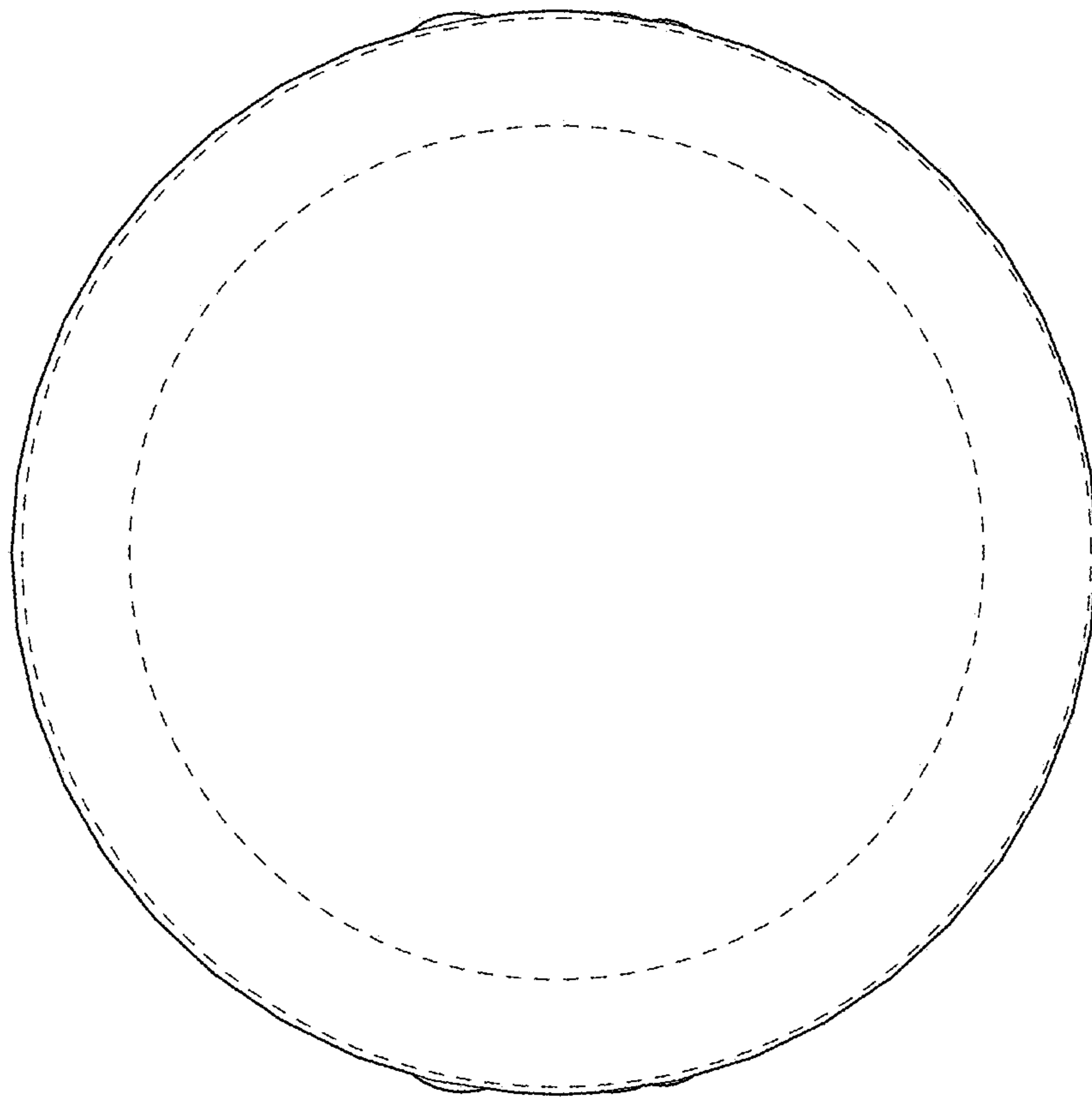
