The ornamental design for a motor vehicle and/or toy replica thereof, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a motor vehicle and/or toy replica thereof showing our new design;

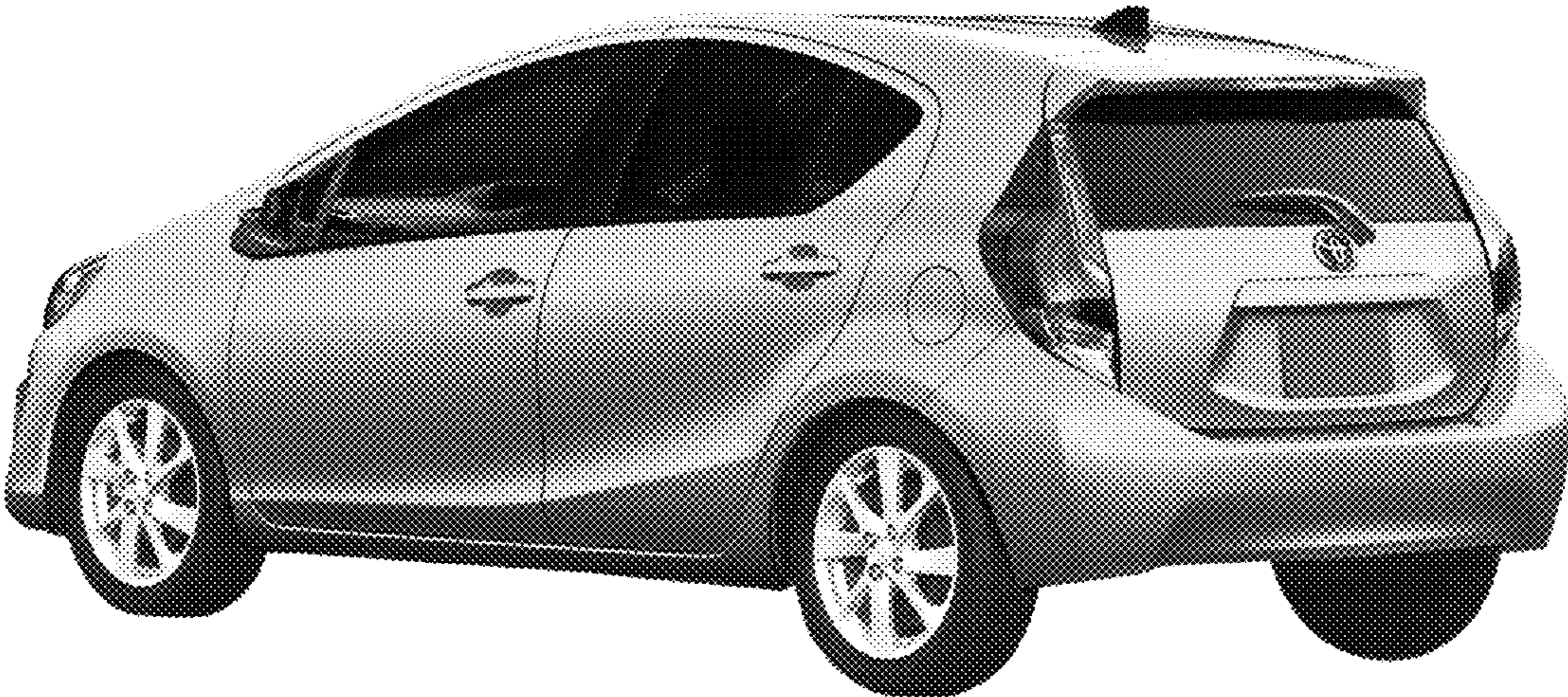

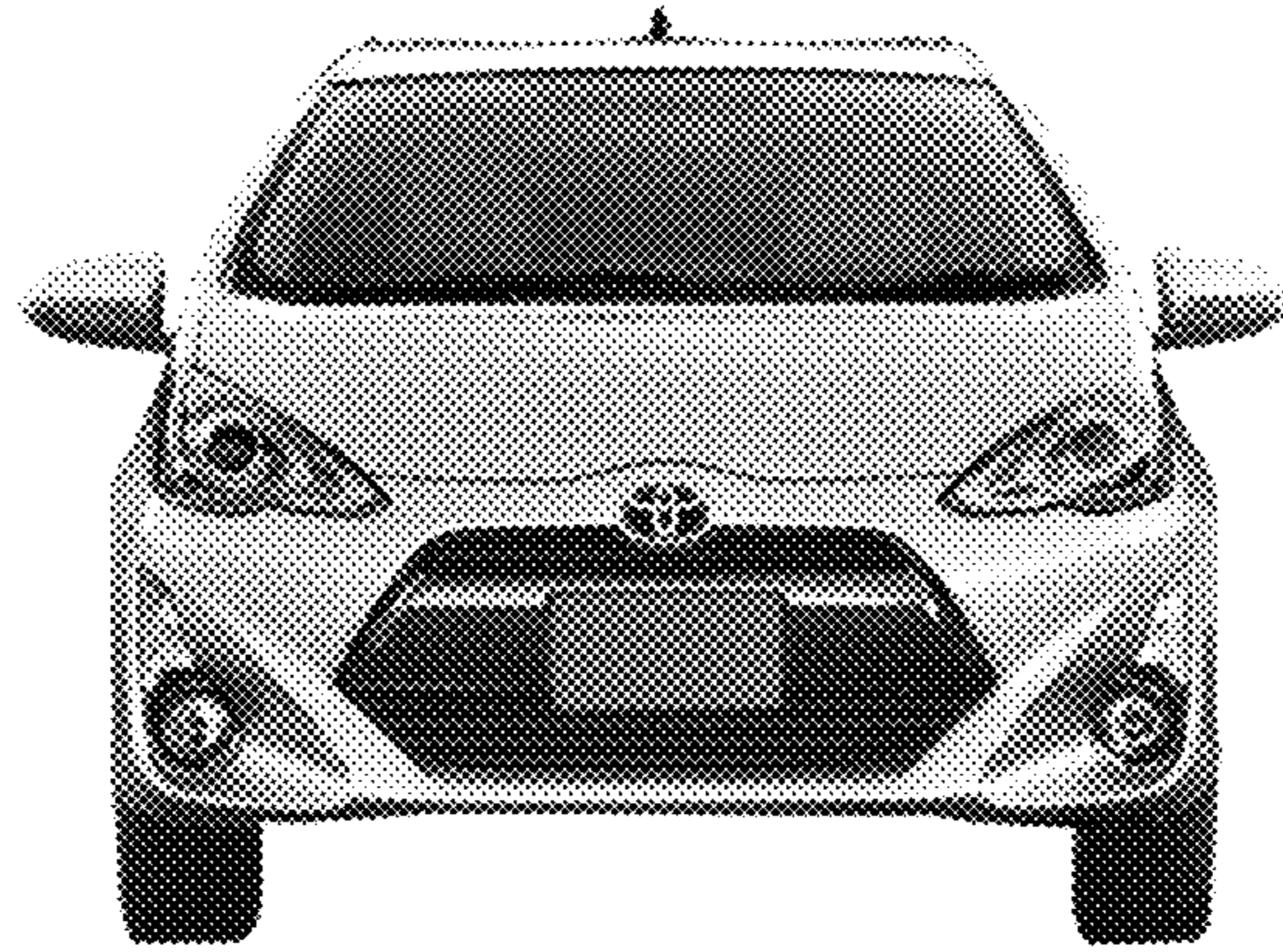

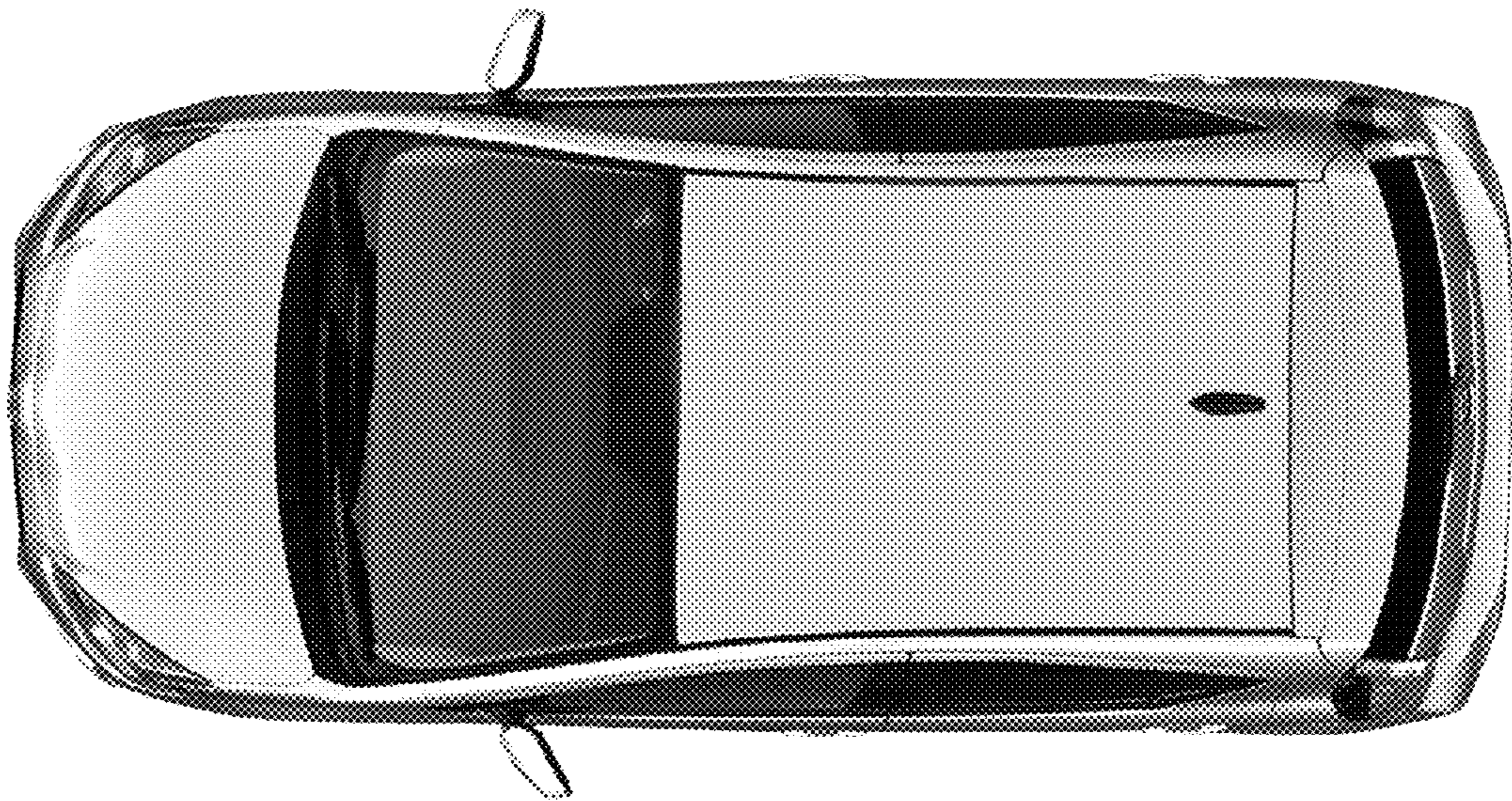

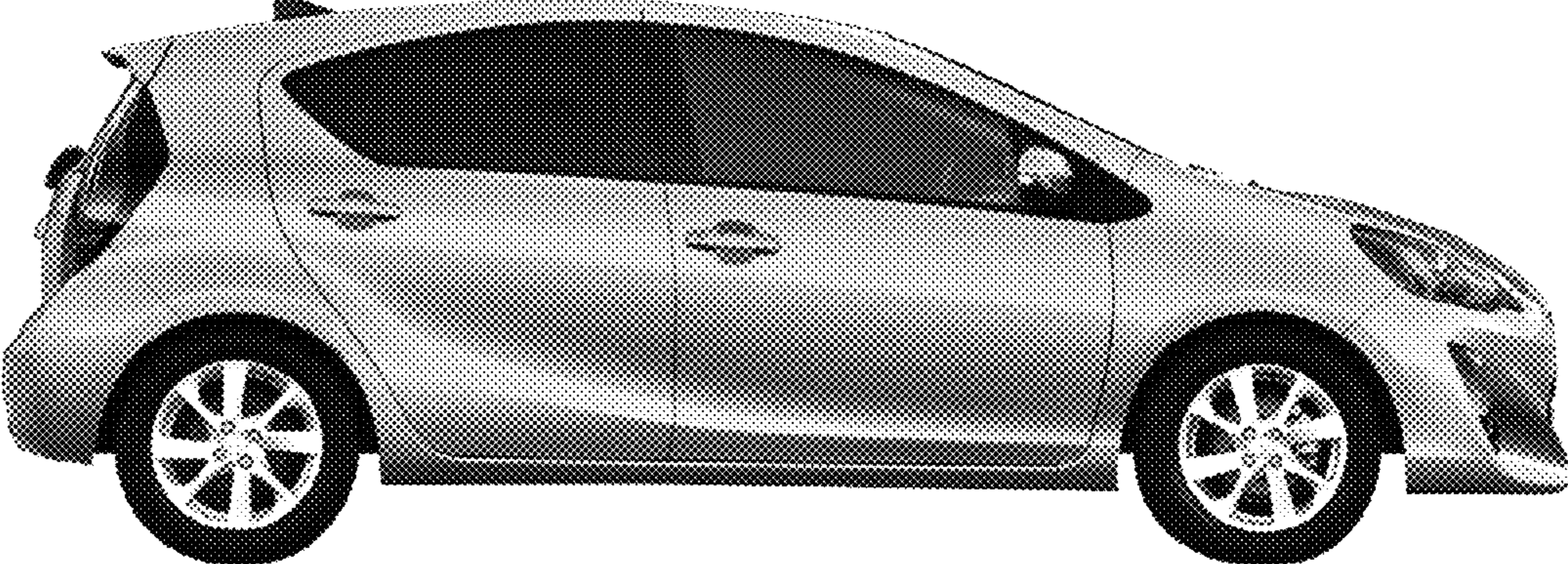

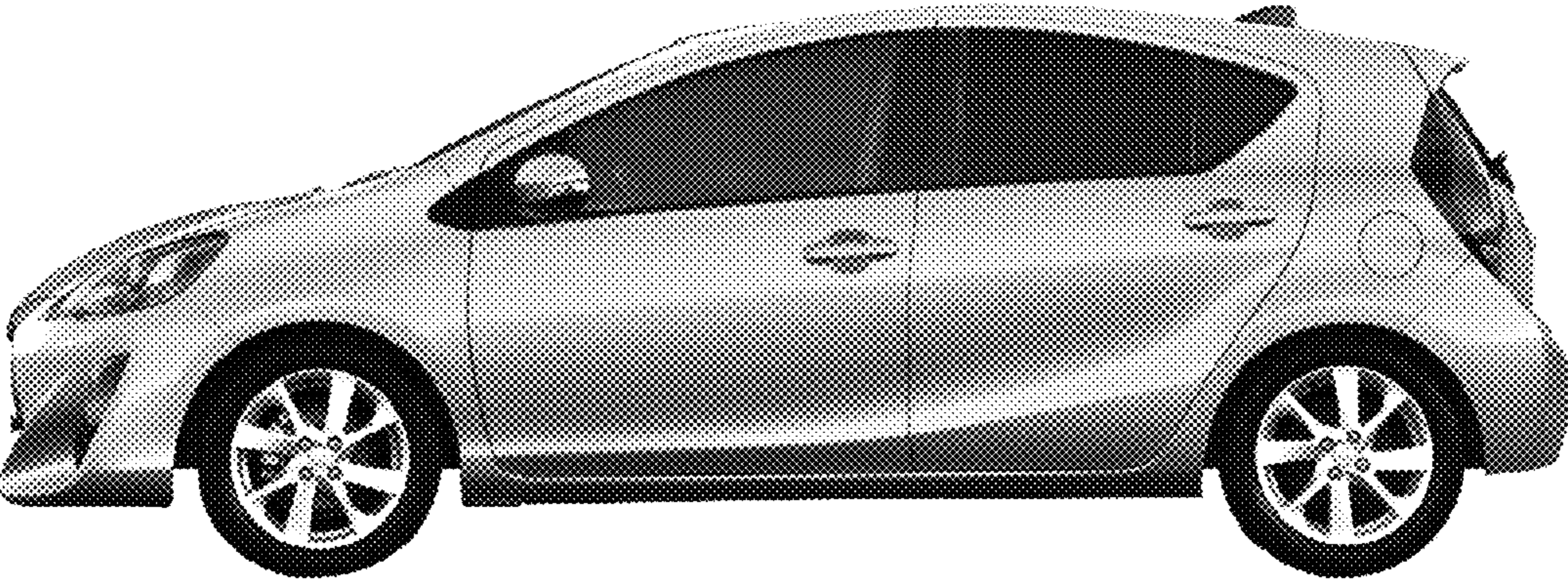
