(57) **CLAIM**

I claim the ornamental design for a bumper with wheel flares, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and left side of perspective view of a bumper wheel flares showing my new design.

FIG. 2 is a front elevation view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is a left side elevation view thereof; and,

FIG. 7 is a right side elevation view.

The broken lines in the drawings illustrate portions of the bumper with wheel flares that forms no part of the claimed design.

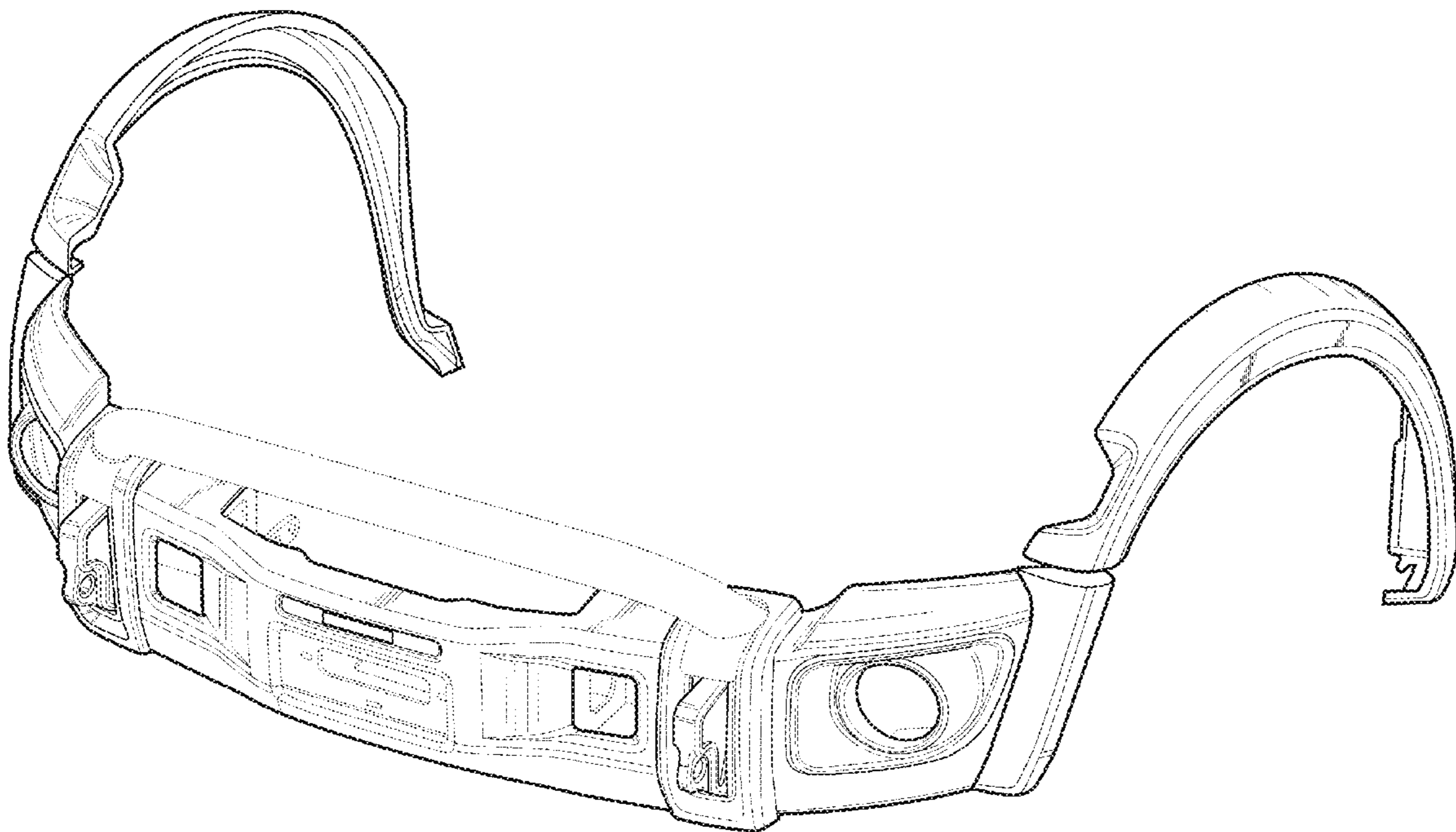
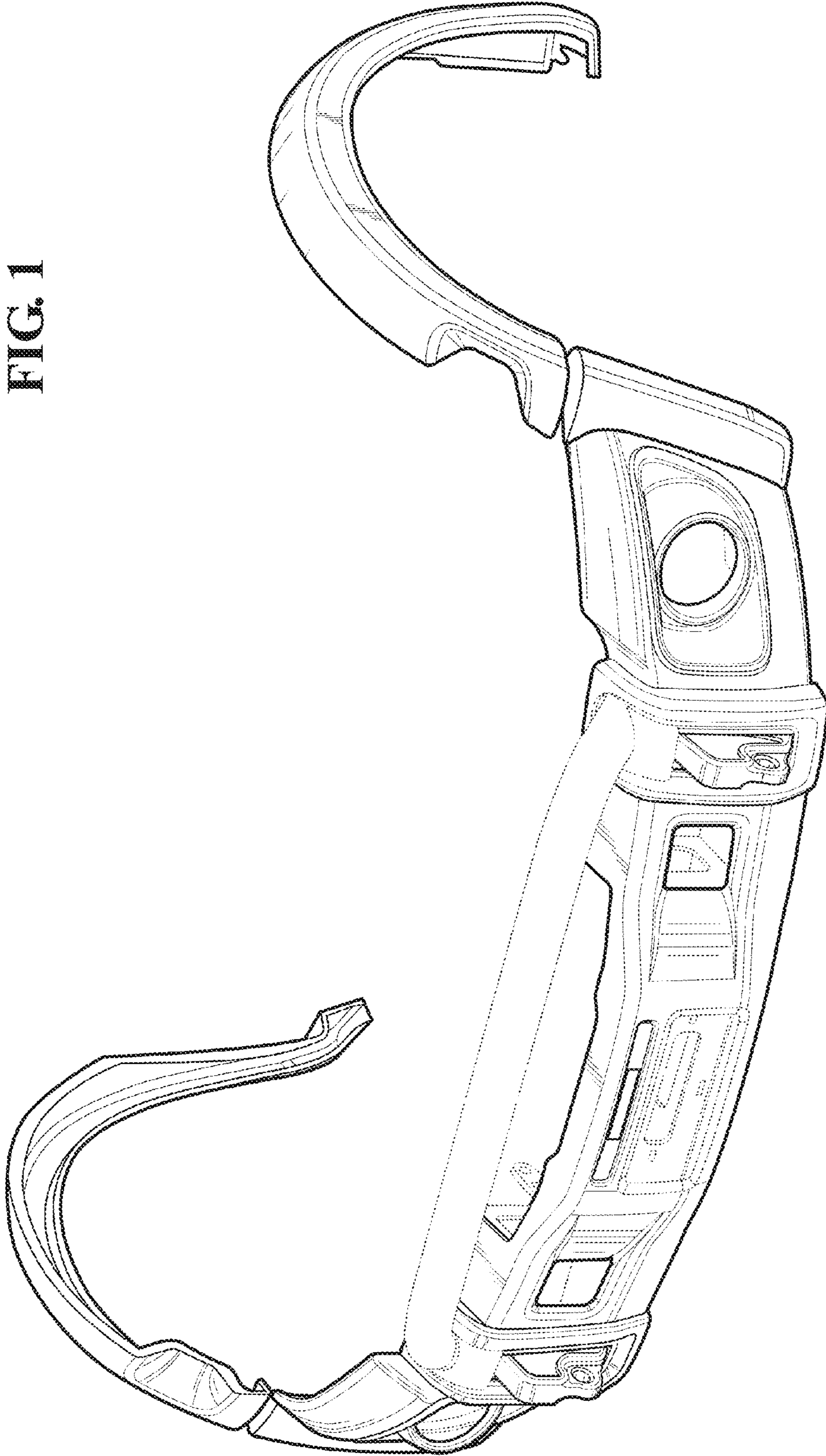

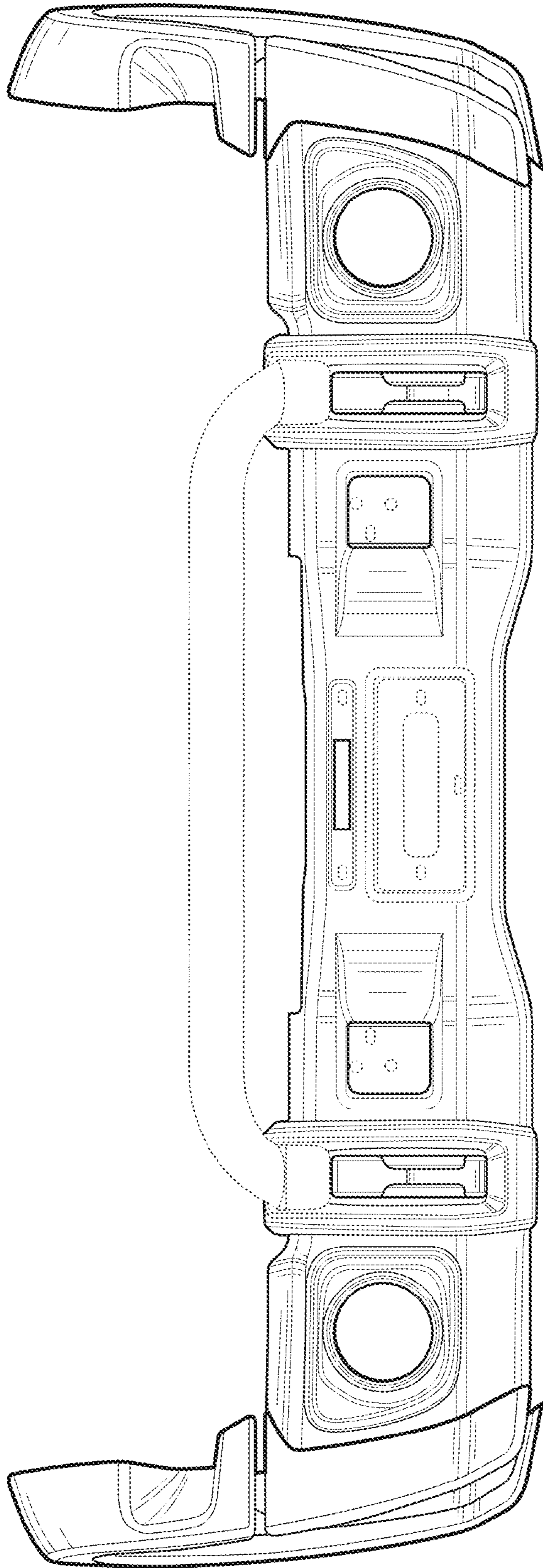

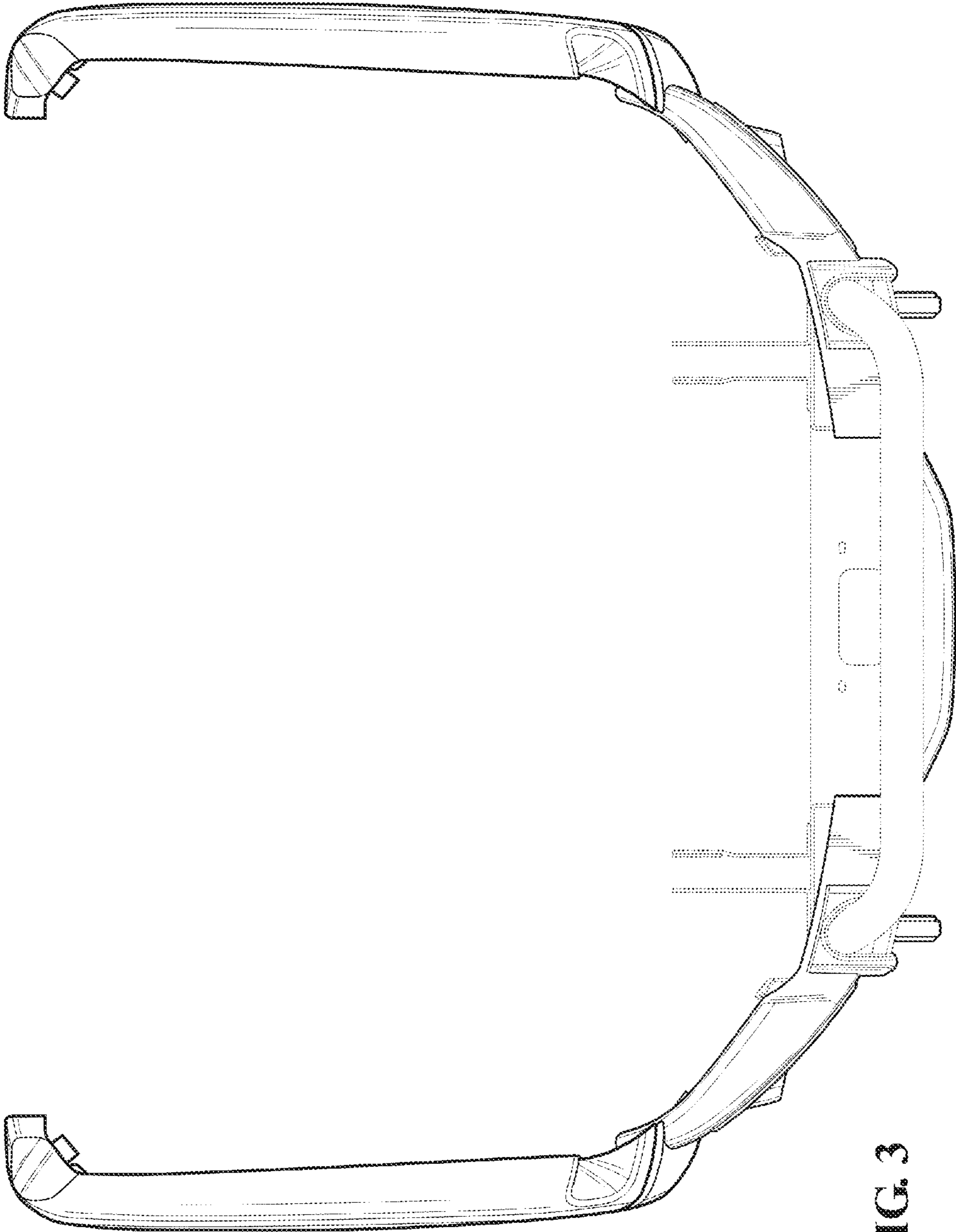

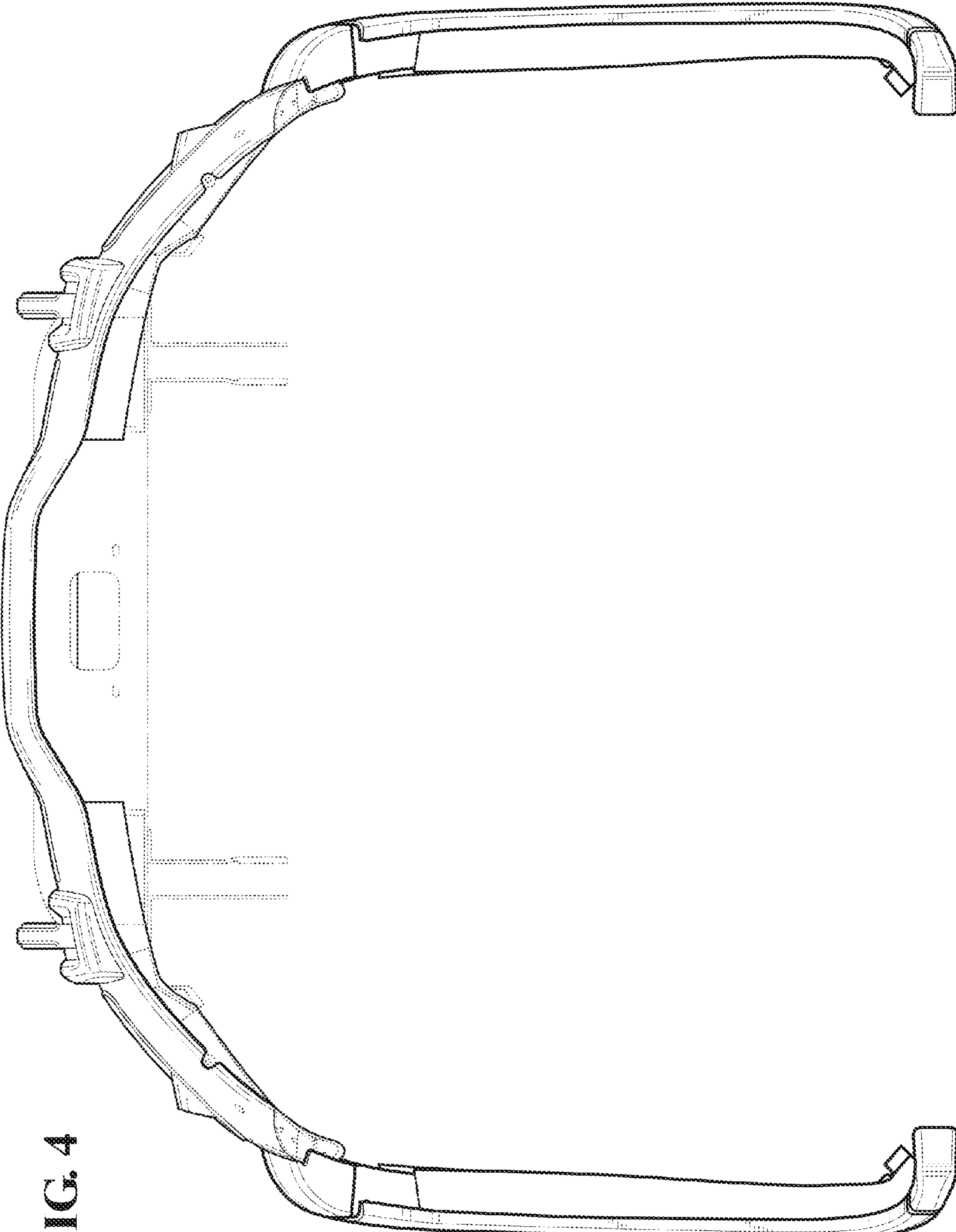

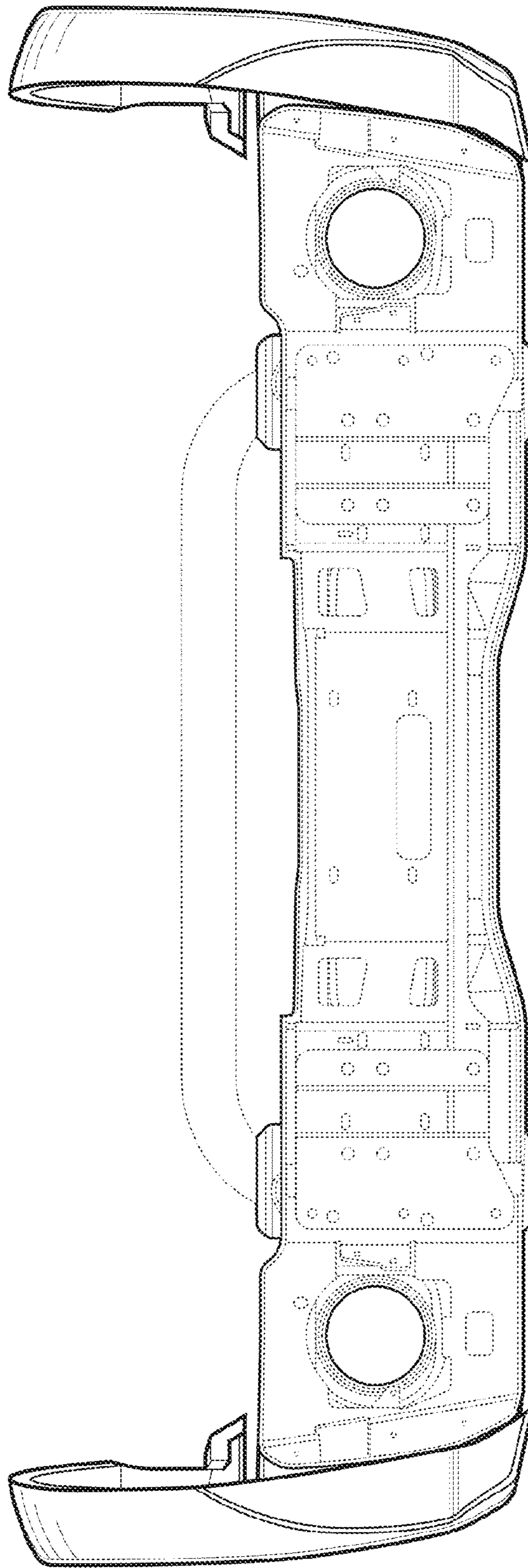

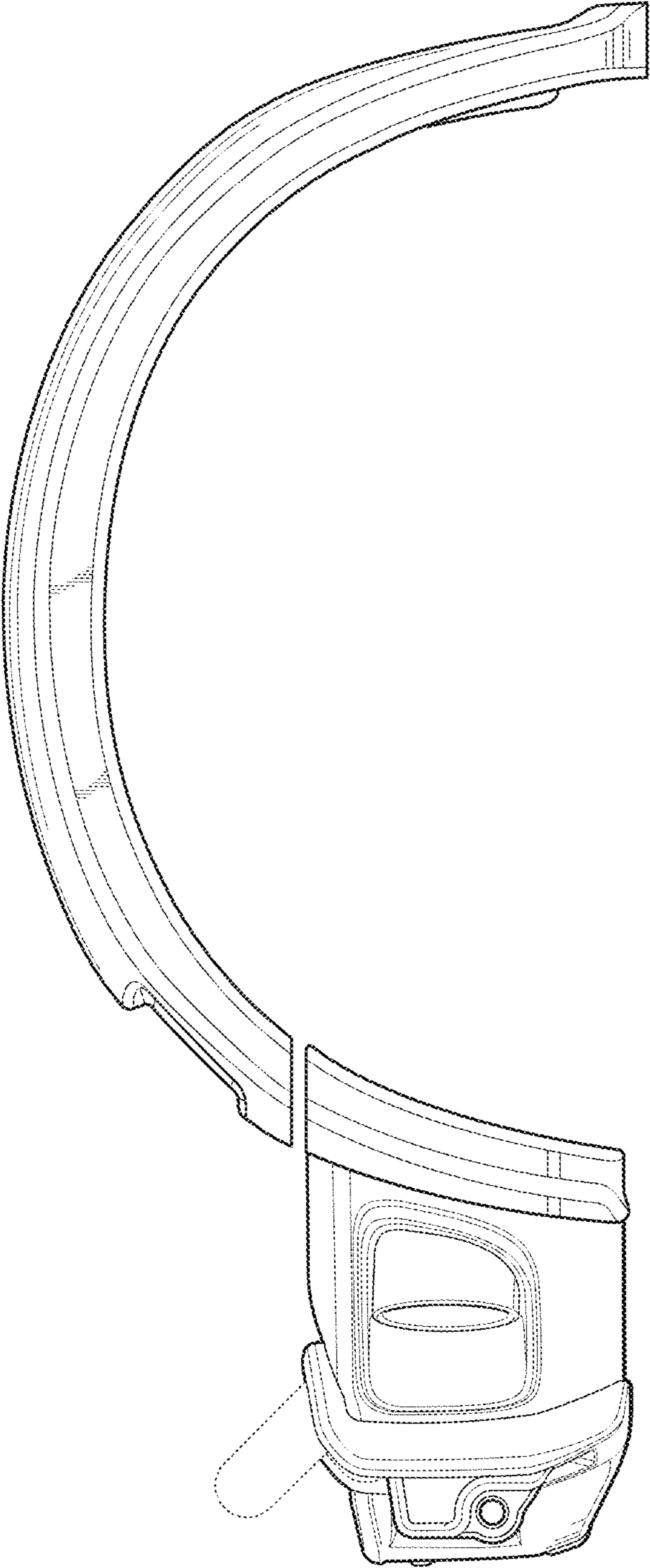

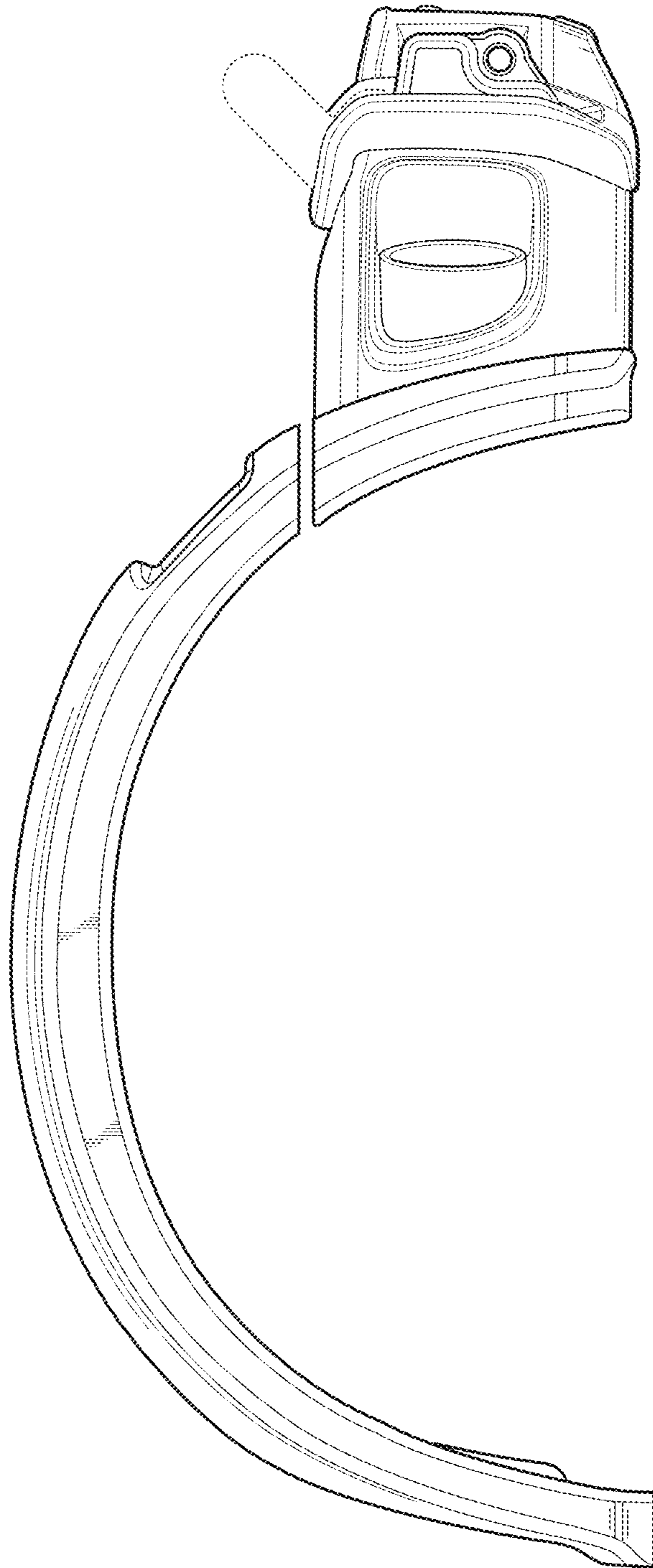
