(57) **CLAIM**

The ornamental design for a vehicle wheel, as shown and described.

DESCRIPTION

This application contains subject matter related to the following co-pending U.S. design patent applications: Application Ser. No. 29/450,362, filed Mar. 18, 2013 and entitled “Vehicle Wheel;” and Application Ser. No. 29/450,383, filed Mar. 18, 2013 and entitled Vehicle Wheel.

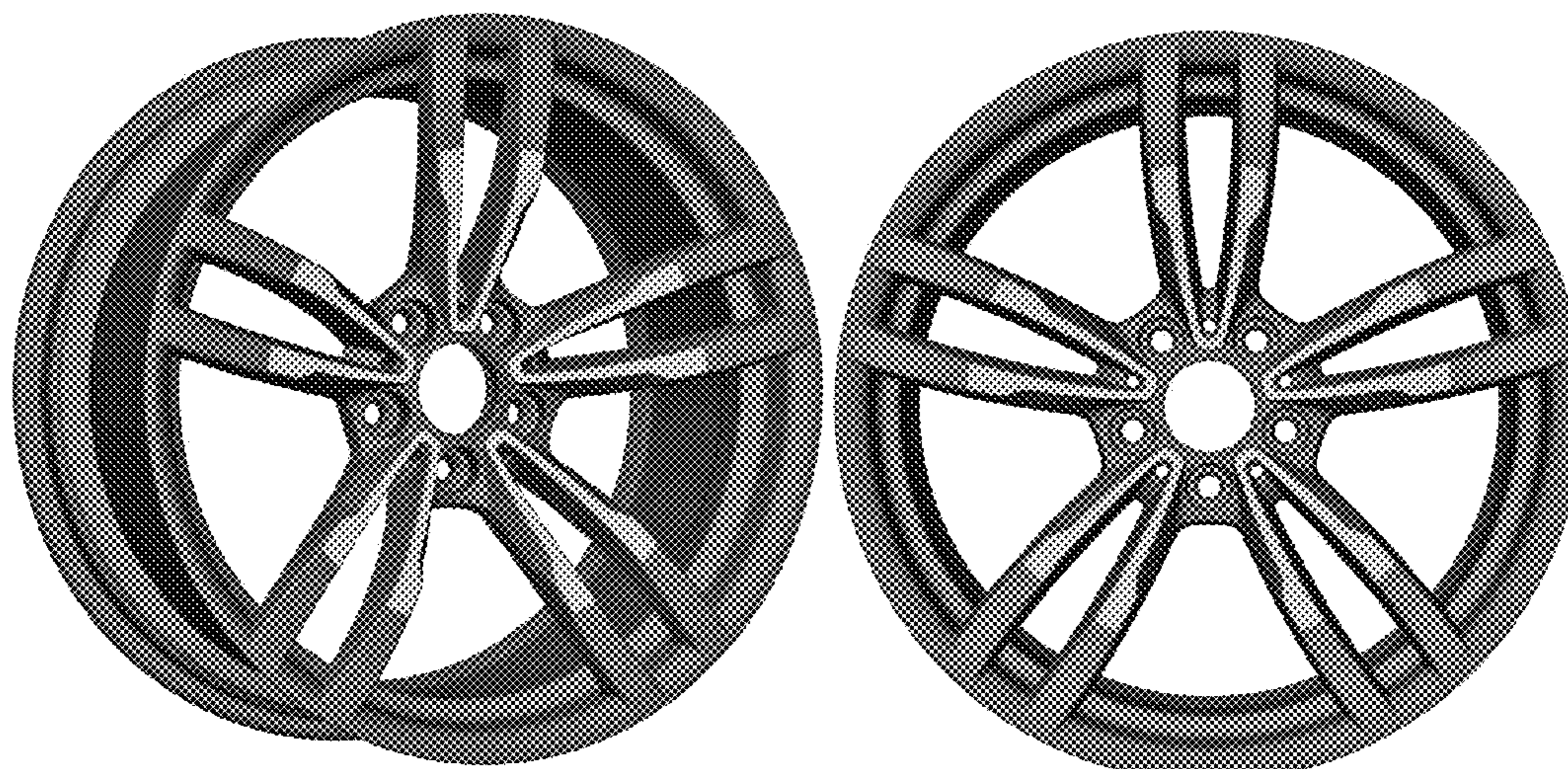

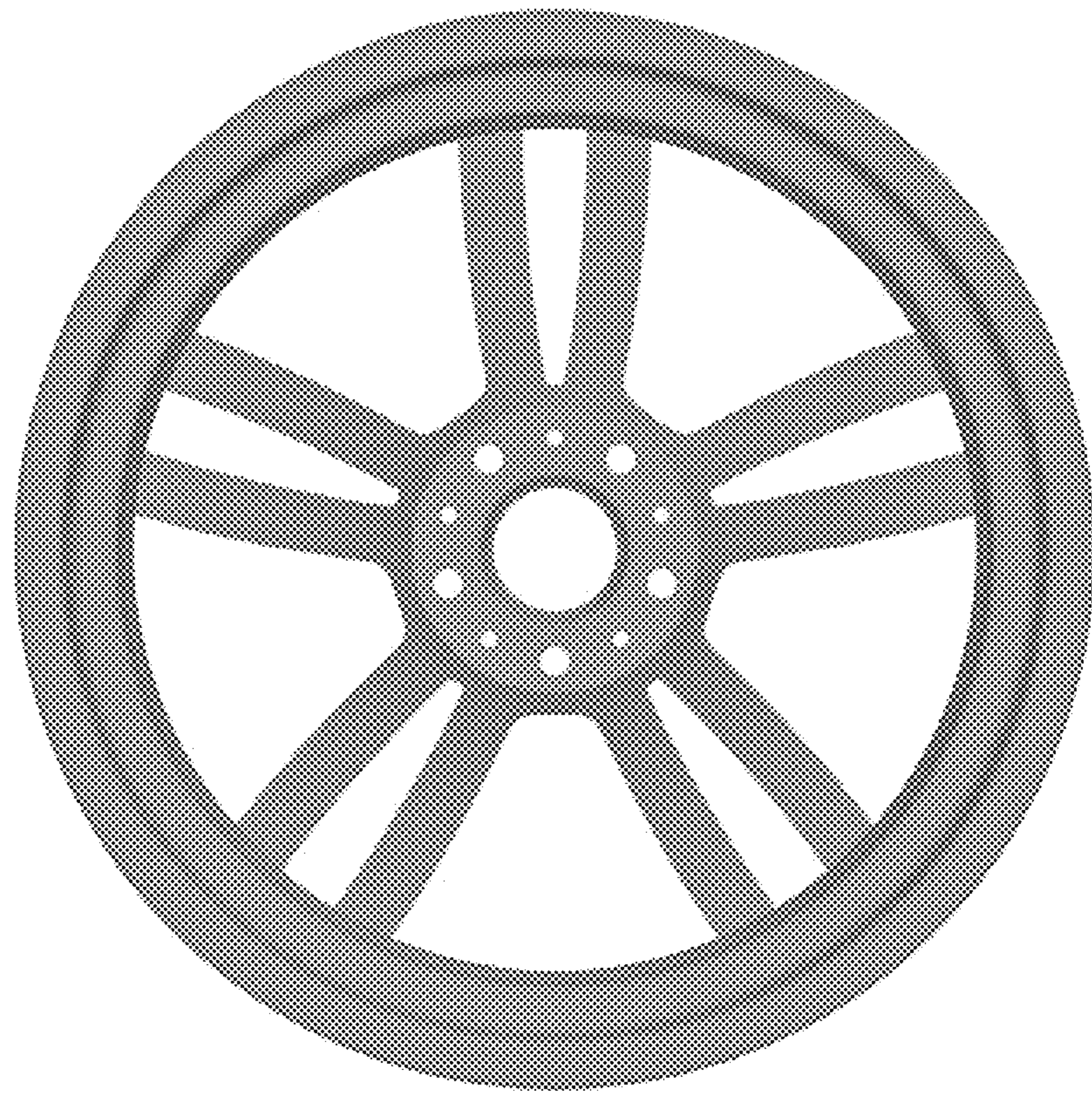
