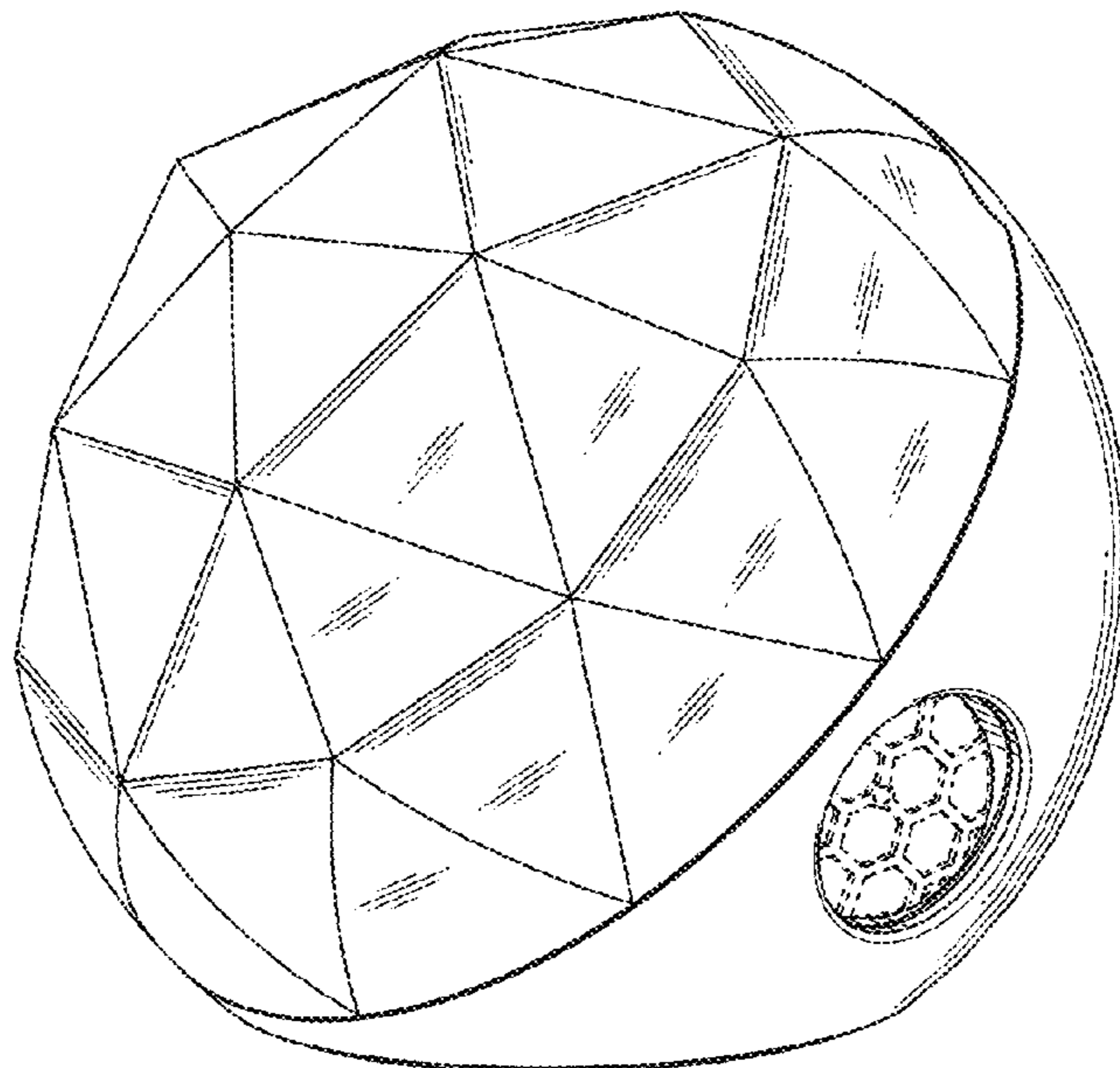
(57) **CLAIM**

The ornamental design for the diamond stereo loudspeaker with mood light, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right perspective view of a diamond stereo loudspeaker with mood light showing our new design; FIG. 2 is a front side view thereof; FIG. 3 is a rear side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. 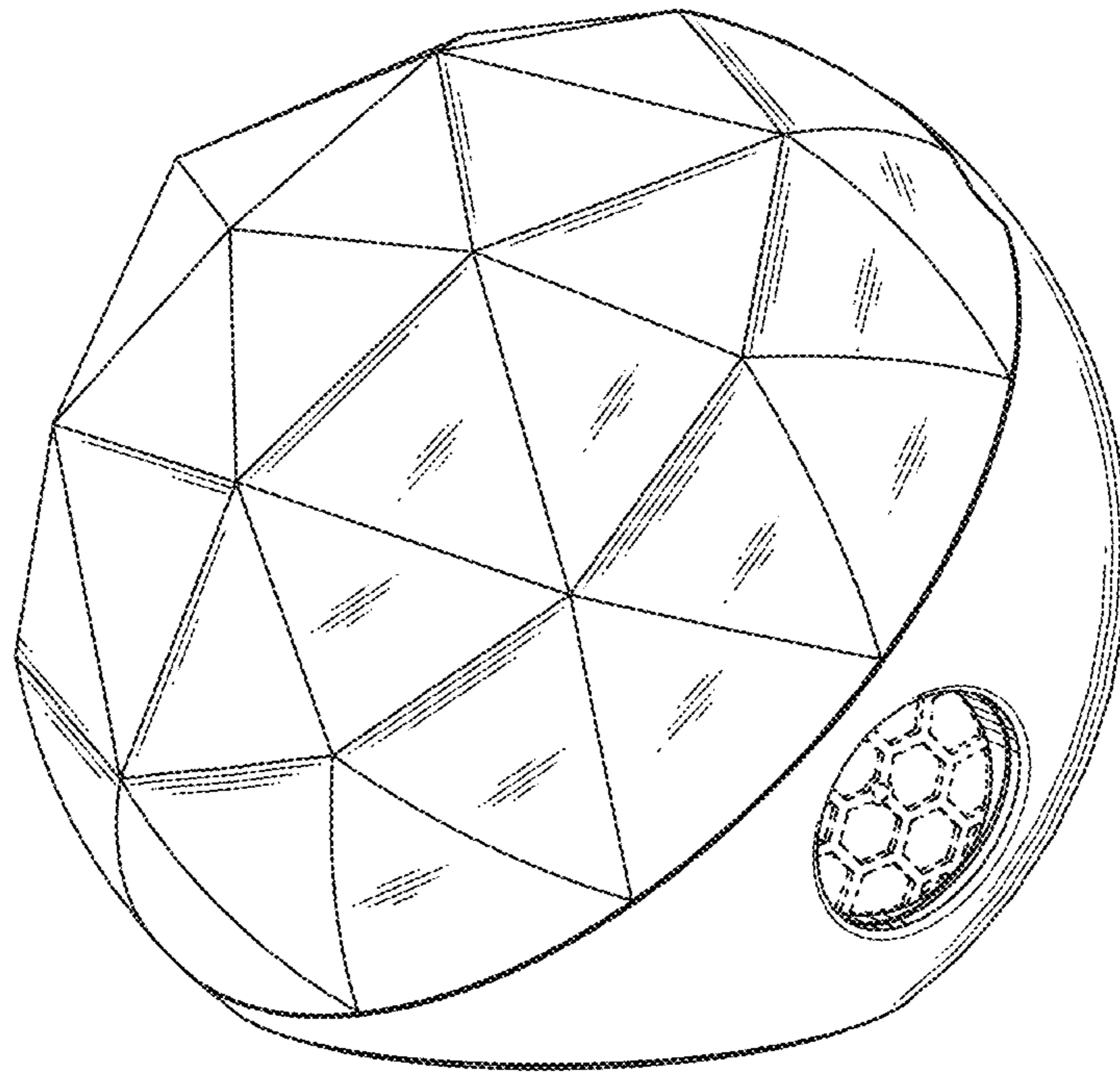

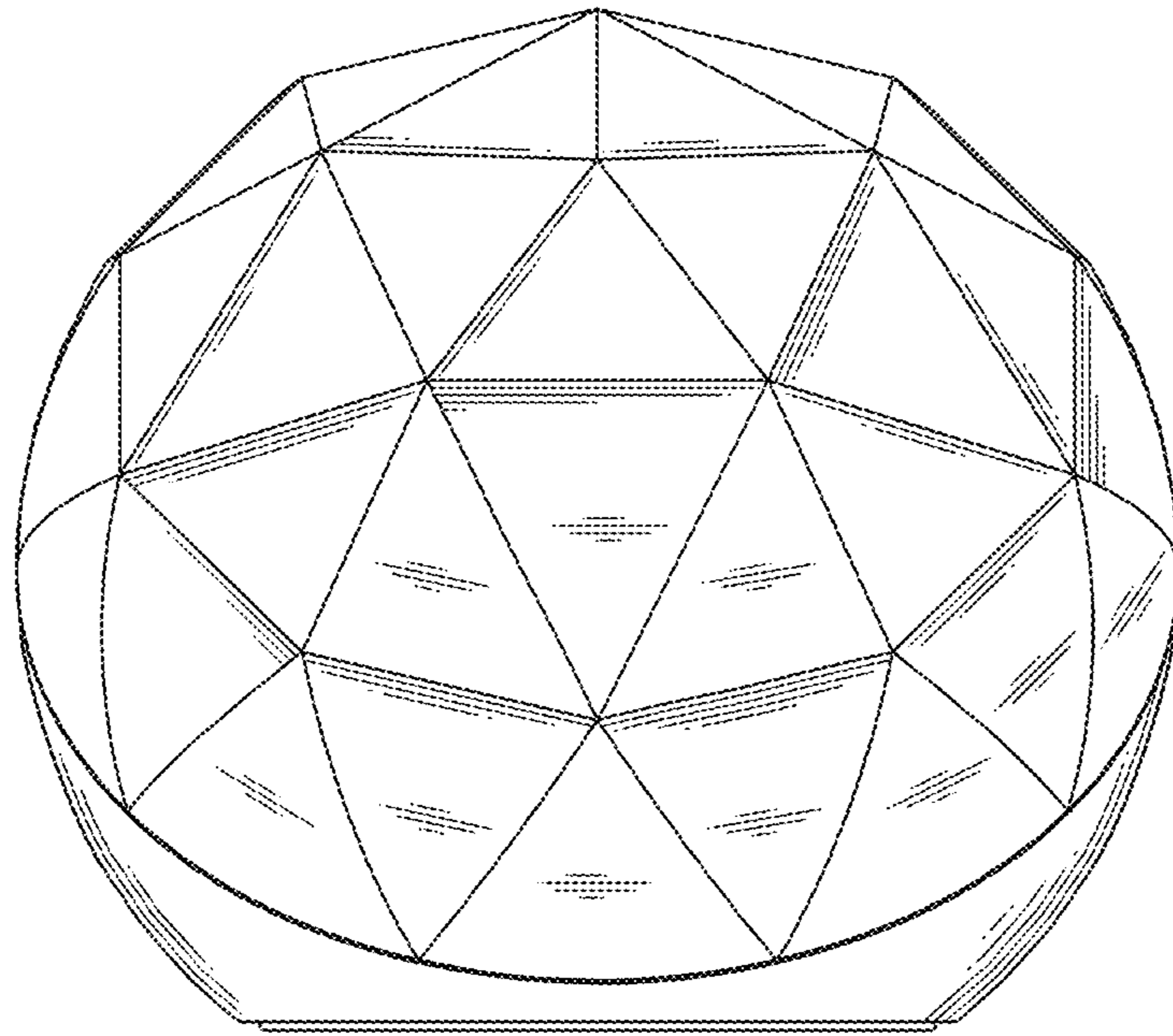

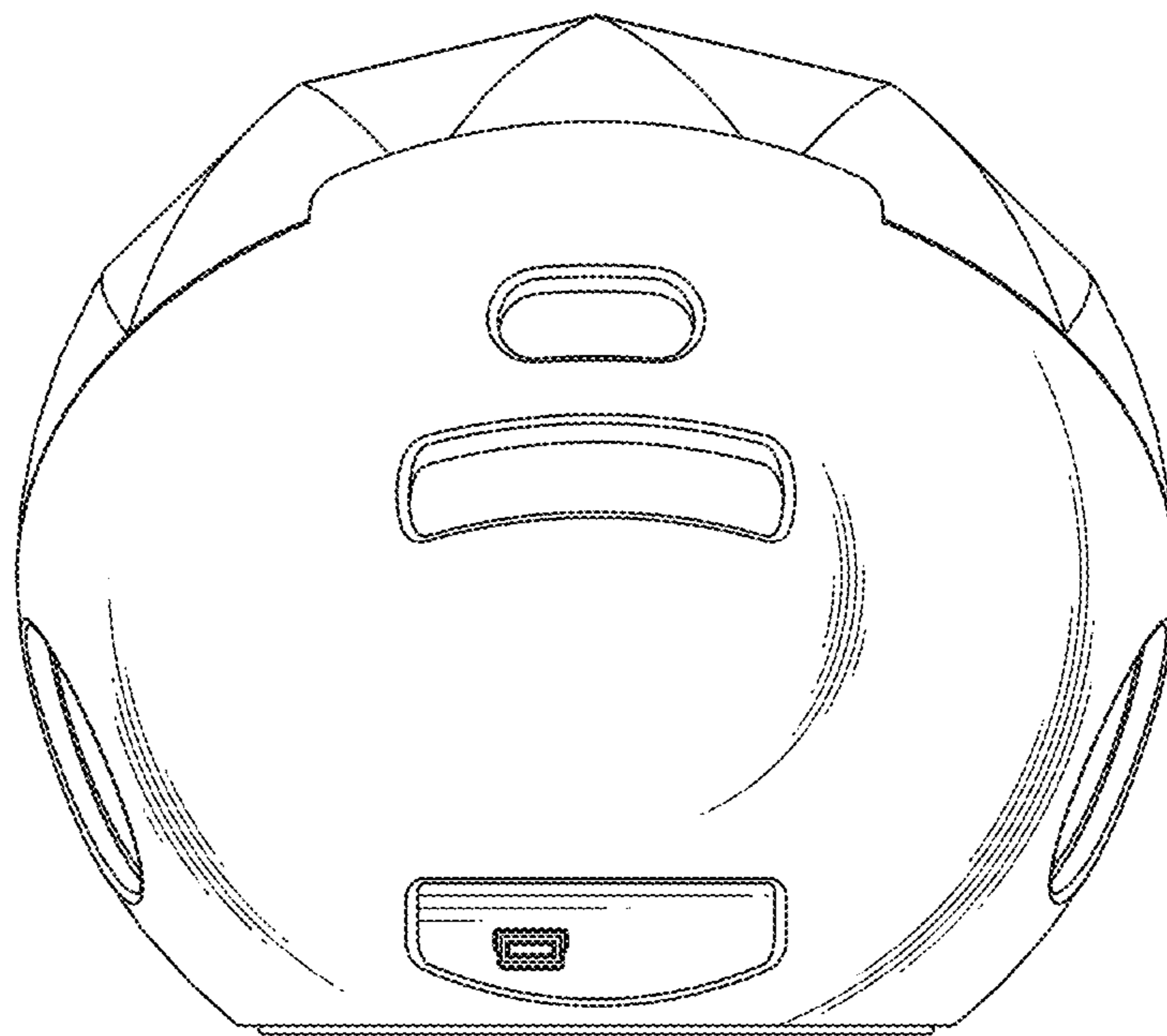

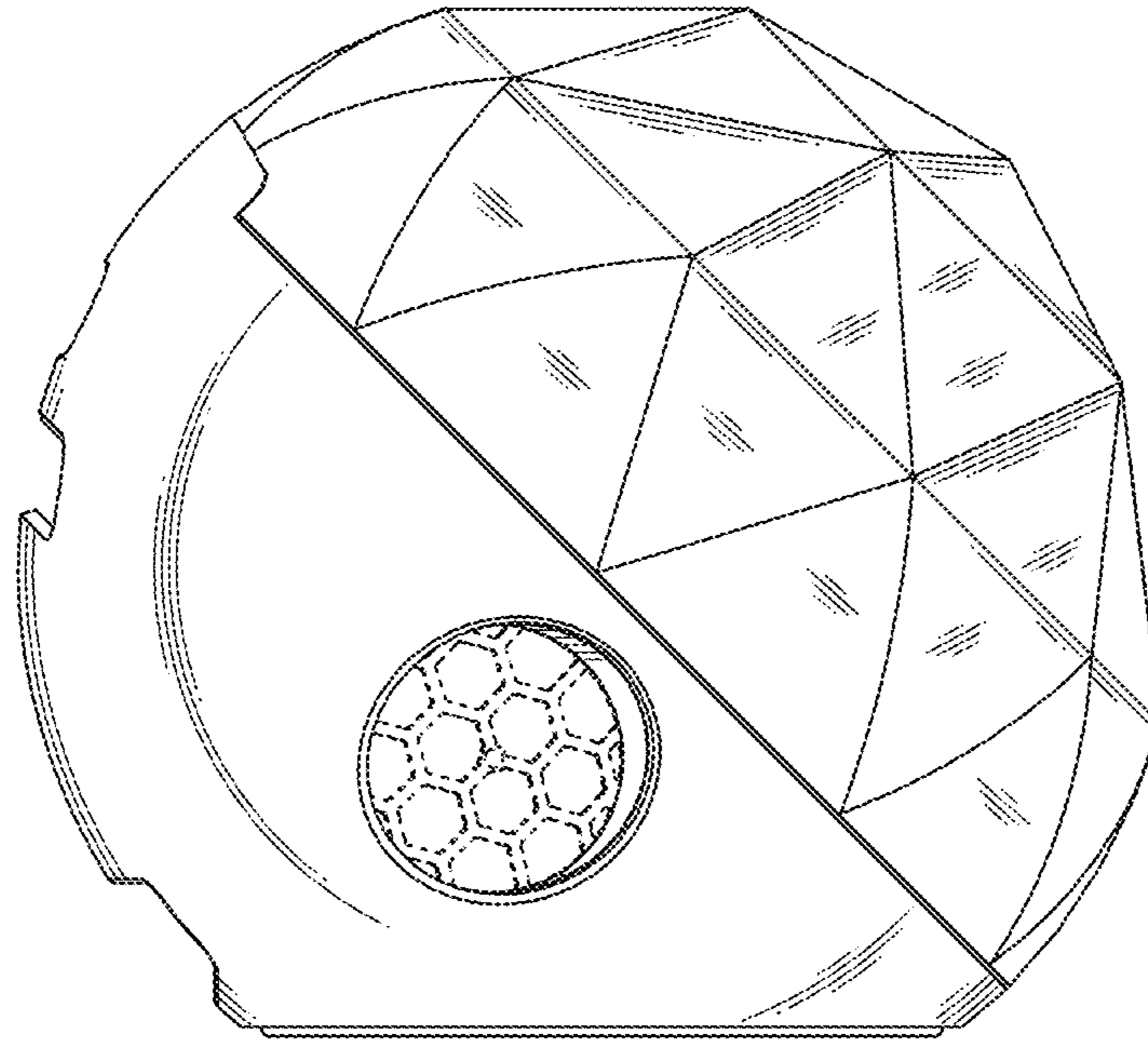

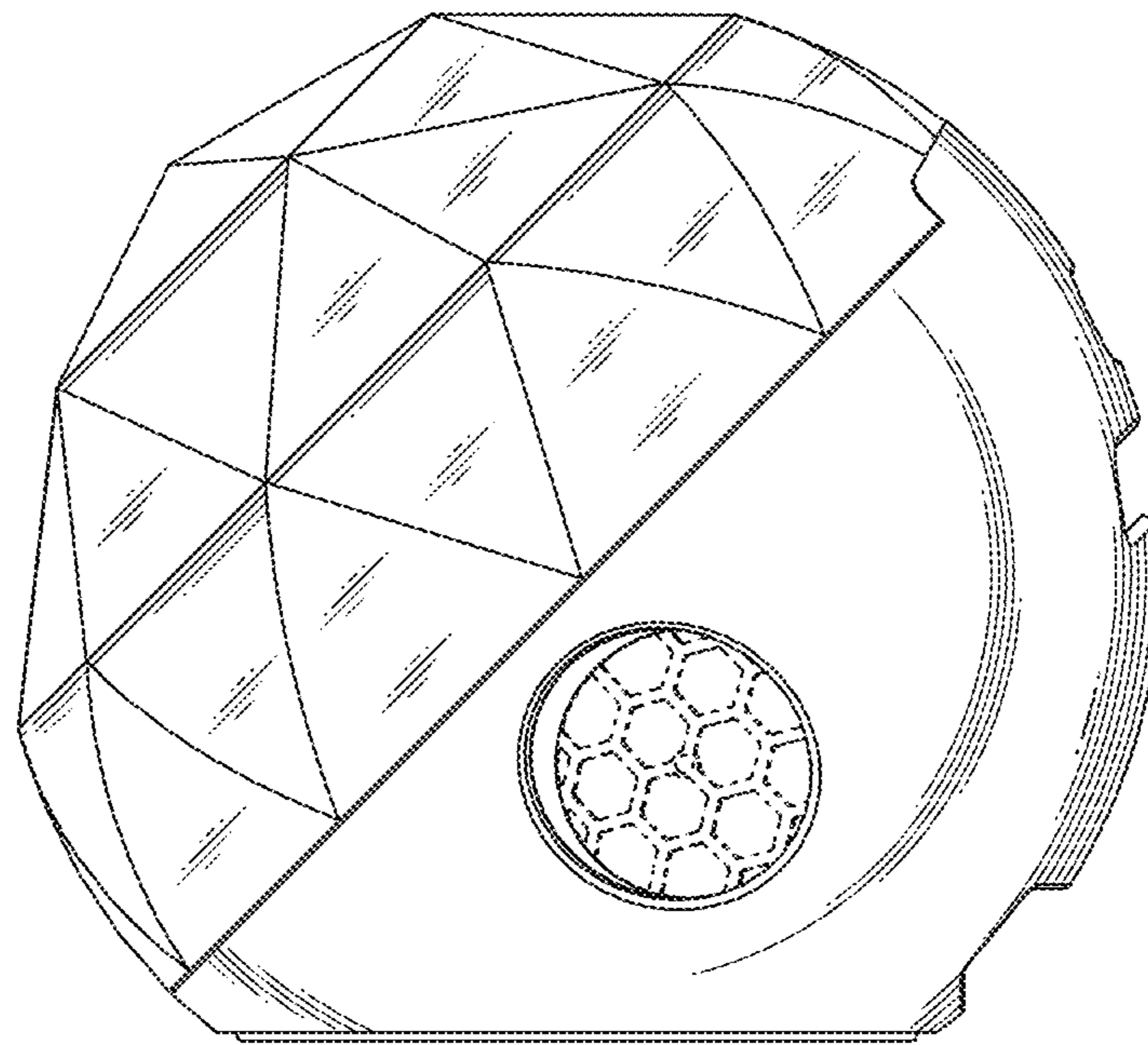

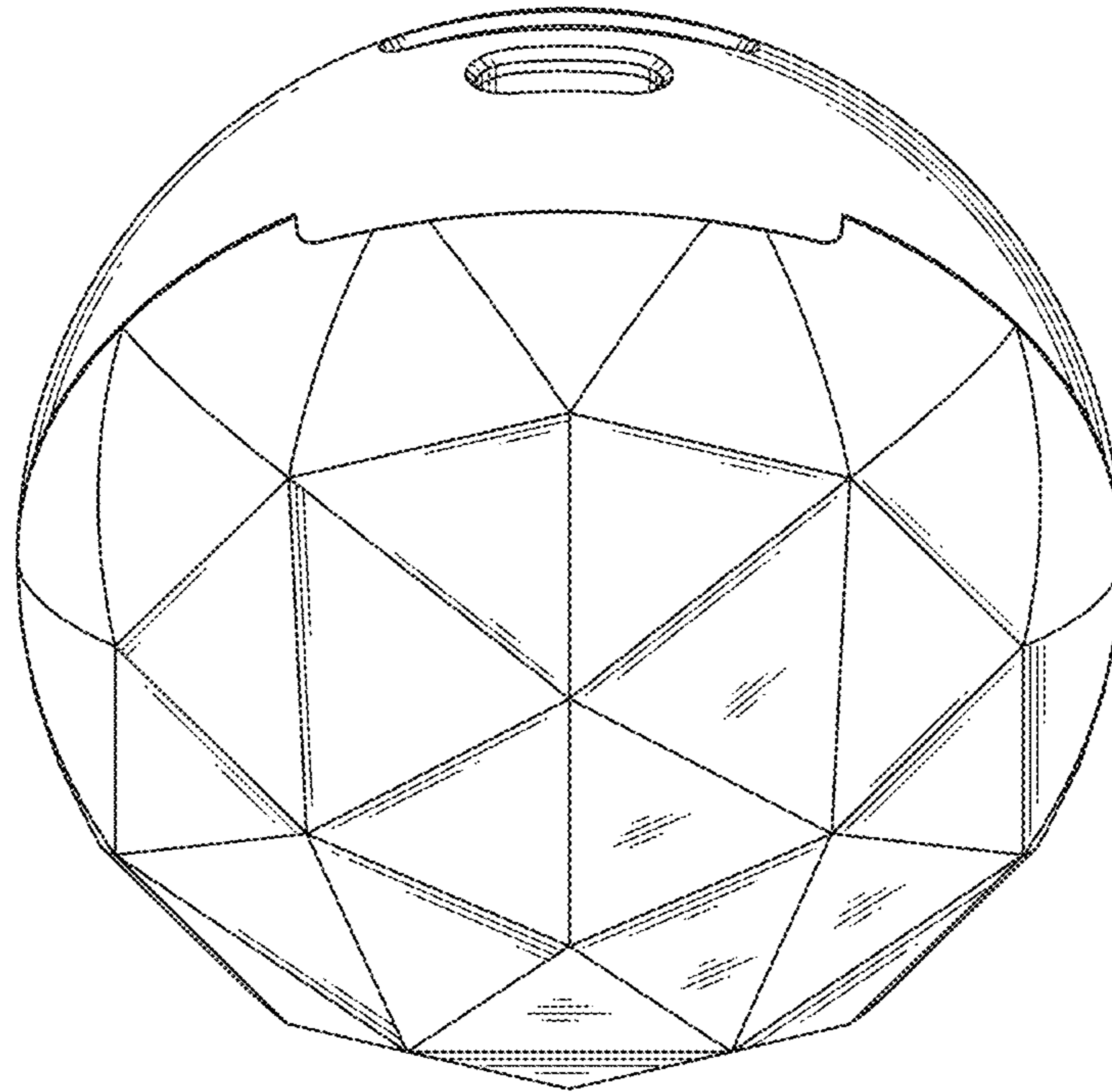

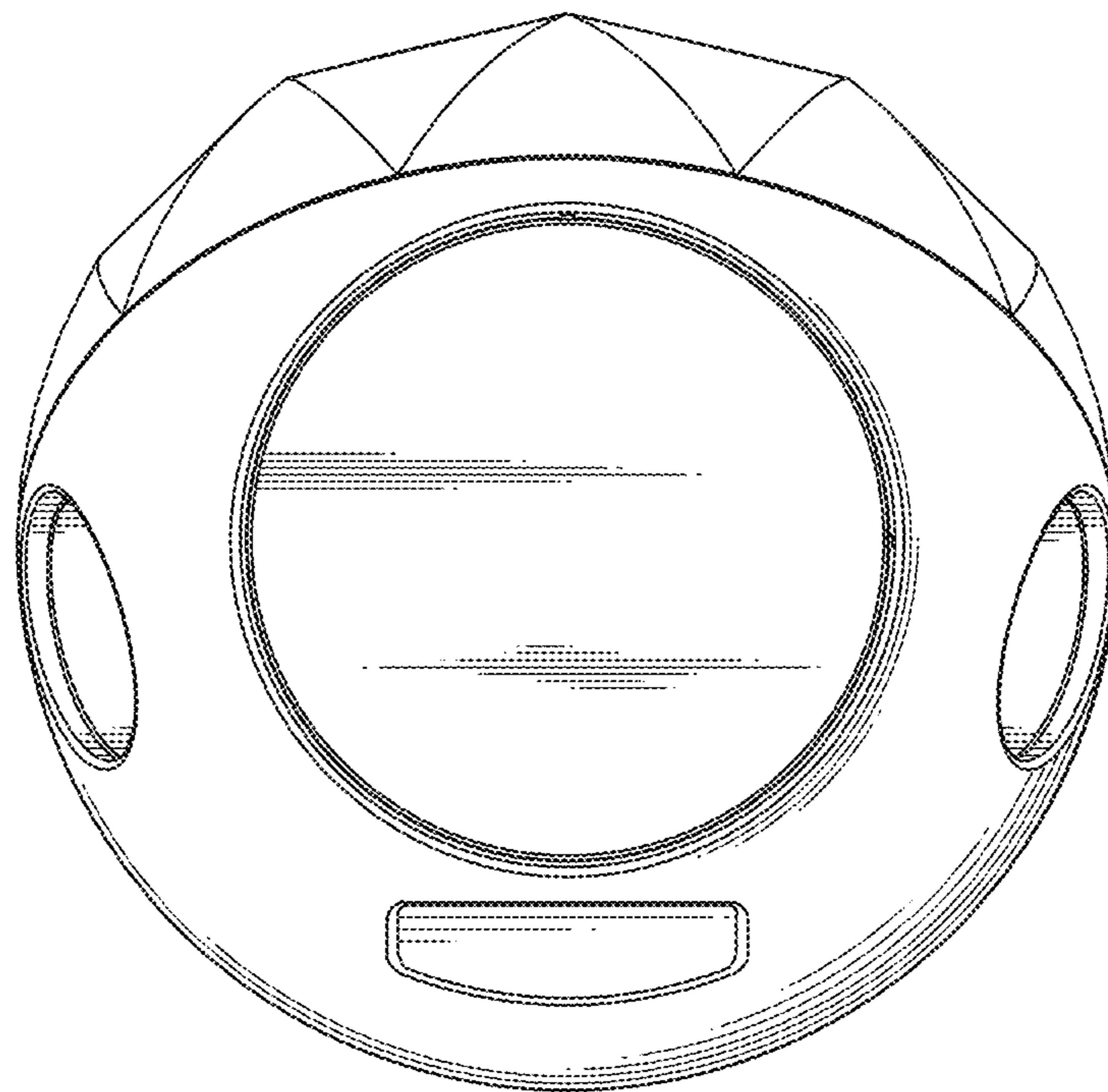
