design.

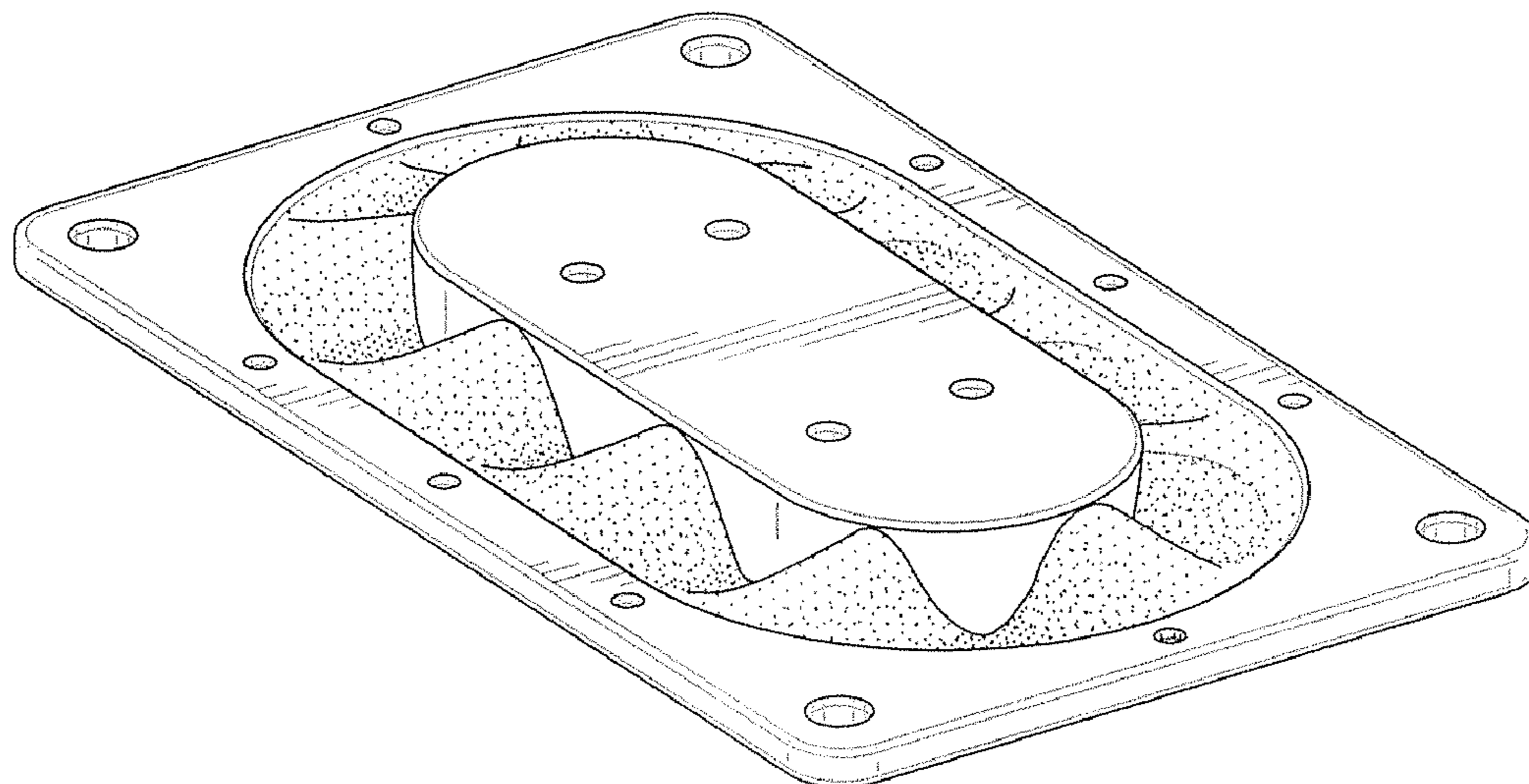
FIG. 4 is a left side elevational view thereof.

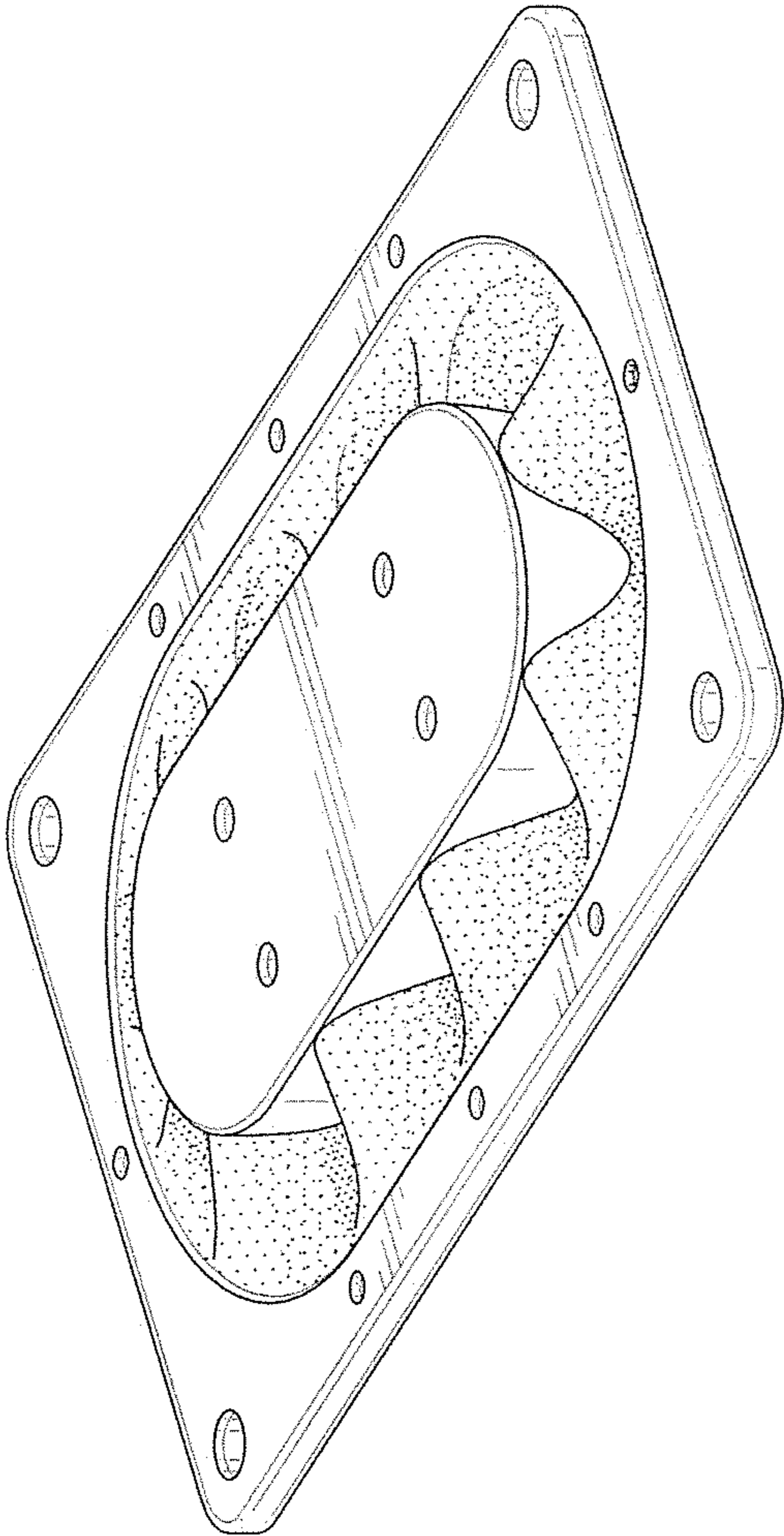

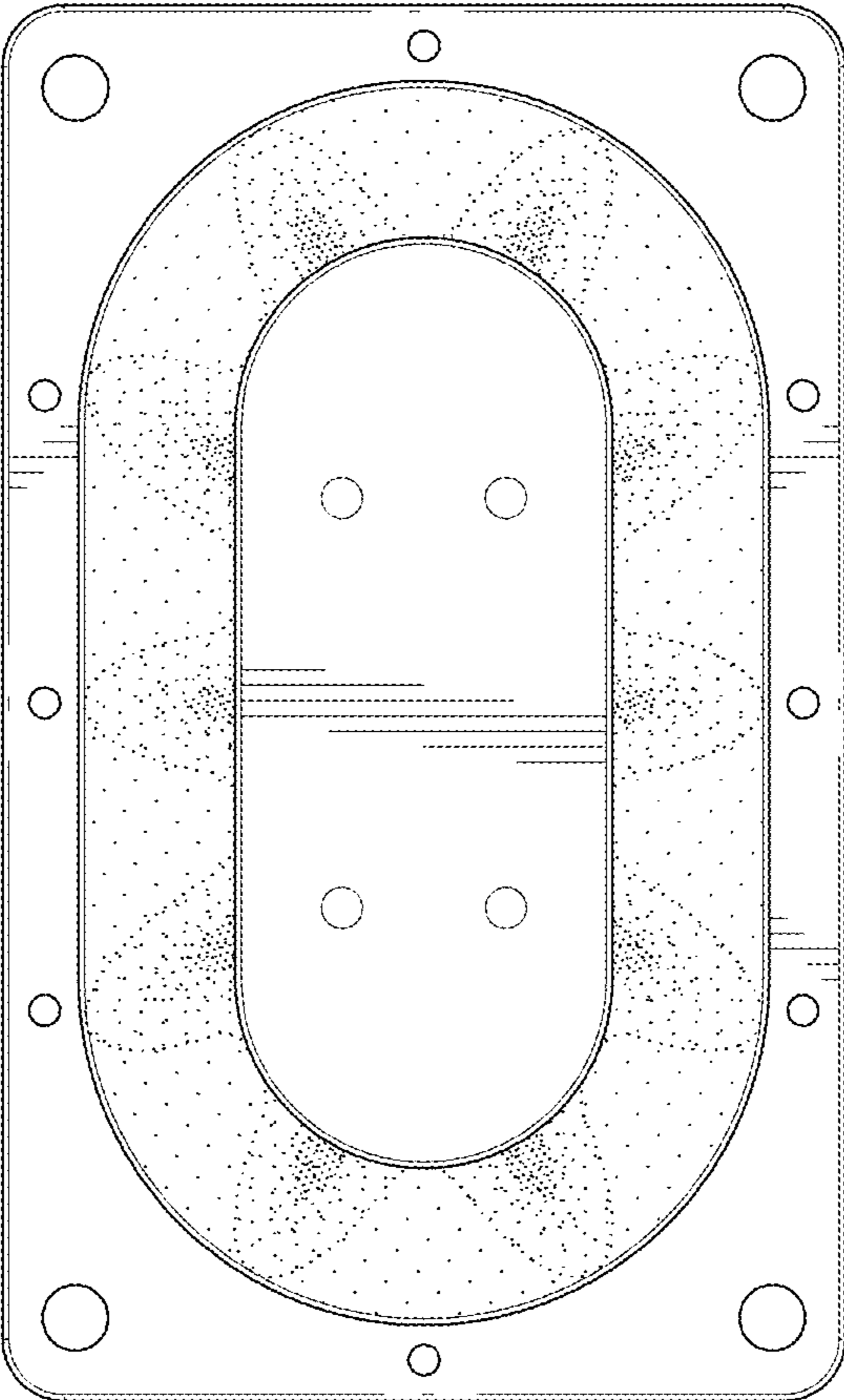

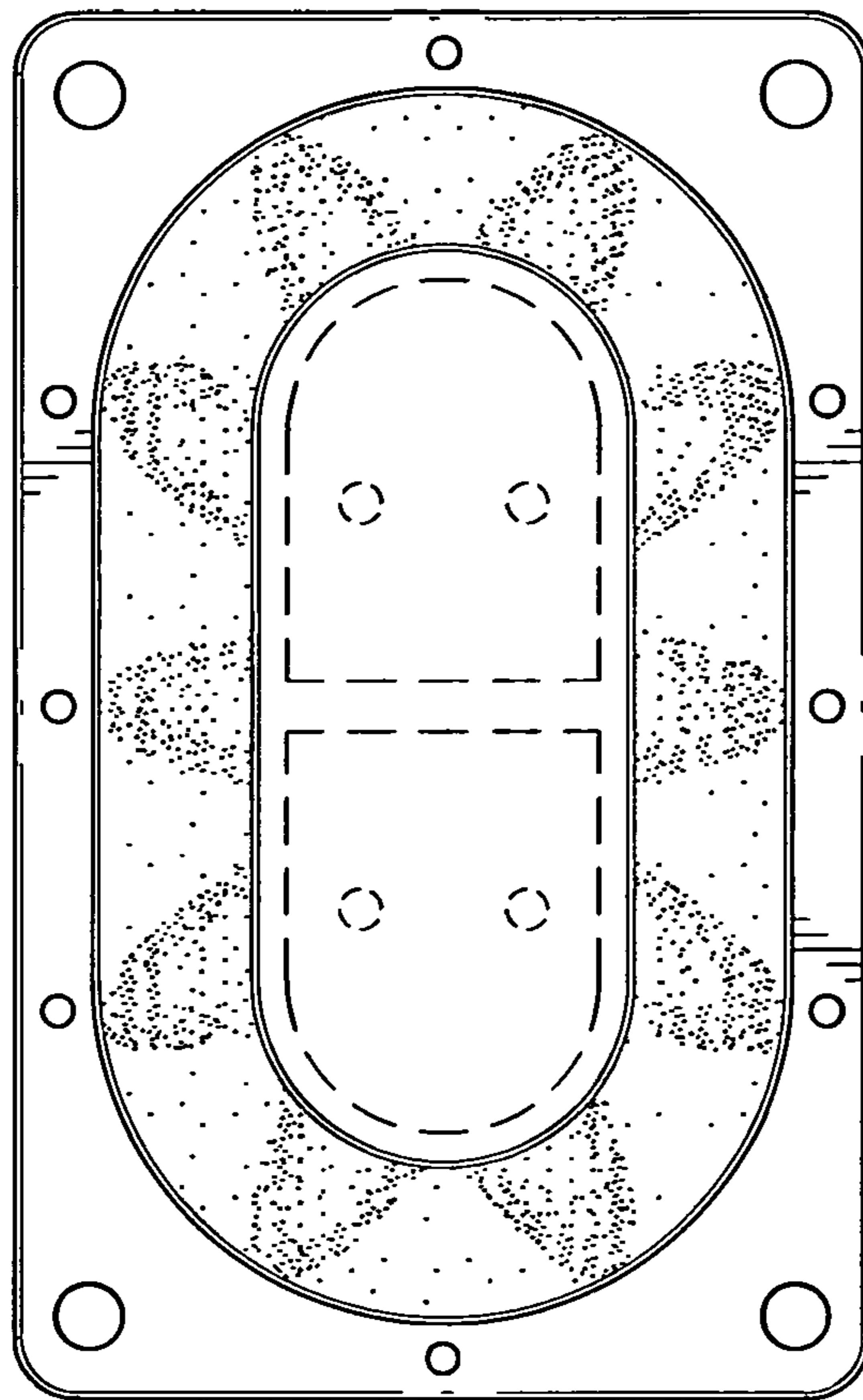

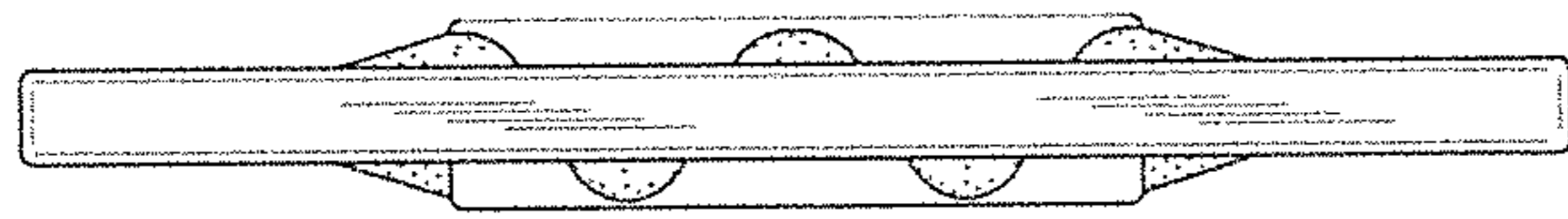

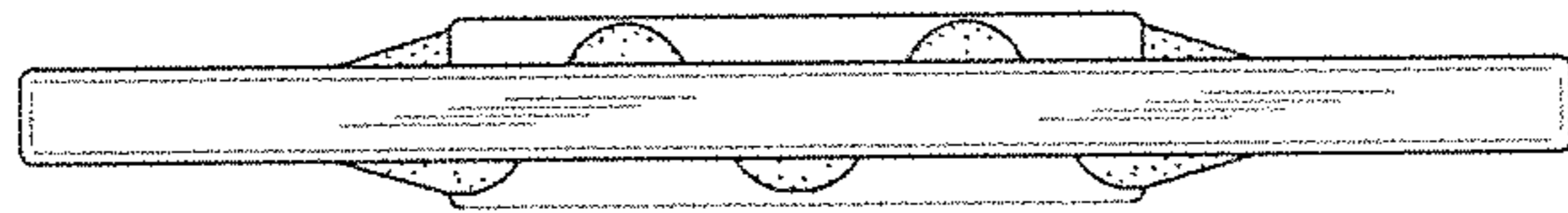
