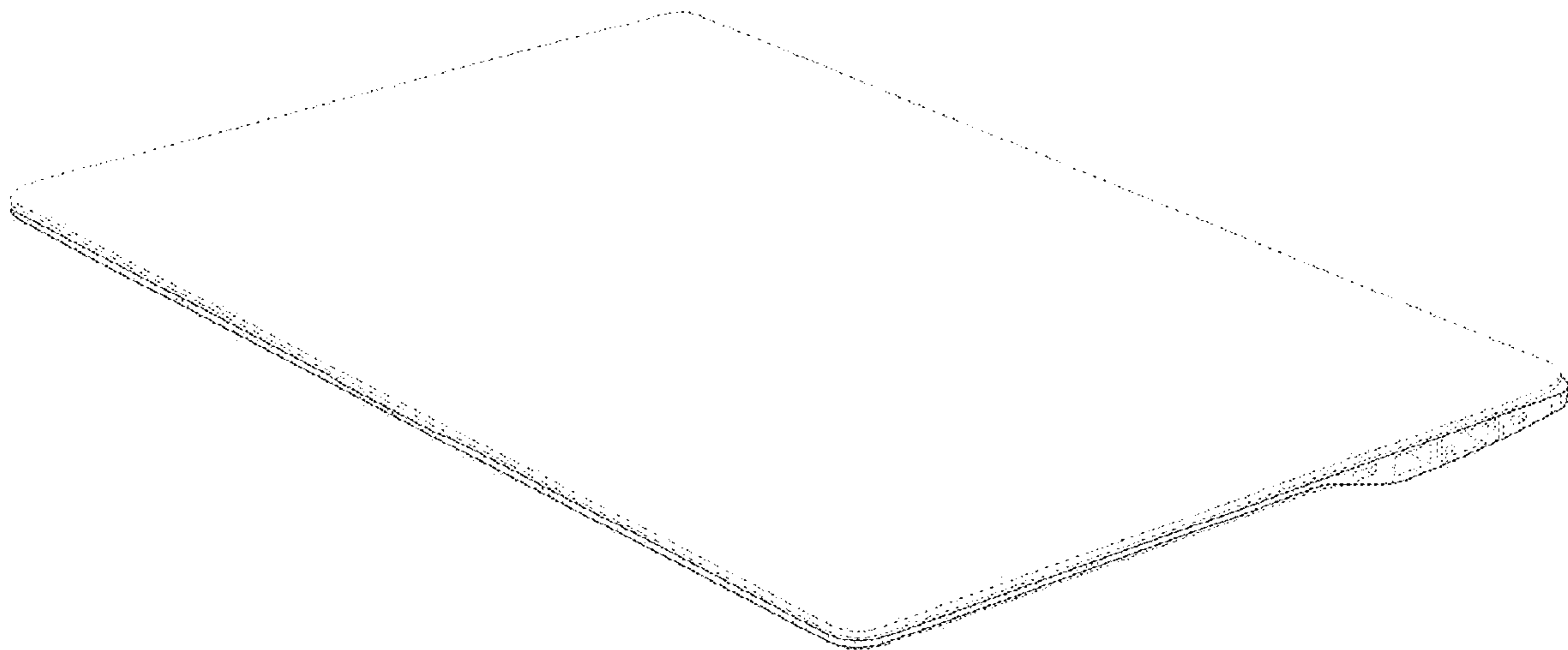
(57) **CLAIM**

The ornamental design for a notebook computer, as shown and described.

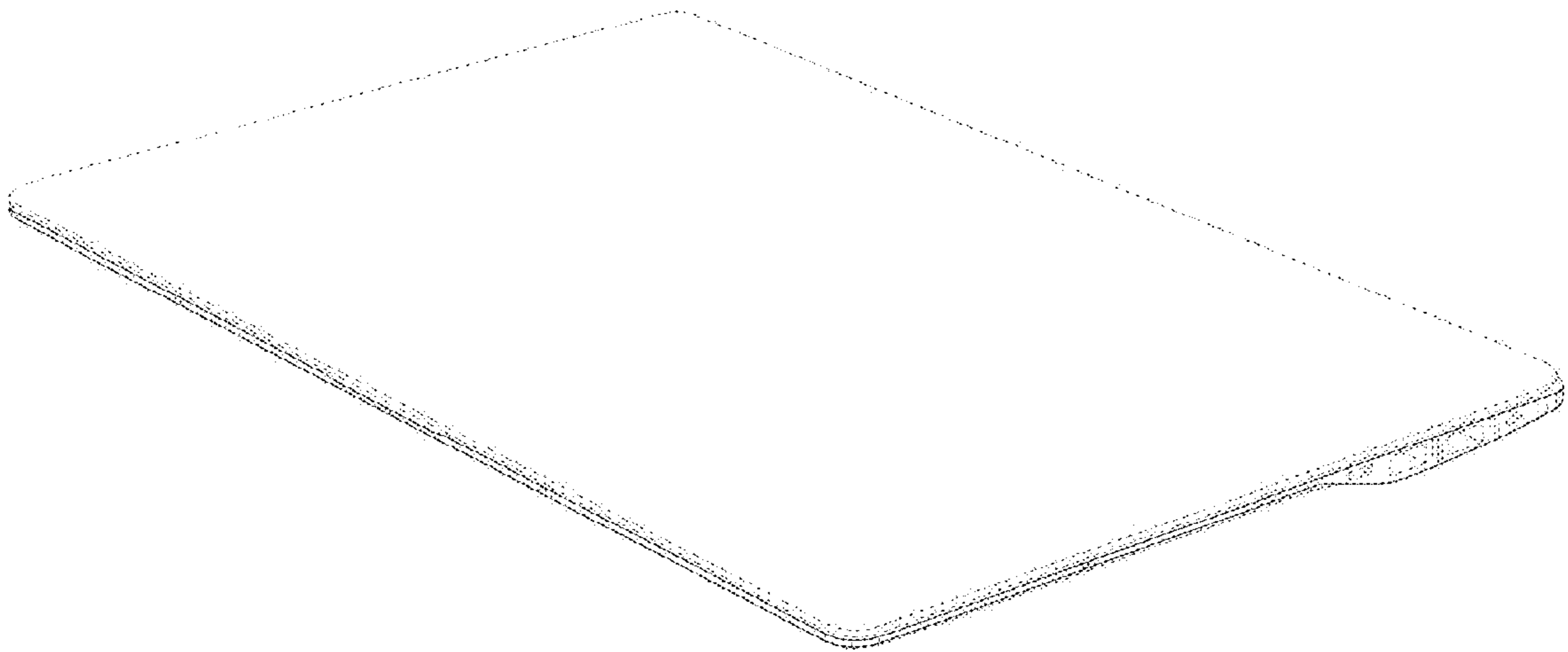
**DESCRIPTION**

The broken lines illustrating portions of the notebook computer are for environmental purposes only and form no part of the claimed design.

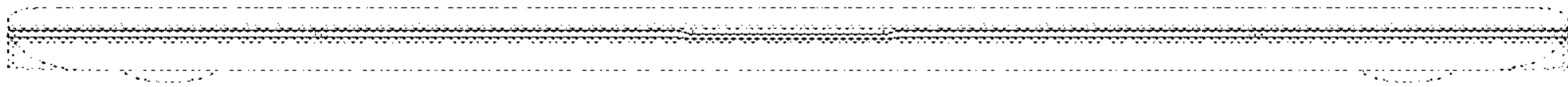

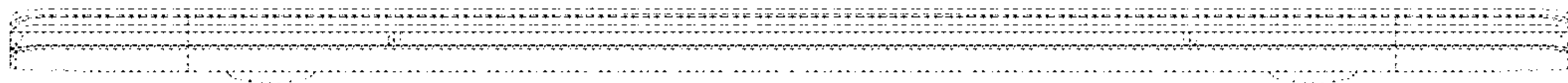

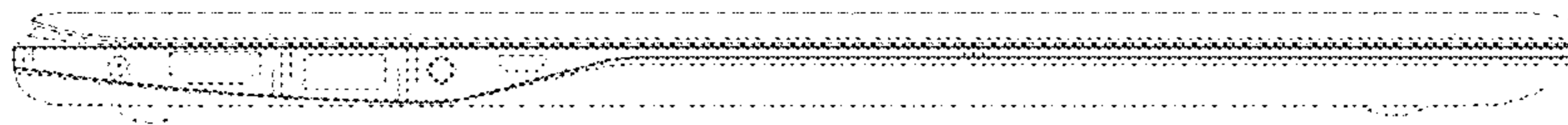

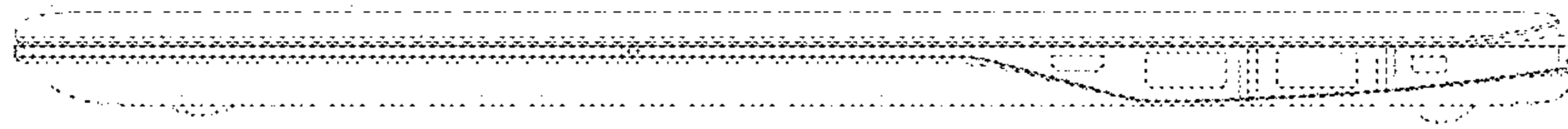
