The ornamental design for a display screen with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen with graphical user interface showing our new design;

FIG. 2 is a front view of a display screen with graphical user interface showing an alternative embodiment of our new design;

FIG. 3 is a front view of a display screen with graphical user interface of FIG. 1 shown on a device;

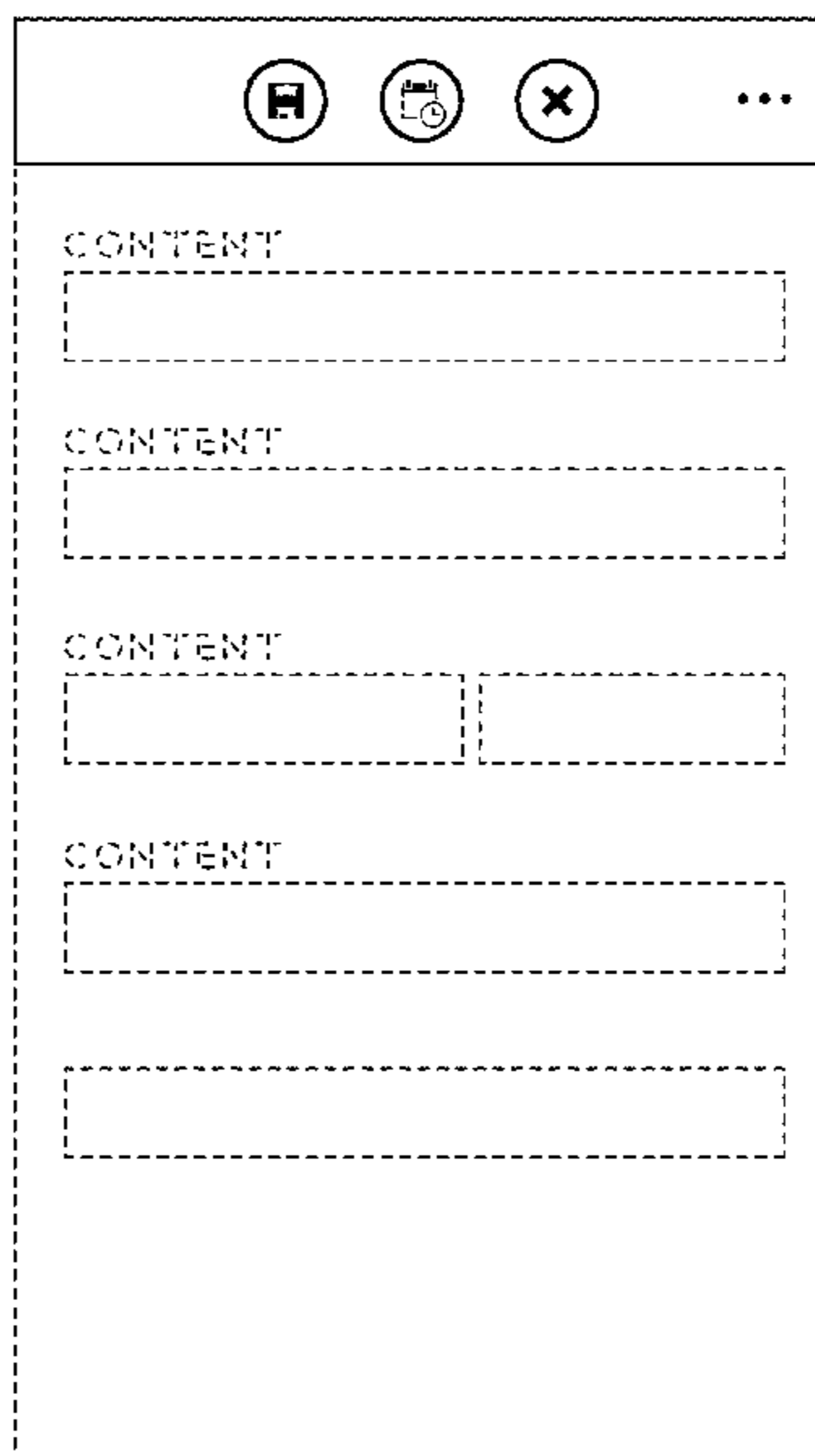
FIG. 4 is a front view of a display screen with graphical user interface of FIG. 2 shown on a device;

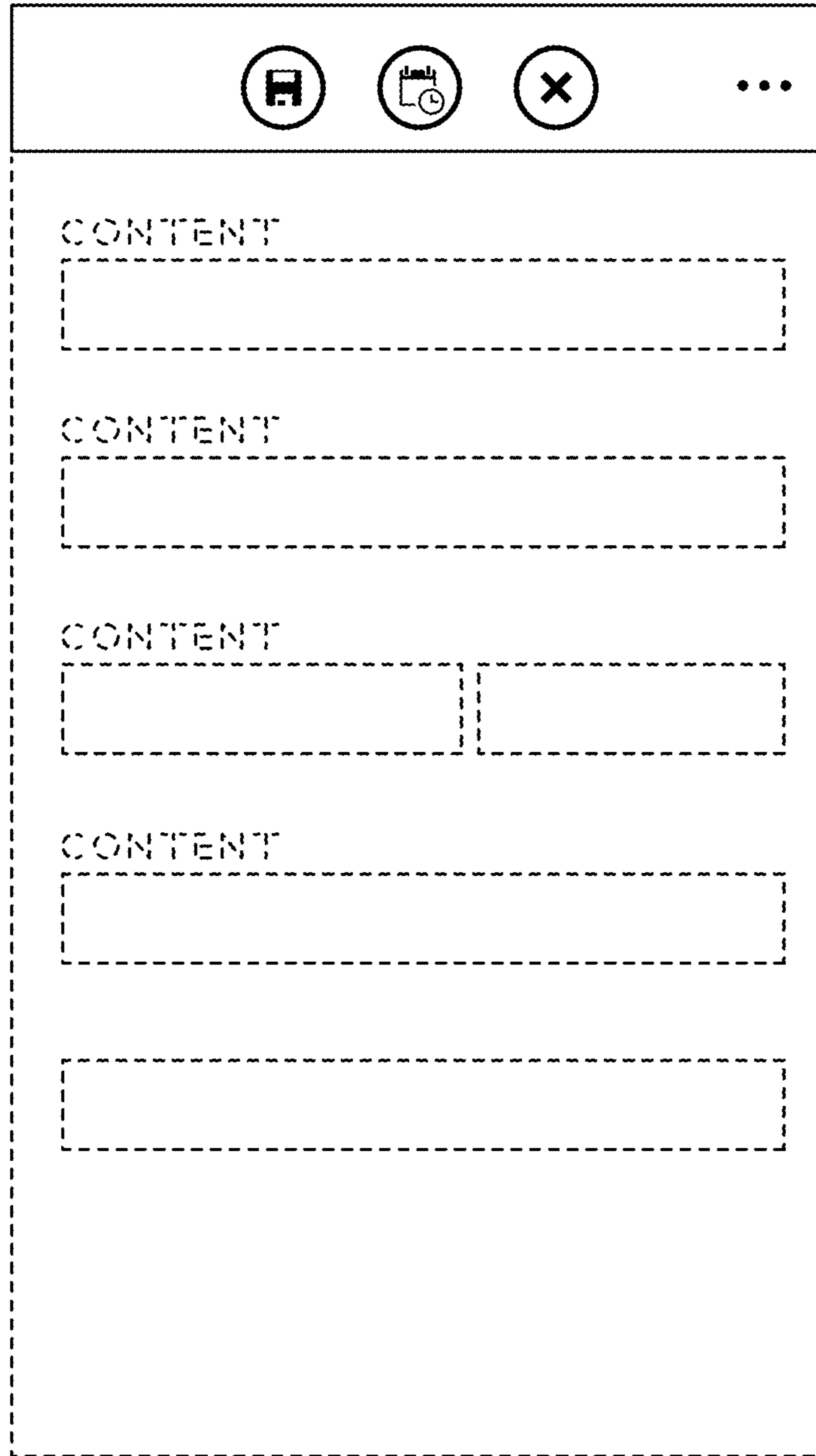

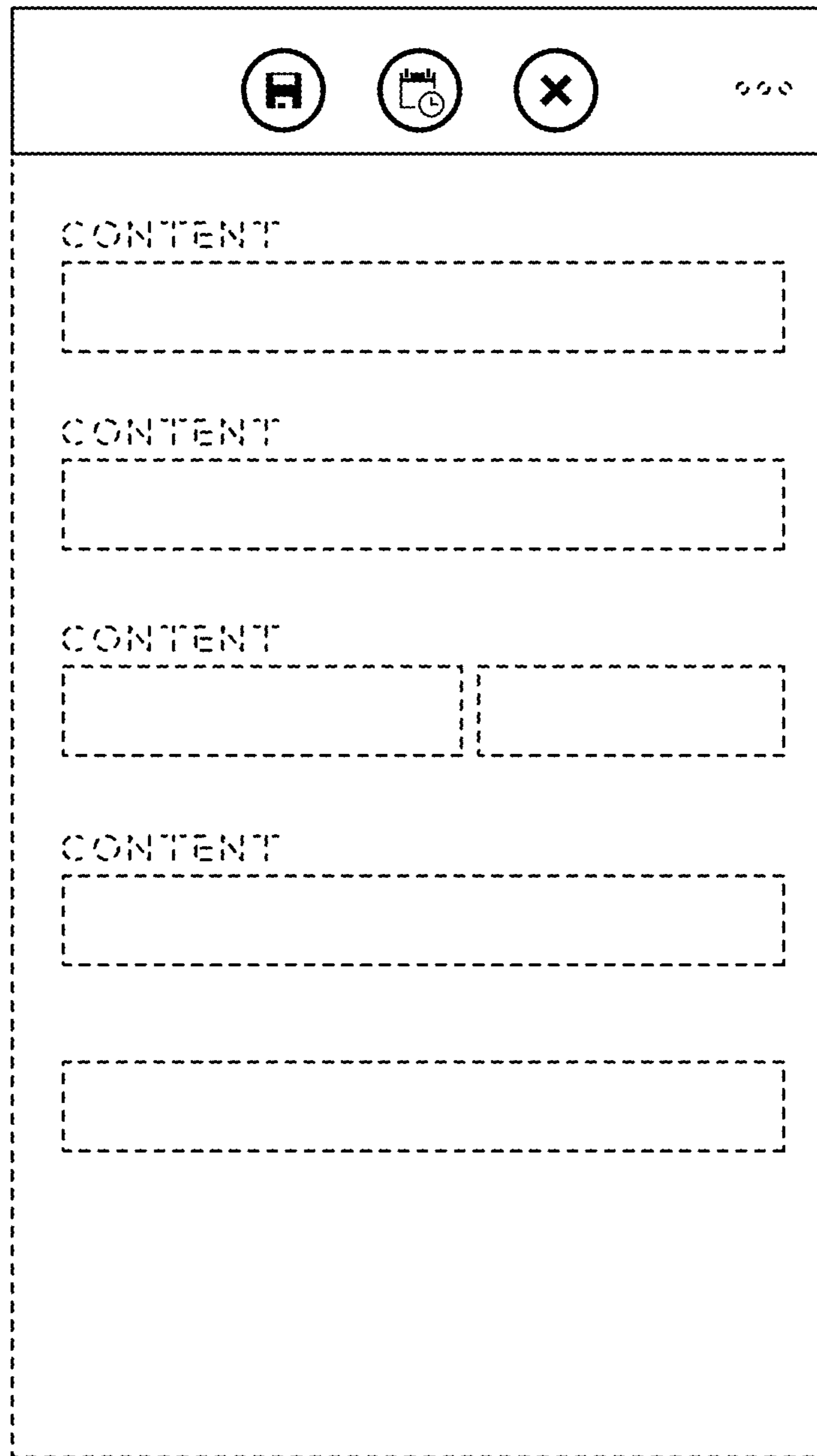

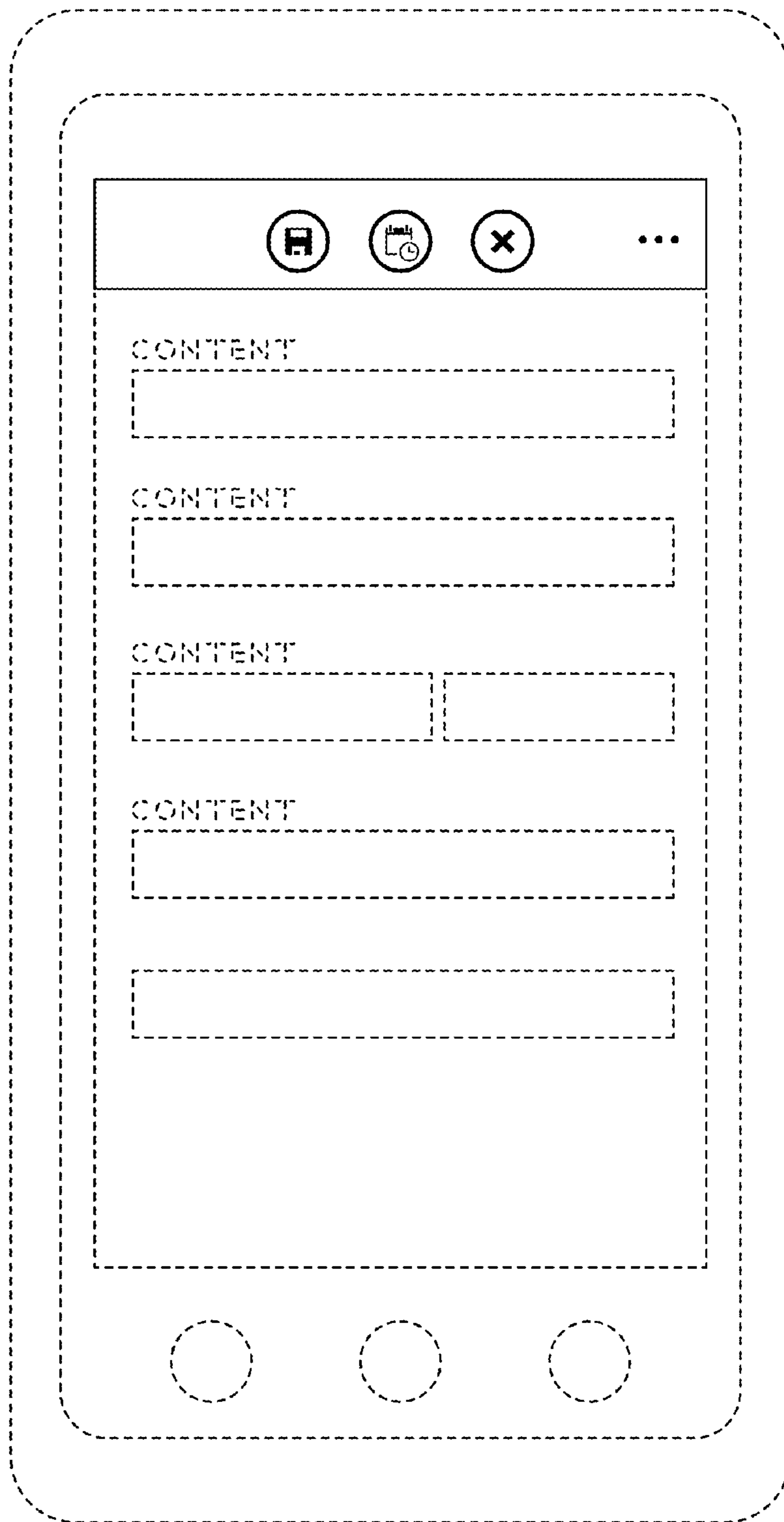

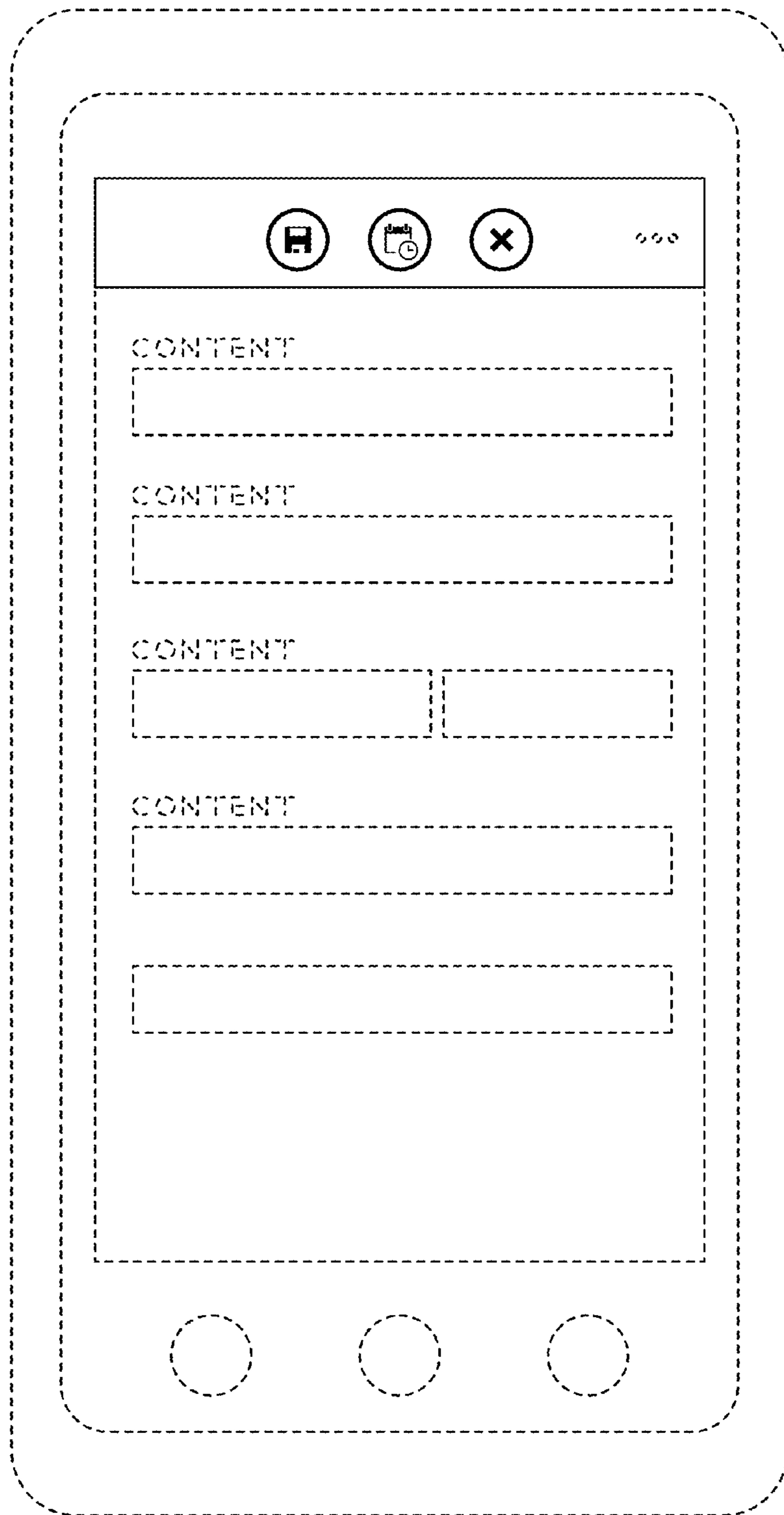

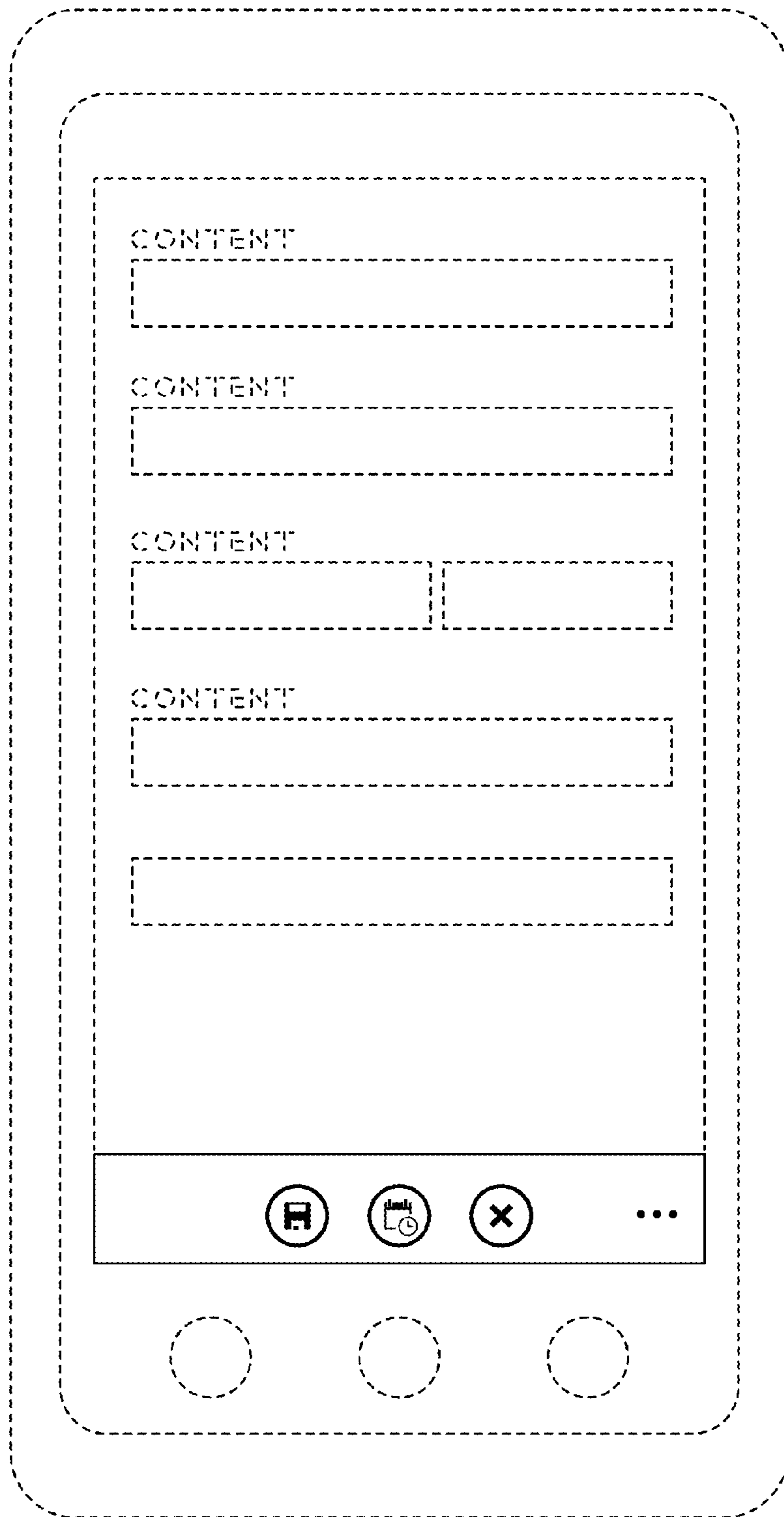

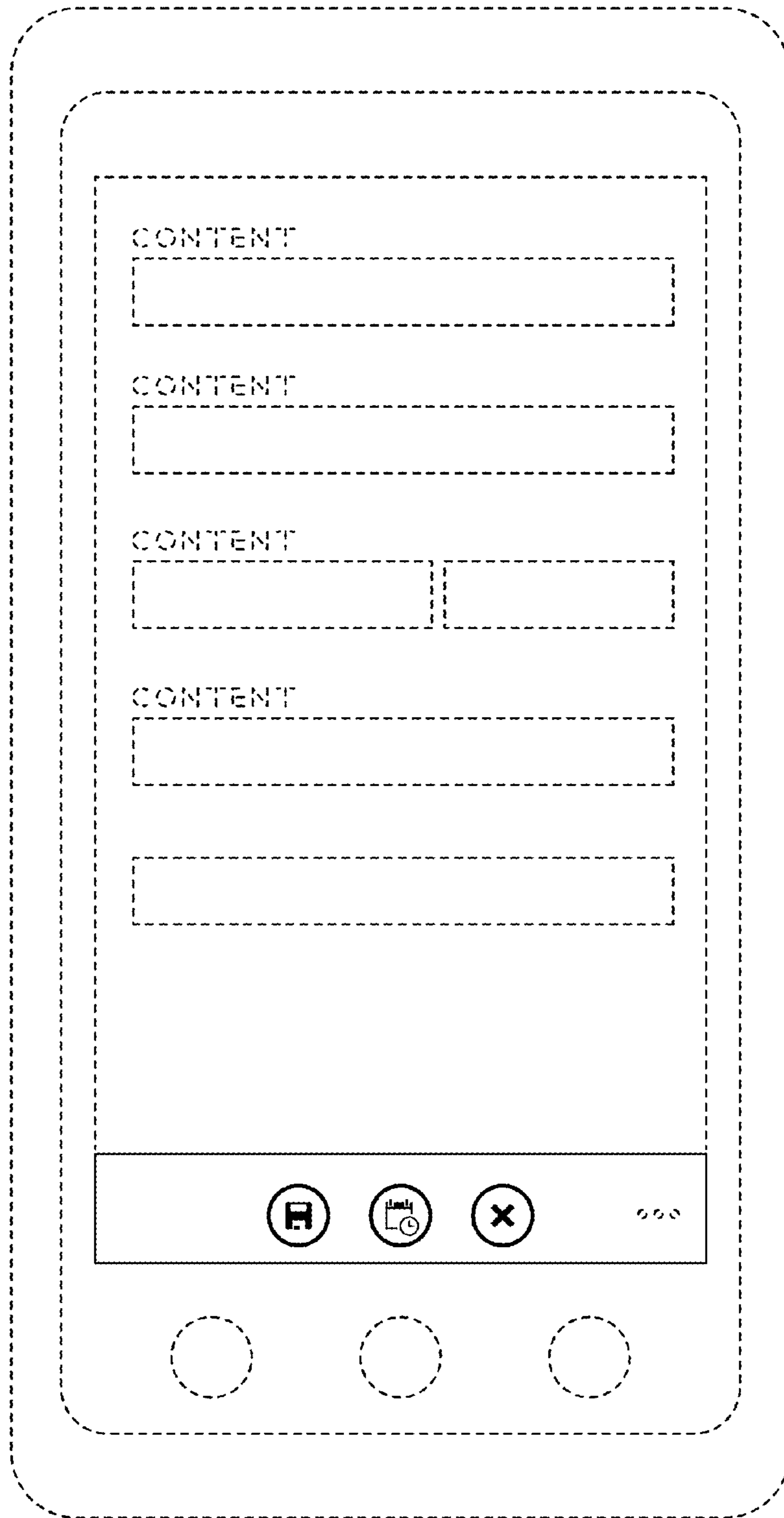
