(57) **CLAIM**

The ornamental design for a baritar scale for ukulele, as shown and described.

DESCRIPTION

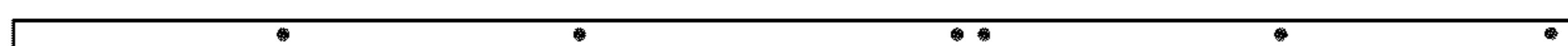
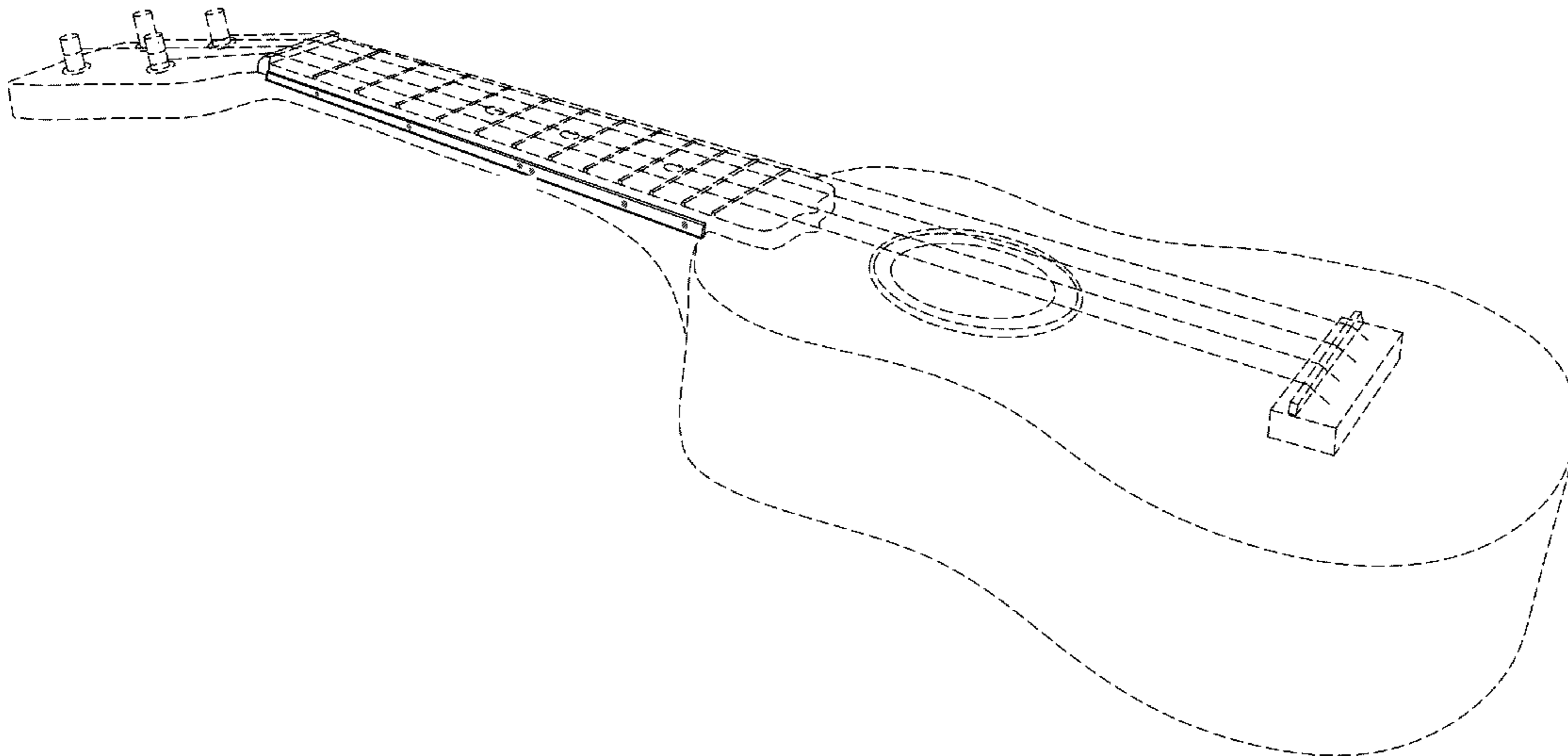
FIG. 1 is a perspective view of the baritar scale for ukulele and its location on a ukulele;
FIG. 2 is a perspective view of the baritar scale for ukulele;
FIG. 3 is a top view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a front view thereof;
FIG. 6 is a left side view thereof; and,
FIG. 7 is a bottom view thereof.

The different surface shading represents different textures on the surface of the article.

The broken line showing of the ukulele in FIG. 1 illustrates the environment of the claimed design and forms no part thereof. The black circles on the front of the claimed design represent the color black. The stippling shown in FIG. 7 represents an adhesive surface.

The baritar scale is a rectangular strip with a series of dots that, when placed along the fret board of a ukulele, will allow a guitar player to more easily master the chords of the ukulele.

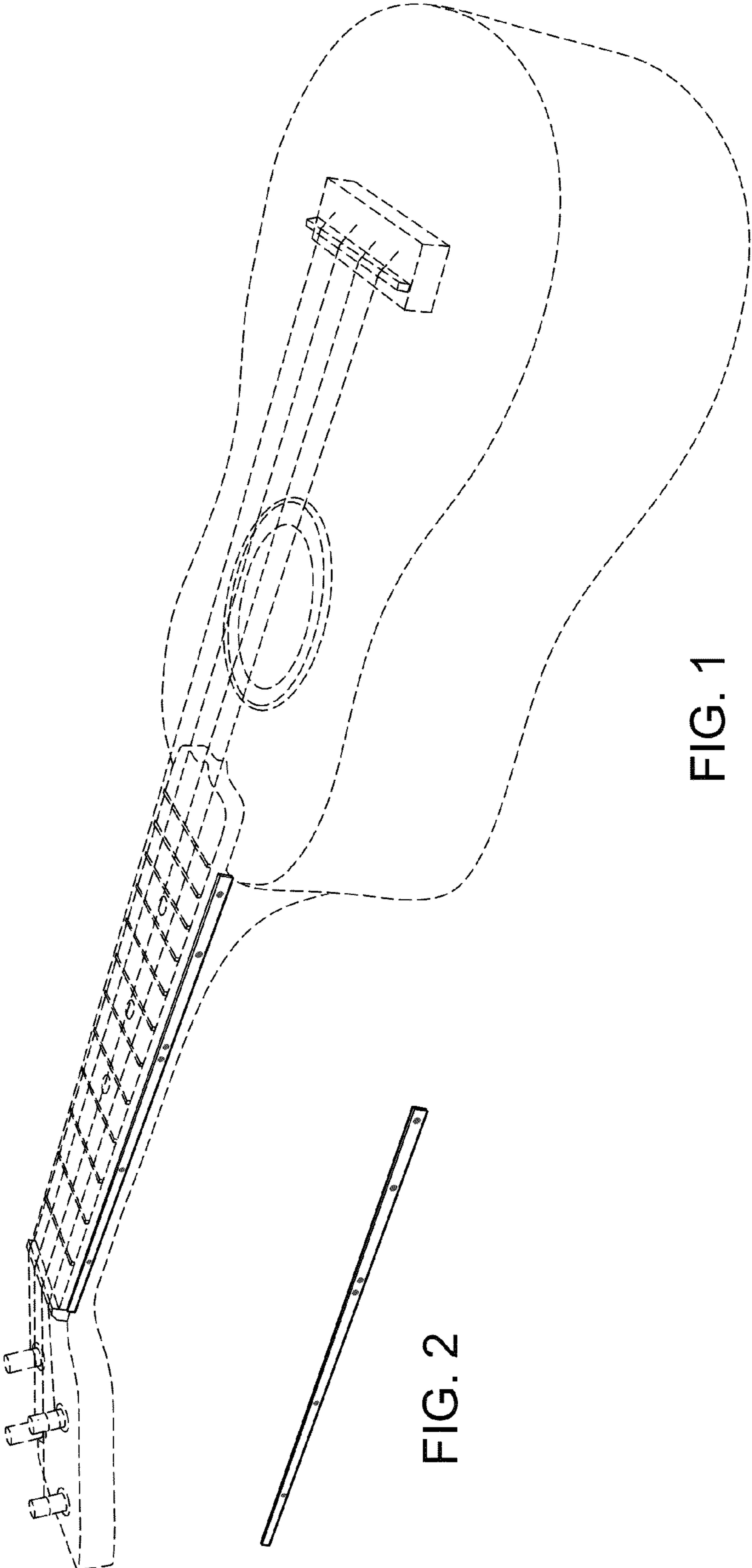
